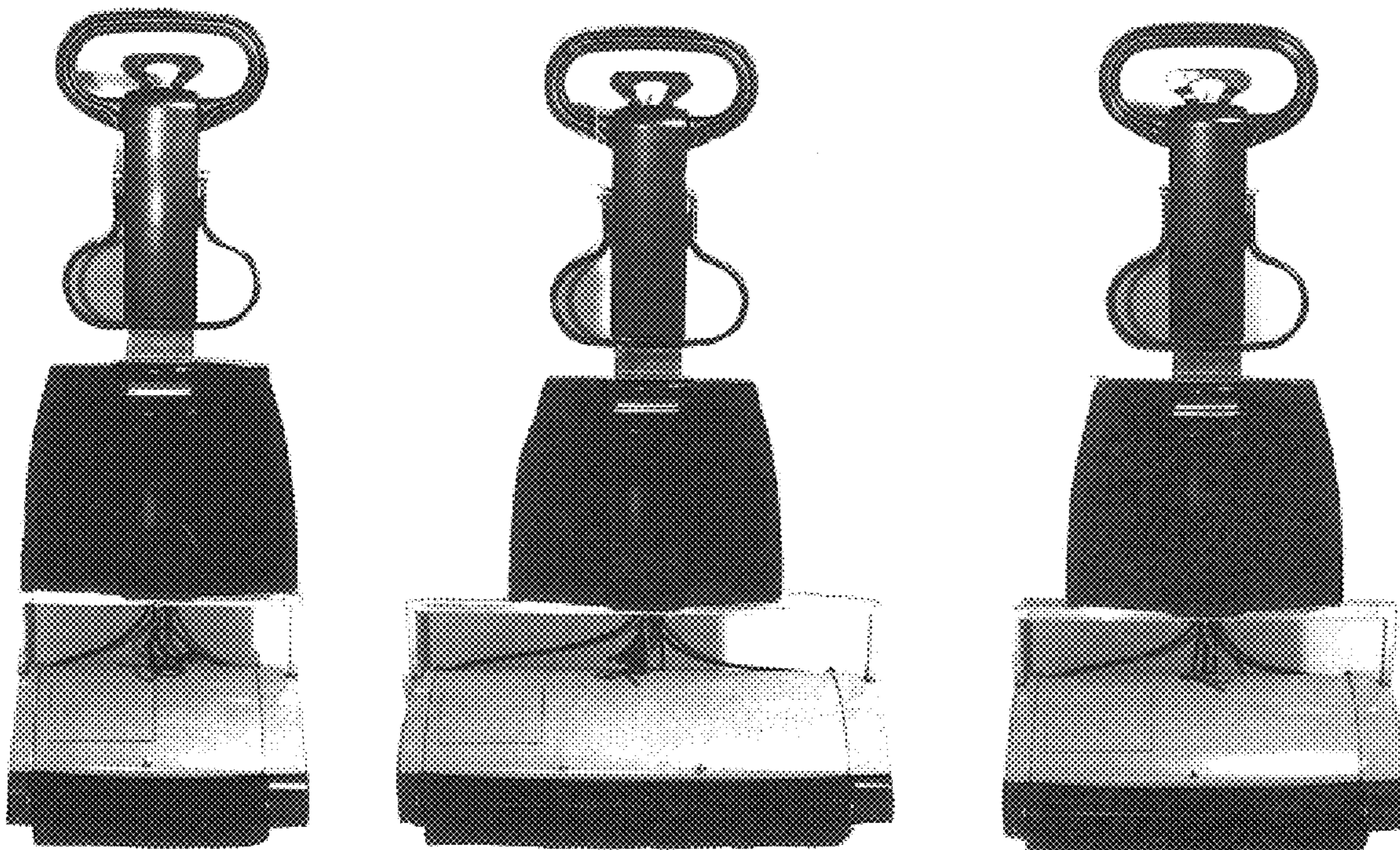
[57] **CLAIM**

The ornamental design for a floor cleaning device, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of one embodiment of a floor cleaning device, showing my new design; FIG. 2 is a top and rear perspective view thereof; FIG. 3 is a top and left side perspective view thereof; FIG. 4 is a top and right side perspective view thereof; FIG. 5 is a top and front perspective view of a second embodiment thereof, FIG. 6 is a top and rear perspective view of the second embodiment; FIG. 7 is a top and left side perspective view of the second embodiment; FIG. 8 is a top and right side perspective view of the second embodiment; FIG. 9 is a top and front perspective view of a third embodiment thereof, FIG. 10 is a top and rear perspective view of the third embodiment; and, FIG. 11 is a top and left side perspective view of the third embodiment; FIG. 12 is a top and right side perspective view of the third embodiment.

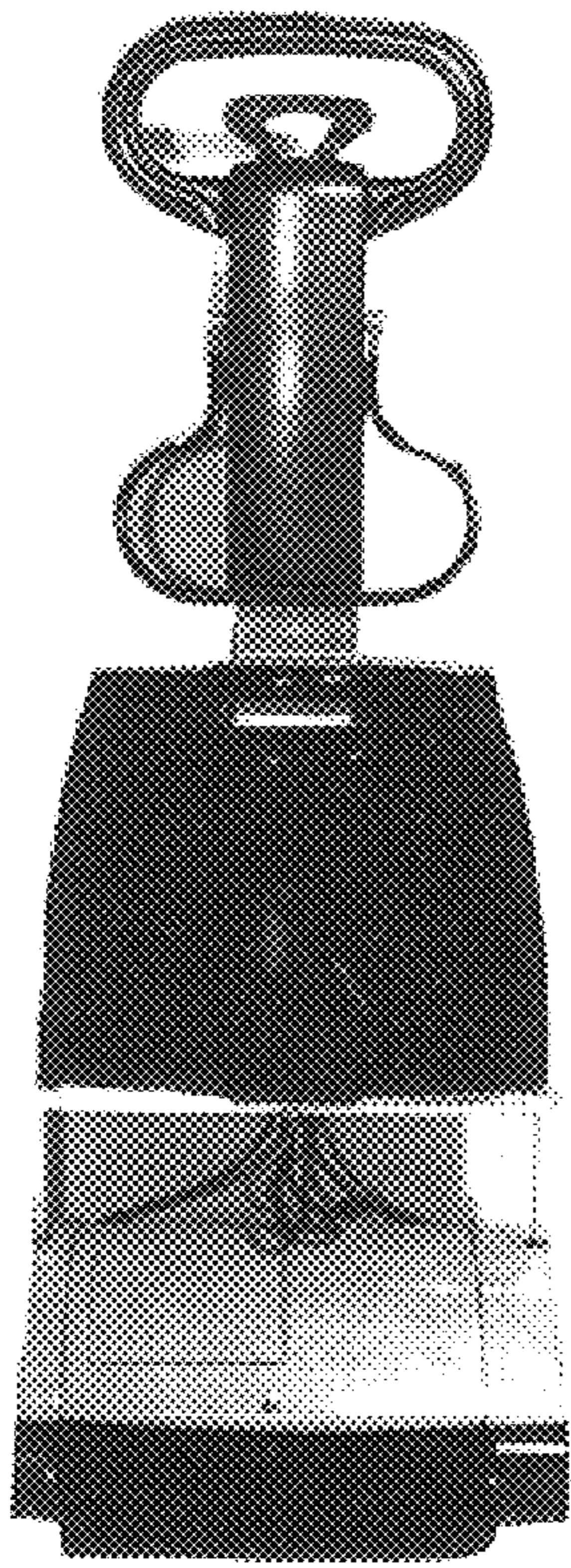

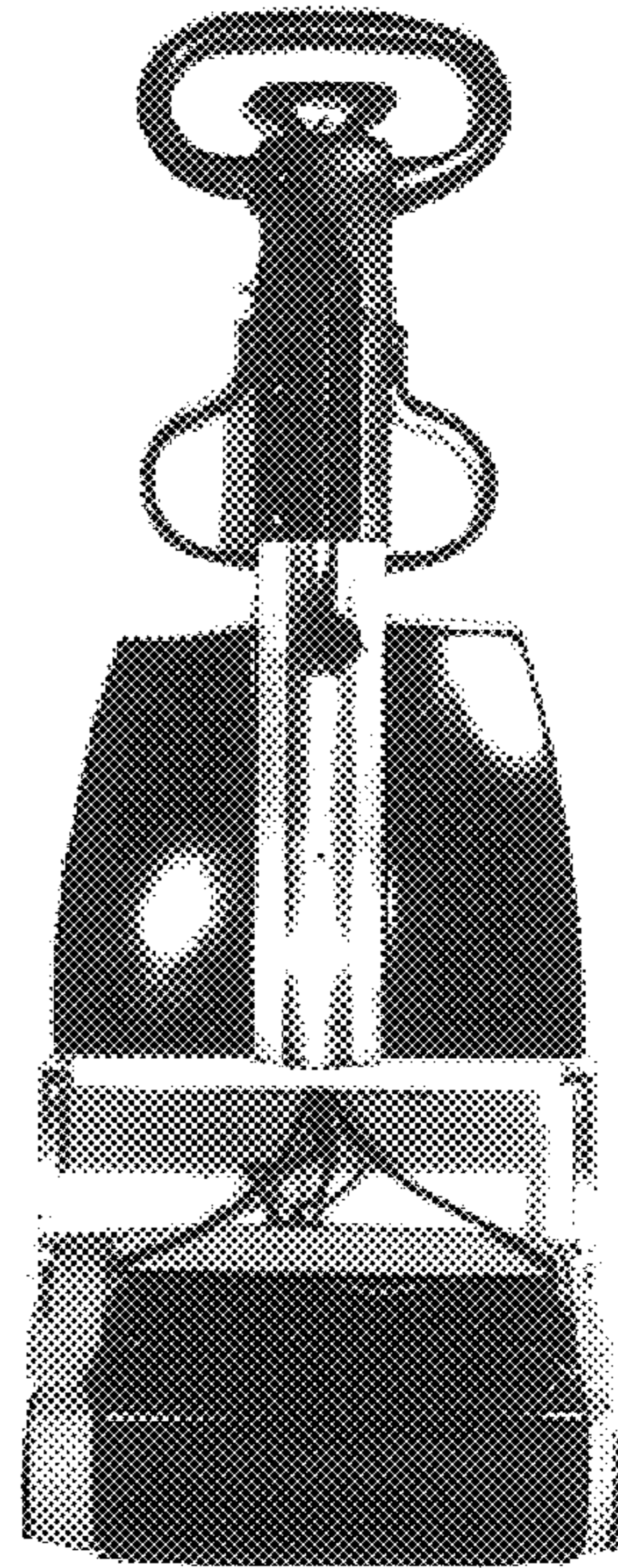

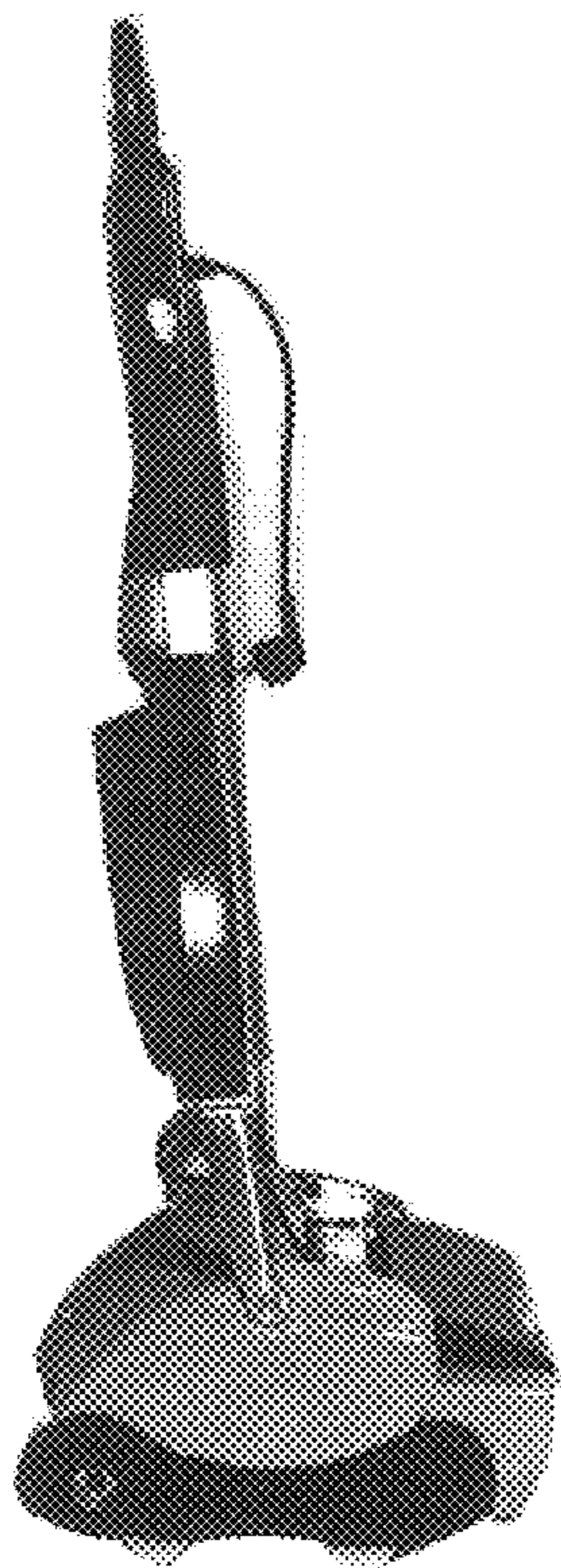

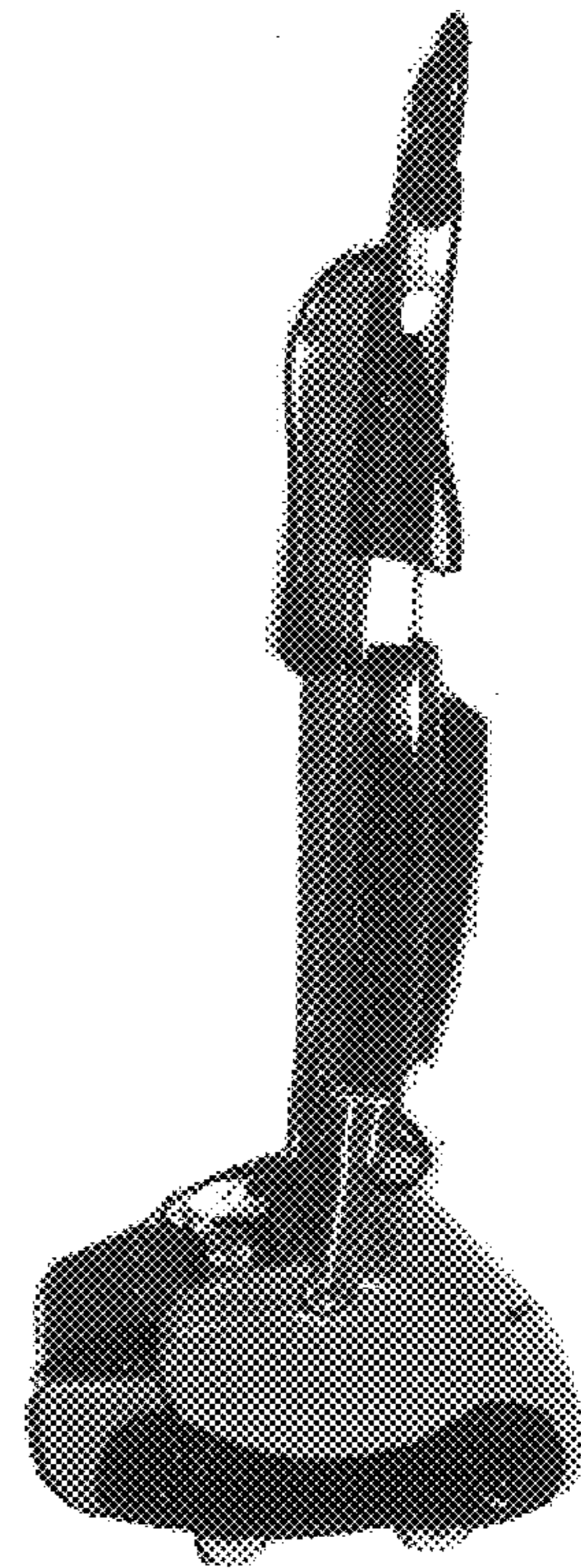

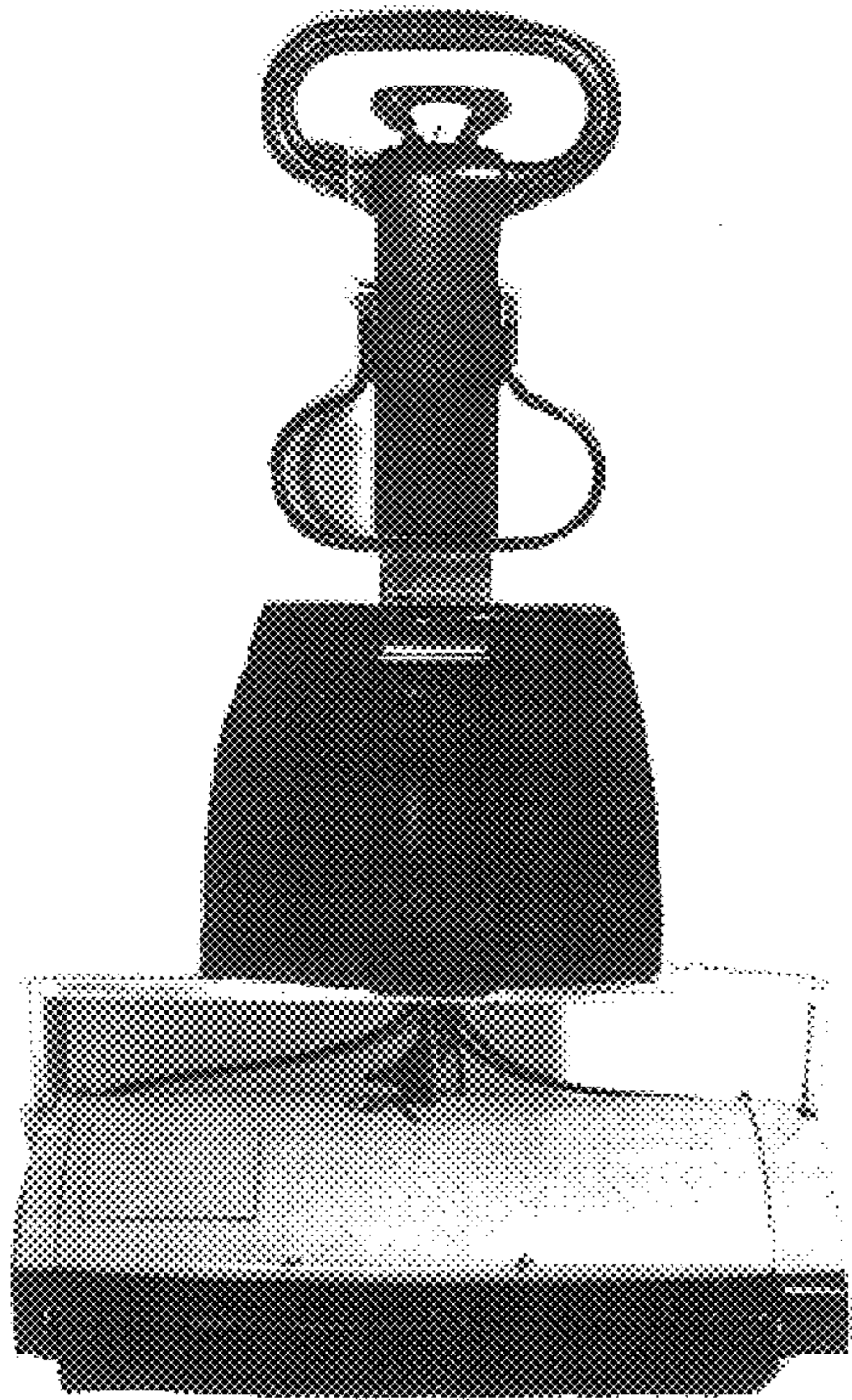

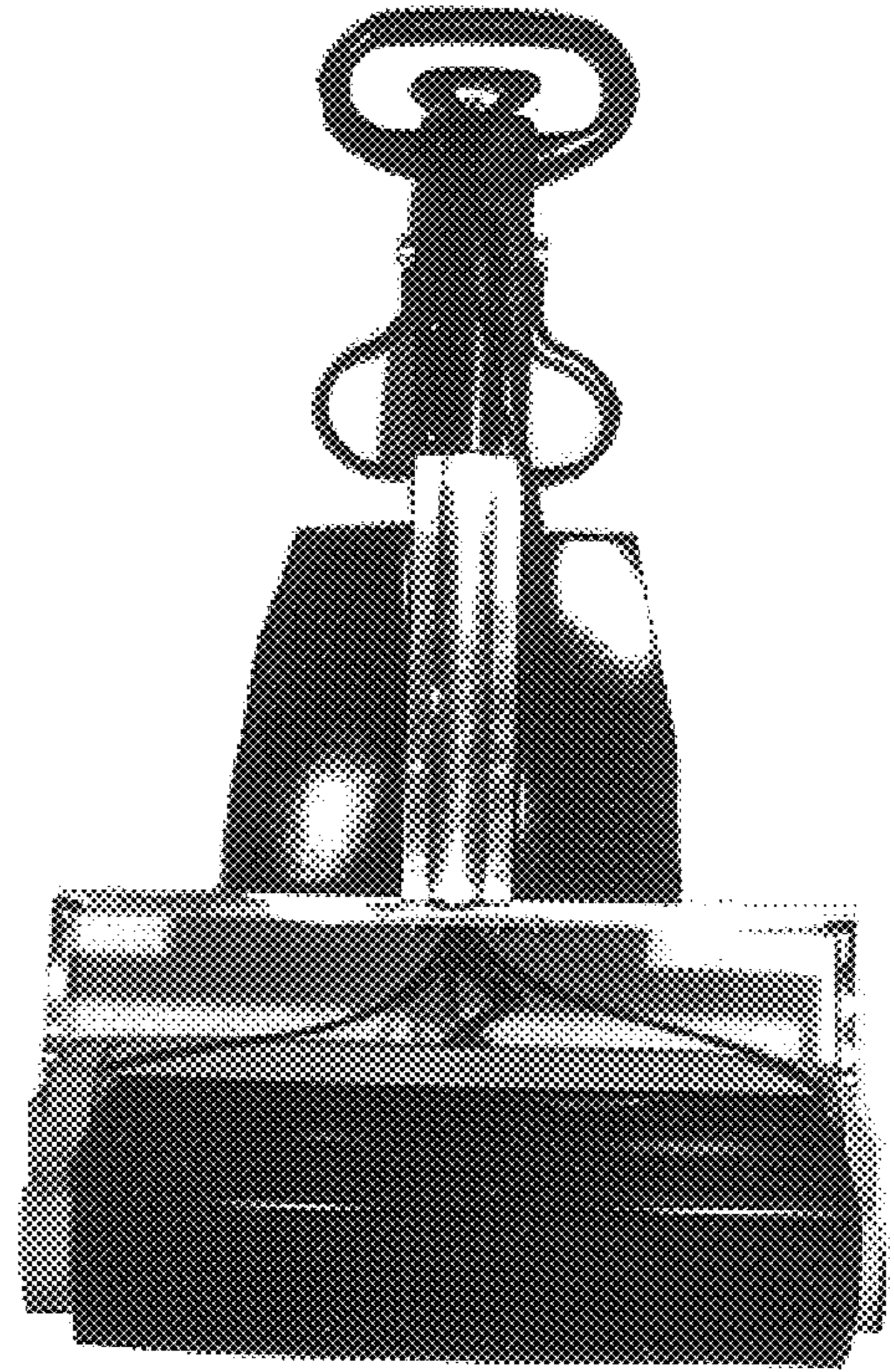

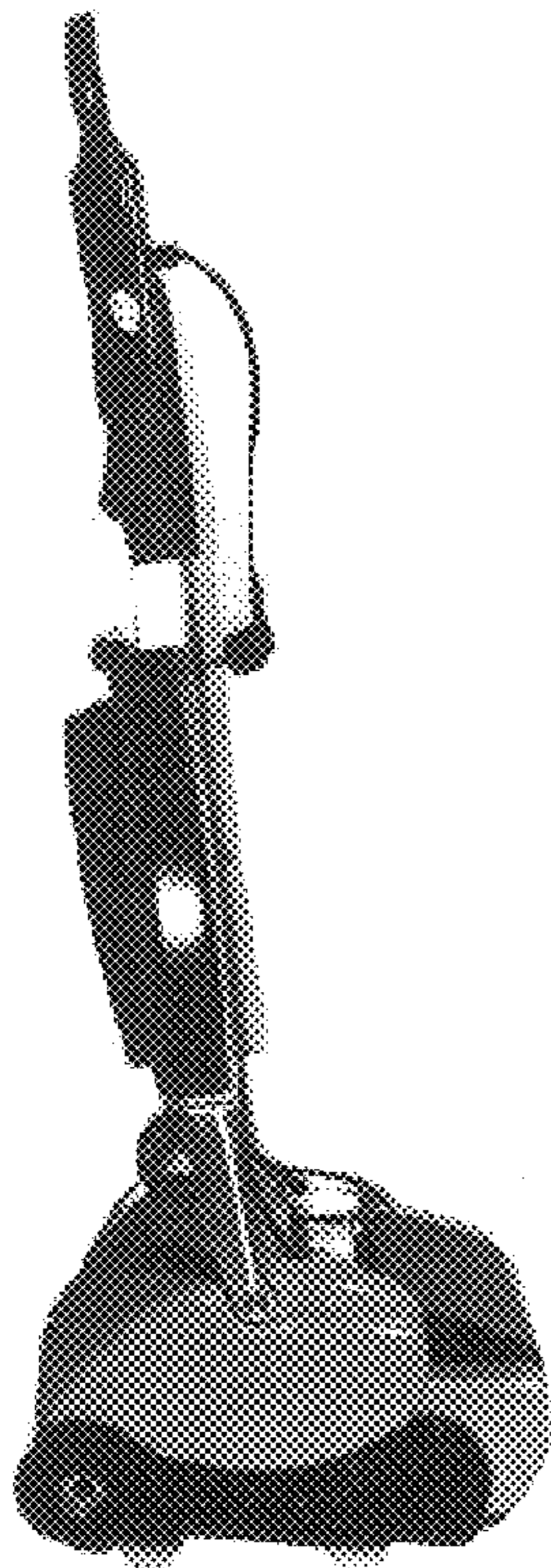

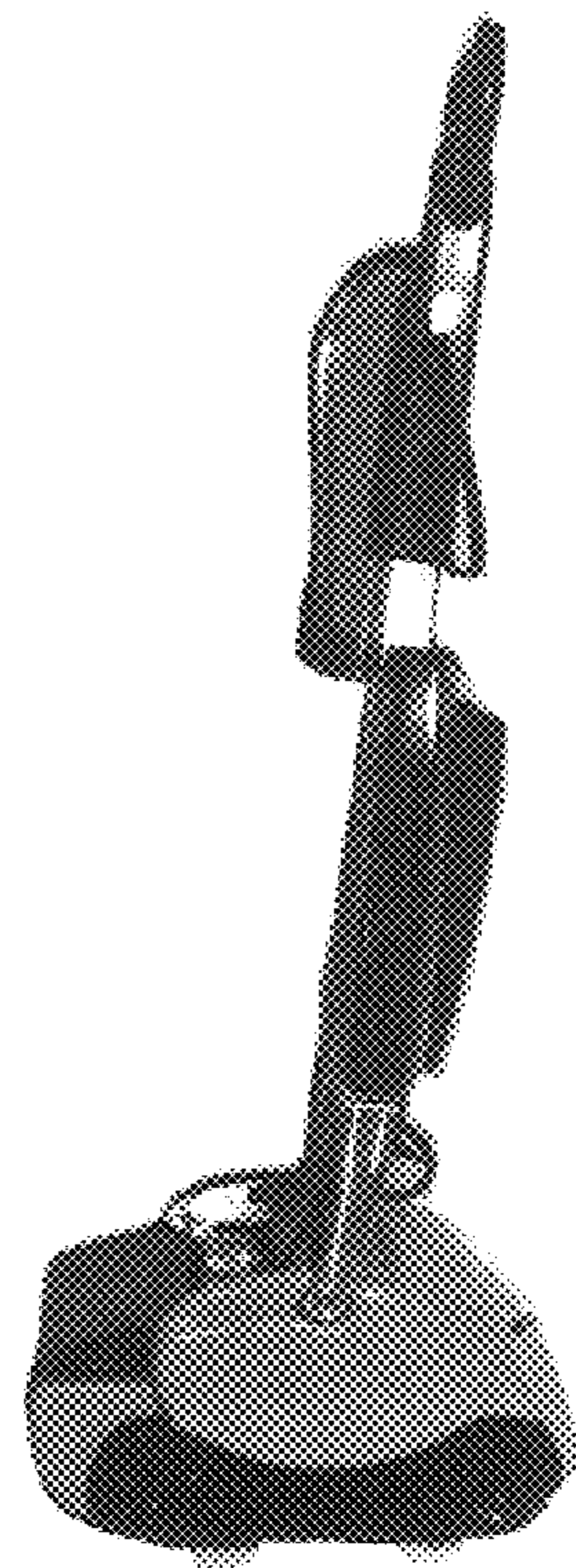

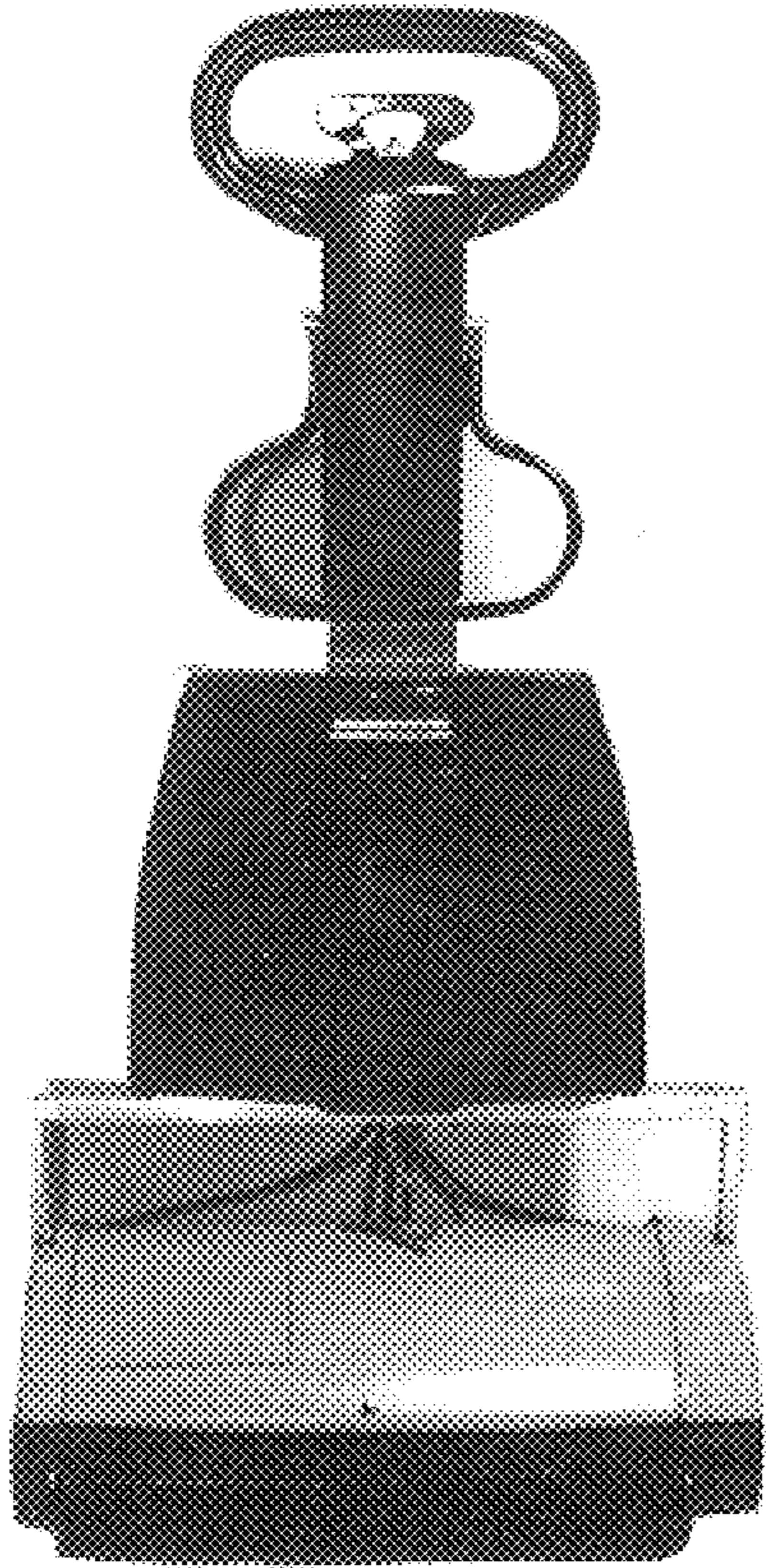

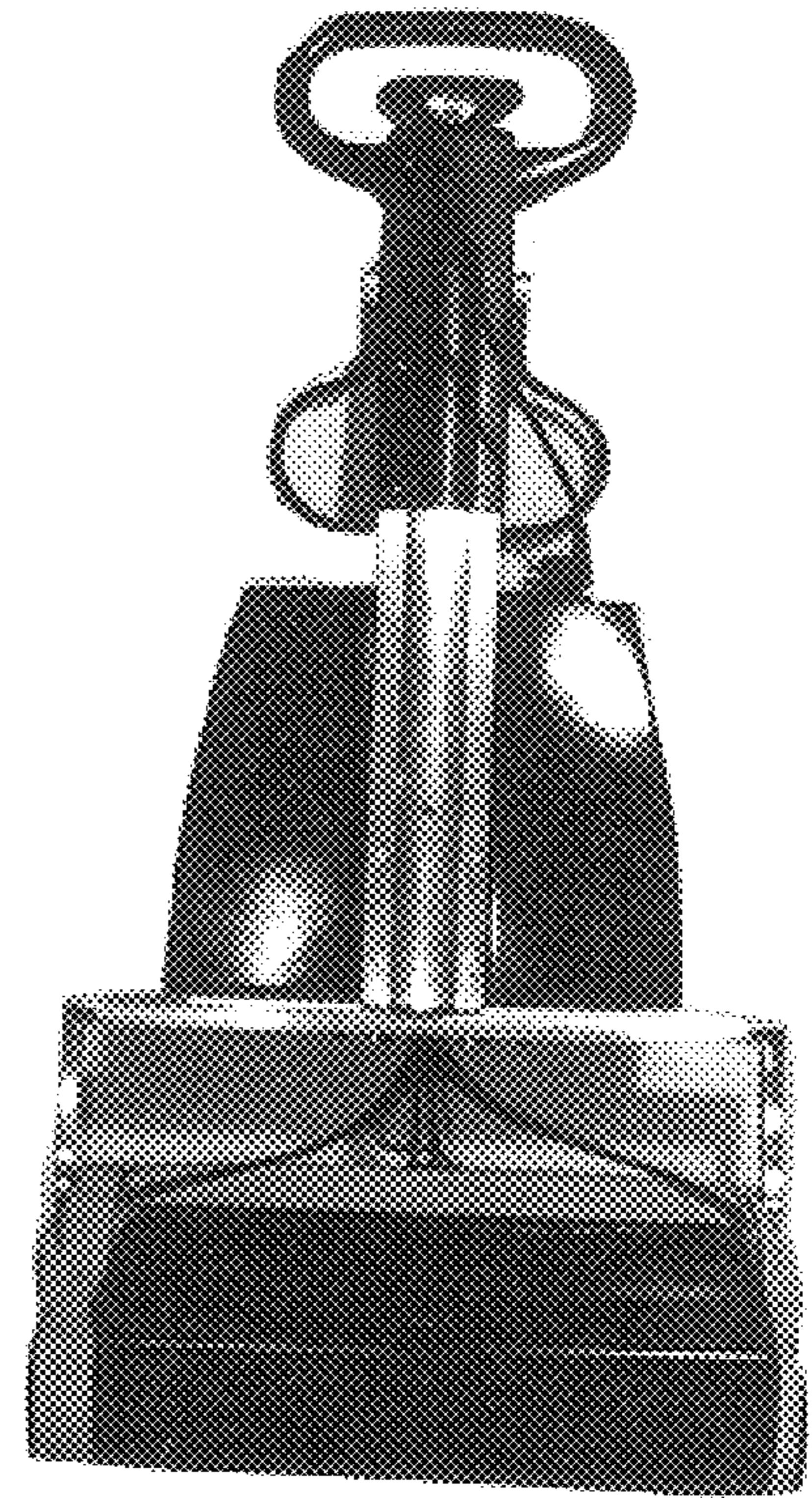

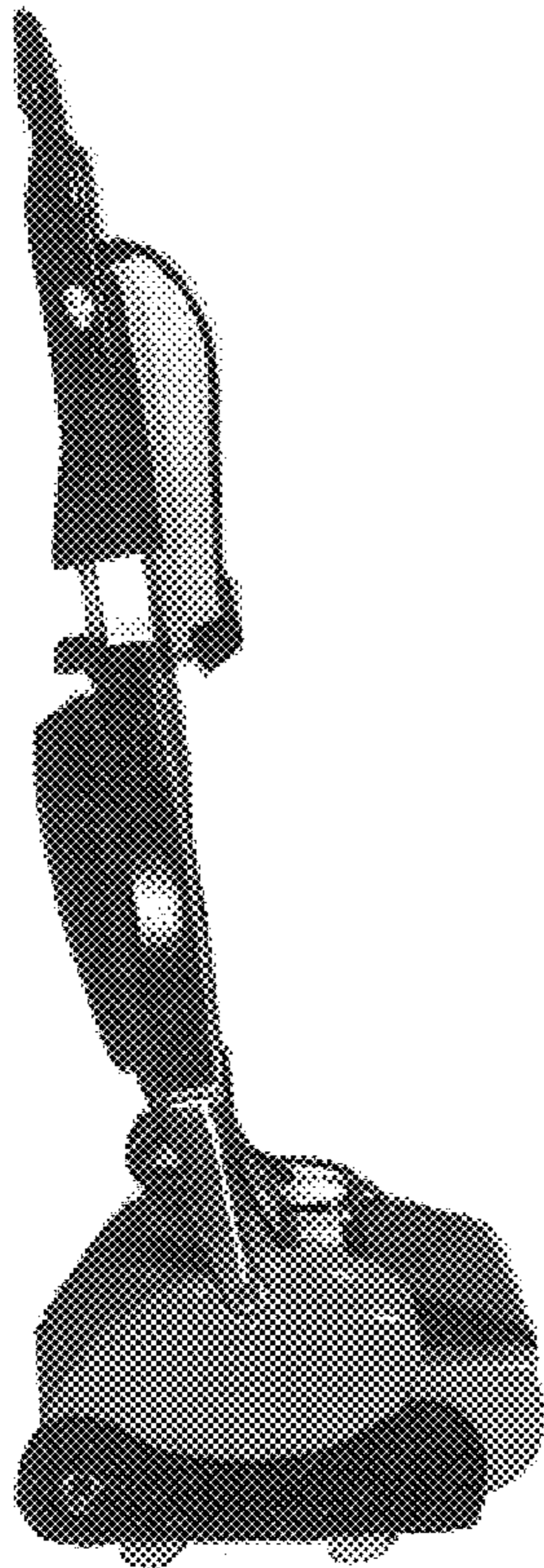

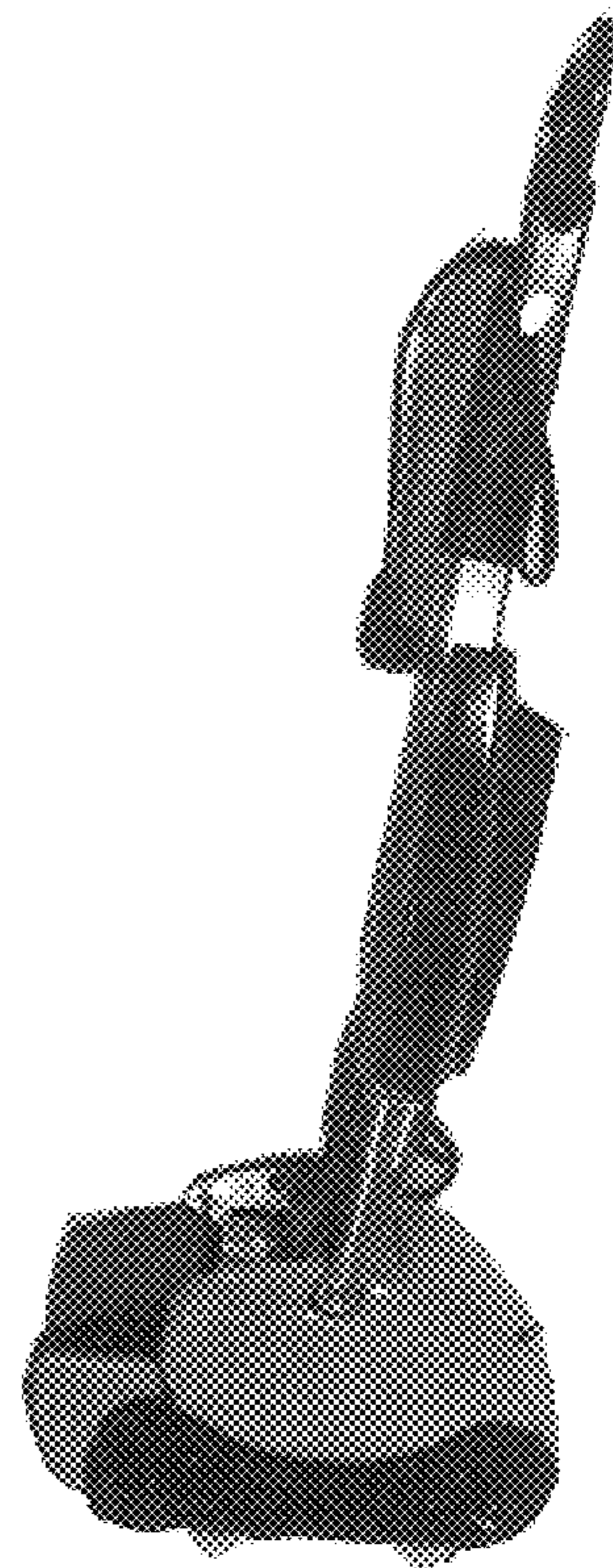
