The ornamental design for a domed dual fragrance bottle, as shown and described.

### DESCRIPTION

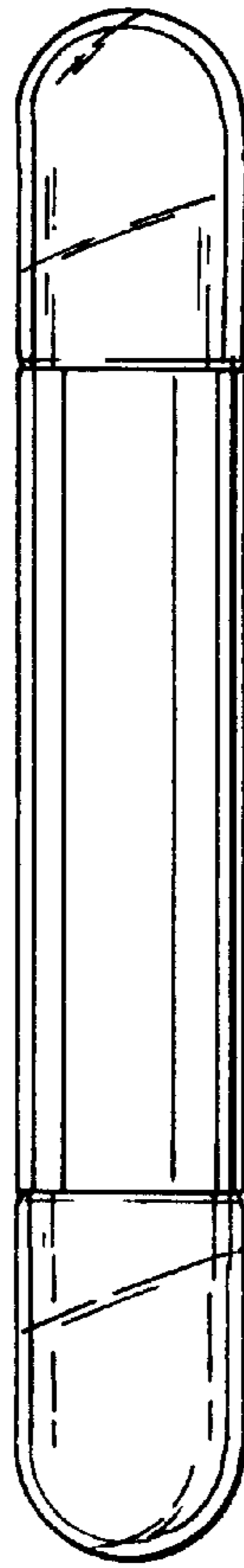
FIG. 1 is a perspective view of a domed dual fragrance bottle, showing our new design;

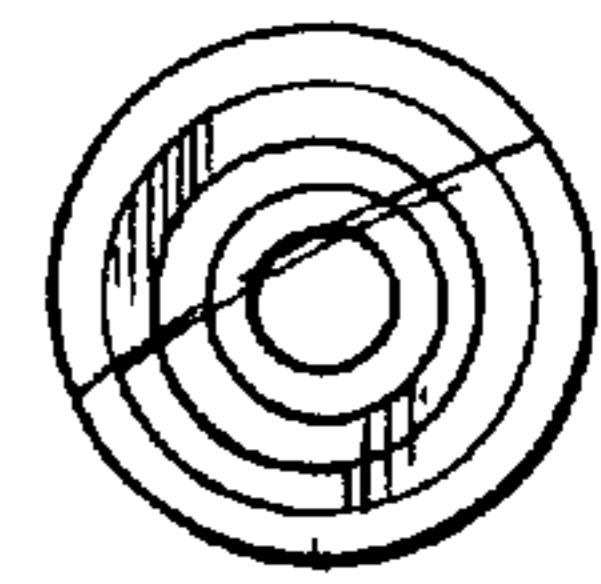
