[57] **CLAIM**

The ornamental design for a toy pickle character, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a toy pickle character with arms folded and lips together, showing my new design.

FIG. 2 is a front elevational view of the toy pickle character of FIG. 1.

FIG. 3 is a rear elevational view of the toy pickle character of FIG. 1.

FIG. 4 is a right side elevational view of the toy pickle character of FIG. 1.

FIG. 5 is a left side elevational view of the toy pickle character of FIG. 1.

FIG. 6 is a top plan view of the toy pickle character of FIG. 1.

FIG. 7 is a bottom plan view of the toy pickle character of FIG. 1.

FIG. 8 is a perspective view of another embodiment of the toy pickle character with arms outstretched and tongue extended, showing my new design.

FIG. 9 is a front elevational view of the toy pickle character of FIG. 8.

FIG. 10 is a rear elevational view of the toy pickle character of FIG. 8.

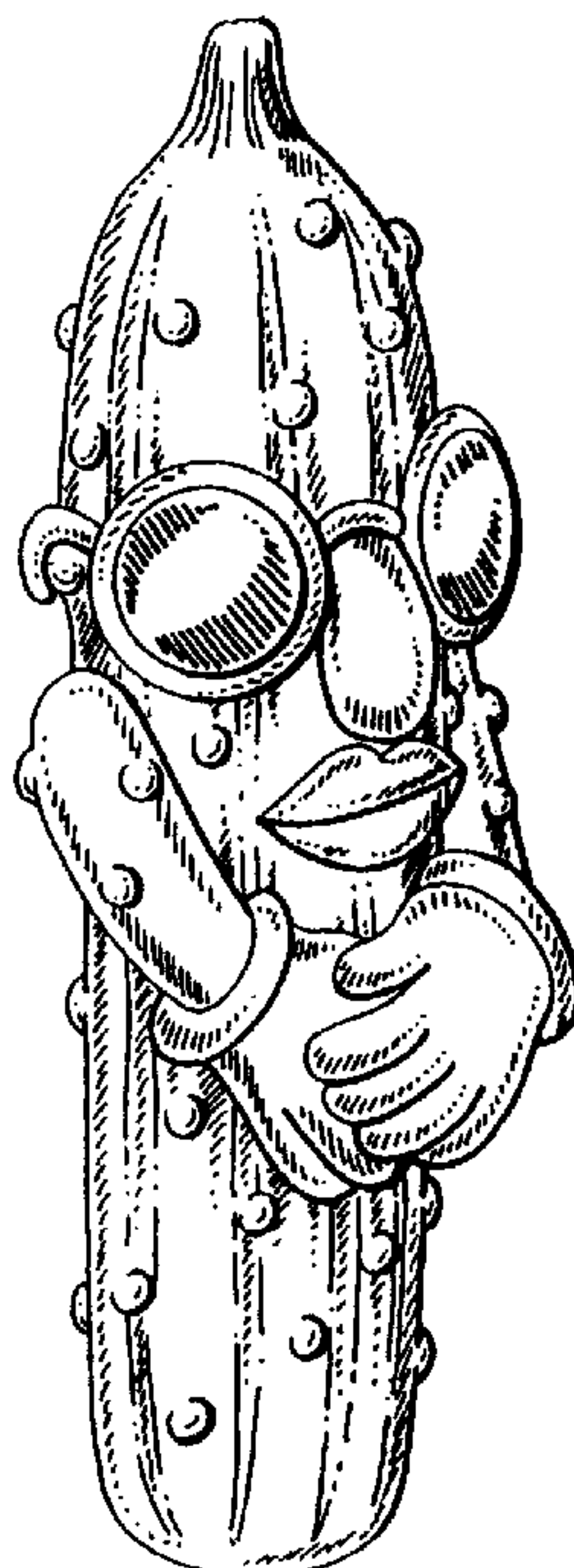
FIG. 11 is a right side elevational view of the toy pickle character of FIG. 8.

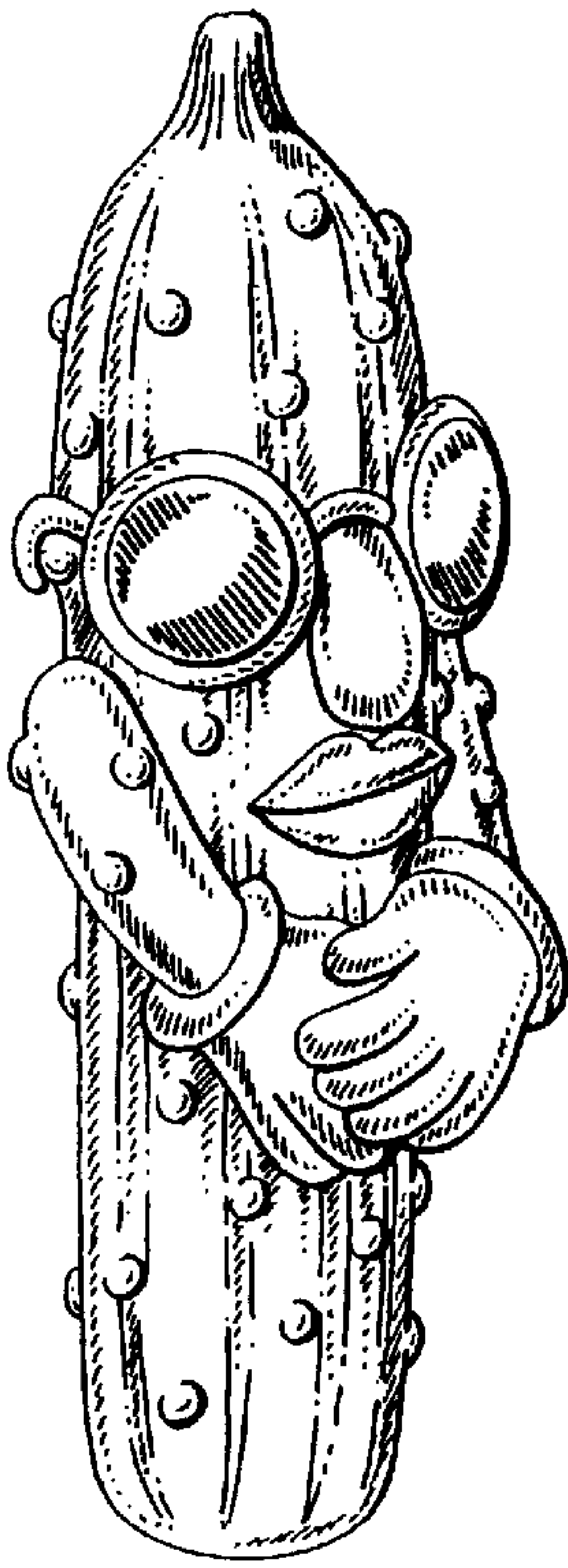

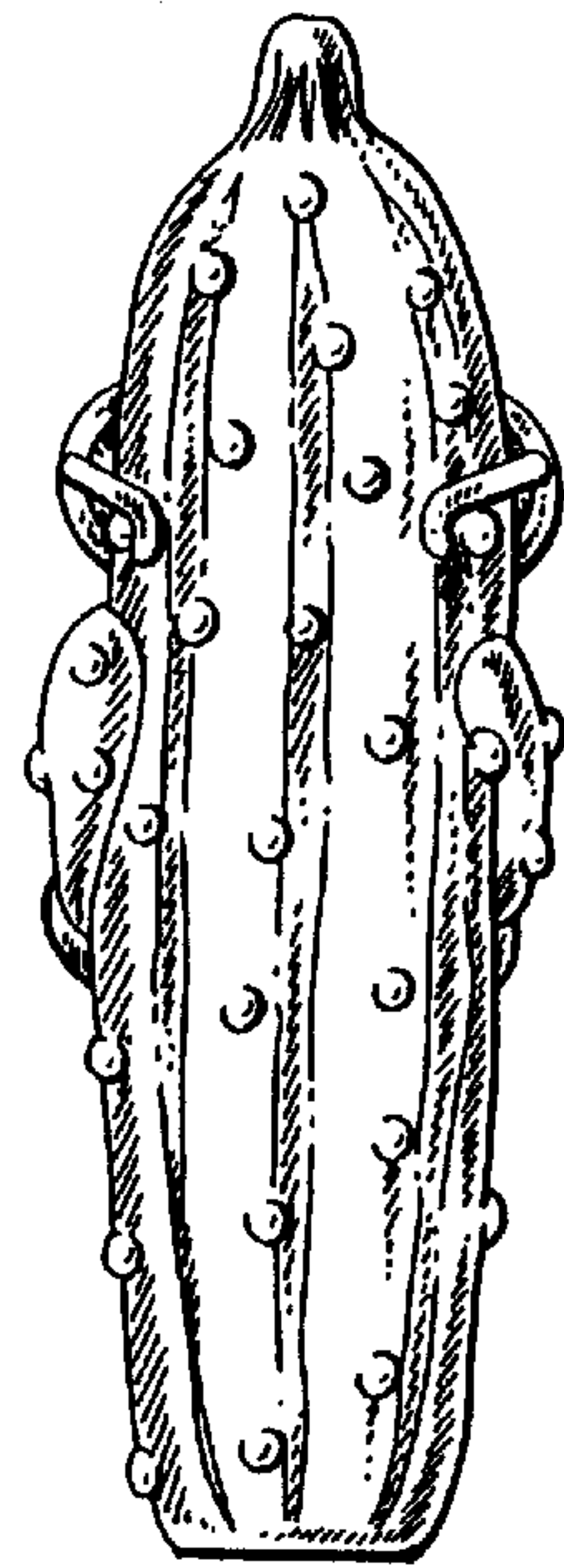

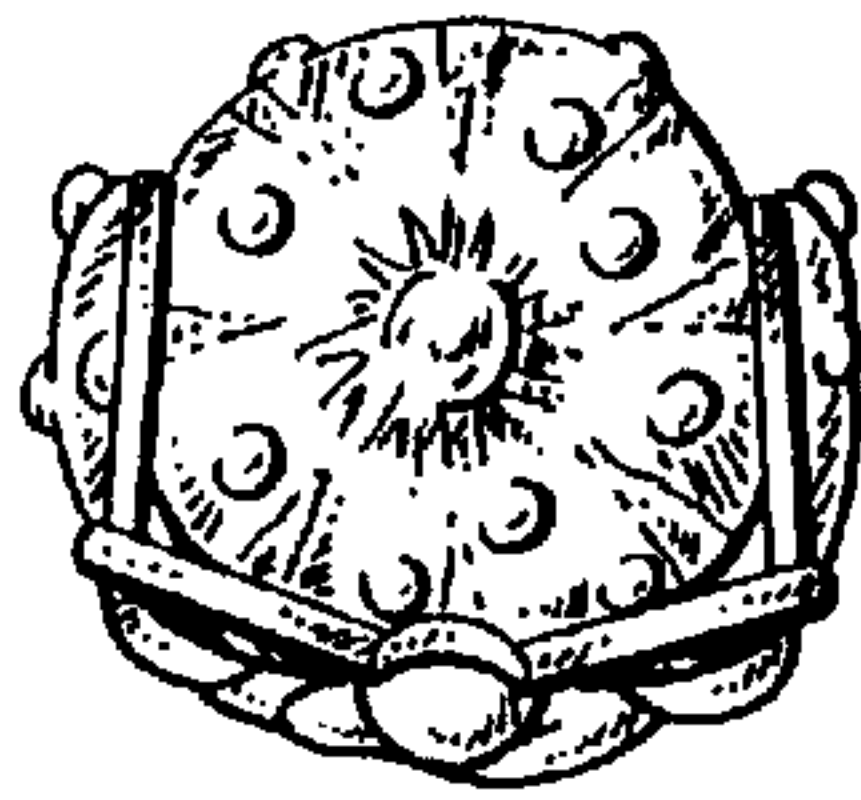

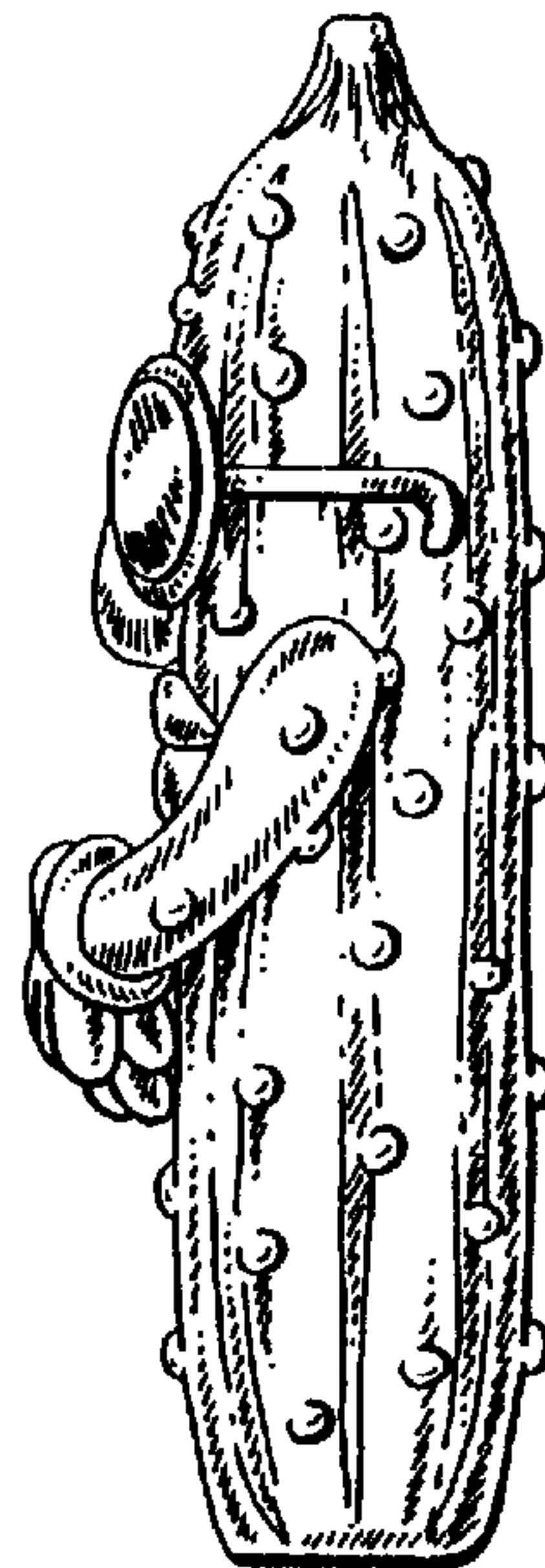

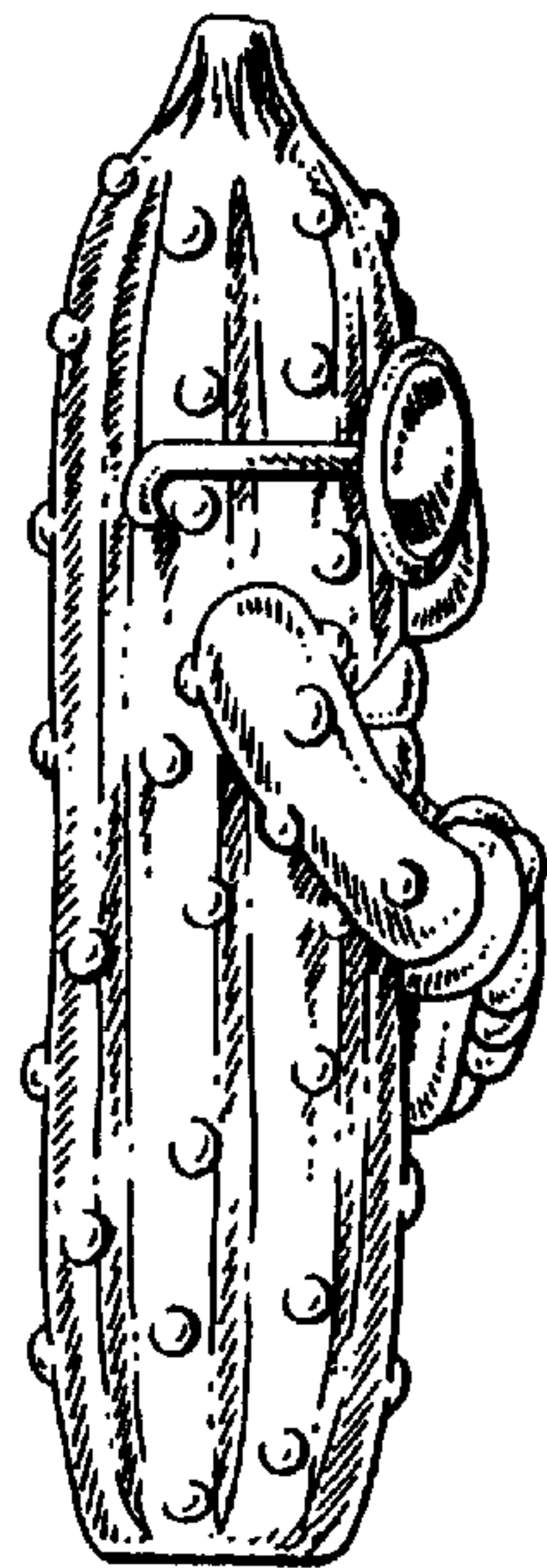

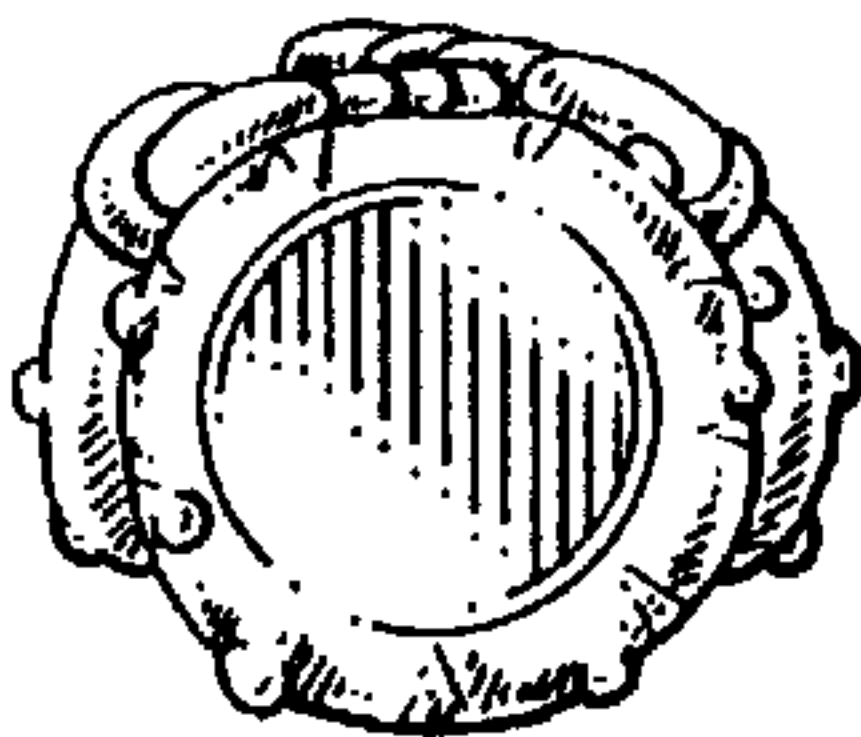
