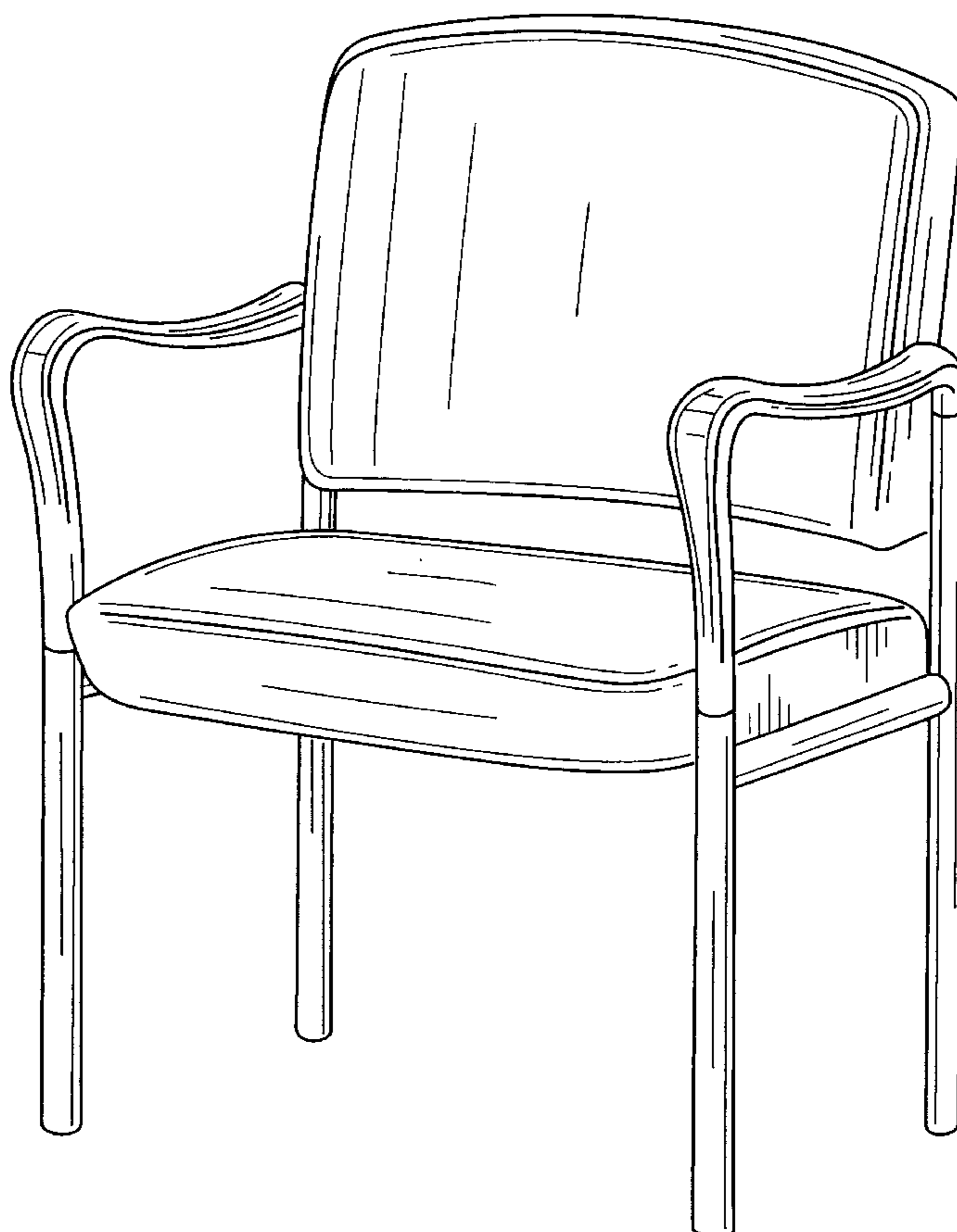
[57] **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chair showing my new design;
 FIG. 2 is a right side view thereof, the left side being a mirror image;
 FIG. 3 is a front view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a perspective view of a second embodiment of my new design;
 FIG. 6 is a front view thereof;
 FIG. 7 is a perspective view of a third embodiment of my new design; and,
 FIG. 8 is a perspective view of a fourth embodiment of my new design.
 The rear view of each embodiment has not been shown and forms no part of the claimed design.
 The opposite ends of FIGS. 5, 7 and 8 are mirror images of what has been shown.

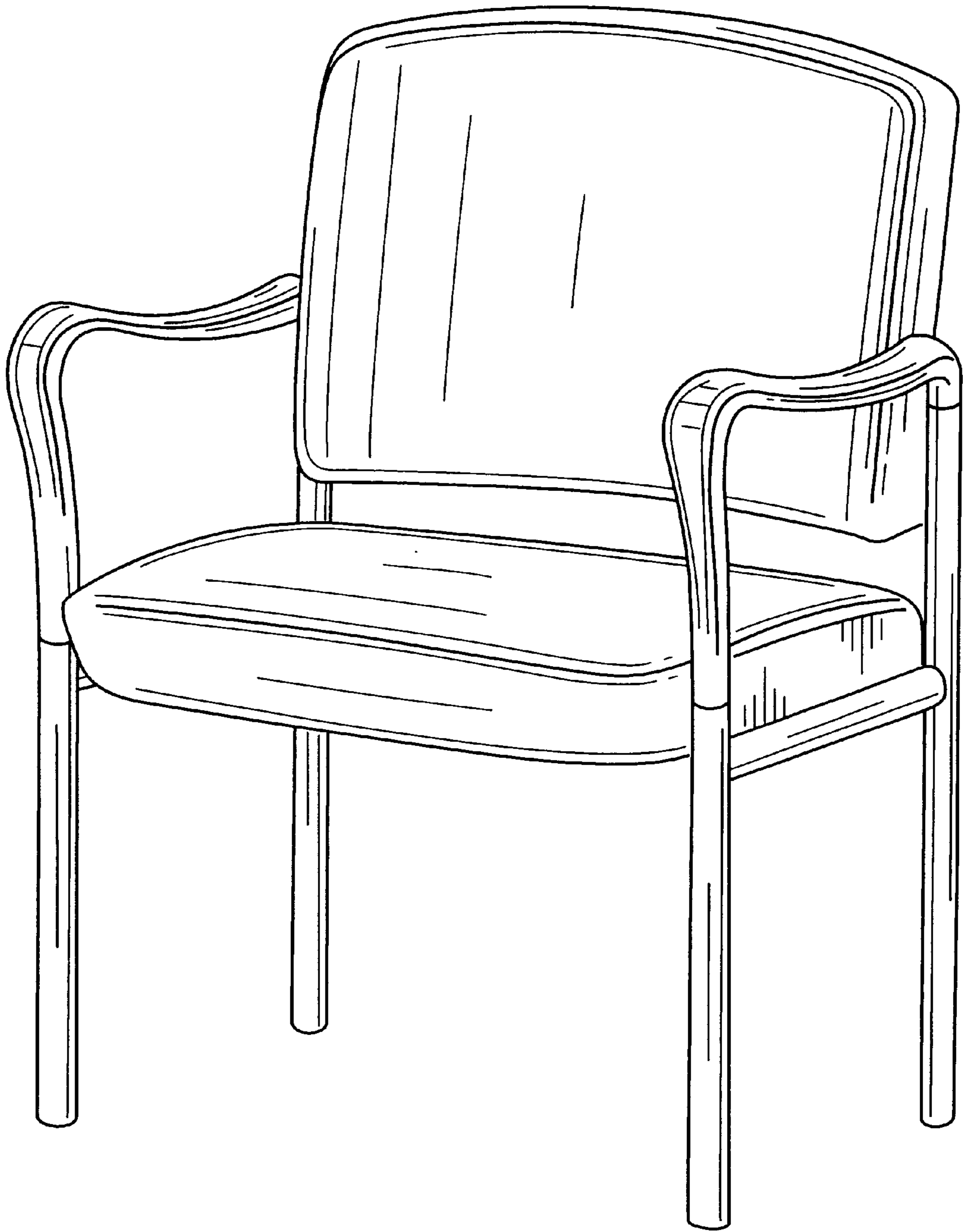

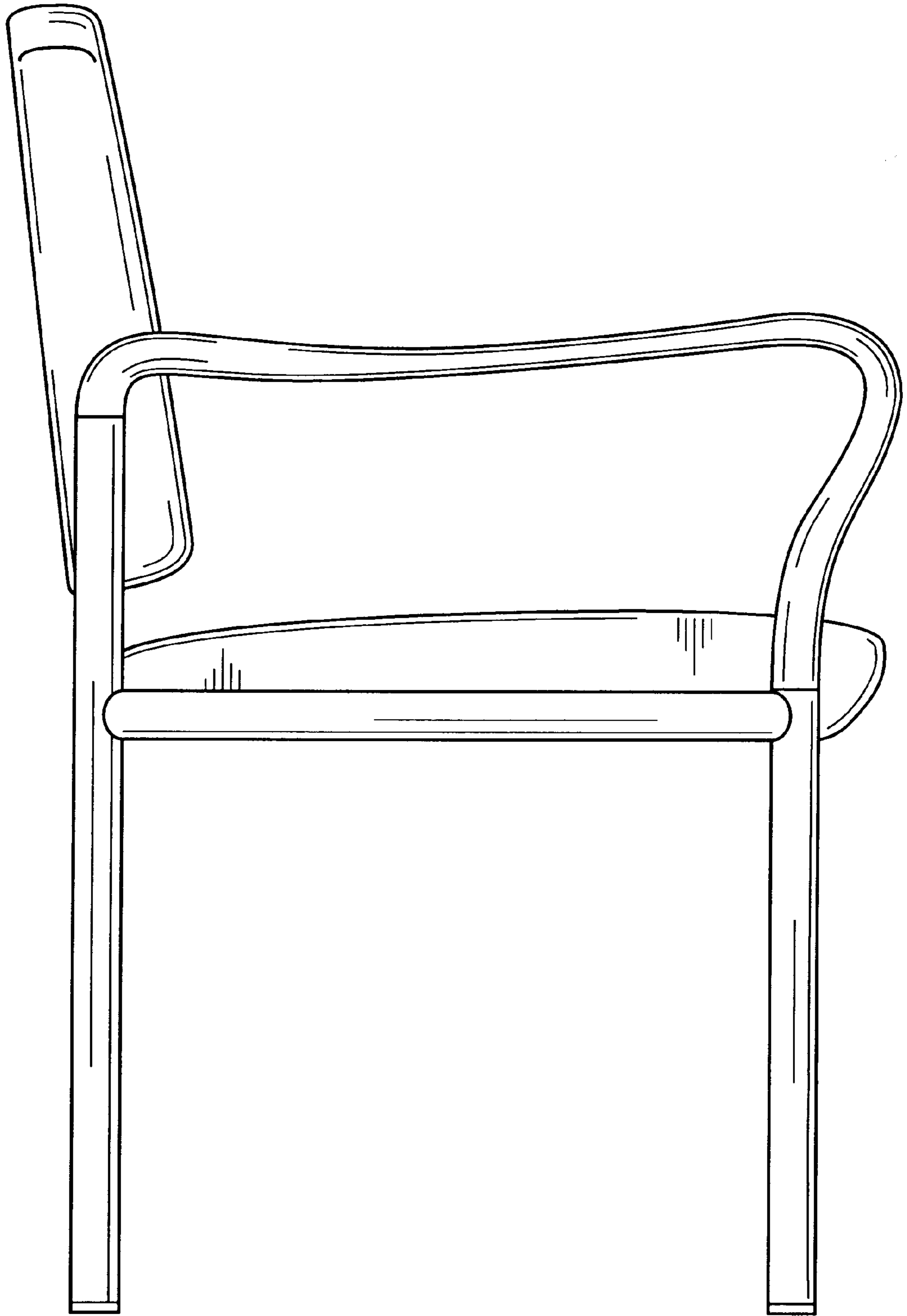

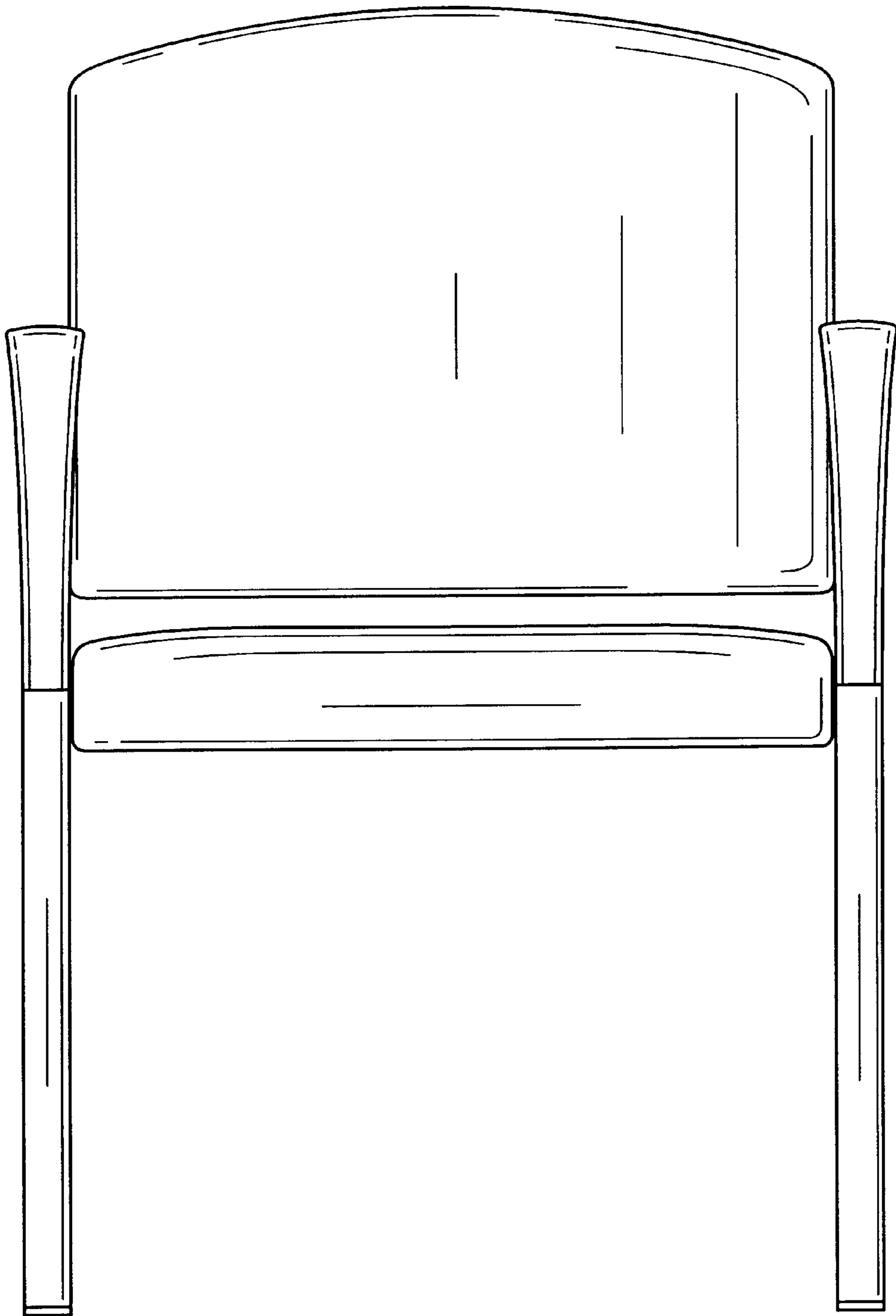

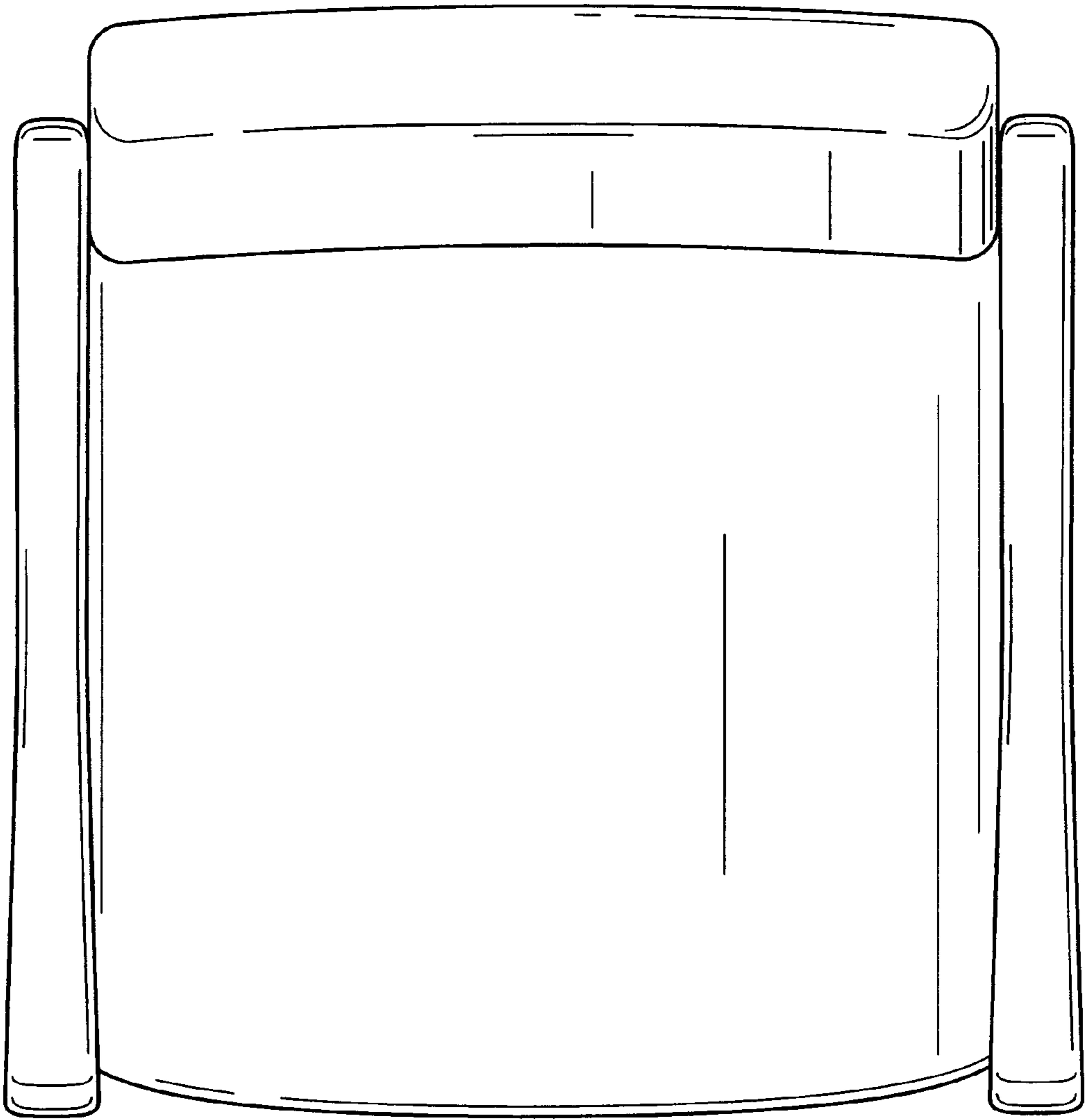

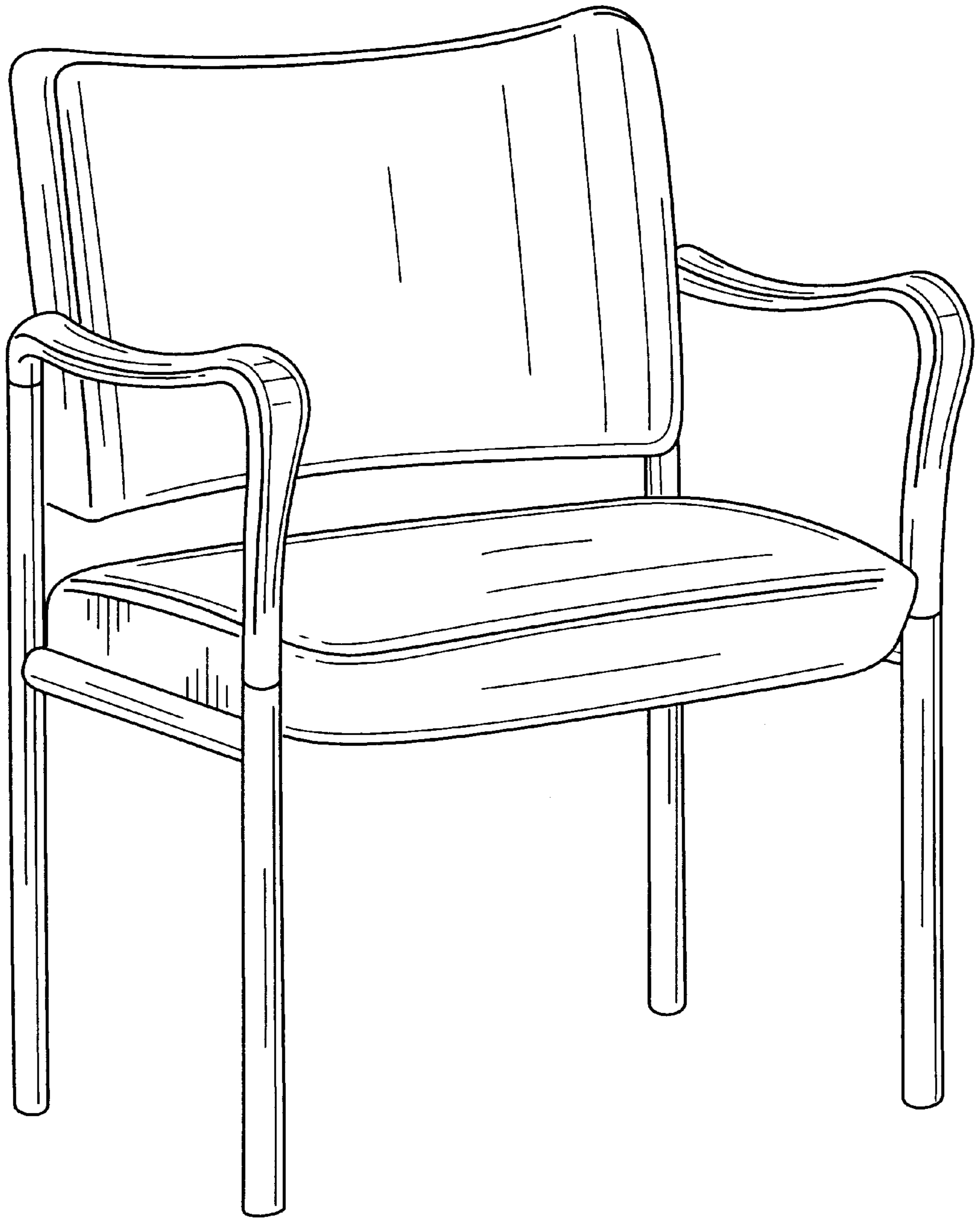

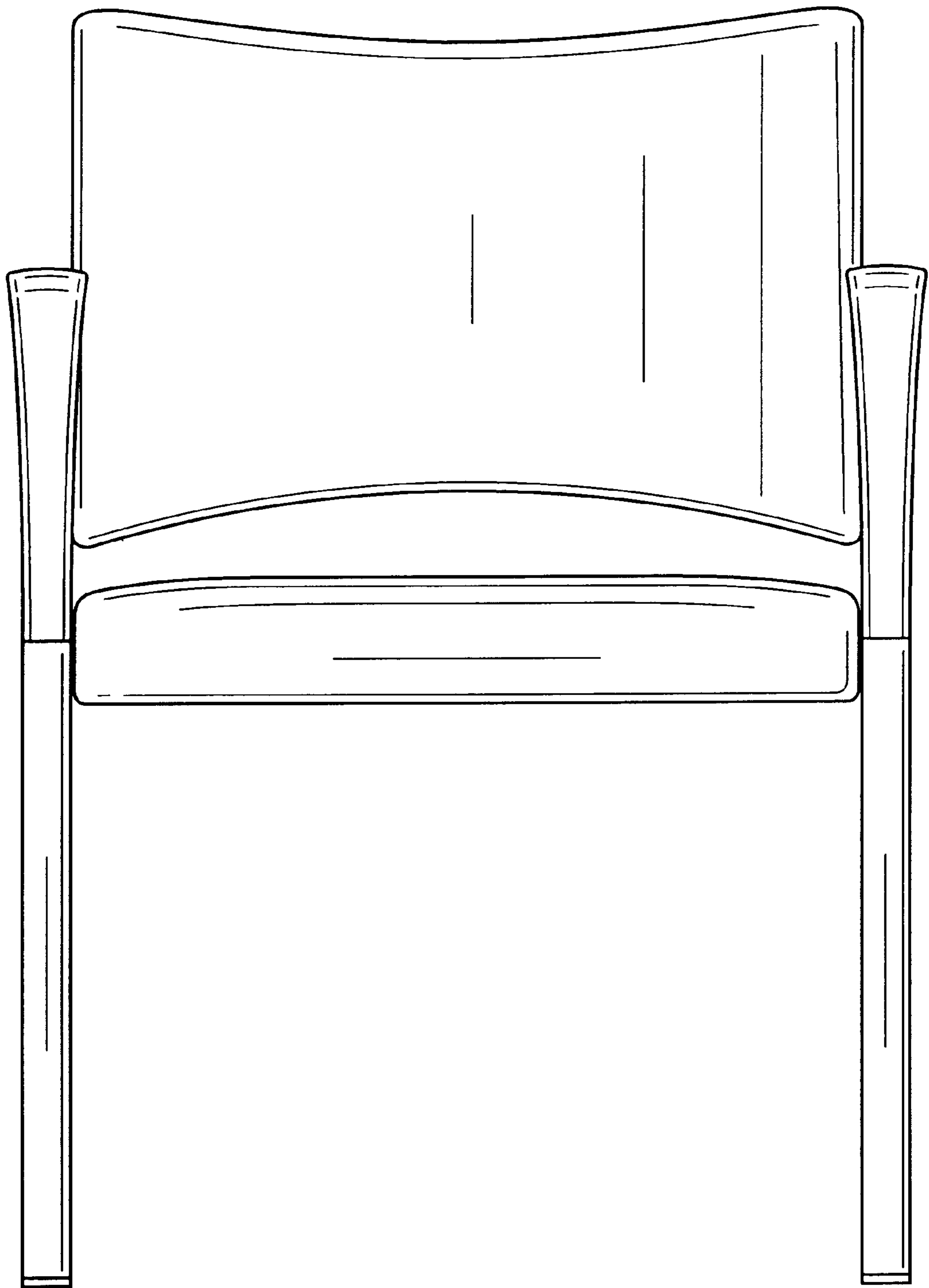

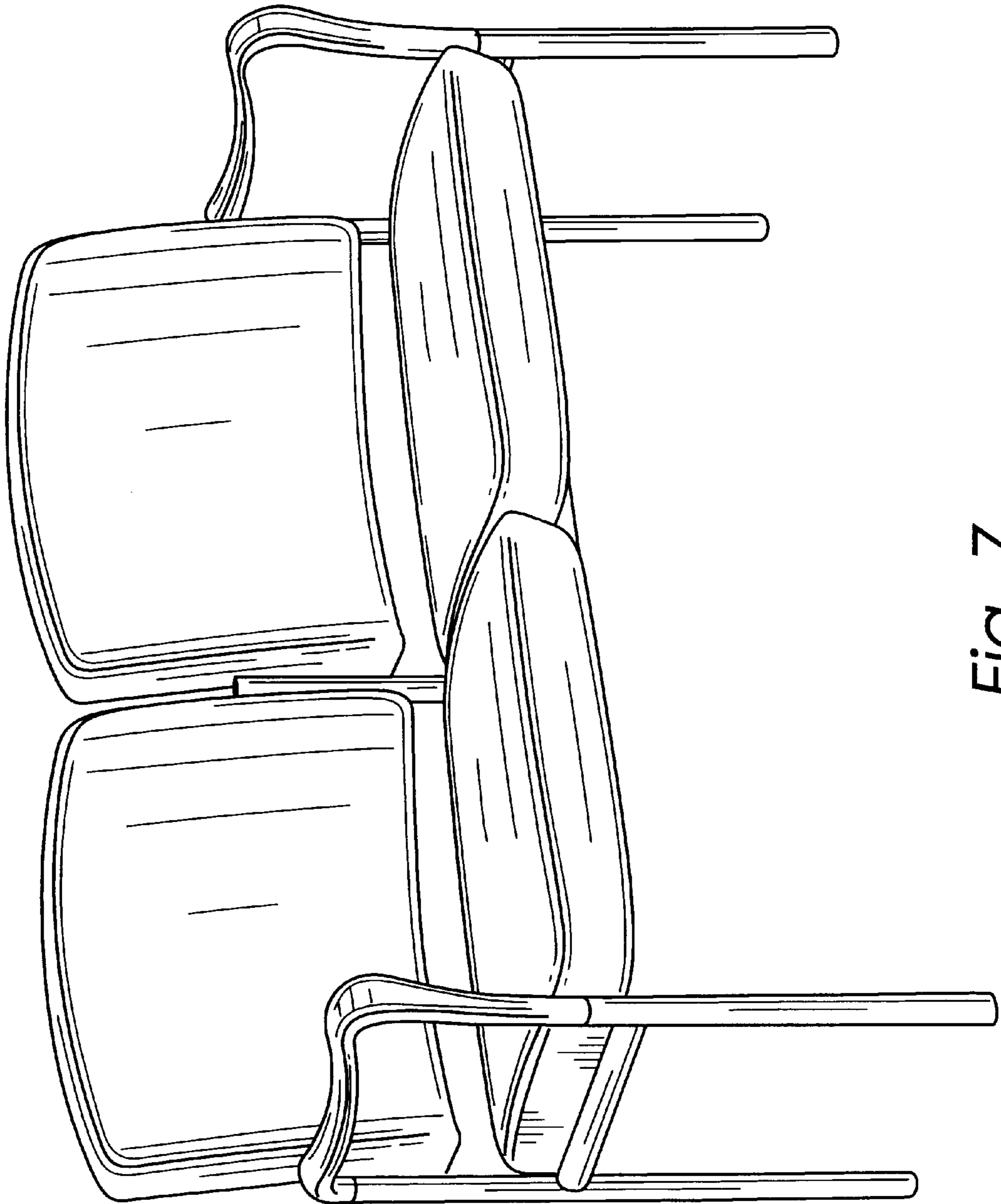

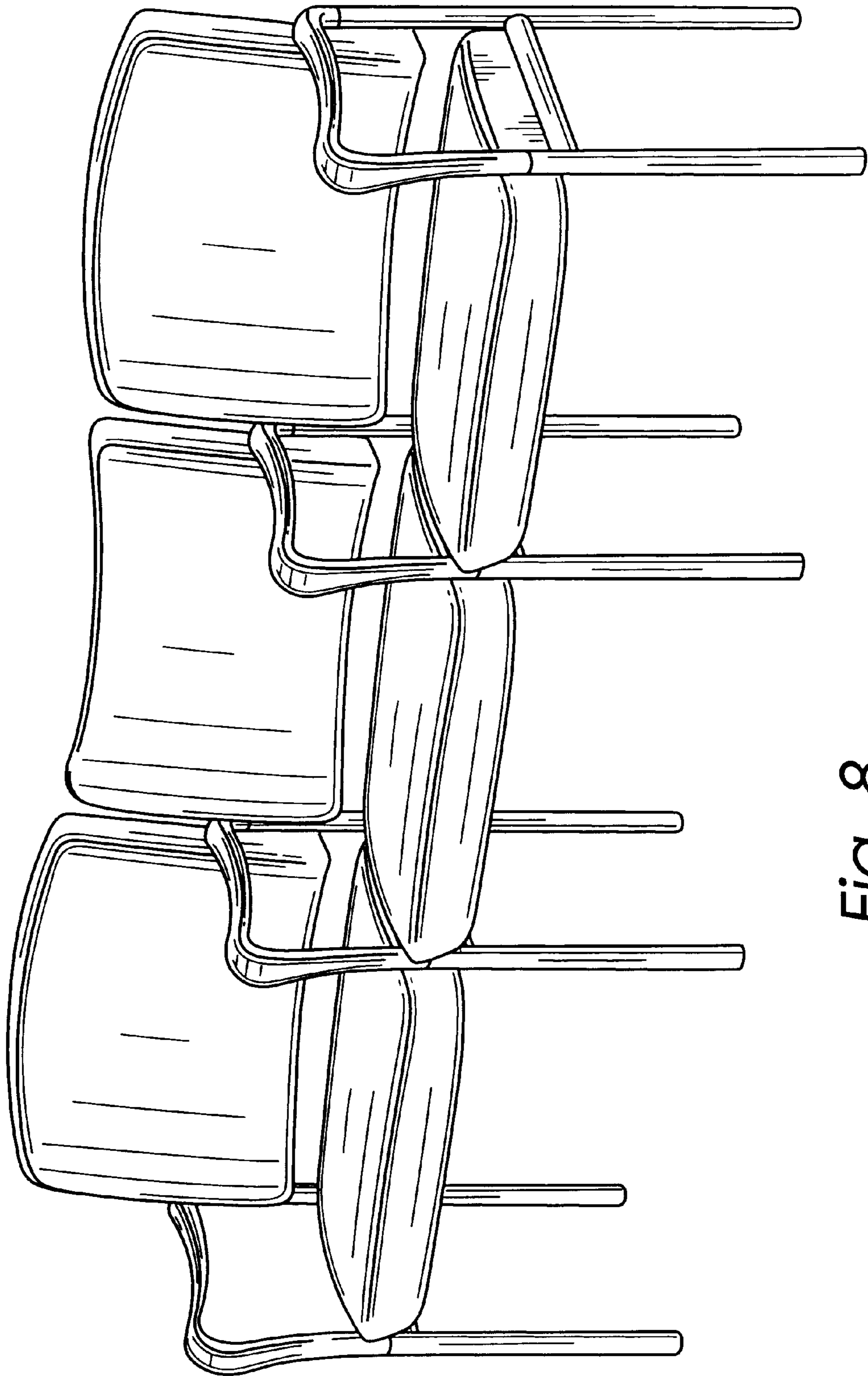
