### [57] CLAIM

The ornamental design for a garlic press, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the inventive design for a garlic press and cleaning tool;

FIG. 2 is a top plan view of the FIG. 1 garlic press and cleaning tool;

FIG. 3 is a right side (relative to FIG. 1) elevational view of the FIG. 1 garlic press and cleaning tool;

FIG. 4 is a left side (relative to FIG. 1) elevational view of the FIG. 1 garlic press and cleaning tool;

FIG. 5 is a front side (relative to FIG. 1) elevational view of the FIG. 1 garlic press and cleaning tool;

FIG. 6 is a back side (relative to FIG. 1) elevational view of the FIG. 1 garlic press and cleaning tool;

FIG. 7 is a bottom plan view of the FIG. 1 garlic press and cleaning tool;

FIG. 8 is a top plan view of the garlic press of FIG. 1;

FIG. 9 is a right side (relative to FIG. 8) elevational view of the garlic press of FIG. 1;

FIG. 10 is a left side (relative to FIG. 8) elevational view of the garlic press of FIG. 1;

FIG. 11 is a front side (relative to FIG. 8) elevational view of the garlic press of FIG. 1;

FIG. 12 is a back side (relative to FIG. 8) elevational view of the garlic press of FIG. 1;

FIG. 13 is a bottom plan view (relative to FIG. 8) of the garlic press of FIG. 1;

FIG. 14 is a top plan view of the cleaning tool of FIG. 1;

FIG. 15 is a right side (relative to FIG. 14) elevational view of the cleaning tool of FIG. 1;

FIG. 16 is a left side (relative to FIG. 14) elevational view of the cleaning tool of FIG. 1;

FIG. 17 is a front side (relative to FIG. 14) elevational view of the cleaning tool of FIG. 1;

FIG. 18 is a bottom plan view (relative to FIG. 14) of the cleaning tool of FIG. 1; and,

FIG. 19 is a back side (relative to FIG. 14) elevational view of the cleaning tool of FIG. 1.

The garlic press and cleaning tool are shown separately in FIGS. 8–13 and 14–19, respectively, for clarity of illustration.

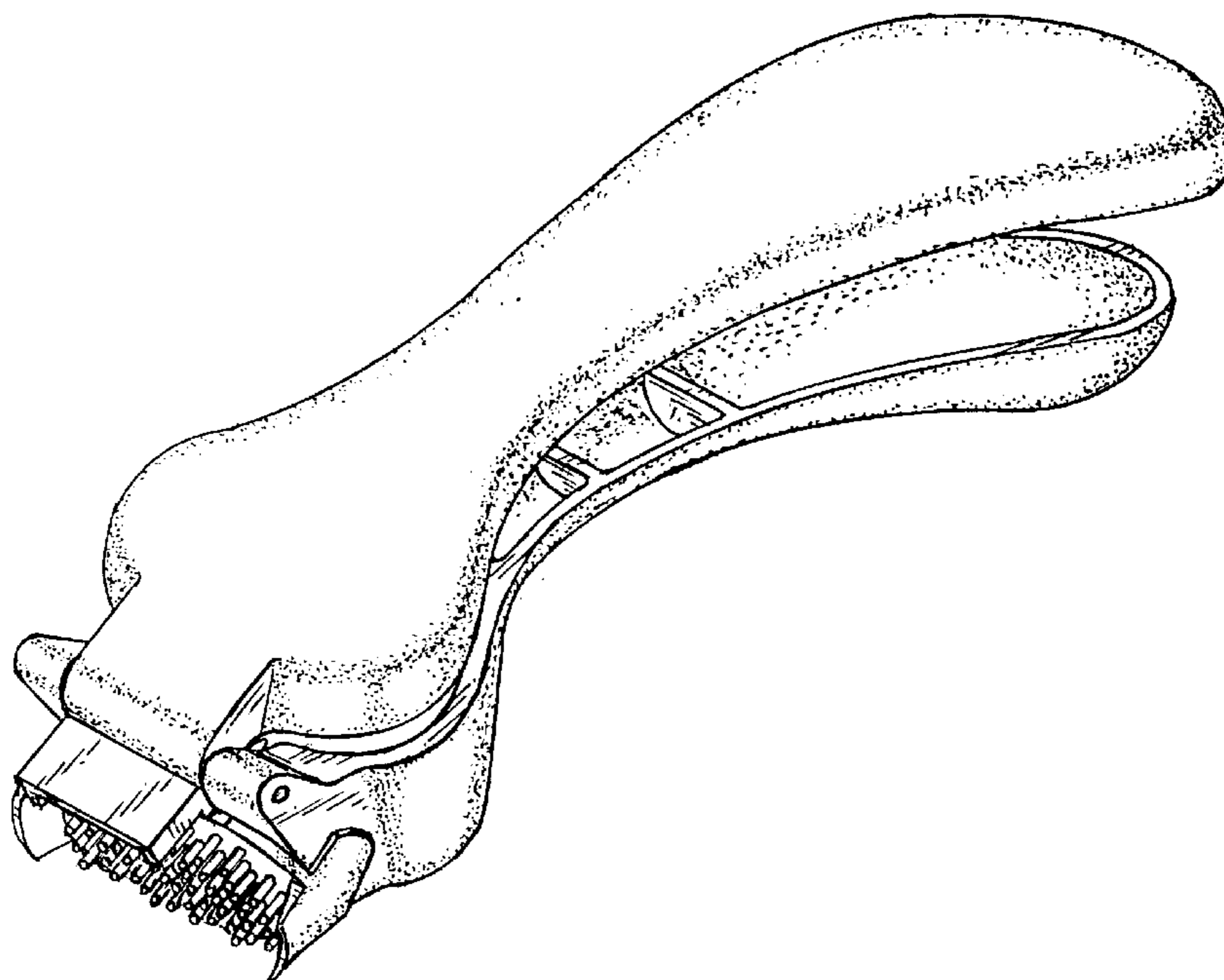

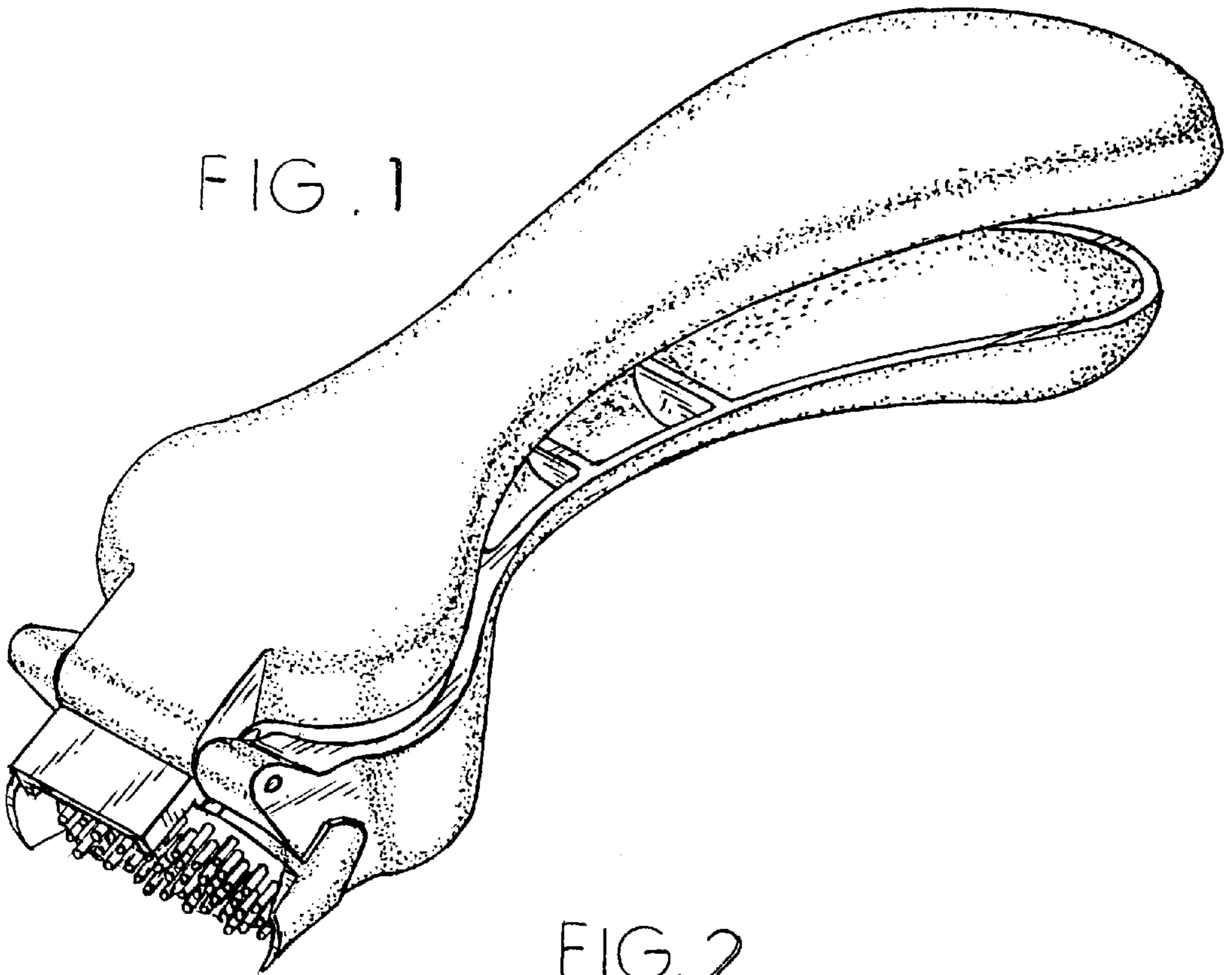

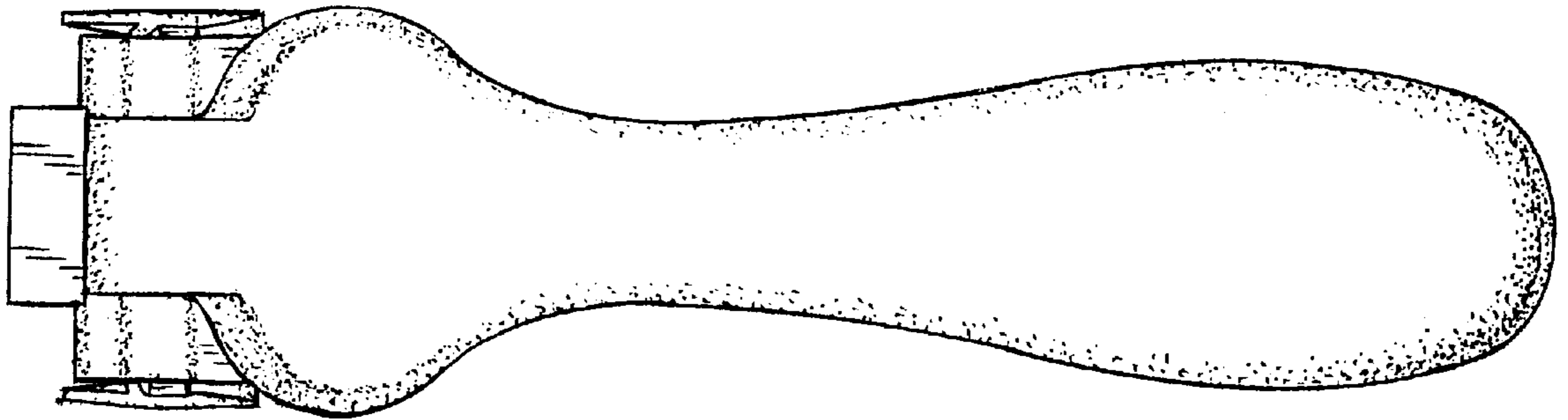

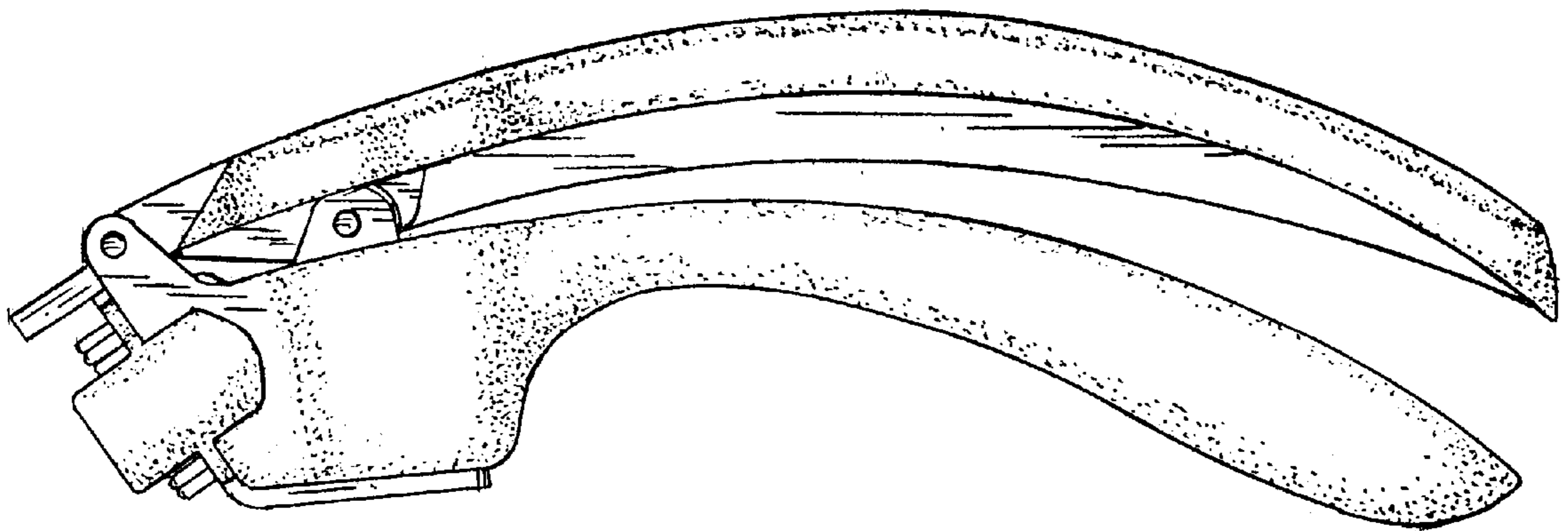

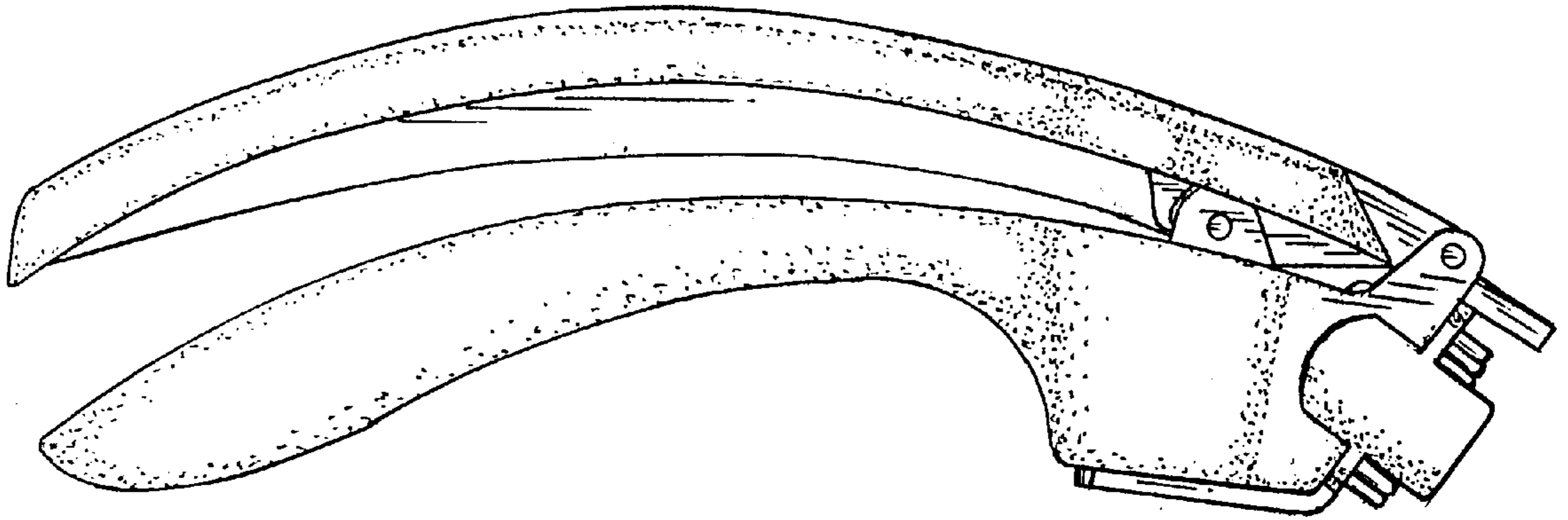

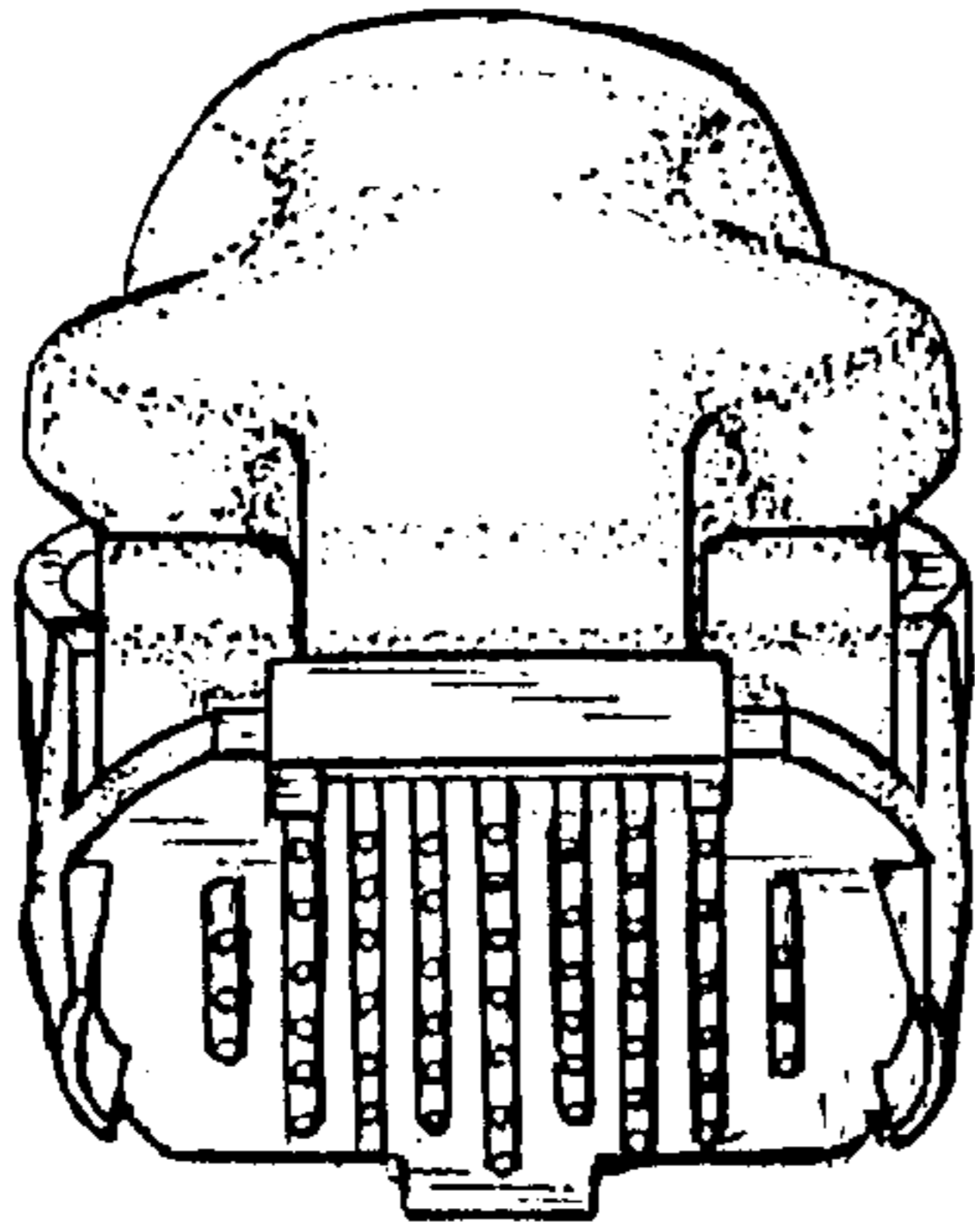

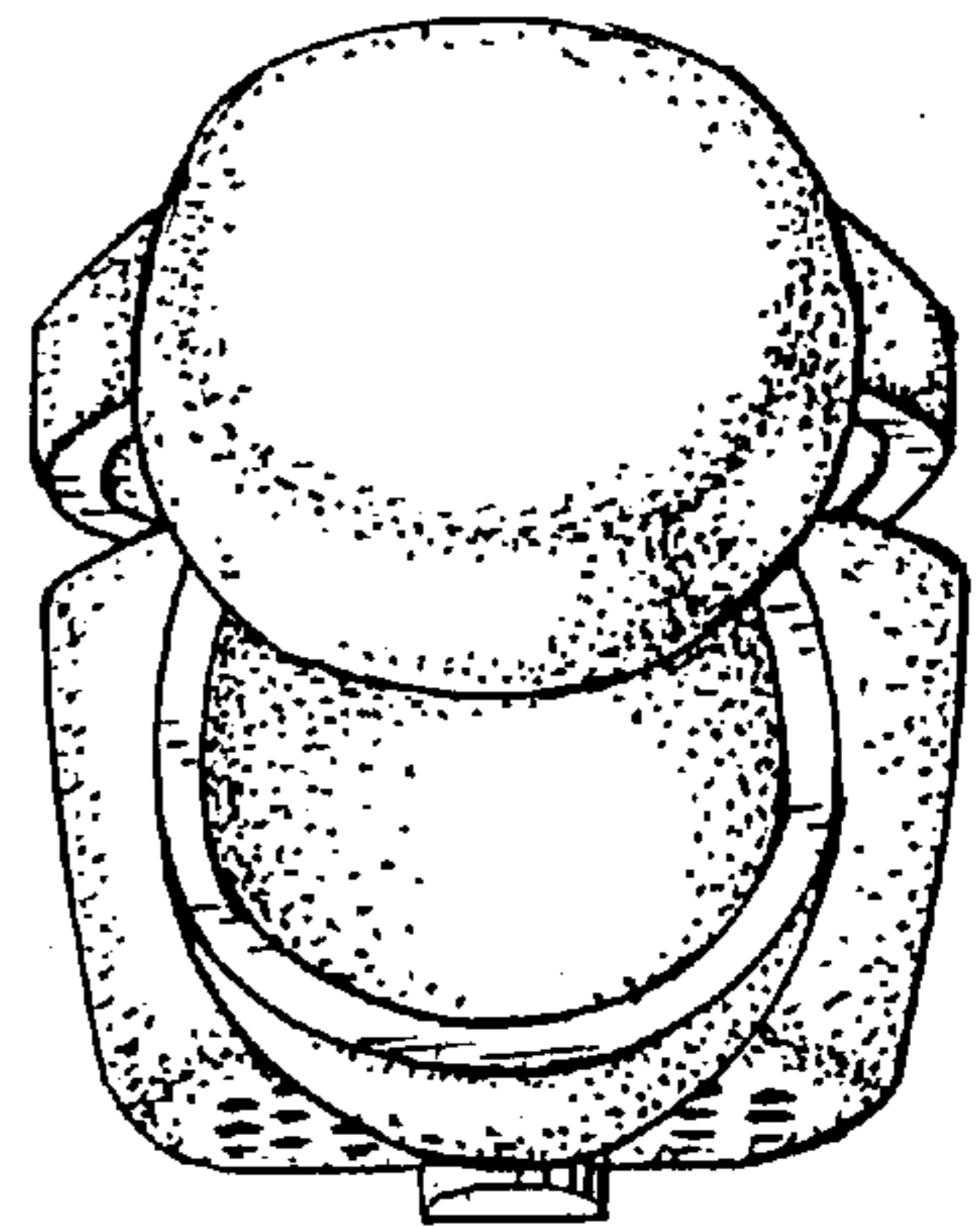

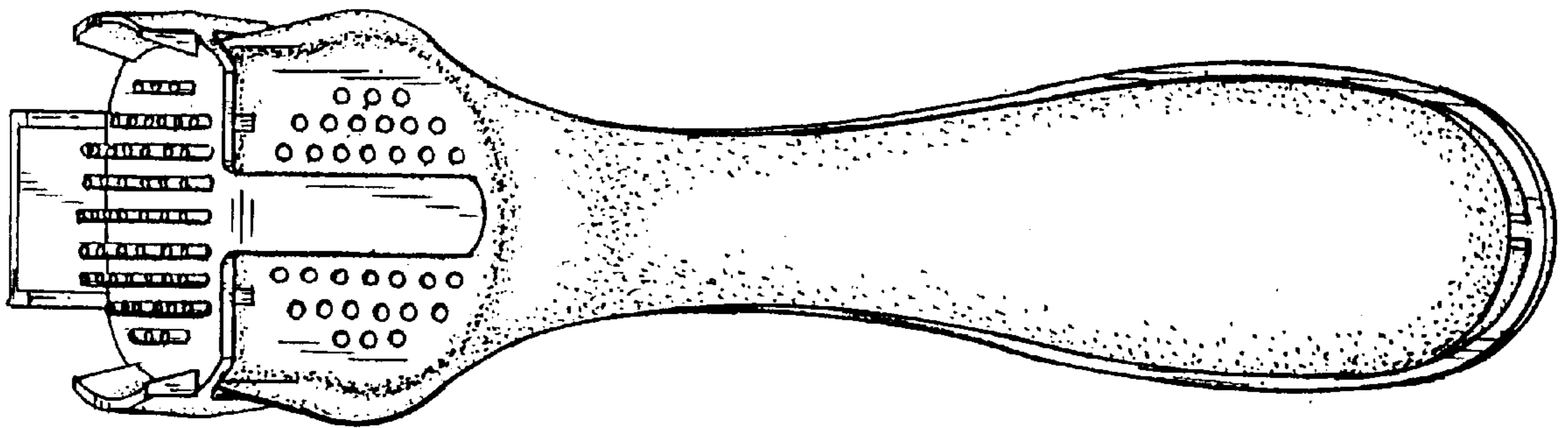

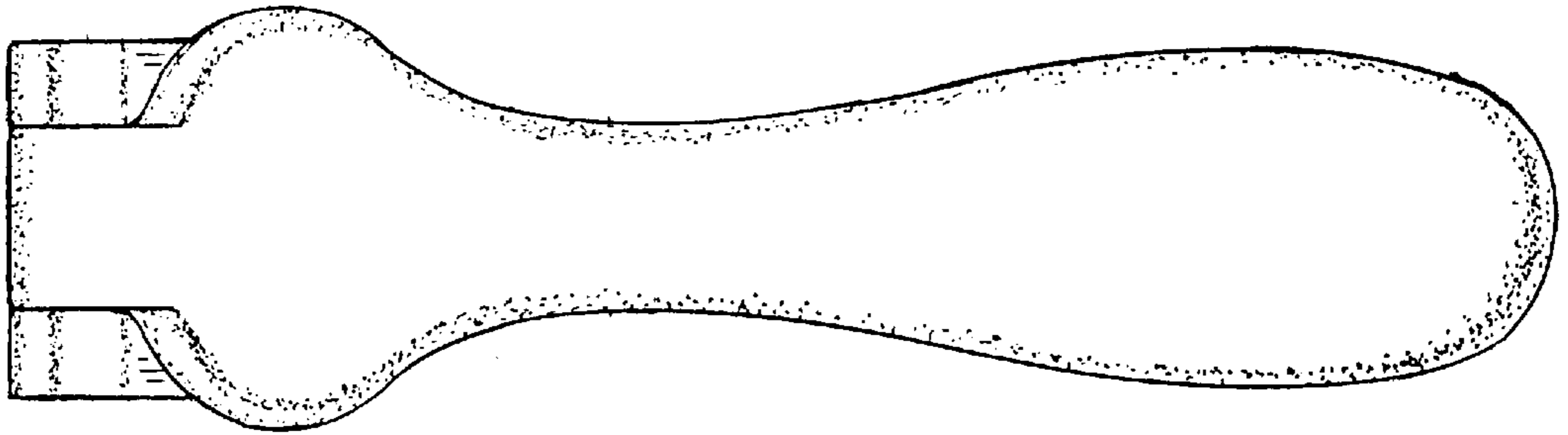

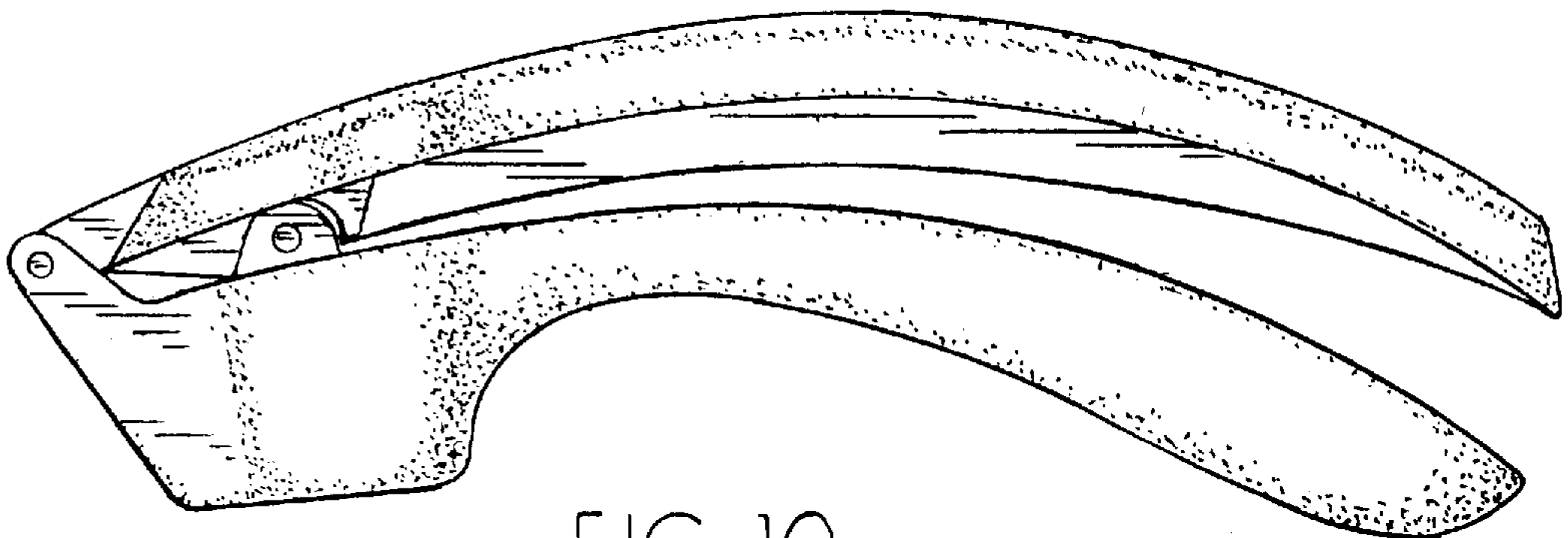

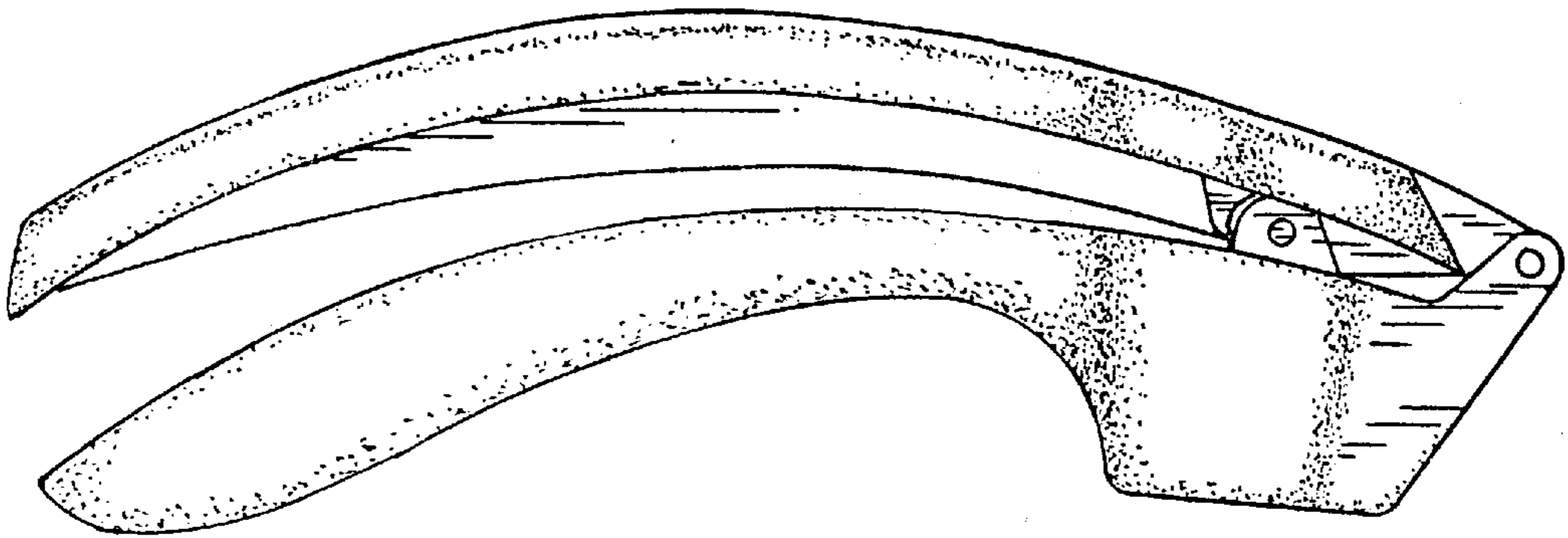

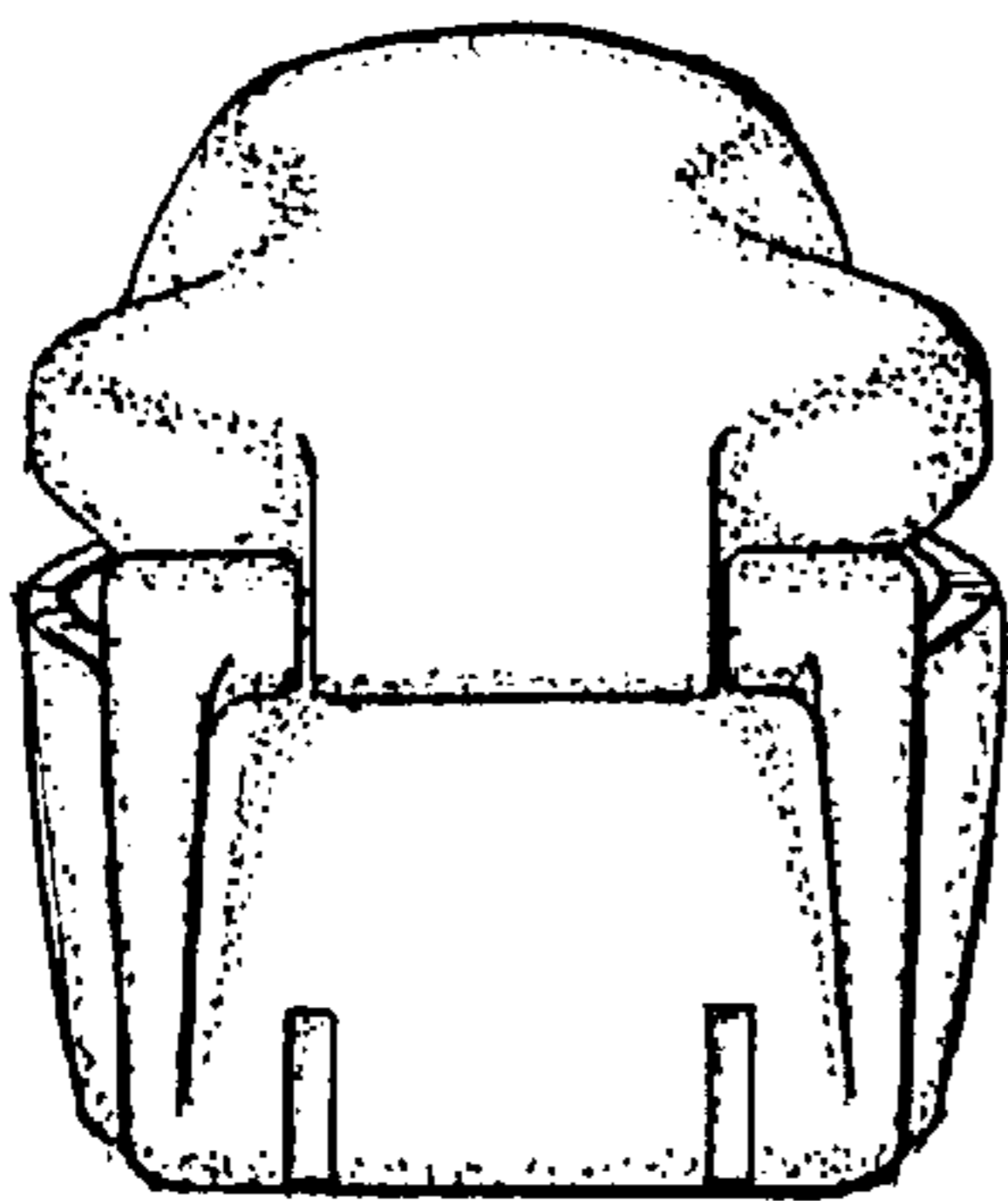

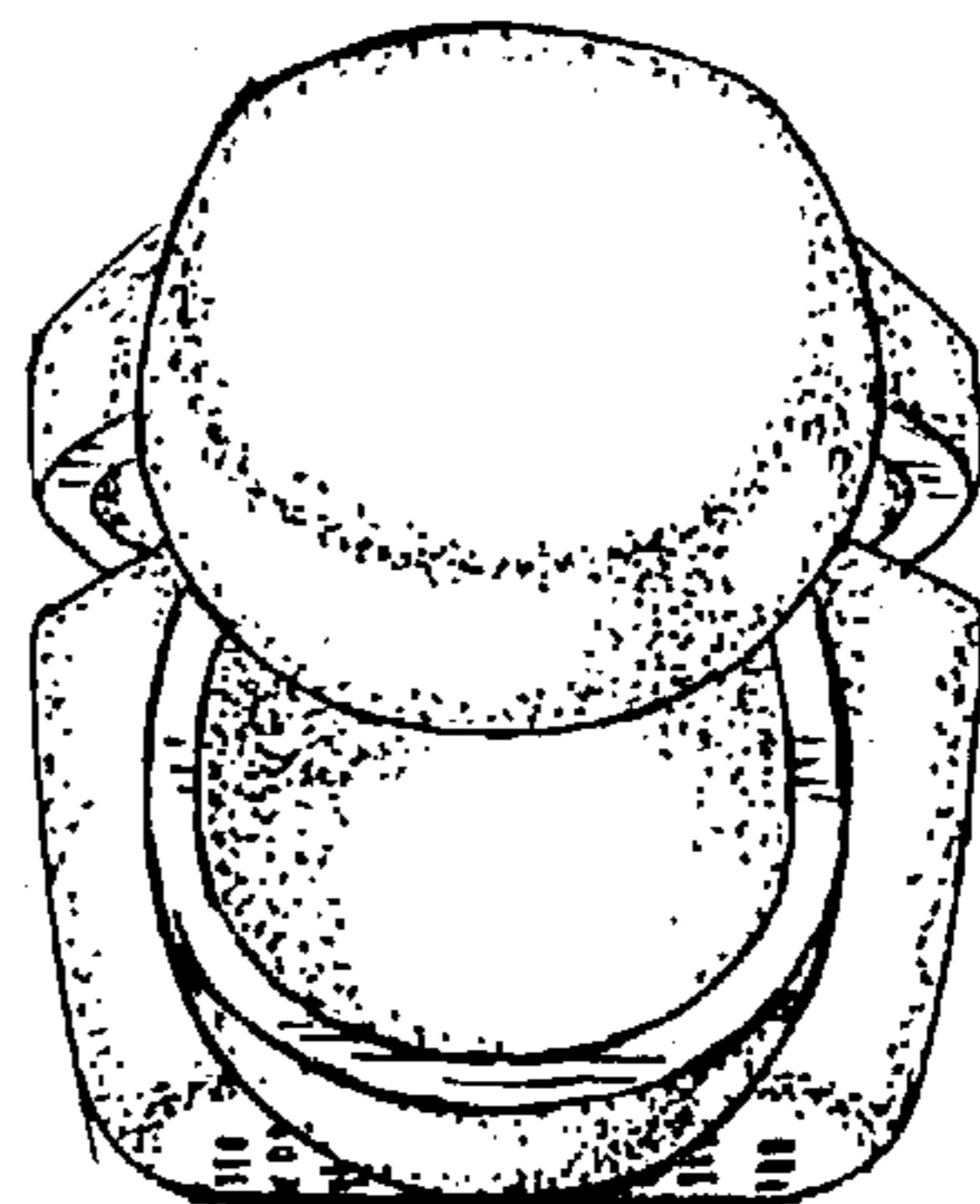

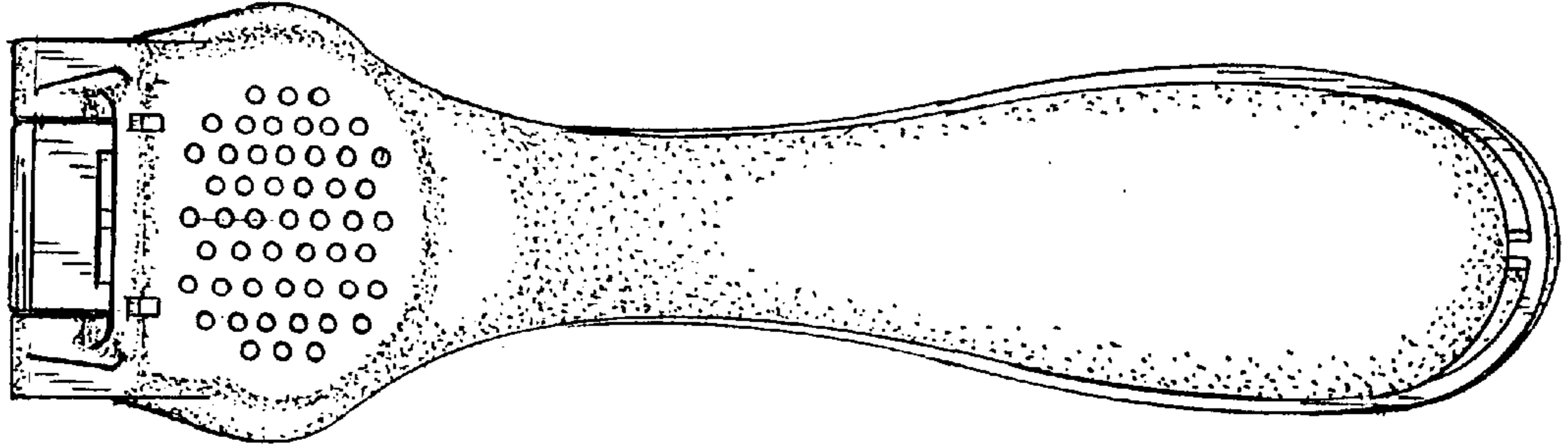

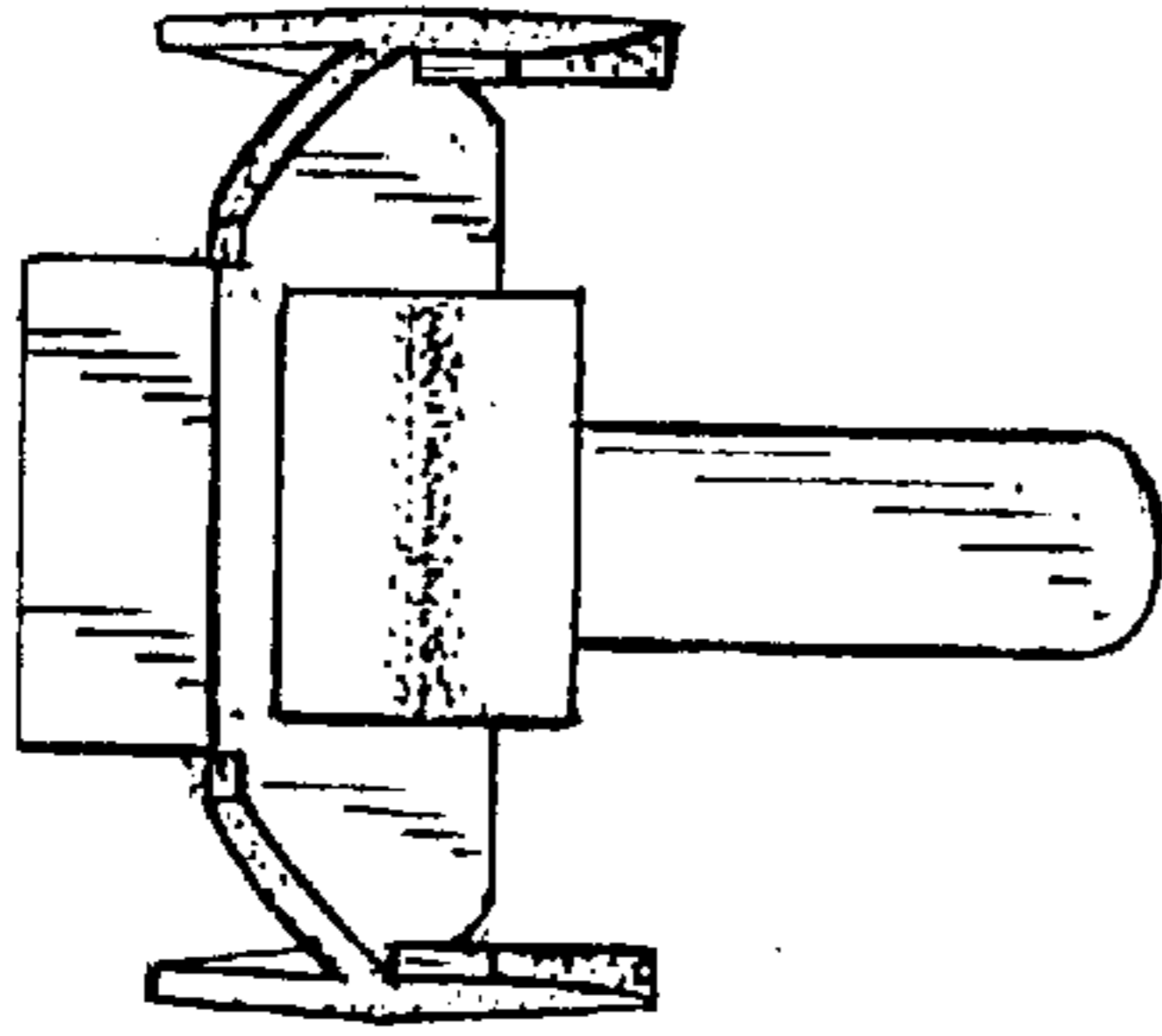

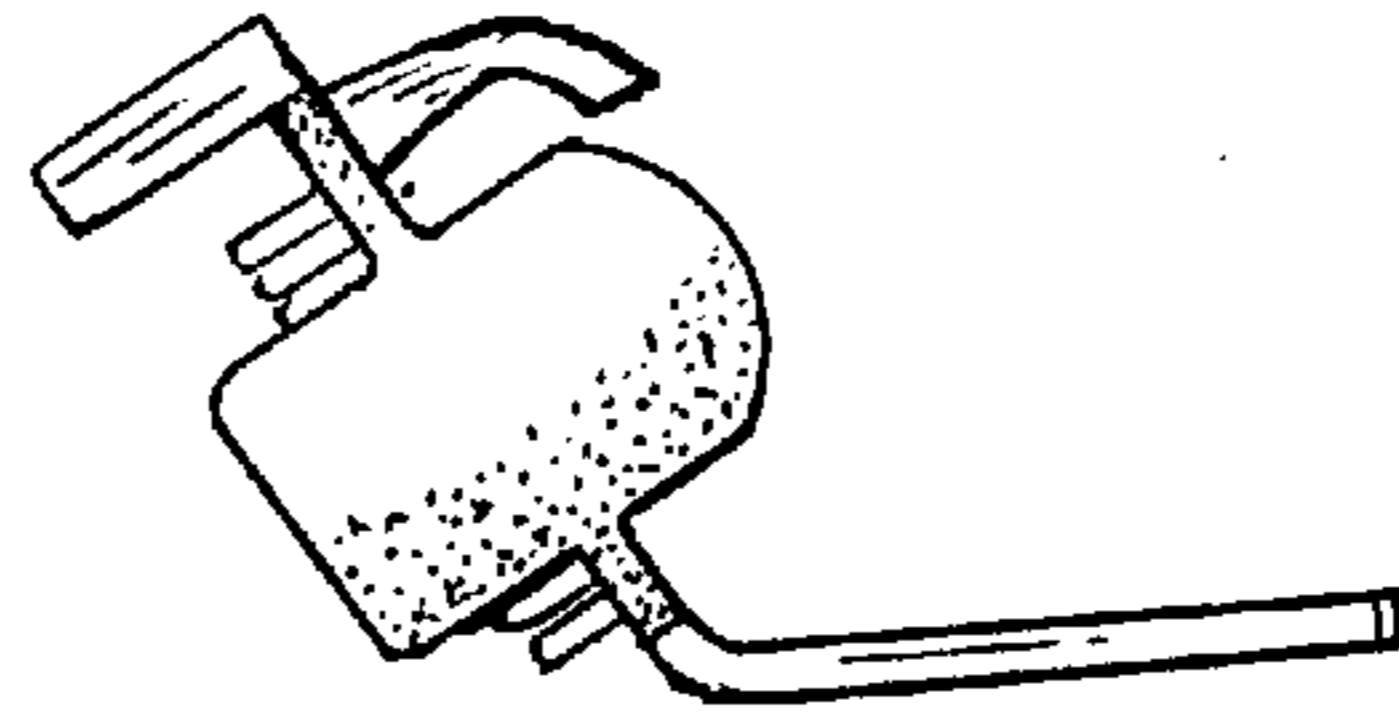

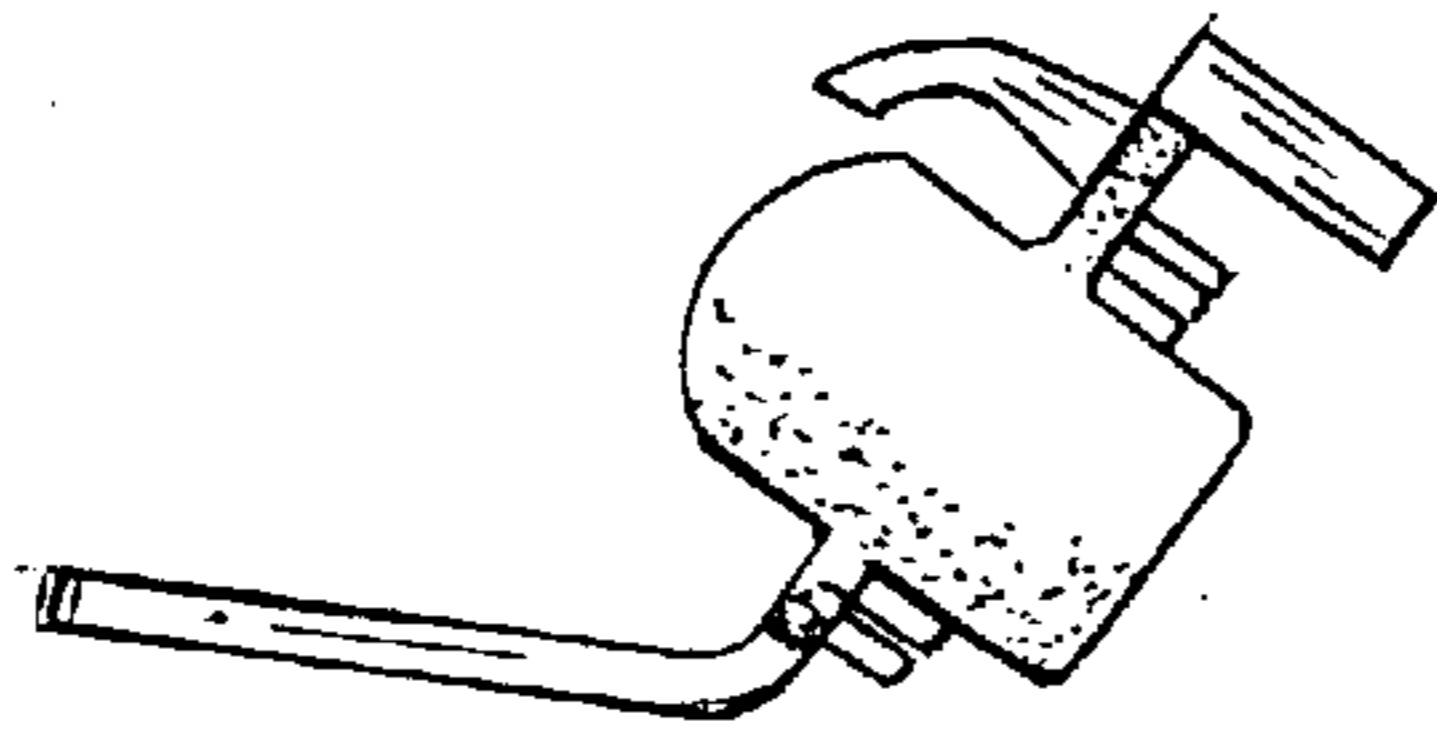

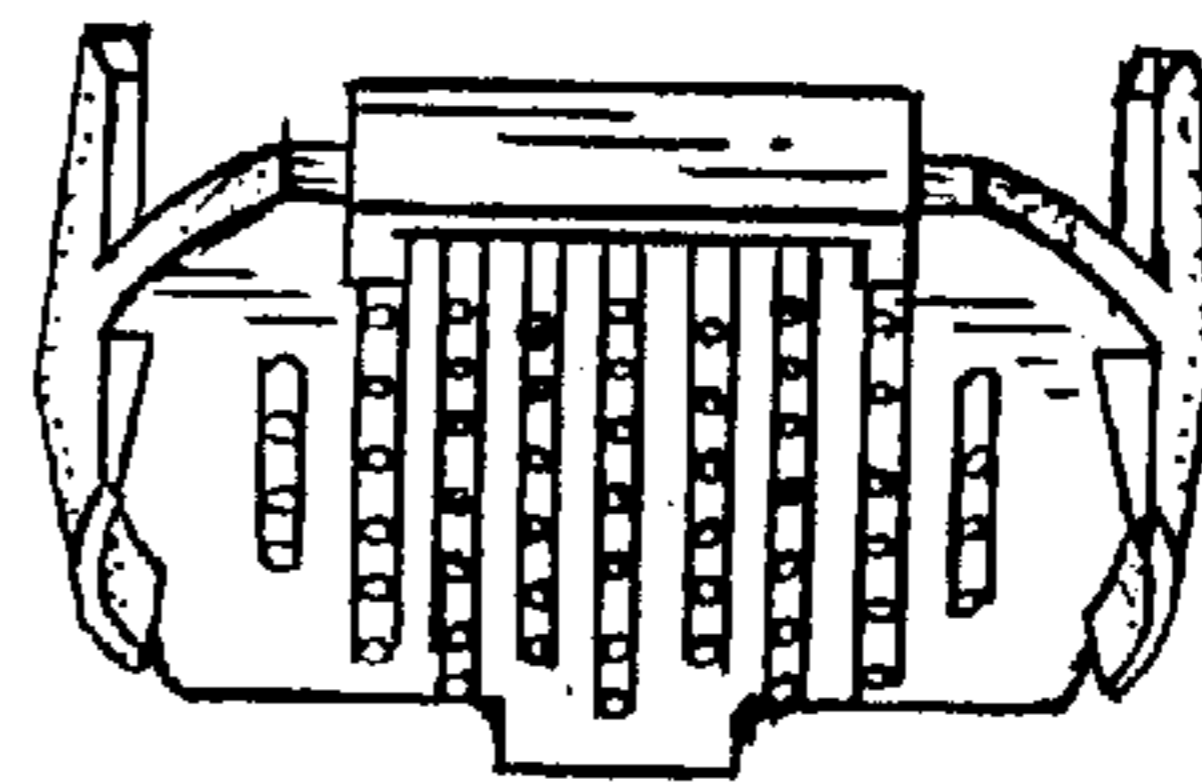

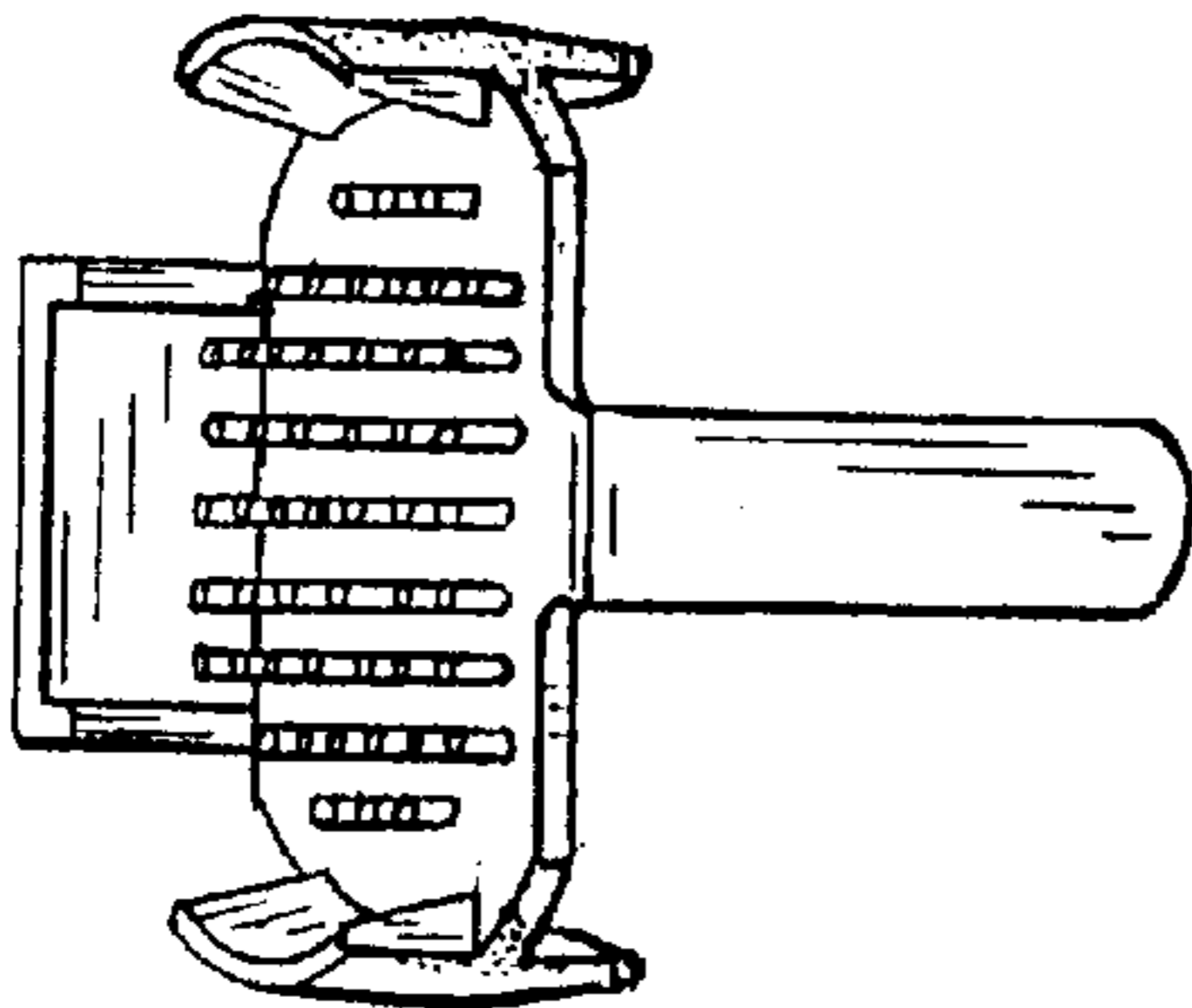
