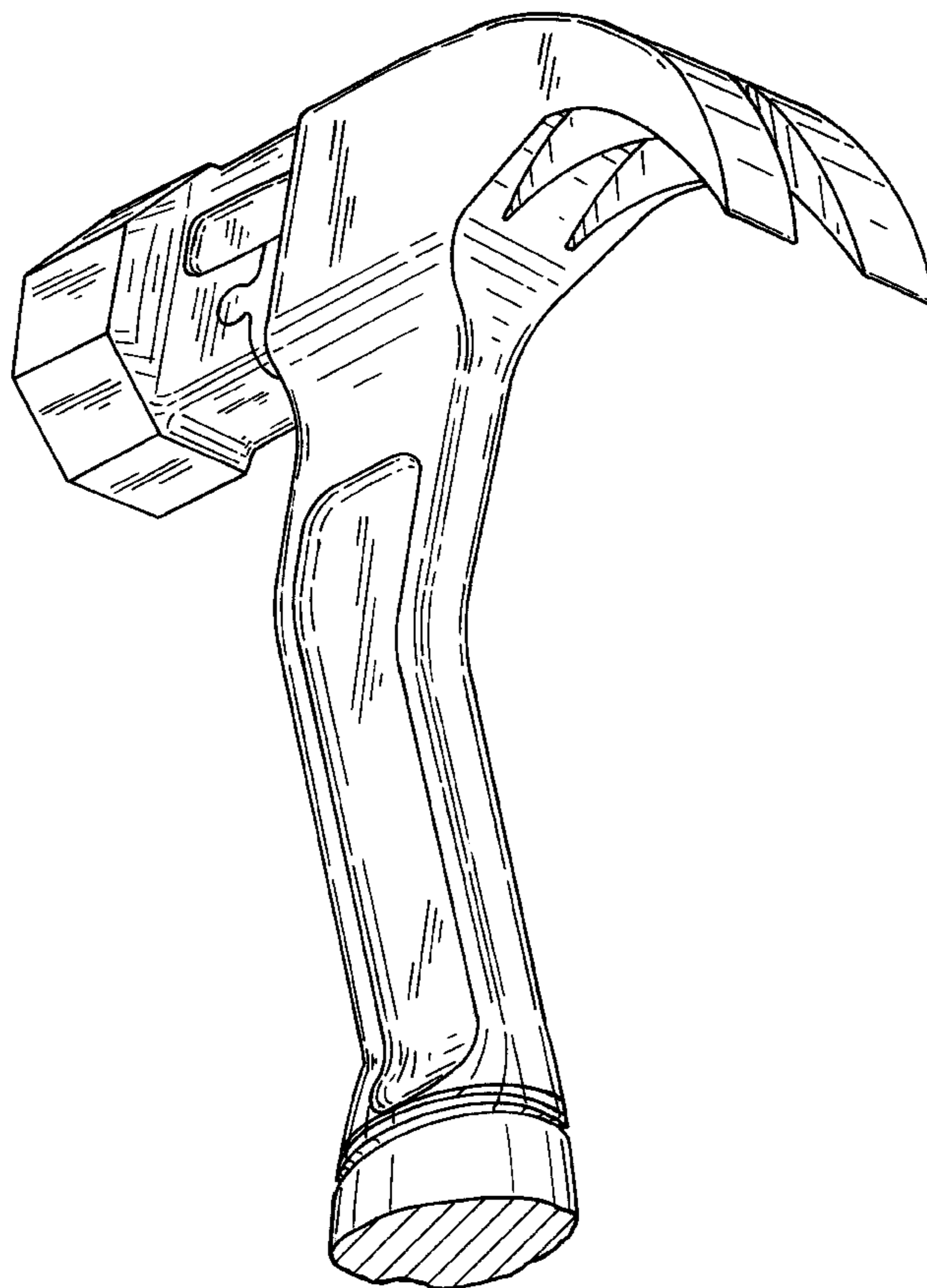
FIG. 4 is a back view of the claw hammer head of the present invention;

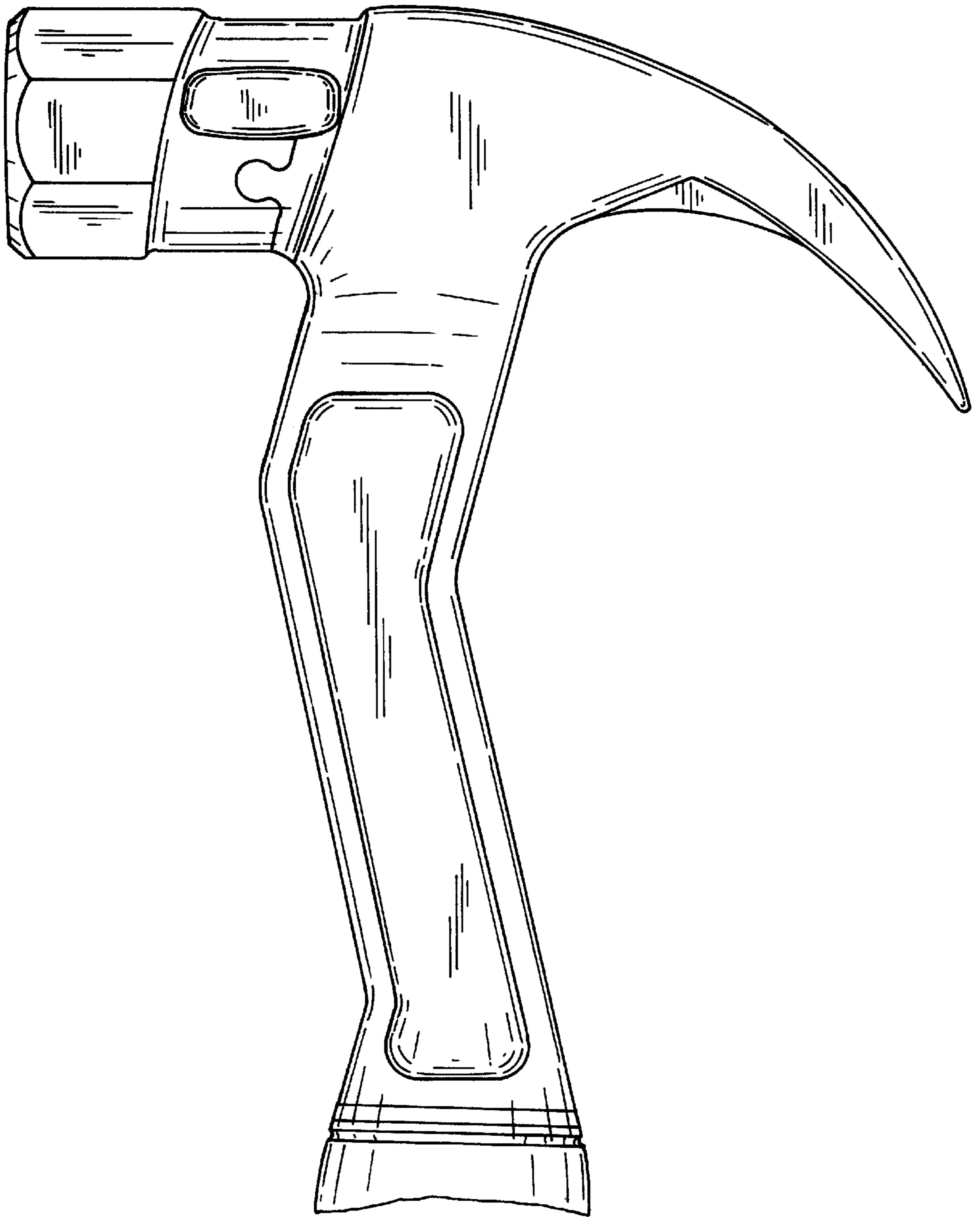
FIG. 5 is a front view of the claw hammer head of the present invention;

FIG. 6 is a top view of the claw hammer head of the present invention; and,

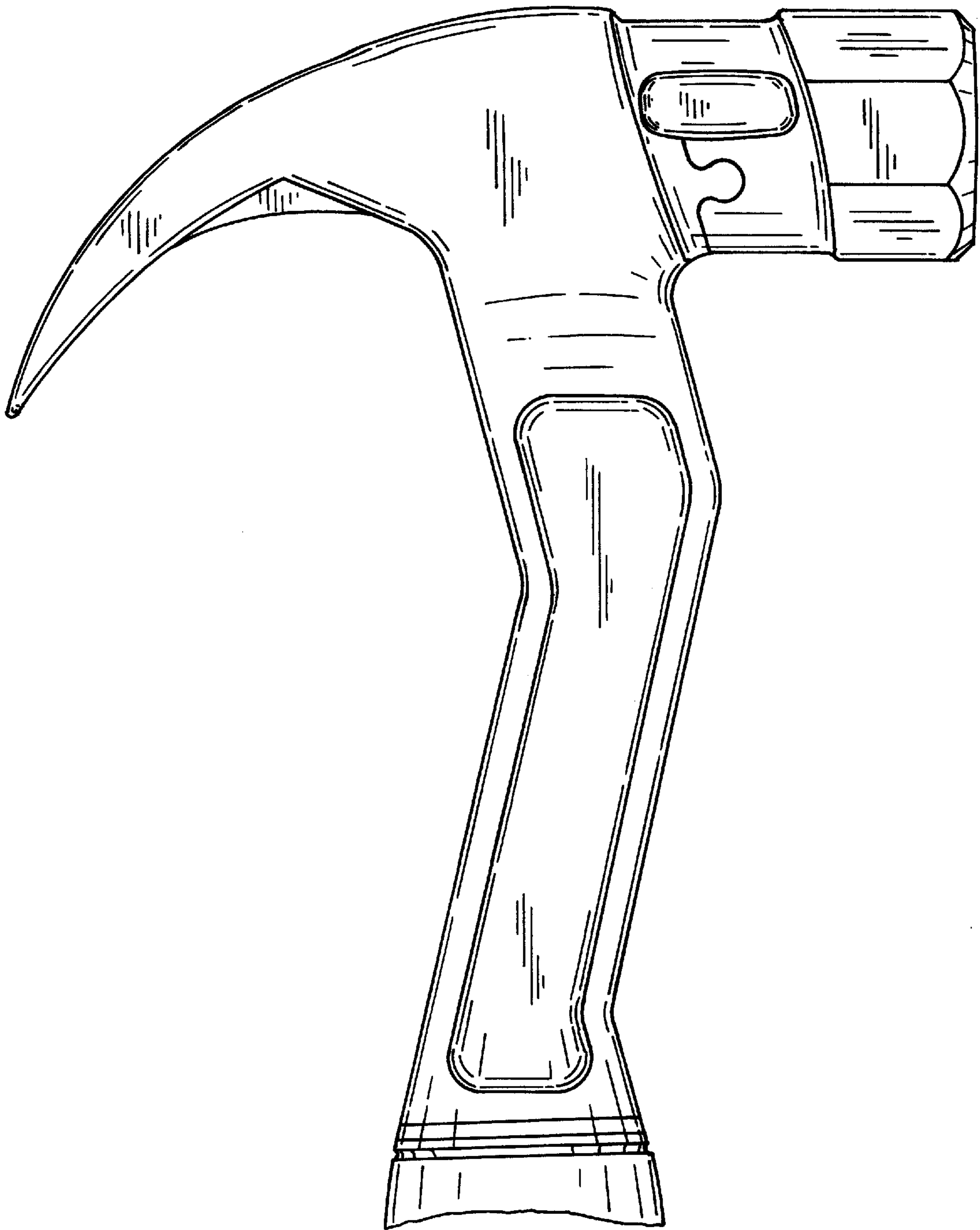
FIG. 7 is a bottom view of the claw hammer head of the present invention.

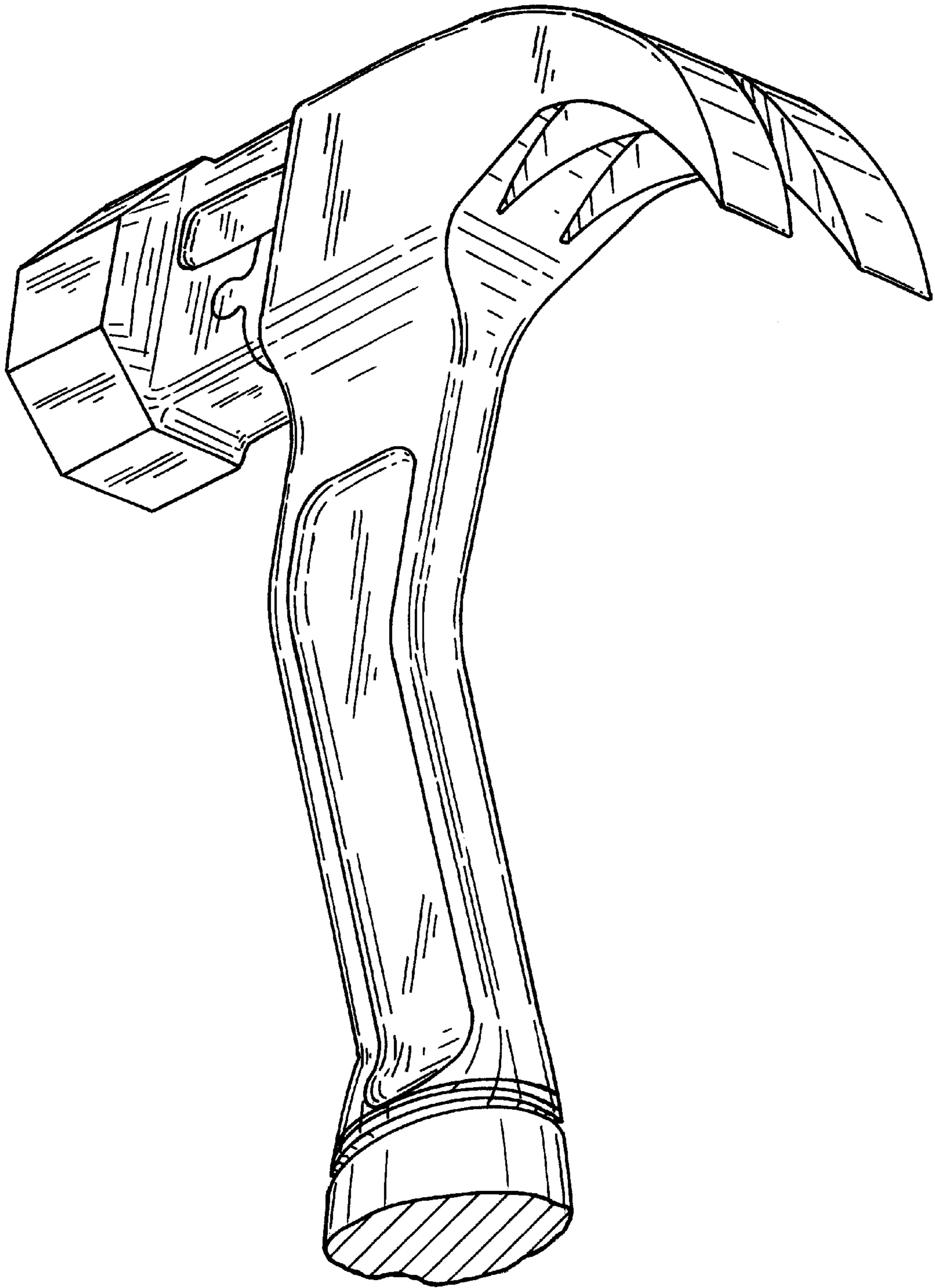




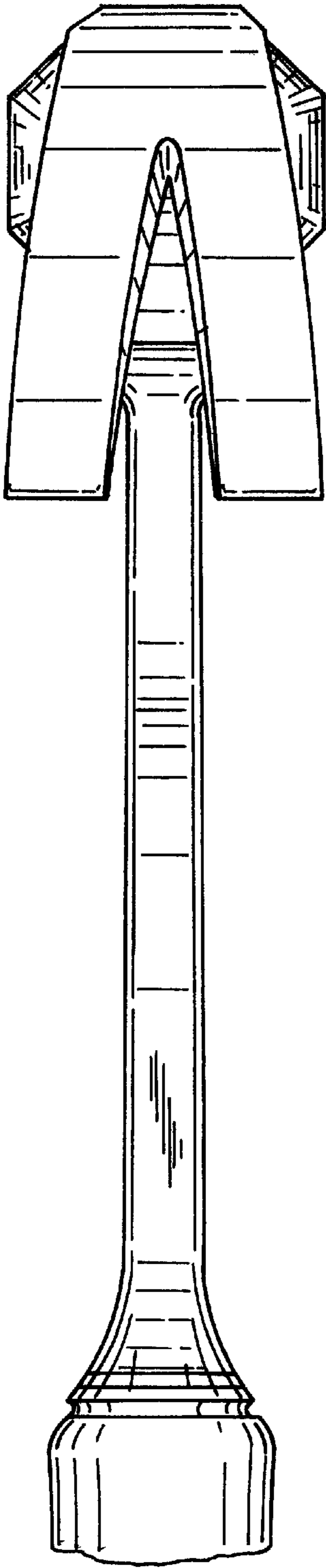

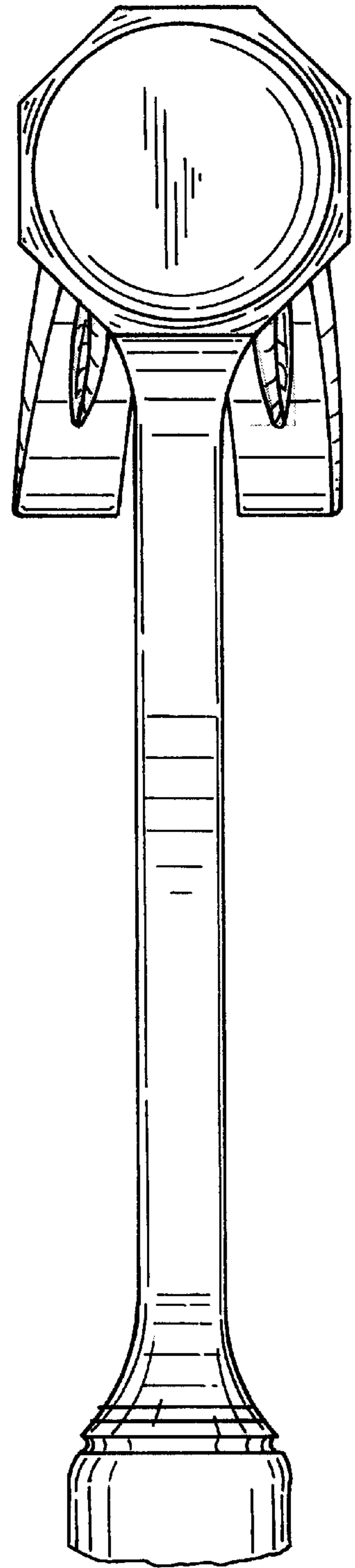

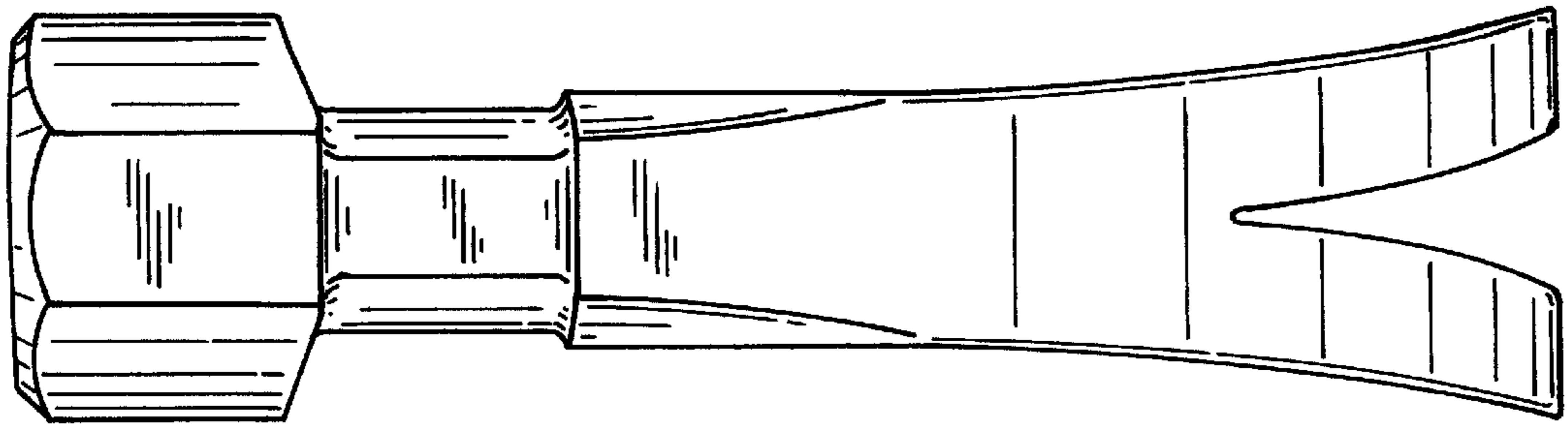

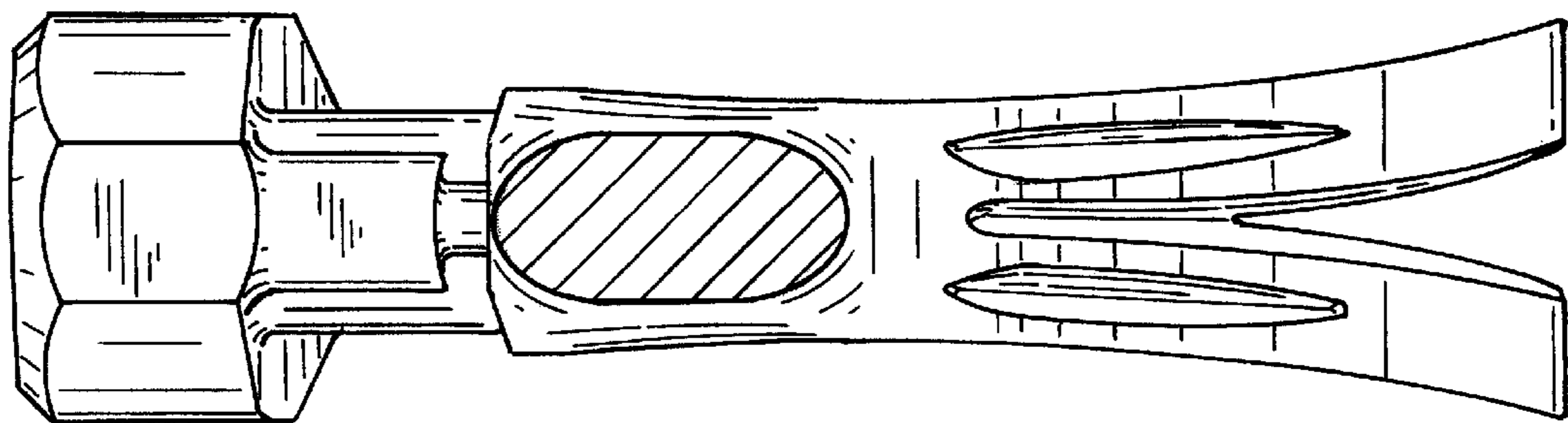
