[57] CLAIM

The ornamental design for “cord stopper”, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a cord stopper;
 FIG. 2 is a left side view of the cord stopper of FIG. 1 with the opposite side being a mirror image;
 FIG. 3 is a front view of the cord stopper of FIG. 1.
 FIG. 4 is a bottom plan view of the cord stopper of FIG. 1;
 FIG. 5 is a rear view of the cord stopper of FIG. 1.
 FIG. 6 is a left side view of the cord stopper of FIG. 1 in opened disposition.
 FIG. 7 is a front view of the cord stopper of FIG. 1 in opened disposition.
 FIG. 8 is a perspective view of the cord stopper of FIG. 1 in opened disposition; and,
 FIG. 9 is a reduced scale environmental perspective view showing the cord stopper in a closed position with the broken line showing of a partial cord being for illustrative purposes only and forming no part of the claimed design.

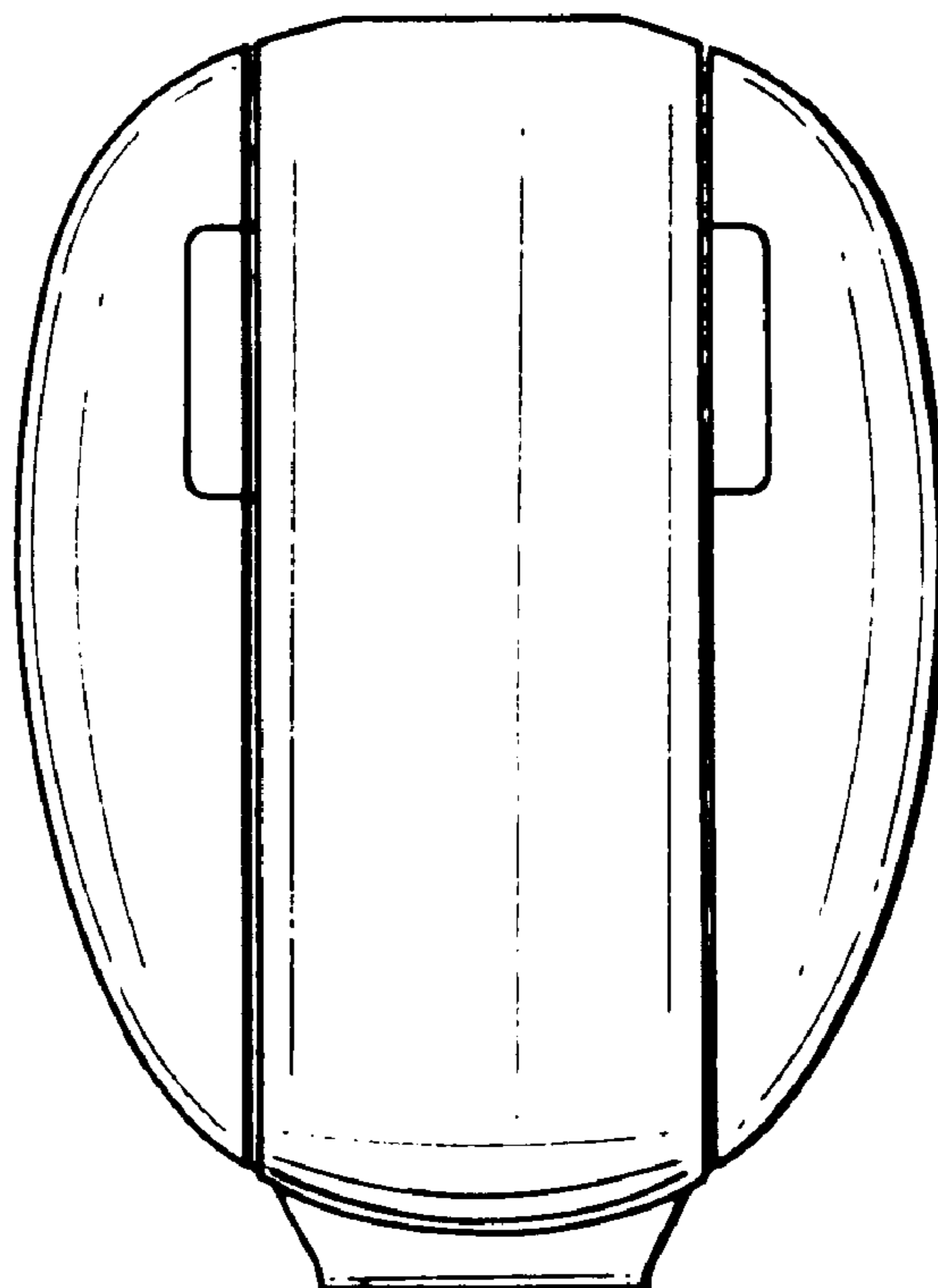

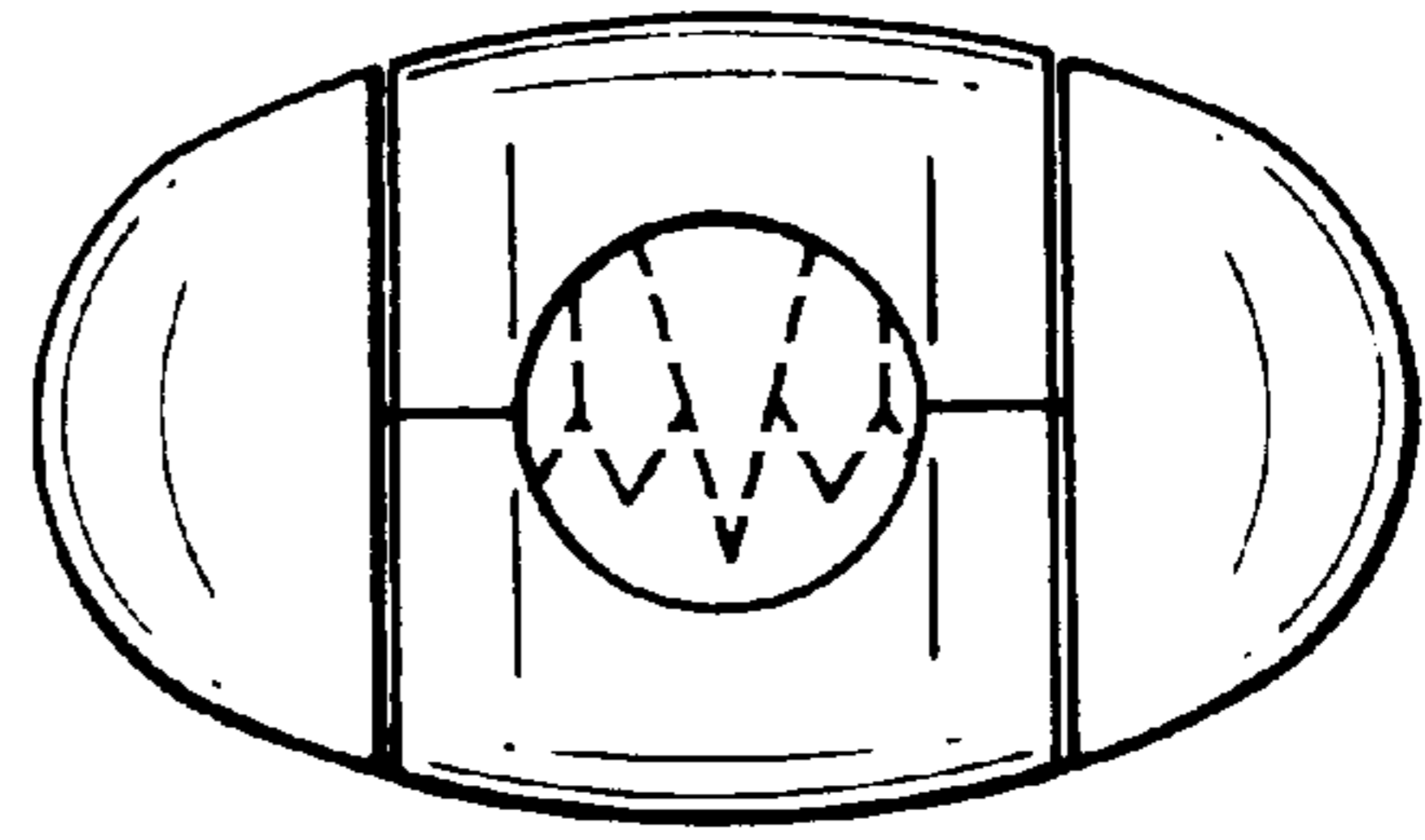

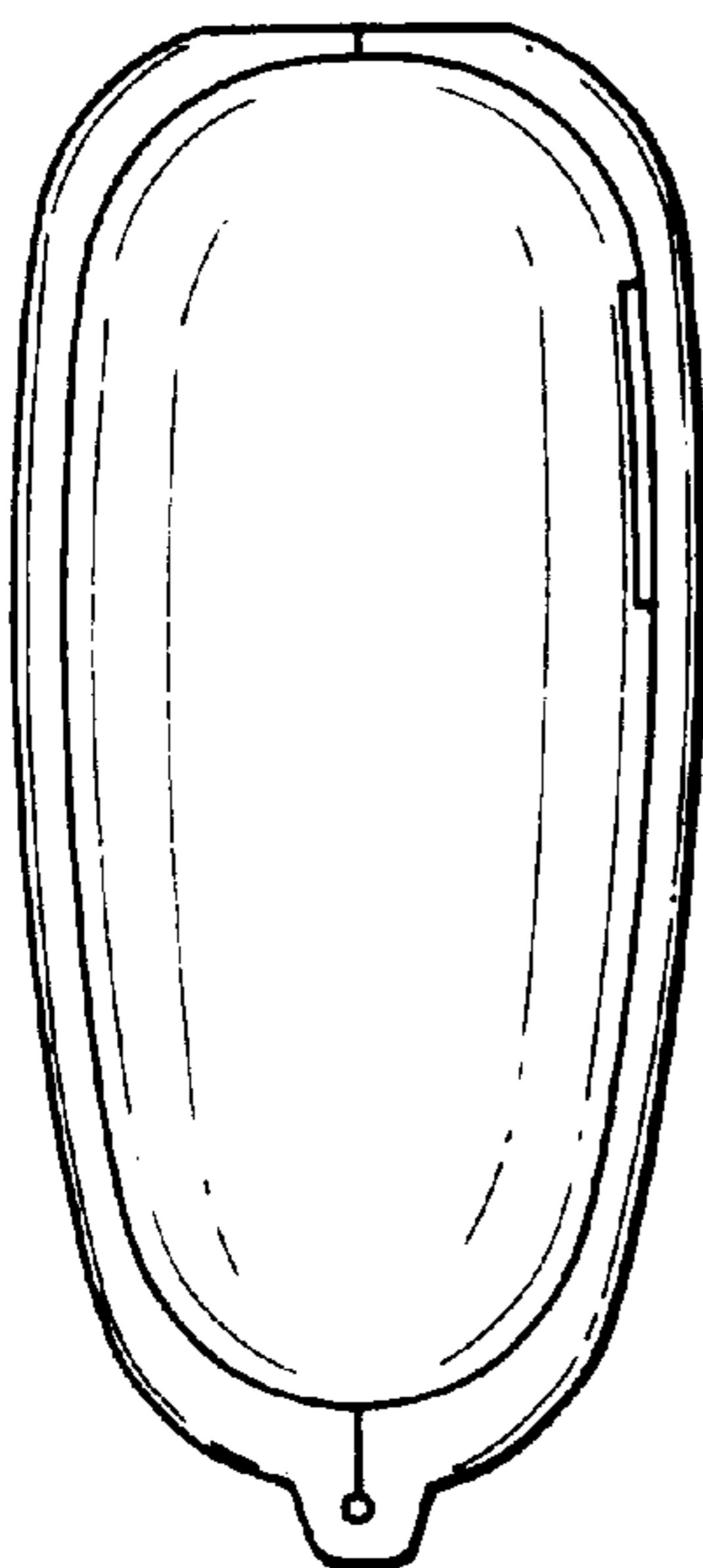
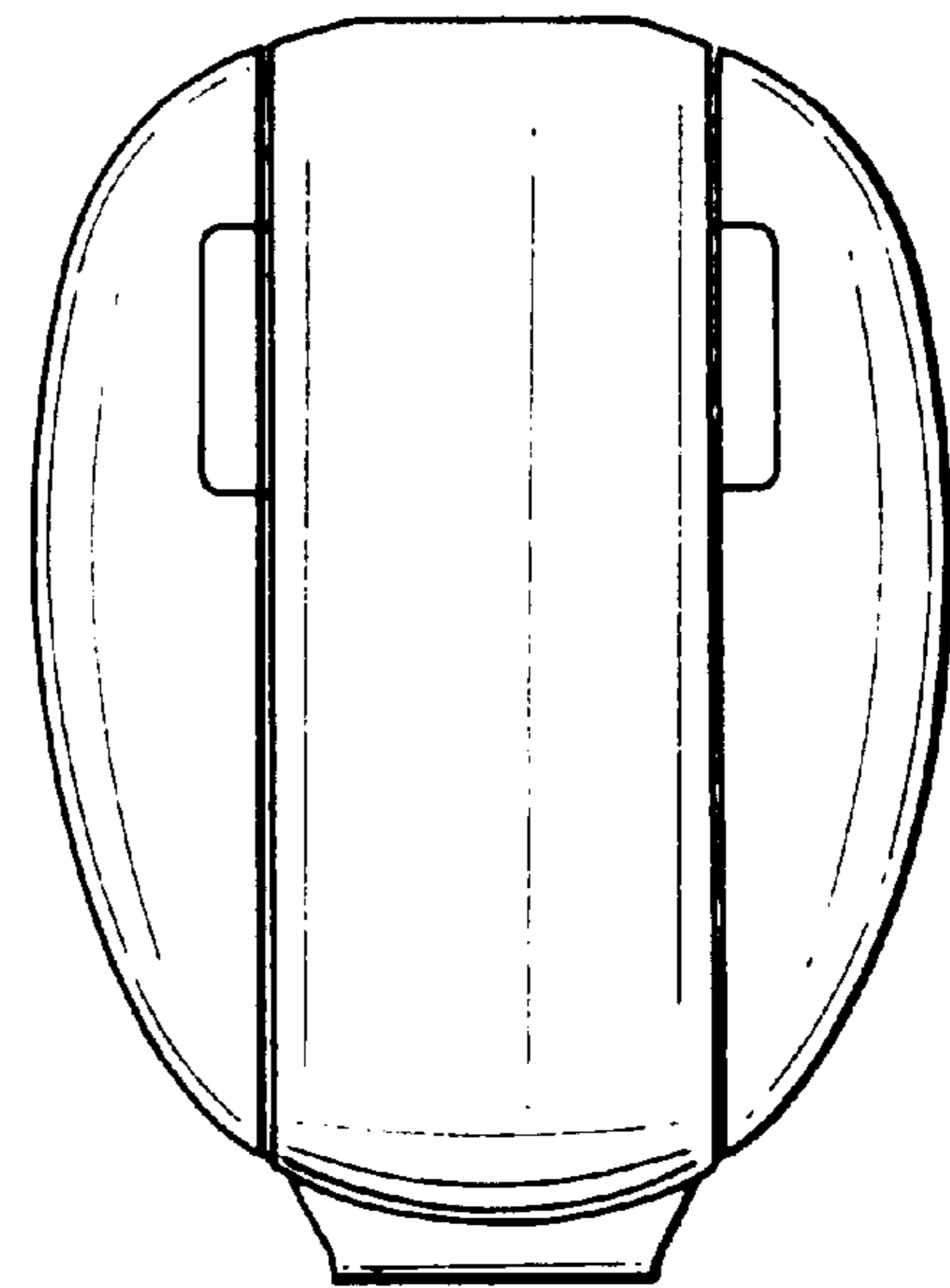

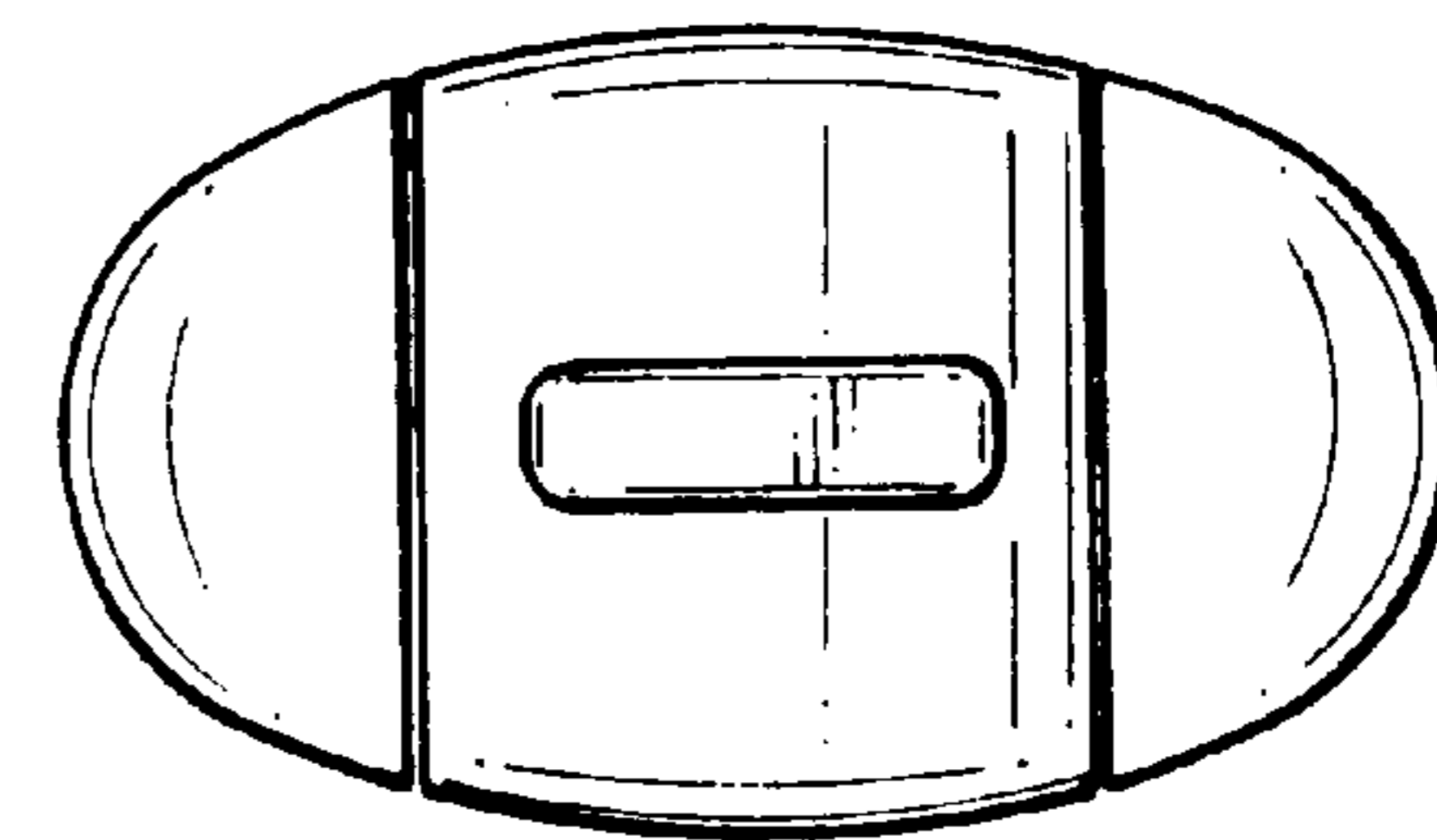
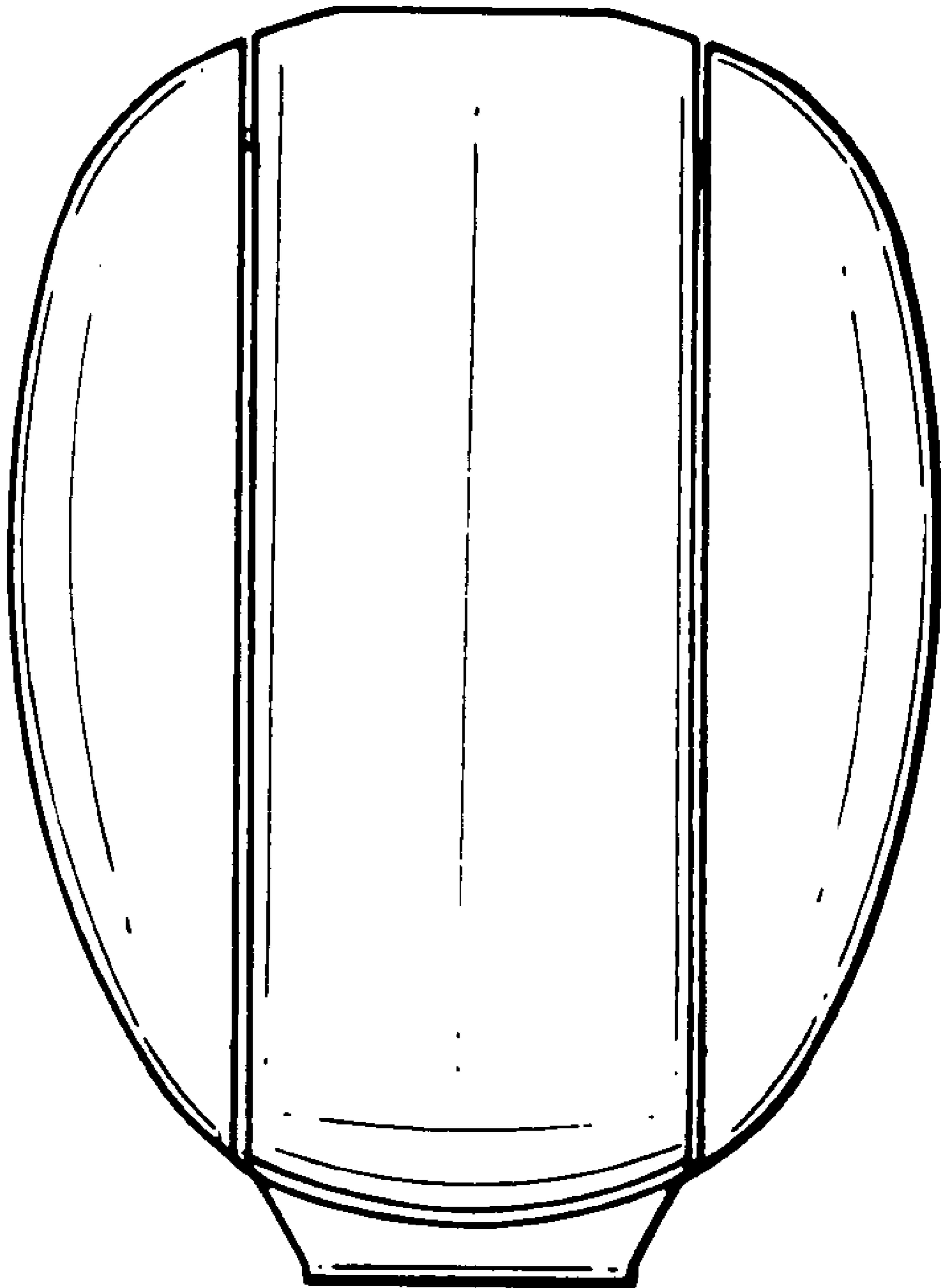

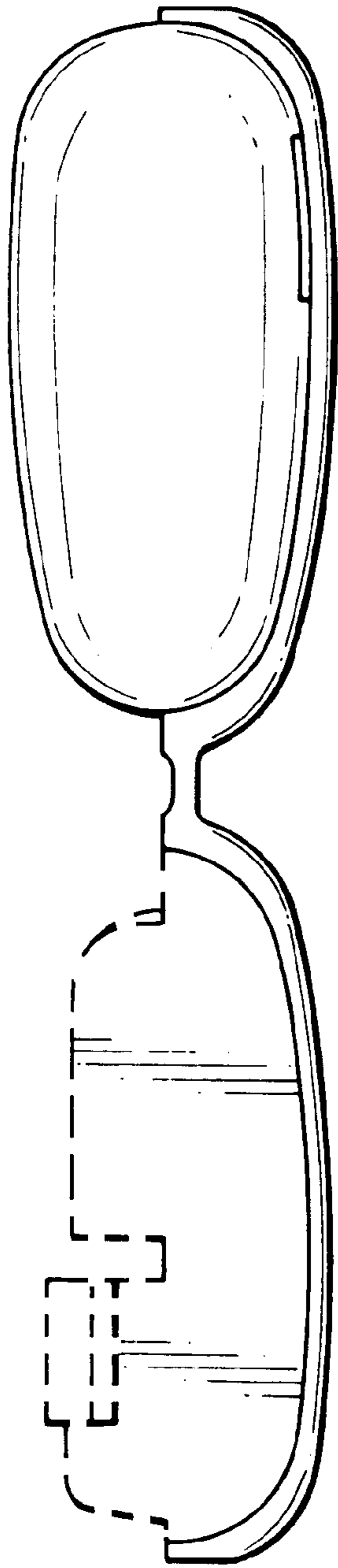

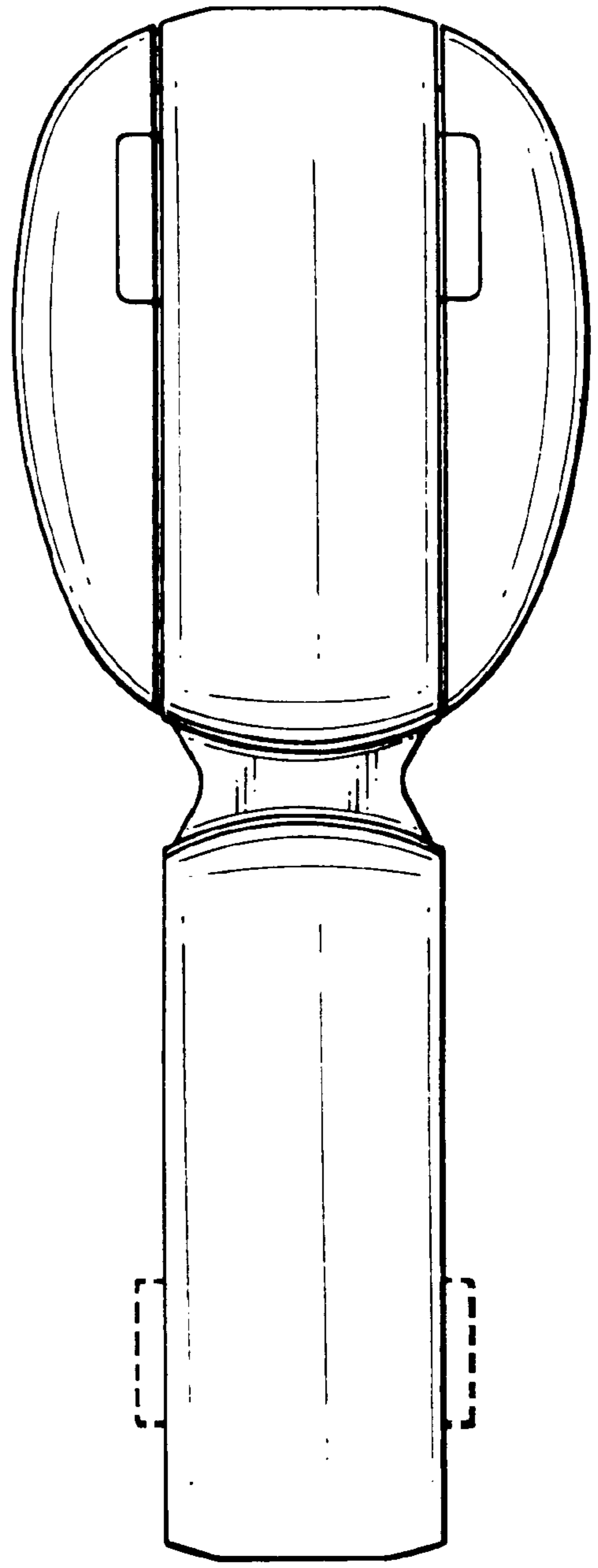

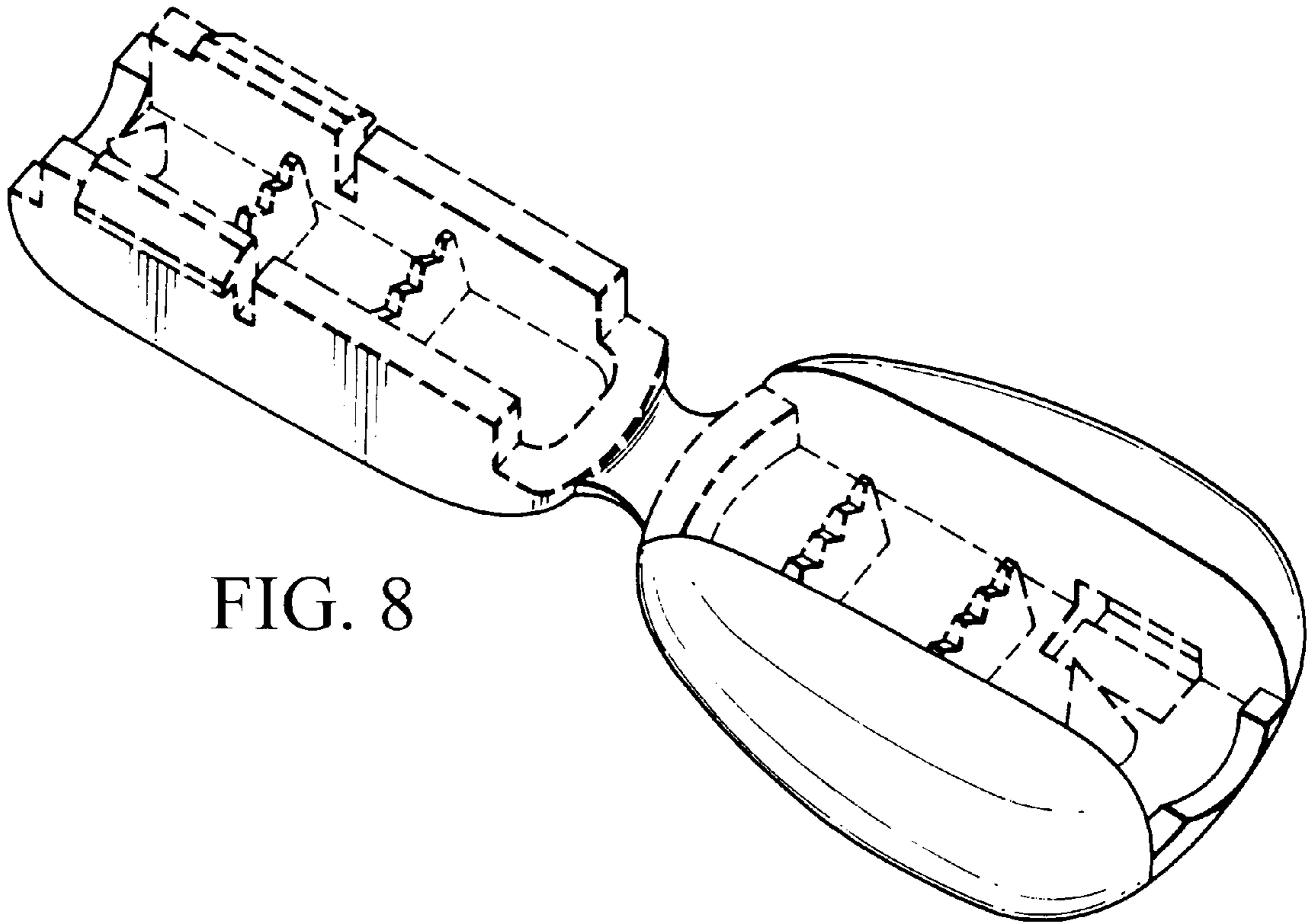

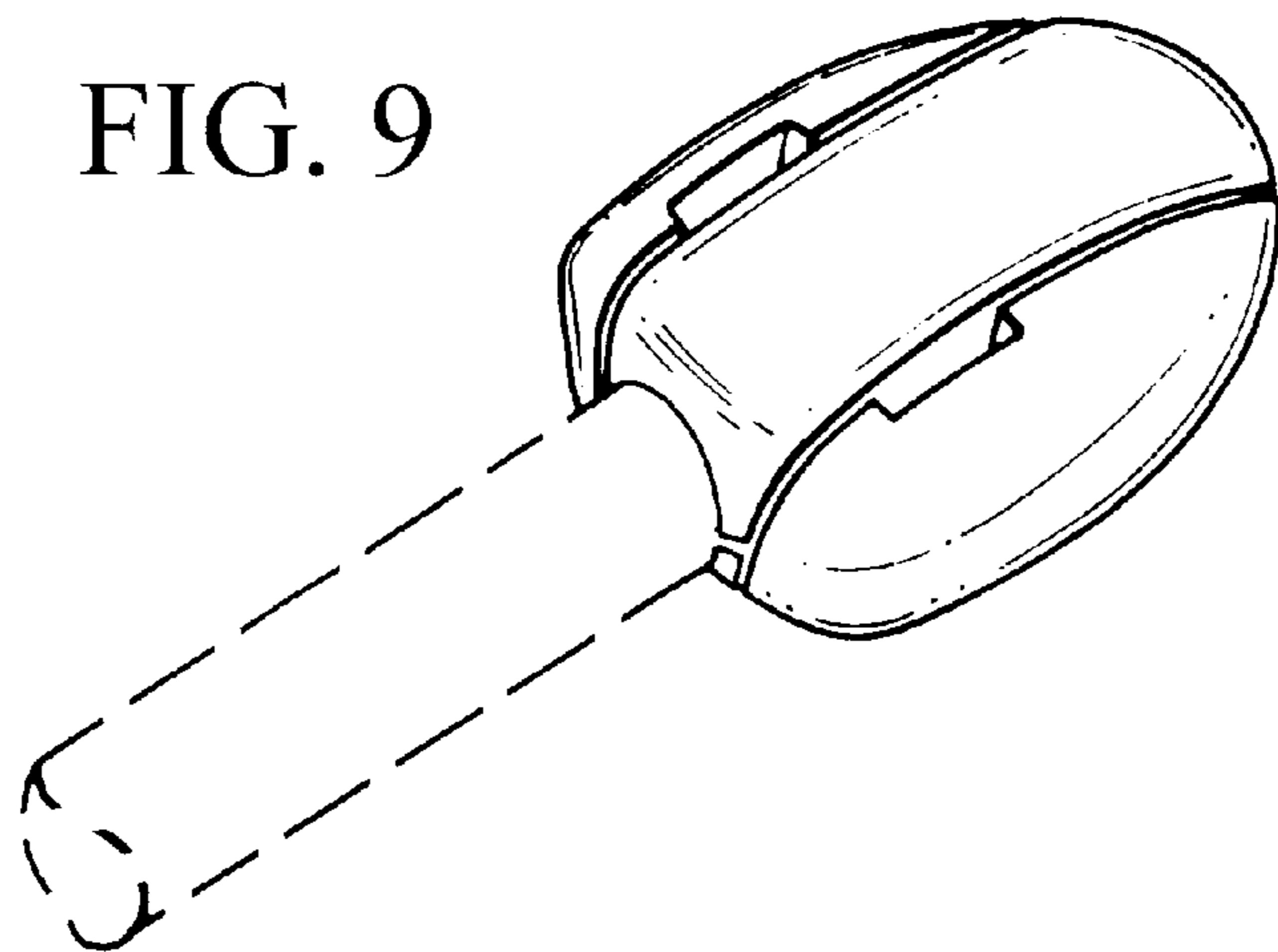
