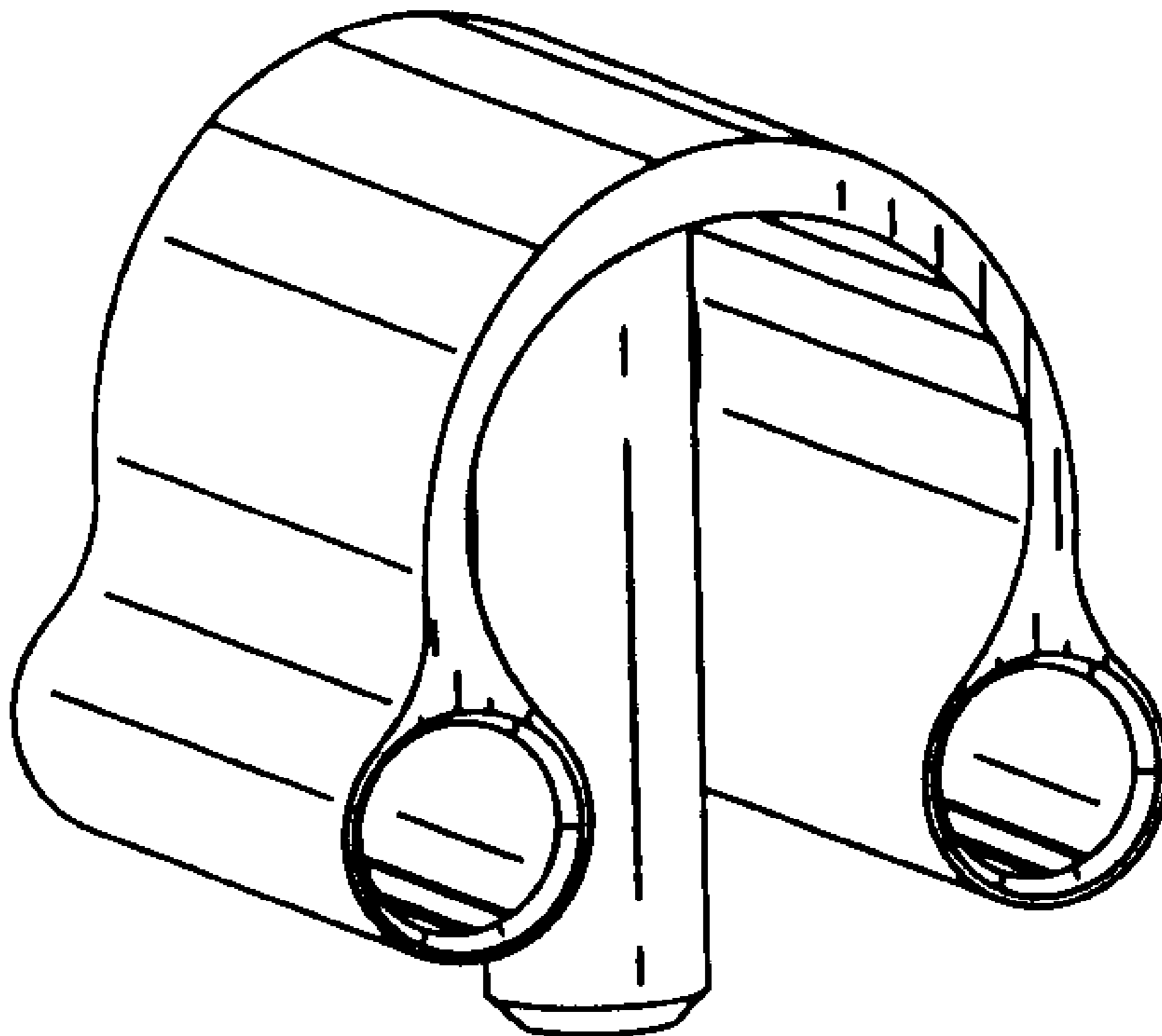
[57] **CLAIM**

The ornamental design for a conduit guide clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of conduit guide clip showing our new design;
FIG. 2 is an end elevational view thereof;
FIG. 3 is an opposite end elevational view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a side elevational view thereof, the opposite being a mirror image

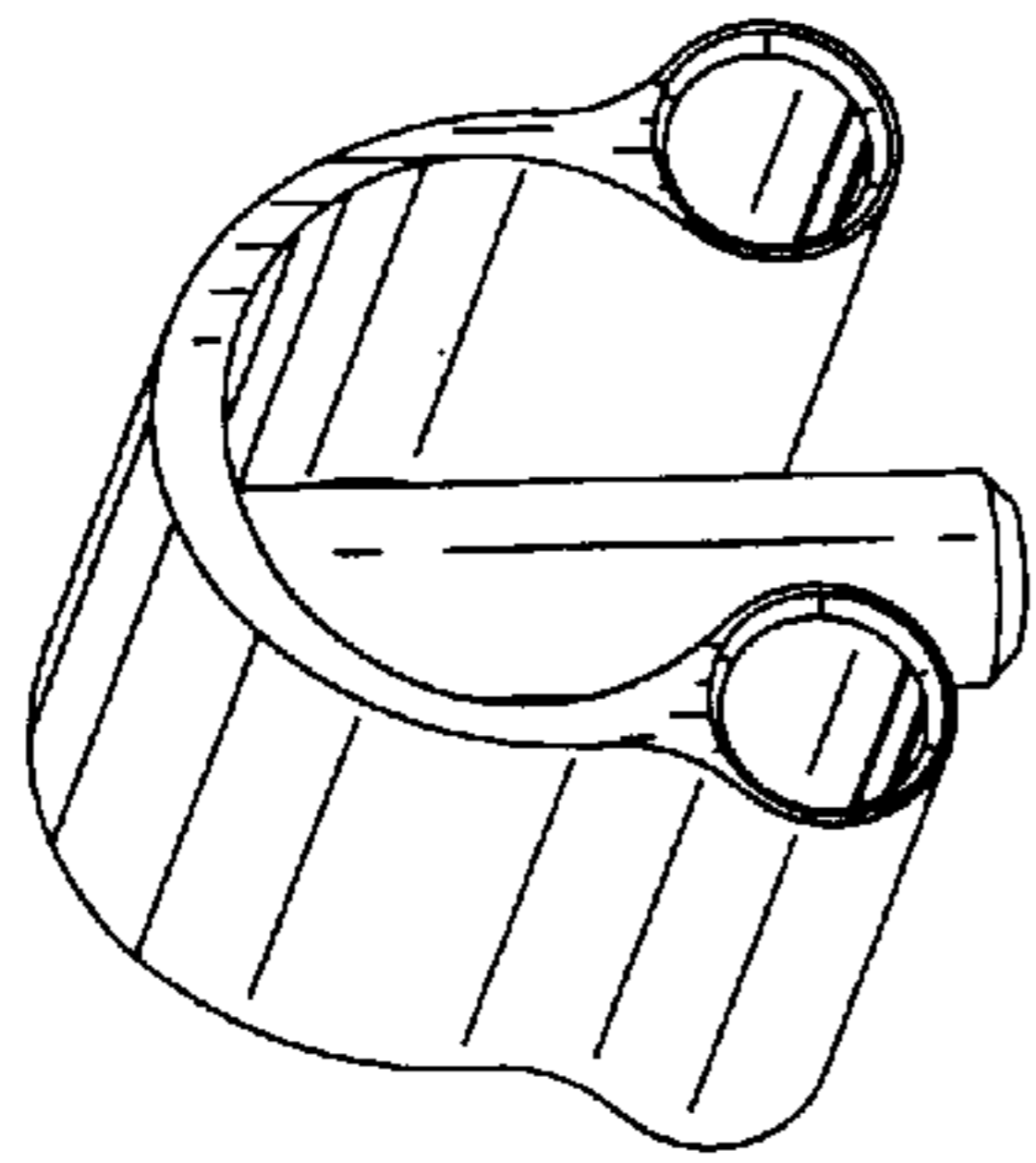

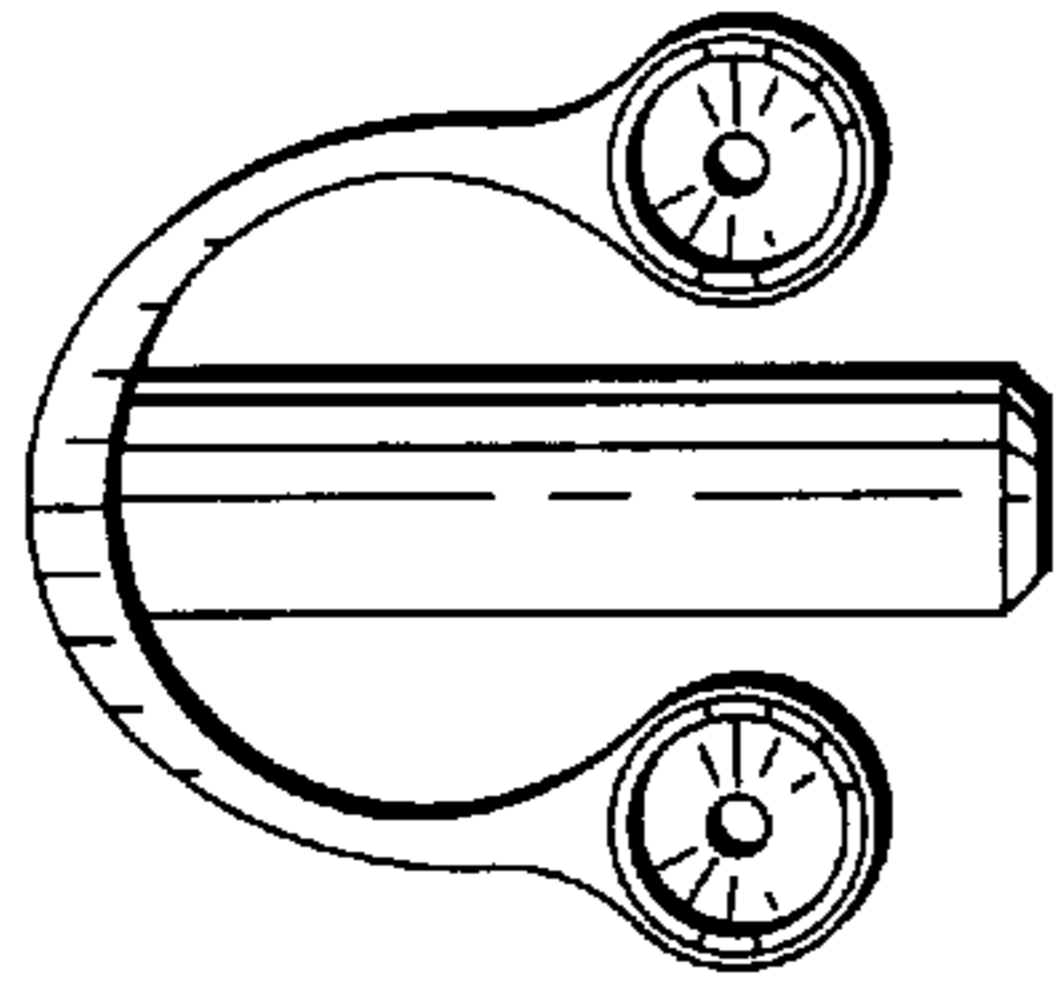

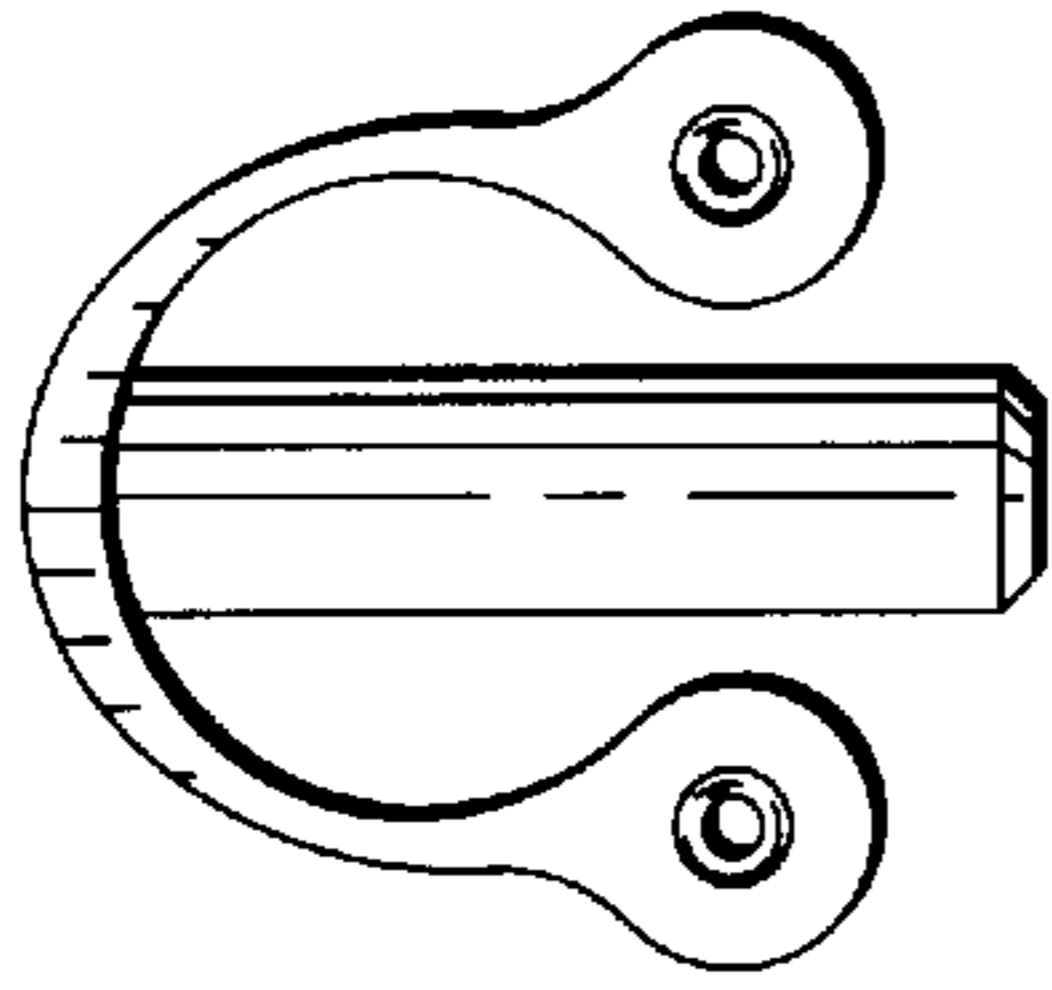

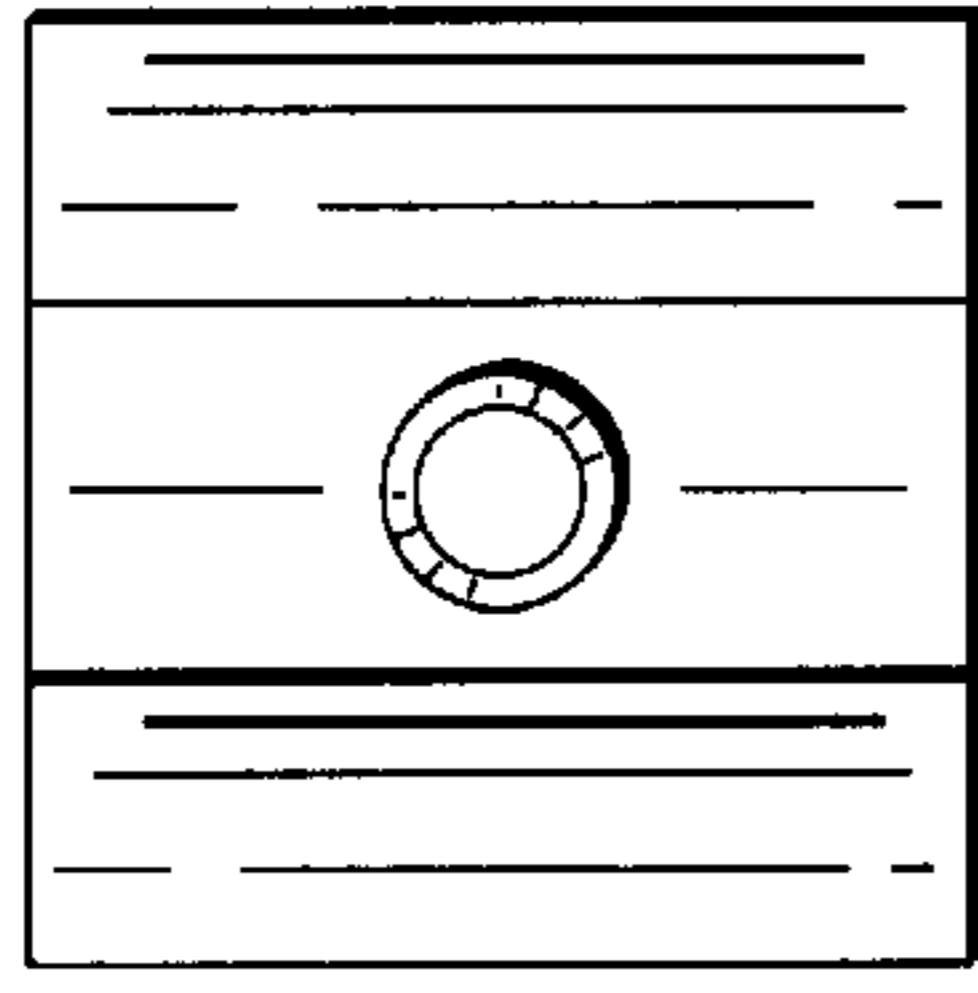

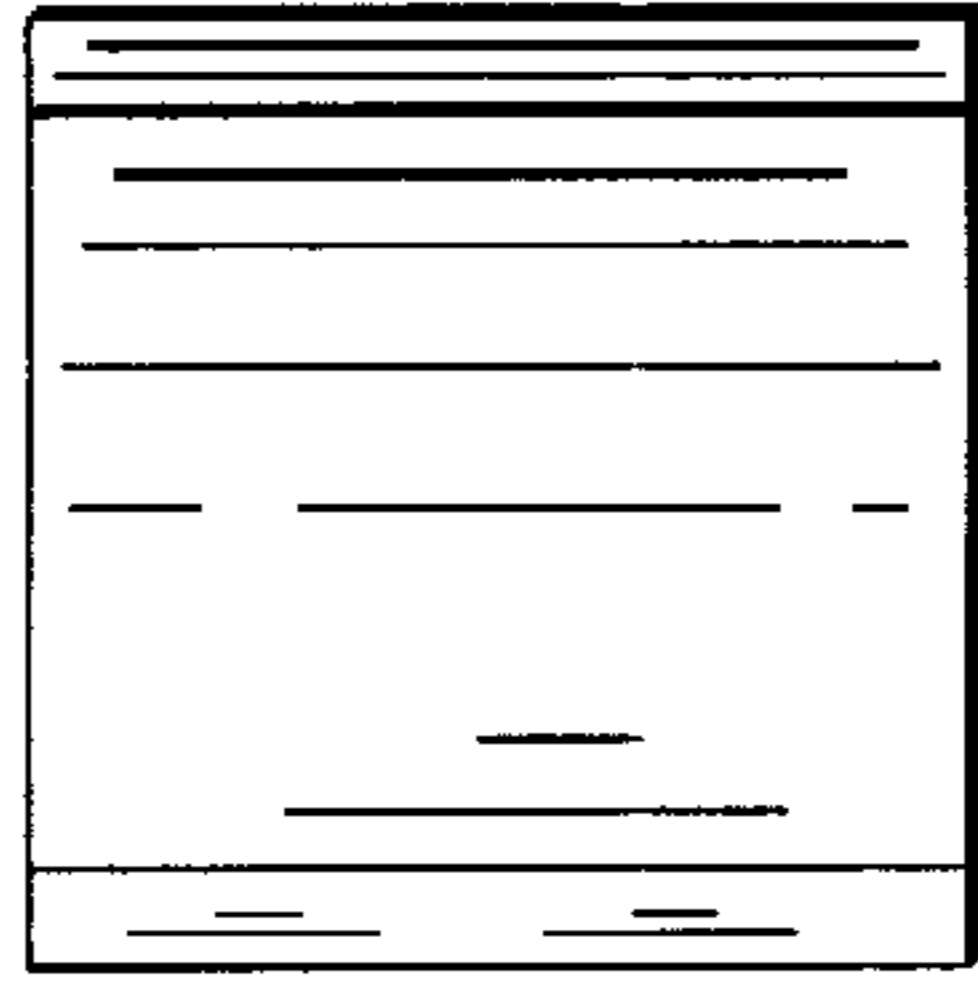

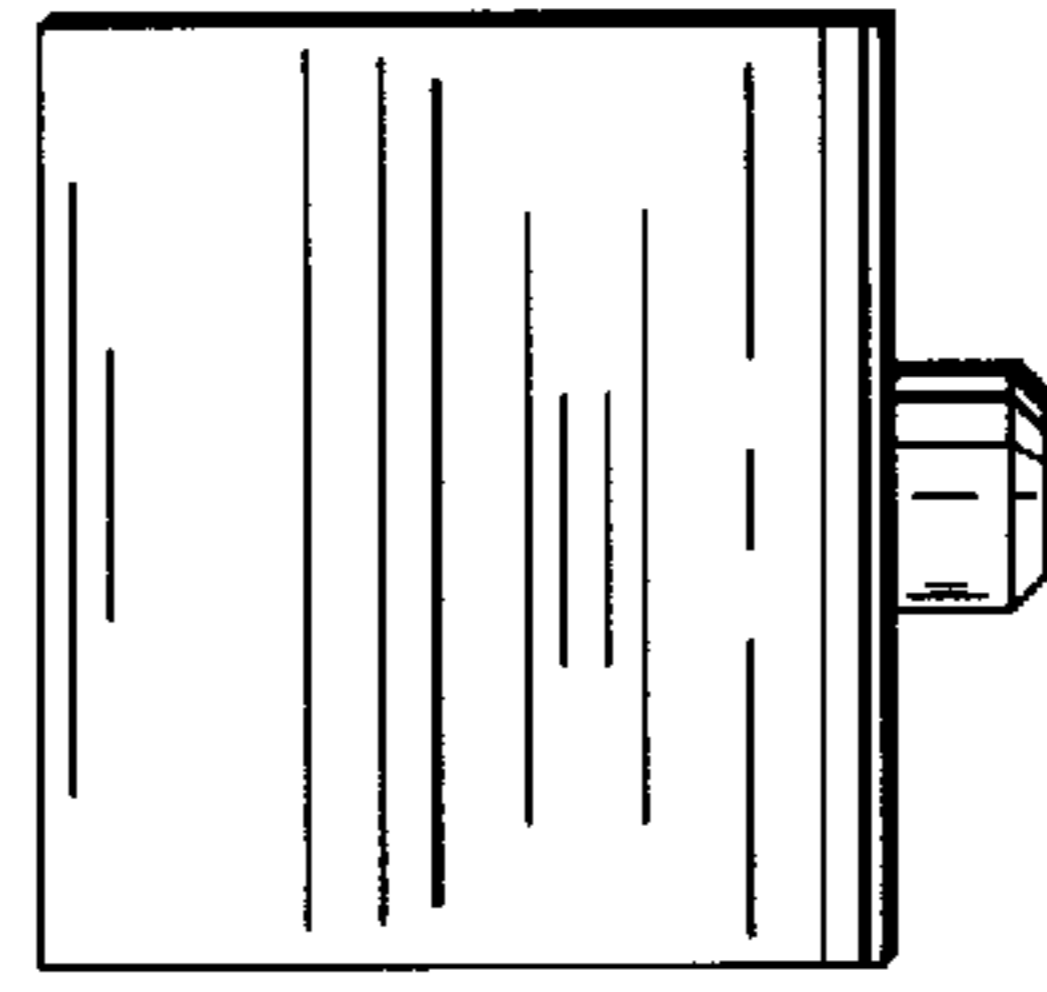
