FIG. 2 is a front elevational view thereof.

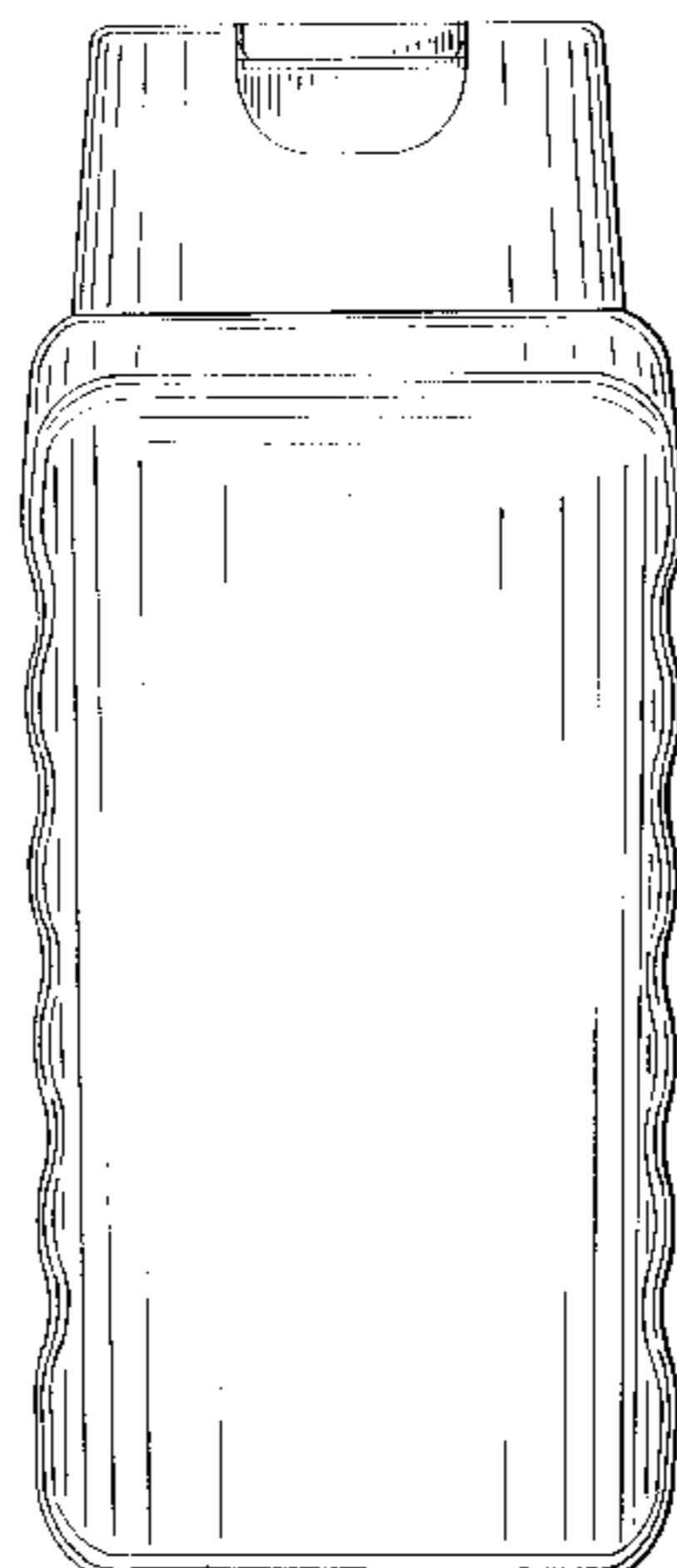
FIG. 3 is a rear elevational view thereof.

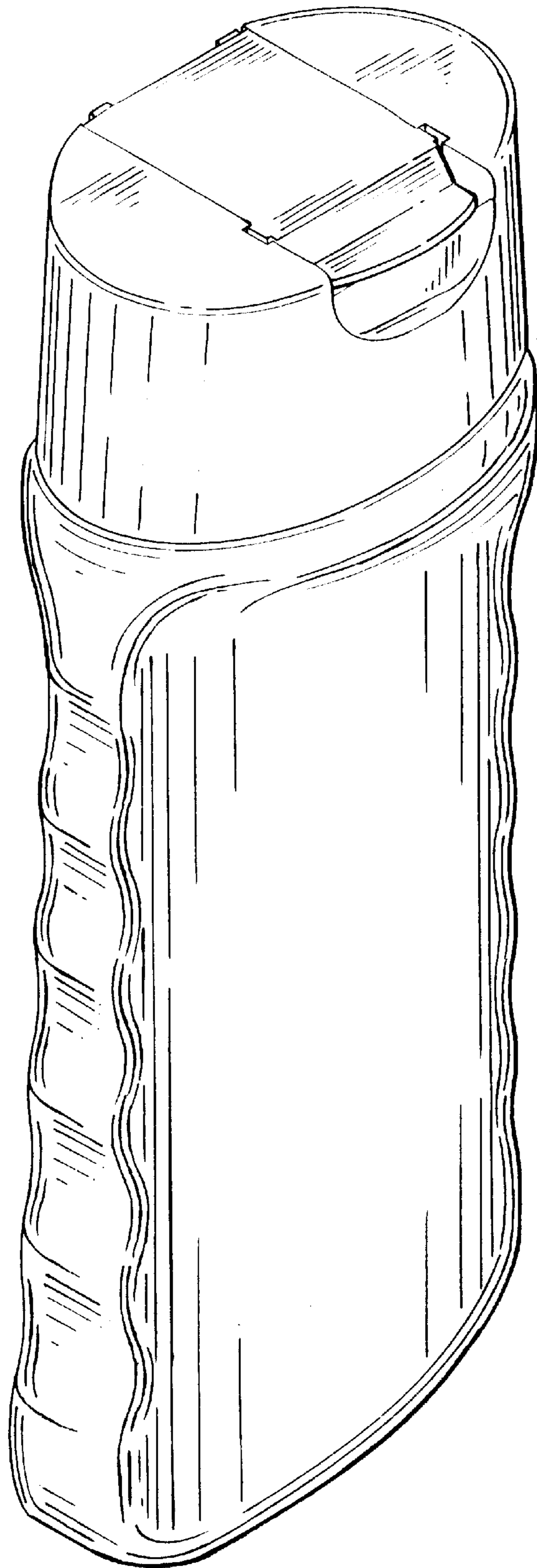

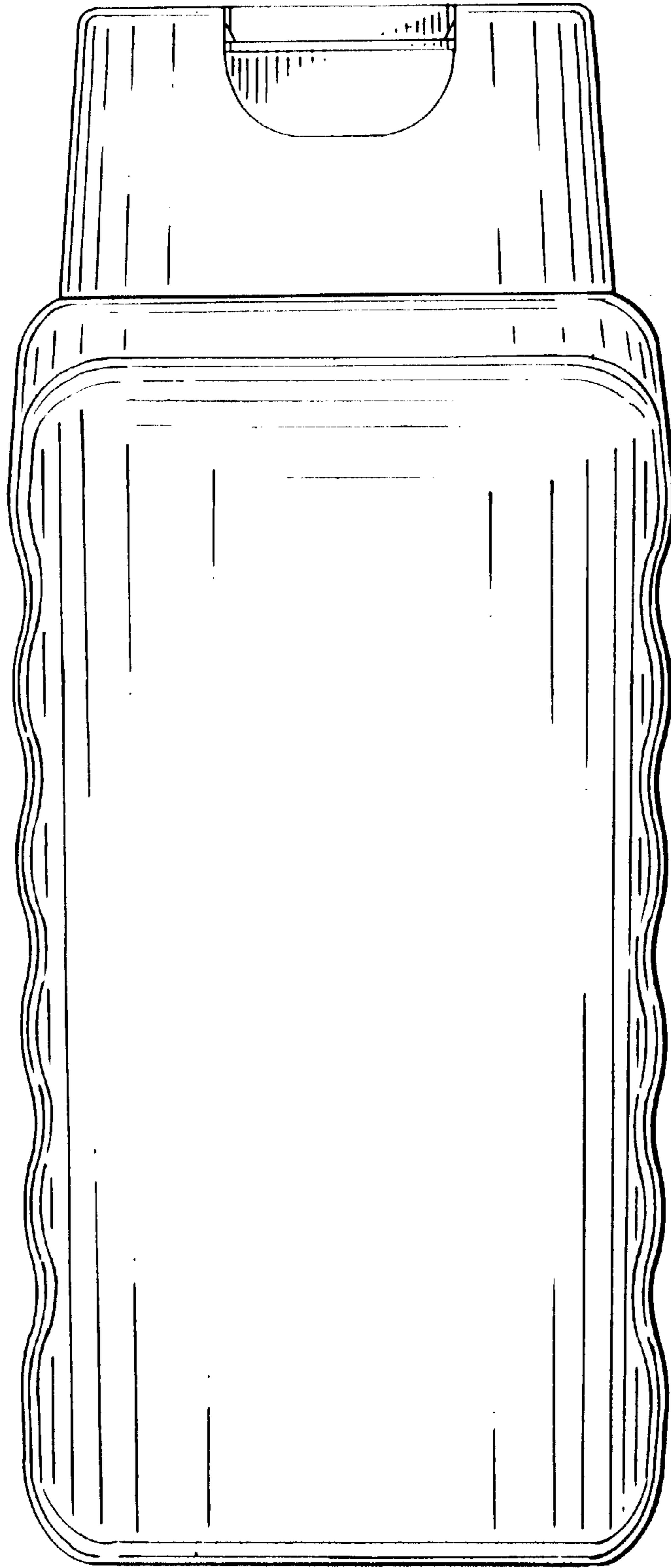

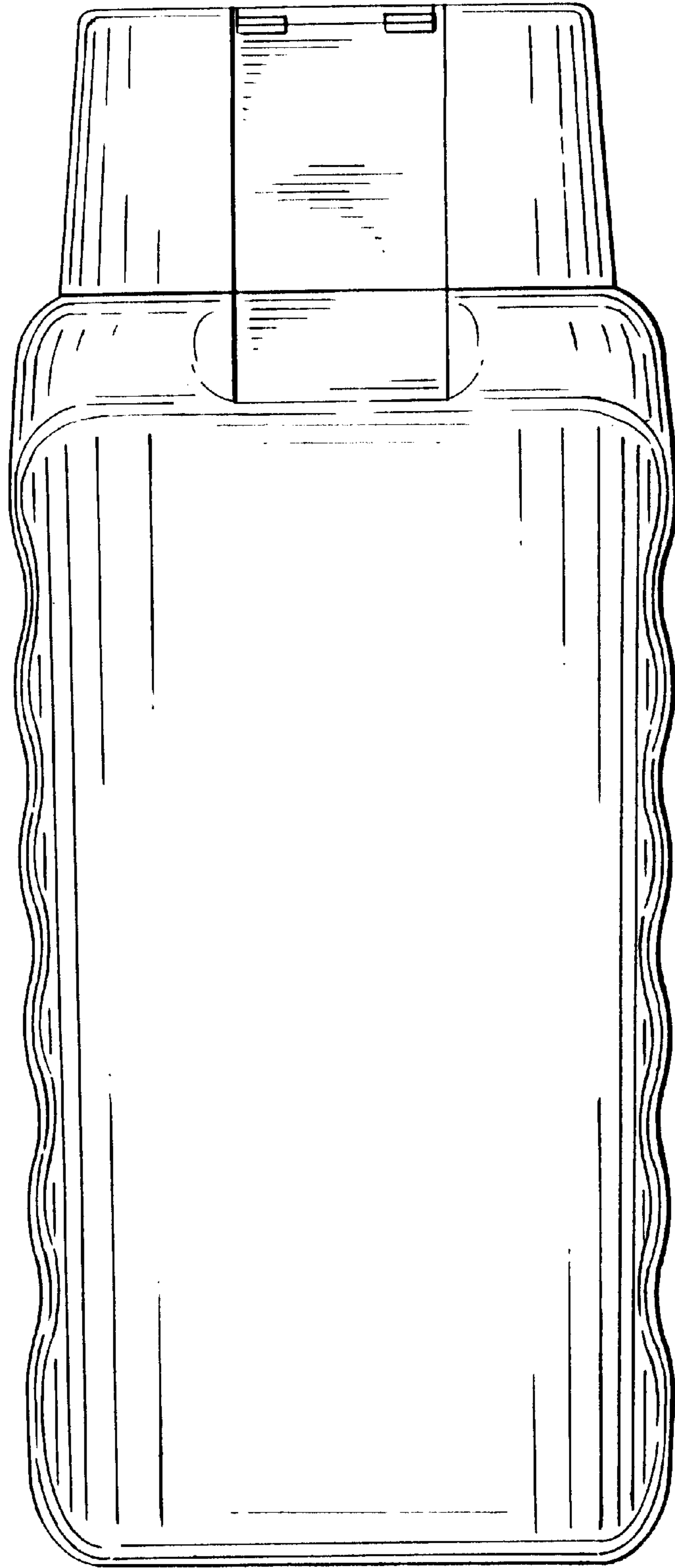

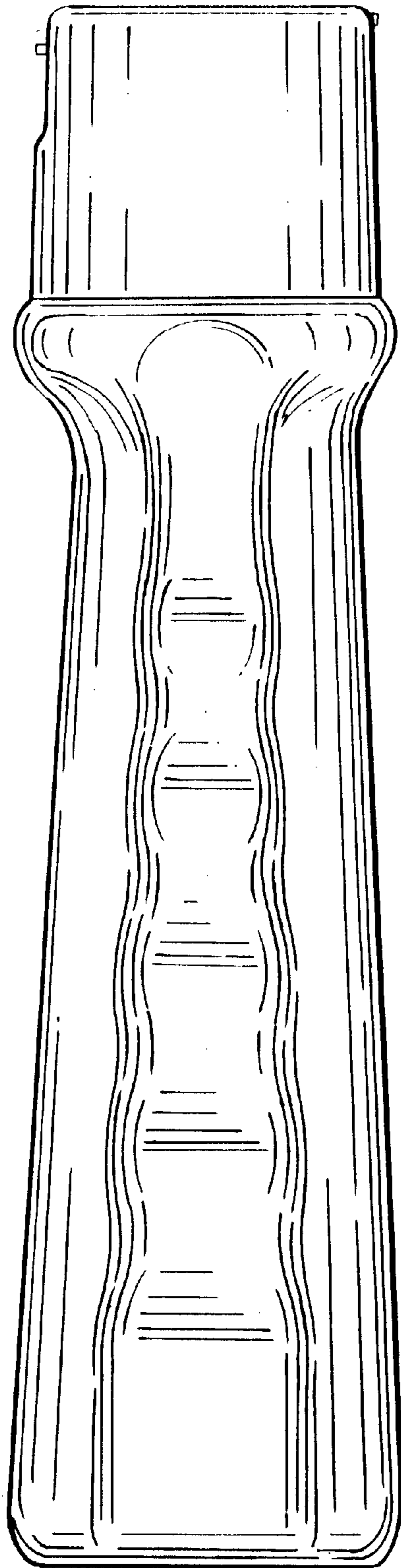

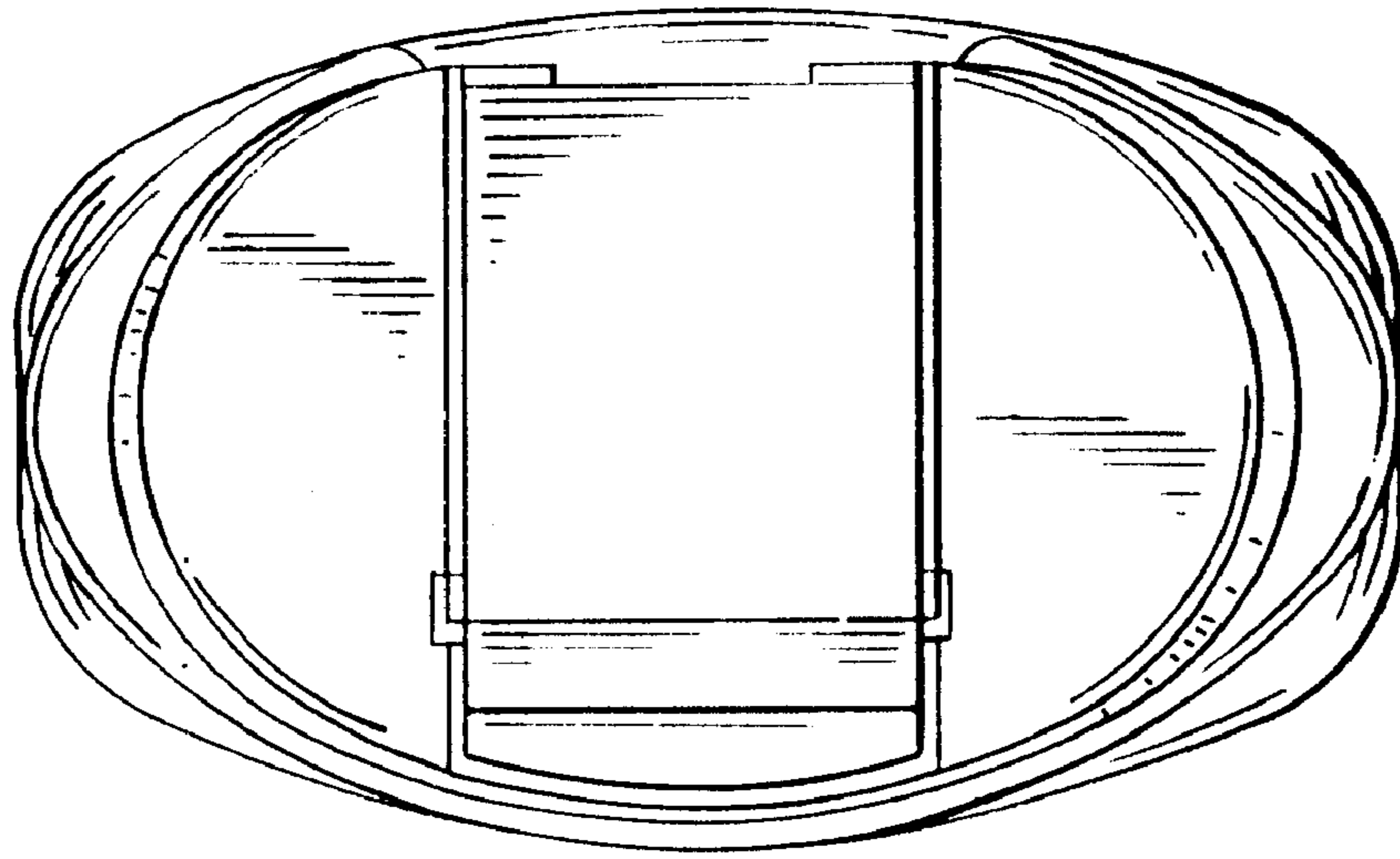

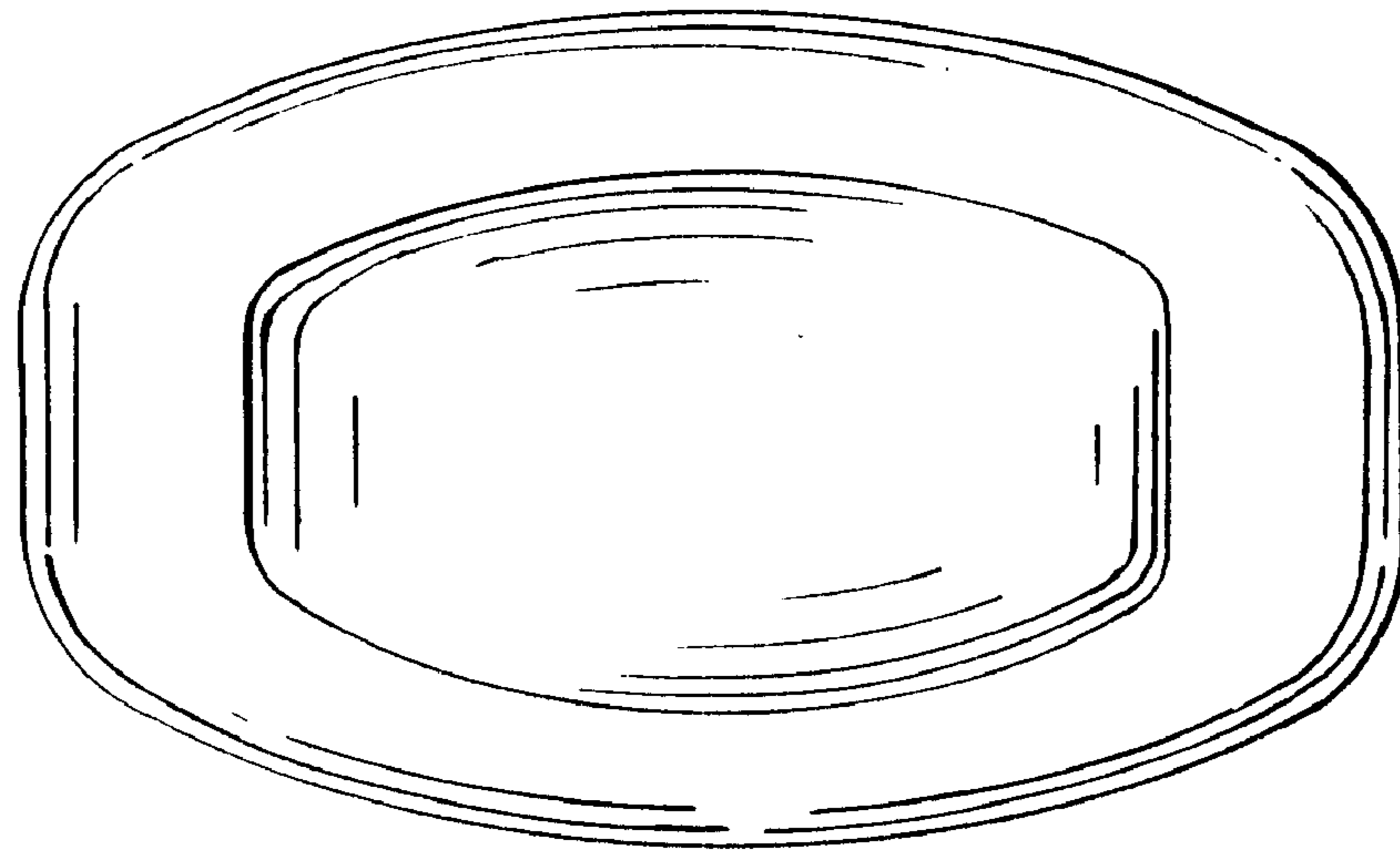
