[57] **CLAIM**

The ornamental design for an electric connector, as shown and described.

FIG. 1 is a perspective view of a first embodiment of an electric connector showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof; and

FIG. 7 is a rear elevational view thereof.

FIG. 8 is a perspective view of a second embodiment of an electric connector showing my new design;

FIG. 9 is a top plan view thereof;

FIG. 10 is a left side elevational view thereof;

FIG. 11 is a front elevational view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a right side elevational view thereof; and

FIG. 14 is a rear elevational view thereof.

FIG. 15 is a top, front, left perspective view of a third embodiment of an electric connector showing my new design;

FIG. 16 is a top, rear, right perspective view thereof;

FIG. 17 is a top plan view thereof;

FIG. 18 is a left side elevational view thereof;

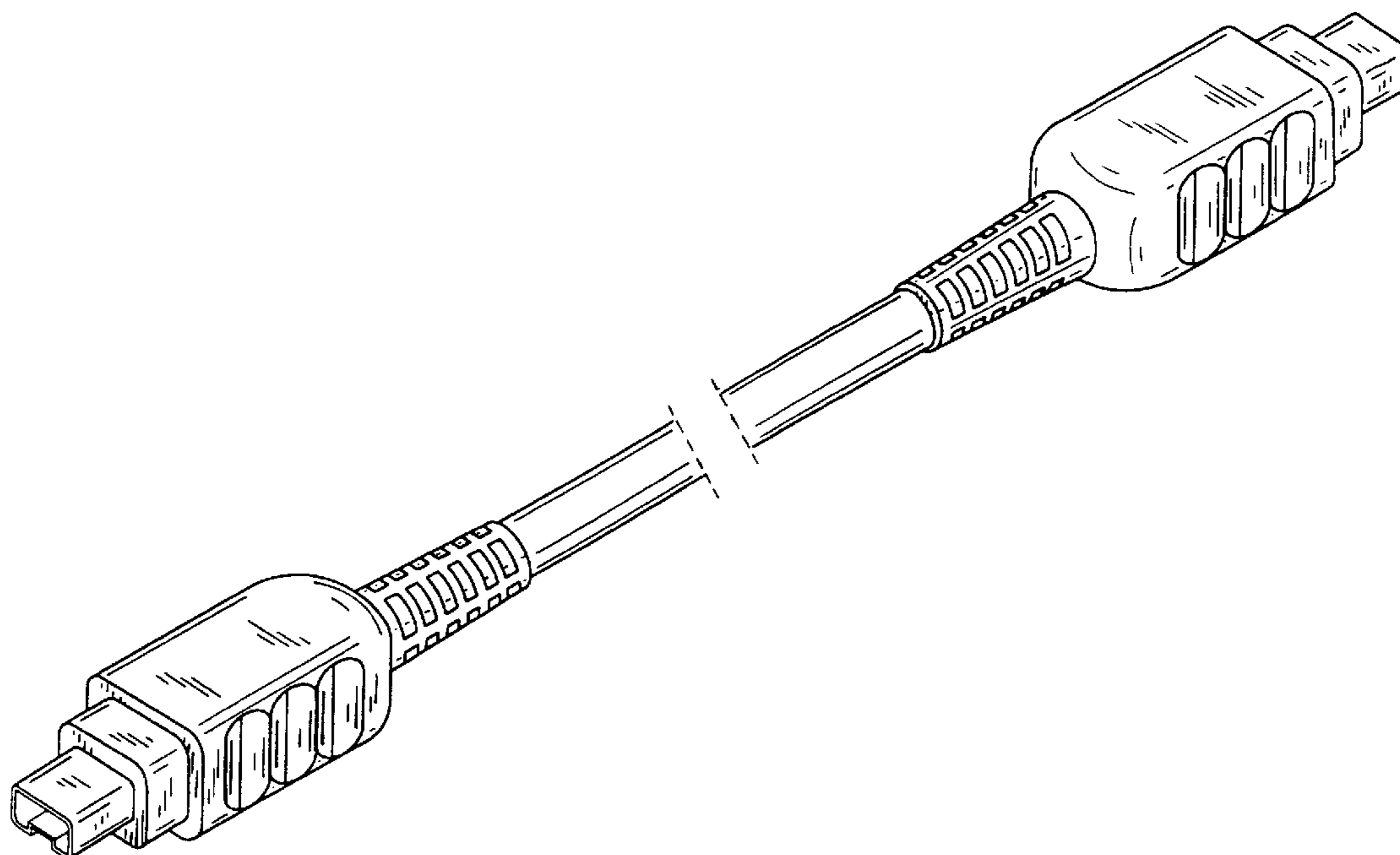
FIG. 19 is a front elevational view thereof, a rear elevational view thereof being a mirror image;

FIG. 20 is a bottom plan view thereof; and,

FIG. 21 is a right side elevational view thereof.

The broken line showing of the cable in FIGS. 1-7 is included for the purpose of illustrating environmental structure only and forms no part of the first embodiment. In FIGS. 8-14, the cable is shown broken away to indicate indeterminate length.

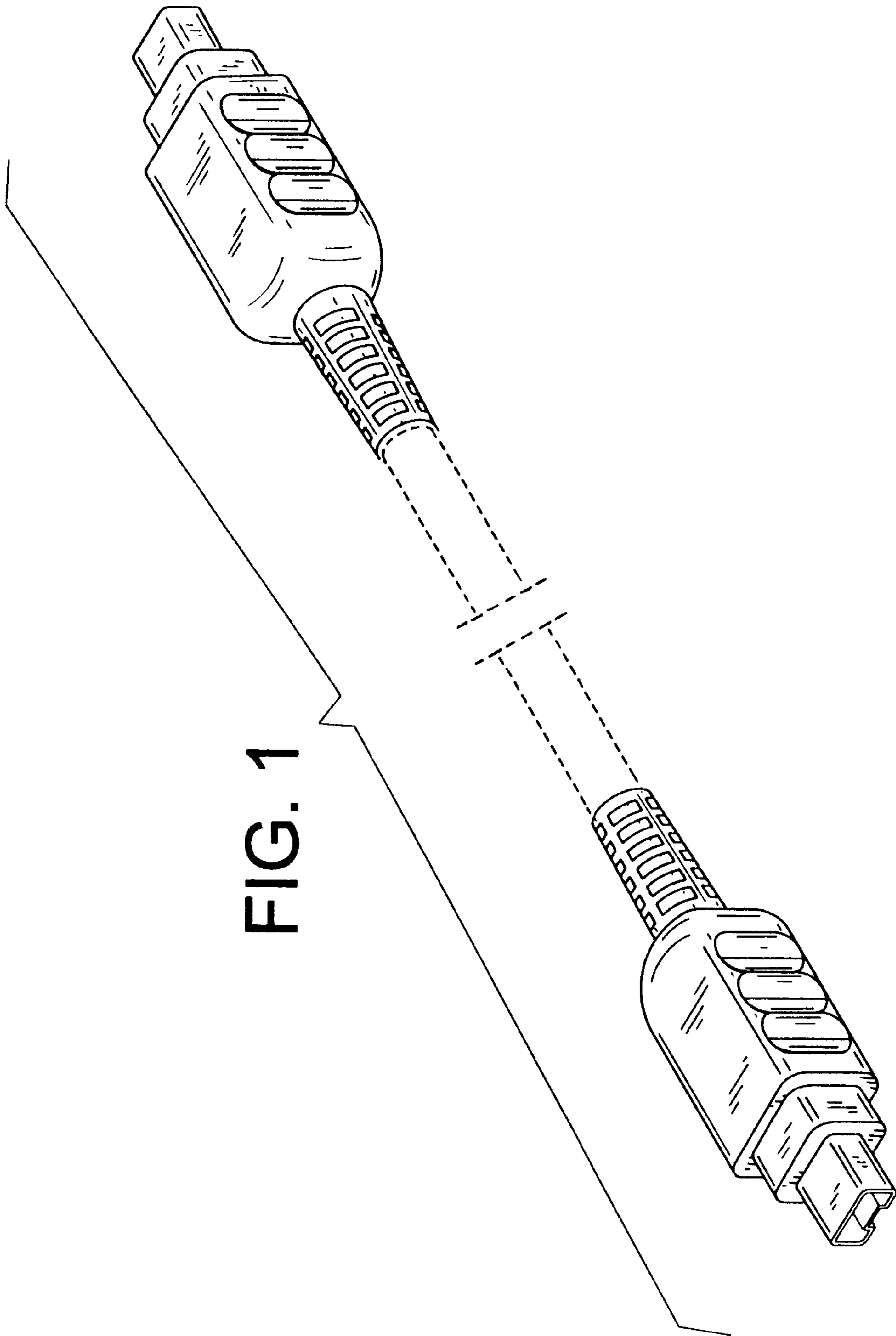

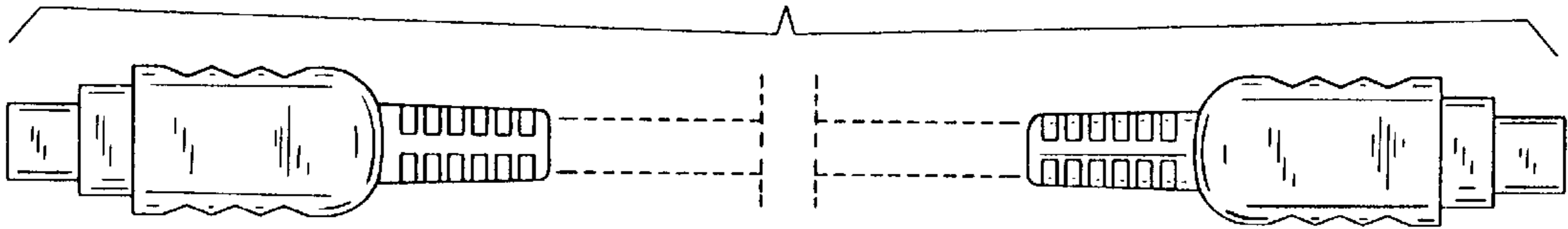

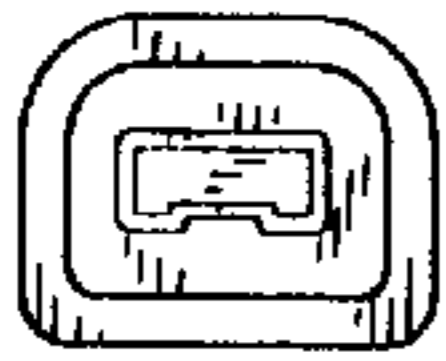

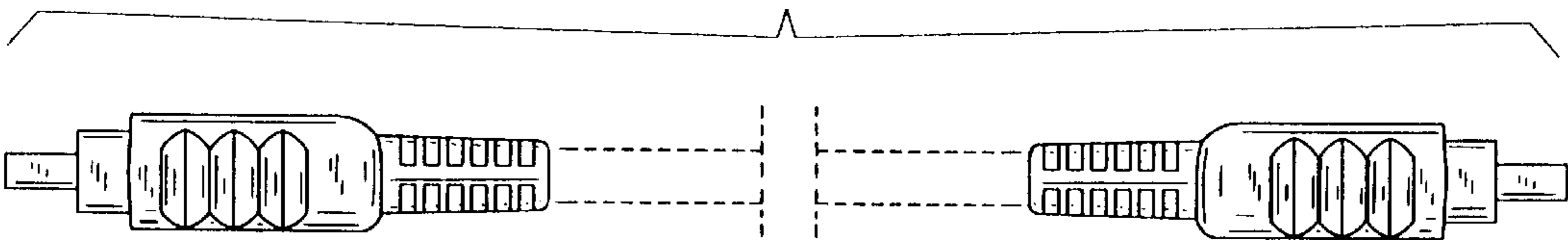

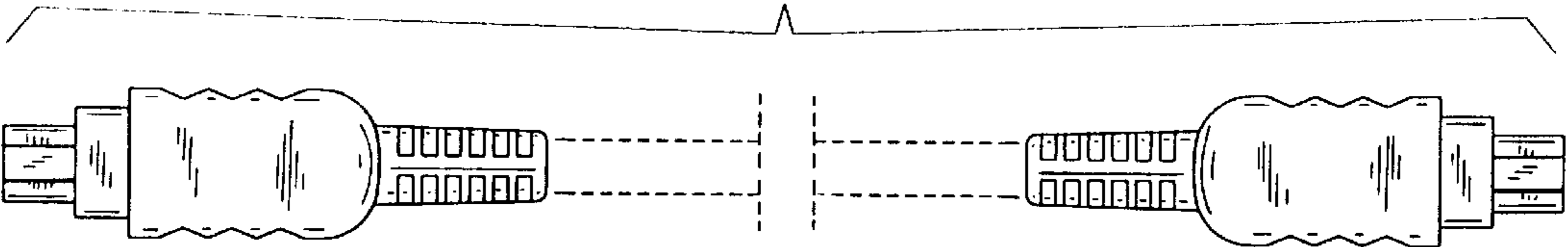
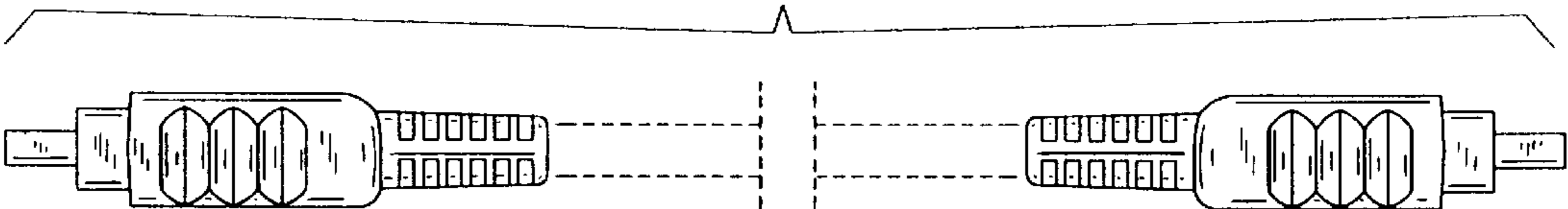

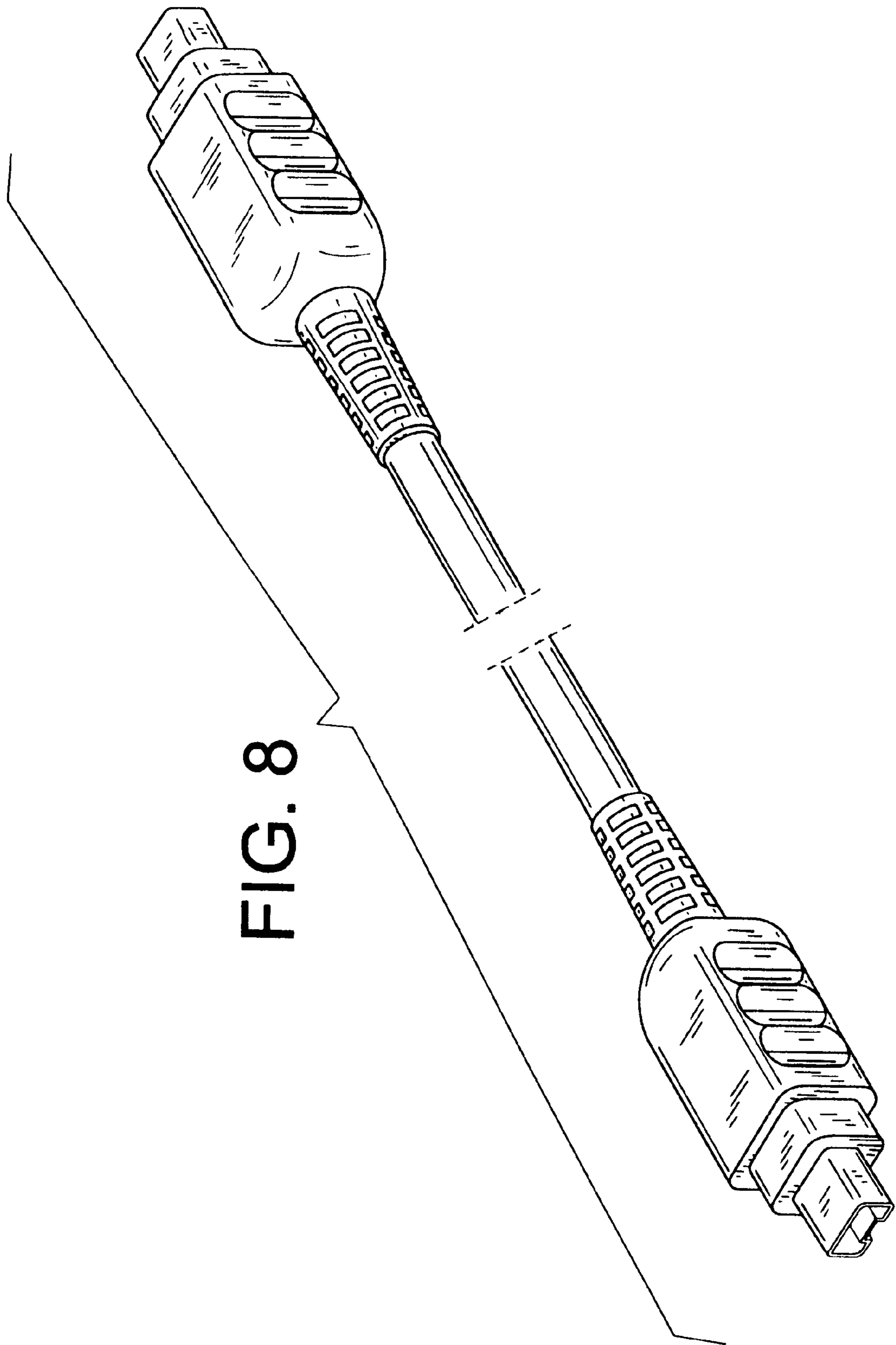

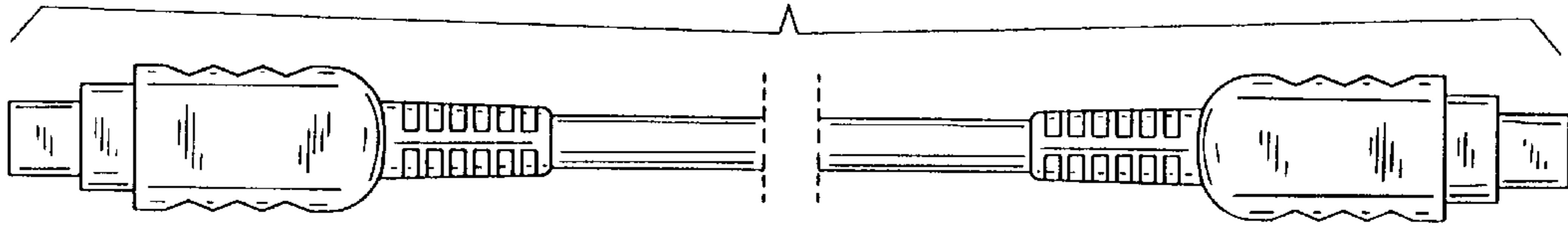

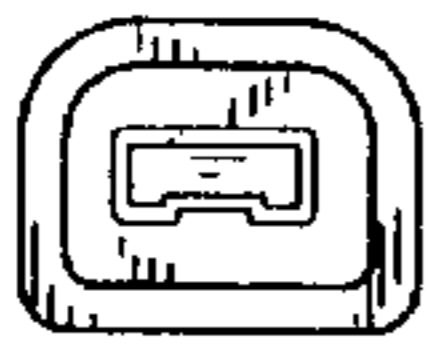

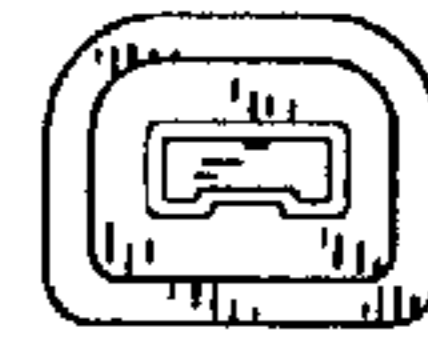

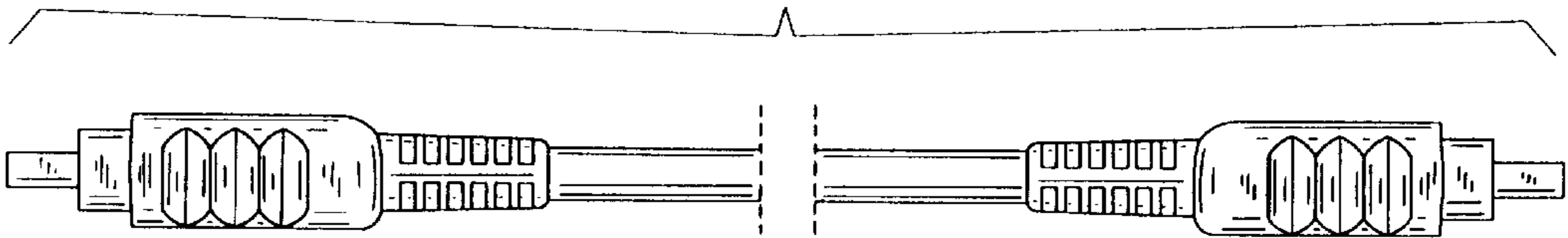

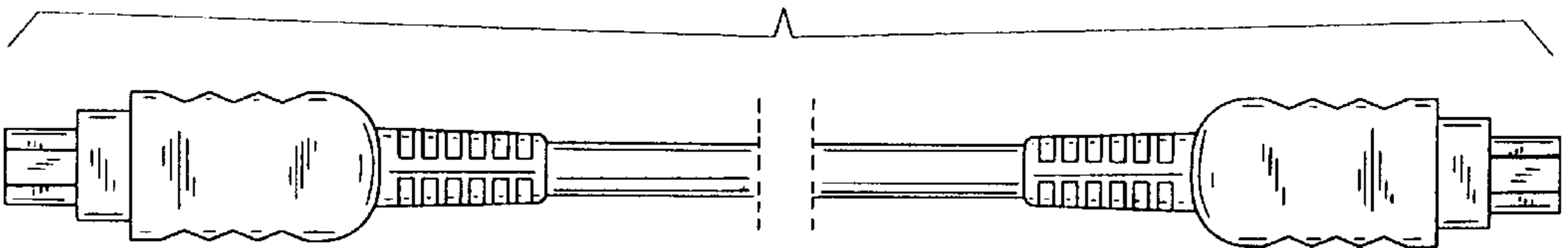

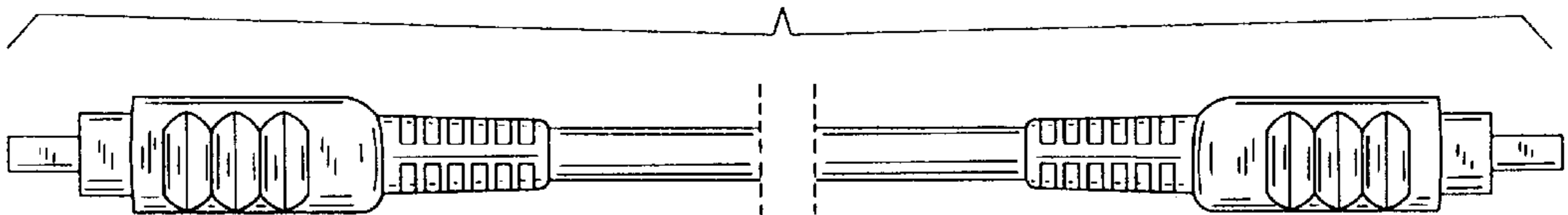

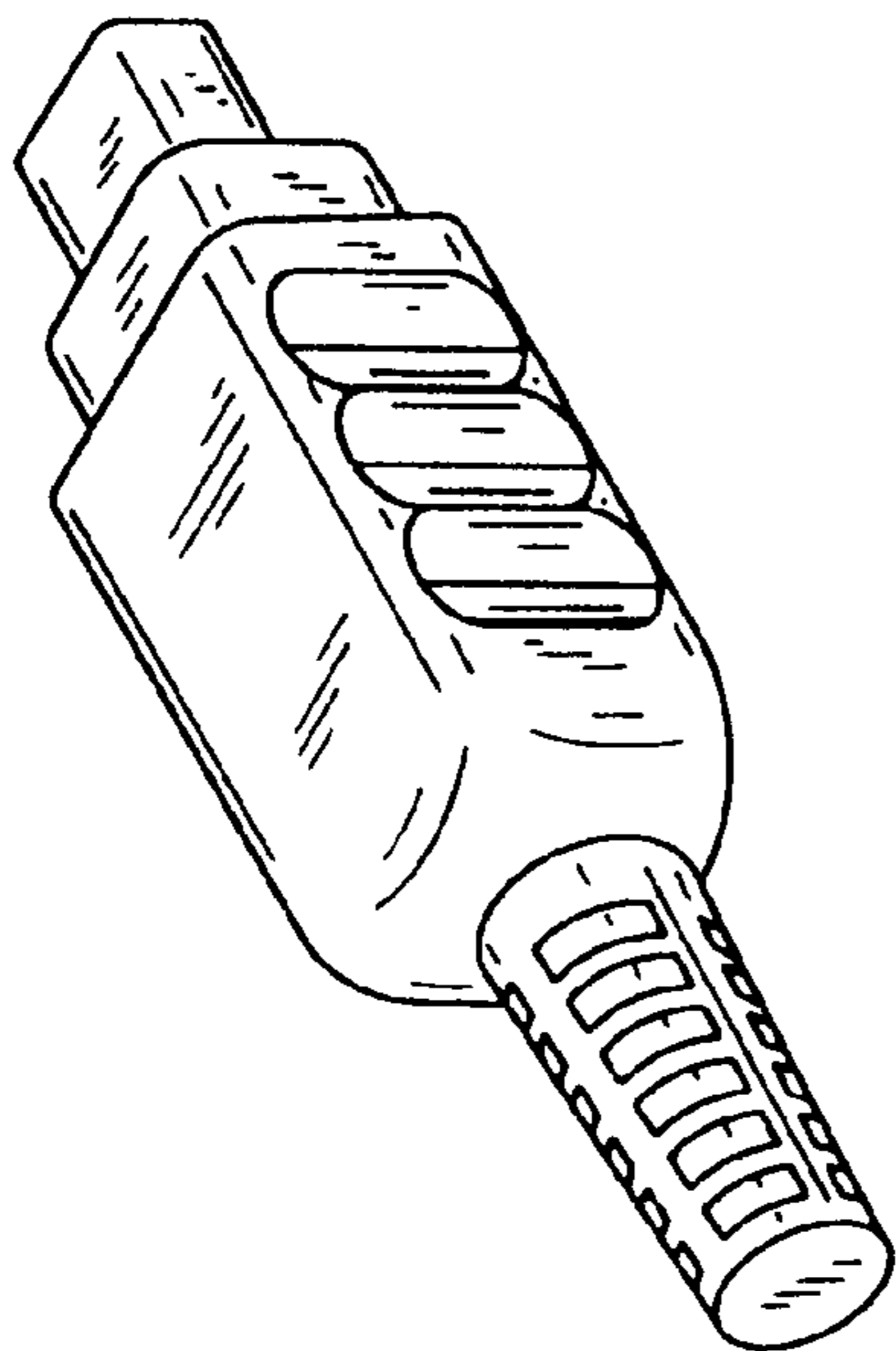

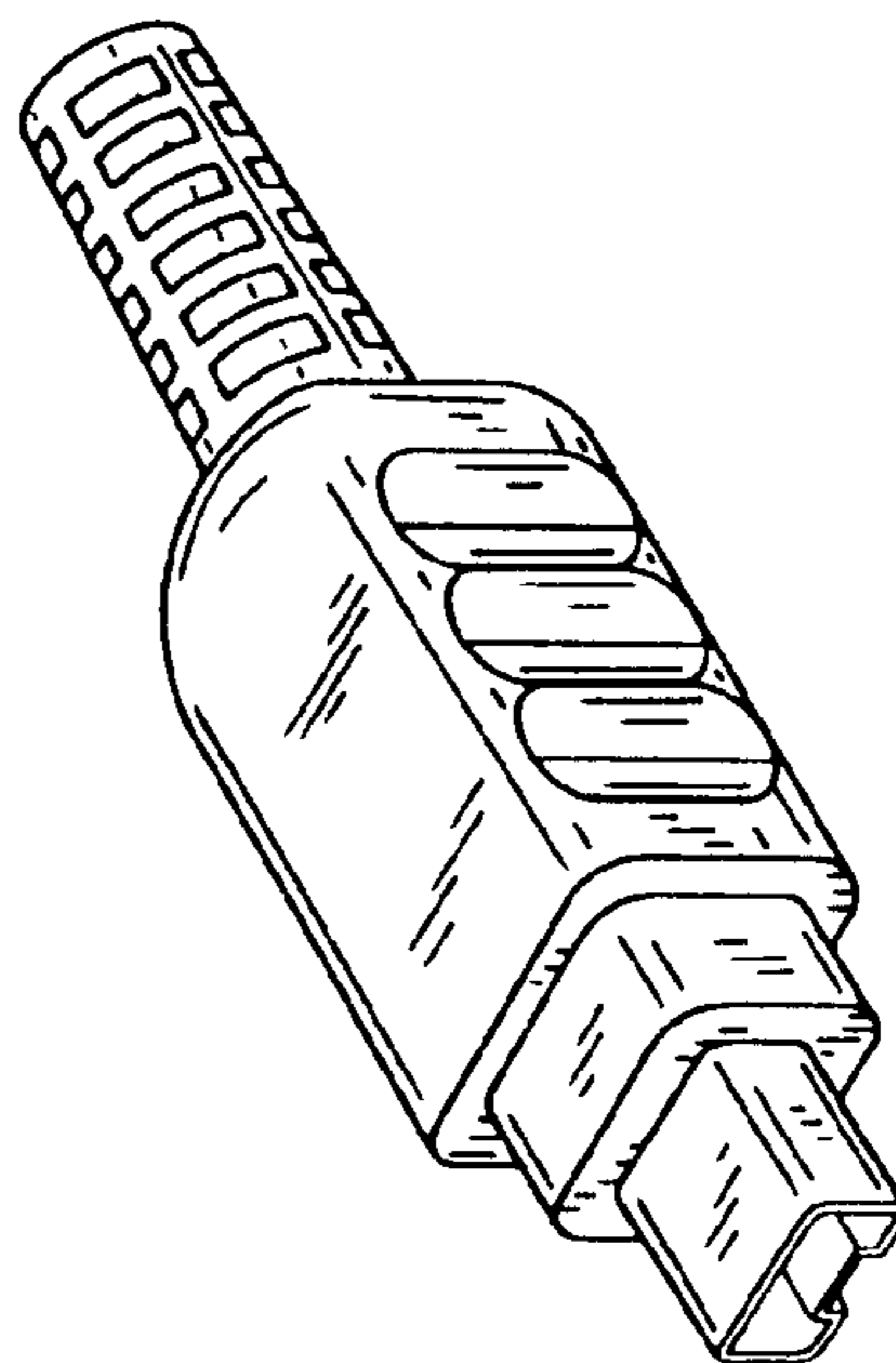

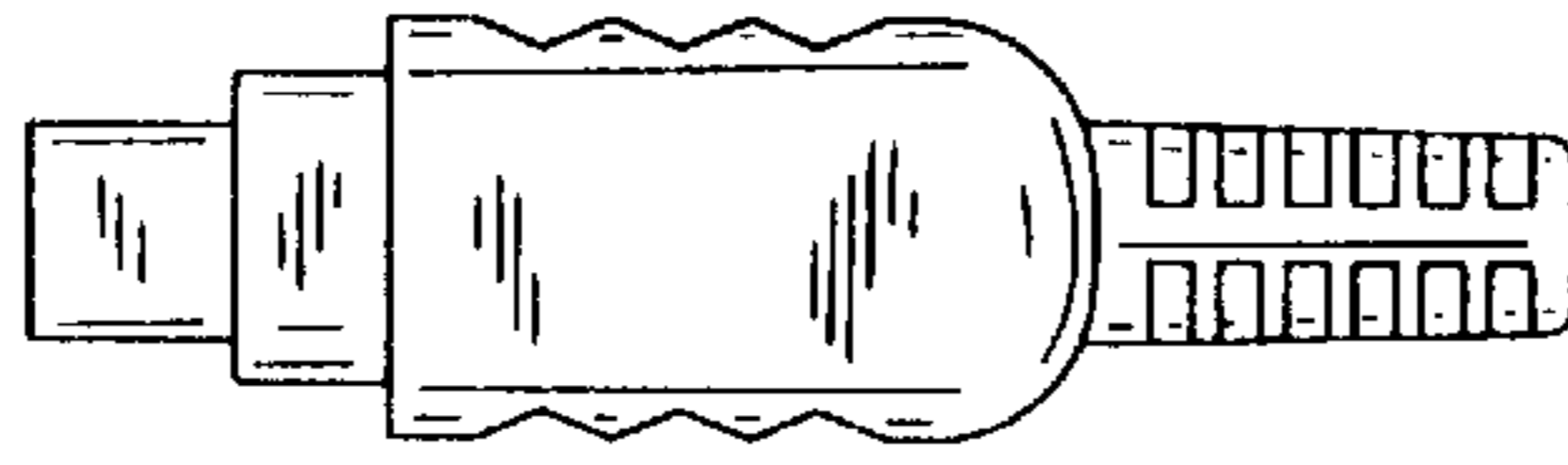

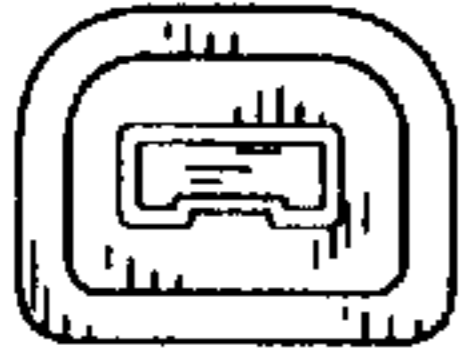

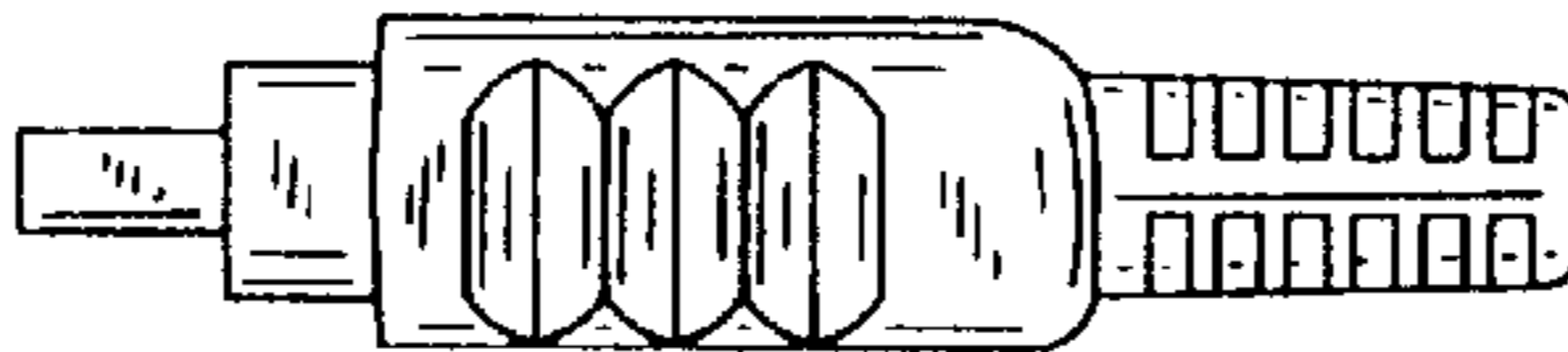
