The ornamental design for a combined card reader and fingerprint scanner, as shown.

DESCRIPTION

FIG. 1 is an isometric view of the combined card reader and fingerprint scanner;

FIG. 4 is a side view of the invention shown in FIG. 1;

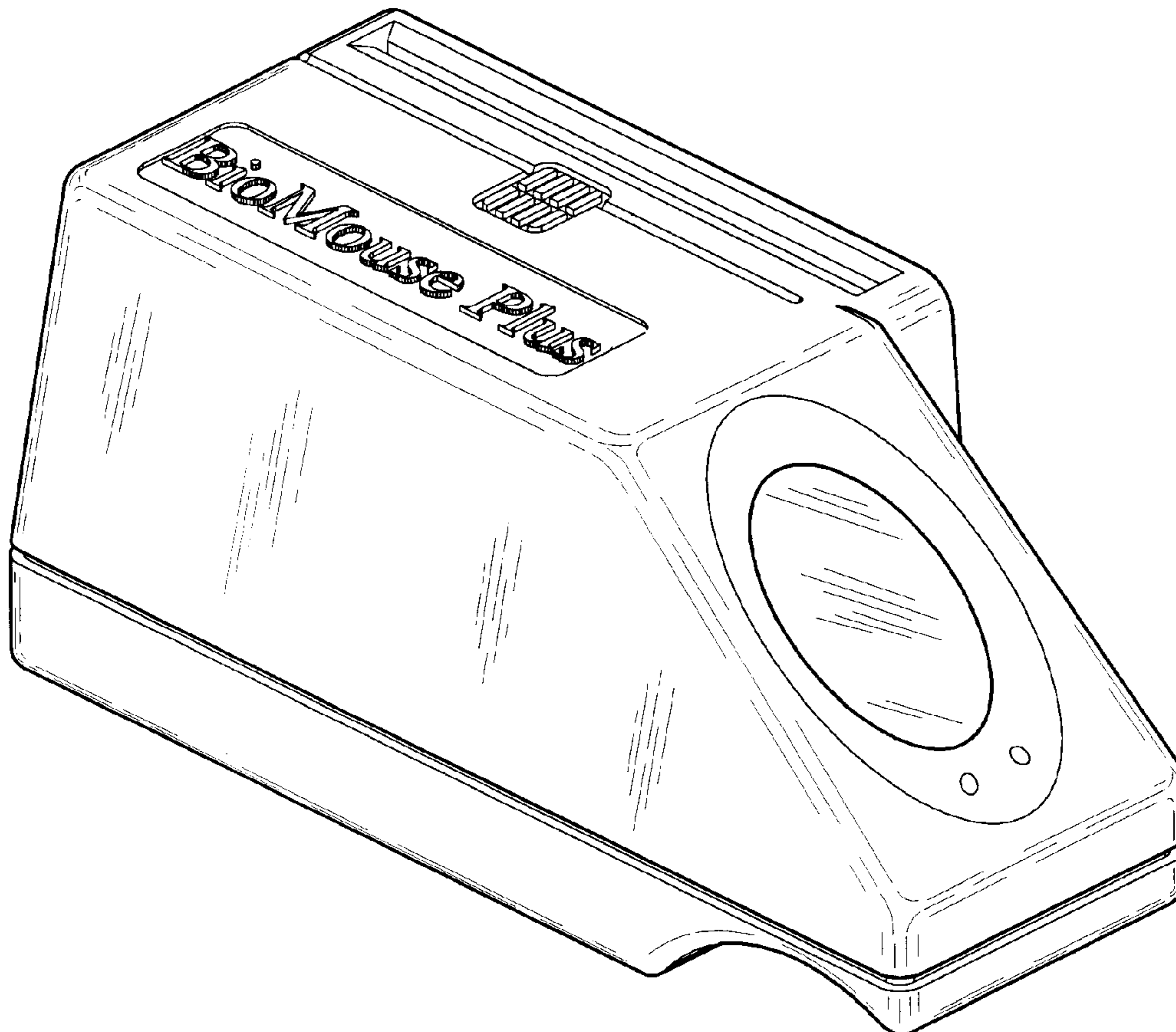
FIG. 5 is a front view of the invention shown in FIG. 1;

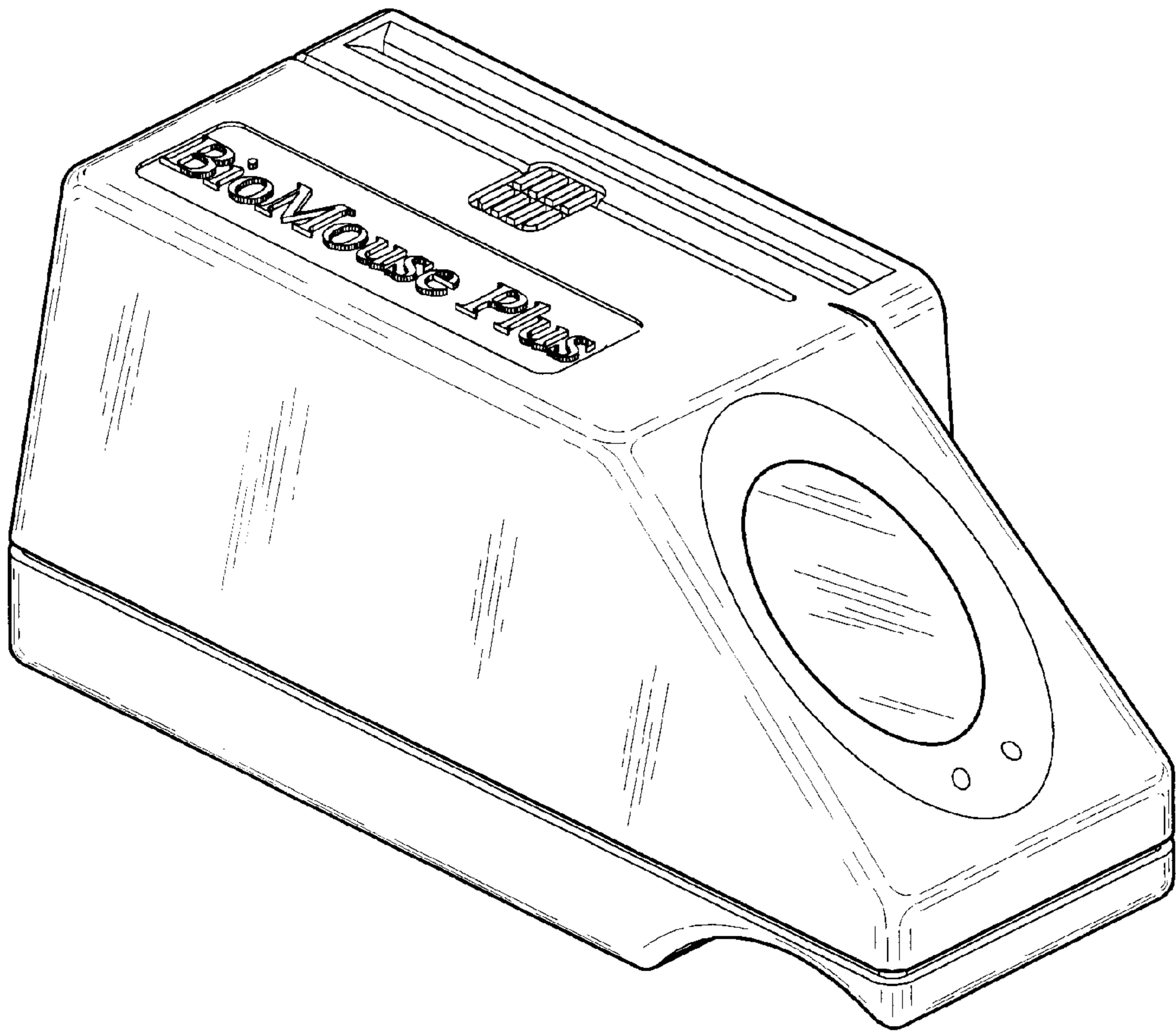

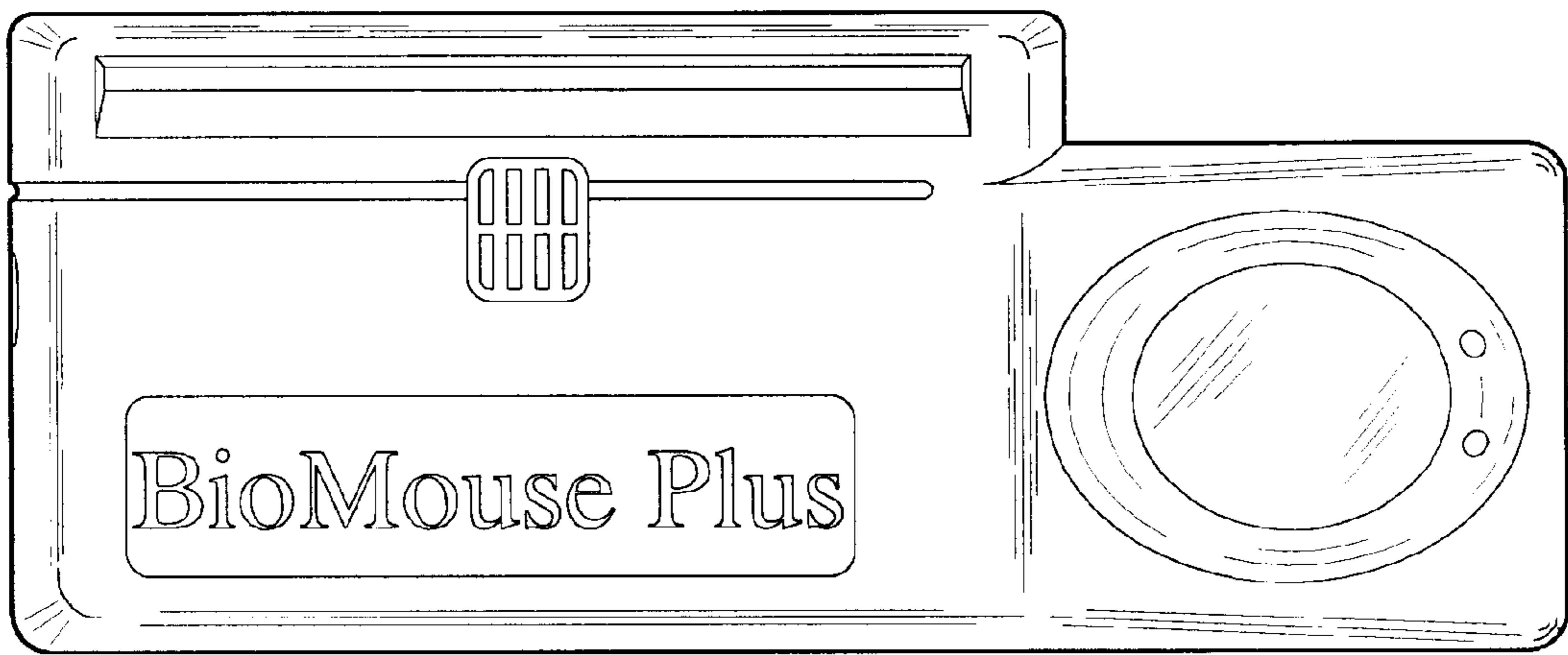

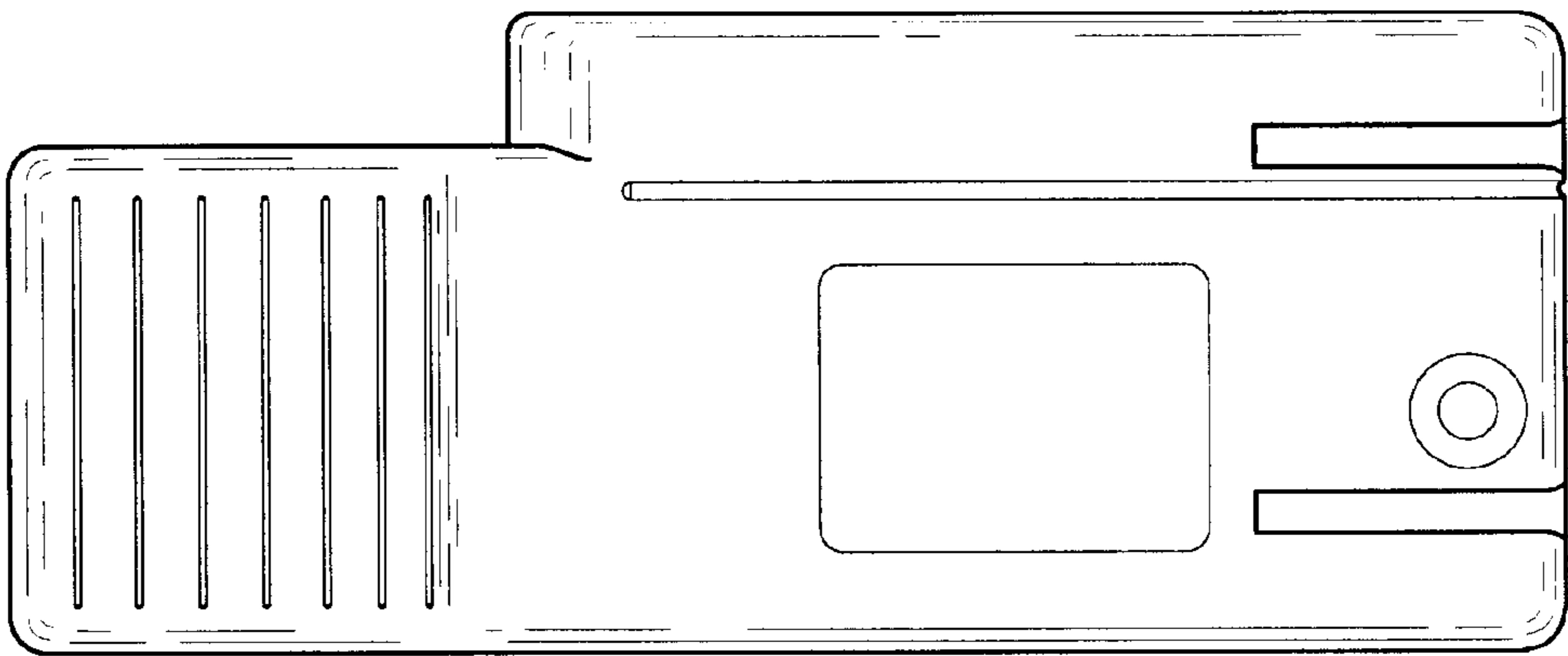

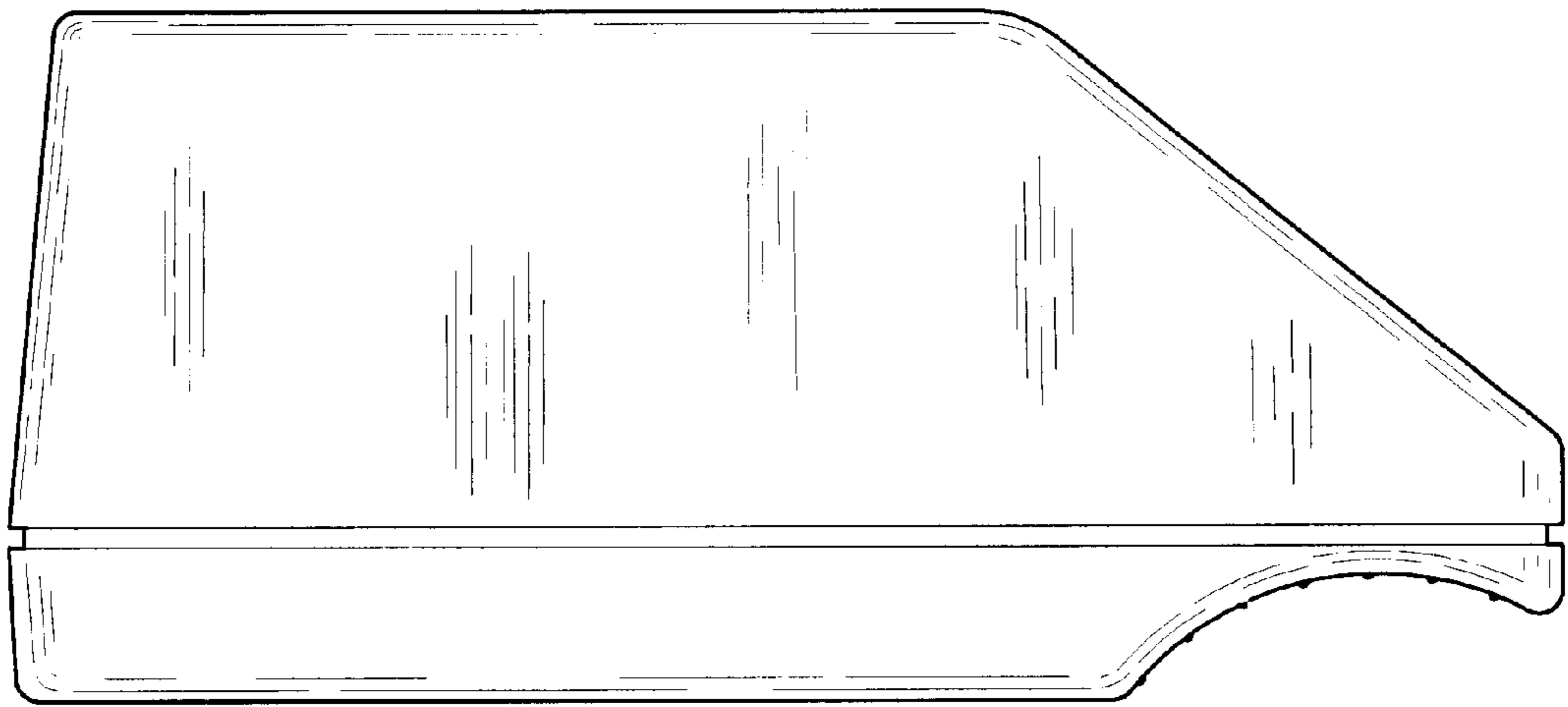

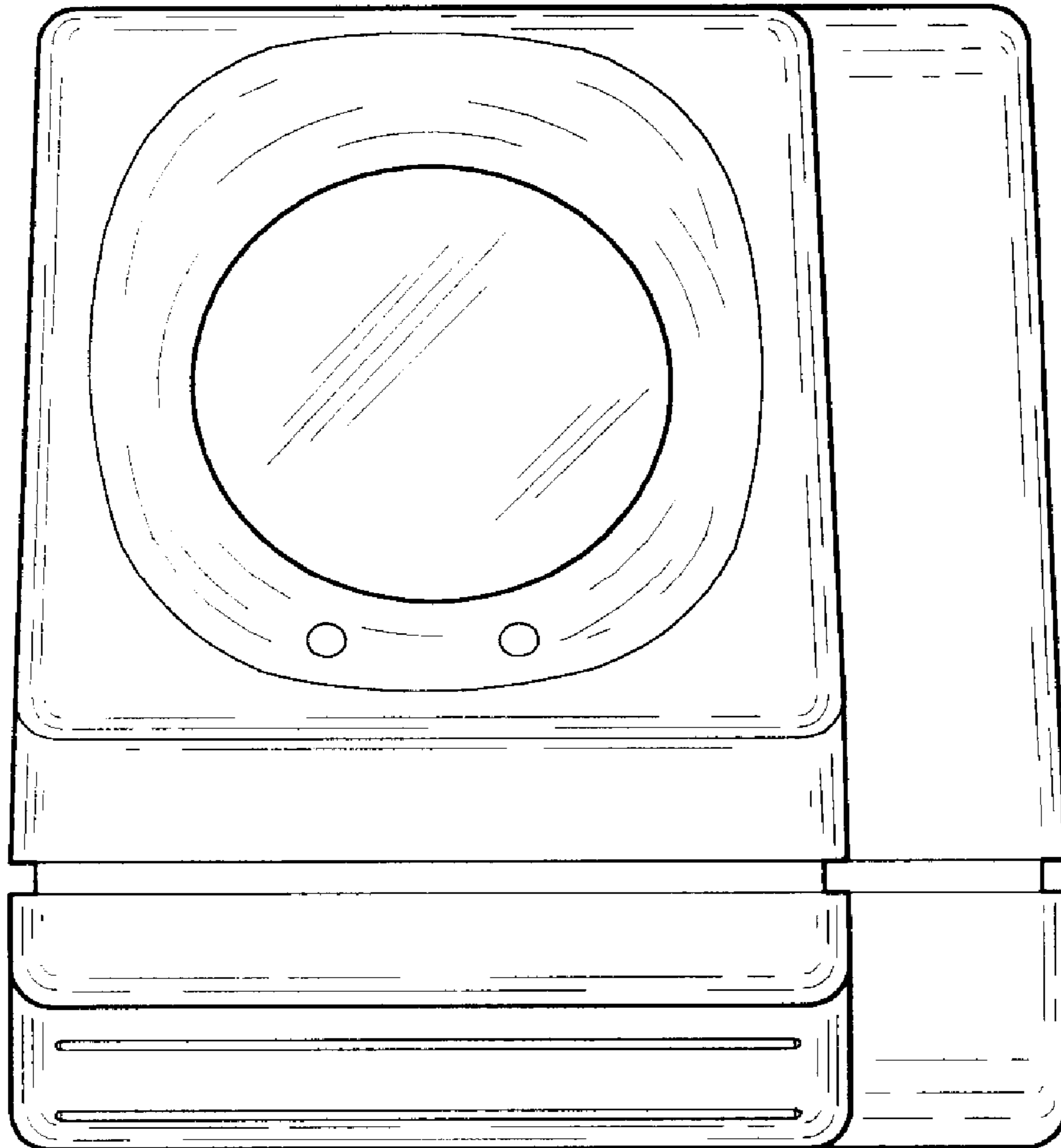

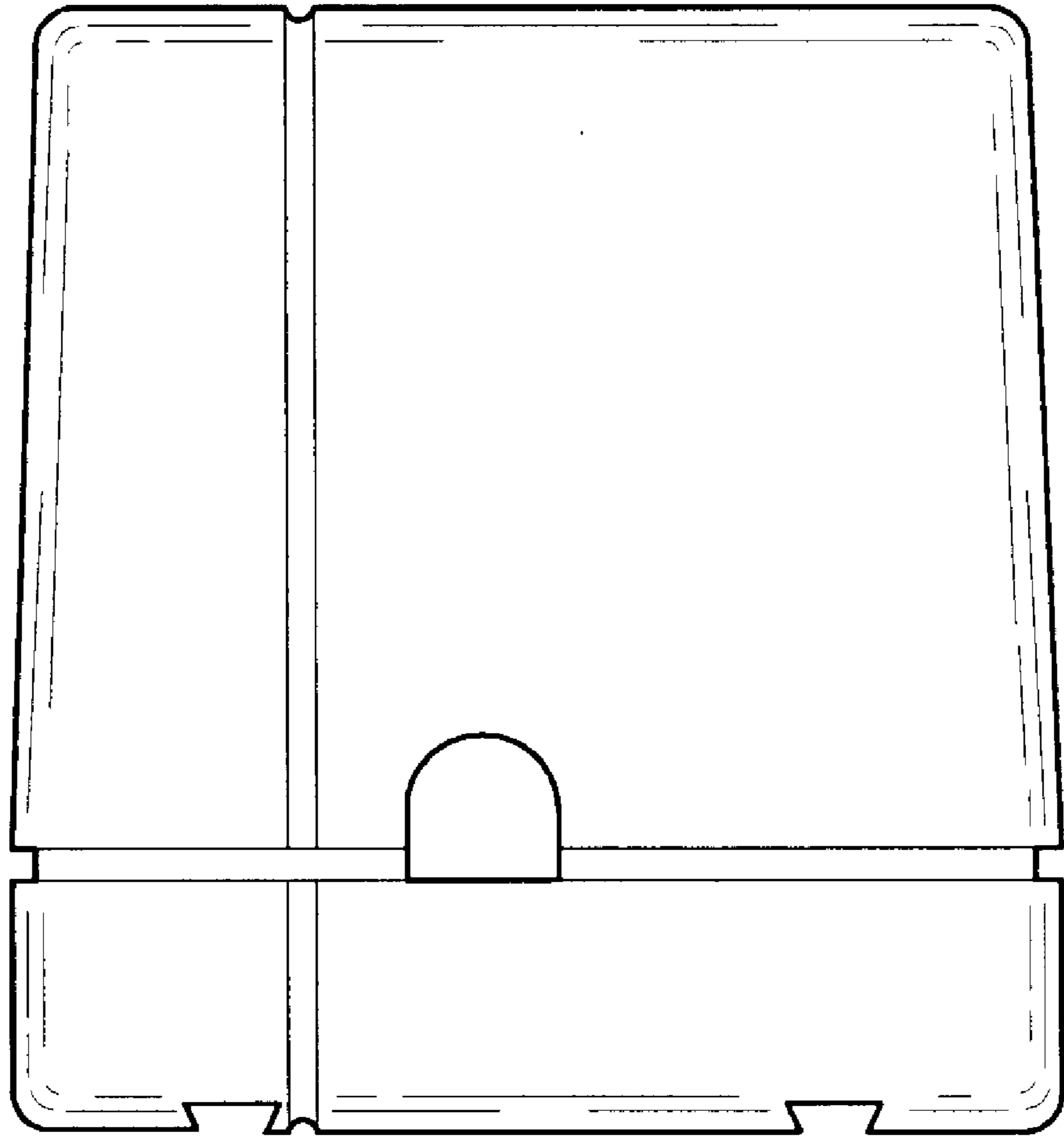

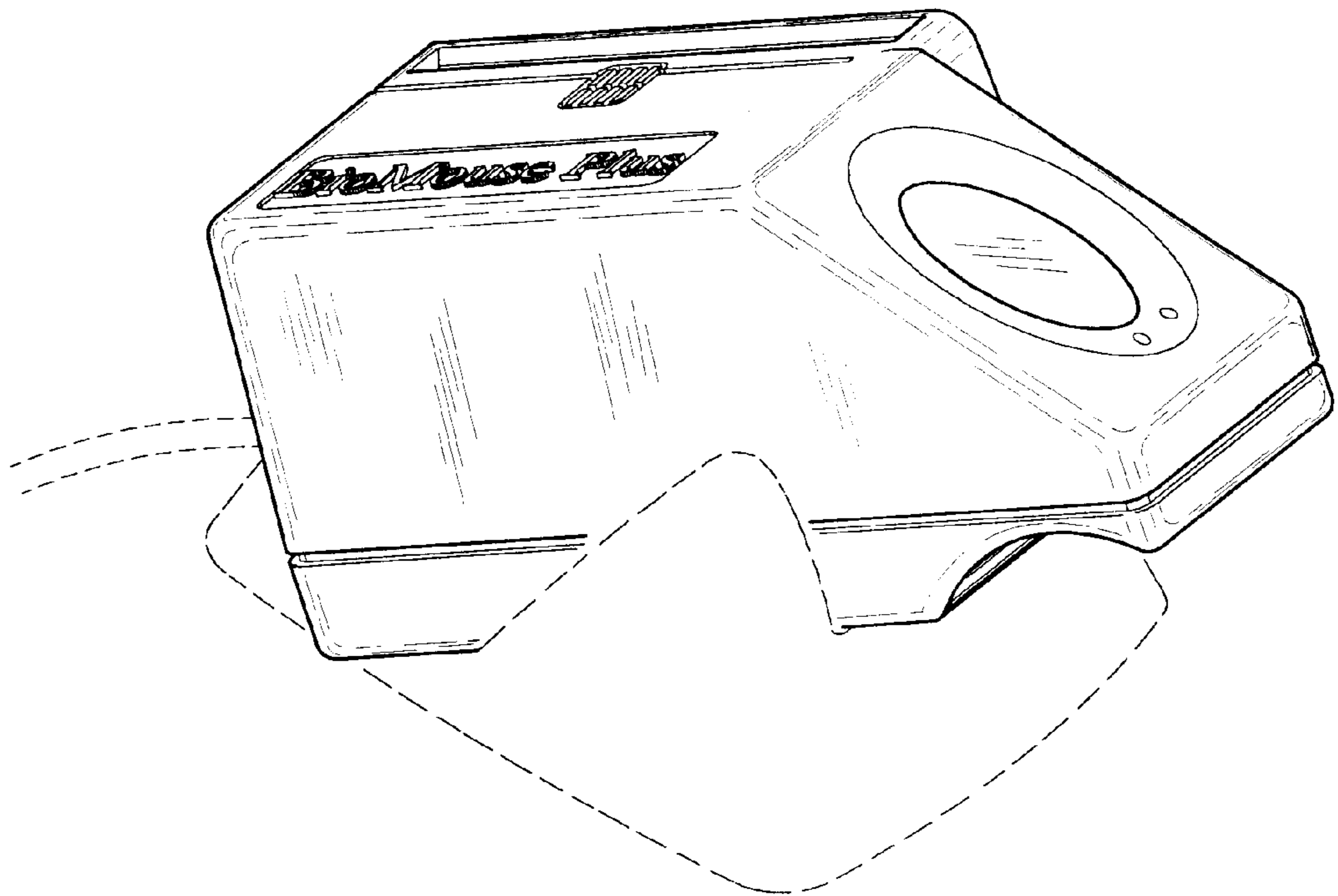

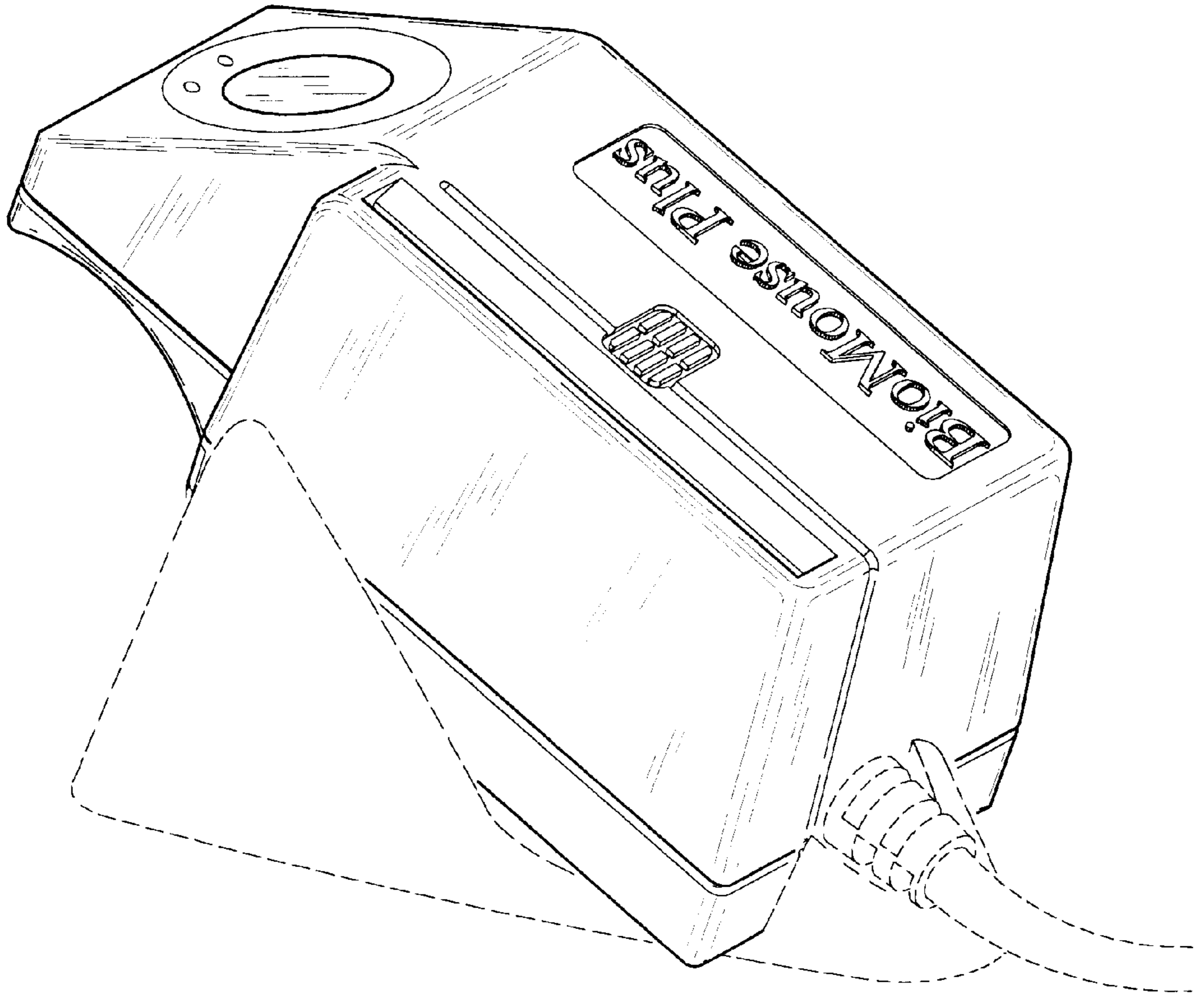
