FIG. 10 is a front and rear elevation view thereof;

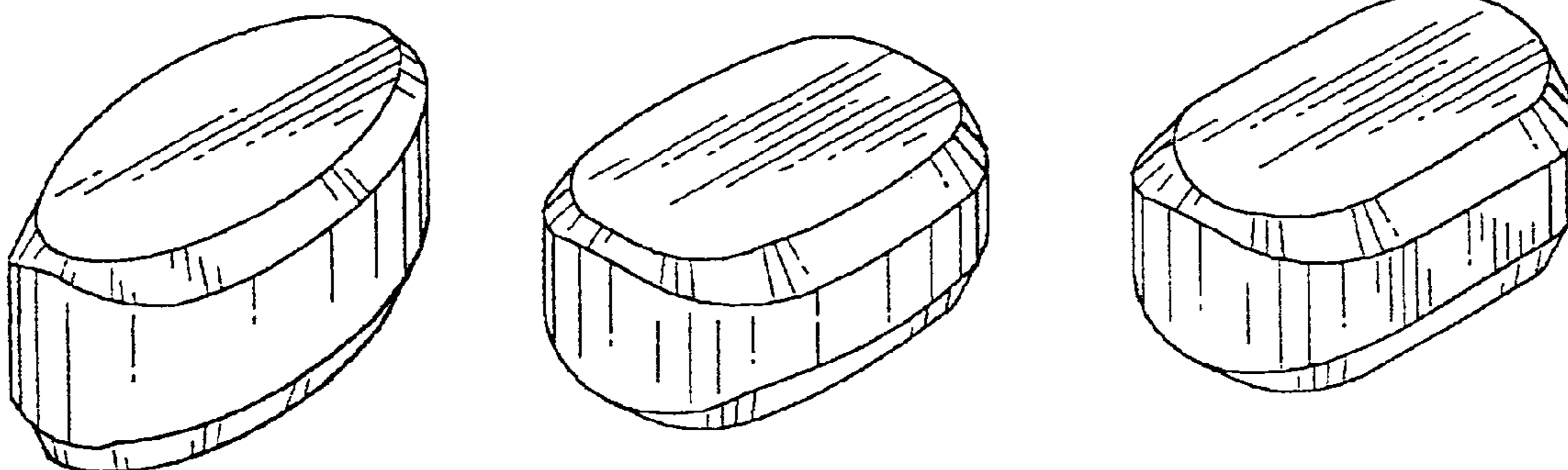
FIG. 11 is a left and right side elevation view thereof; and,

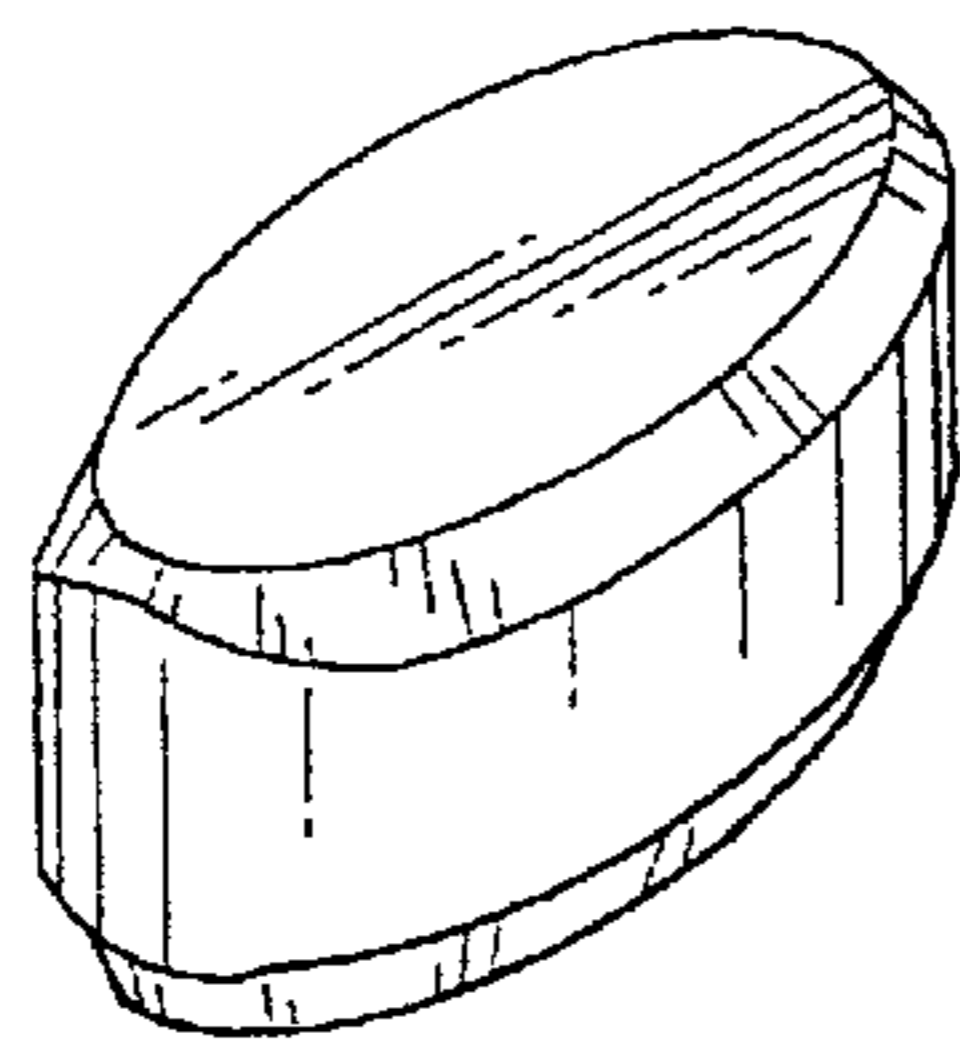

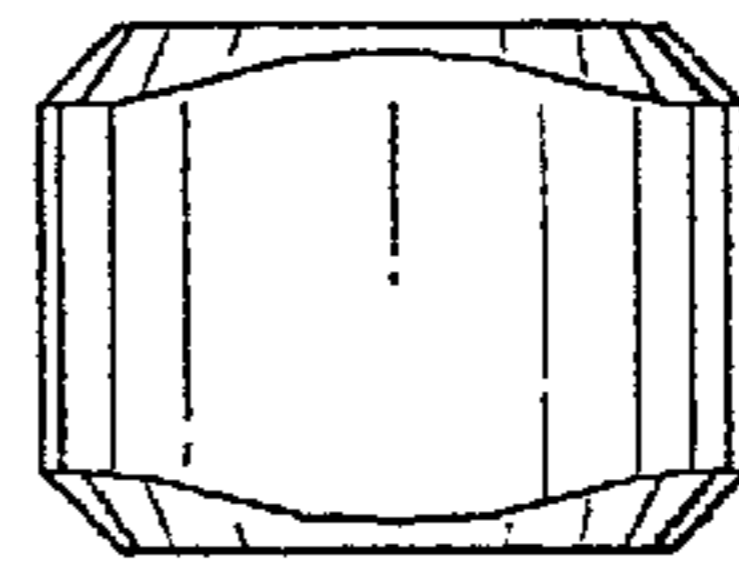

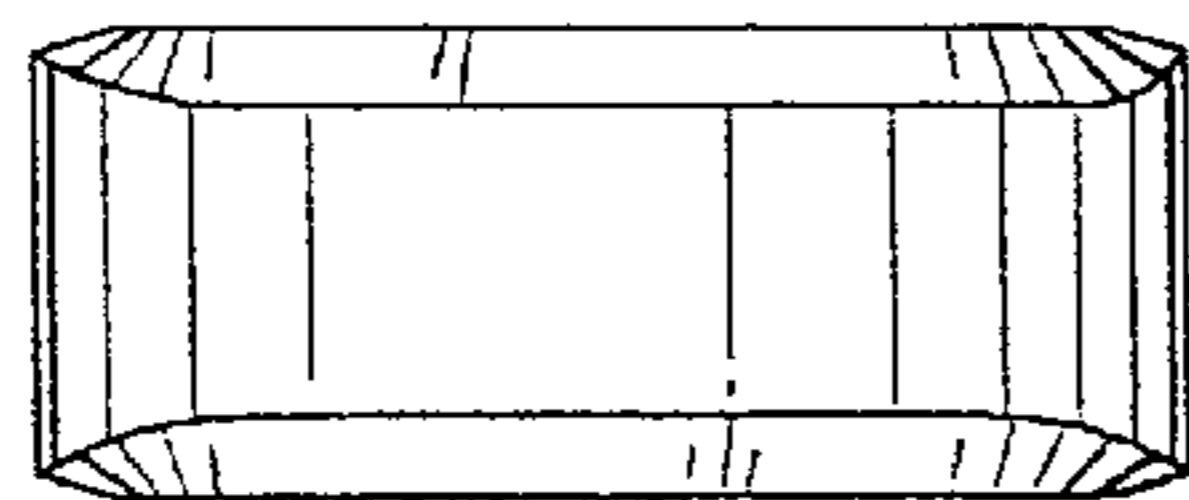

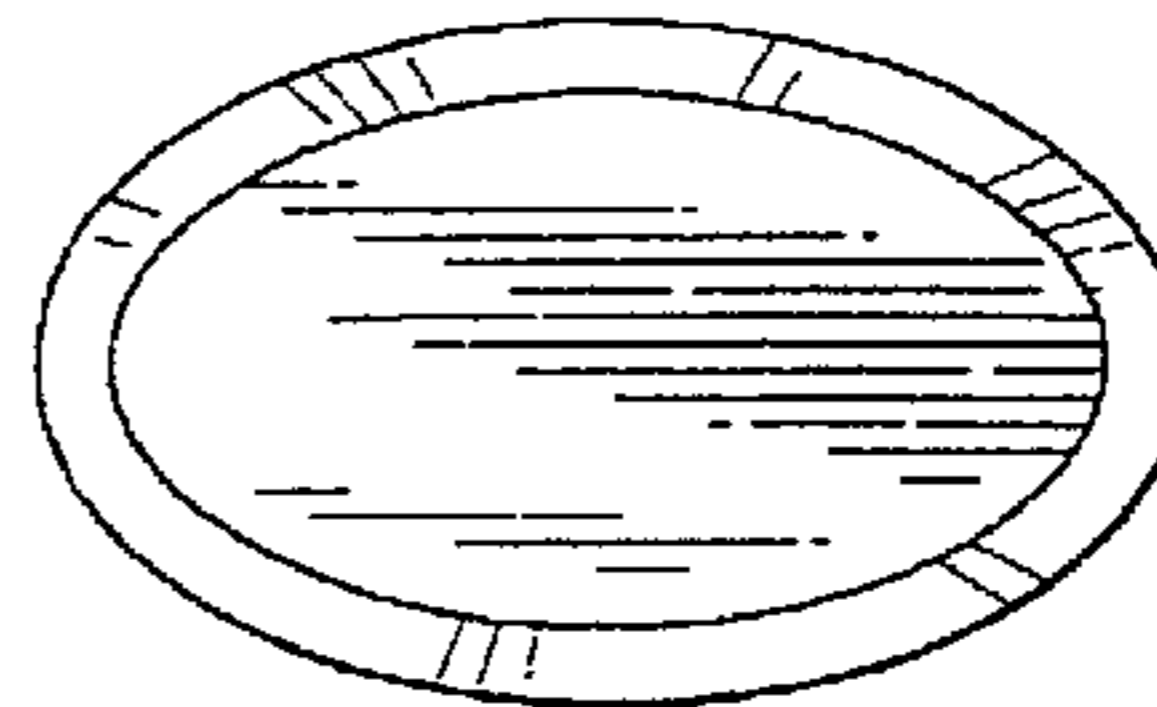

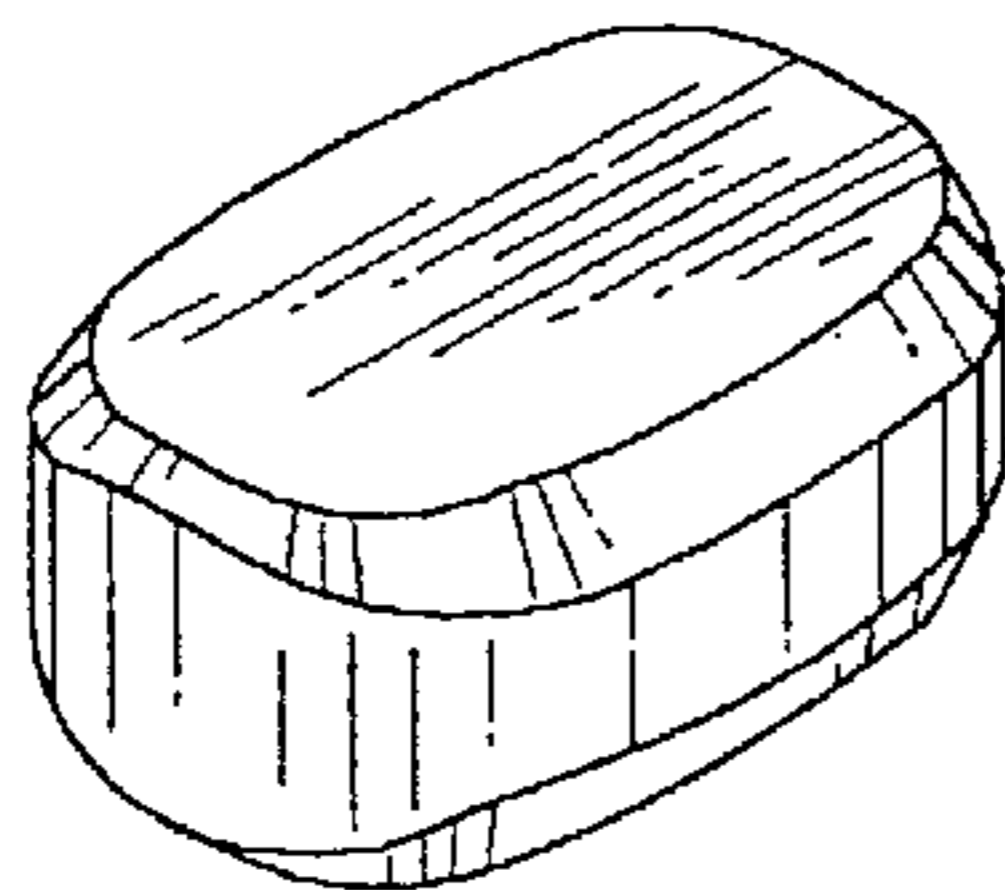

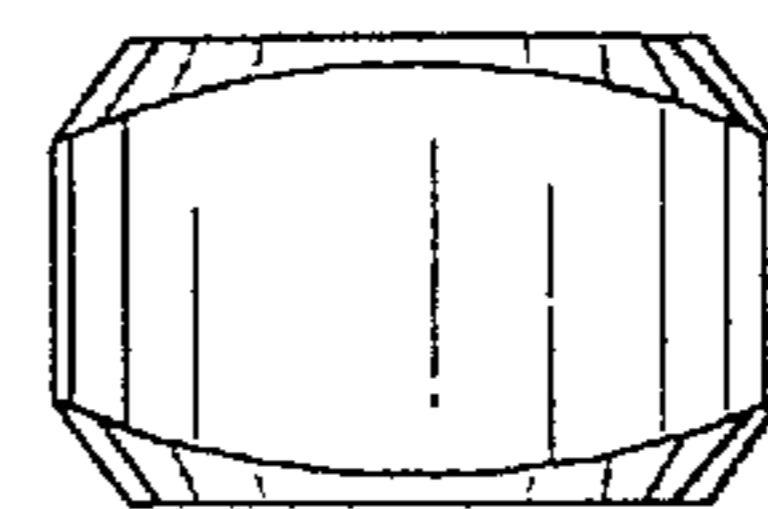

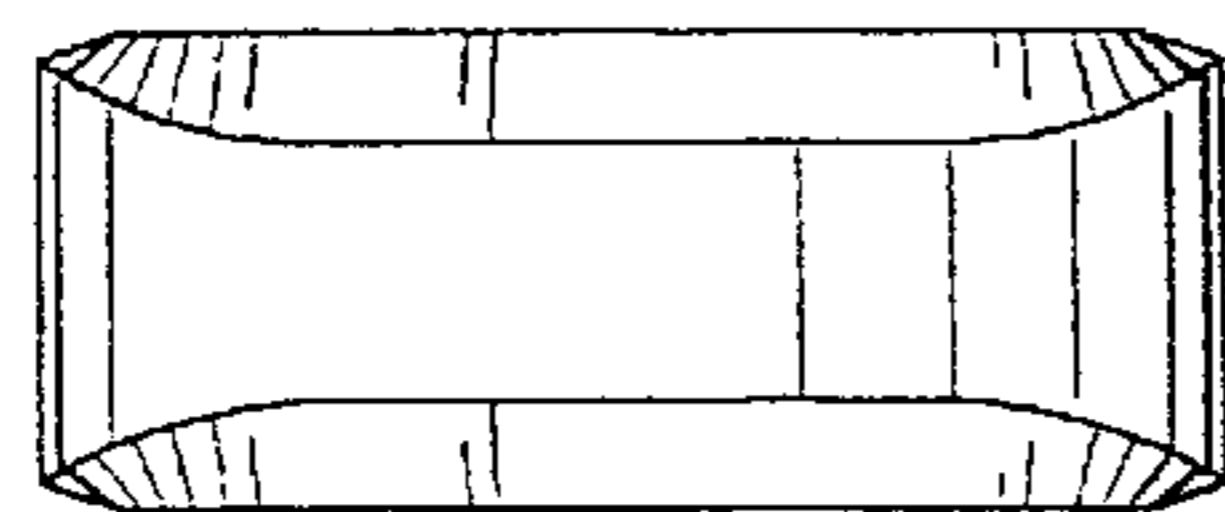

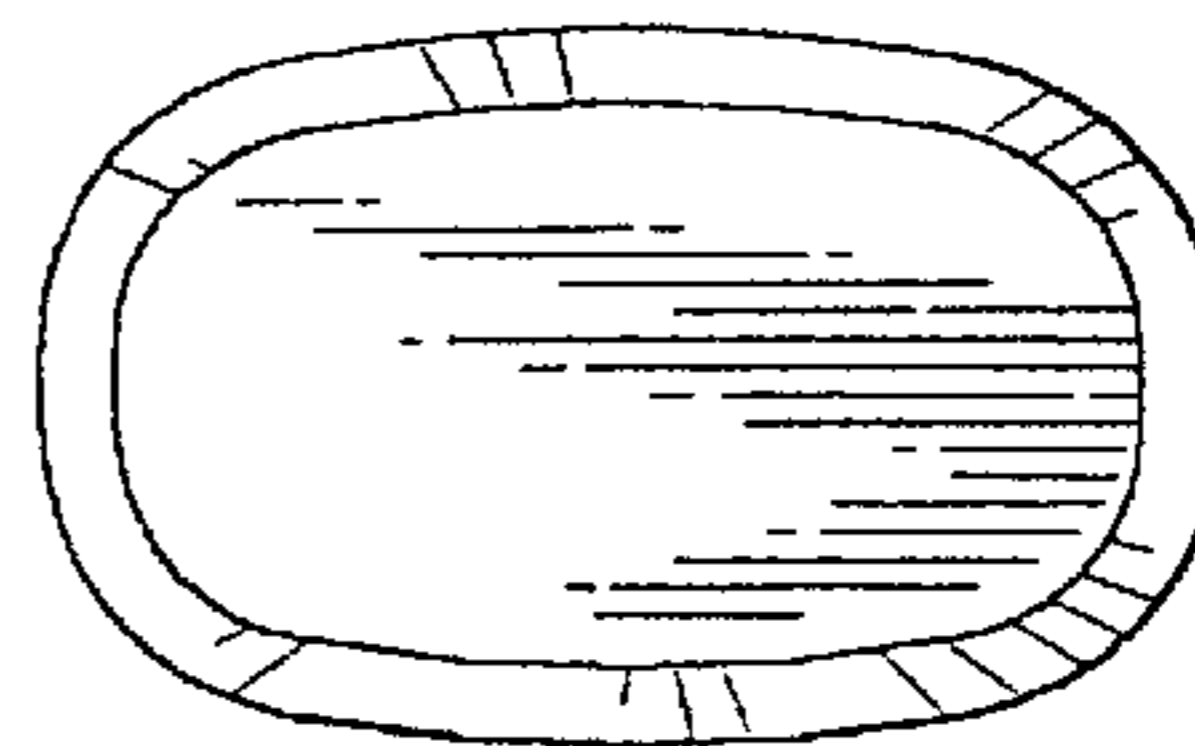

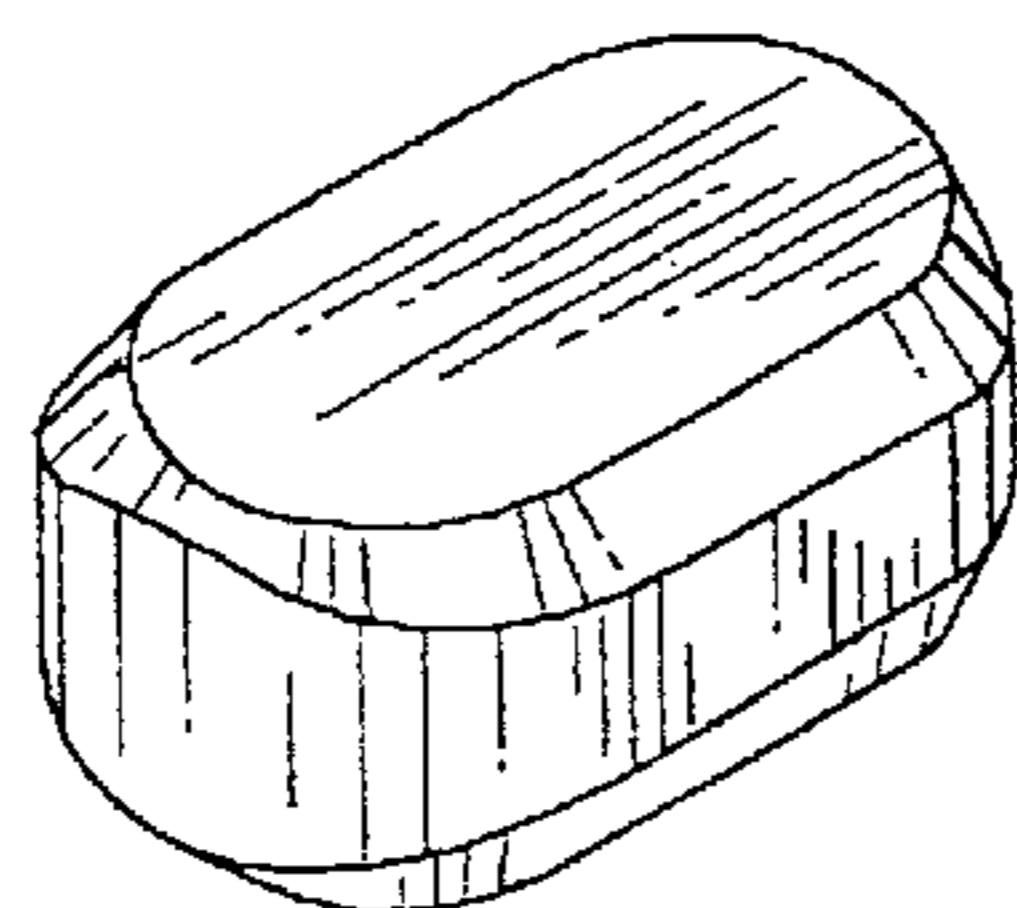

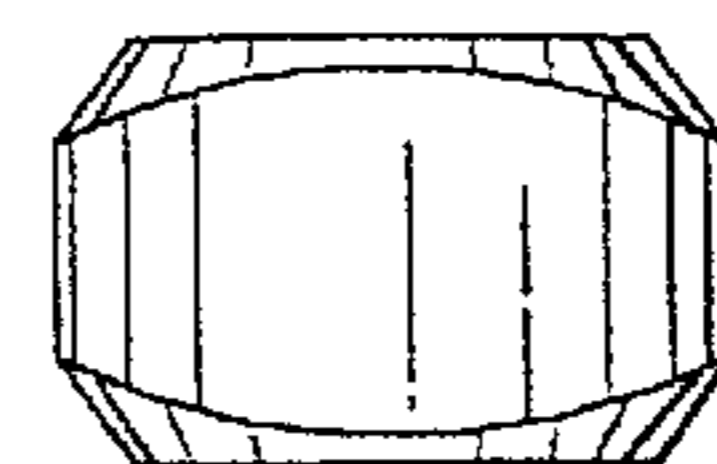

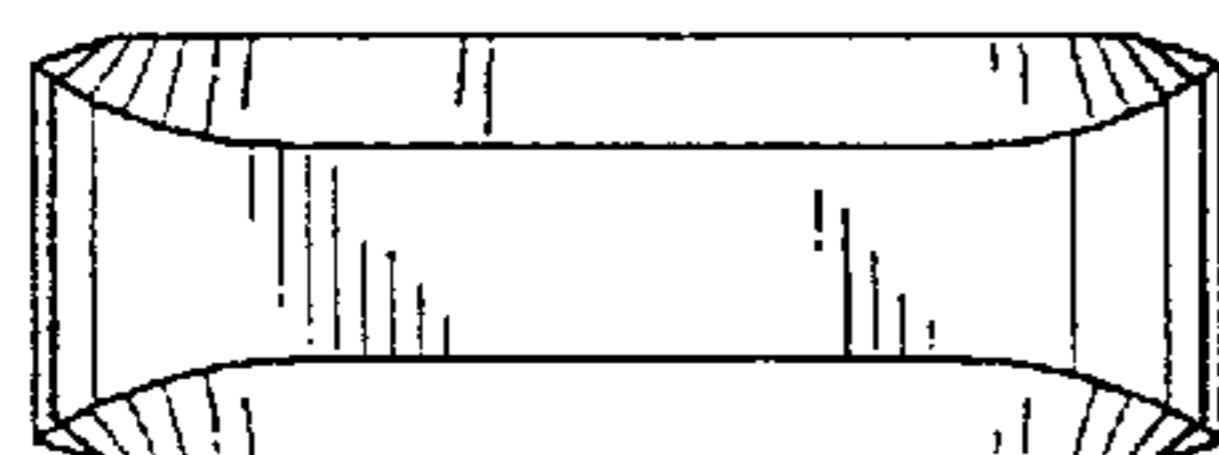

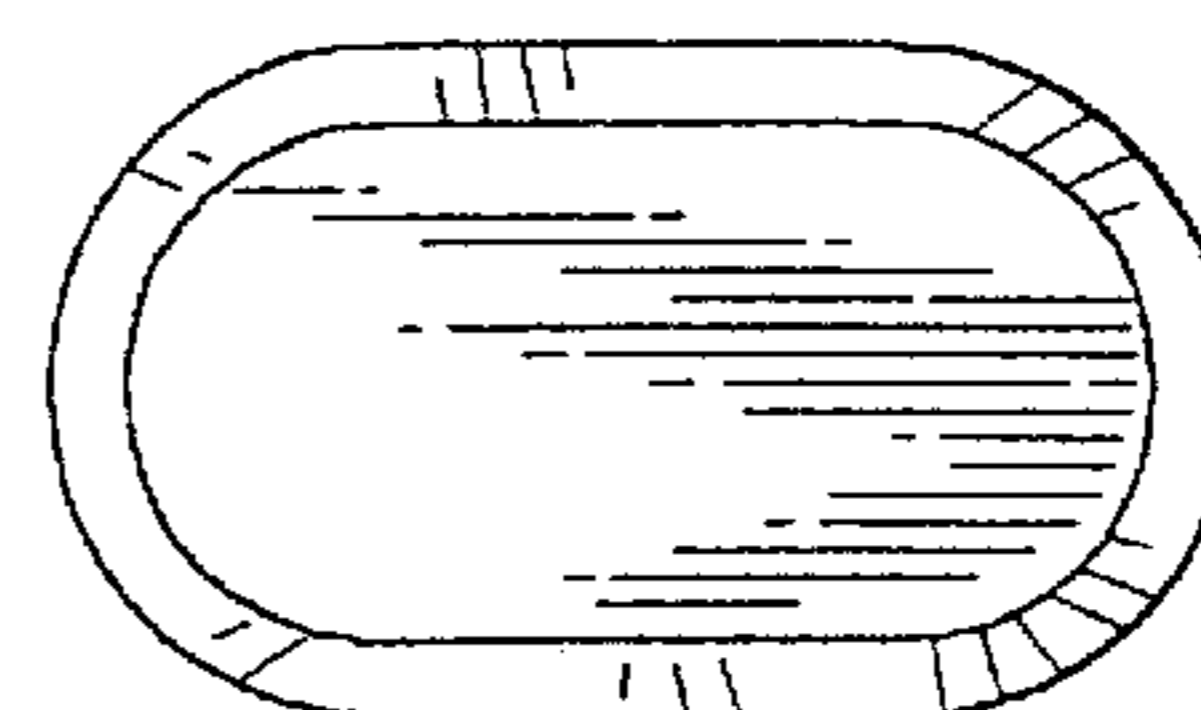
