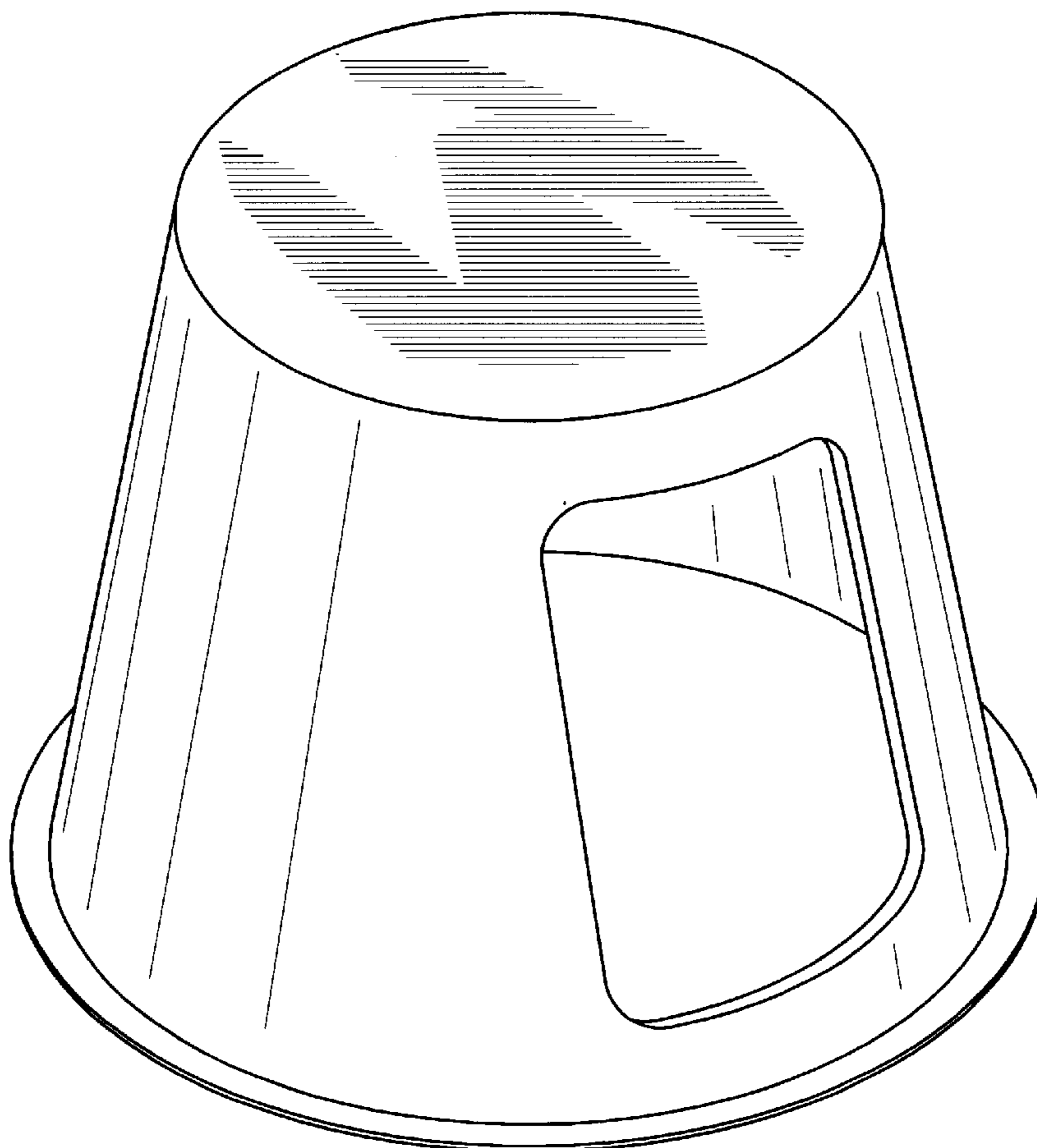
[57] **CLAIM**

The ornamental design for a calf shelter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the calf shelter of the present invention;  
 FIG. 2 is a right side elevational view of the calf shelter of FIG. 1, the left side elevational view being a mirror image thereof;  
 FIG. 3 is a top plan view of the calf shelter of FIG. 1;  
 FIG. 4 is a bottom plan view of the calf shelter of FIG. 1; and,  
 FIG. 5 is a top, front, left side perspective view of the calf shelter of FIG. 1.

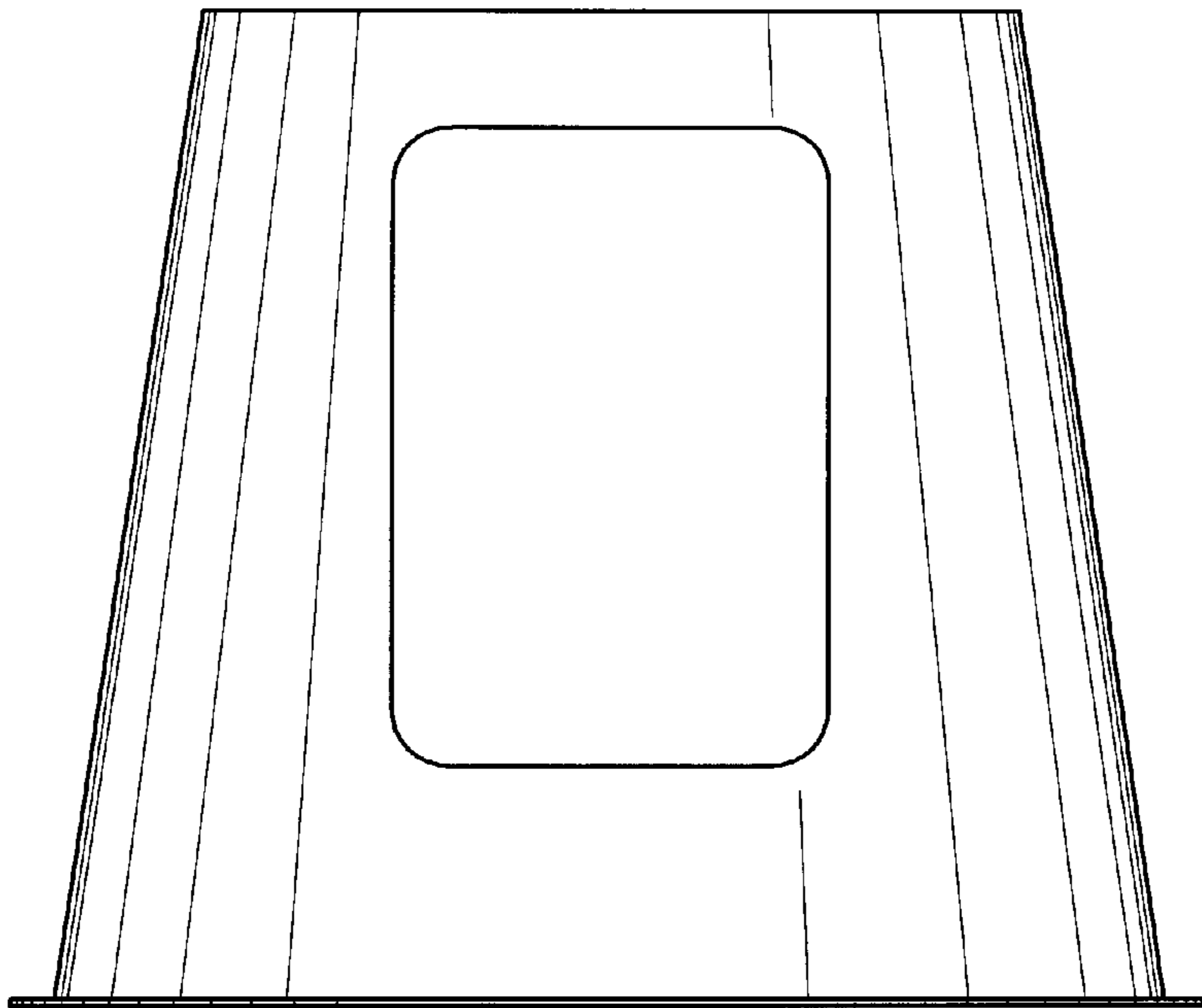

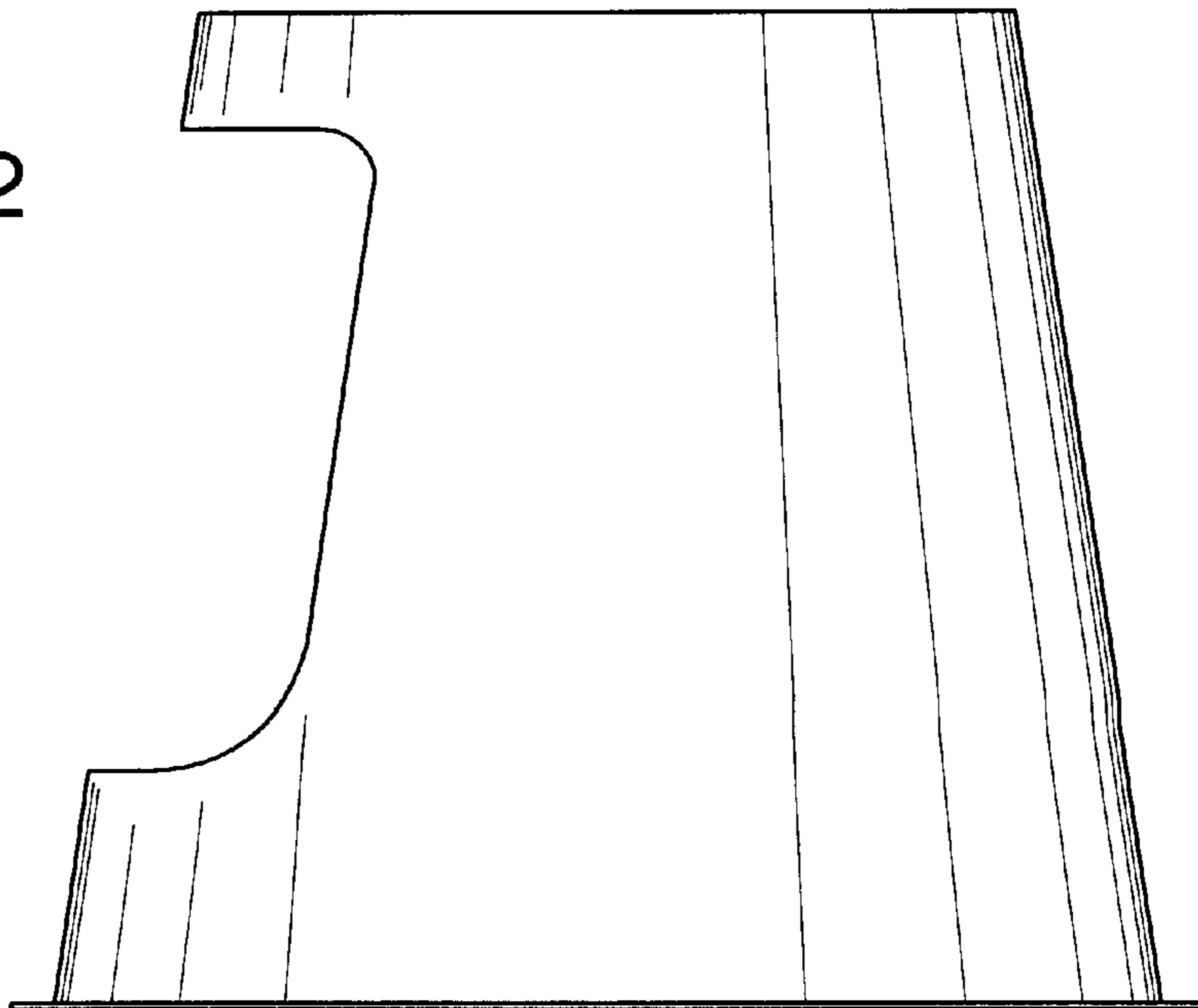

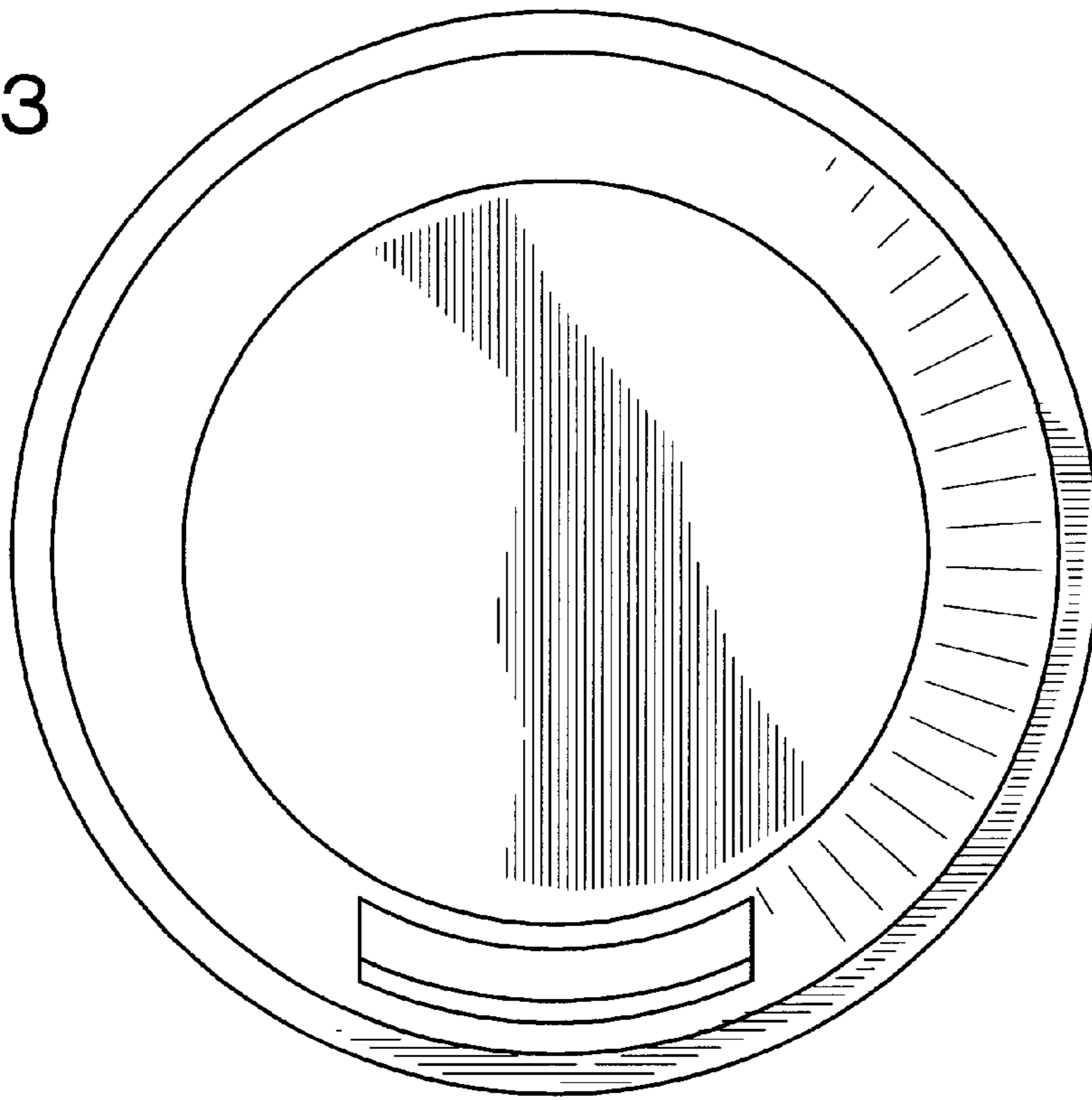

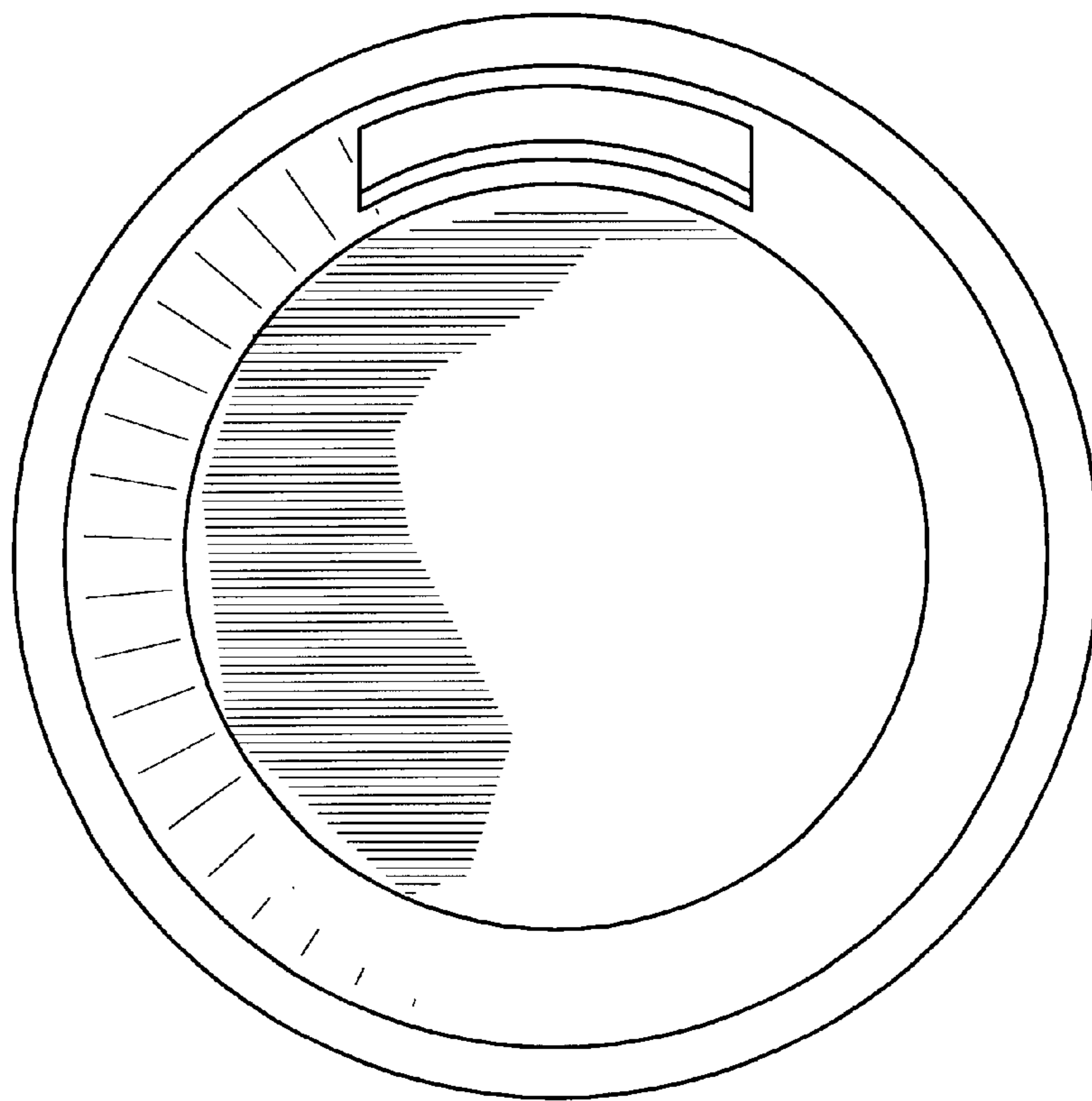
