FIG. 6 is a bottom plan view of the infant car seat sun cover of FIG. 1; and,

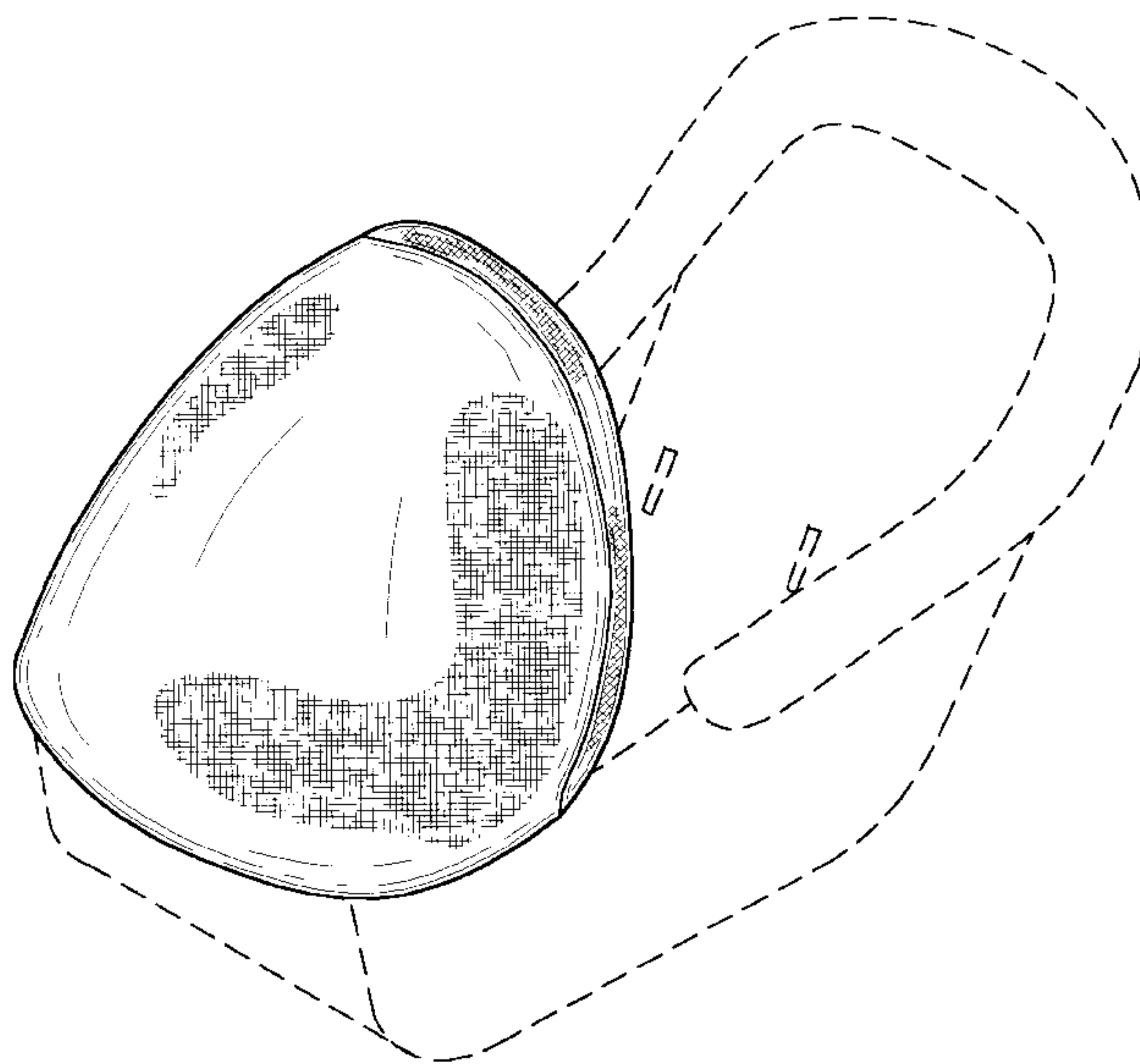
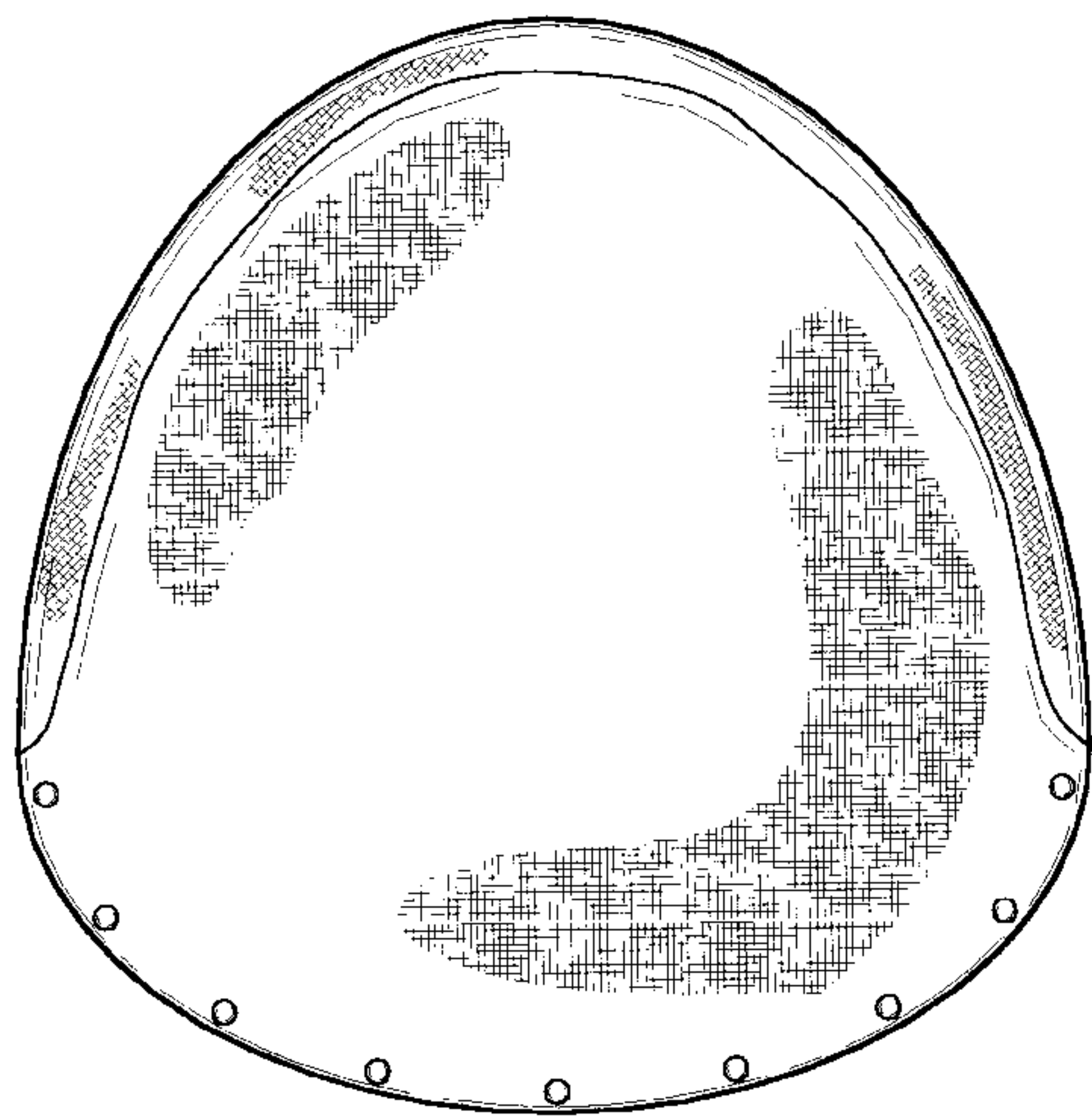

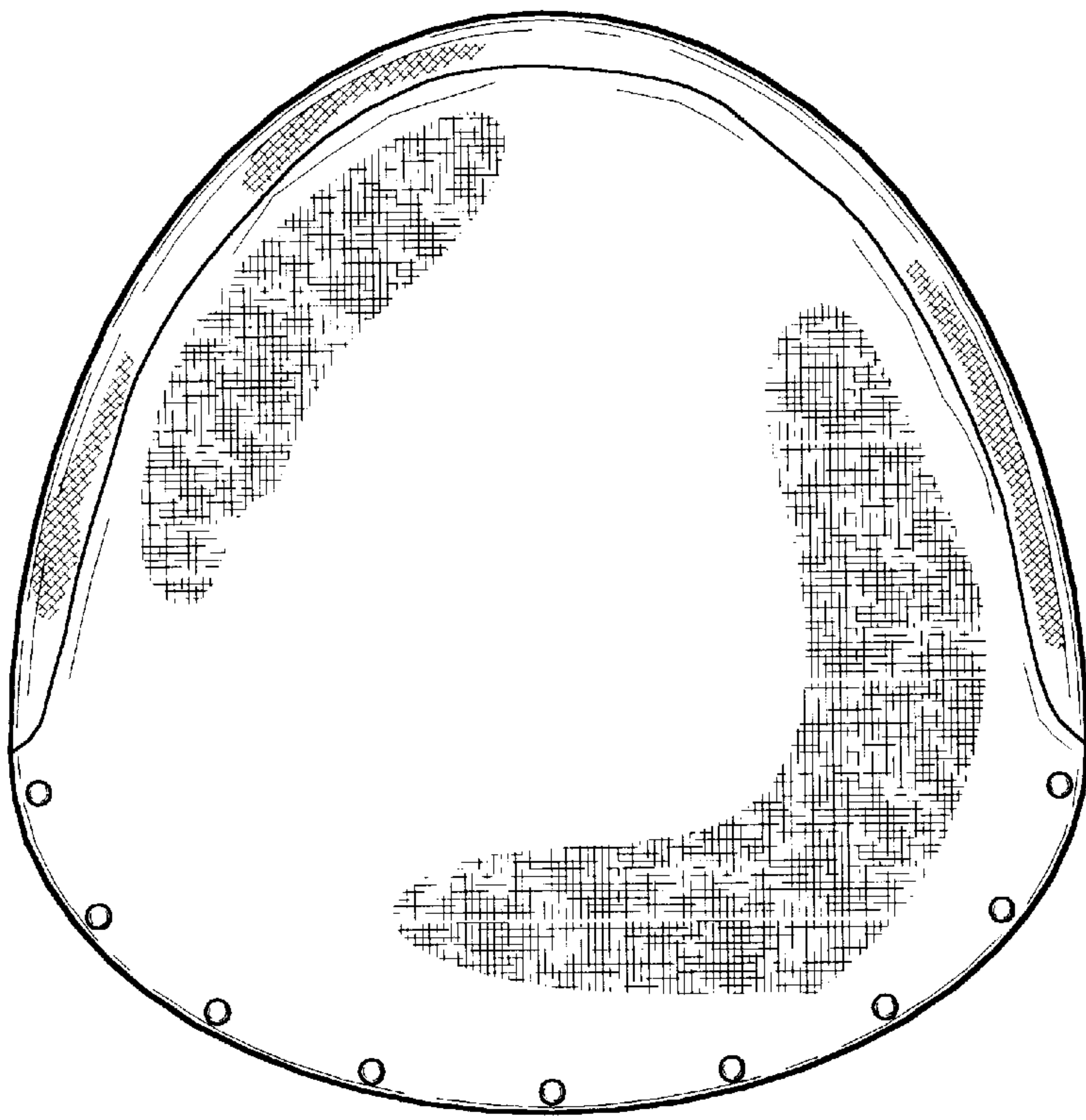

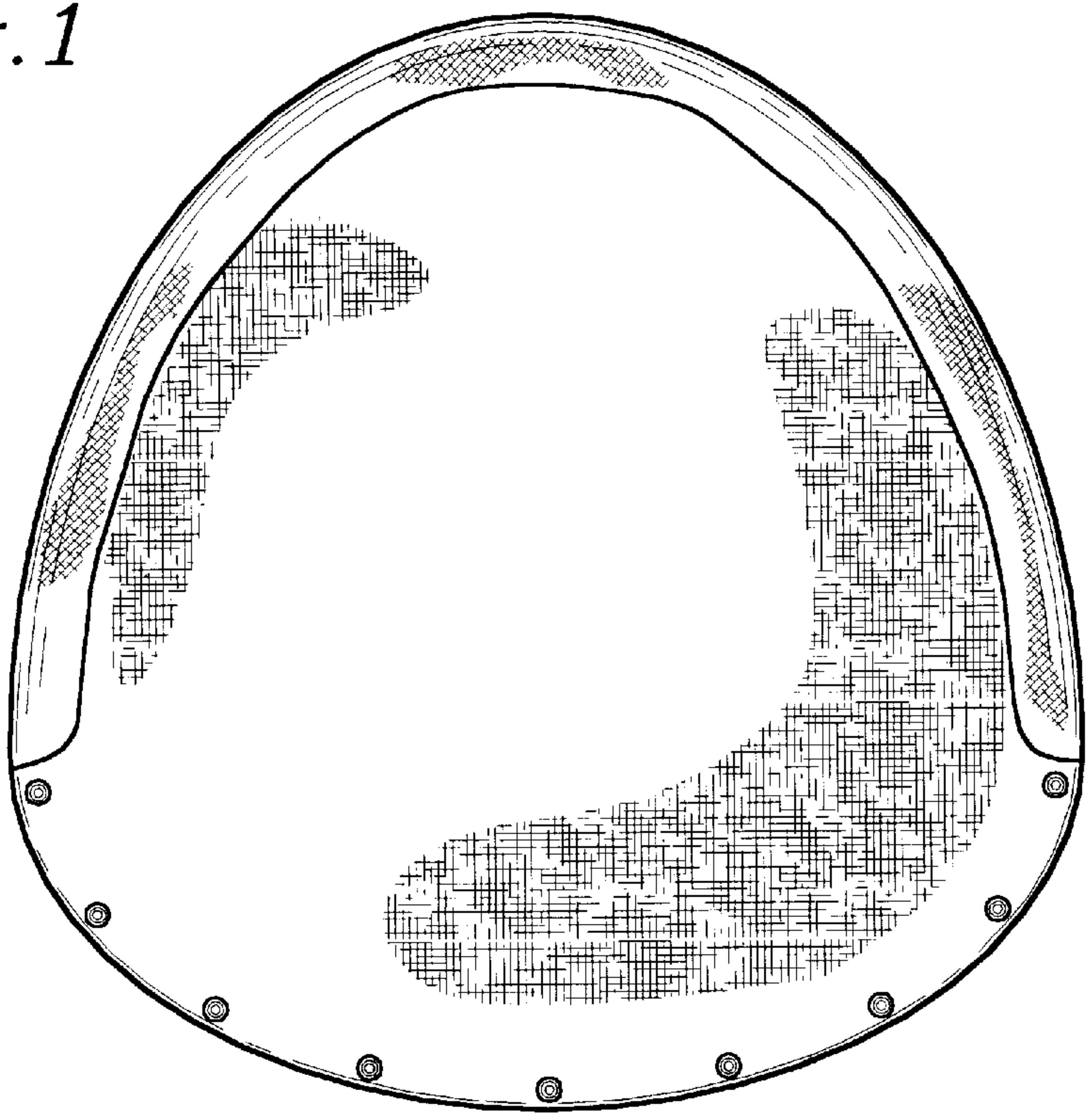

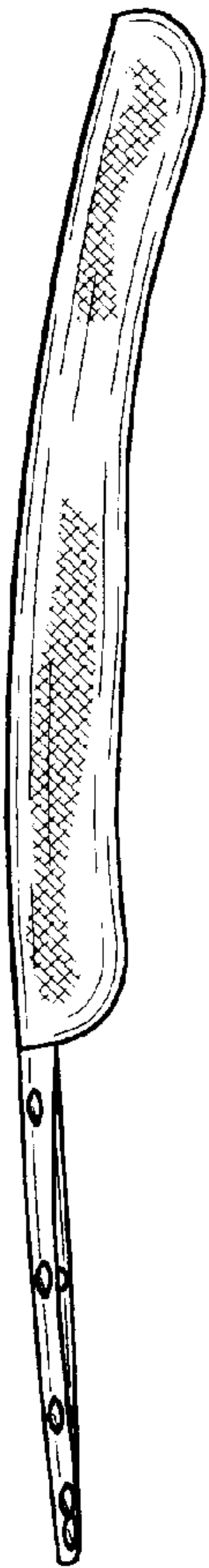

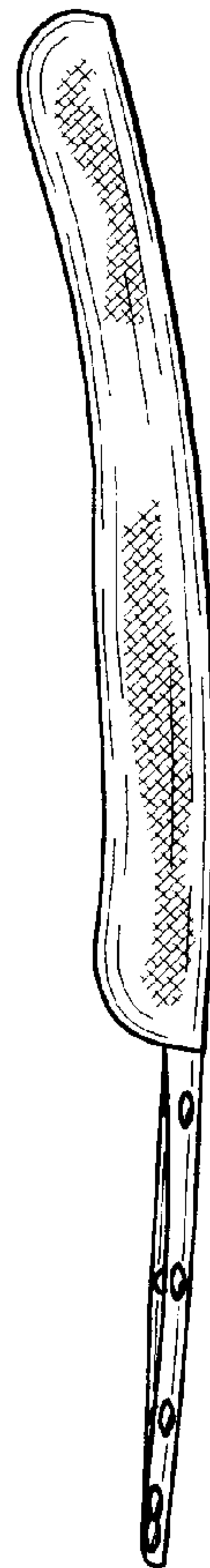

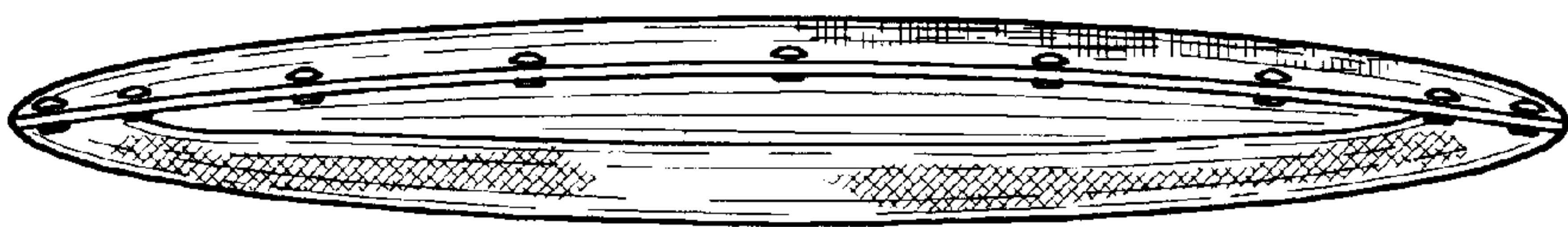

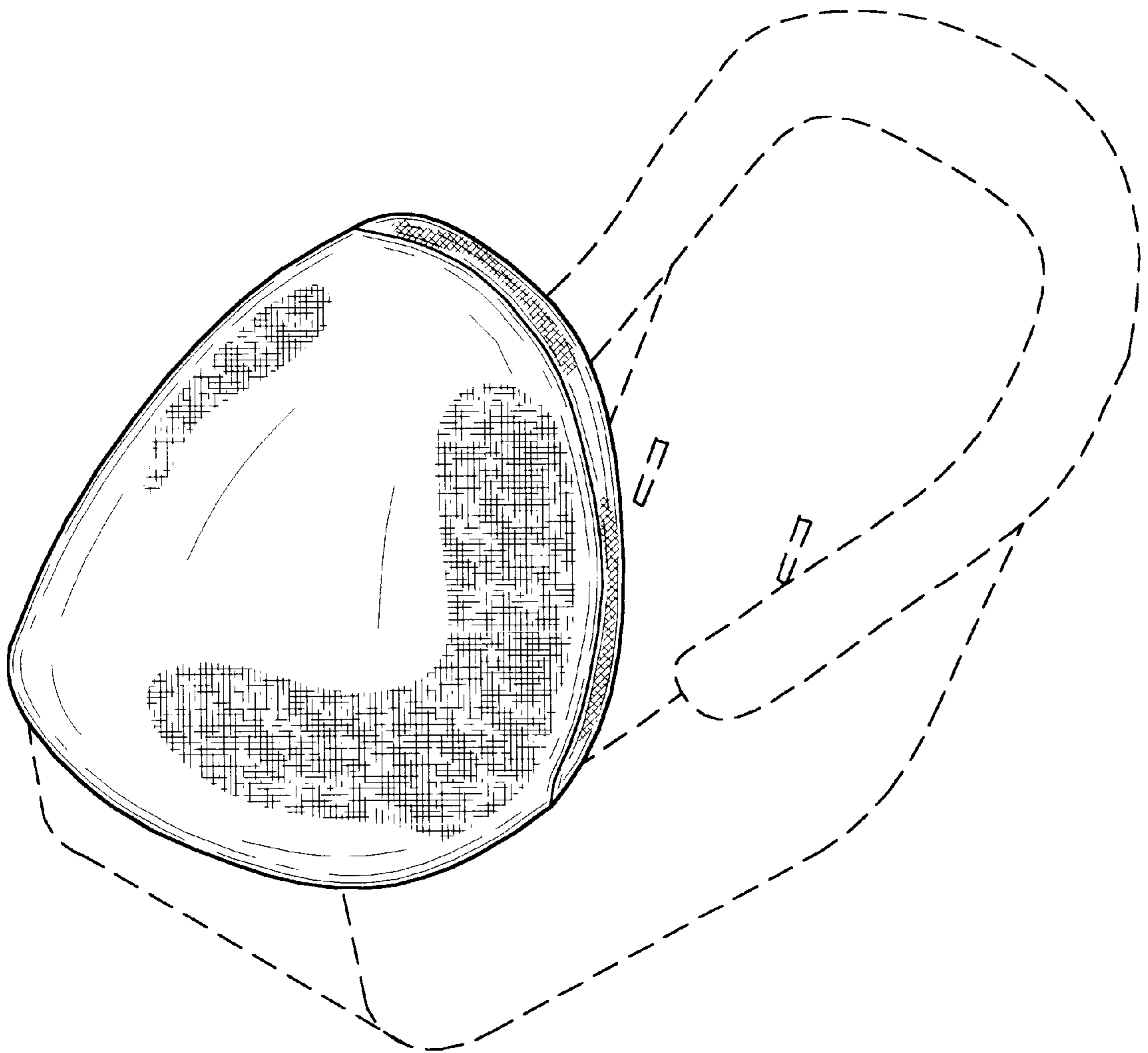
