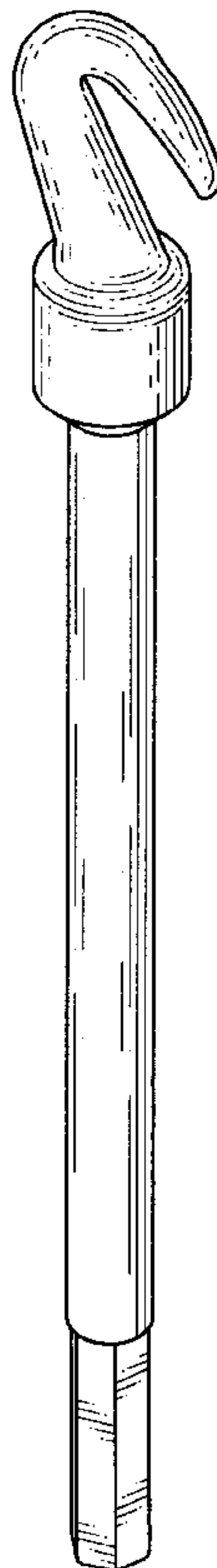
[57] CLAIM

The ornamental design for a tool for twisting rebar wires, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tool for twisting rebar wires in accordance with the present invention;
 FIG. 2 is a top view;

 FIG. 4 is a rear view;
 FIG. 5 is a side view, the opposite side view being a mirror image;

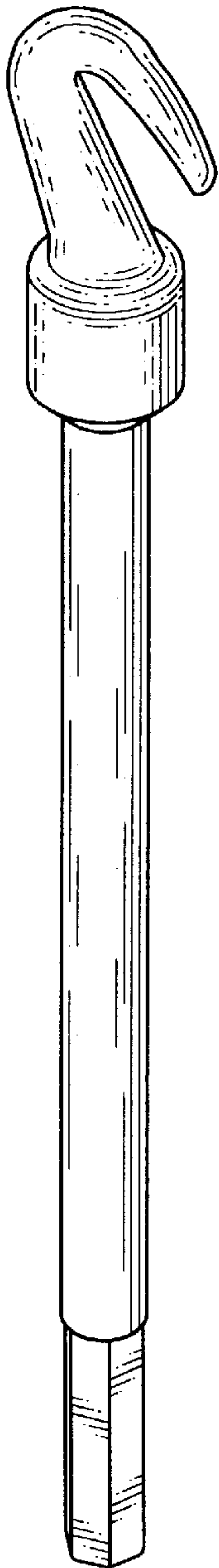

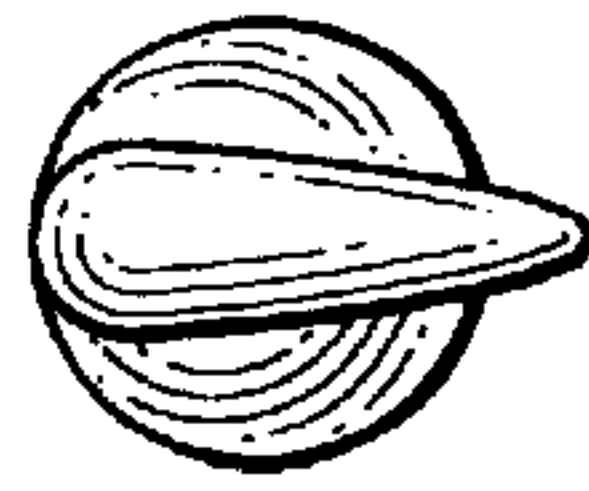

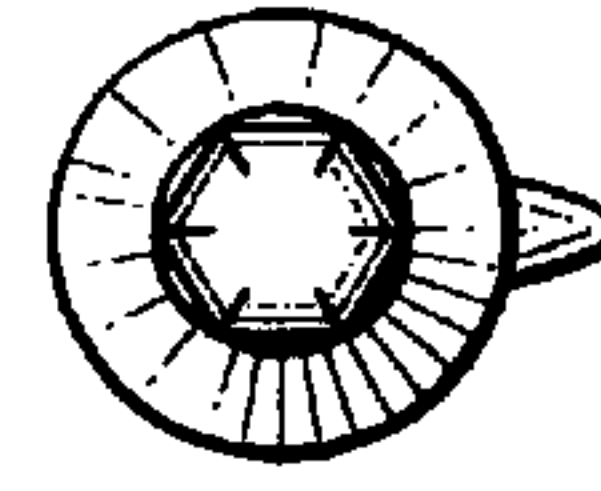

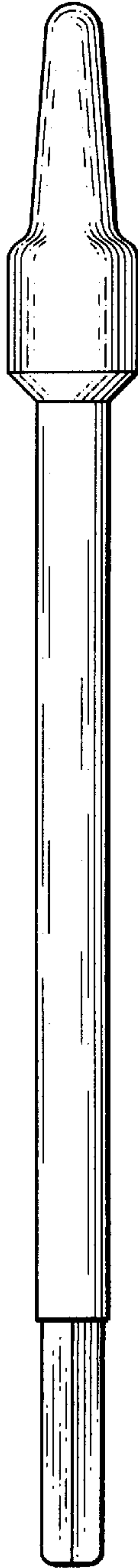

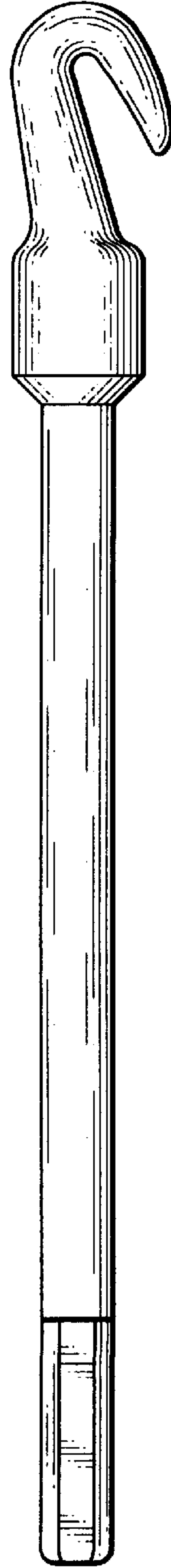

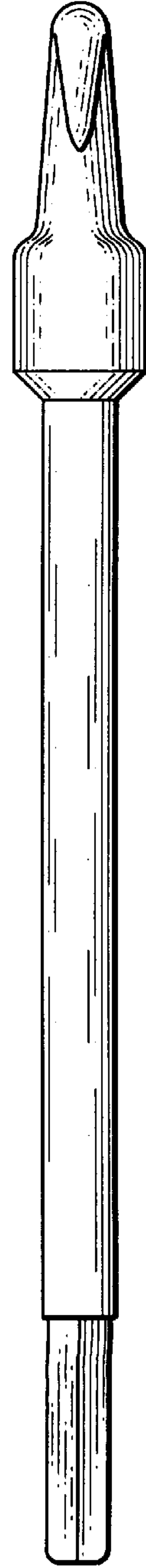

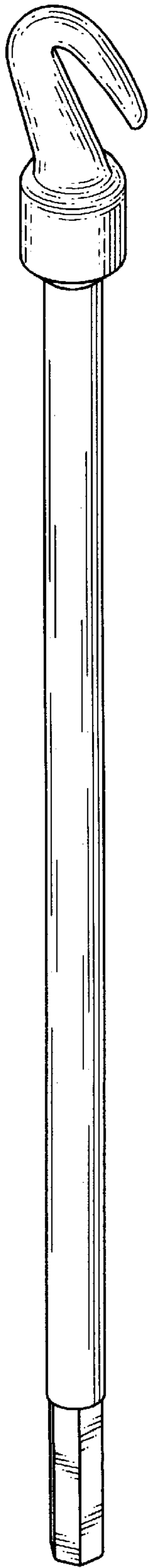

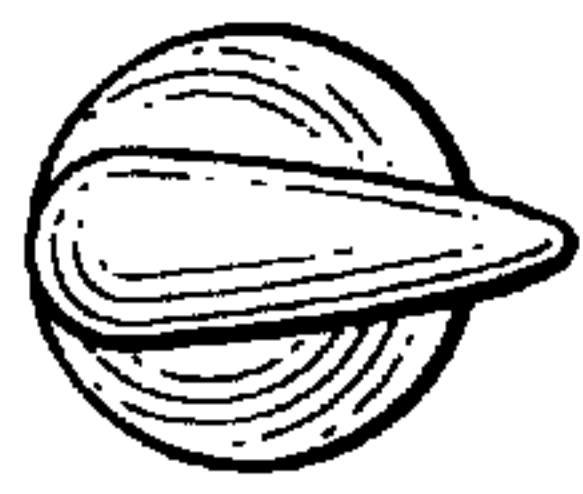

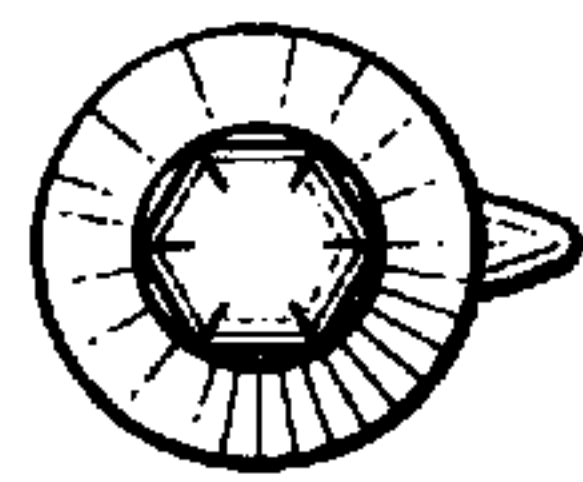

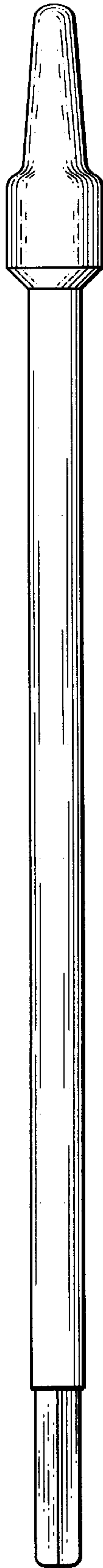

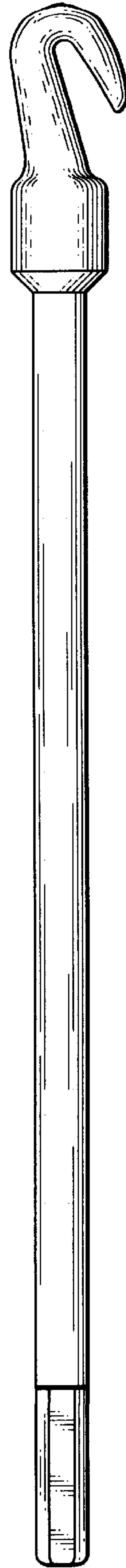

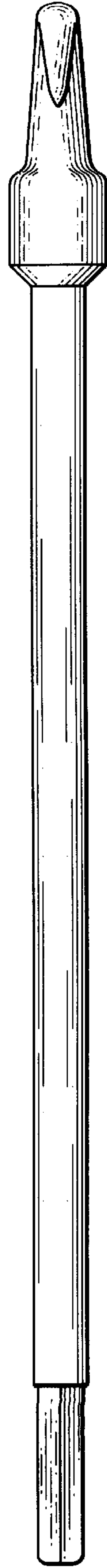

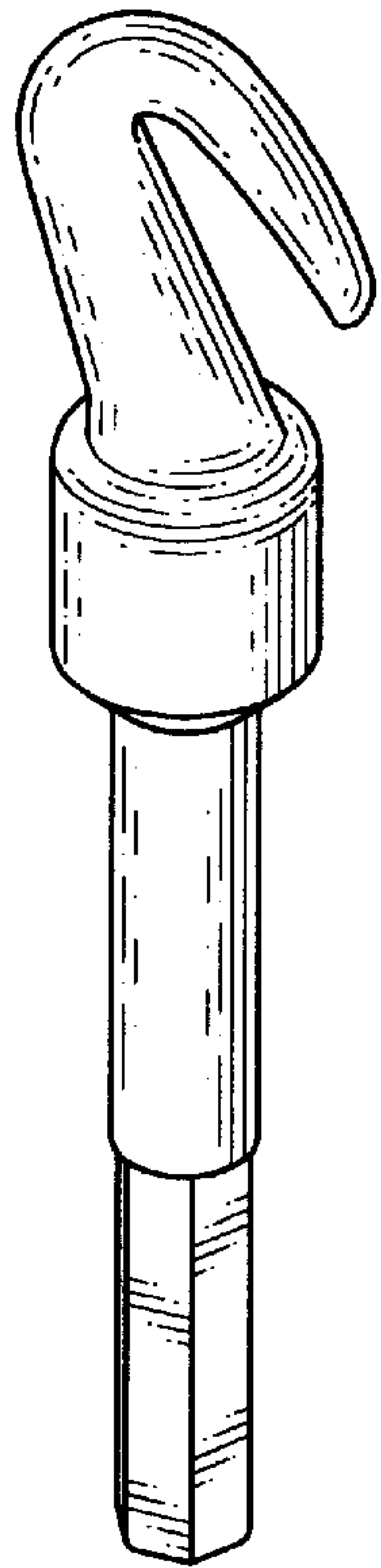

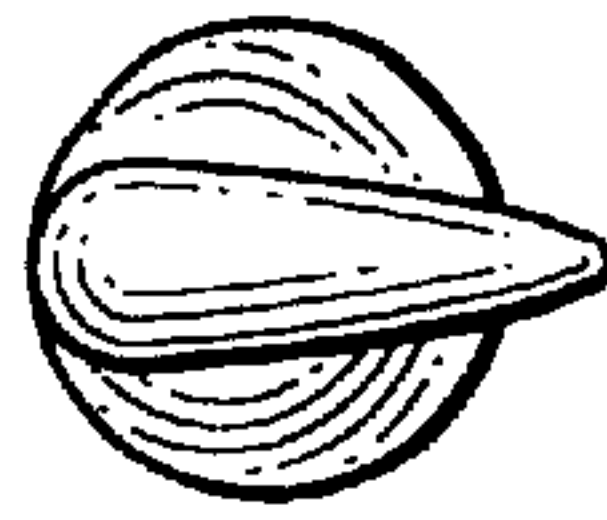

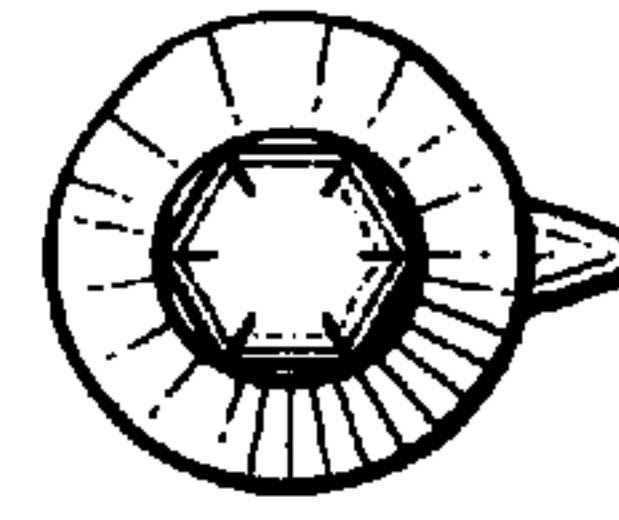

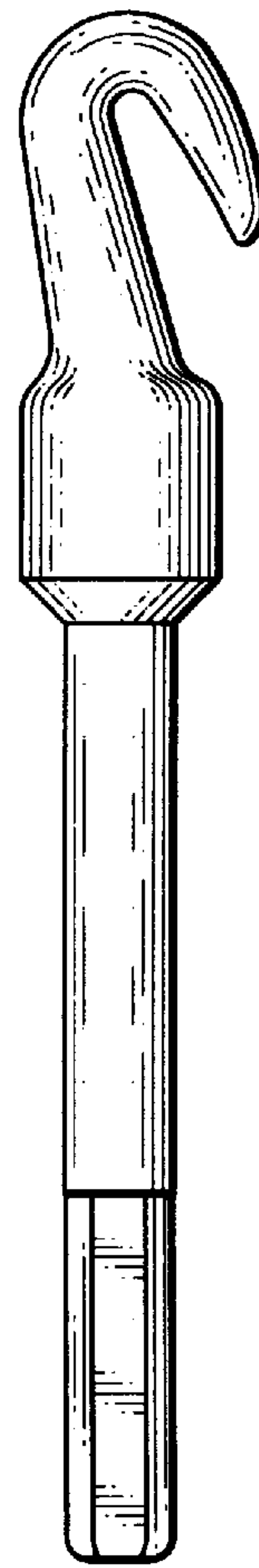

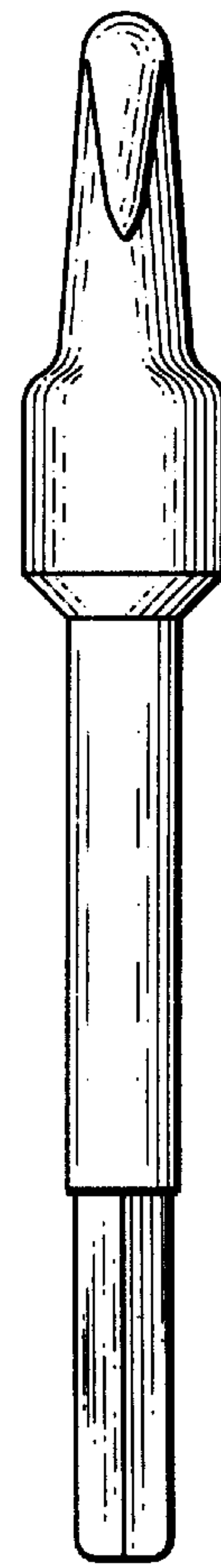
