[57] **CLAIM**

The ornamental design for scissors with interchangeable blades, as shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of a first embodiment of the scissors showing my new design;
 FIG. 2 is a view similar to FIG. 1 scissors being in an opened position;
 FIG. 3 is a side elevational view thereof, the side opposite that shown in FIG. 3 being the mirror image thereof;
 FIG. 4 is a top plan view thereof, the bottom plan view opposite that shown in FIG. 4 being the mirror image thereof;
 FIG. 5 is an end elevational view thereof taken from the right of FIG. 4;
 FIG. 6 is an elevational view thereof taken from the left of FIG. 4;
 FIG. 7 is a view similar to FIG. 1 but showing the same without the blades which have been omitted for clarity of illustration;
 FIG. 8 is a view similar to FIG. 4 but showing the same without the blades which have been omitted for clarity of illustration;
 FIG. 9 is a view similar to FIG. 3 but showing the same without the blades which have been omitted for clarity of illustration;
 FIG. 10 is a view similar to FIG. 1 but showing a modified embodiment thereof;
 FIG. 11 is a side elevational view of the embodiment of FIG. 10;
 FIG. 12 is a top plan view of the embodiment of FIG. 10; and,
 FIG. 13 is a front and side perspective view of the embodiment of FIG. 8 but showing the blades in an opened position.

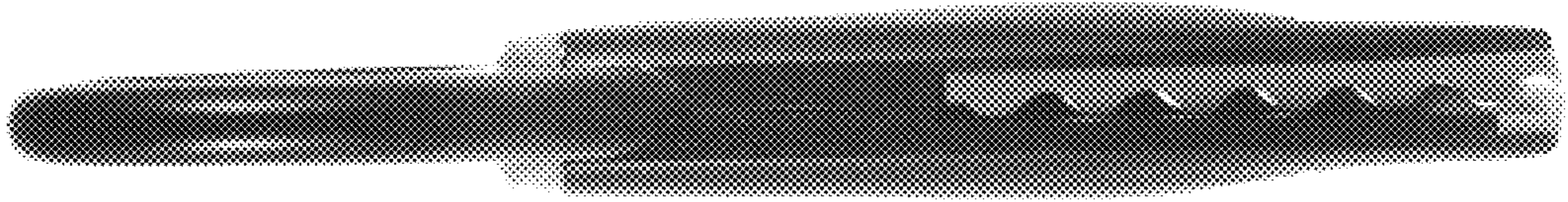

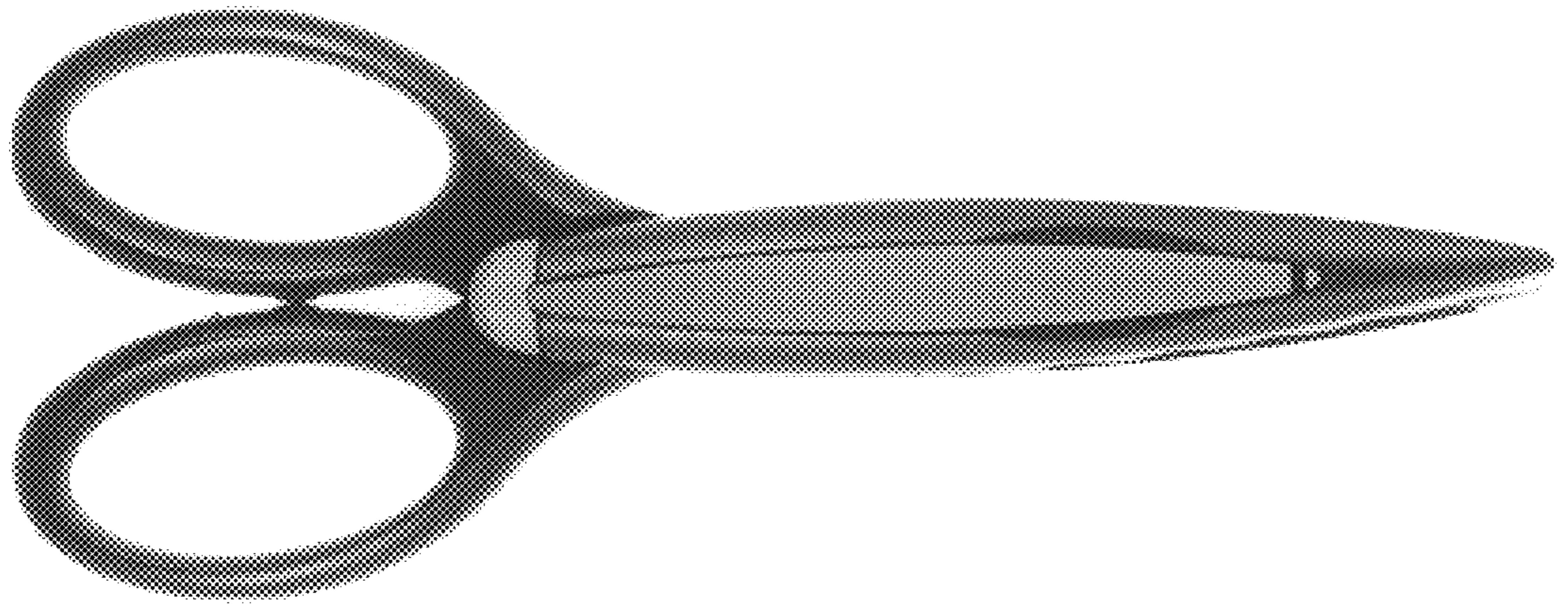

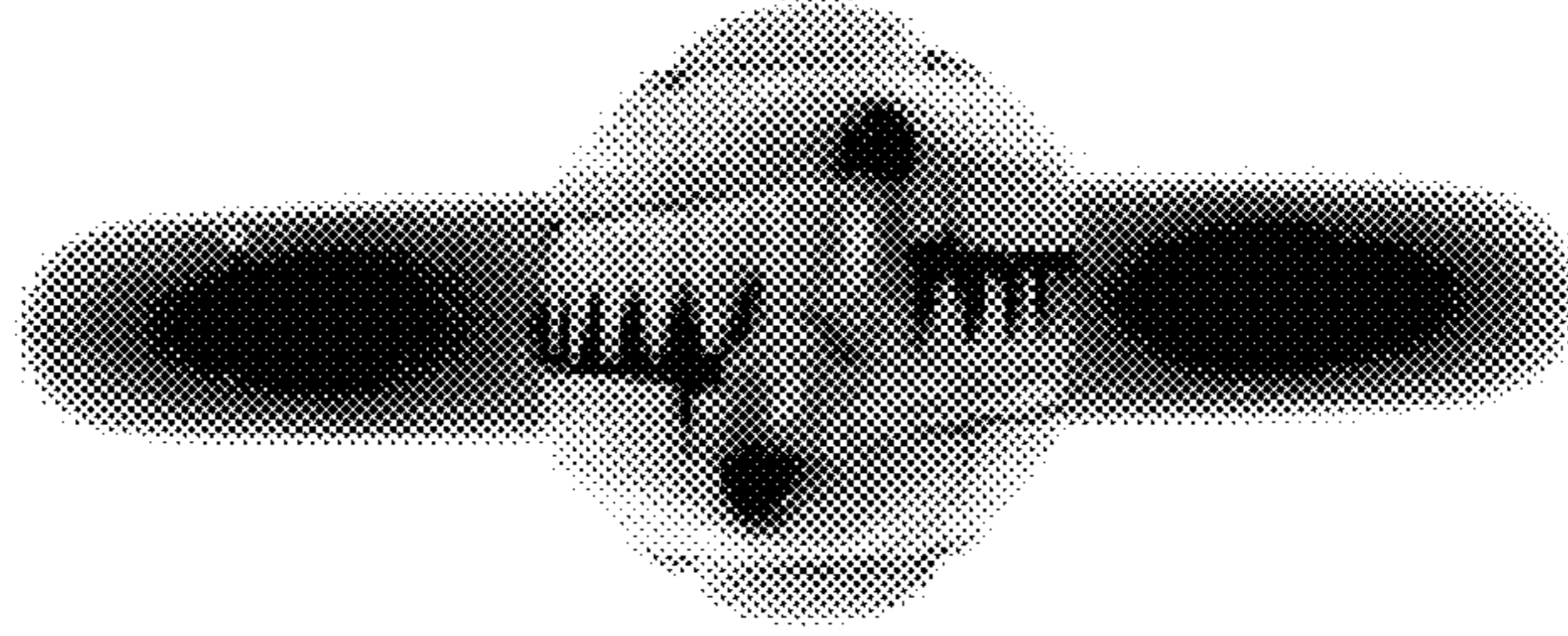

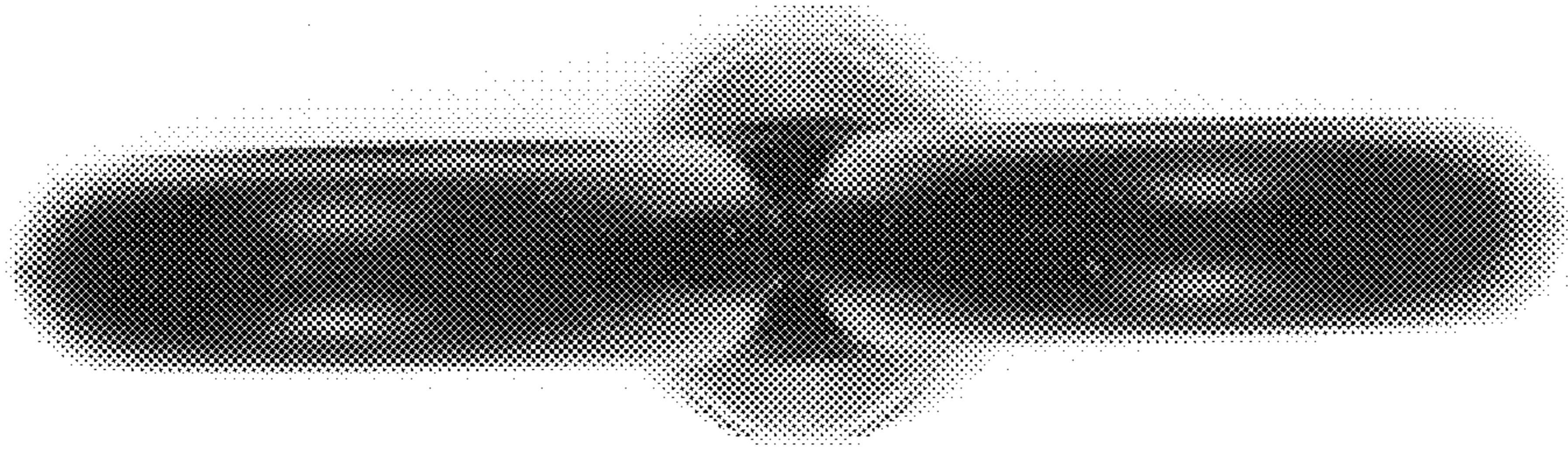

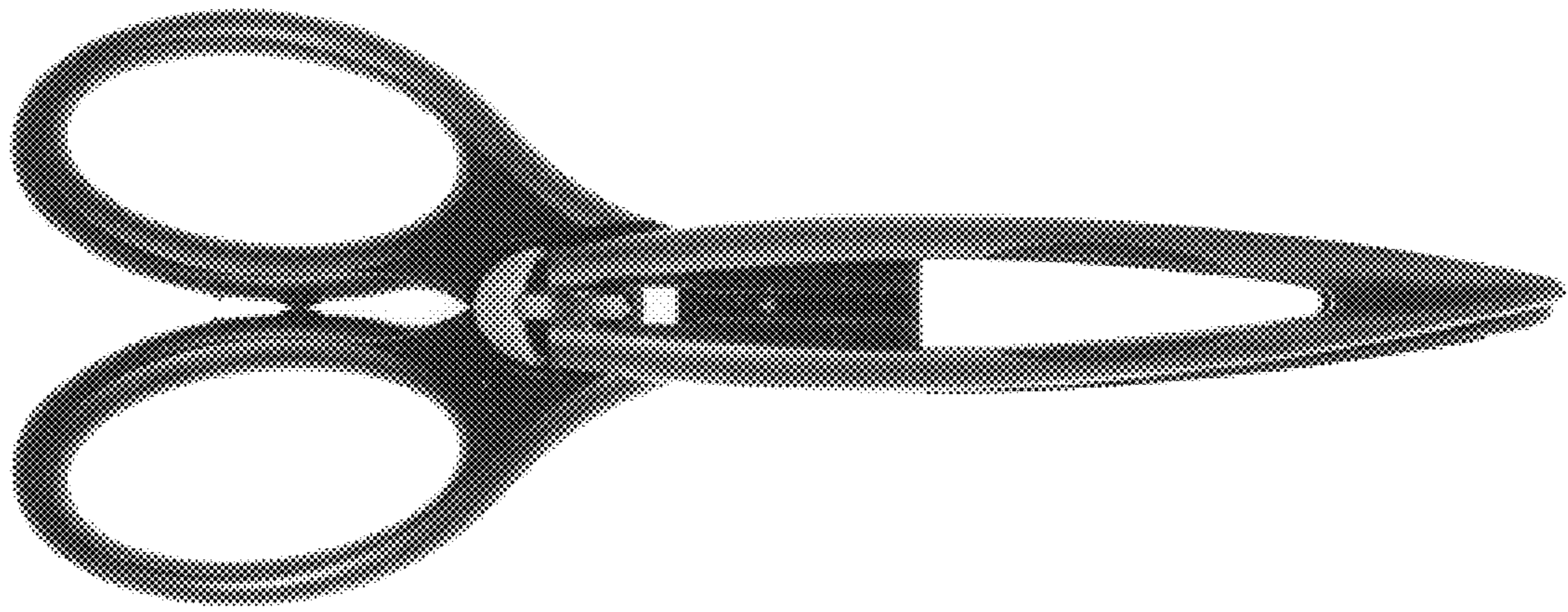

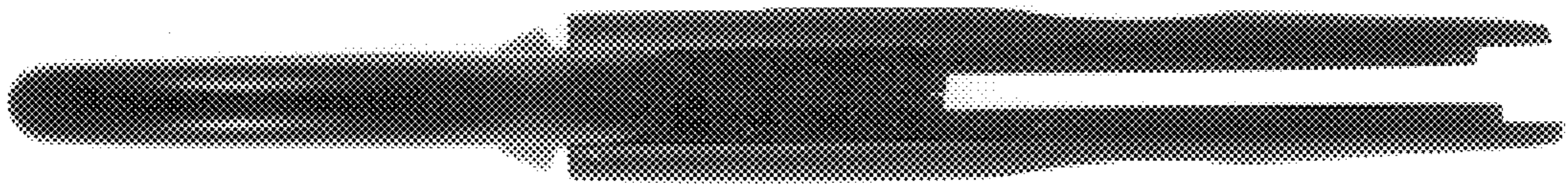

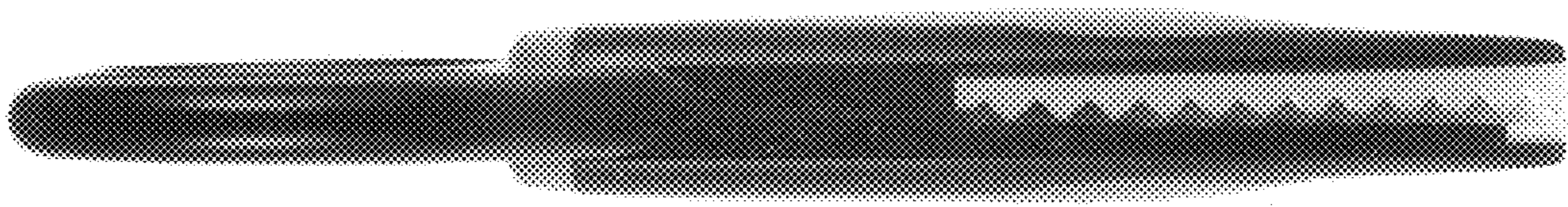

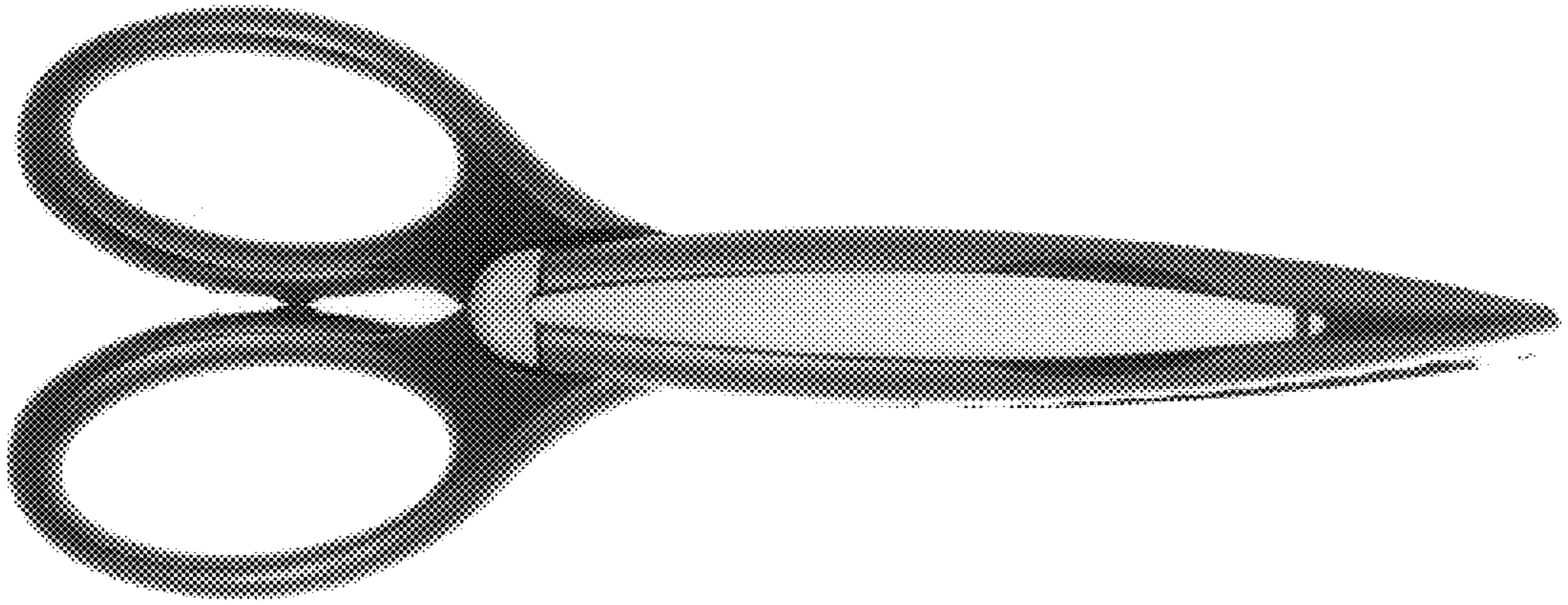
