FIG. 8 is a top plan view thereof; and,

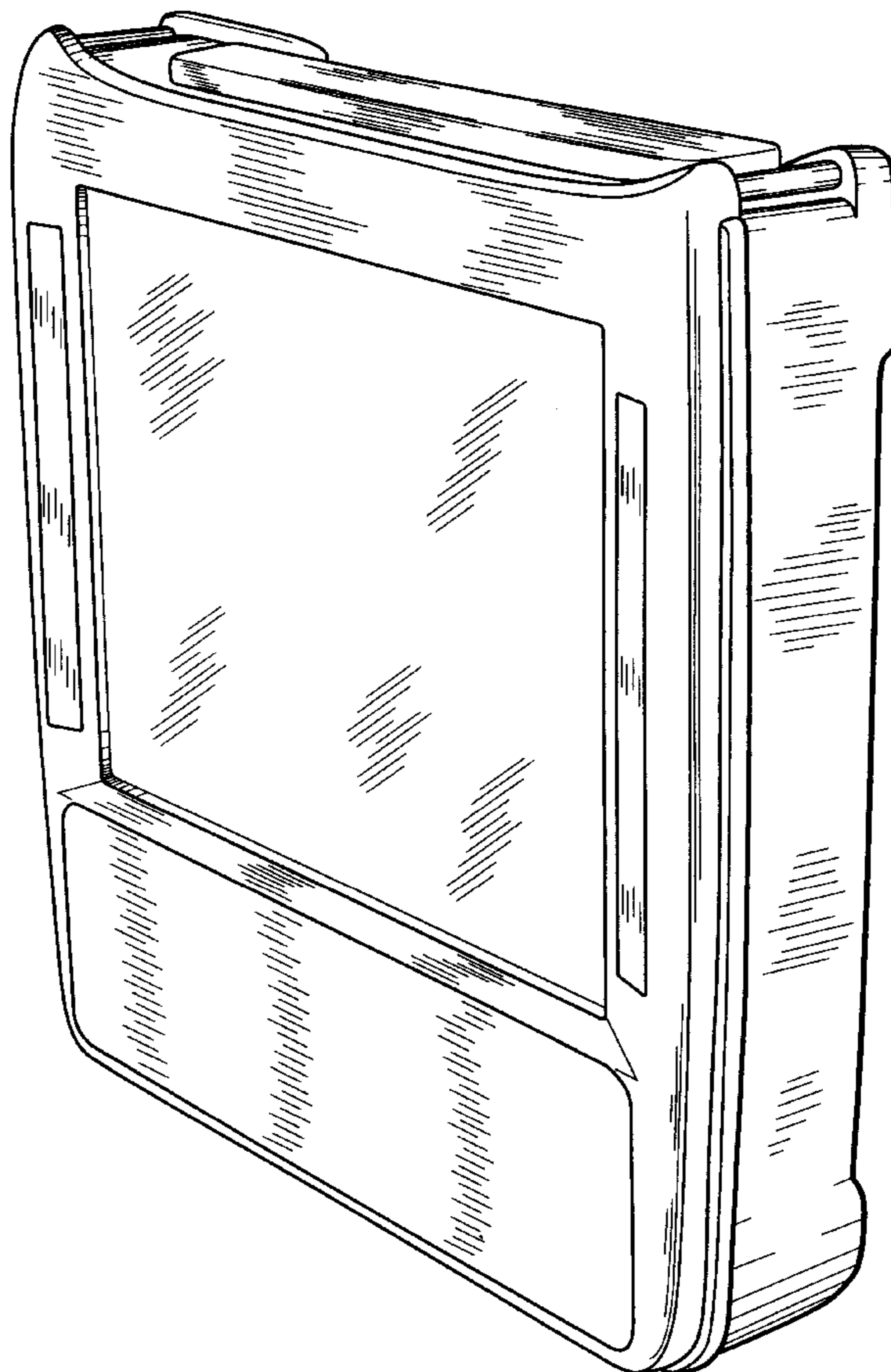
FIG. 9 is a bottom plan view thereof.

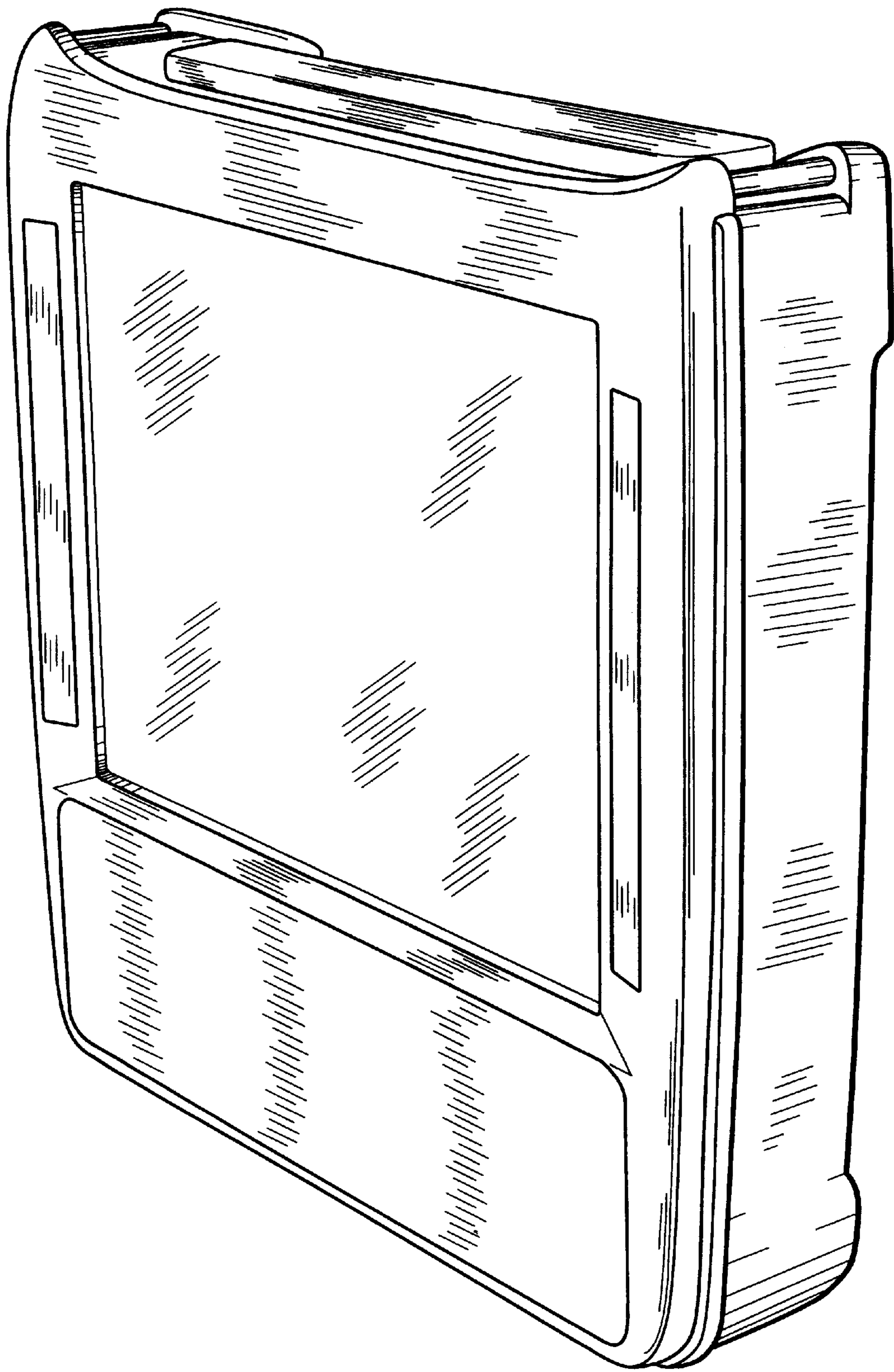

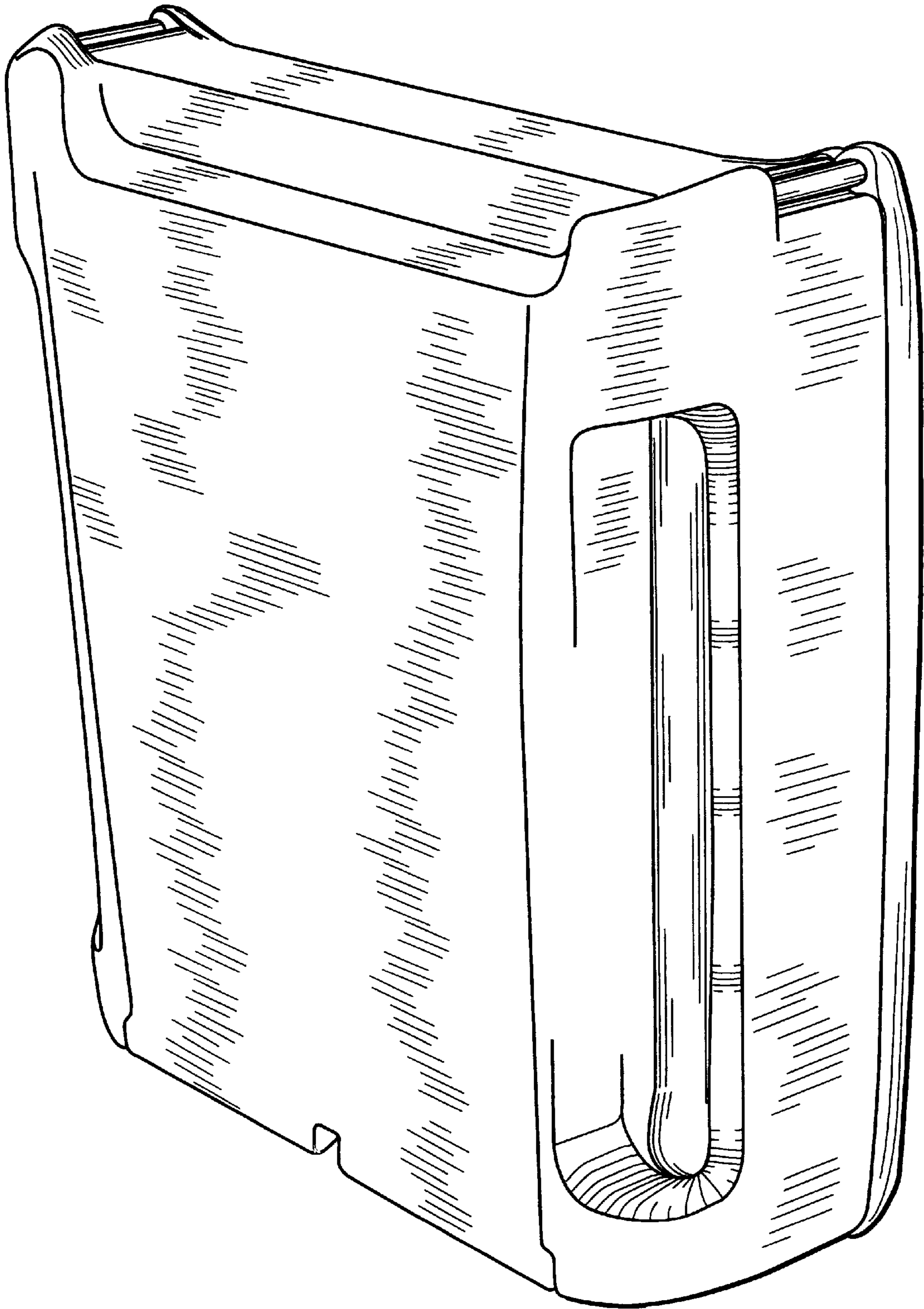

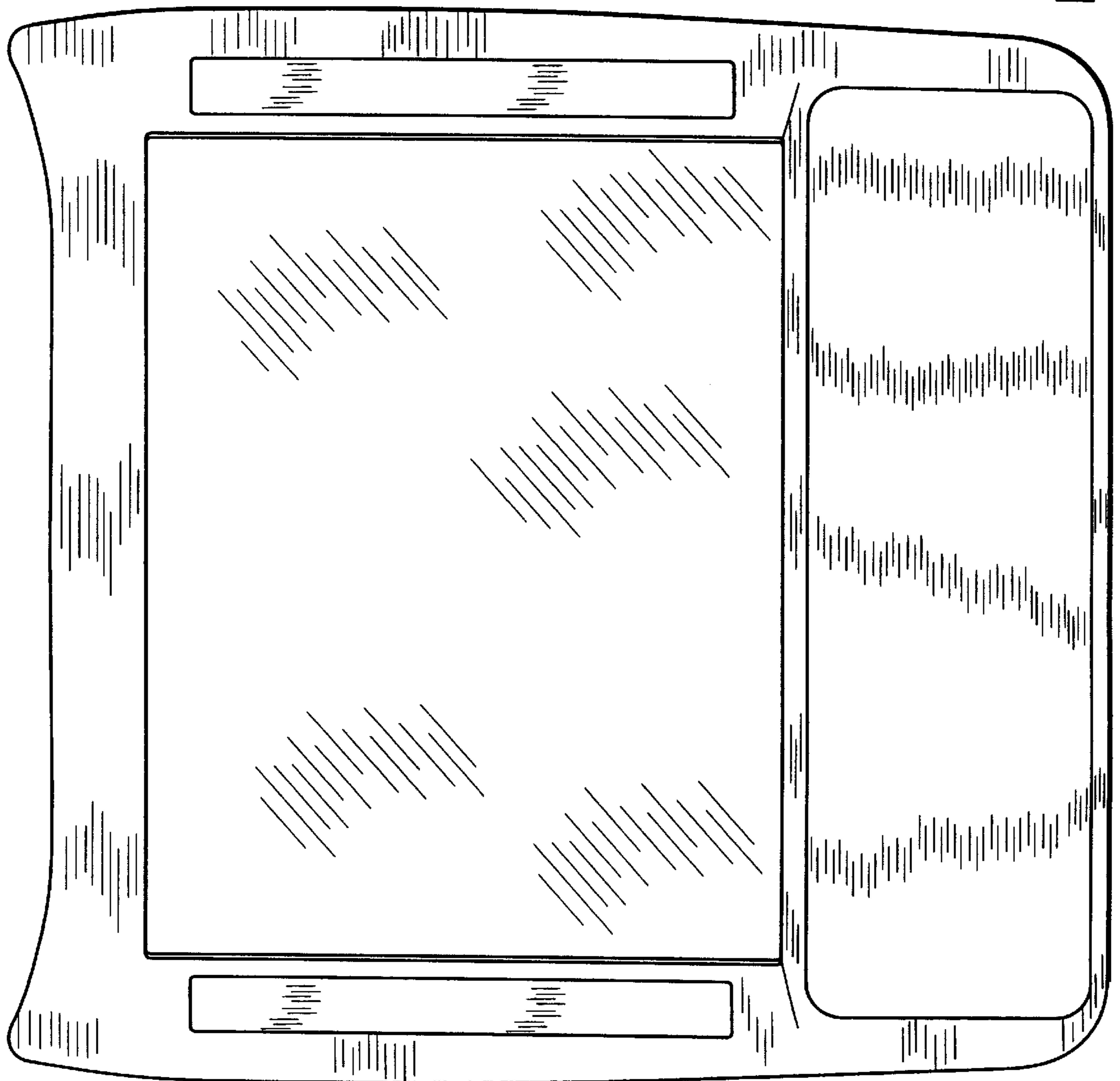

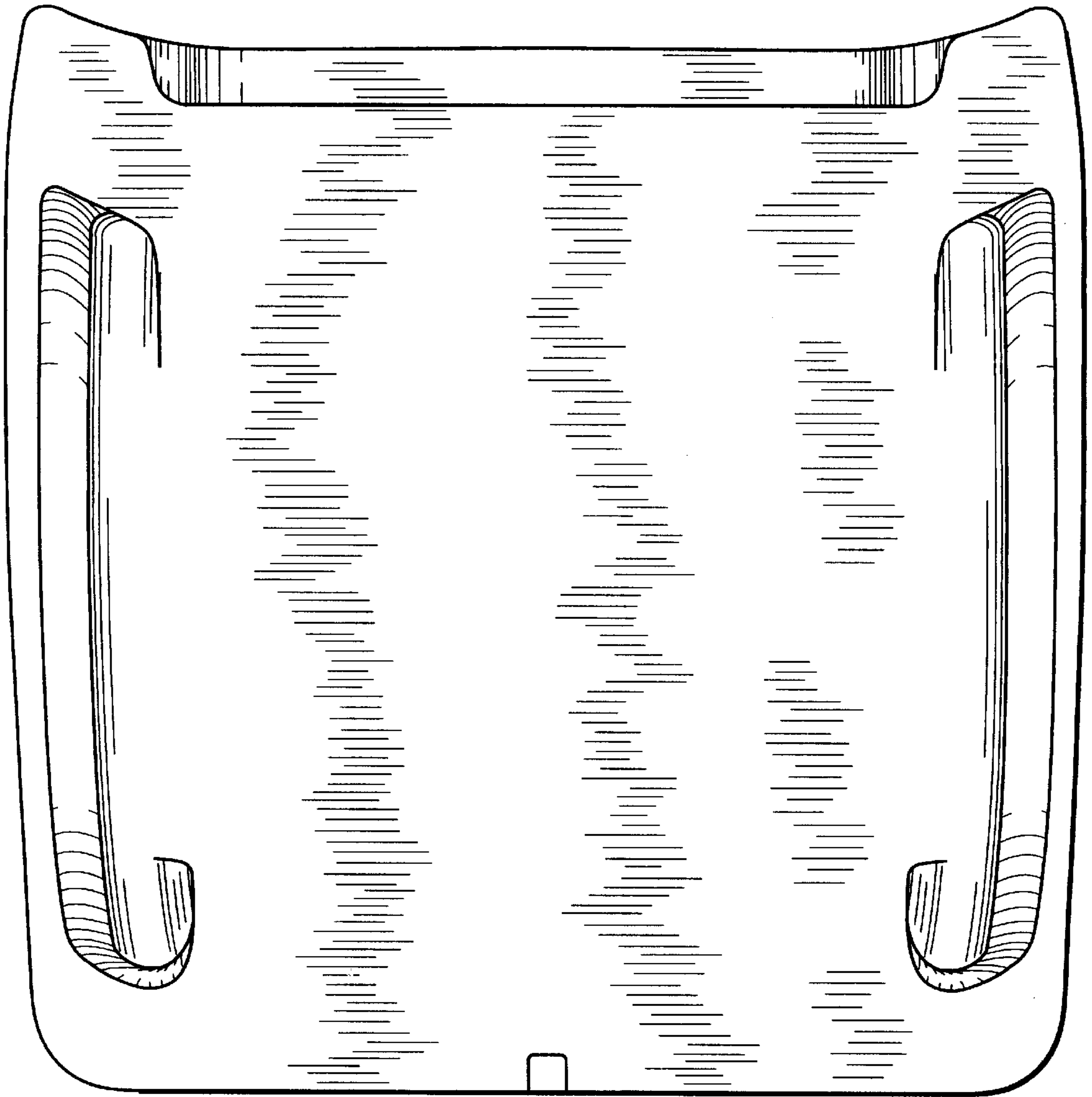

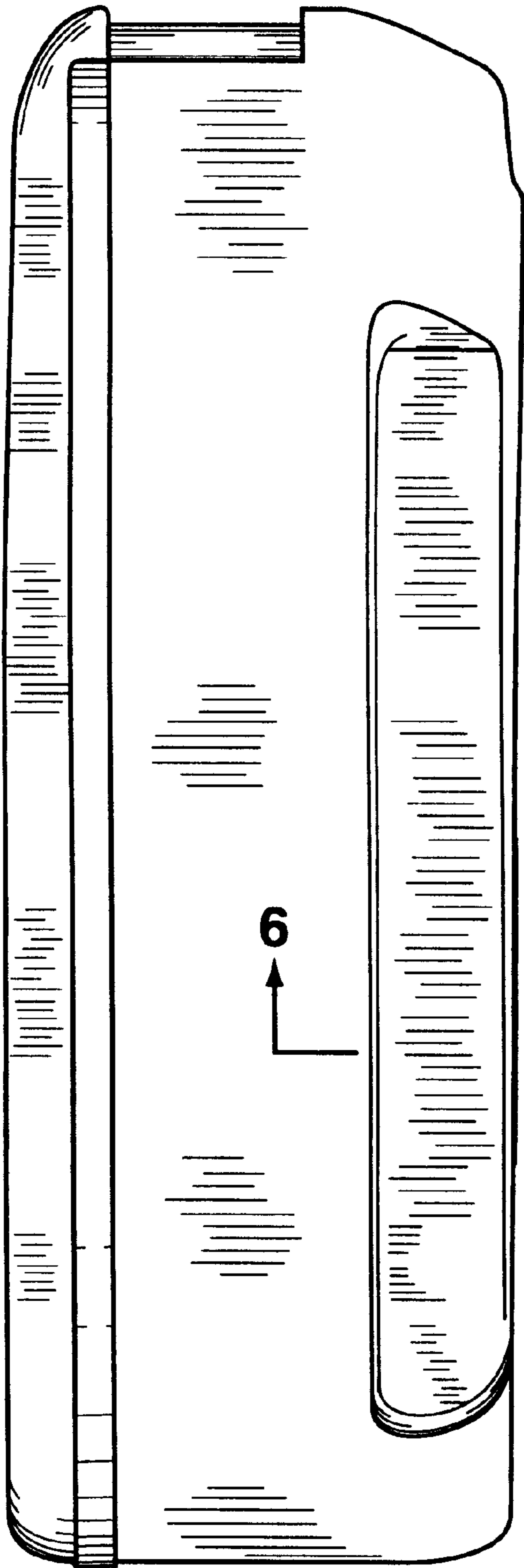

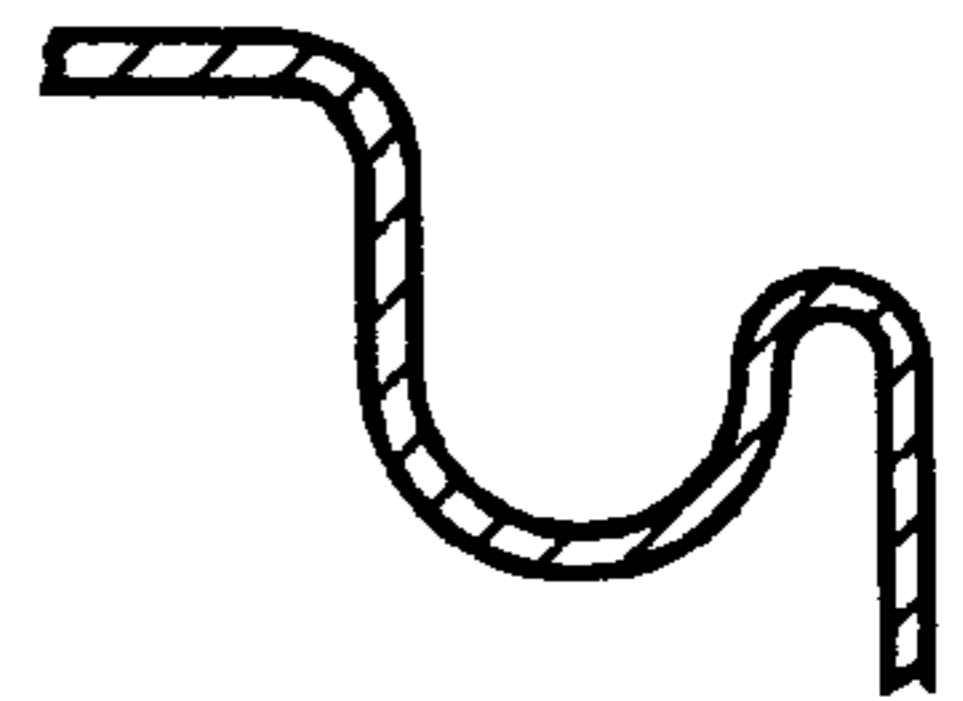

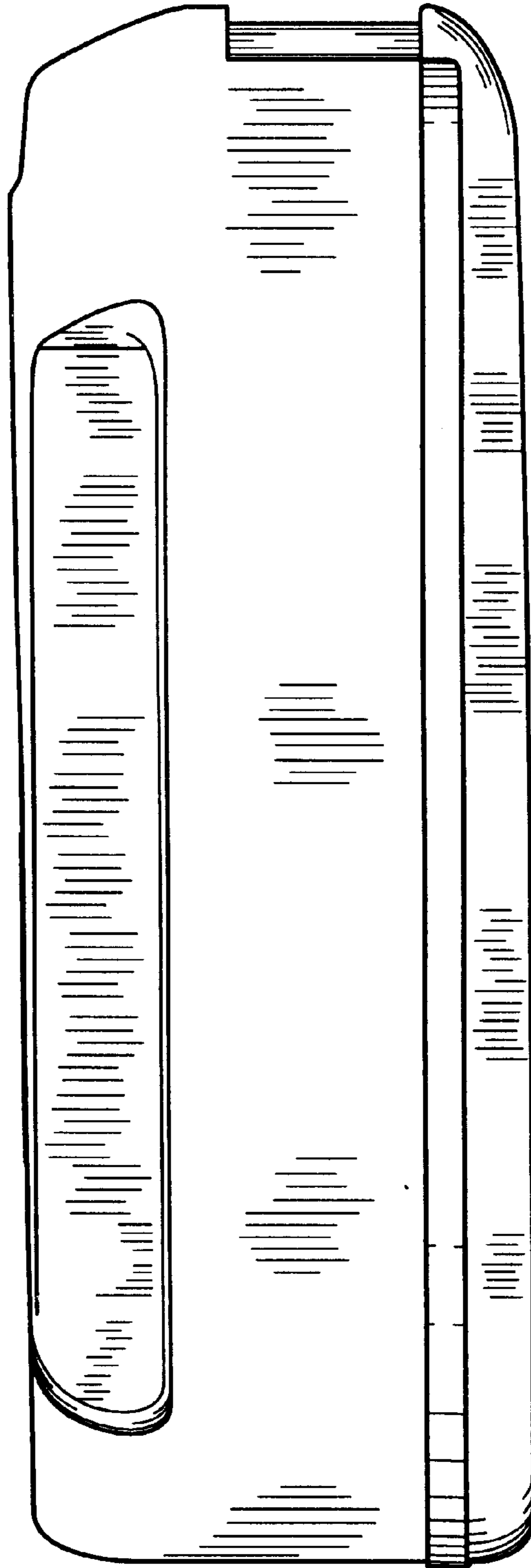

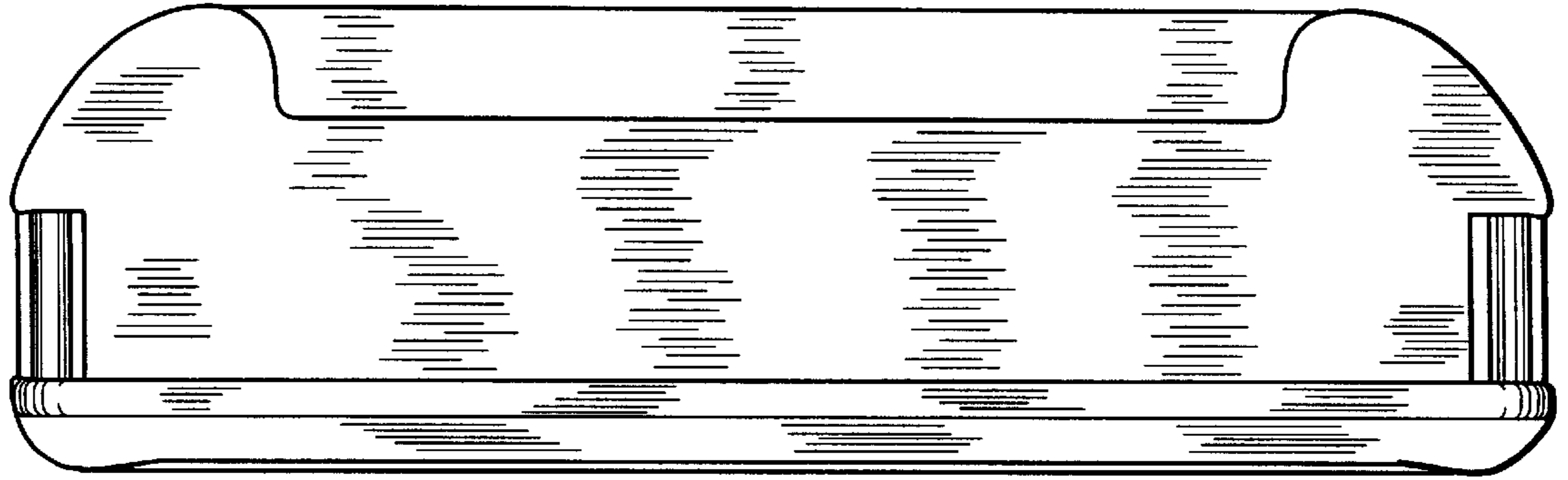

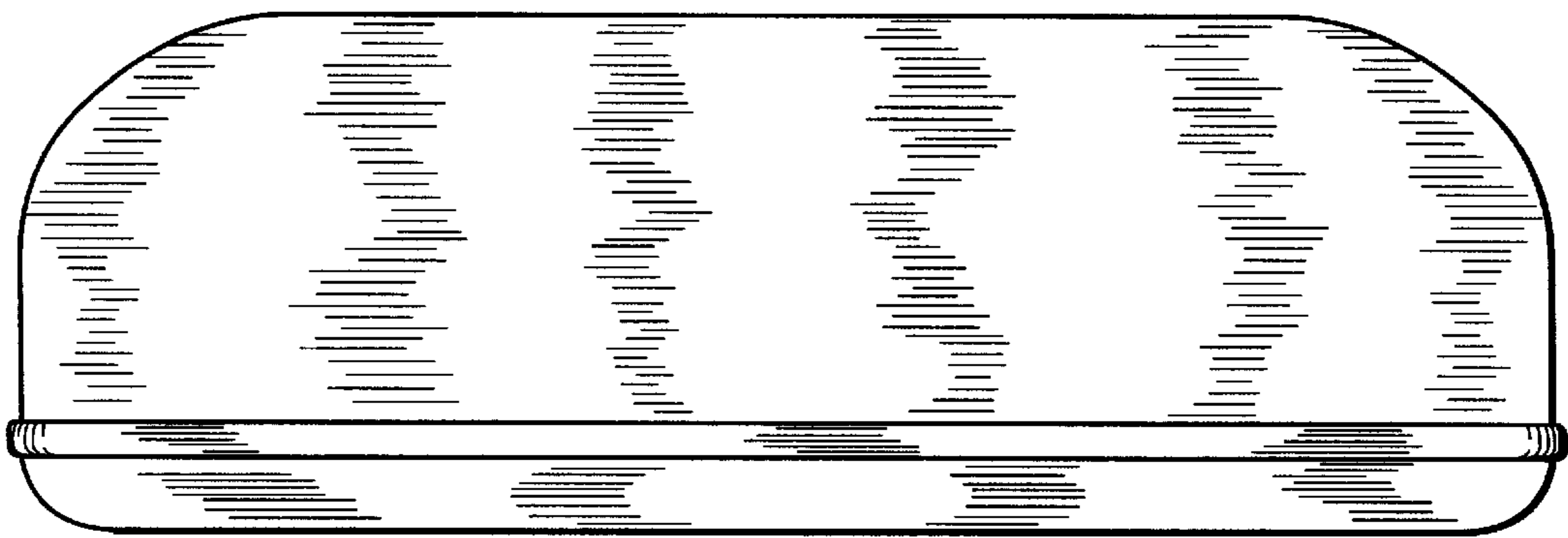
