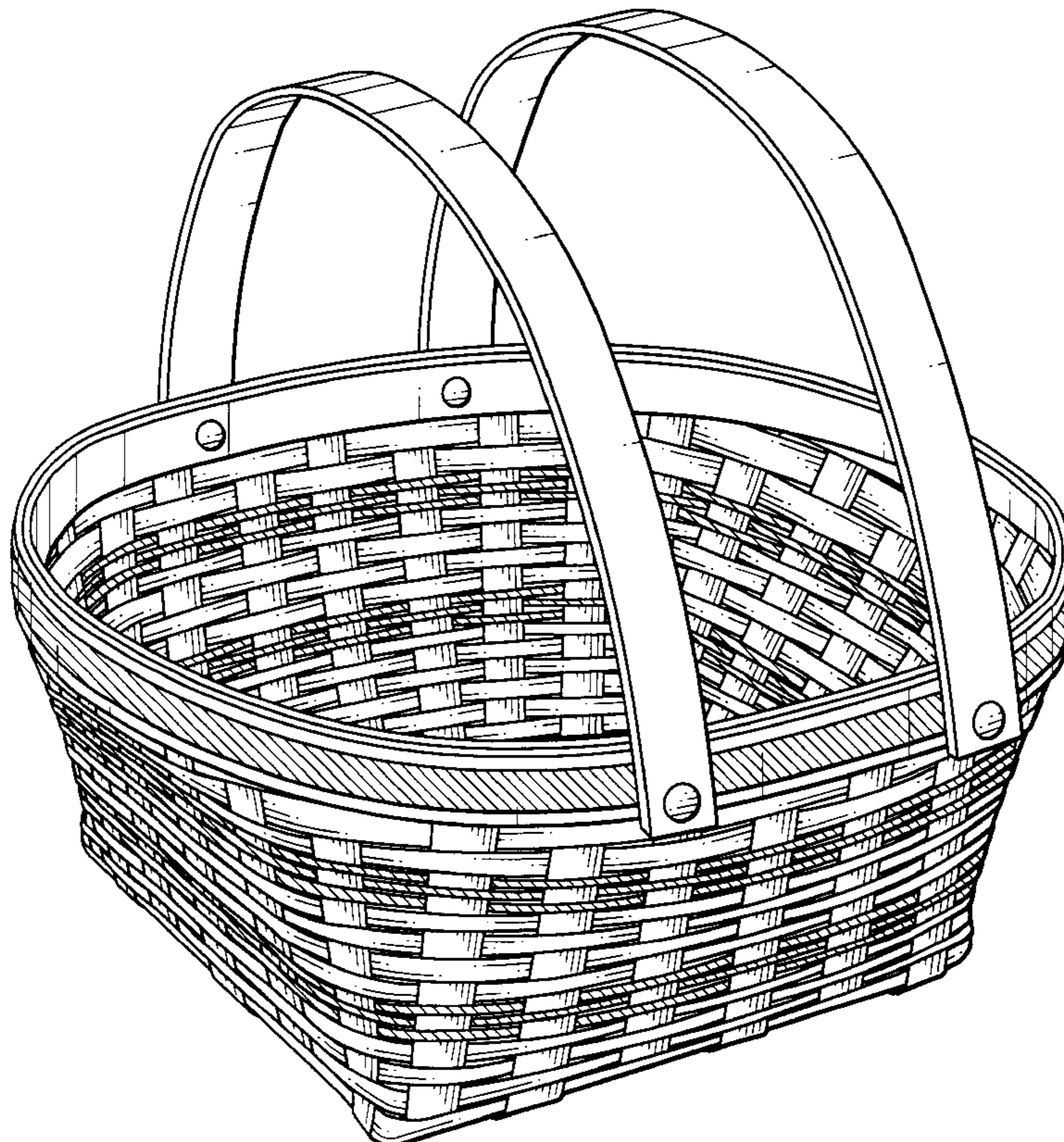
FIG. 1 is a perspective view of the wooden basket showing our new design;

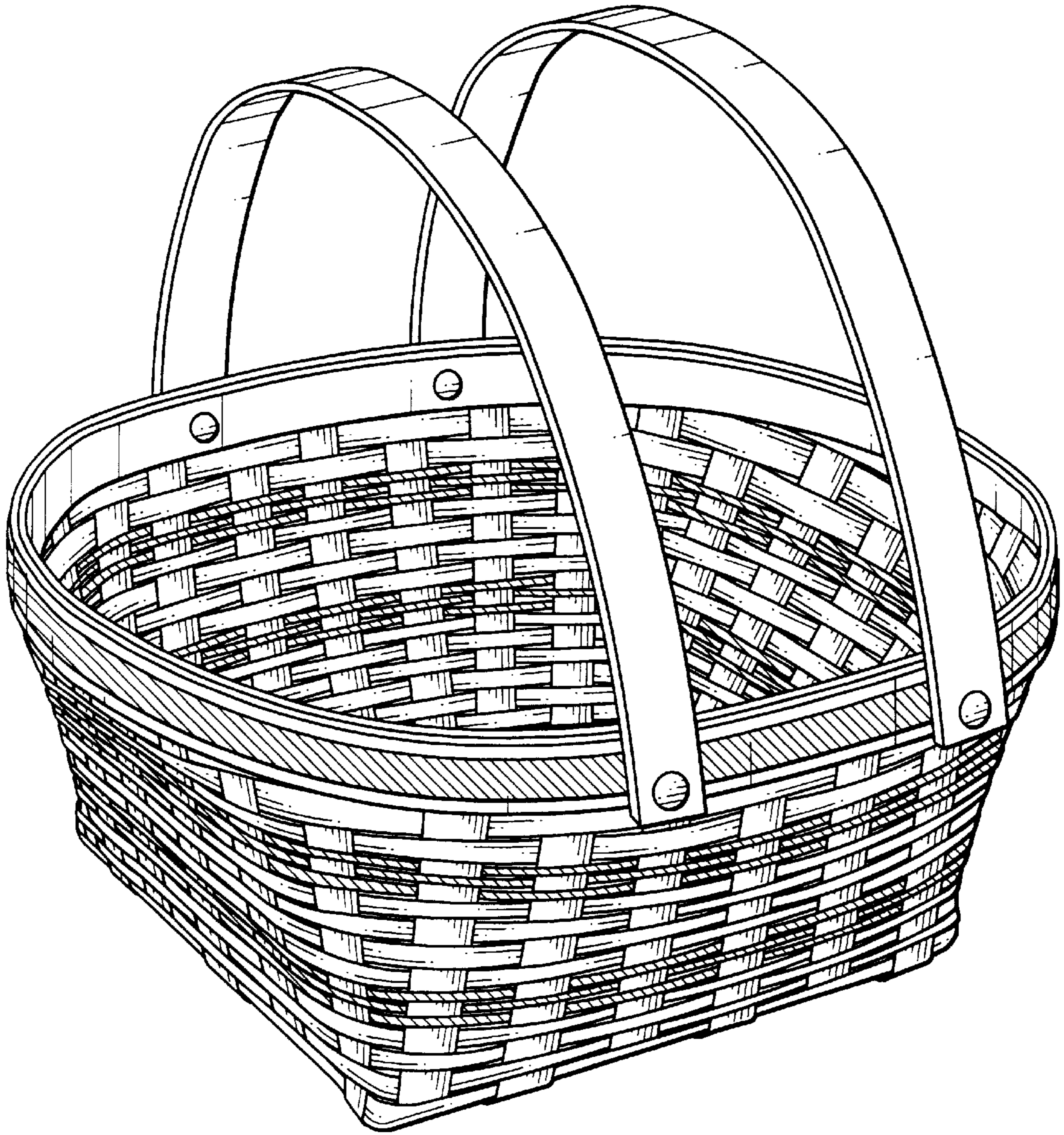

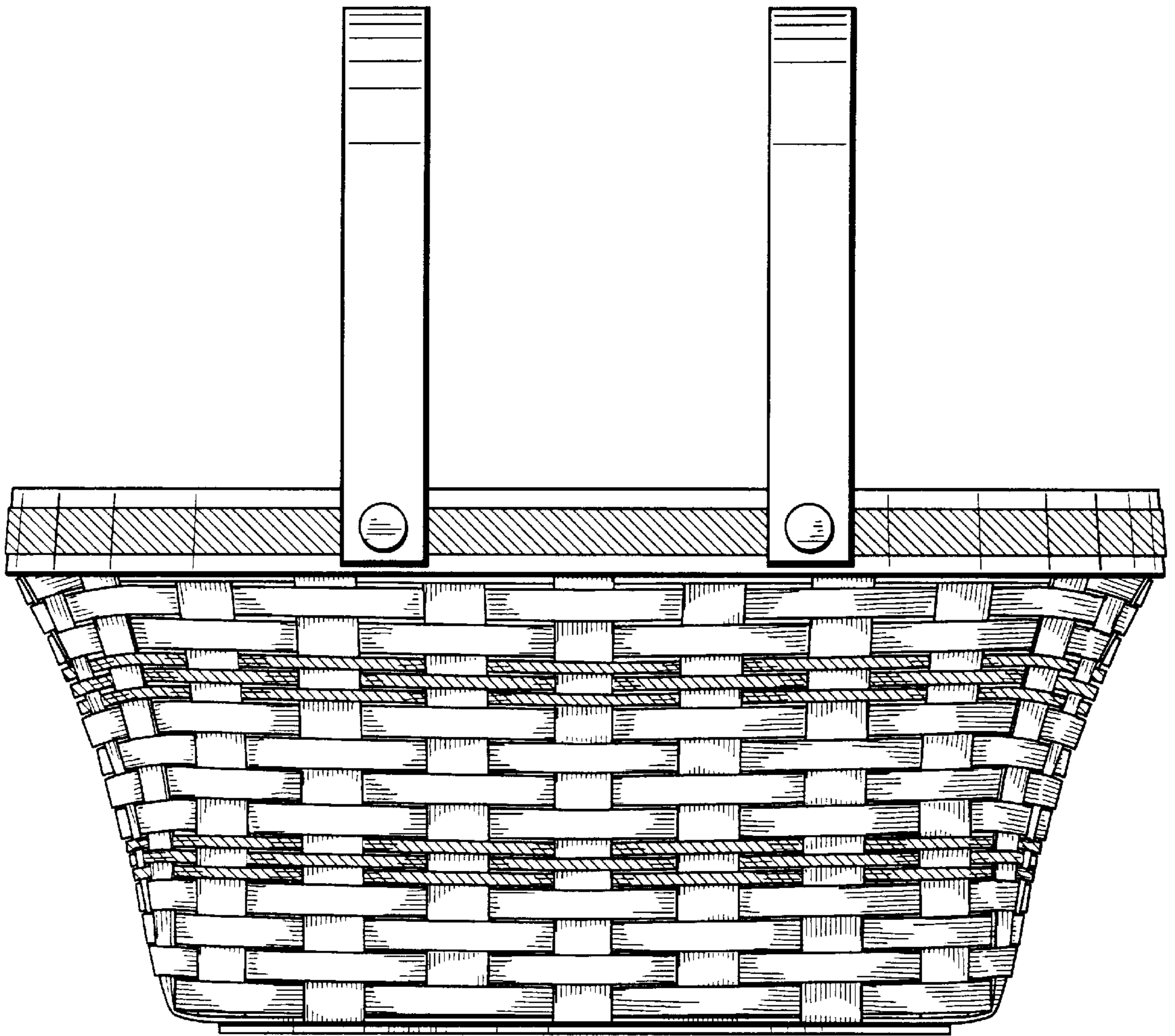

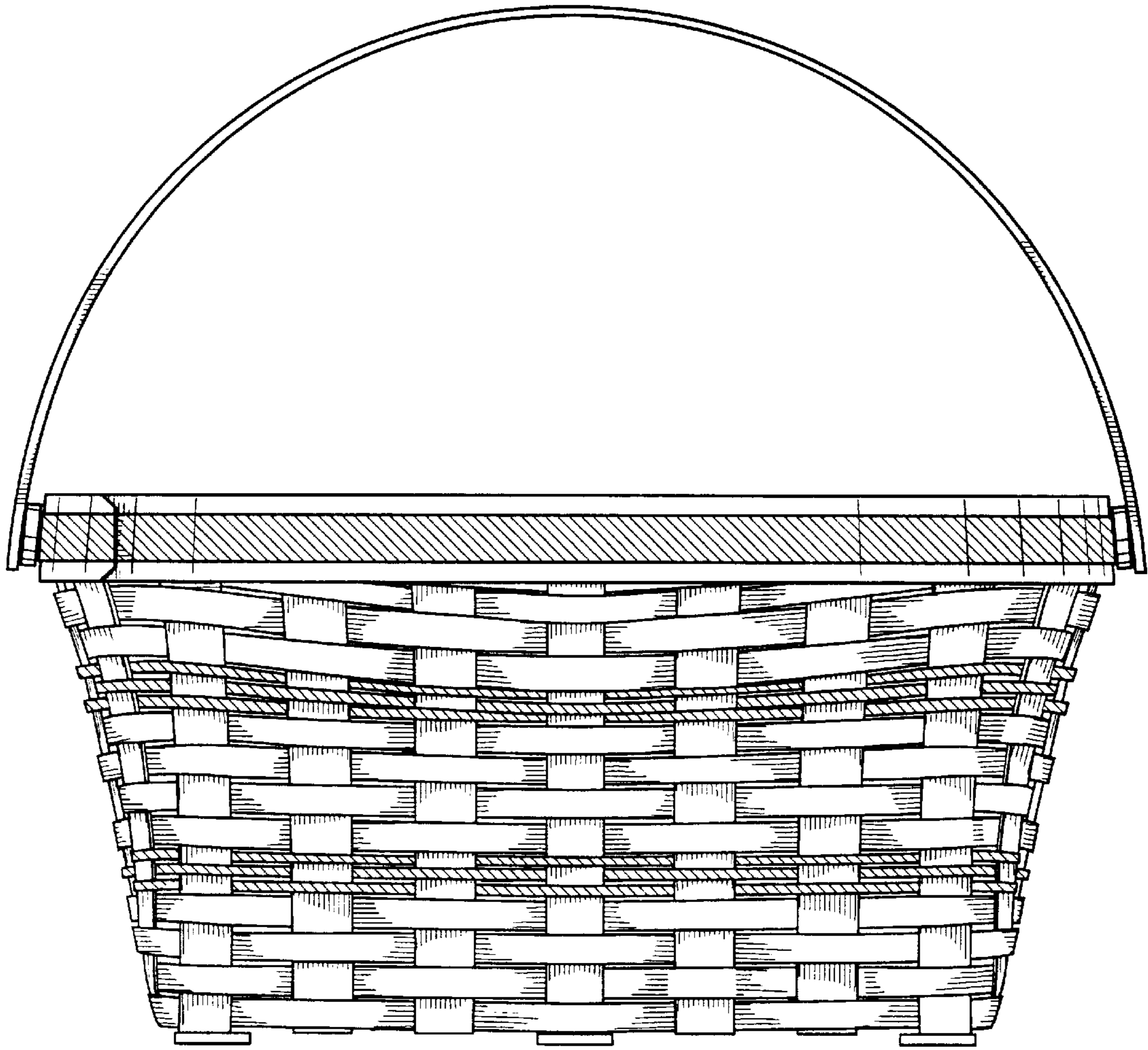

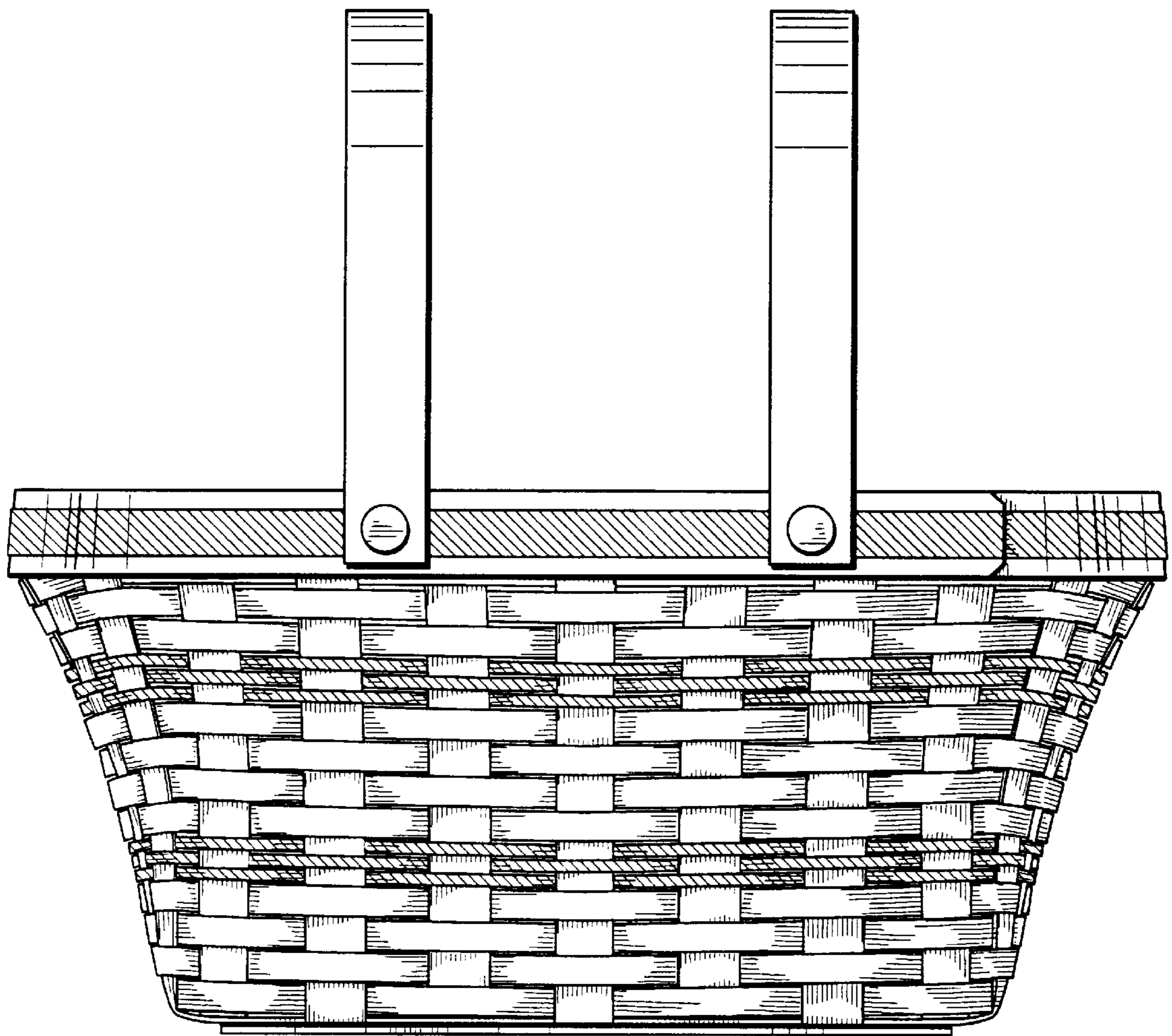

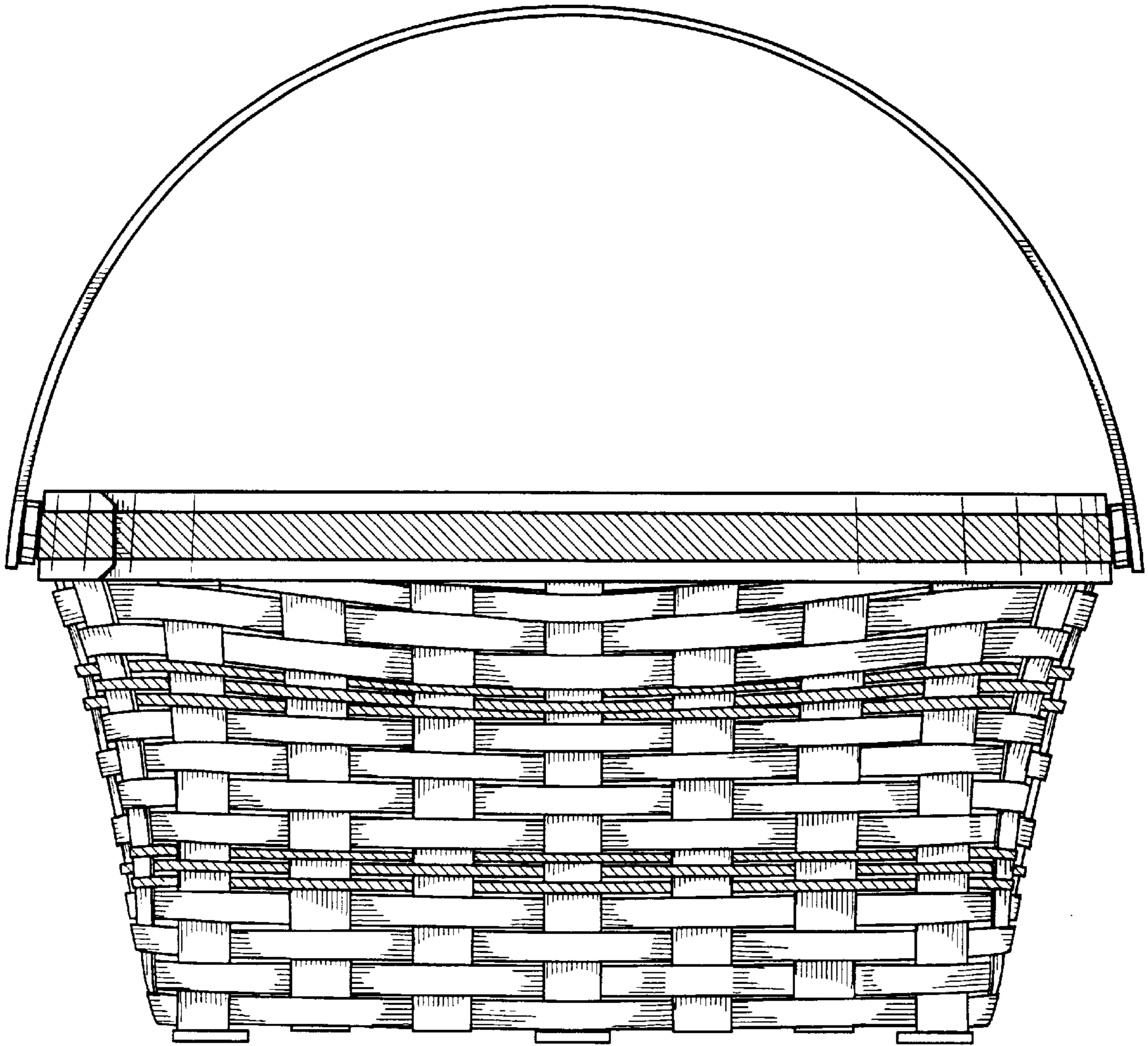

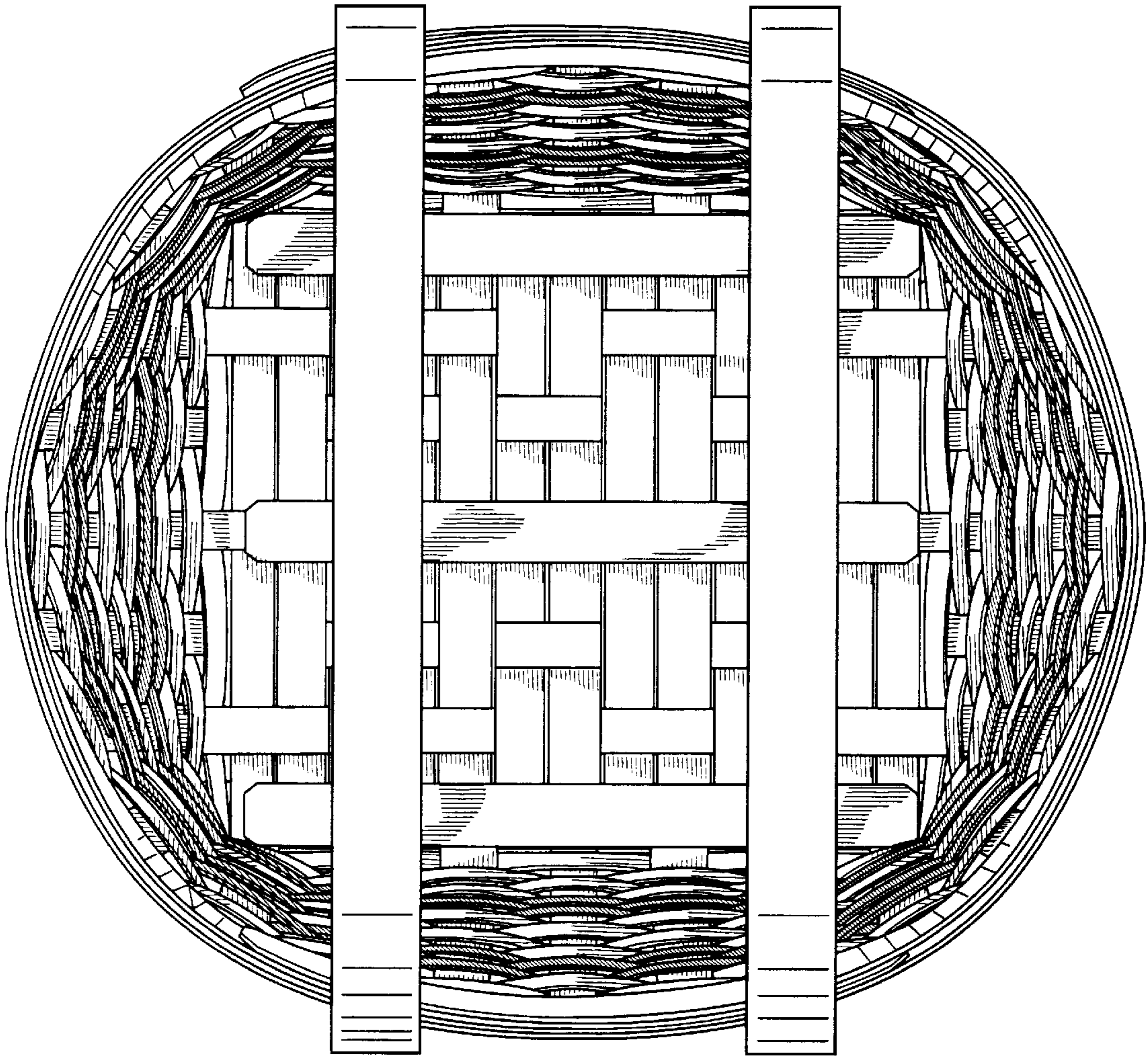

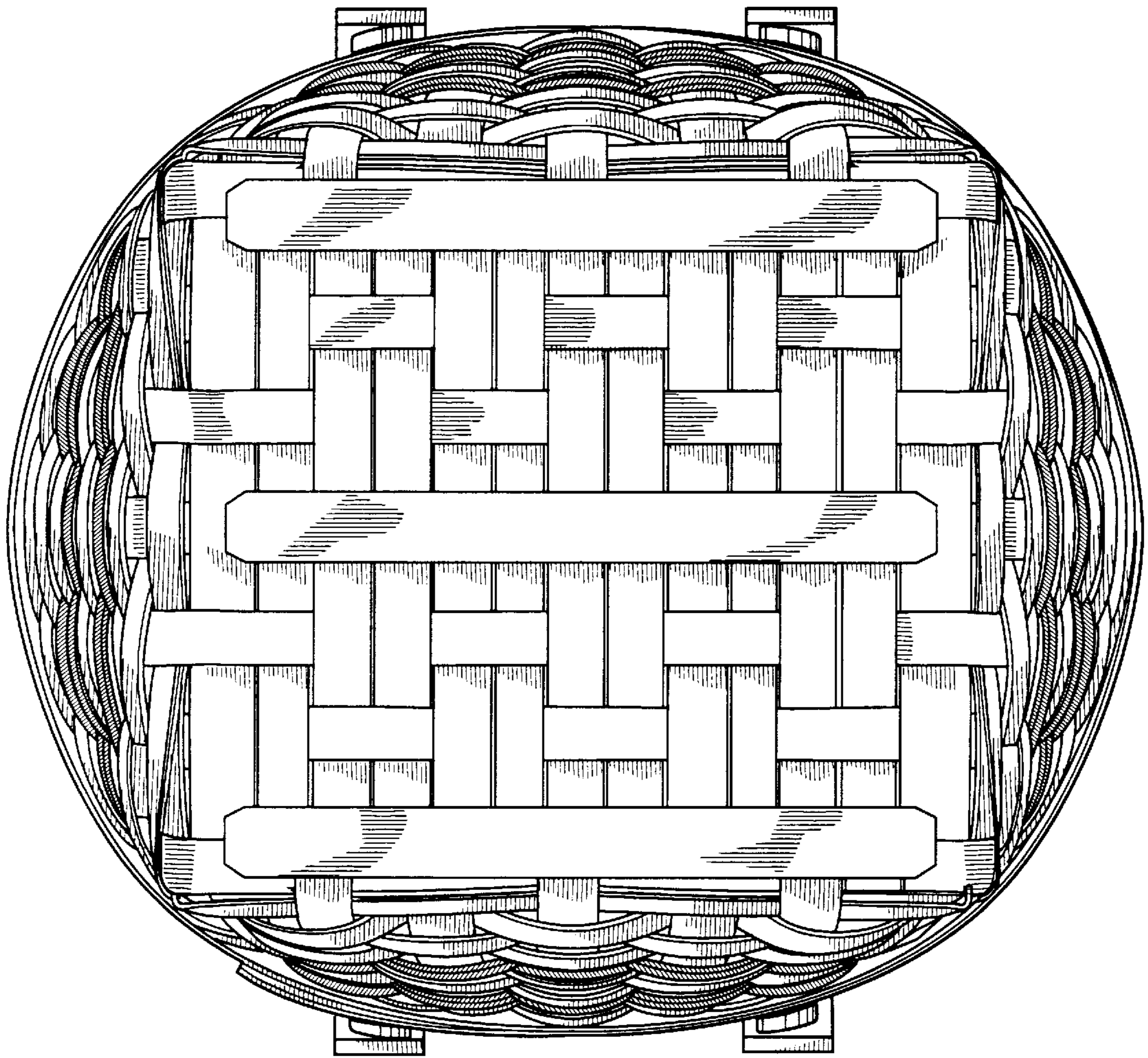
