### [57] CLAIM

The ornamental design for a chaise lounge, as shown and described.

### DESCRIPTION

FIG. 1 is a front, left perspective view of a chaise lounge showing my new design in a raised position; FIG. 2 is a rear, left perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a side elevational view thereof, the other side being a mirror image; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front, left perspective view of the chaise lounge of FIG. 1 in a lowered position; FIG. 8 is a rear, left perspective view thereof; FIG. 9 is a further rear, left perspective view thereof; FIG. 10 is a top plan view thereof; FIG. 11 is a side elevational view thereof, the other side being a mirror image; FIG. 12 is a front elevational view thereof; and, FIG. 13 is a rear elevational view thereof. FIGS. 5 and 6 have been shown on an enlarged scale with respect to FIGS. 1 through 4, FIGS. 12 and 13 have been shown further enlarged and FIGS. 7 through 11 have been shown on a reduced scale in respect to all other views.

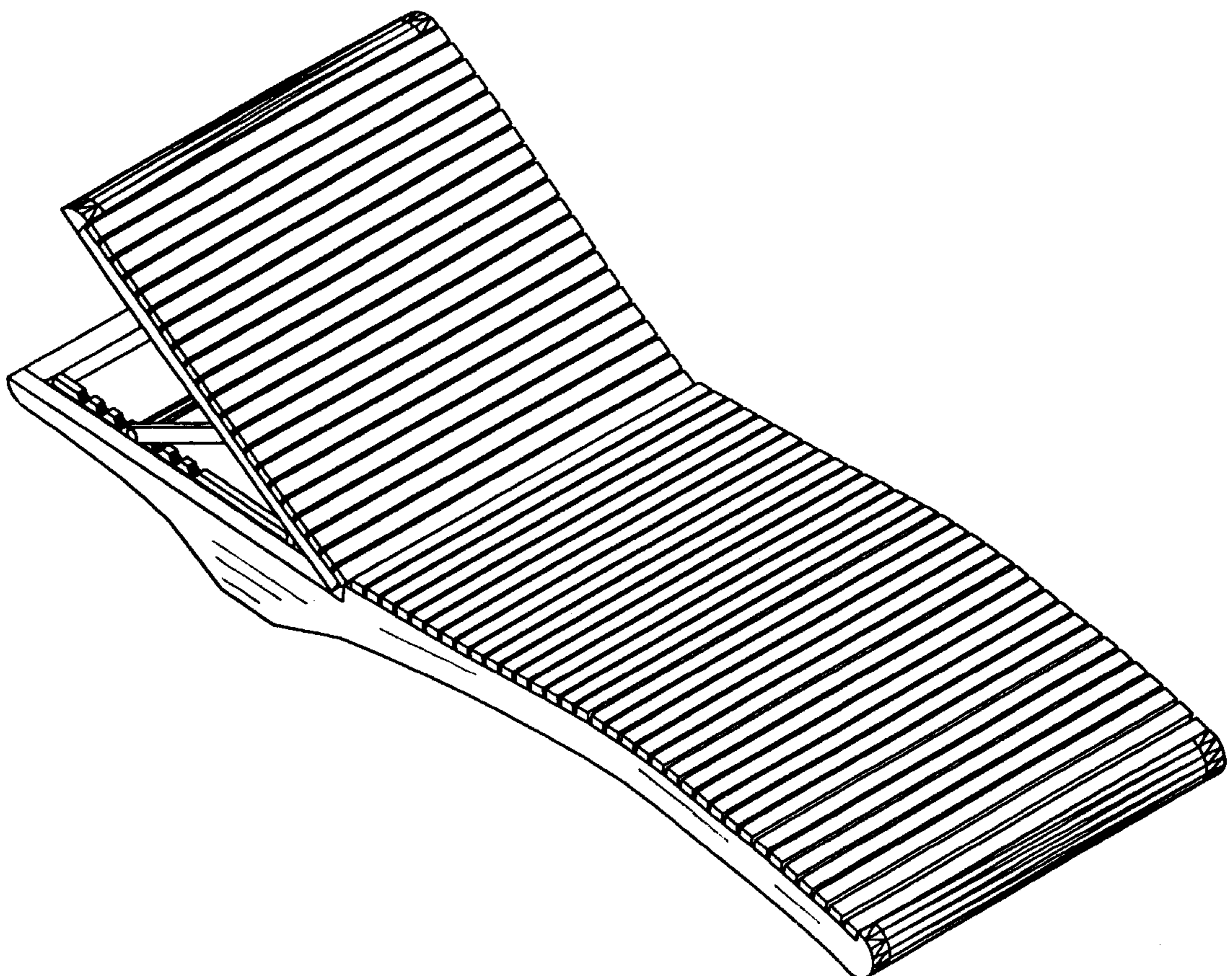
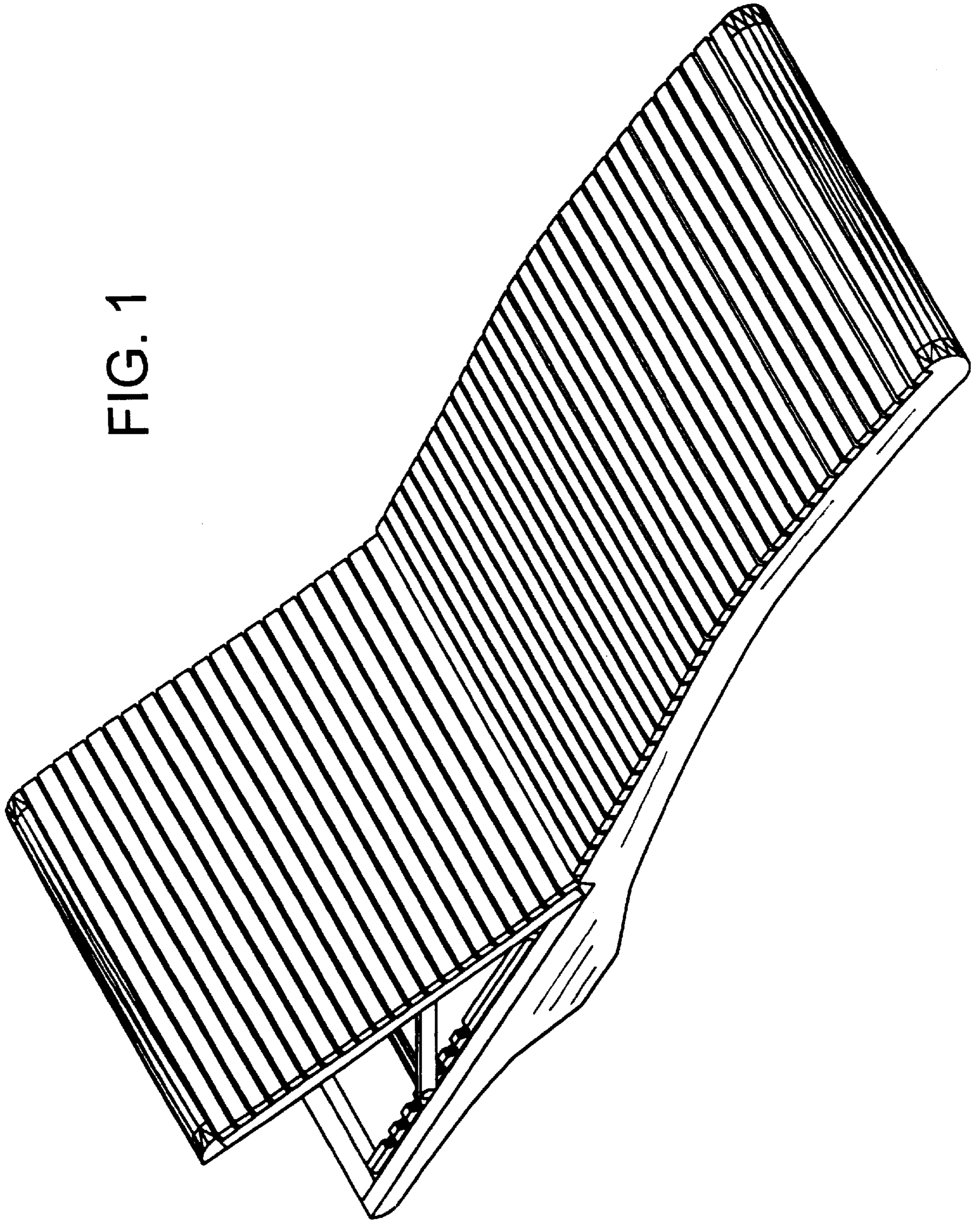

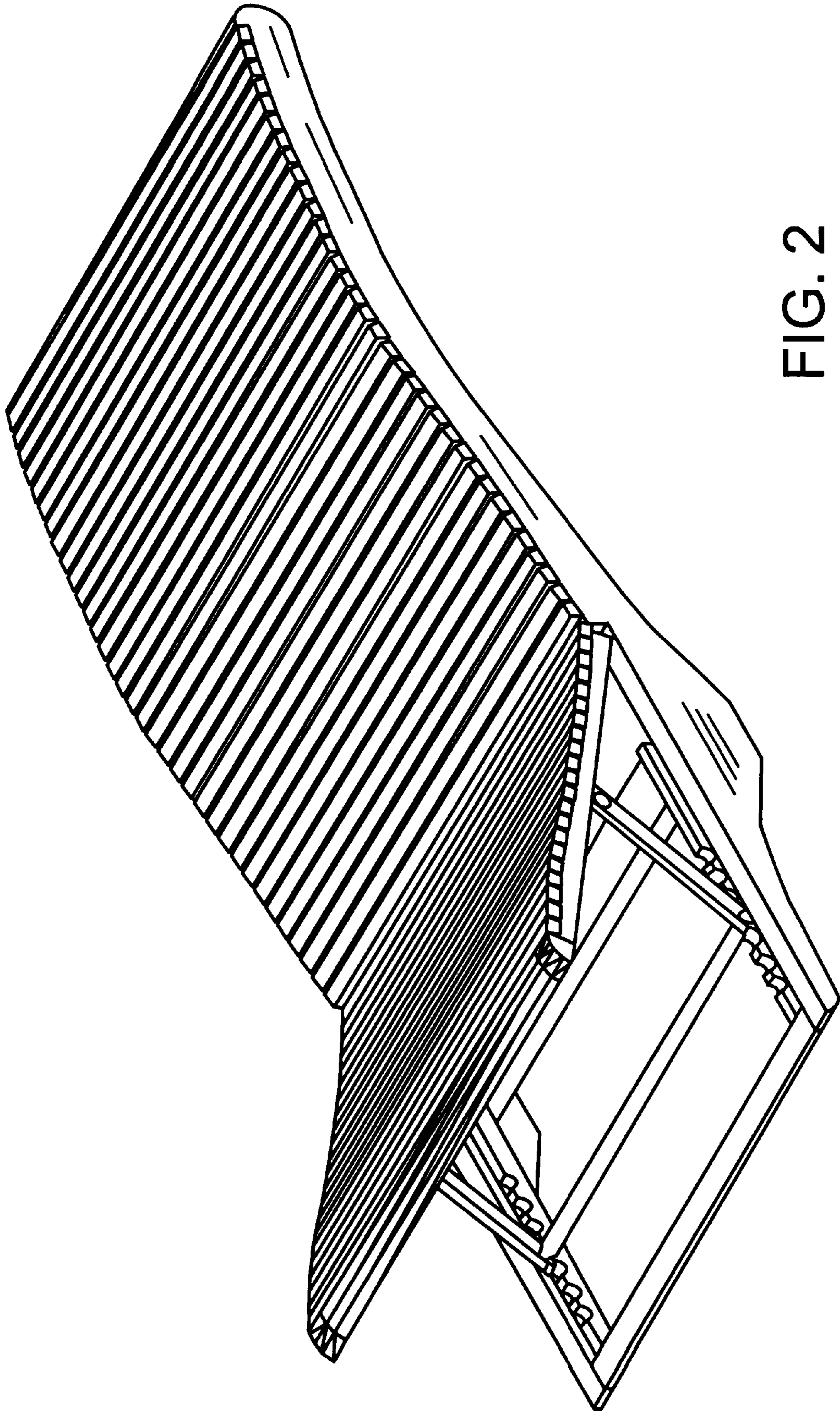

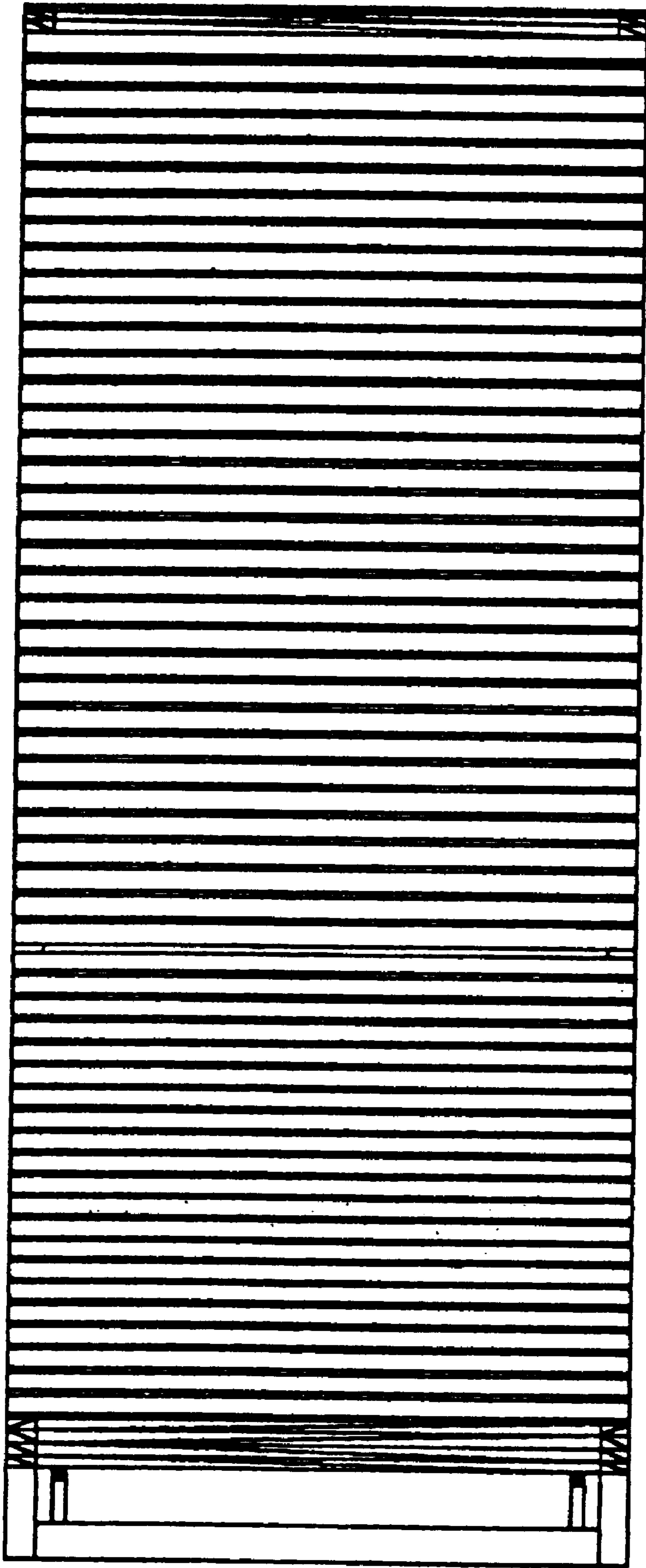

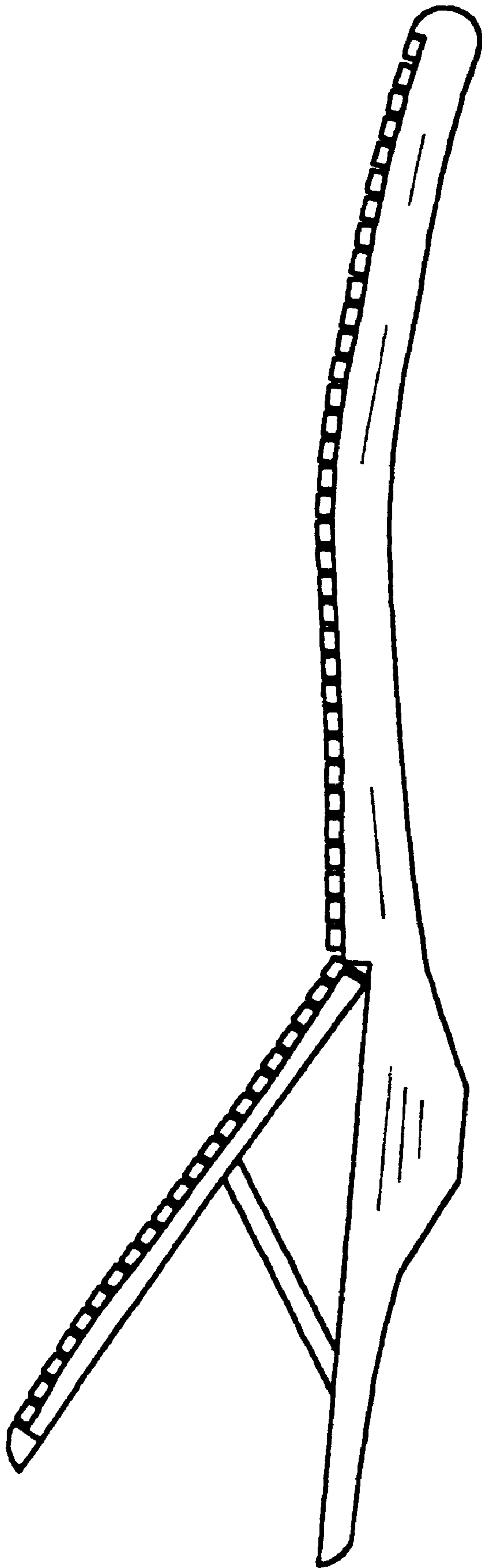

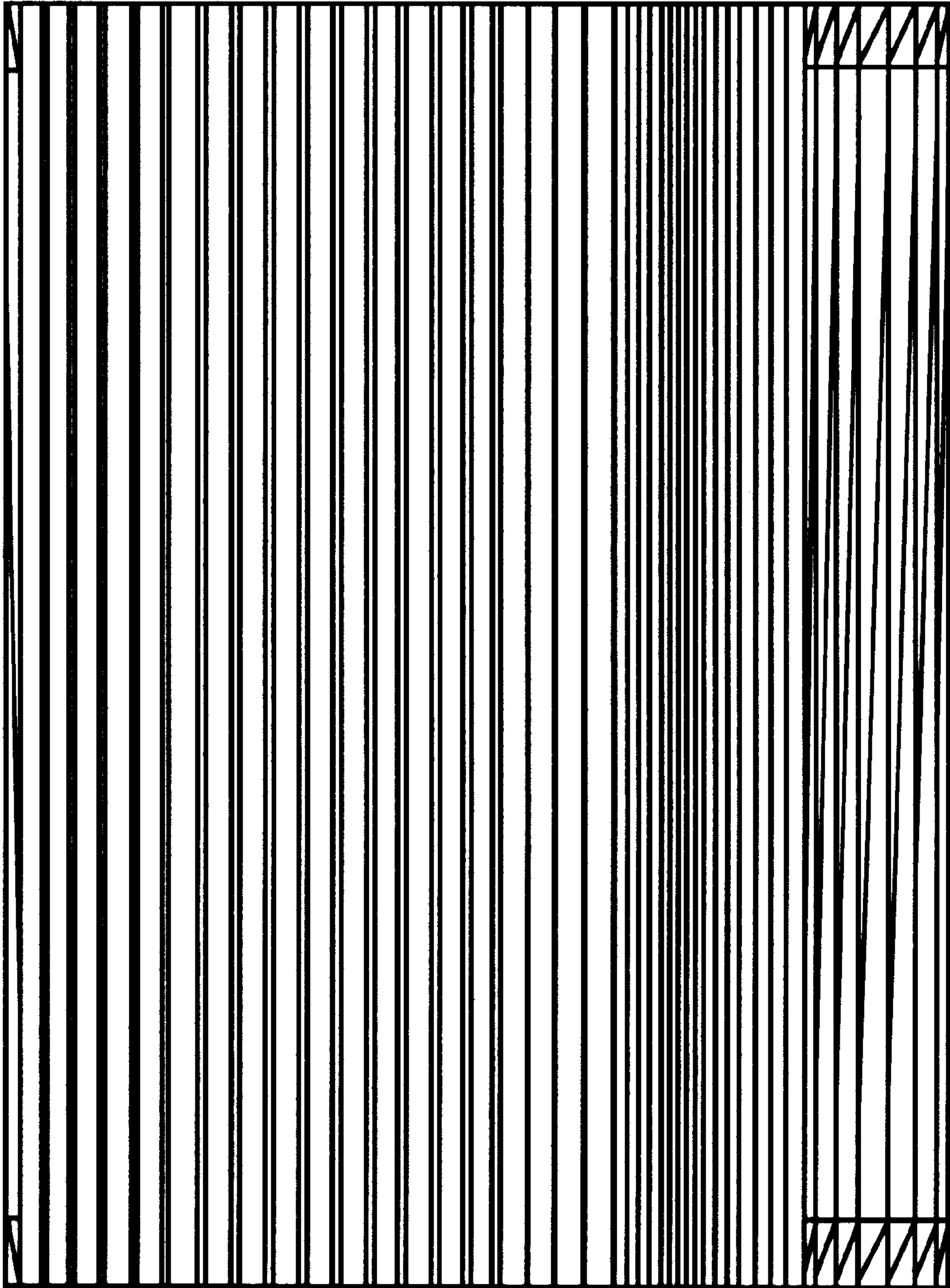

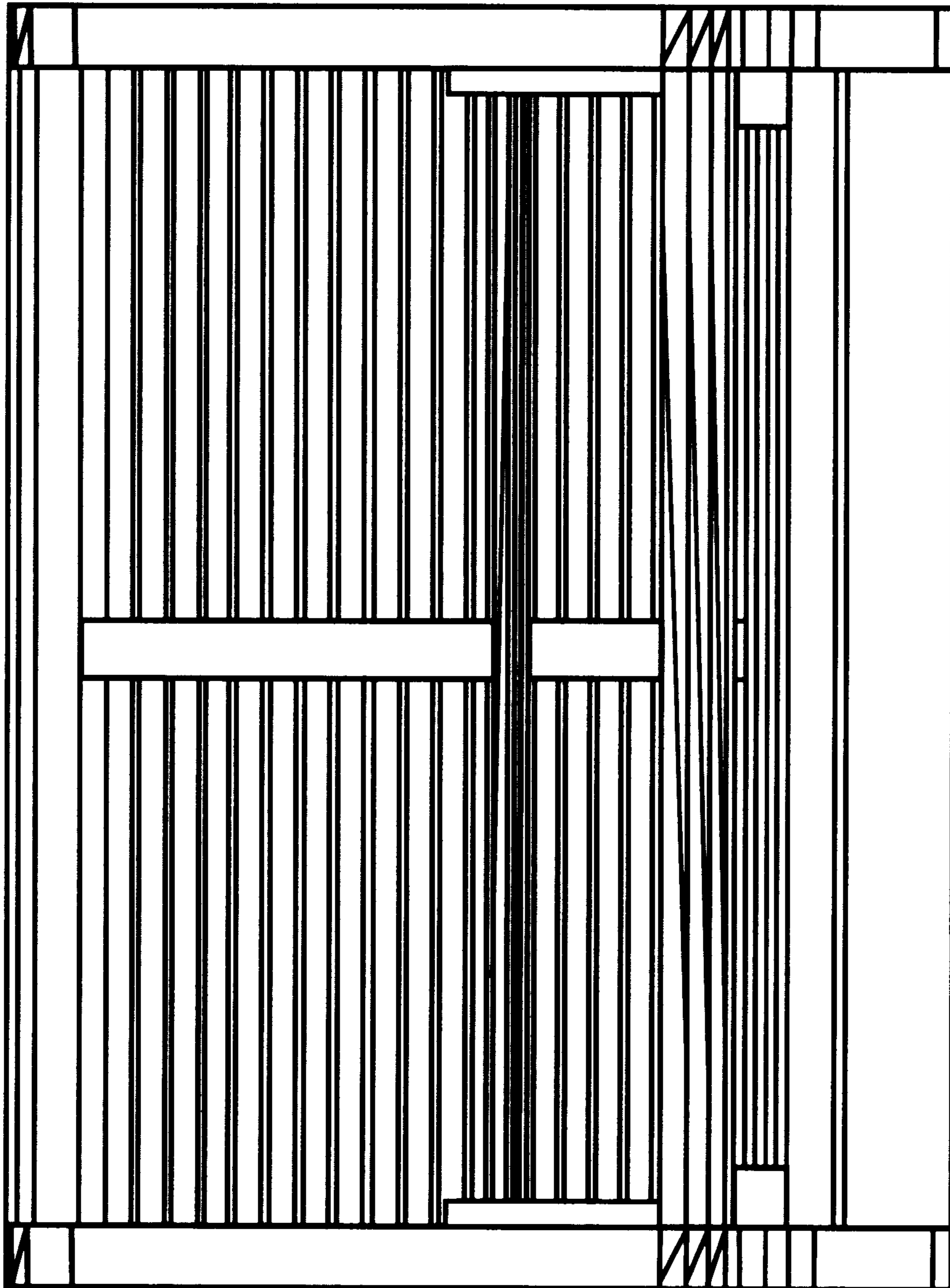

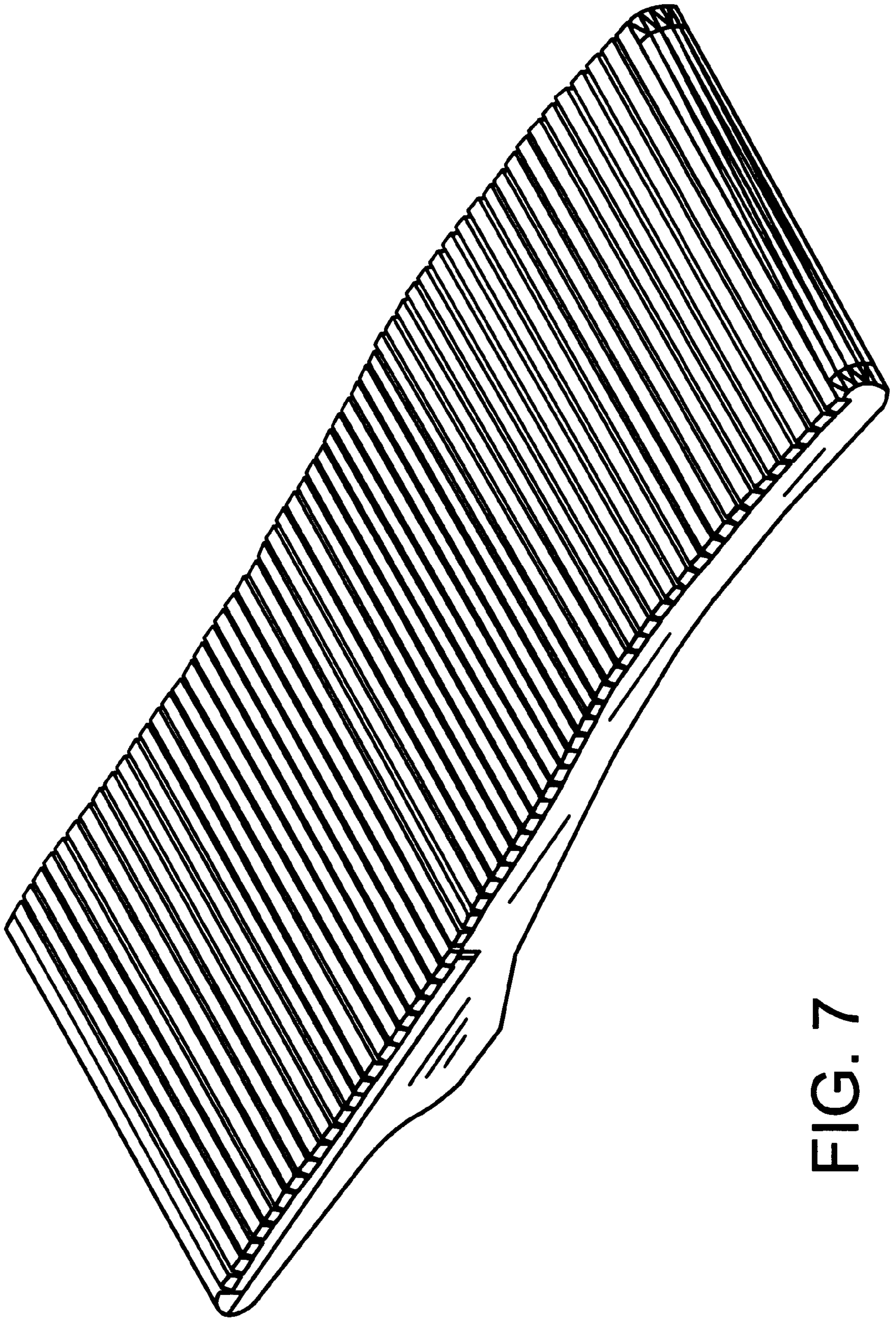

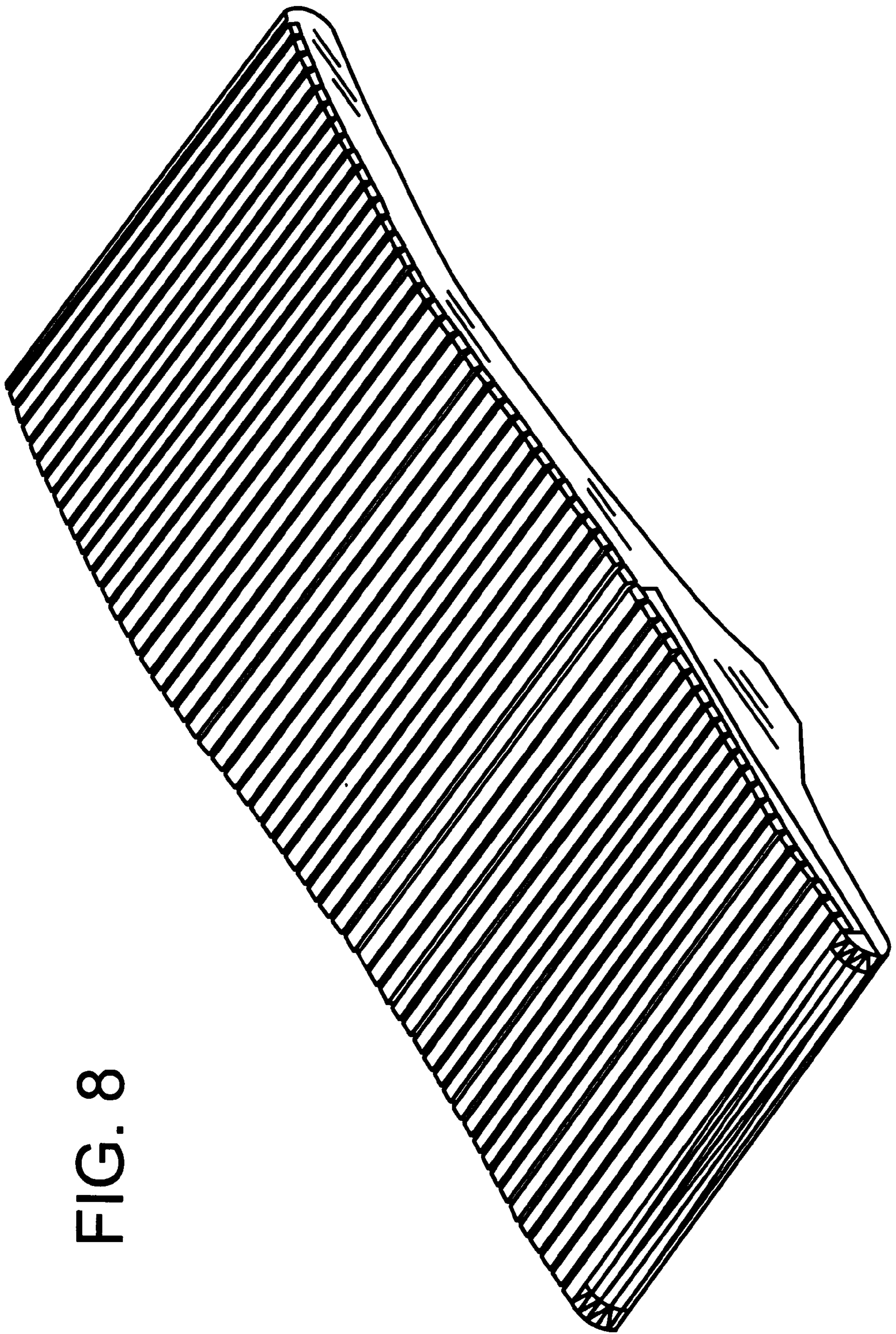

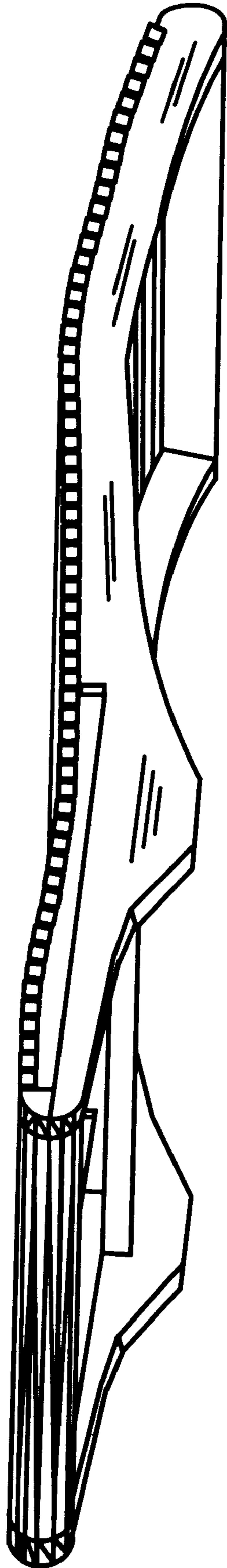

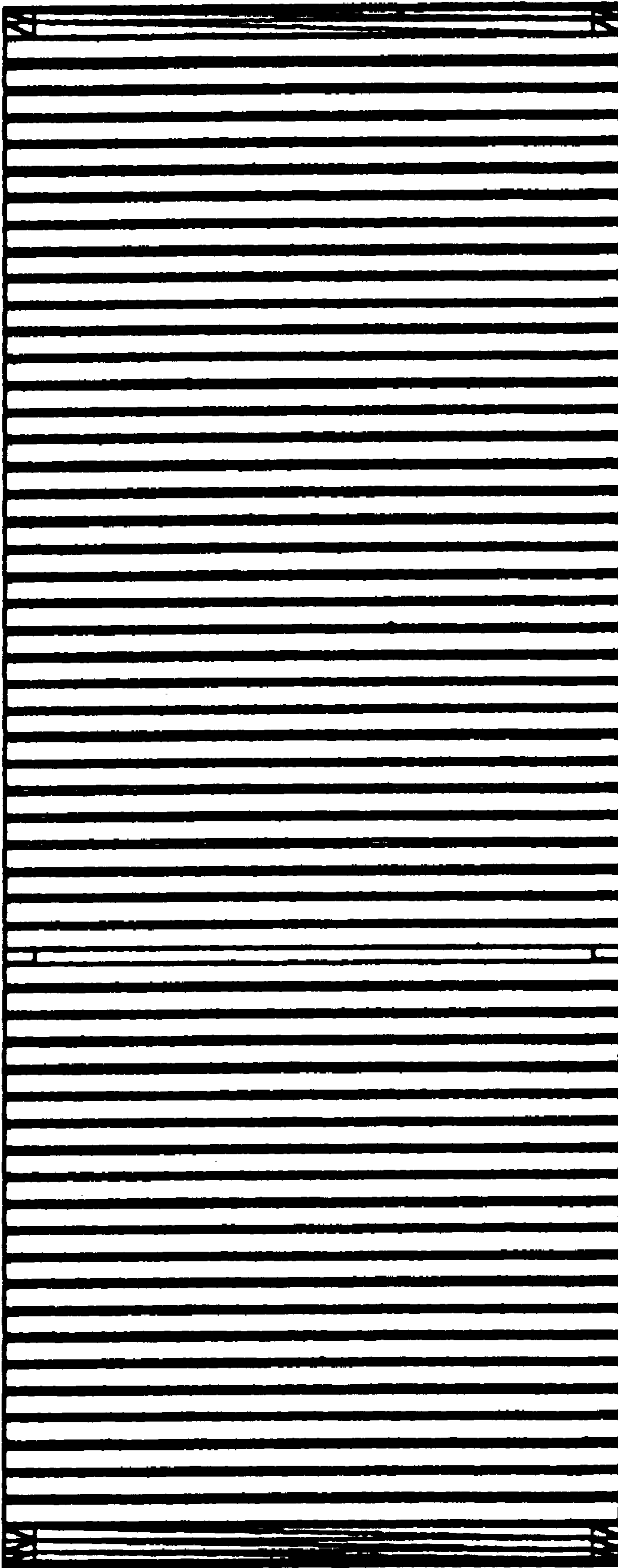

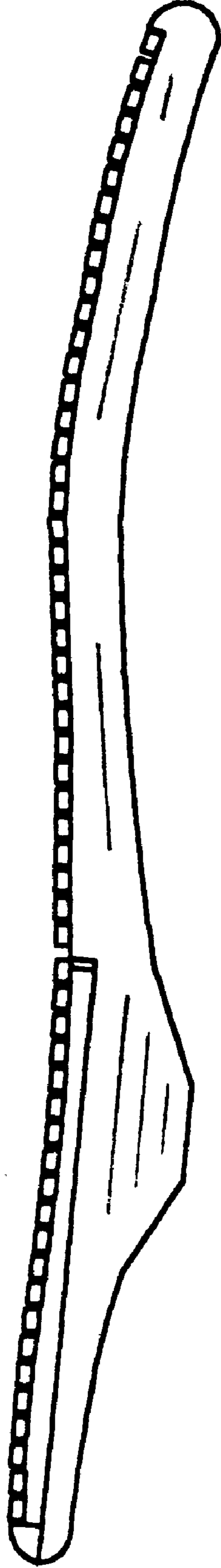

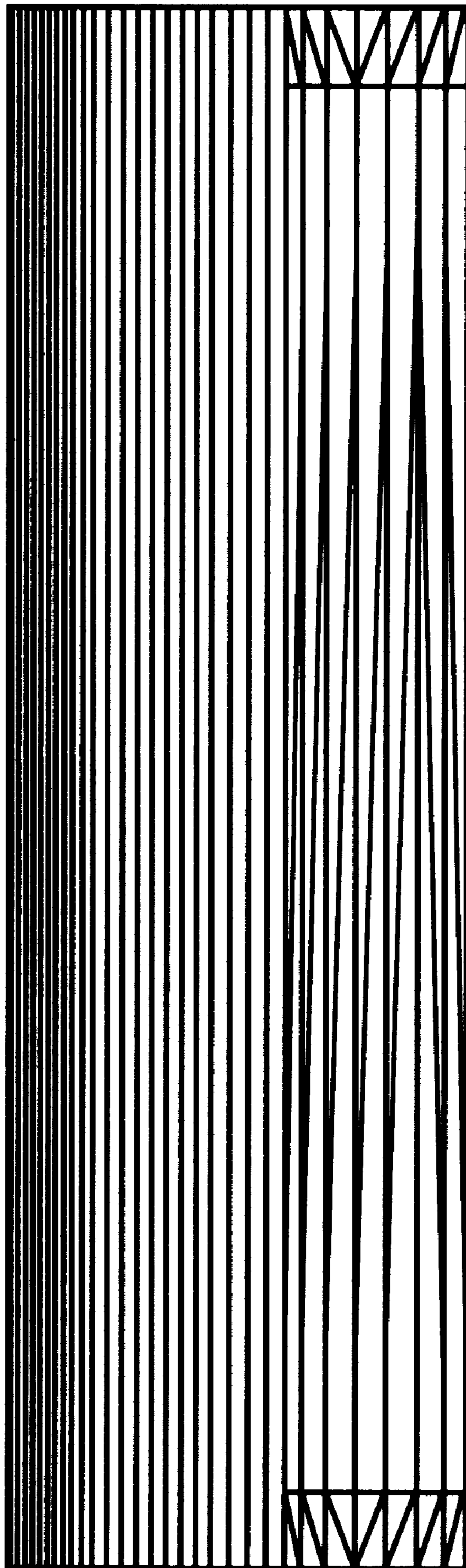

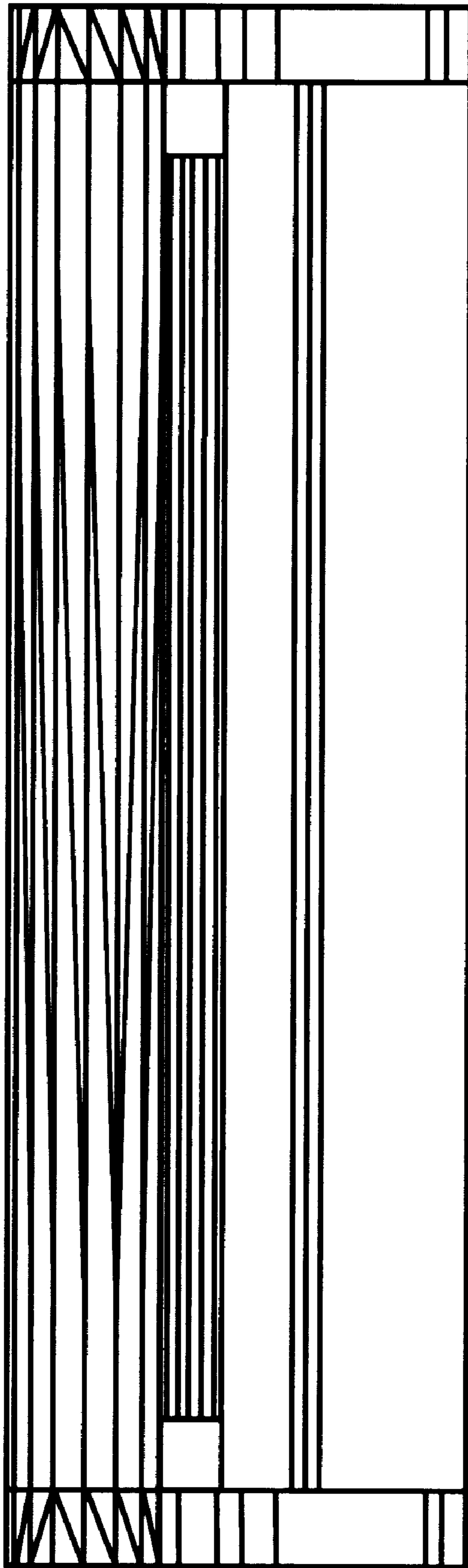
