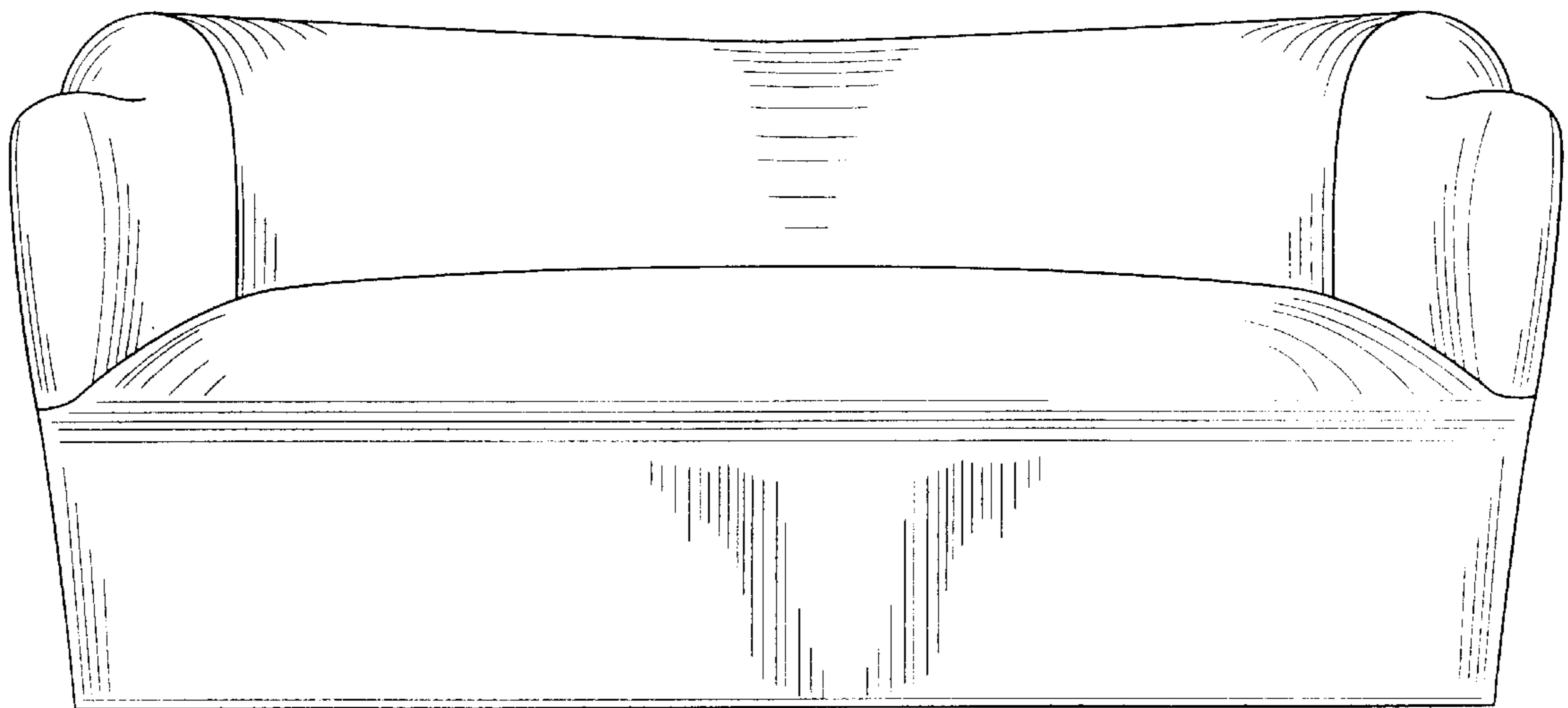

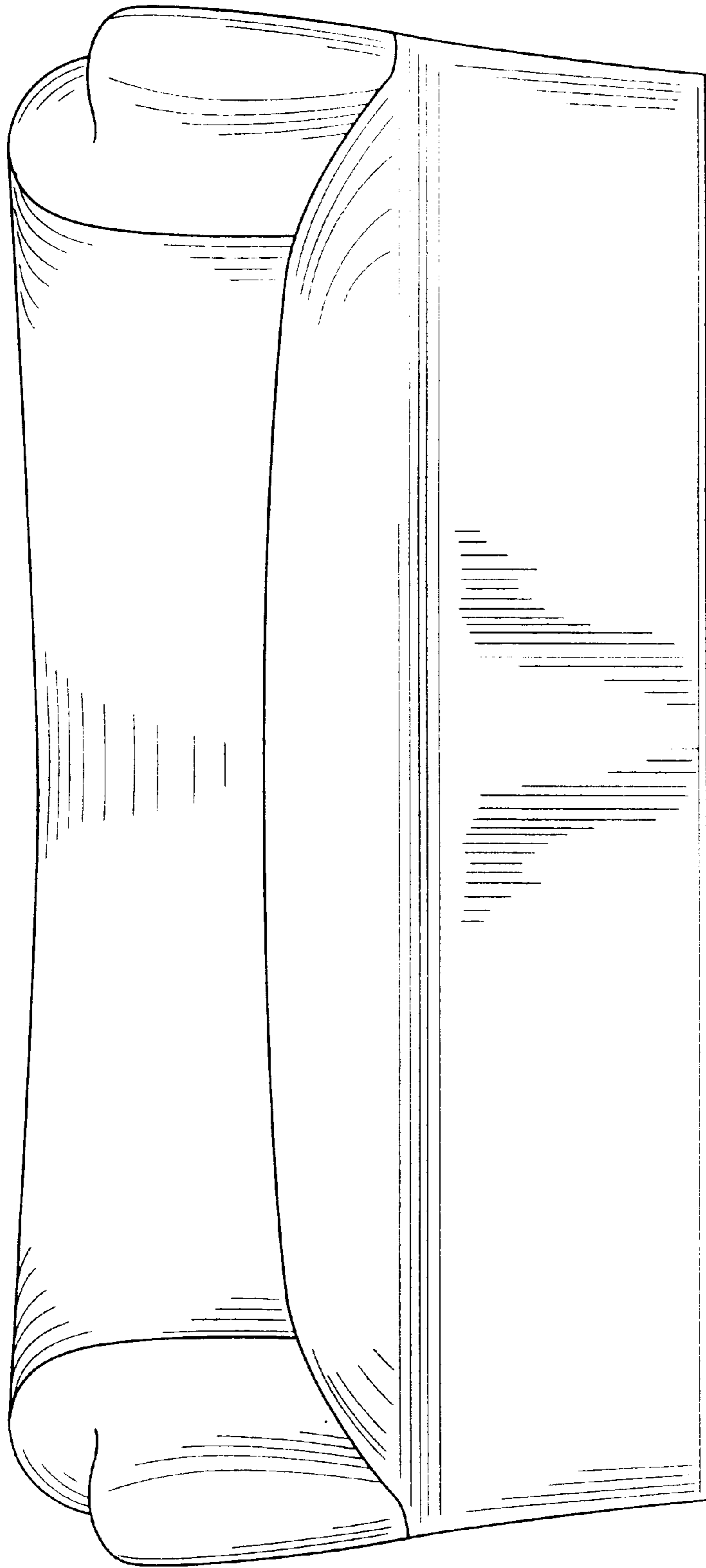
The ornamental design for a sofa, as shown and described.

#### DESCRIPTION

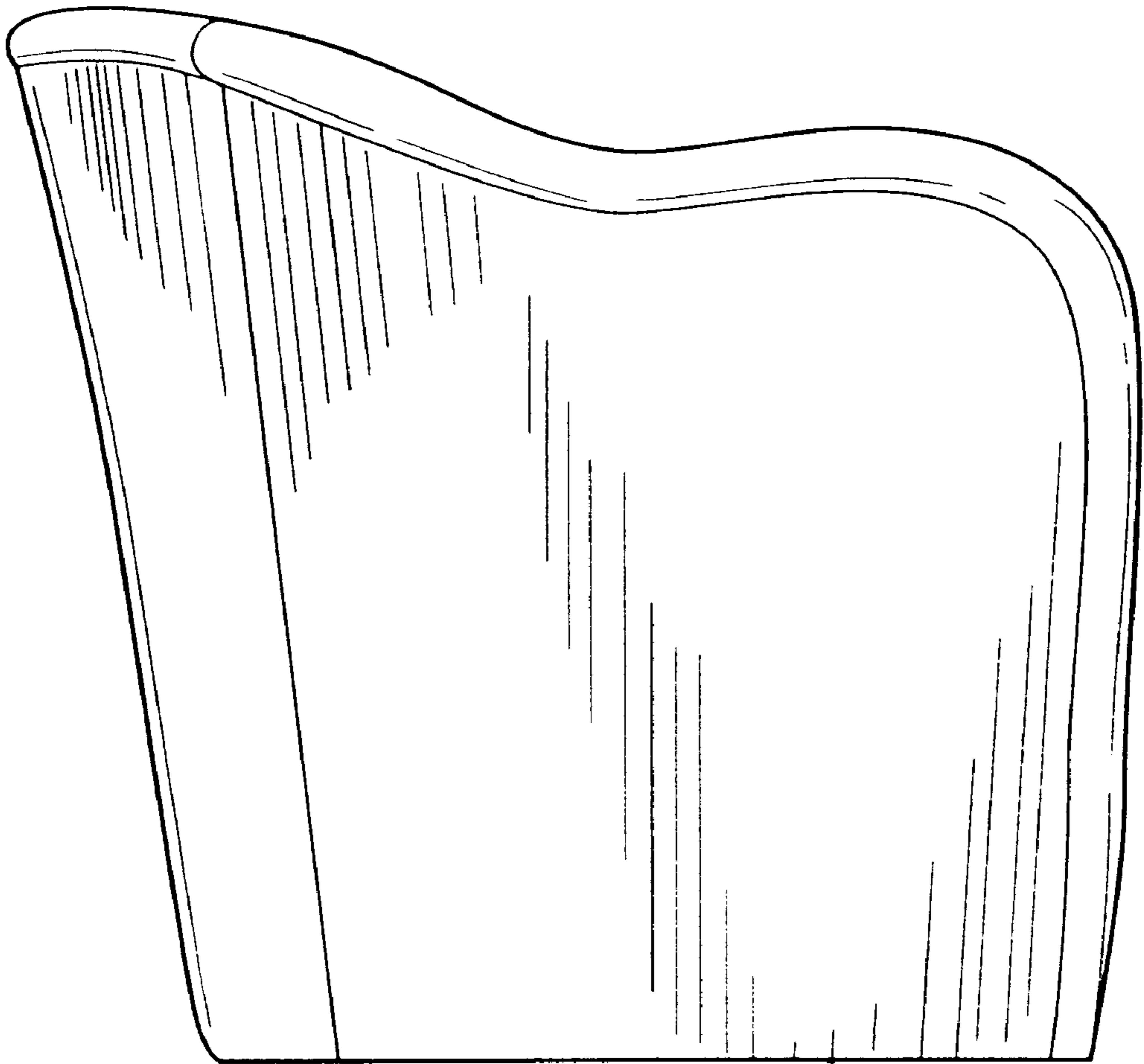
FIG. 1 is a front view of the sofa of my design;

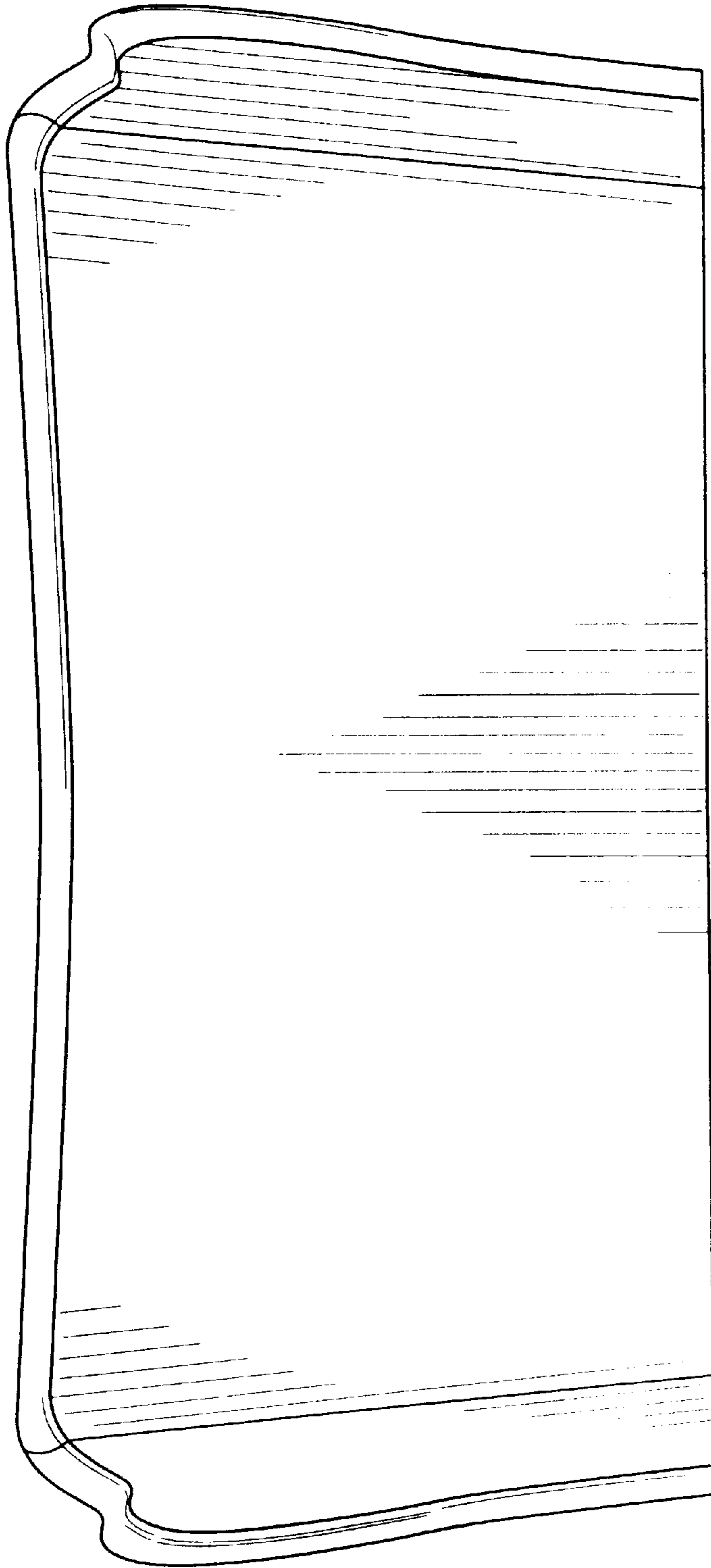




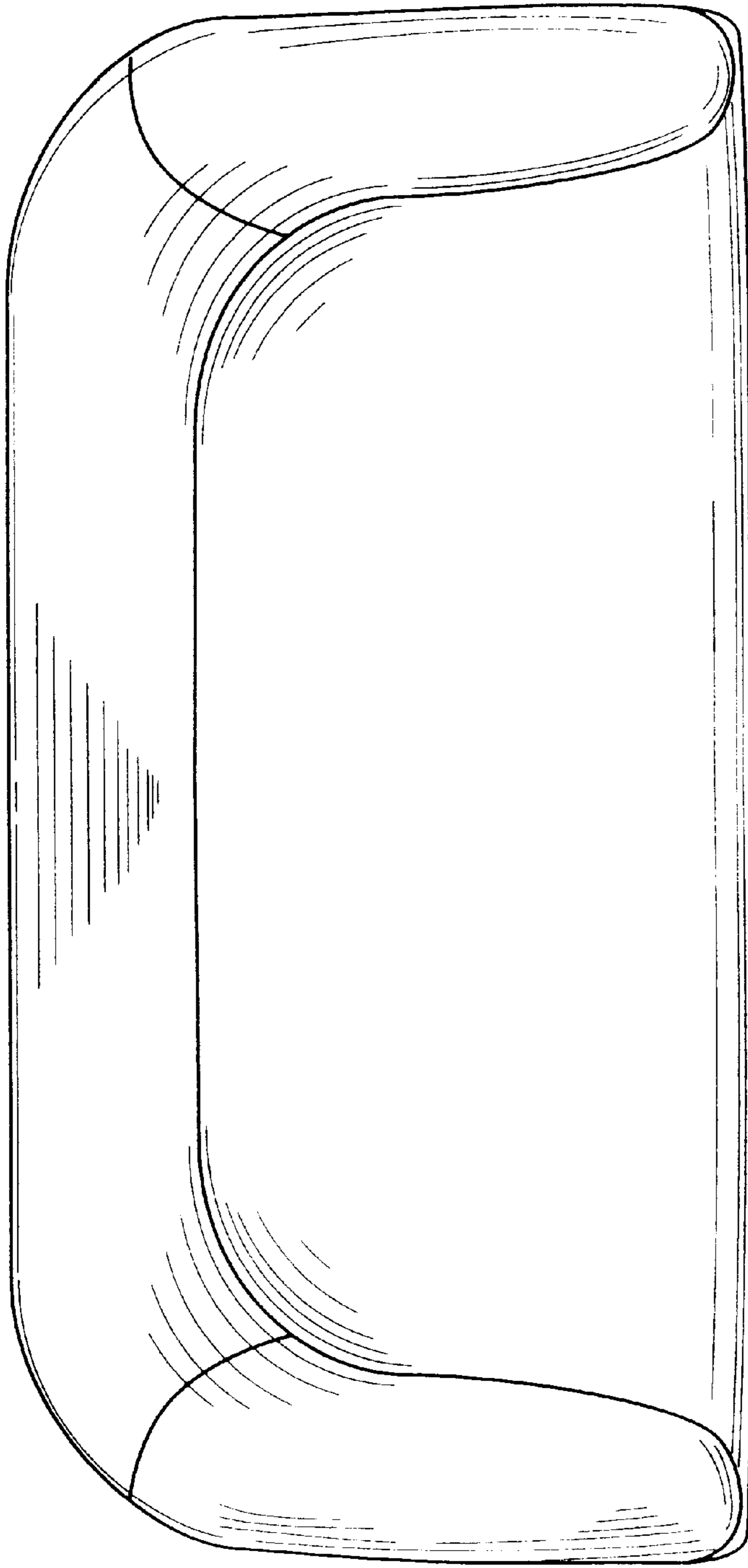

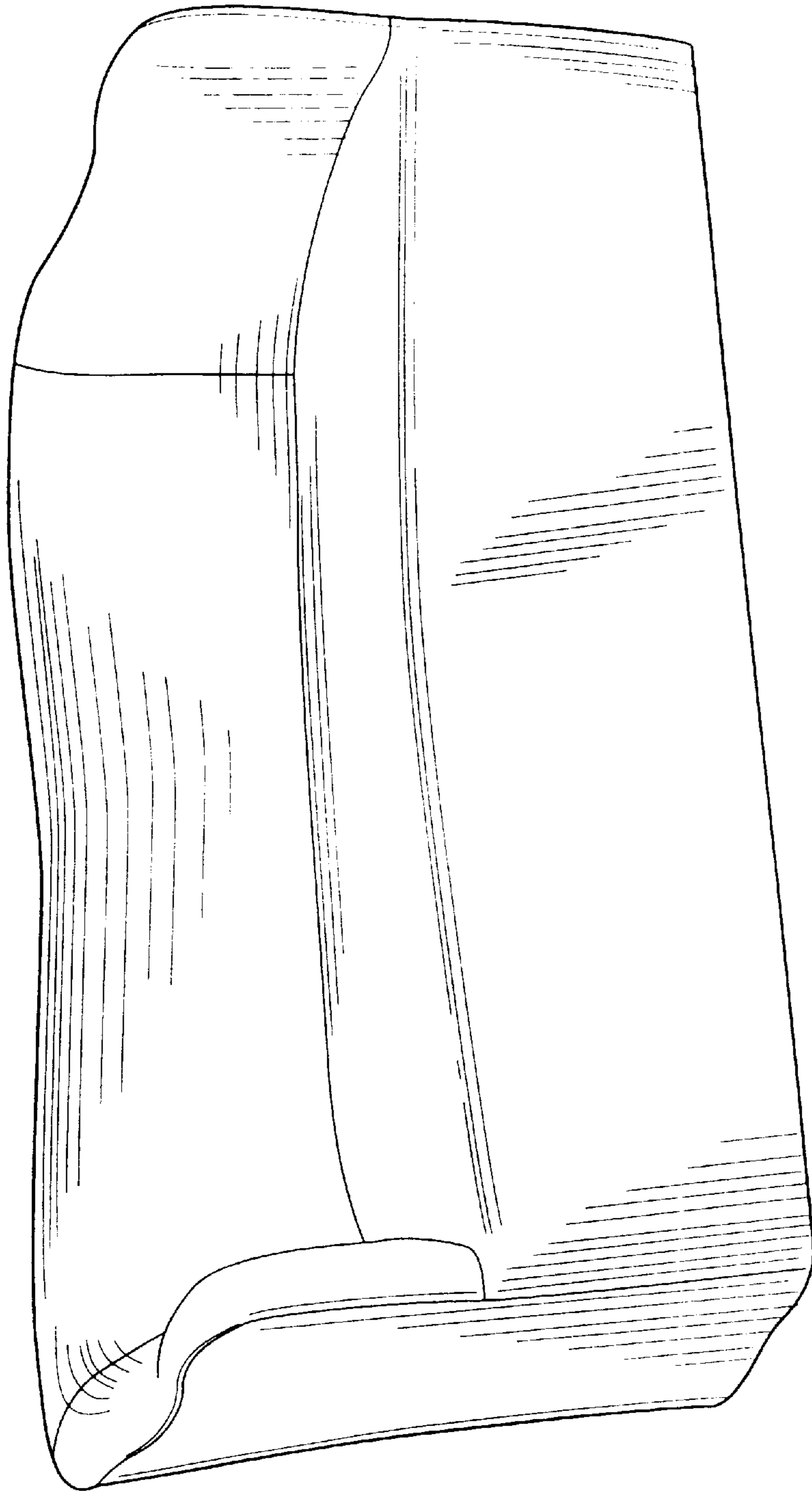
