## [57] **CLAIM**

The ornamental design for a pair of side tables for a glider, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a pair of side tables for a glider, showing my new design.  
FIG. 2 is a top plan view thereof.  
FIG. 3 is a front elevational view thereof.  
FIG. 4 is a side elevational view thereof.  
FIG. 5 is a rear elevational view thereof; and,  
FIG. 6 is a bottom plan view thereof.

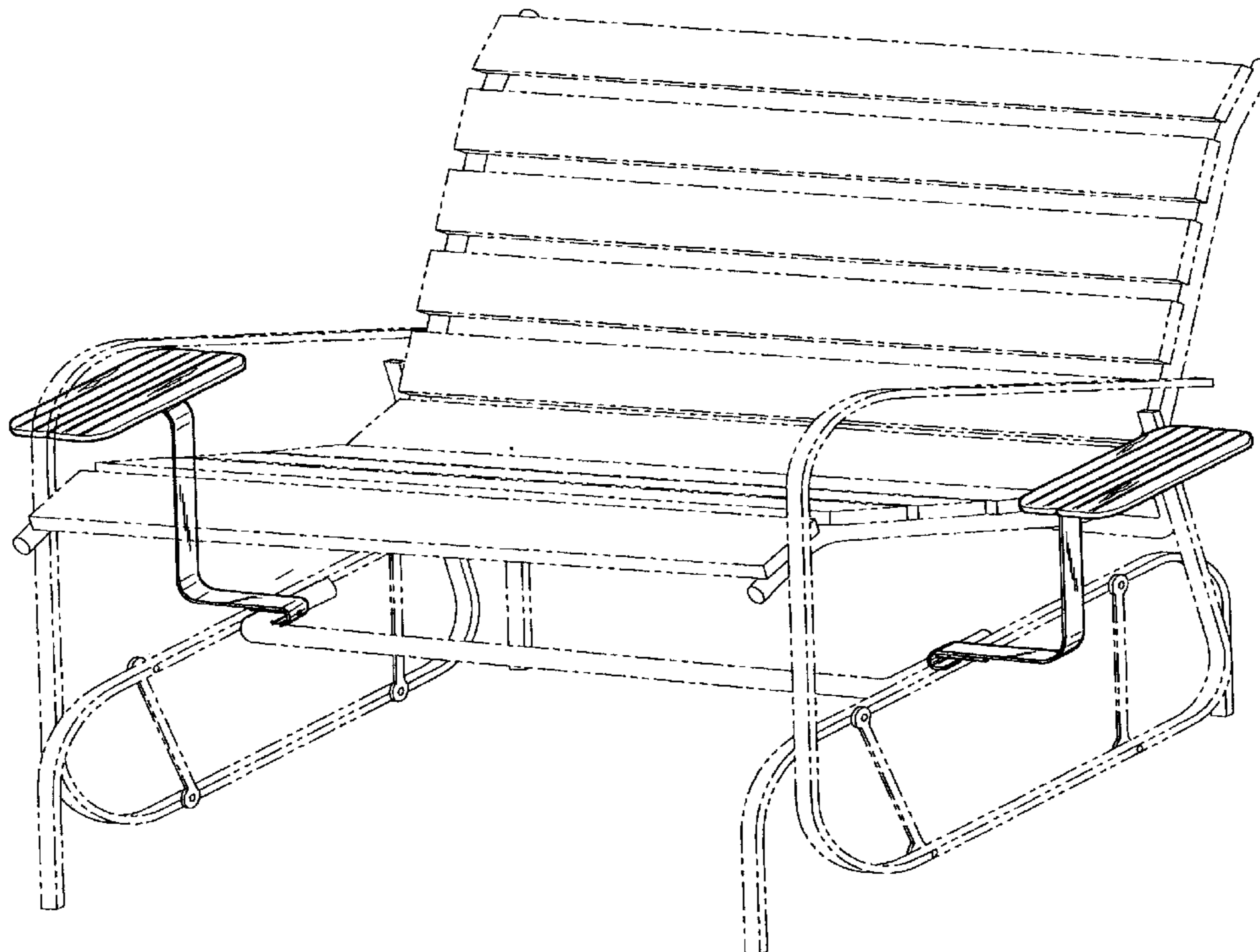
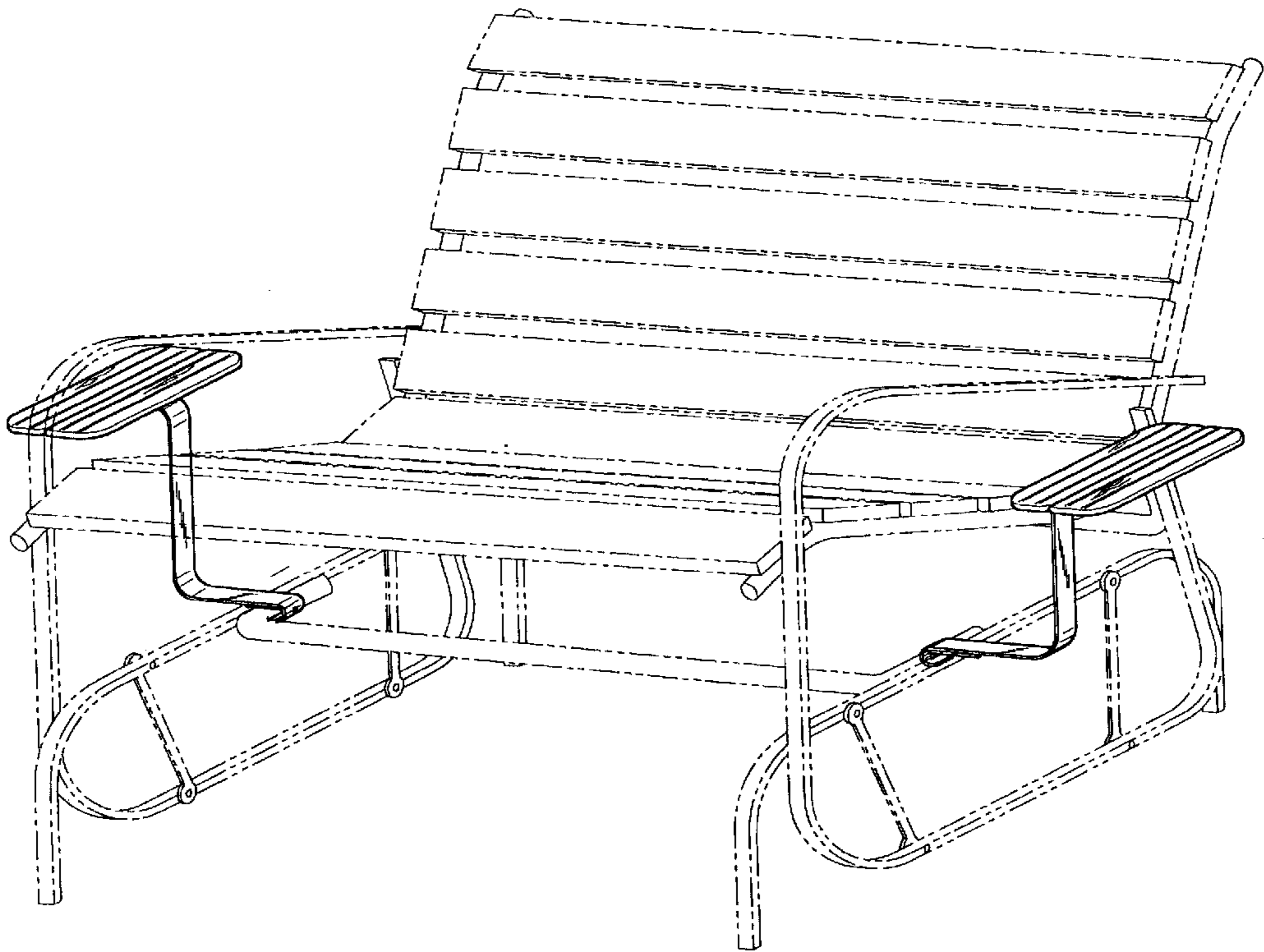

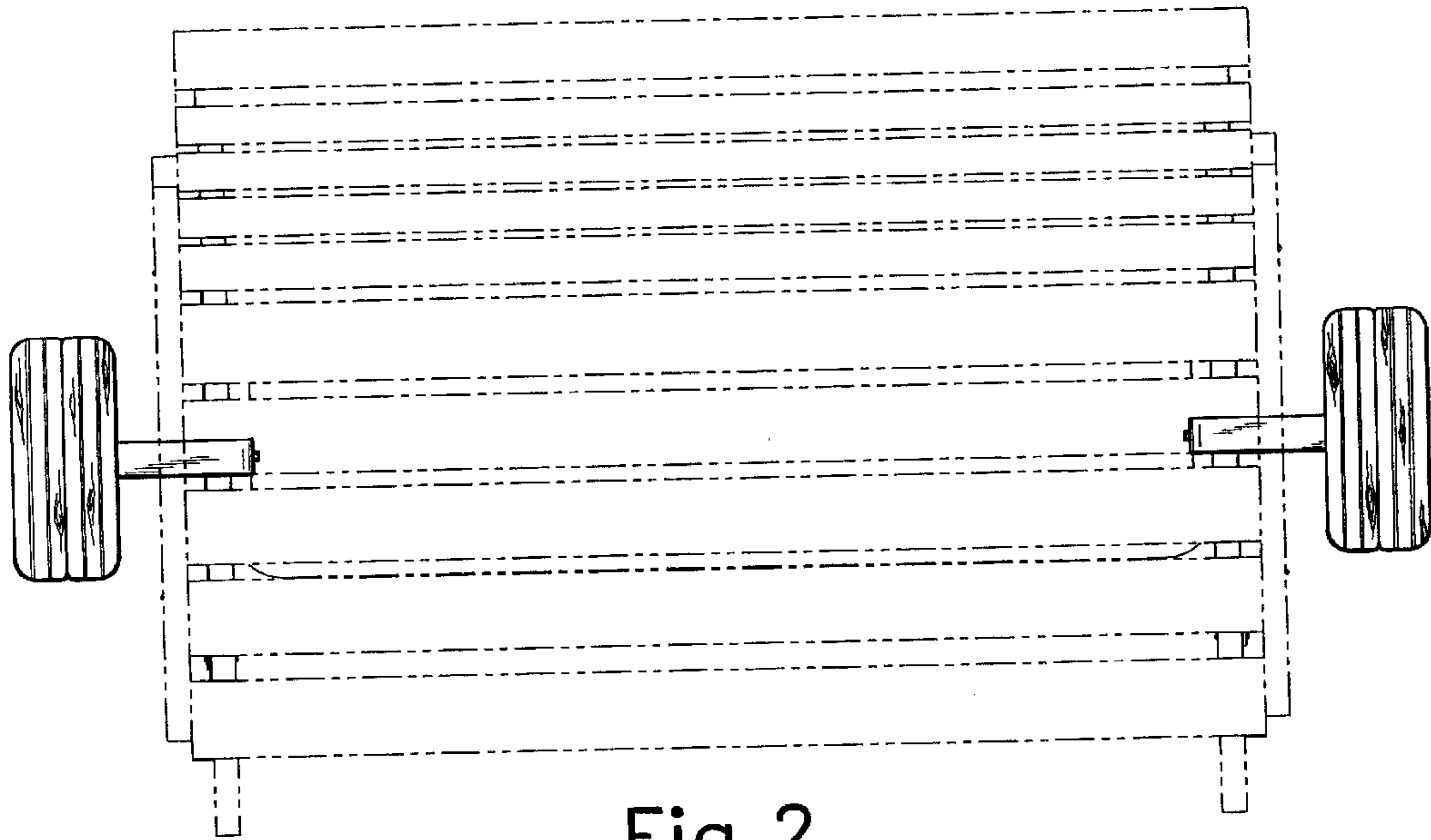

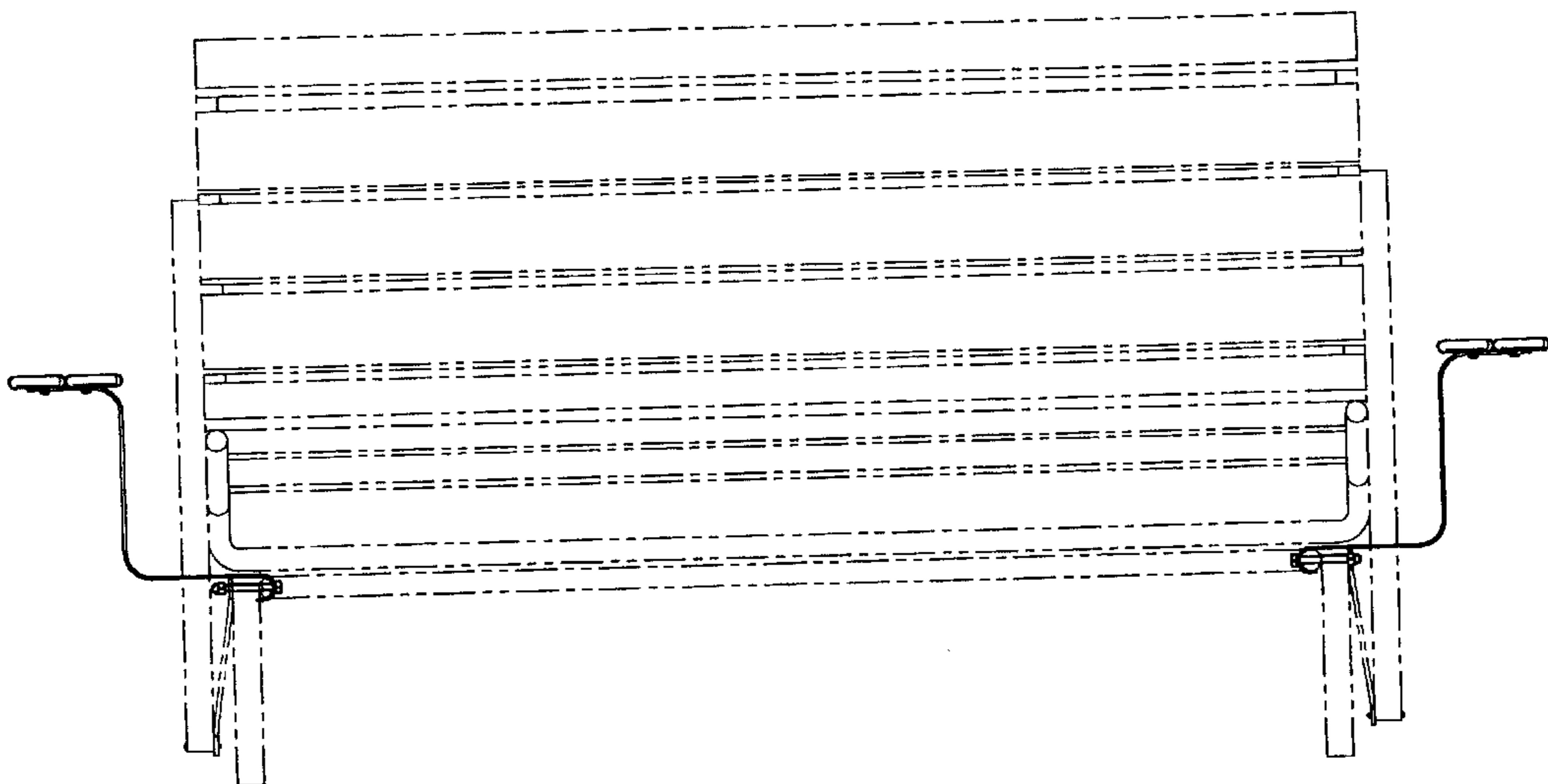

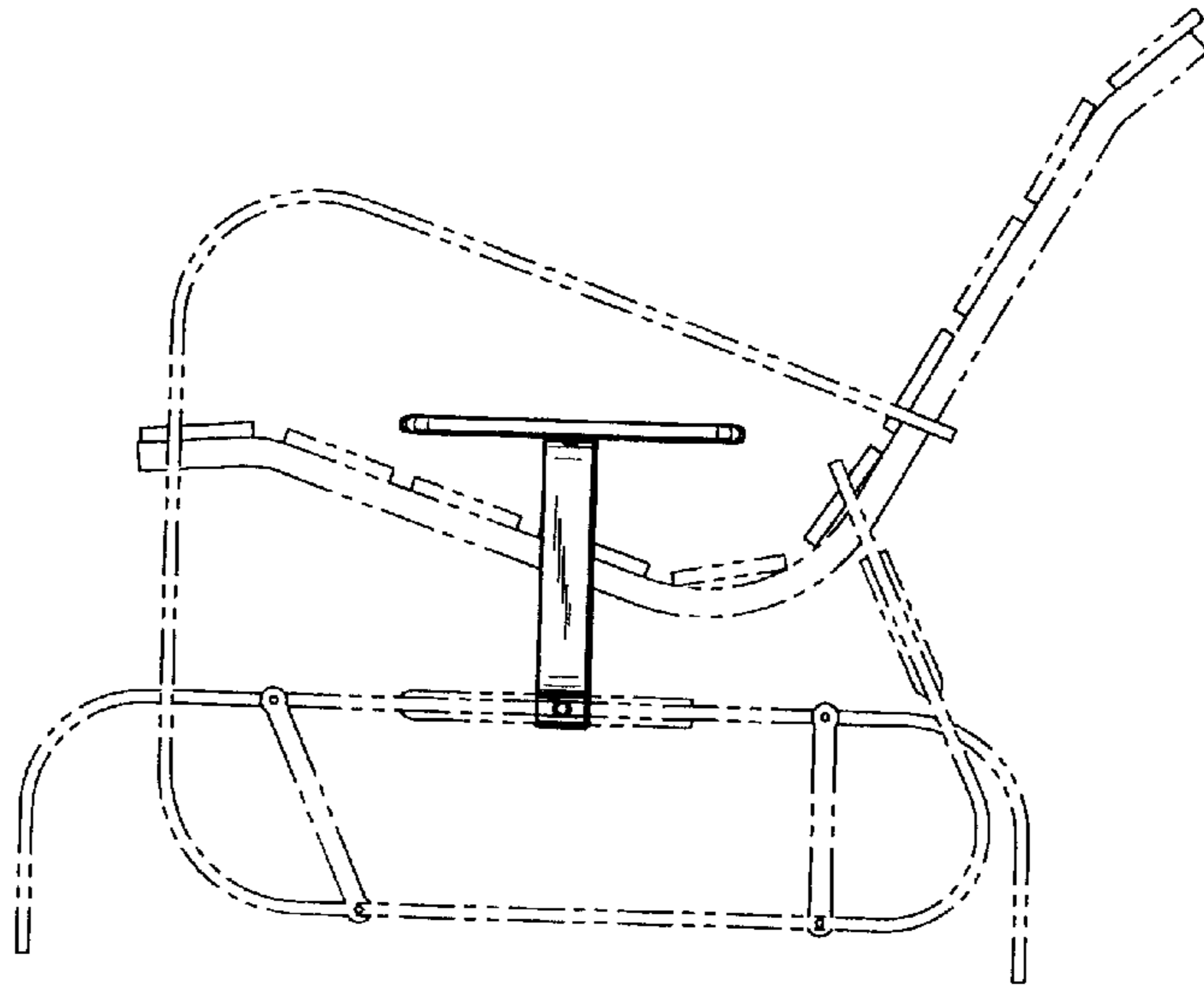

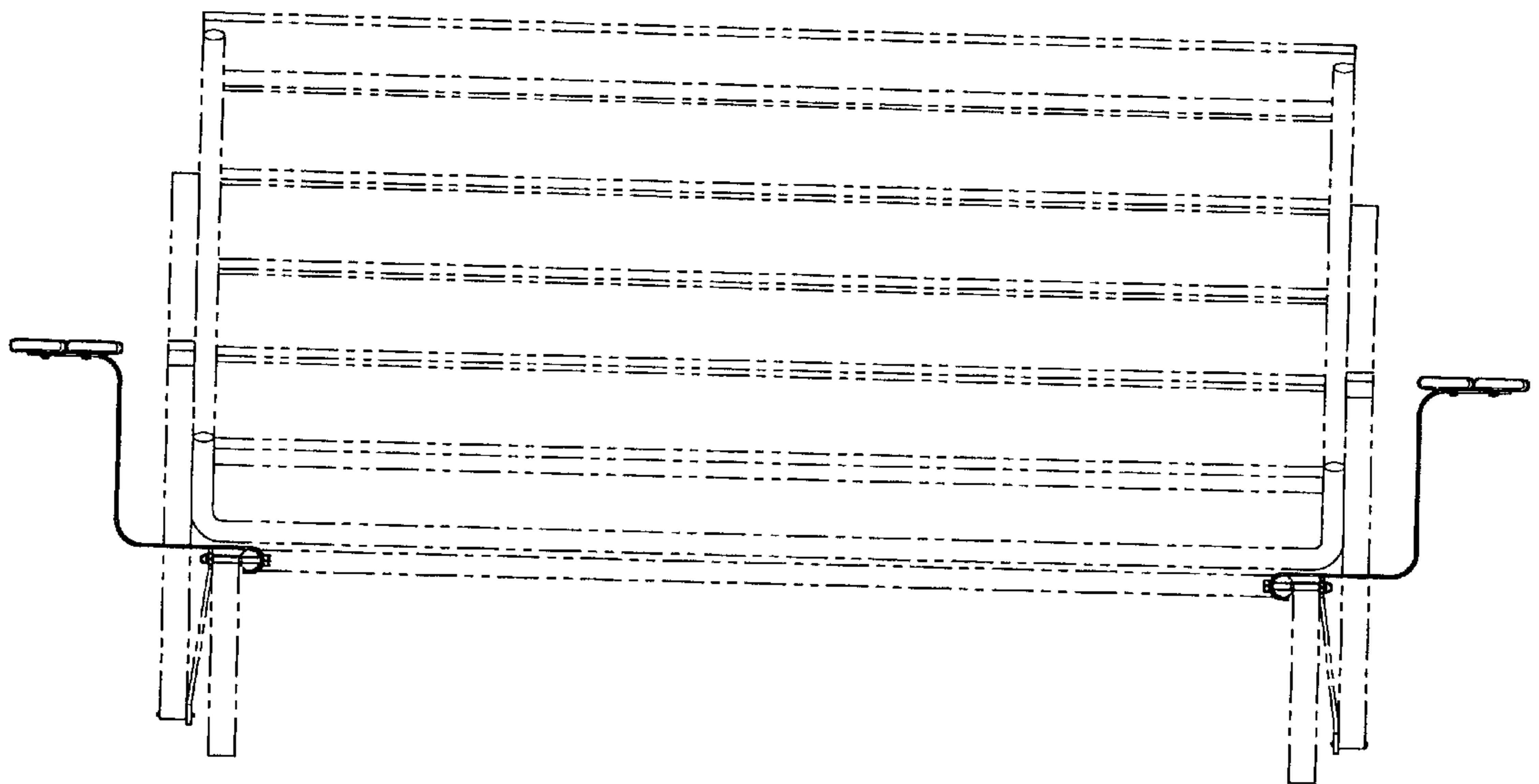

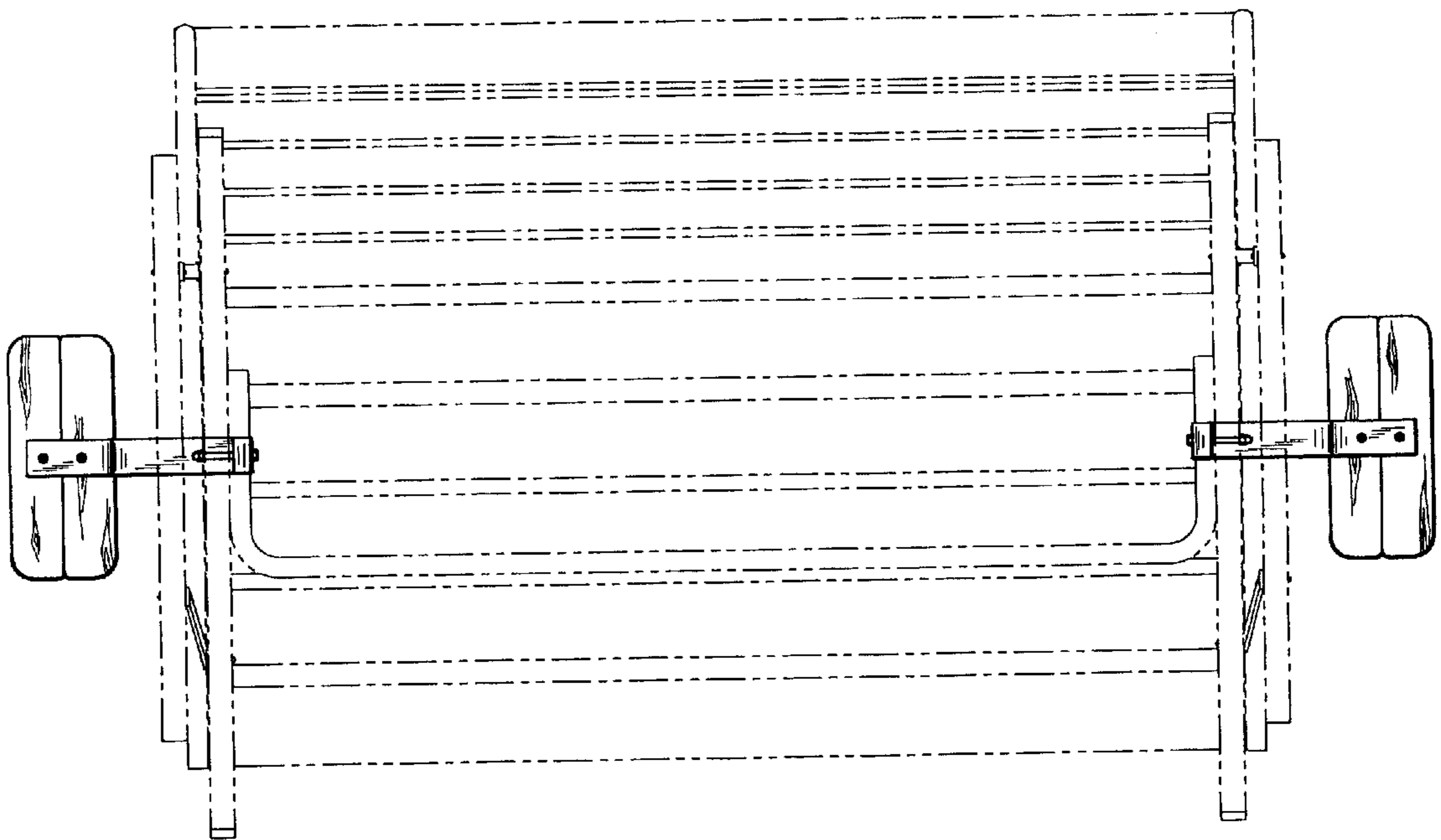
