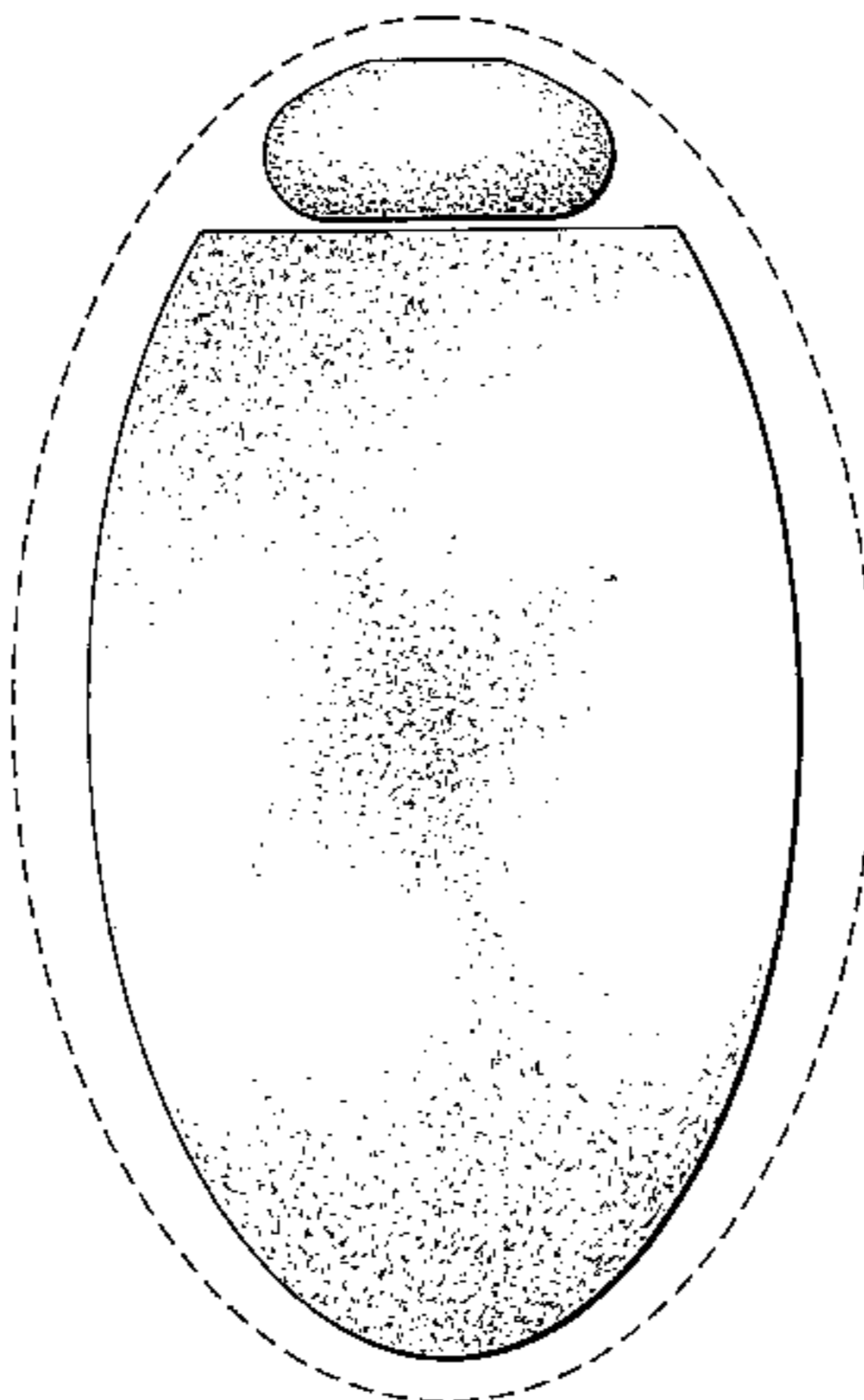
[57] **CLAIM**

The ornamental design for a towel with pillow, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a towel with pillow showing my design;
FIG. 2 is a left side view thereof and the right side being a mirror image thereof; and,
FIG. 3 is a front side view thereof.

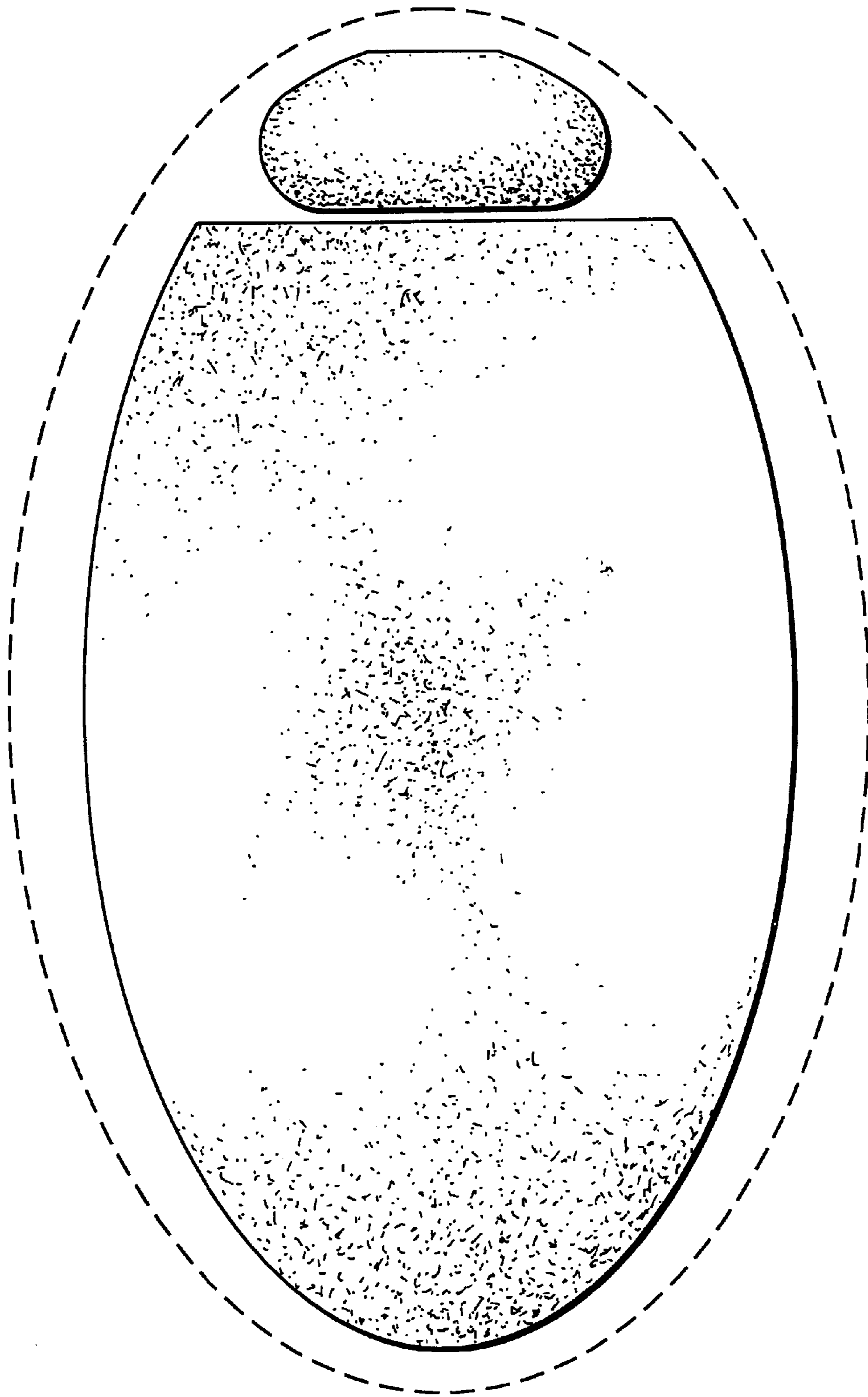

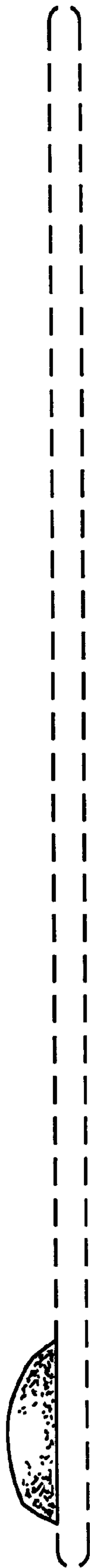
