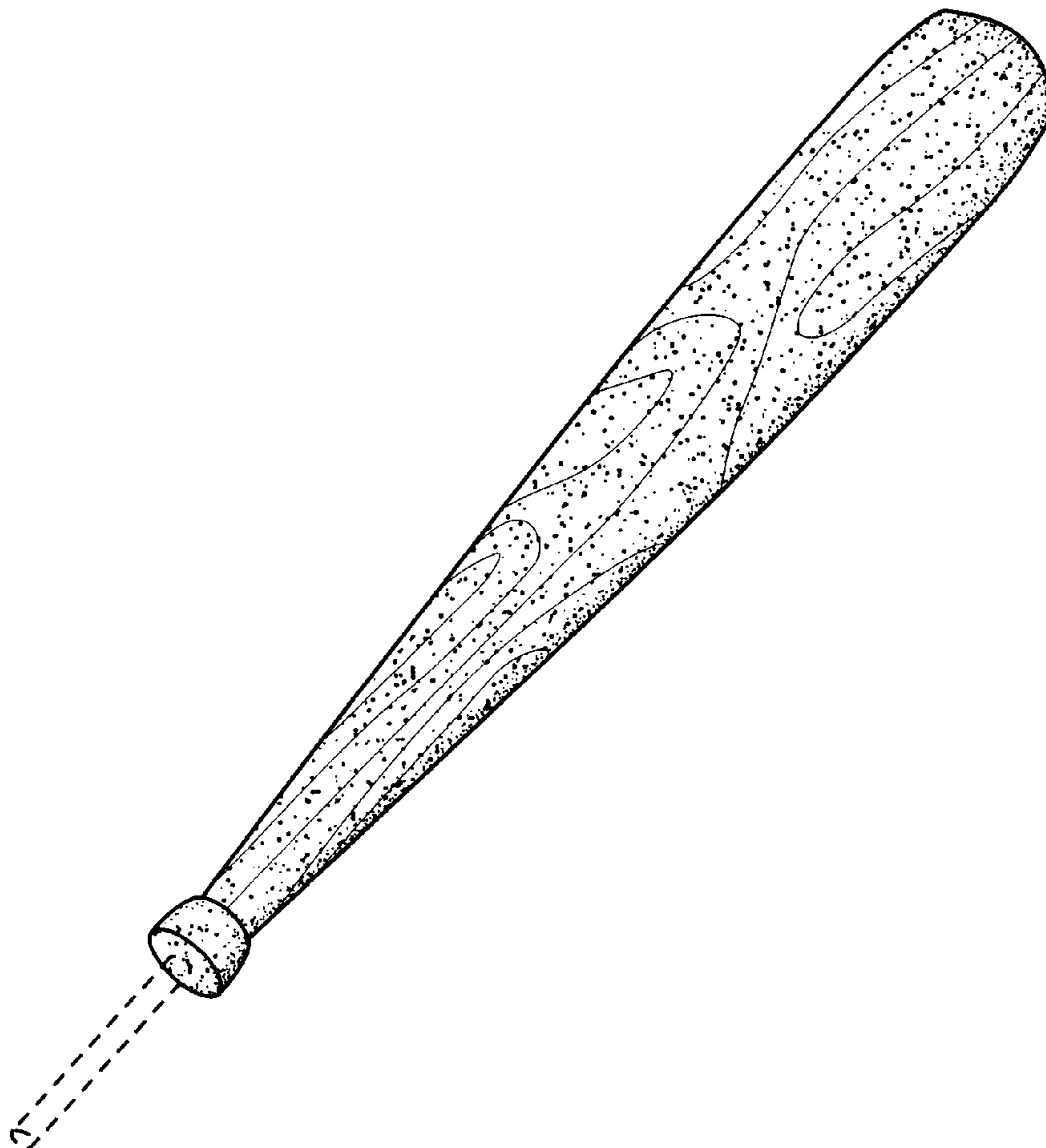
[57] **CLAIM**

The ornamental design for a handle for barbecue tools, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective illustration of a handle for barbecue tools showing my new design, the broken line showing of a fragmented tool is for illustrative purposes only and forms no part of the claimed design;  
FIG. 2 is a front elevational view thereof, the undisclosed sides being identical; the broken line showing of the barbecue tool is for illustrative purposes only and forms no part of the claimed design;  
FIG. 3 is a rear elevational view thereof, the broken line showing of a barbecue tool is for illustrative purposes only and forms no part of the claimed design;  
FIG. 4 is a top plan view of FIG. 1;  
FIG. 5 is a bottom plan view of FIG. 1;  
FIG. 6 is a front elevational view thereof, the broken line showing of the barbecue tool is for illustrative purposes only and forms no part of the claimed design, the undisclosed left side of the tongs is identical to the side disclosed;  
FIG. 7 is a perspective illustration of a second embodiment of a handle for barbecue tools as disclosed in FIG. 1, the undisclosed sides being identical; the broken line showing of a fragmented tool is for illustrative purposes only and forms no part of the claimed design;  
FIG. 8 is a top plan view of FIG. 8; and,  
FIG. 9 is a bottom plan view of FIG. 9.

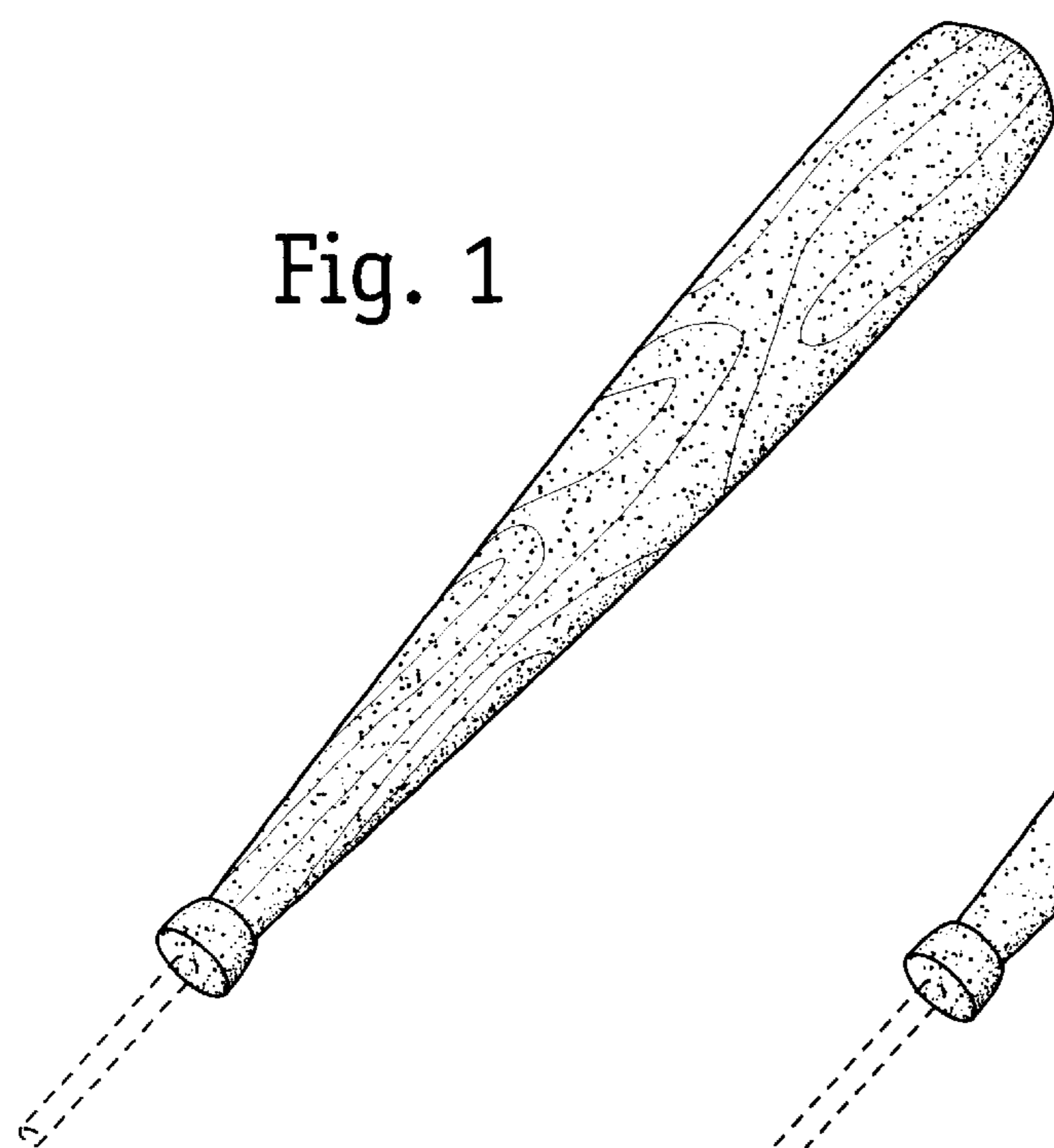

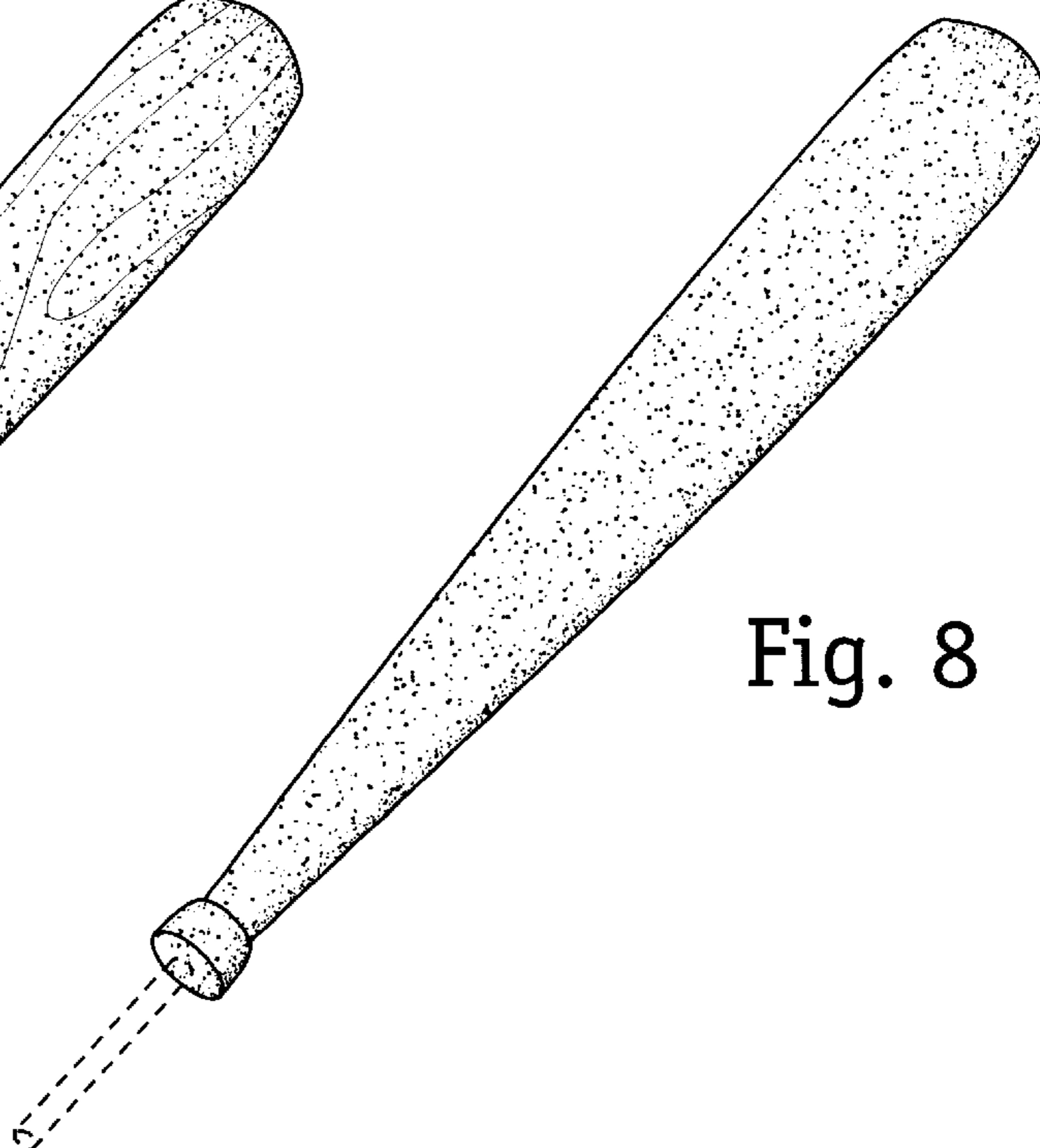

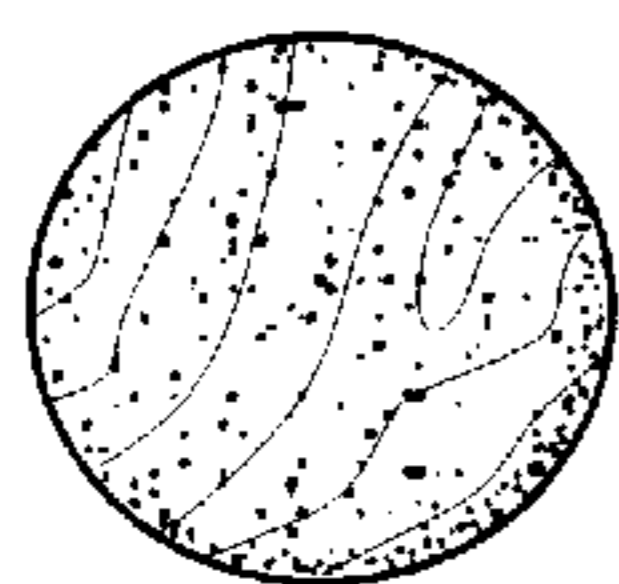

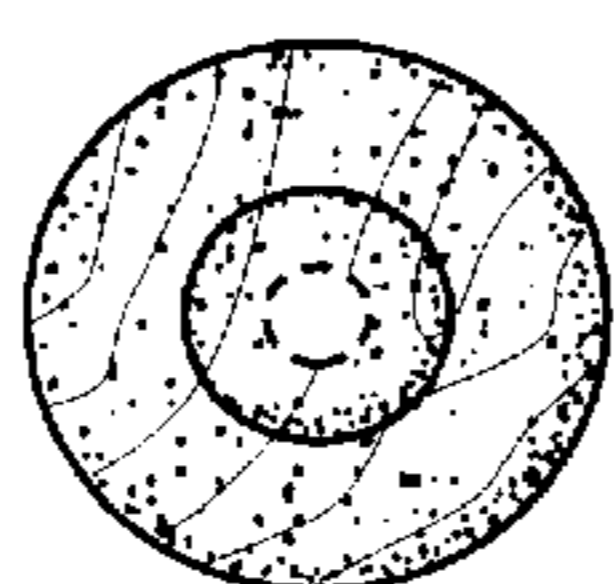

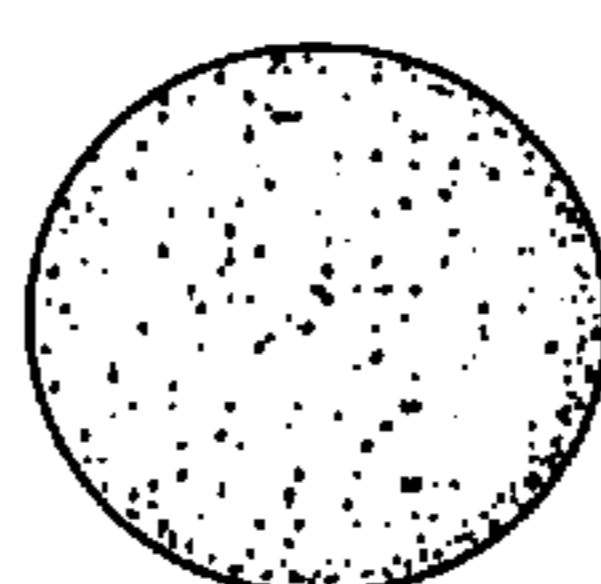

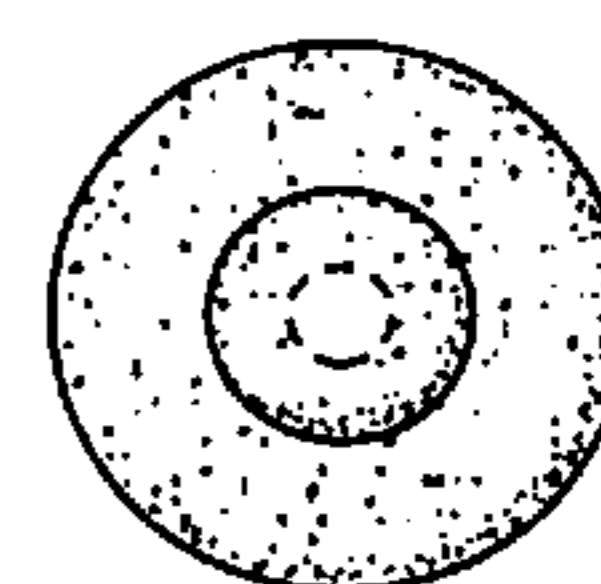

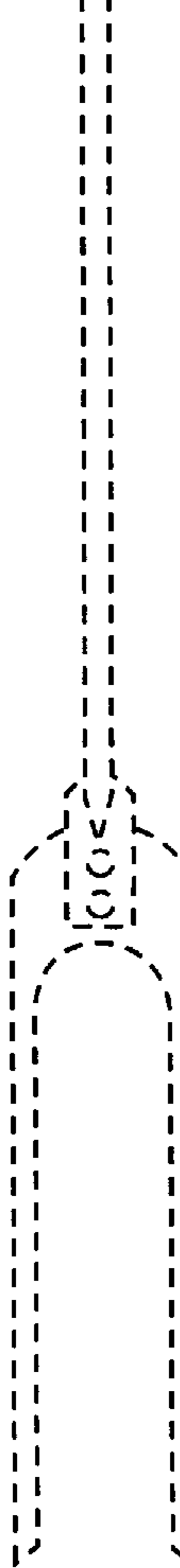
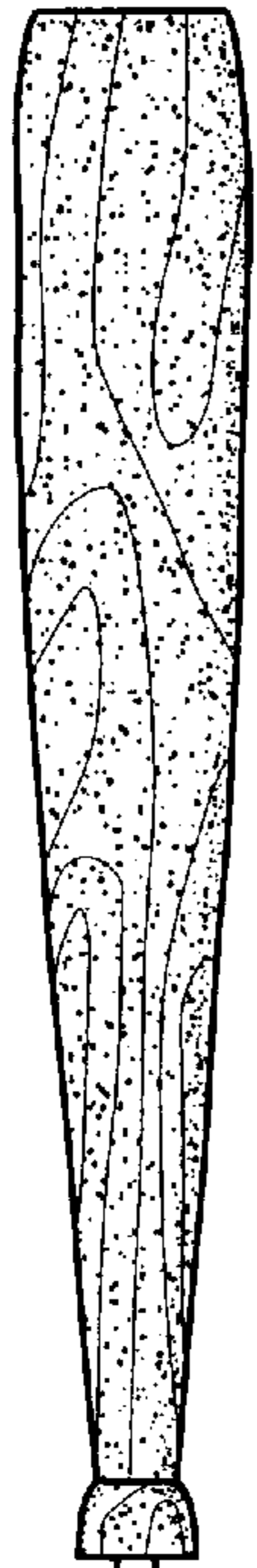

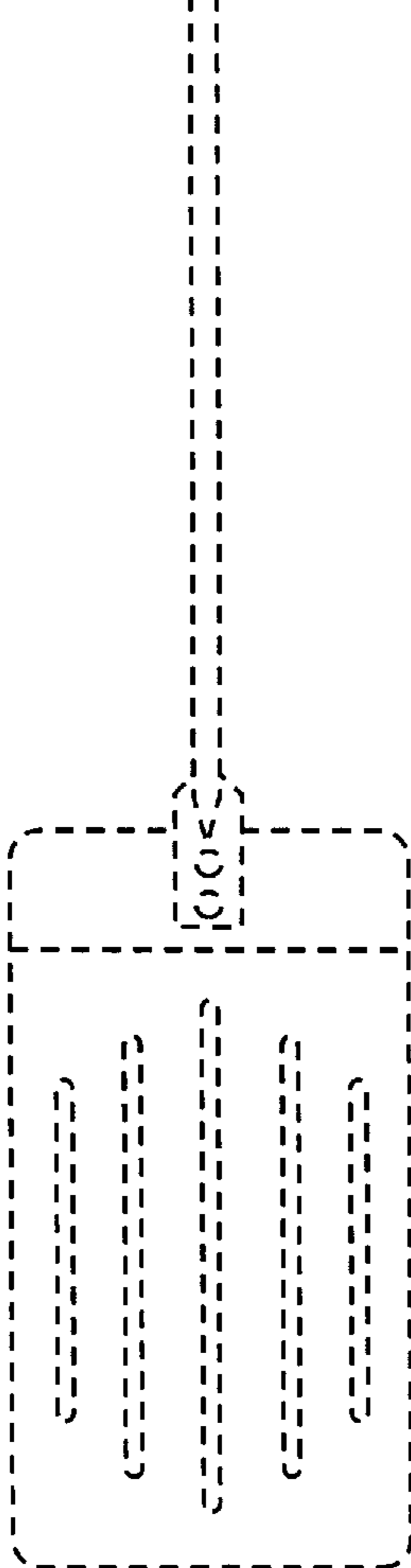
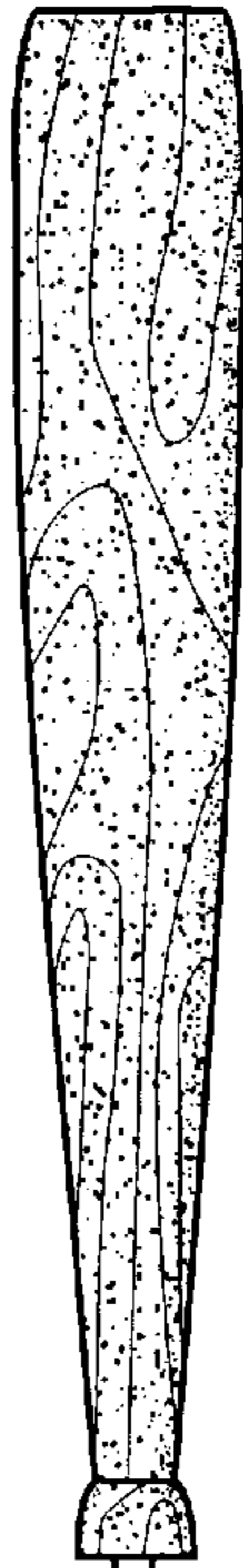
