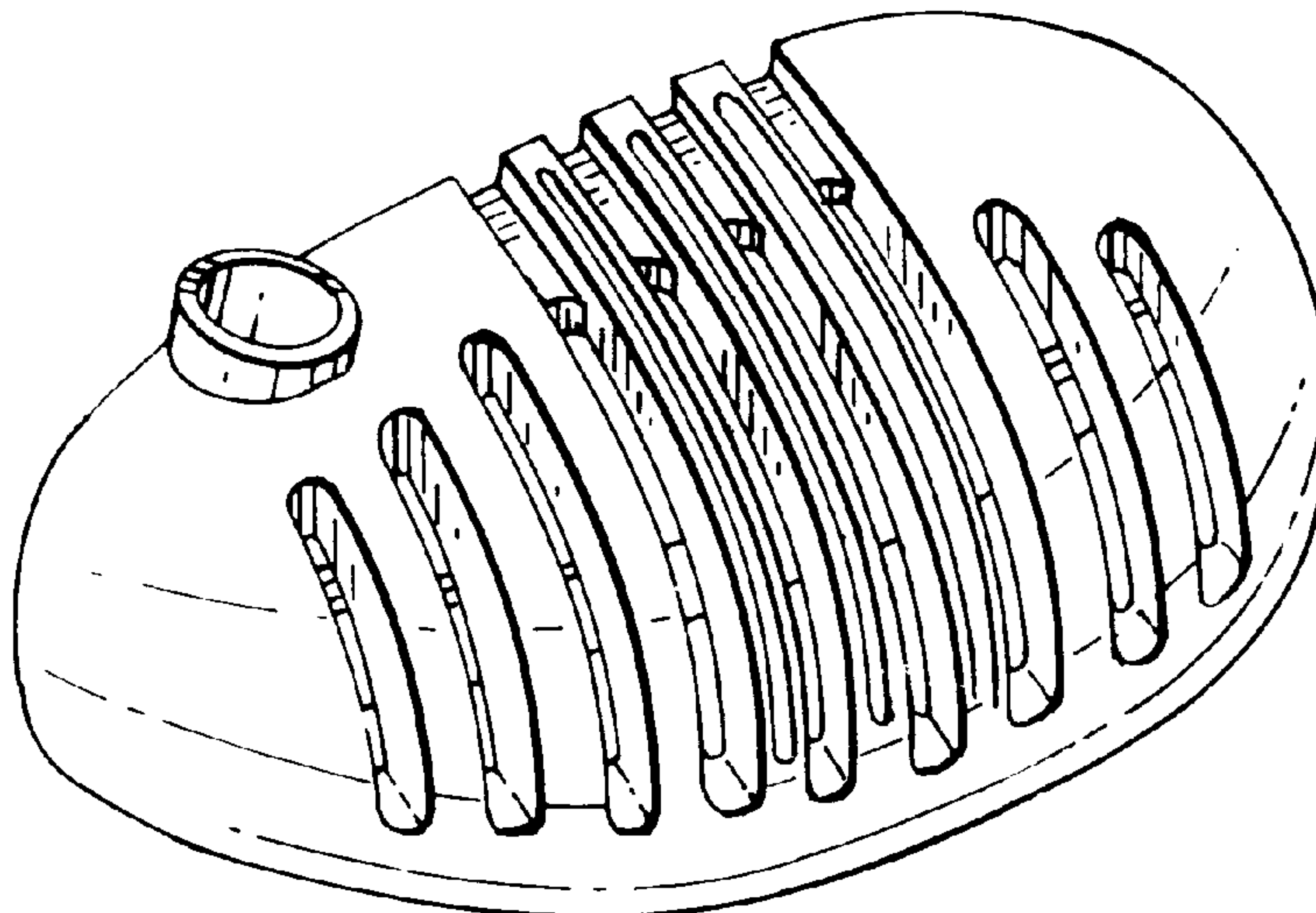
[57] **CLAIM**

The ornamental design for a golf putter head, as shown and described.

DESCRIPTION

FIG. 1 is a heel end rear perspective view of a golf putter head, showing our new design;
FIG. 2 is a heel end front perspective view thereof;
FIG. 3 is a top plan view thereof, showing the upper surface of the golf putter head;
FIG. 4 is a front elevational view thereof, showing the strike face surface of the golf putter head;
FIG. 5 is a bottom plan view thereof, showing the sole surface of the golf putter head;
FIG. 6 is a rear elevation view thereof, showing the rear side surface of the golf putter head;
FIG. 7 is a heel end elevation view thereof; and,
FIG. 8 is a toe end elevation view thereof.

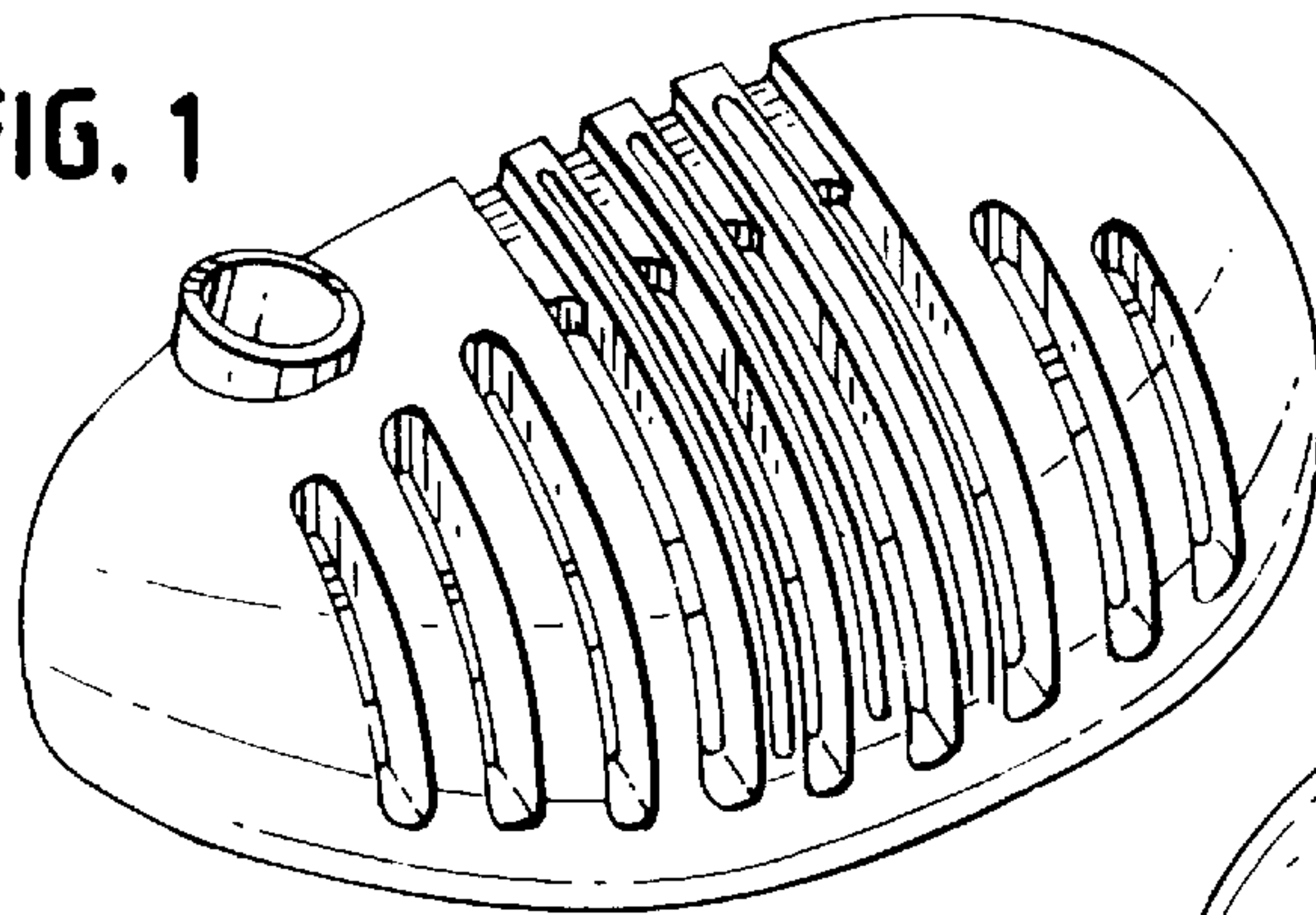

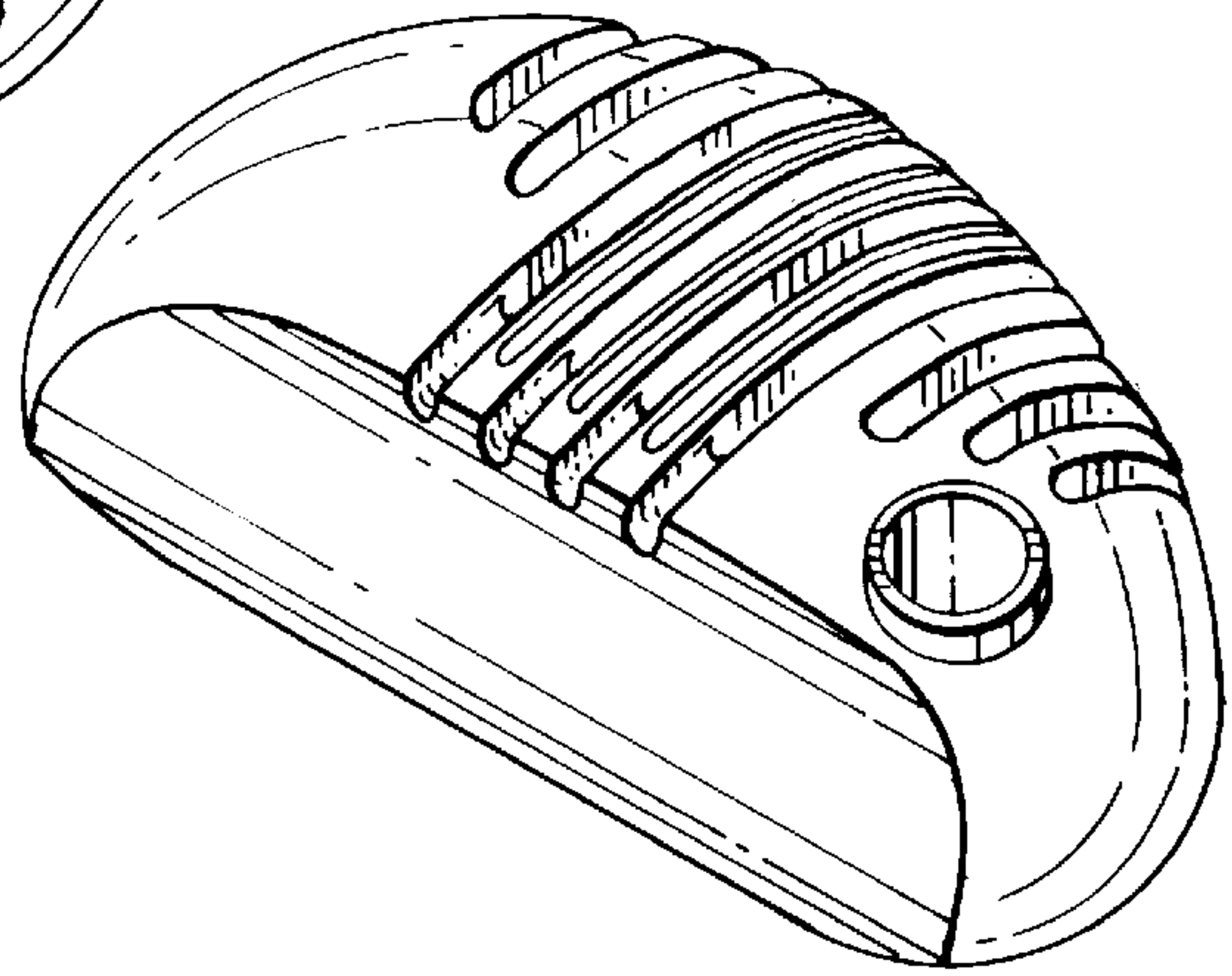

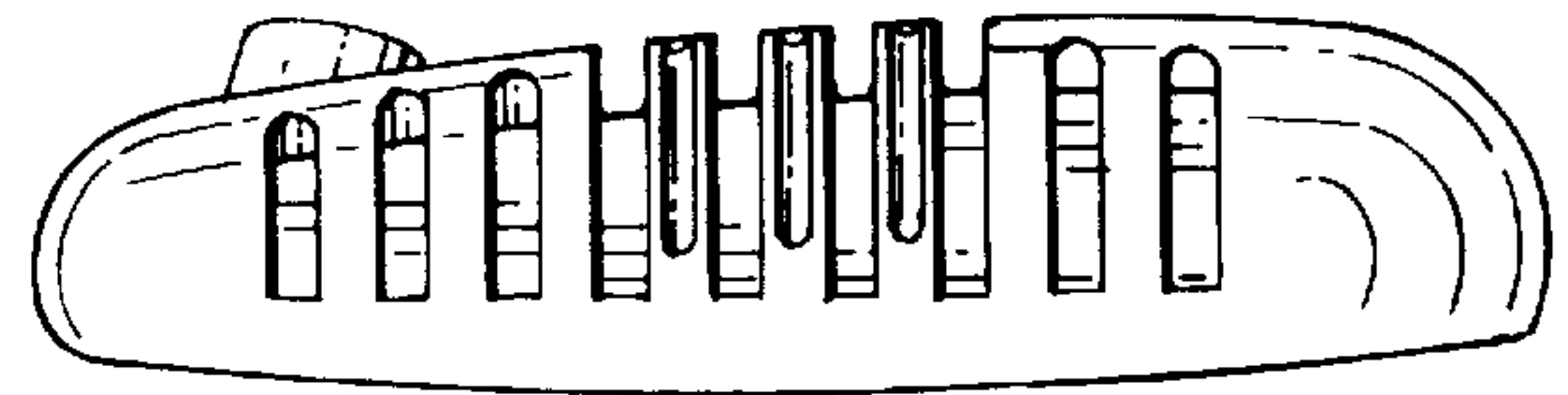
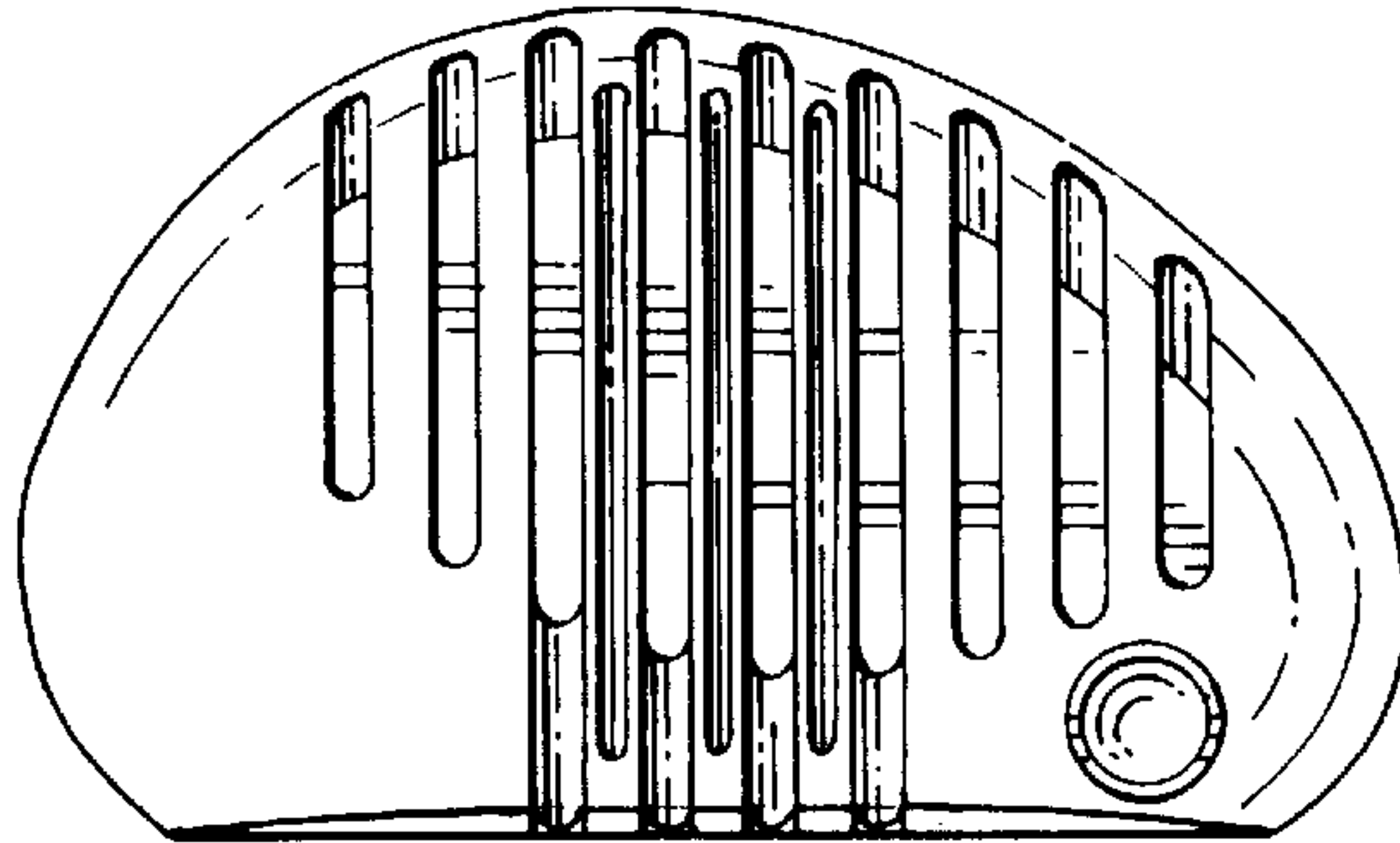

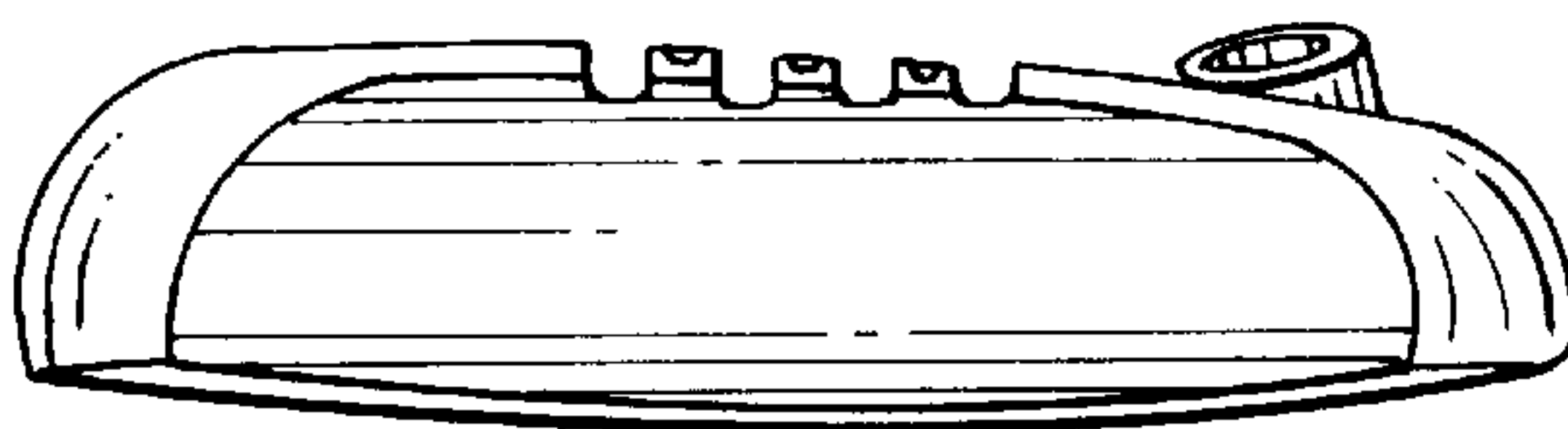

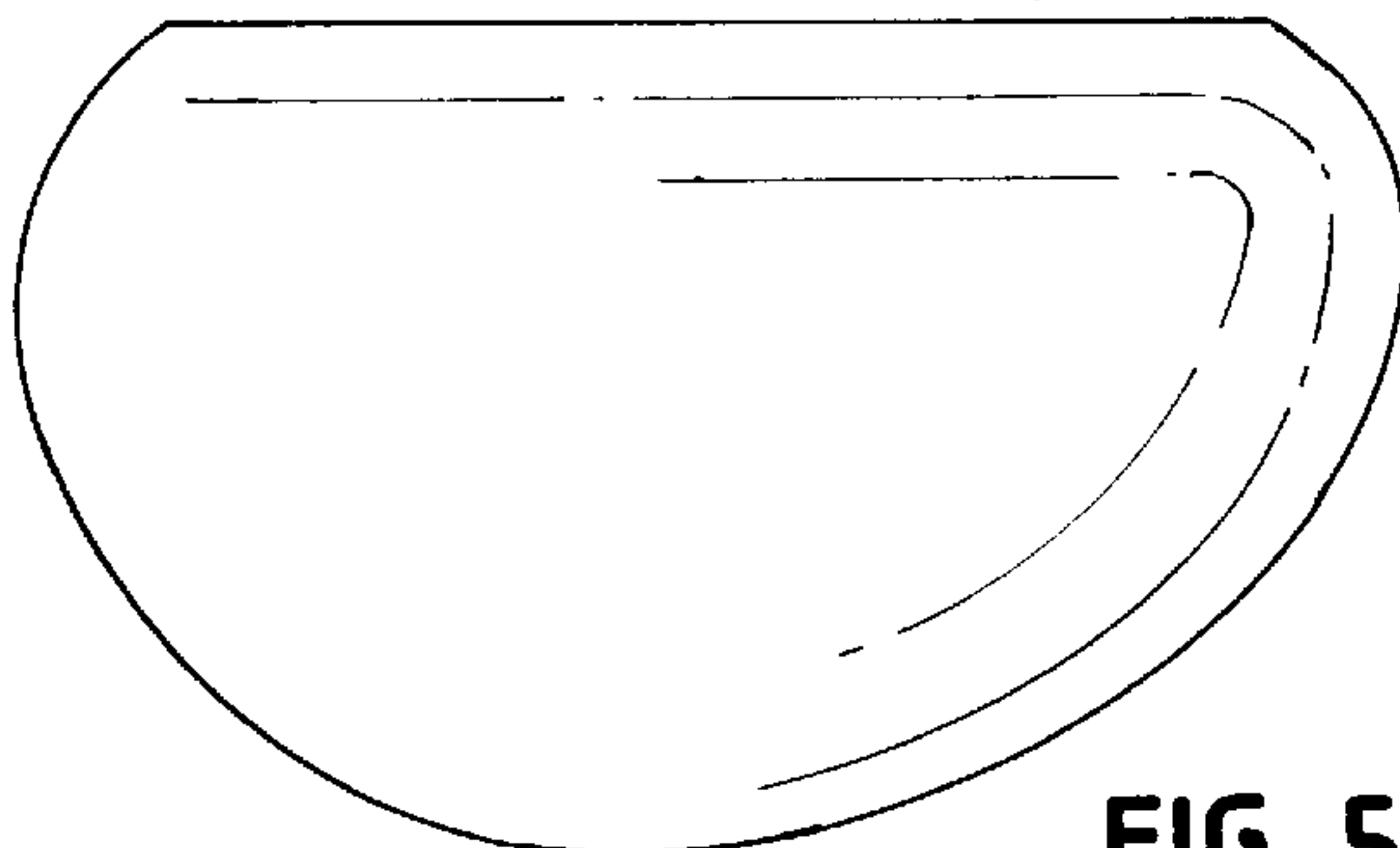
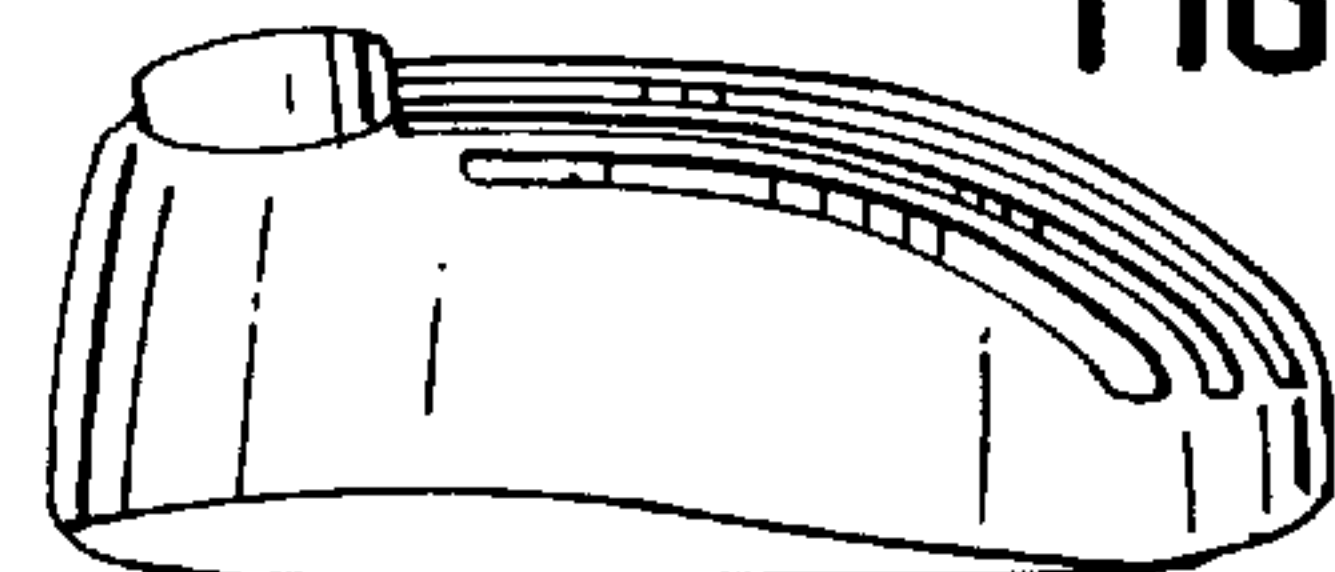

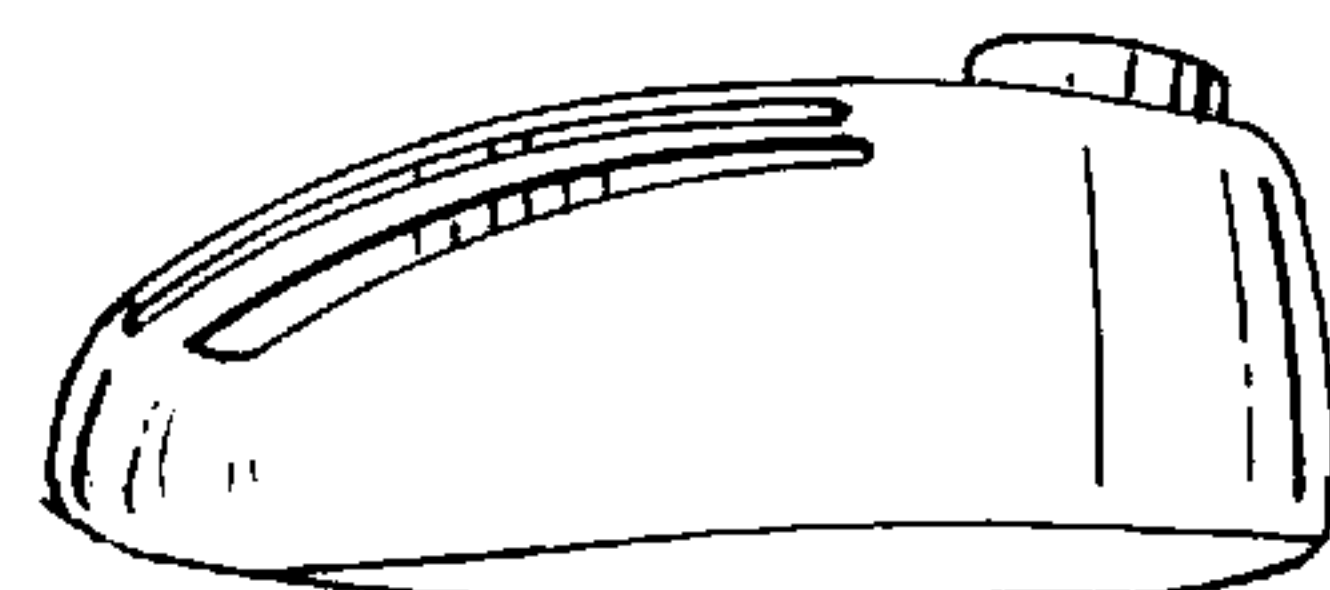
