[57] **CLAIM**

The ornamental design for a cover for chemotherapy solution bag or an intravenous solution or transfusion bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a the cover for a chemotherapy solution bag showing a first embodiment of my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right end elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left end elevational view thereof;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of the cover for an intravenous solution or transfusion bag showing a second embodiment of my new design;

FIG. 9 is a front elevational view thereof;

FIG. 10 is a right end elevational view thereof;

FIG. 11 is a rear elevational view thereof;

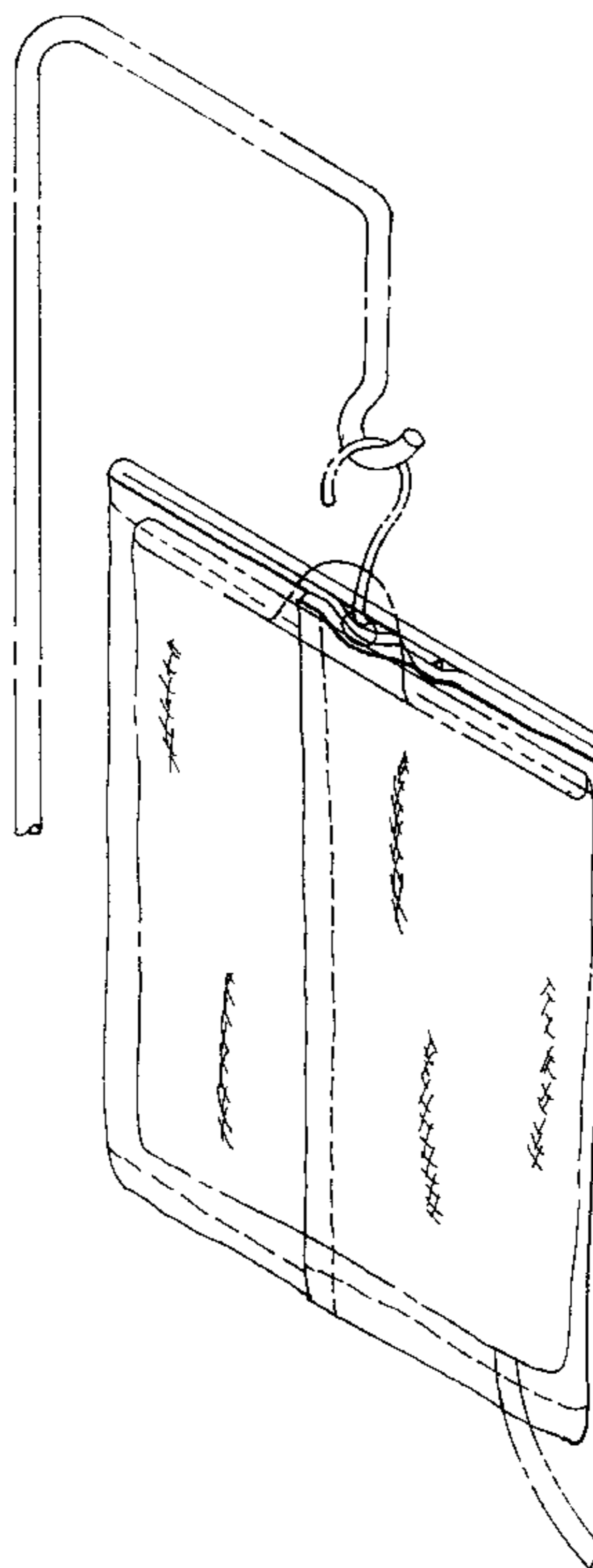
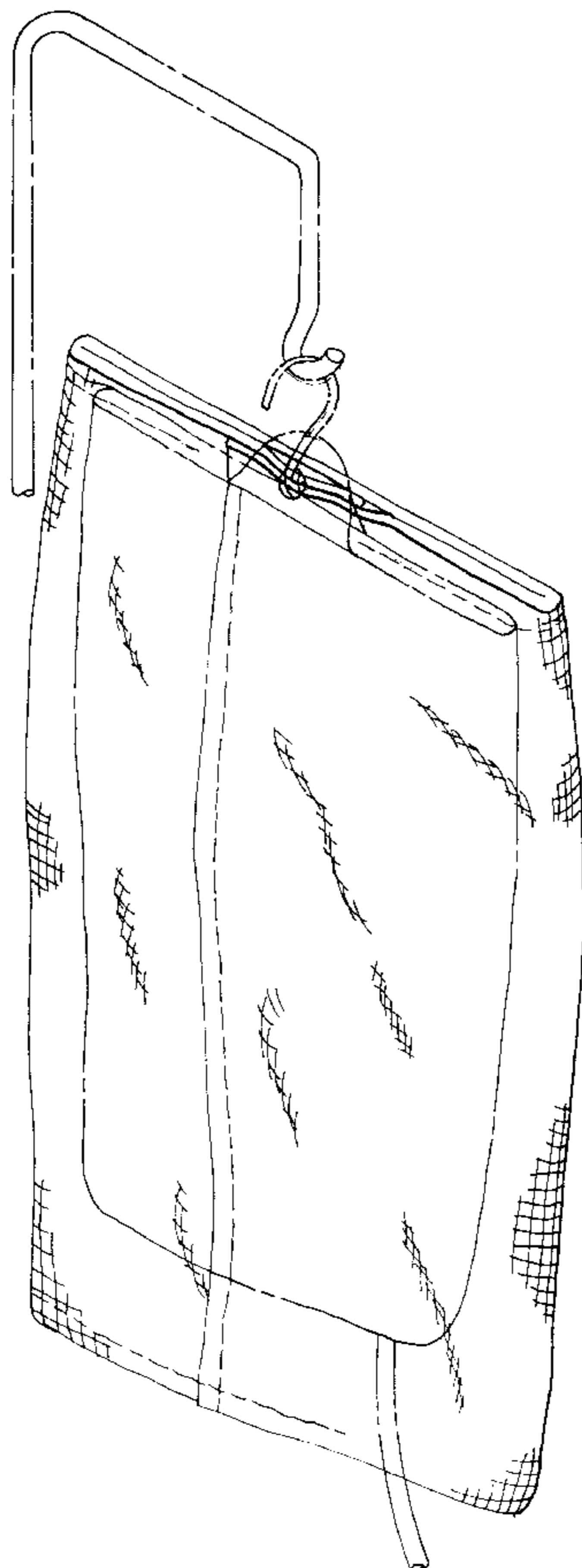
FIG. 12 is a left end elevational view thereof;

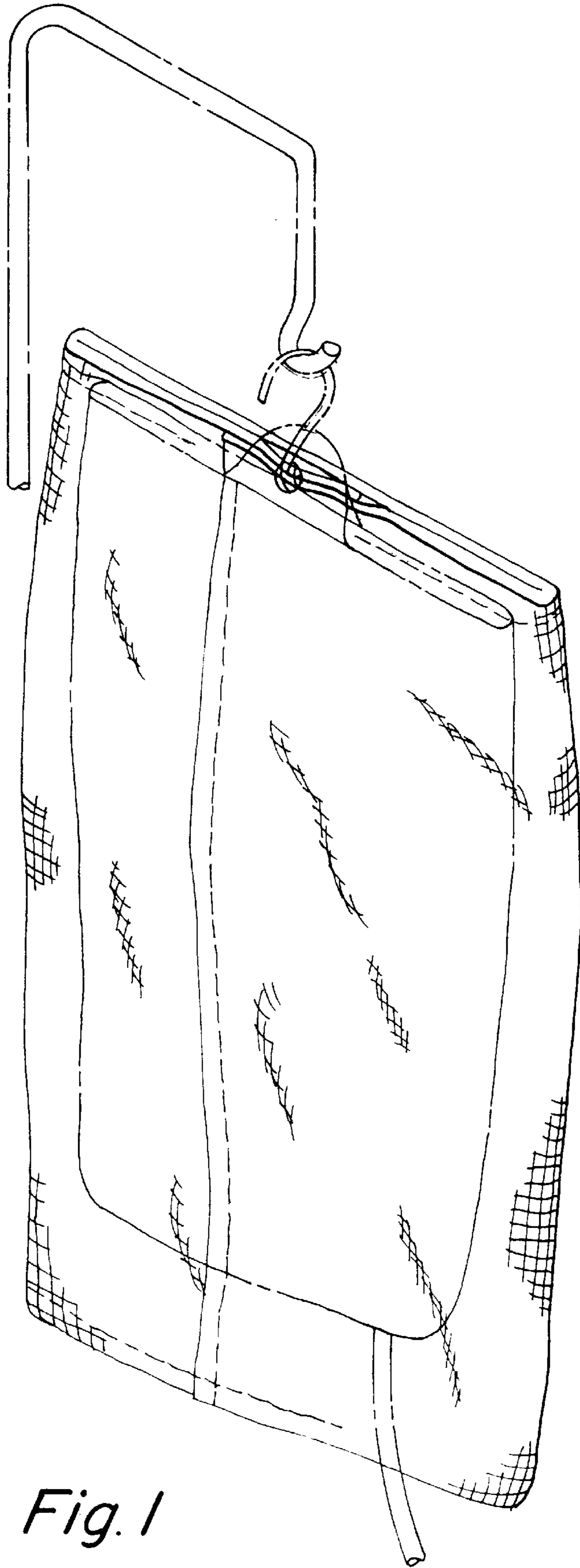

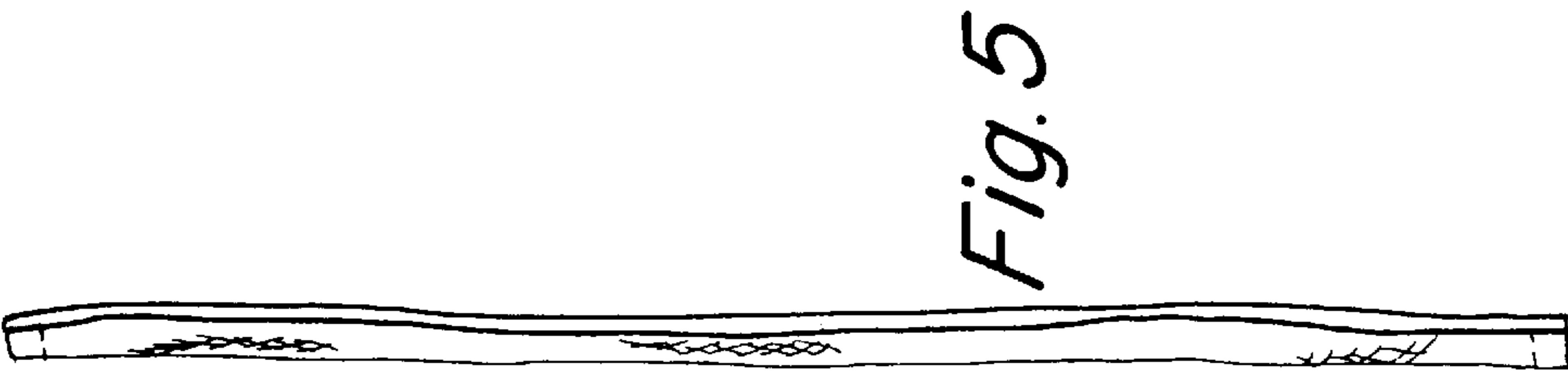

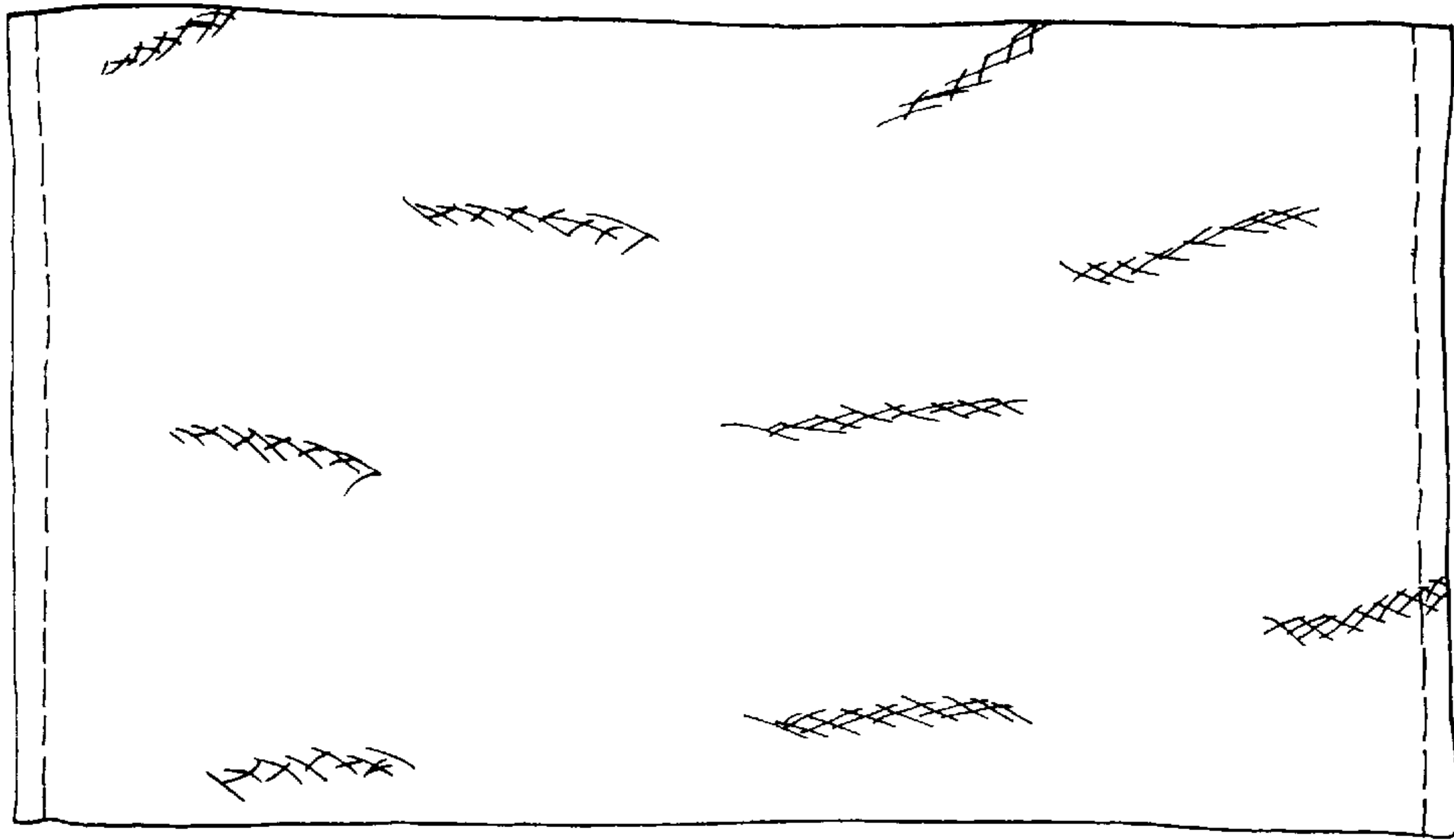

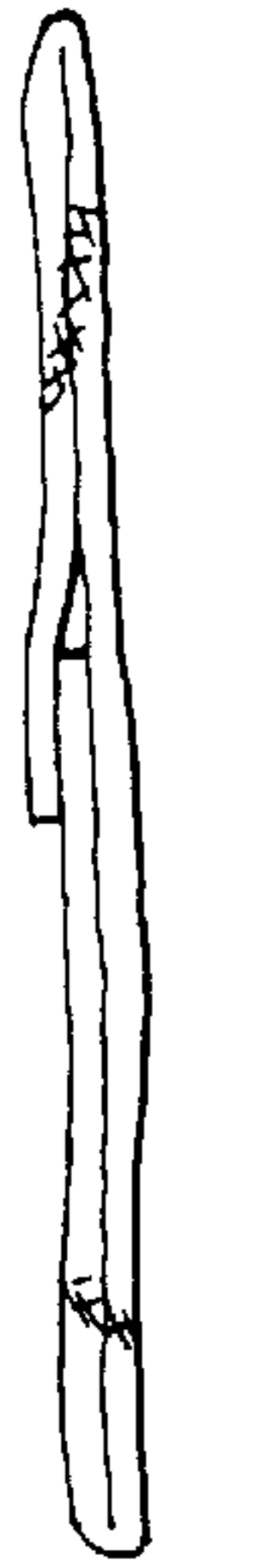

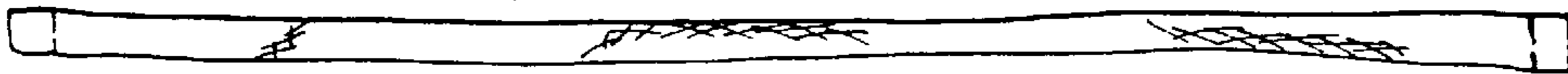

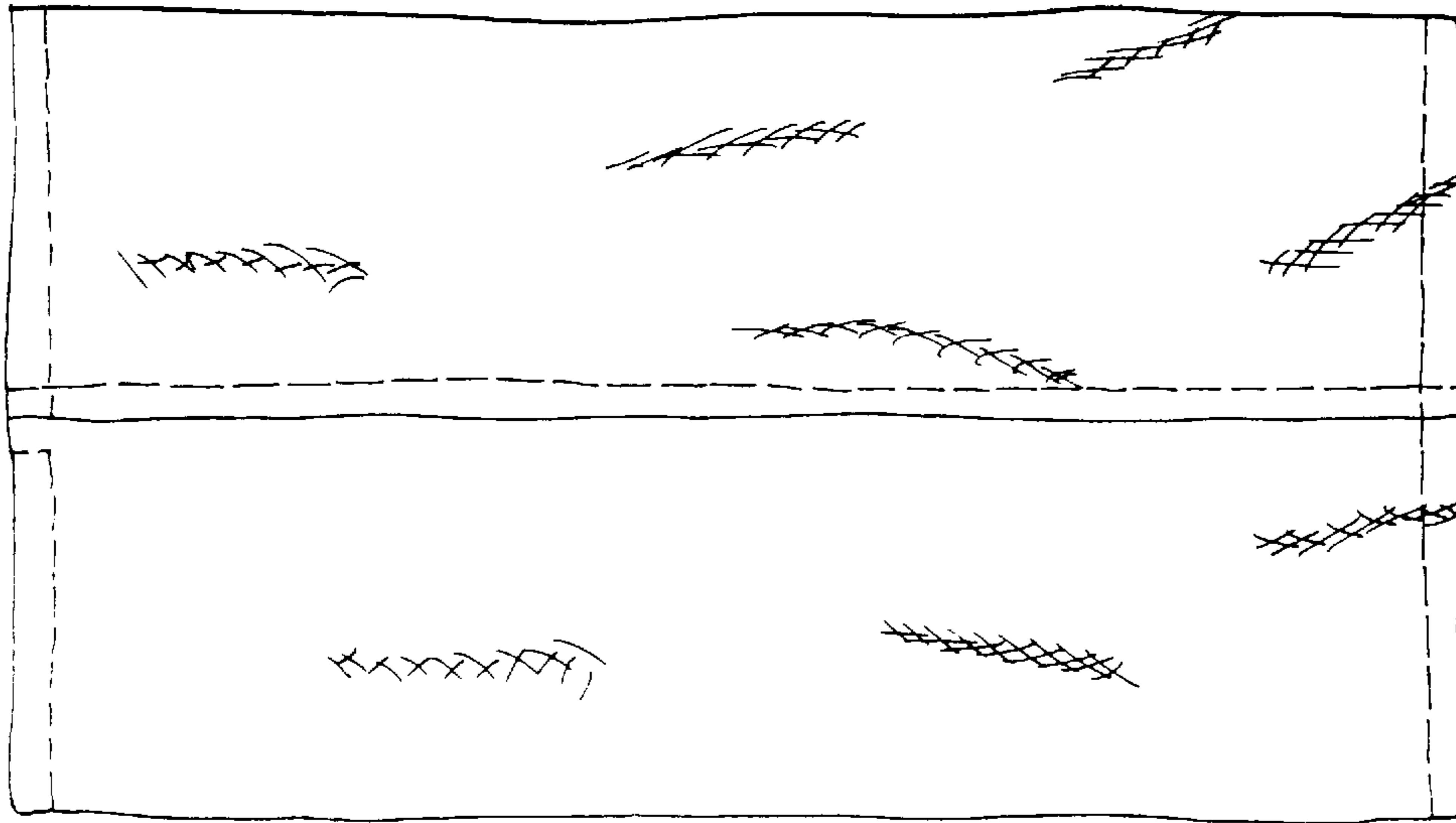

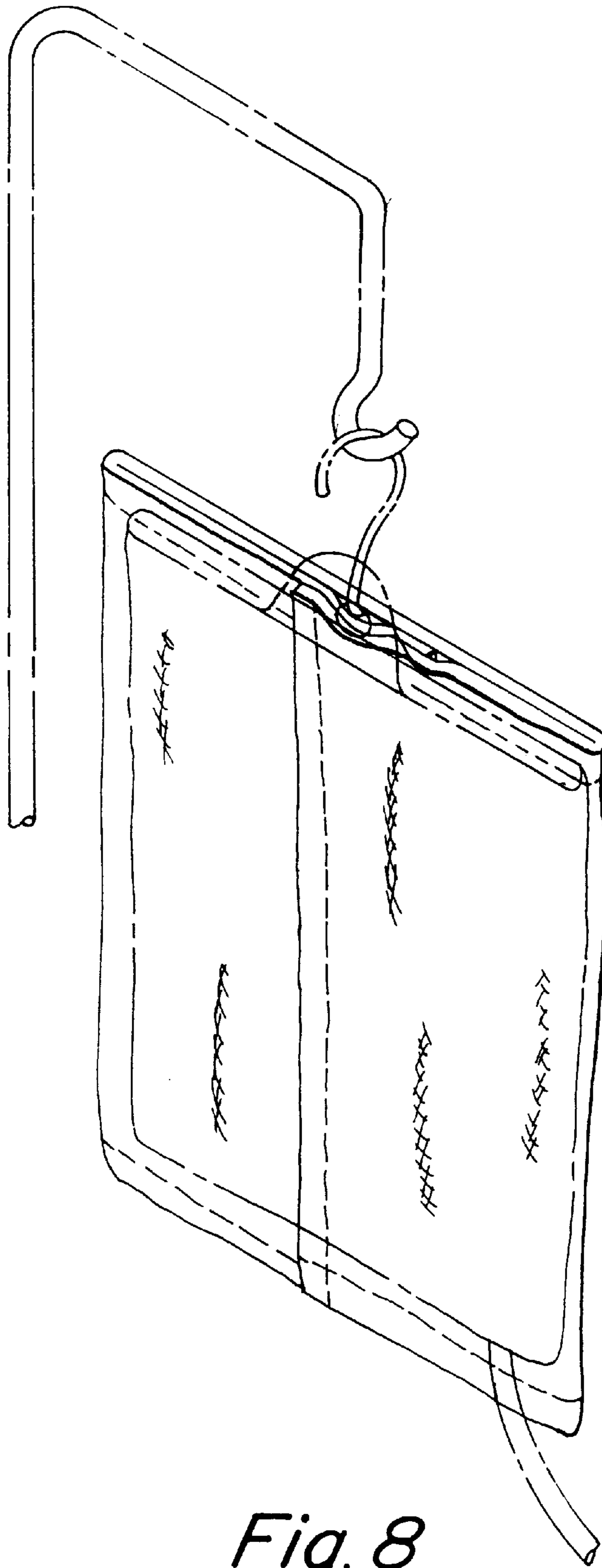

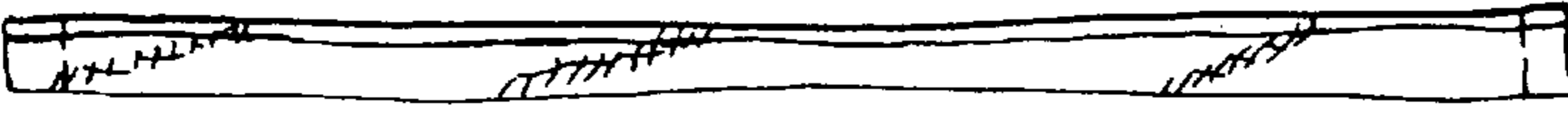

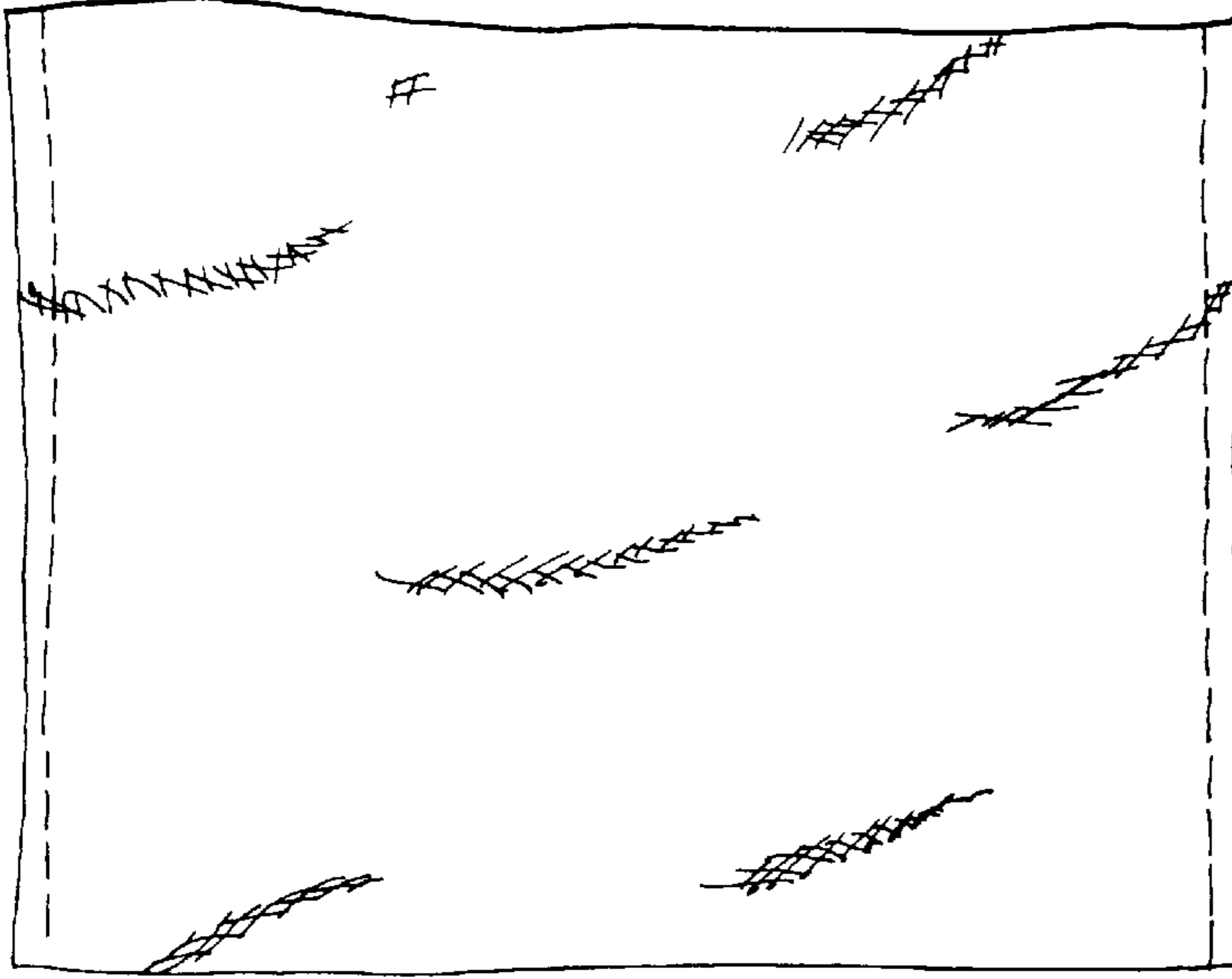

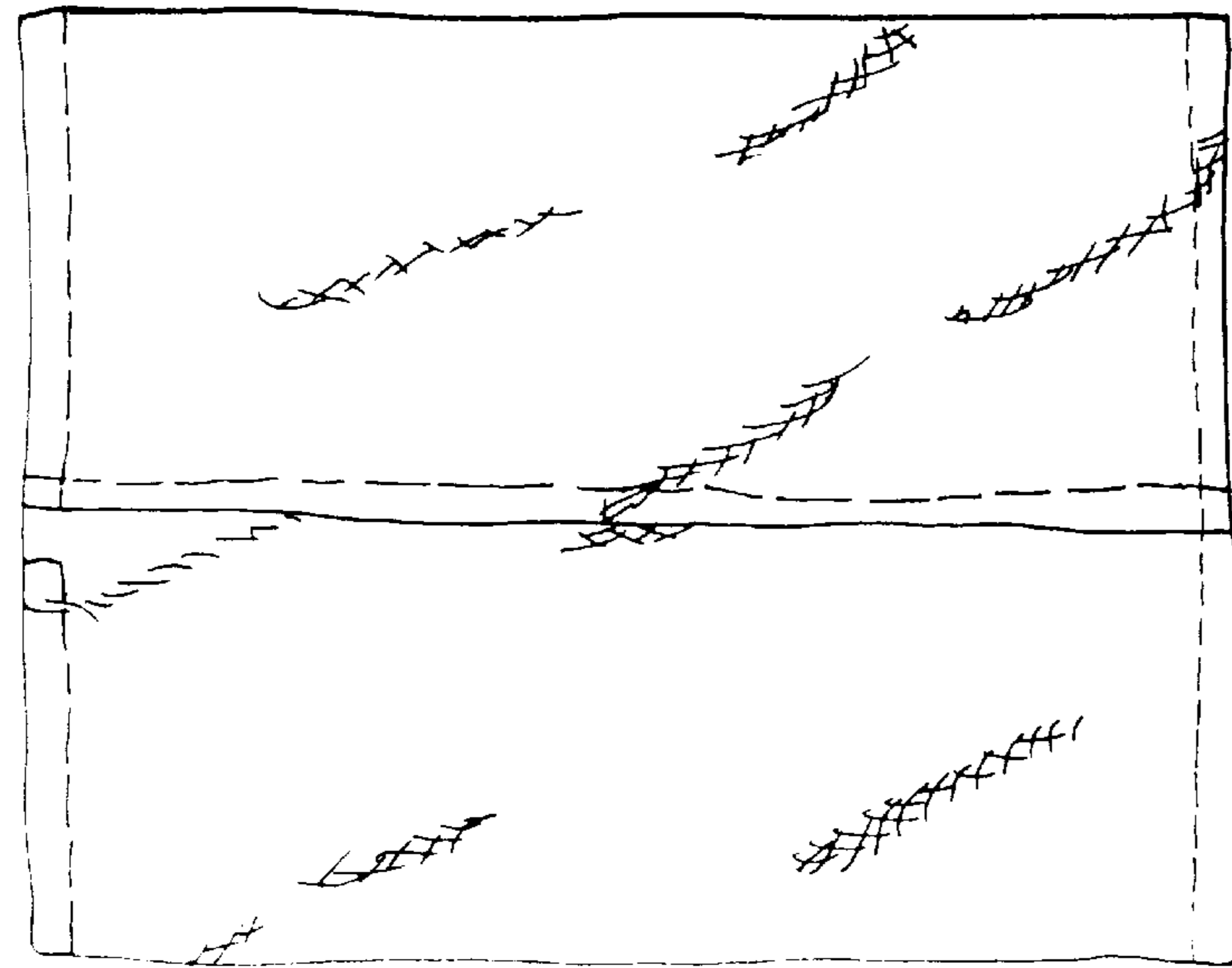
