FIG. 3 is a top perspective view of the product, showing two removable and adjustable magnet holders, the magnet holder on the right side of the product being depicted as being partially removed from the strap.

FIG. 4 is a top plan view of the product.

FIG. 10 is a top plan view of the product, with the magnet holders removed.

FIG. 11 is a side view of the product, with the magnet holders removed, shown with the top side up.

FIG. 12 is a side view of the product with the magnet holders removed, shown along the short edge with the top side to the left.

FIG. 13 is a bottom plan view of the product, with the magnet holders removed; and,

FIG. 14 is a side view of the product, with the magnet holders removed, shown with the bottom side up. The series of dash lines on the surface of the product as show in FIGS. 2-4, 6, 10 and 13 represent top stitching. The broken line showing of the limbs is for illustrative purposes only and forms no part of the claimed design.
