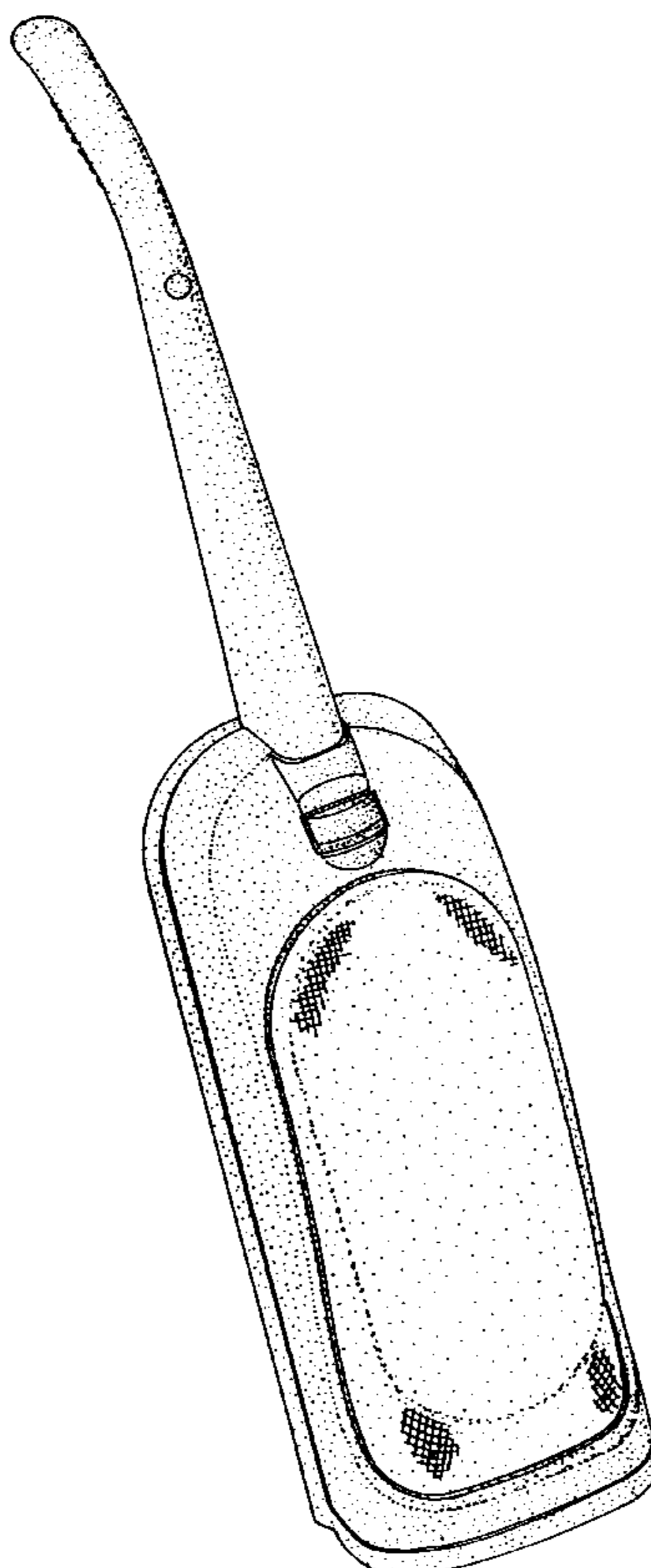
[57] **CLAIM**

The ornamental design of a vacuum cleaner upper portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vacuum cleaner upper portion showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The crosshatch shading in FIGG. 1-4 and 7 is understood to repeat throughout the indicated area.

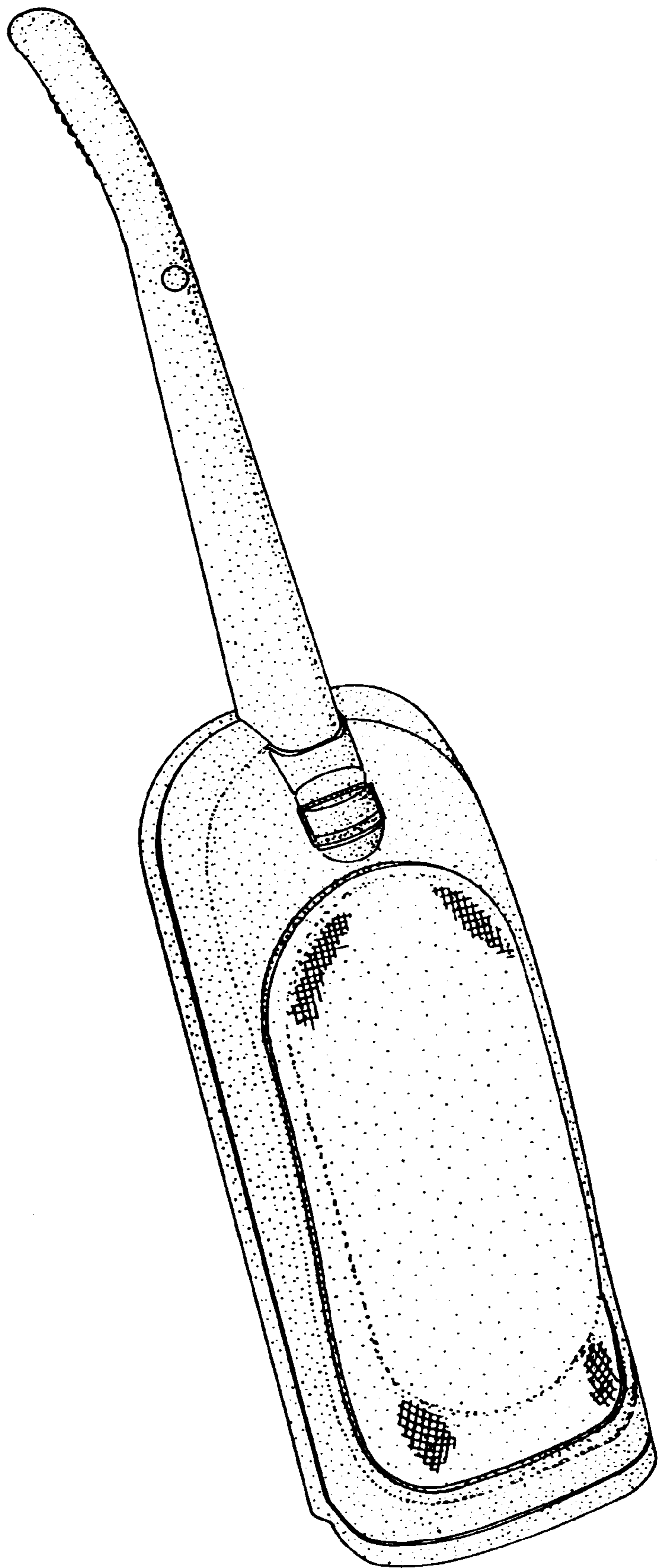

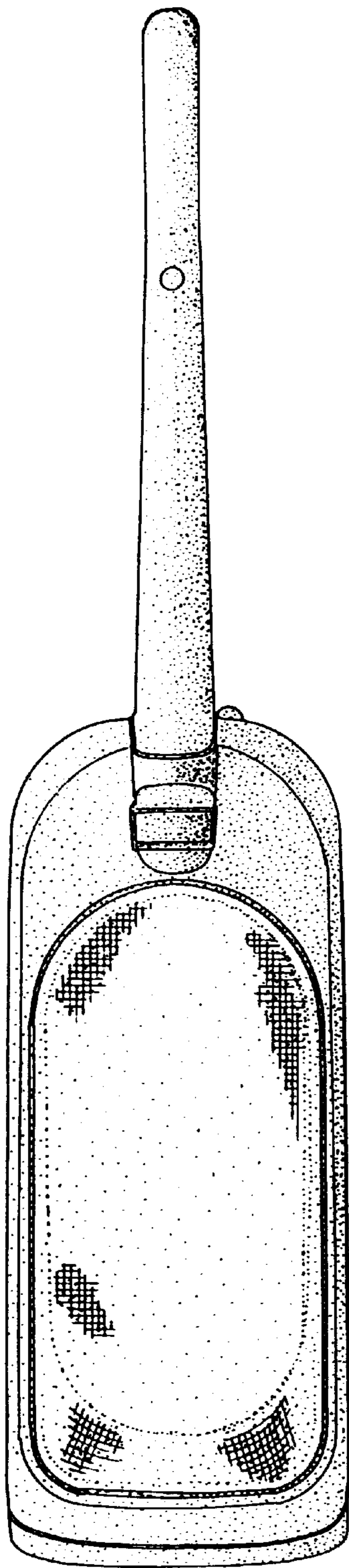

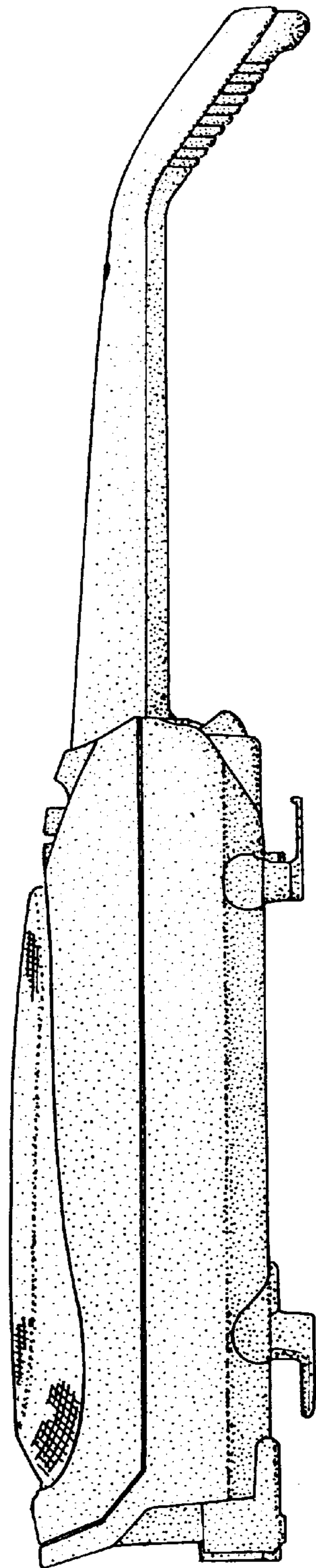

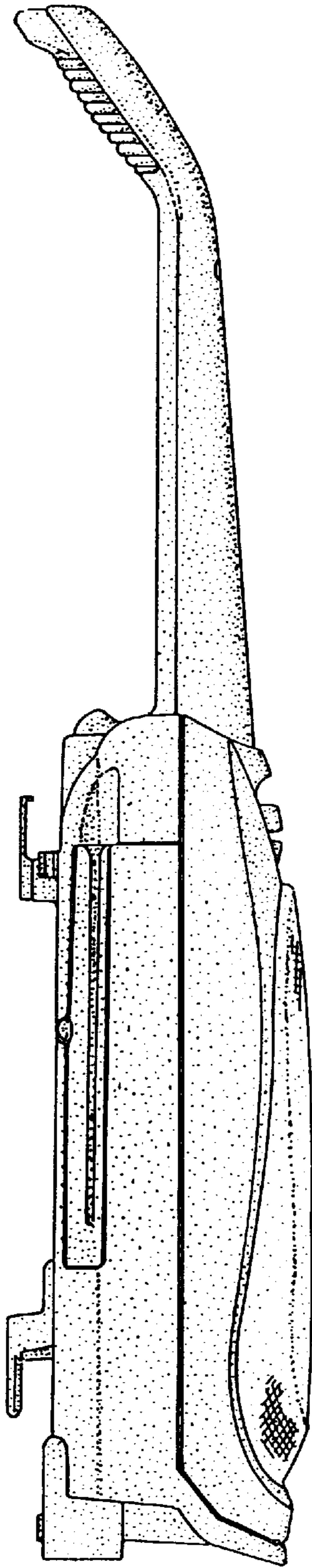

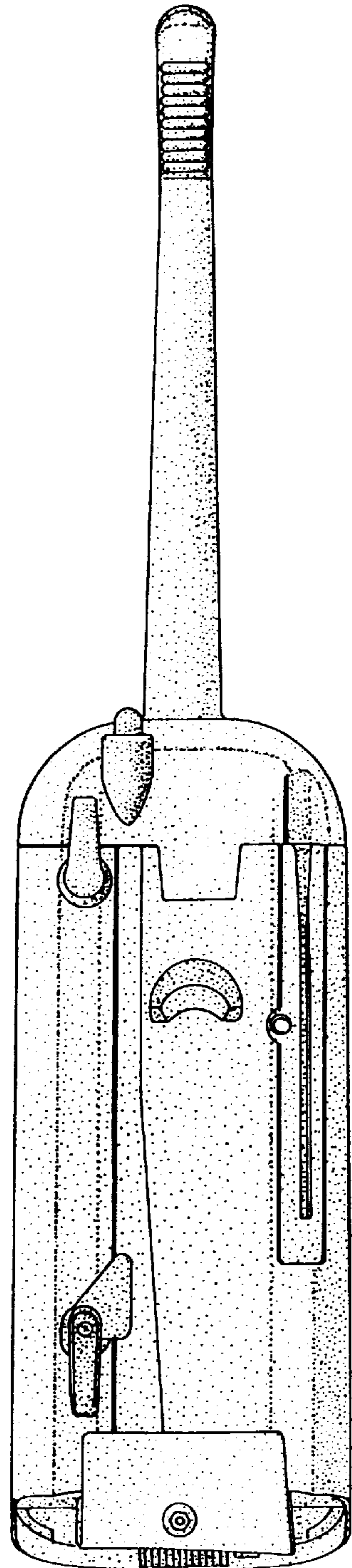

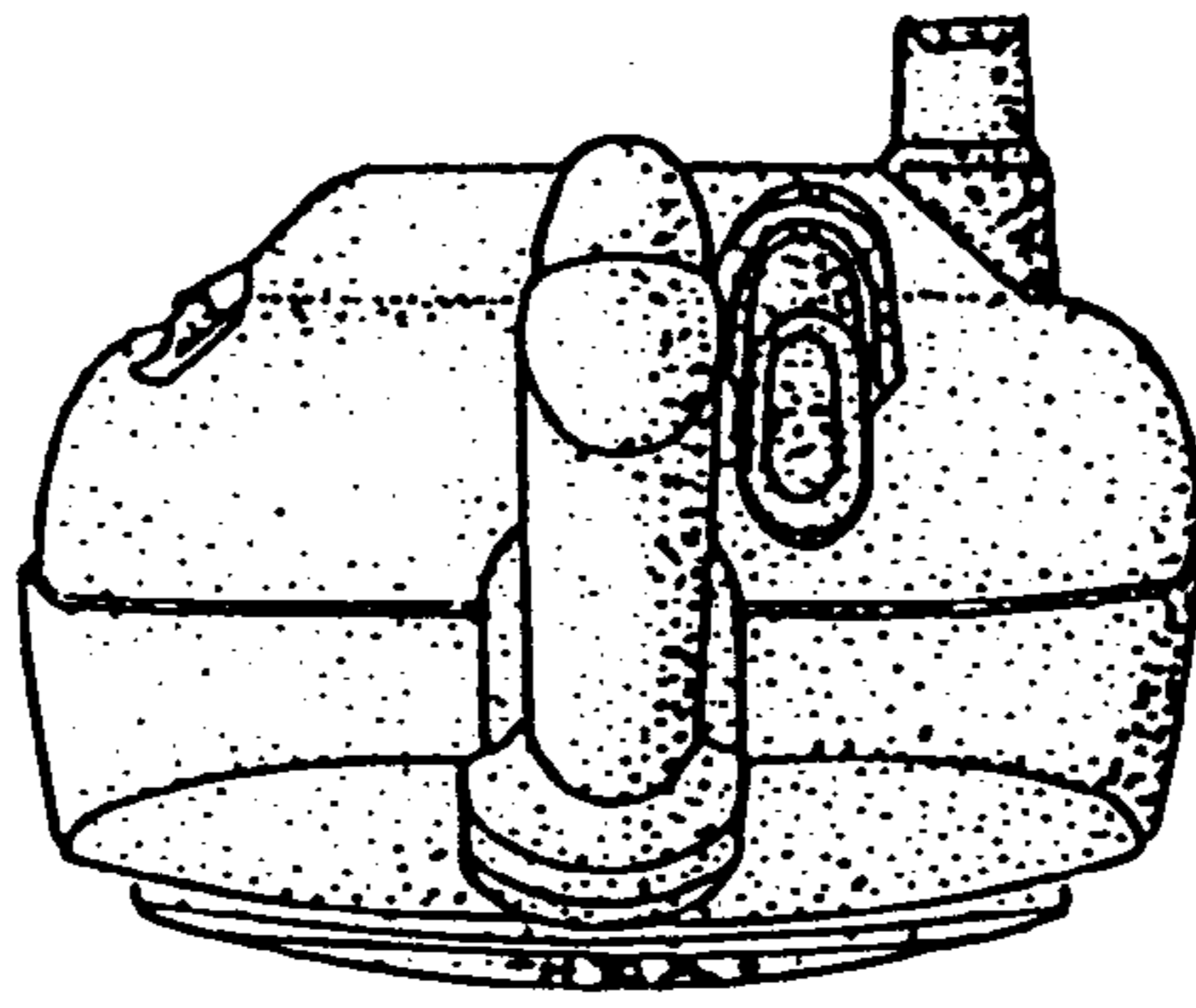

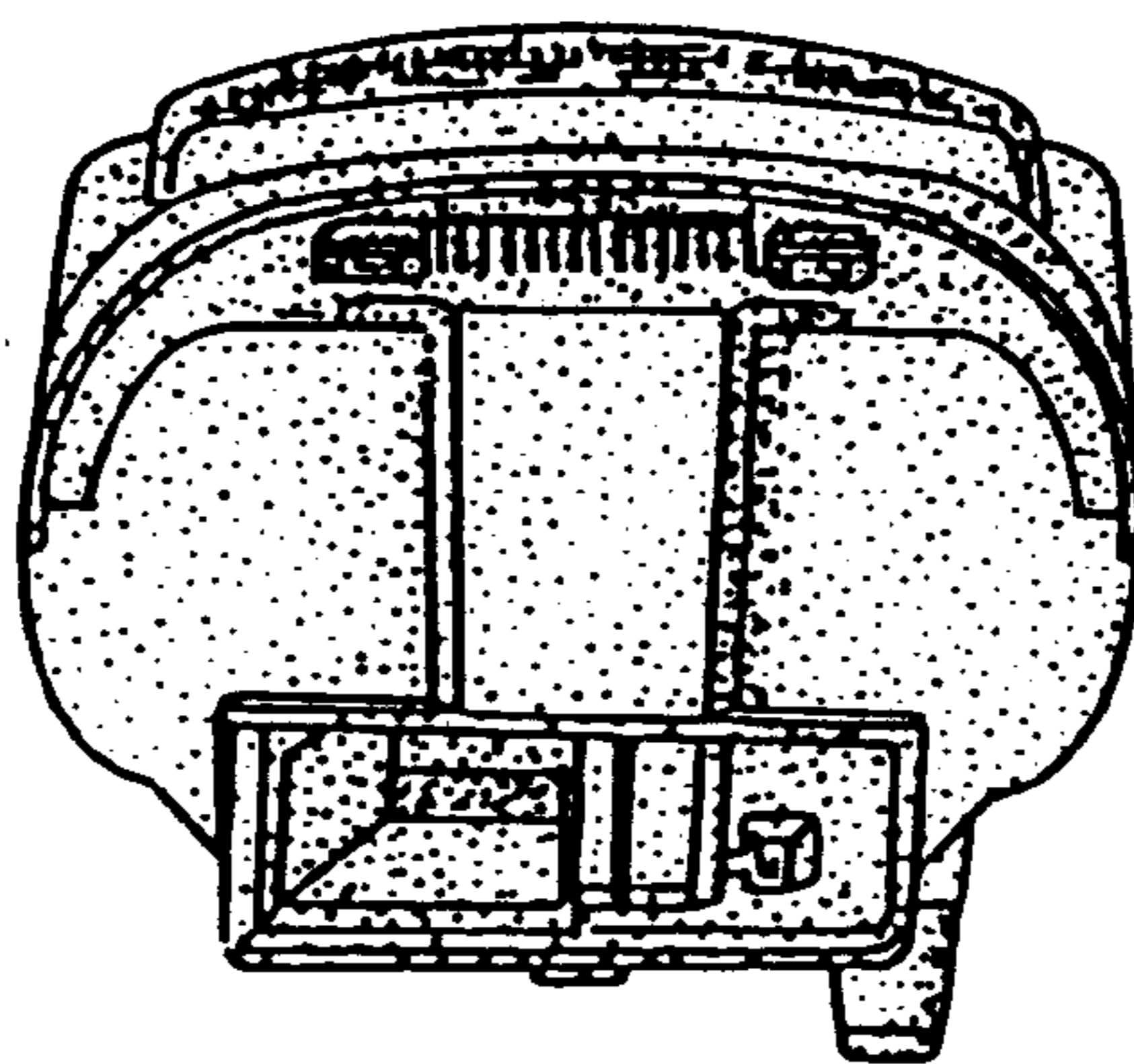
