[57] **CLAIM**

The ornamental design for a repeating pattern for an embossed wipe or similar article, as shown and described.

DESCRIPTION

The single FIGURE is a top plan view of a repeating pattern for an embossed wipe or similar article showing my new design. The broken lines in the drawing define the boundaries of the claimed design, as well as the portion of the wipe or similar article to which the pattern is applied. It is understood that the claimed pattern repeats uniformly throughout the length and width of the wipe or similar article. The broken lines form no part of the claim.
