[57] **CLAIM**

The ornamental design for a mixing container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the inventive design for a mixing container;  
FIG. 2 is a side elevational view of the FIG. 1 mixing container, the opposite side elevational view being a mirror image thereof;  
FIG. 3 is a top plan view of the FIG. 1 mixing container;  
FIG. 4 is a bottom plan view of the FIG. 1 mixing container;  
FIG. 5 is a front side (relative to FIG. 1) elevational view of the FIG. 1 mixing container; and,  
FIG. 6 is a back side (relative to FIG. 1) elevational view of the FIG. 1 mixing container.

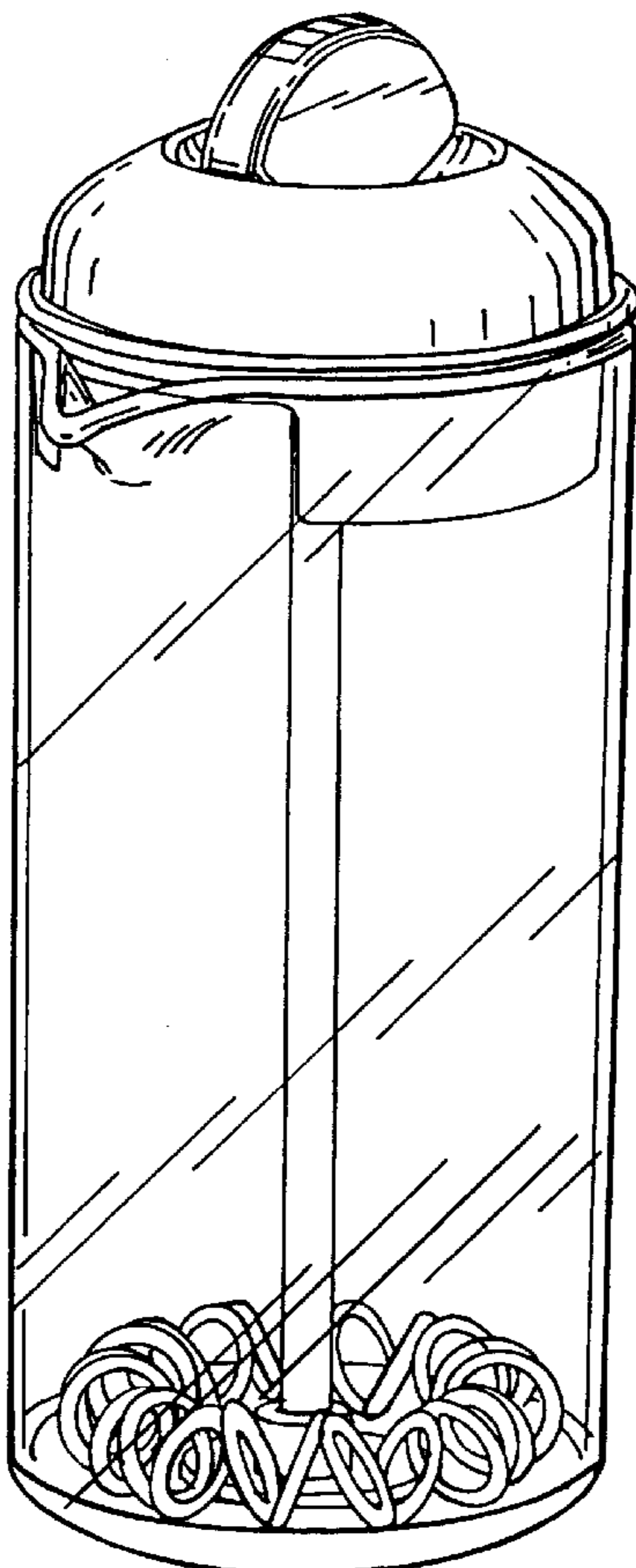

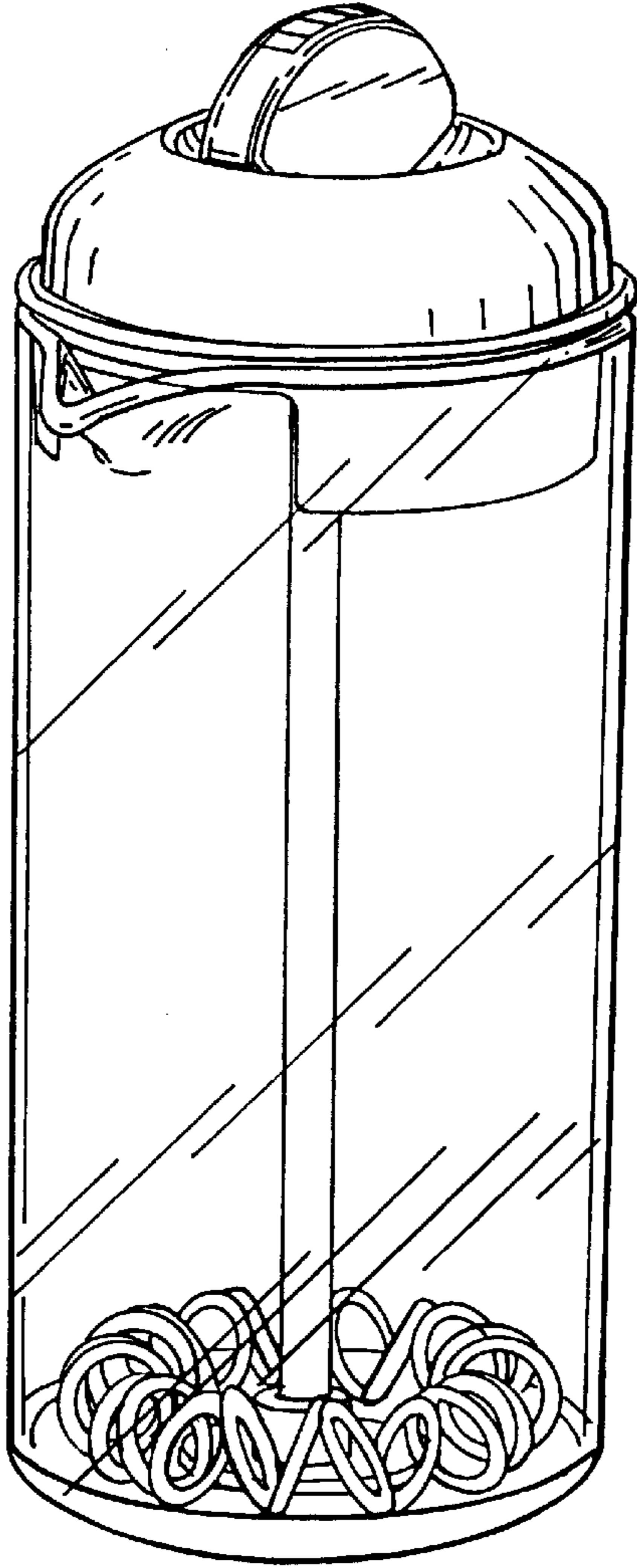

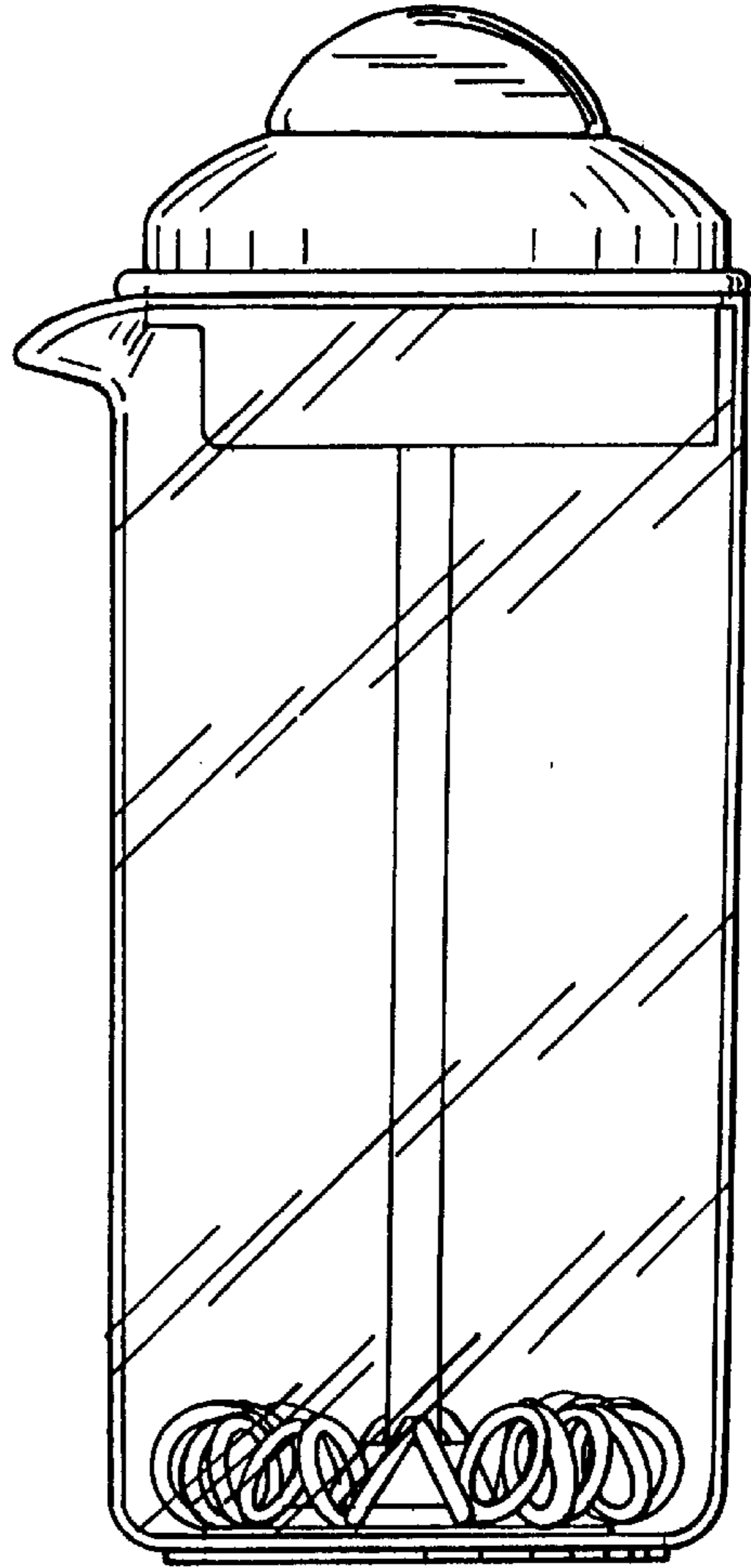

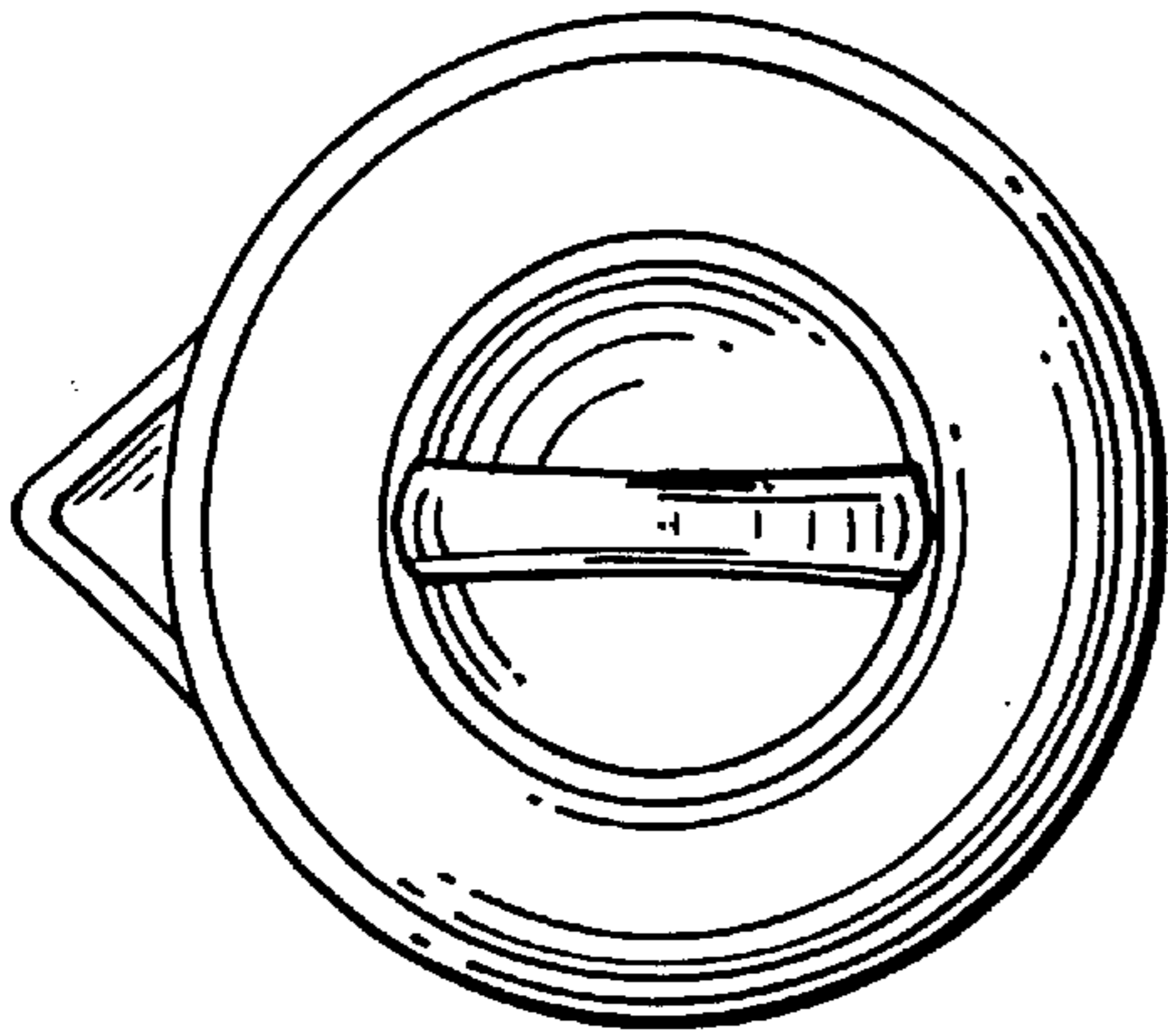

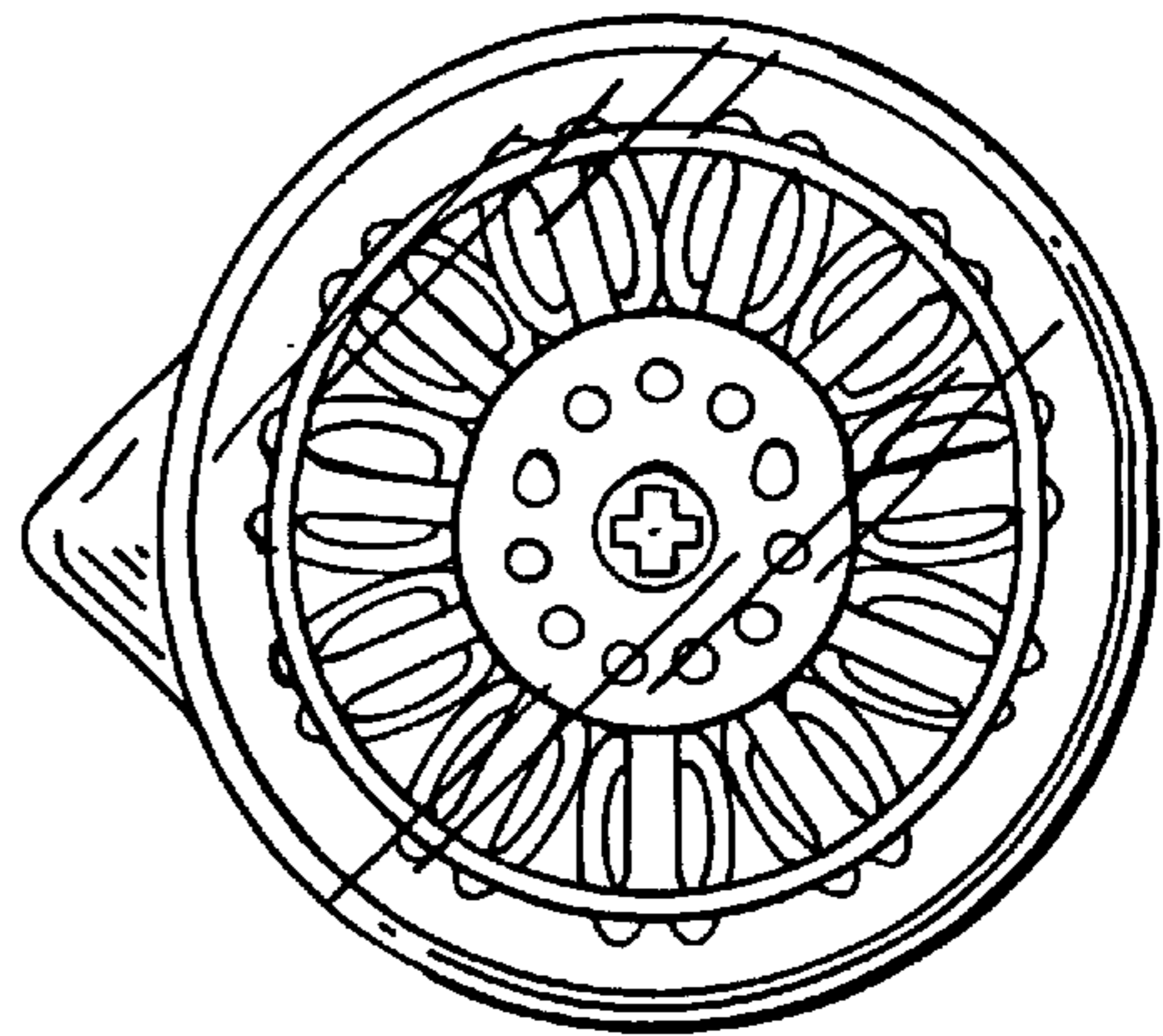

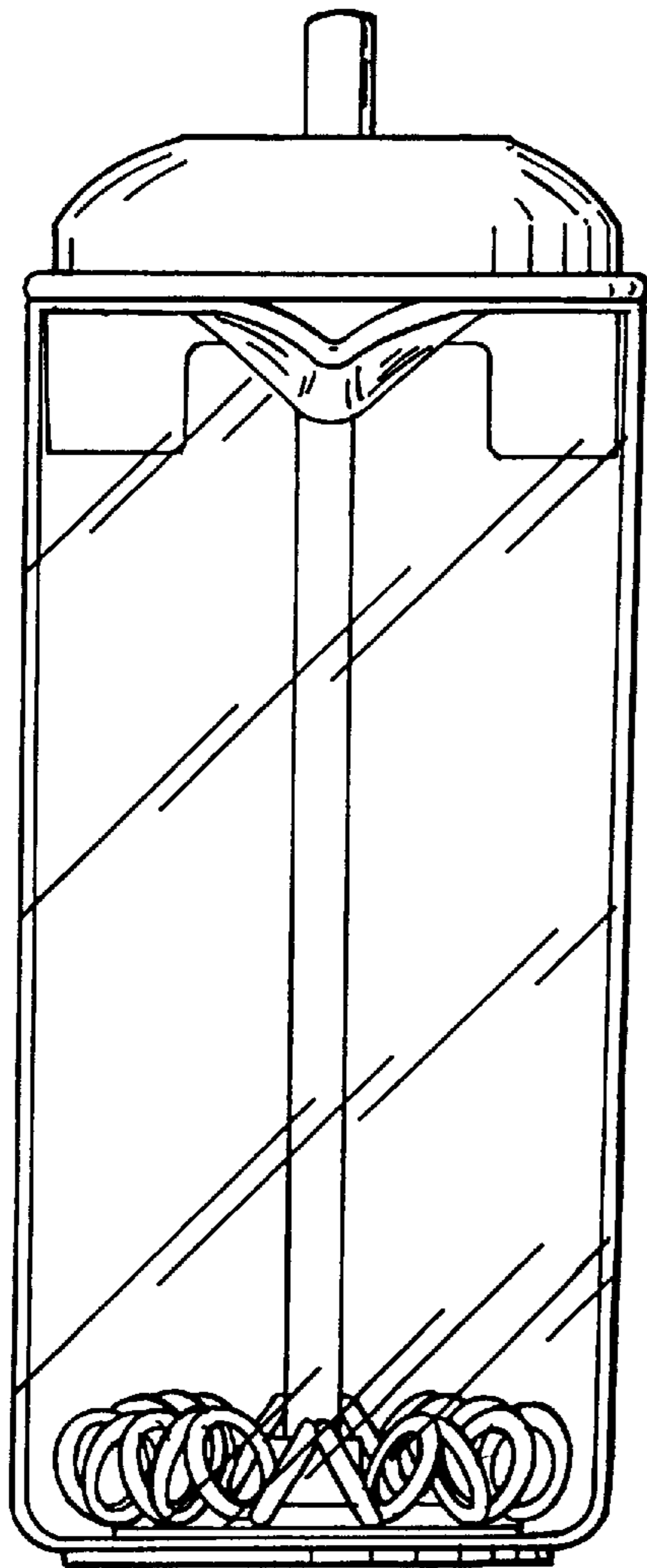
