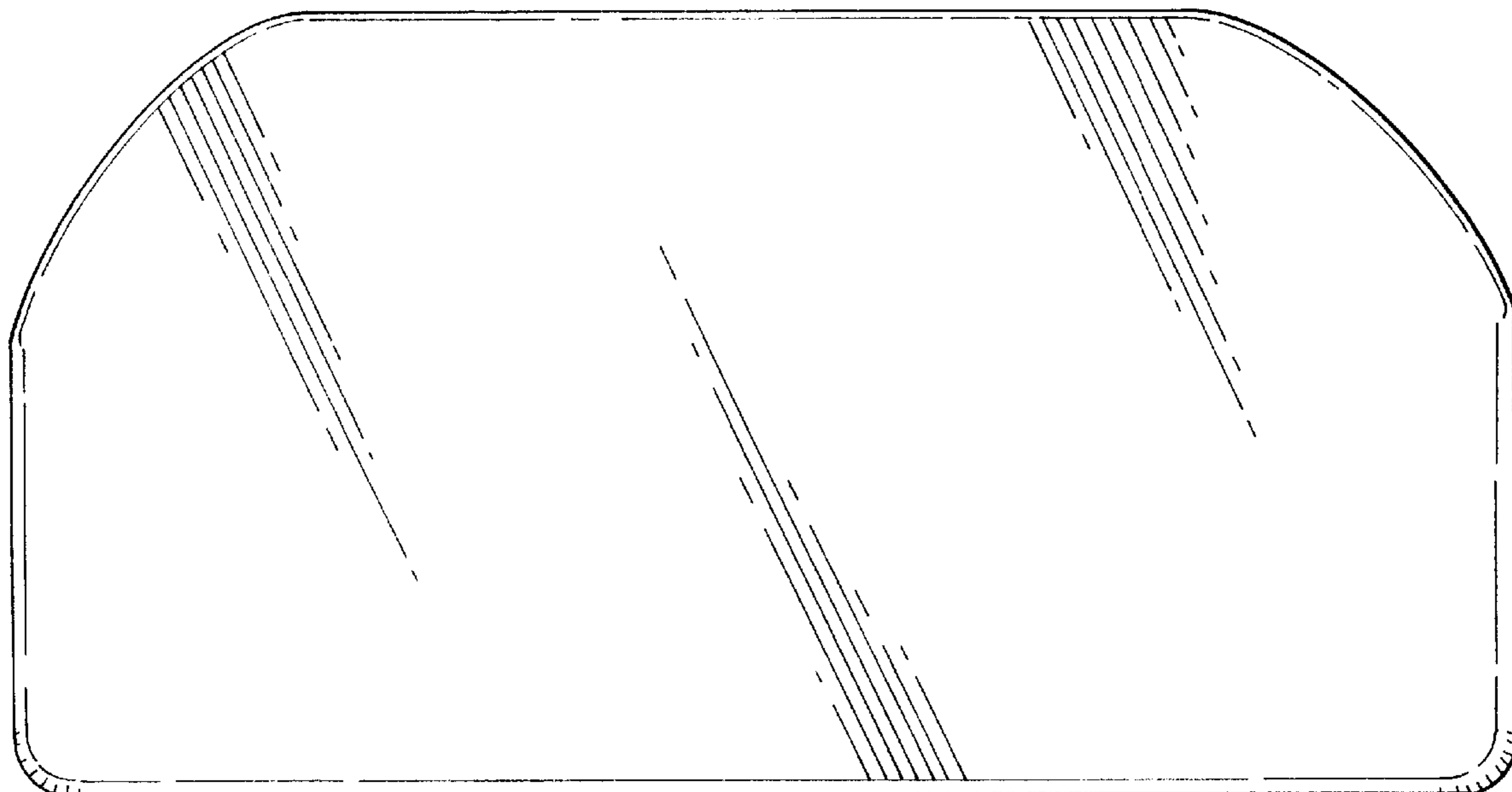
[57] **CLAIM**

I claim the ornamental design for a wallpaper hanging tool,
as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the present design;
 FIG. 2 is a top view of the present design;
 FIG. 3 is a rear elevational view of the present design;
 FIG. 4 is a bottom edge view of the present design;
 FIG. 5 is a left side view of the present design;
 FIG. 6 is a right side view of the present design;
 FIG. 7 is a first cutaway of the edge section of the wallpaper hanging tool according to the present design and taken along line 7—7 of FIG. 1;
 FIG. 8 is a second cutaway of the edge section of the wallpaper hanging tool according to the present design and taken along line 8—8 of FIG. 1;
 FIG. 9 is a third cutaway of the edge section of the wallpaper hanging tool according to the present design and taken along line 9—9 of FIG. 1;
 FIG. 10 is a fourth cutaway of the edge section of the wallpaper hanging tool according to the present design and taken along line 10—10 of FIG. 1; and,
 FIG. 11 is a fifth cutaway of the edge section of the wallpaper hanging tool according to the present design and taken along line 11—11 of FIG. 1.

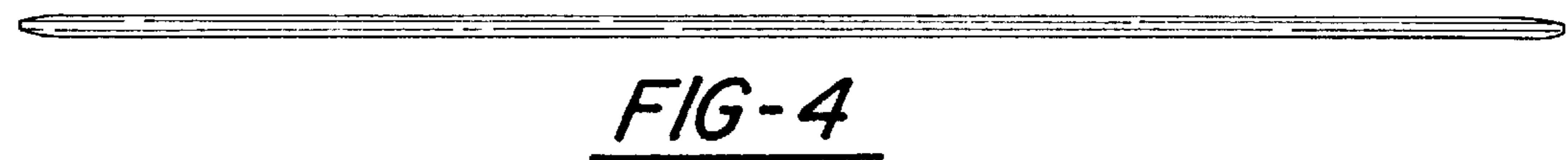
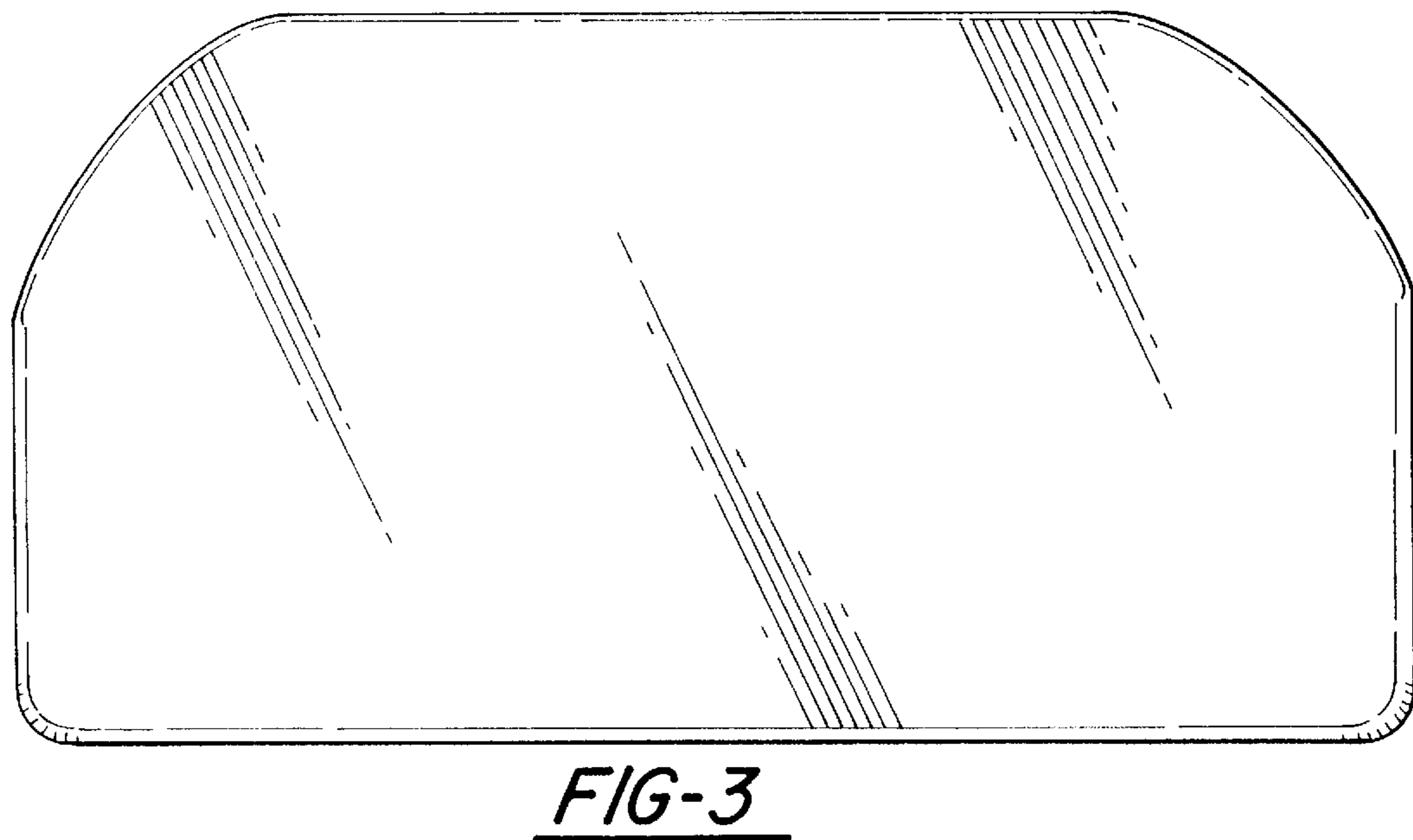
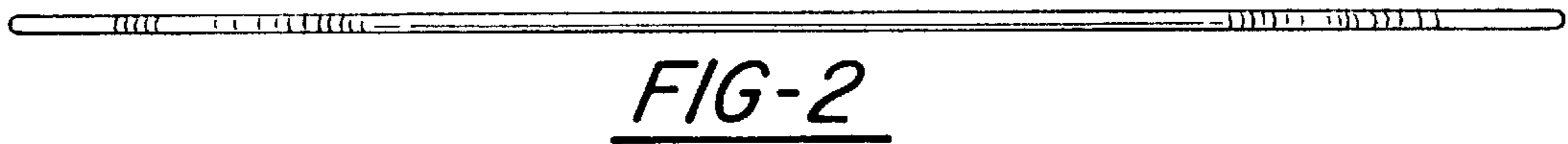
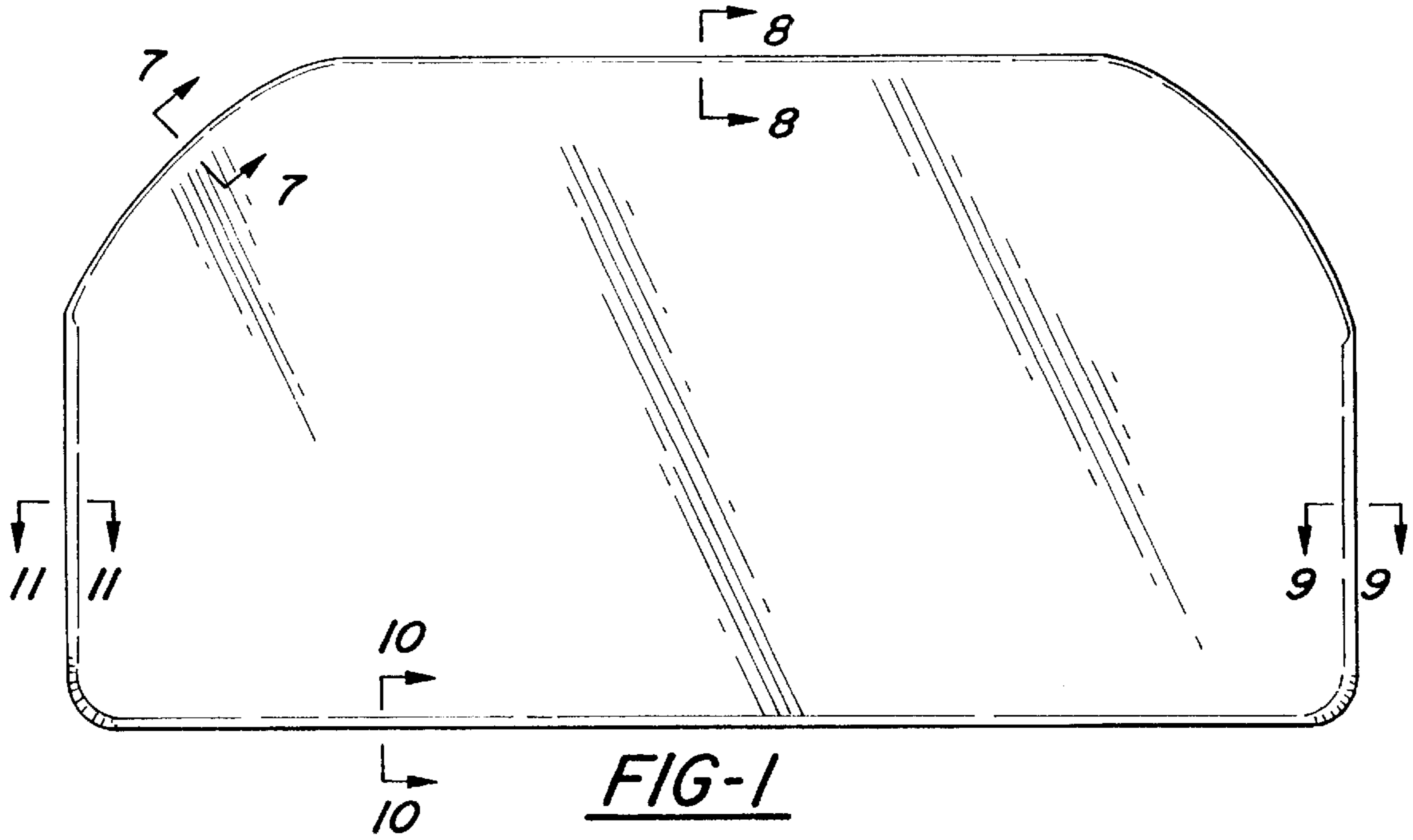

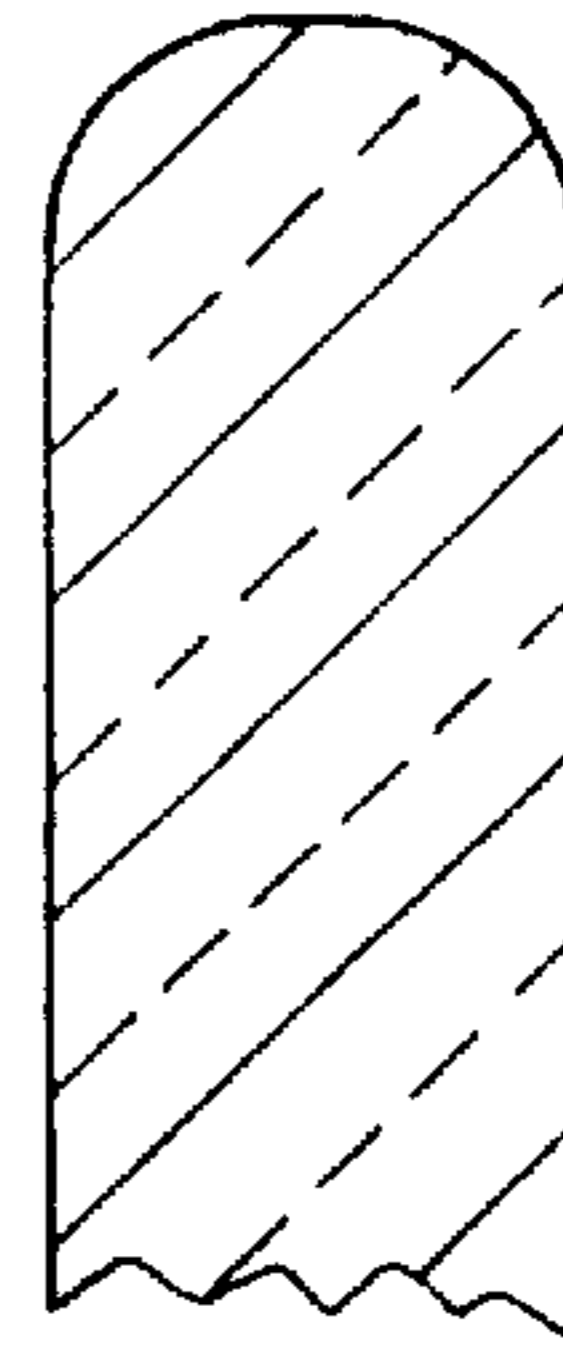

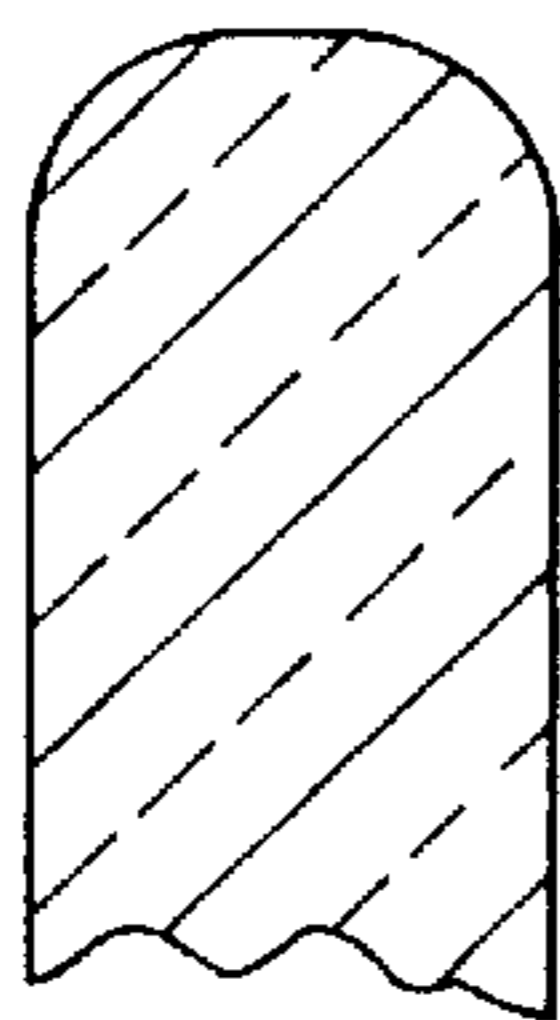

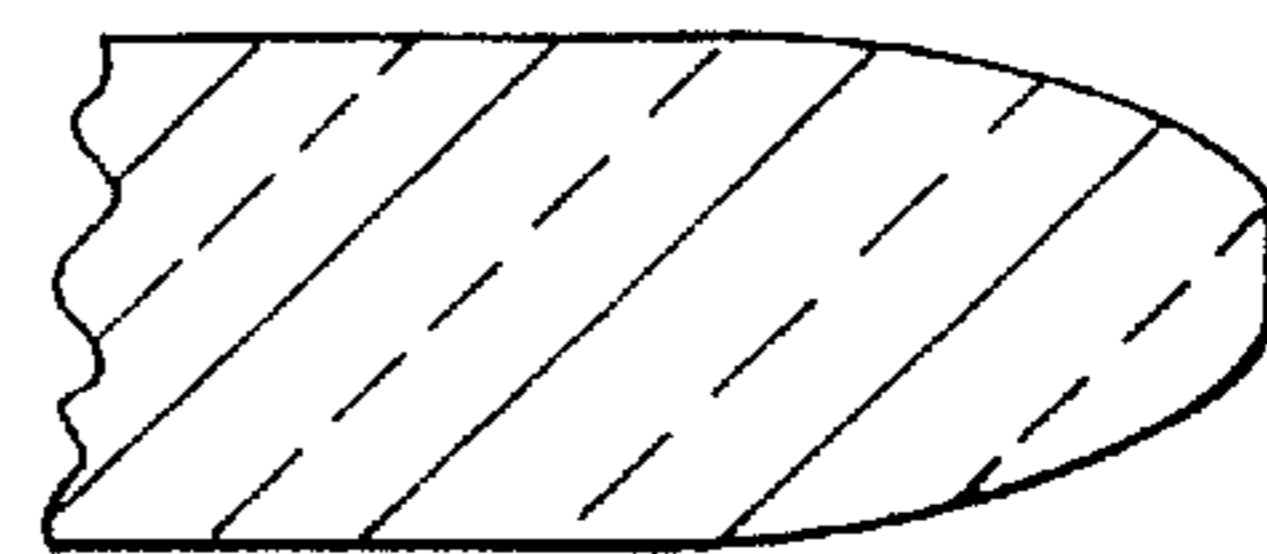

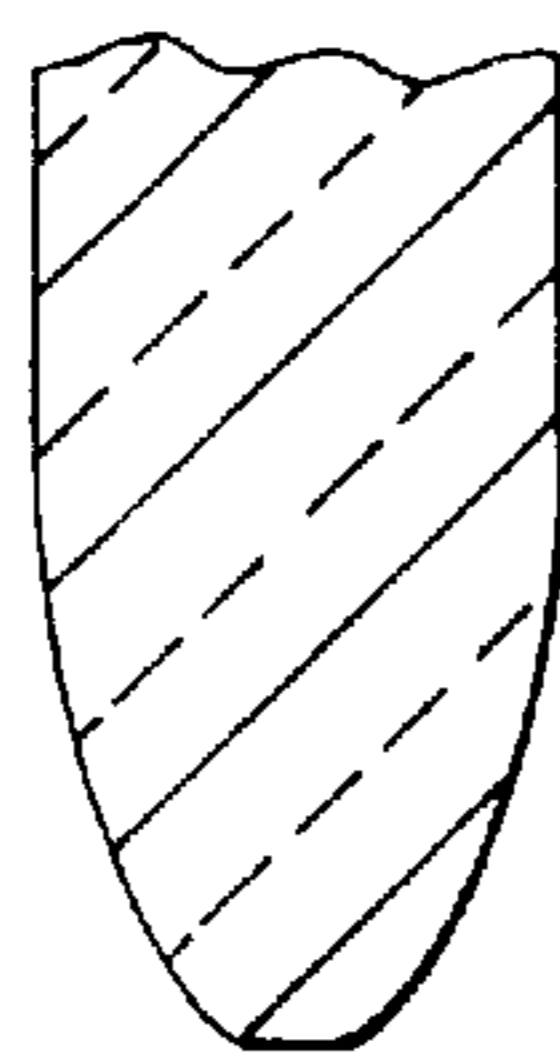

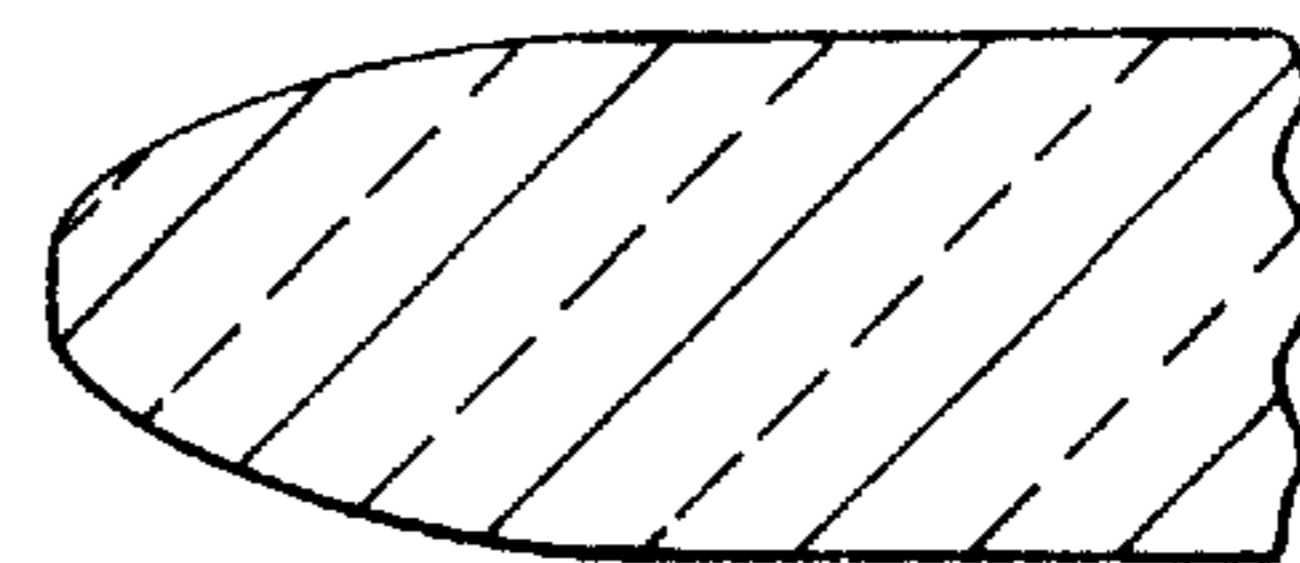
