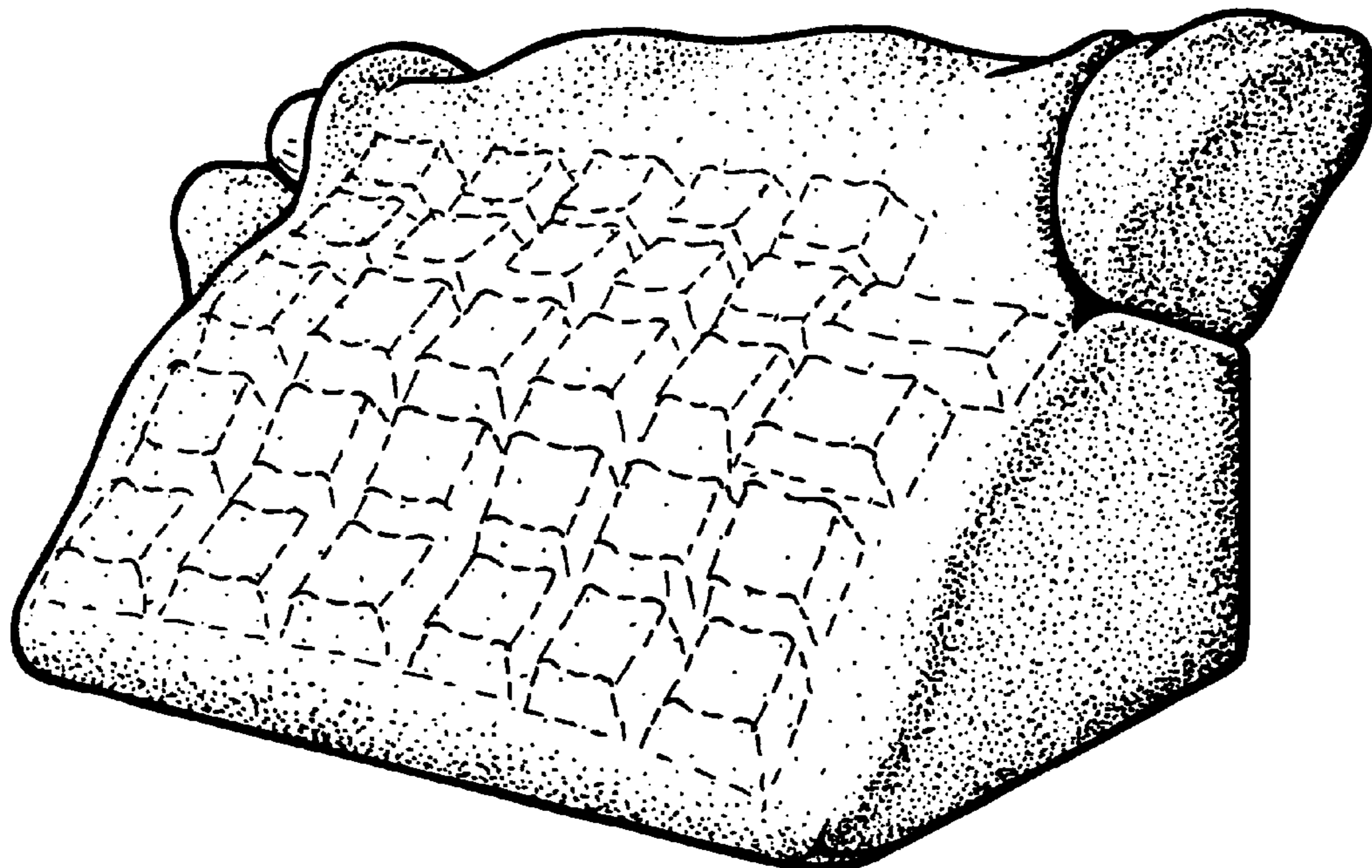
The ornamental design for a computer keyboard, as shown and described.

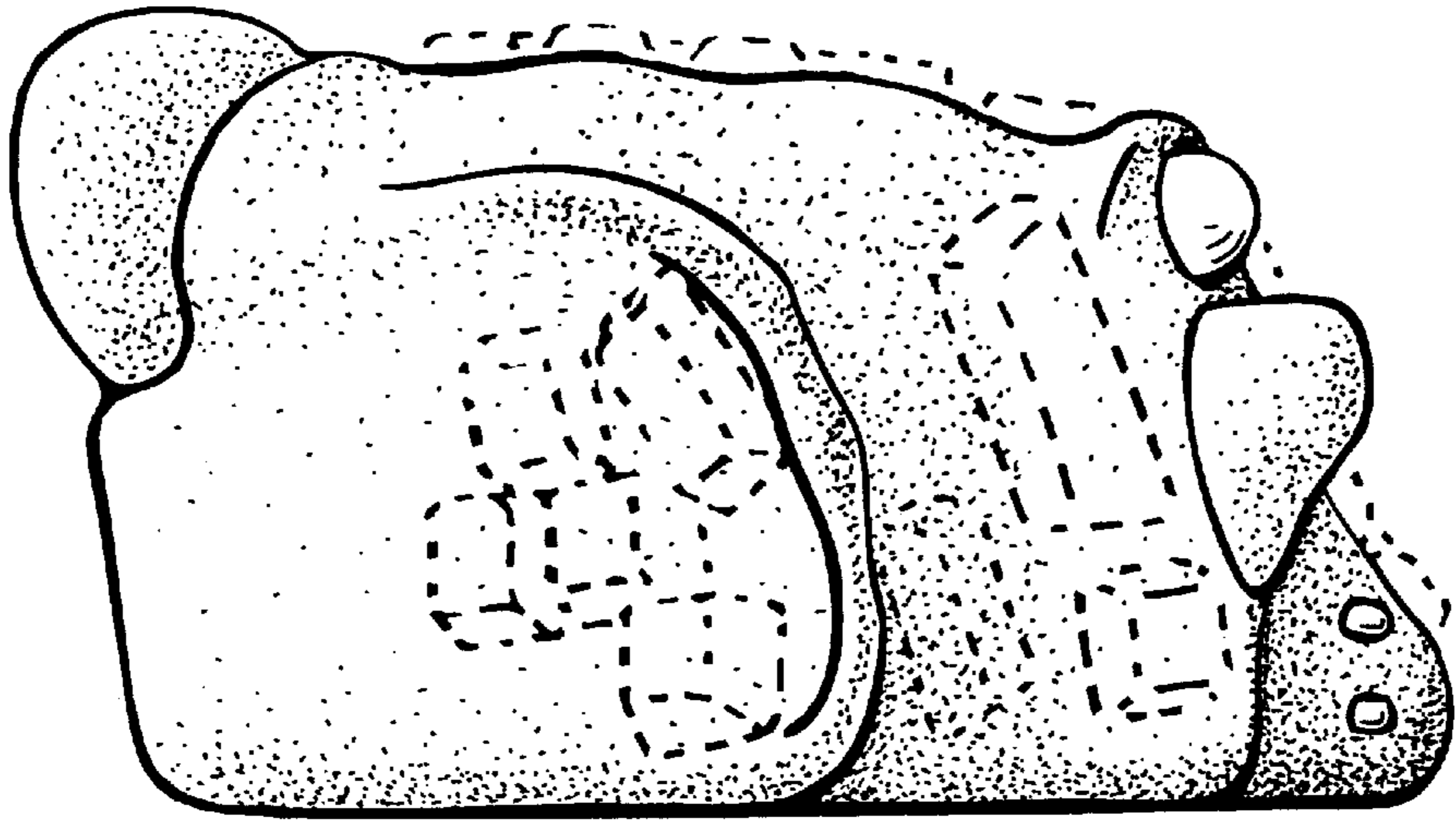

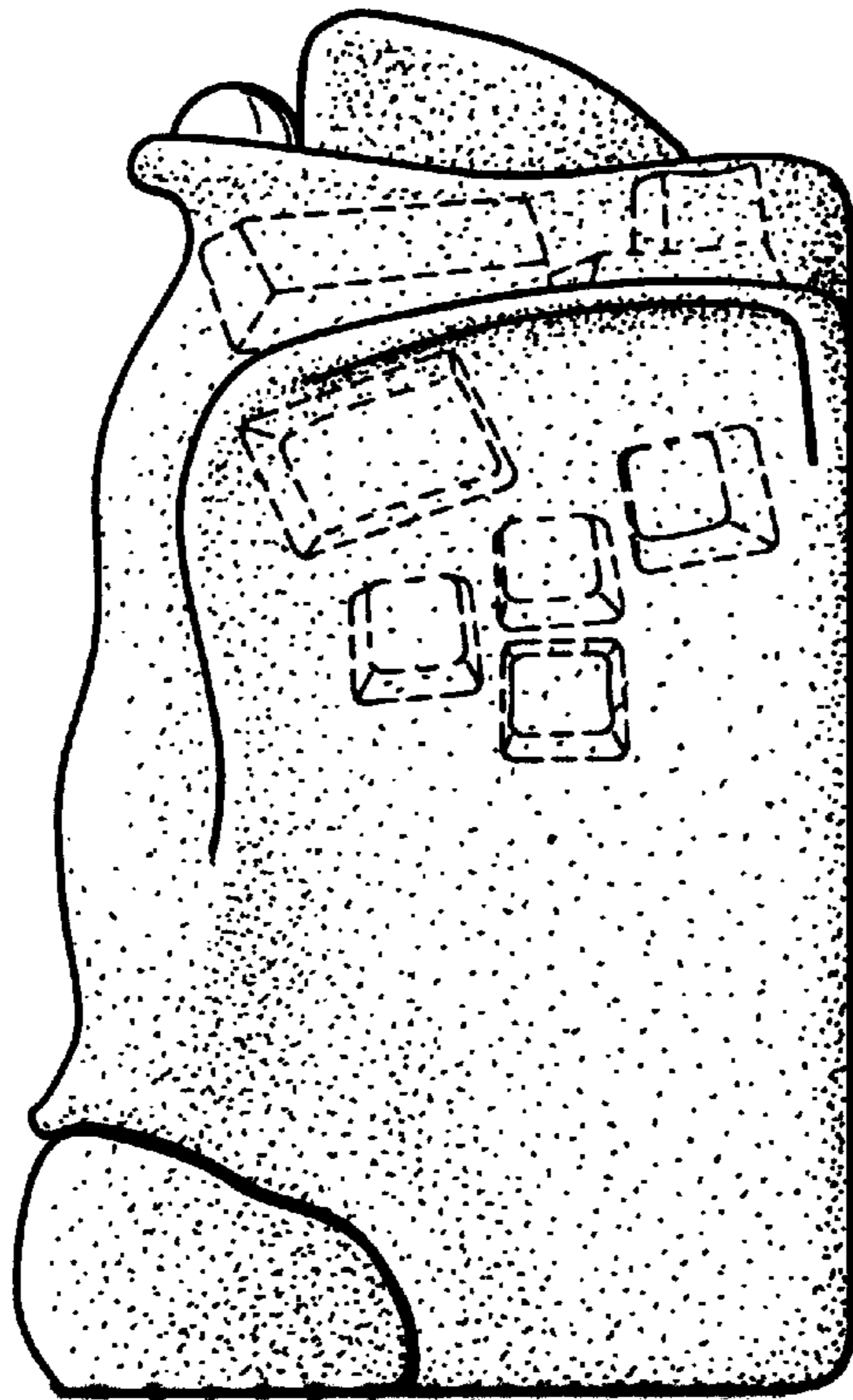

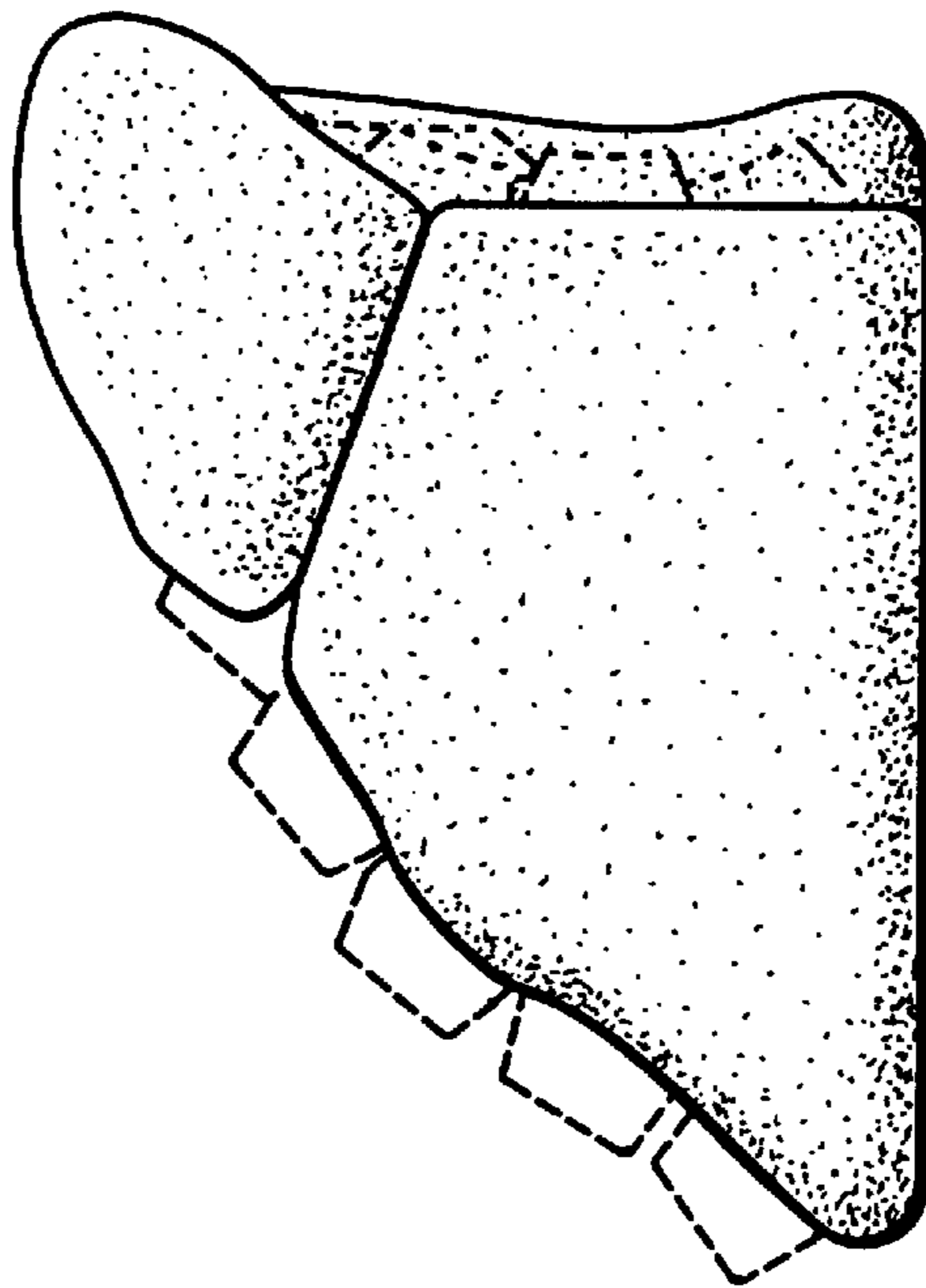

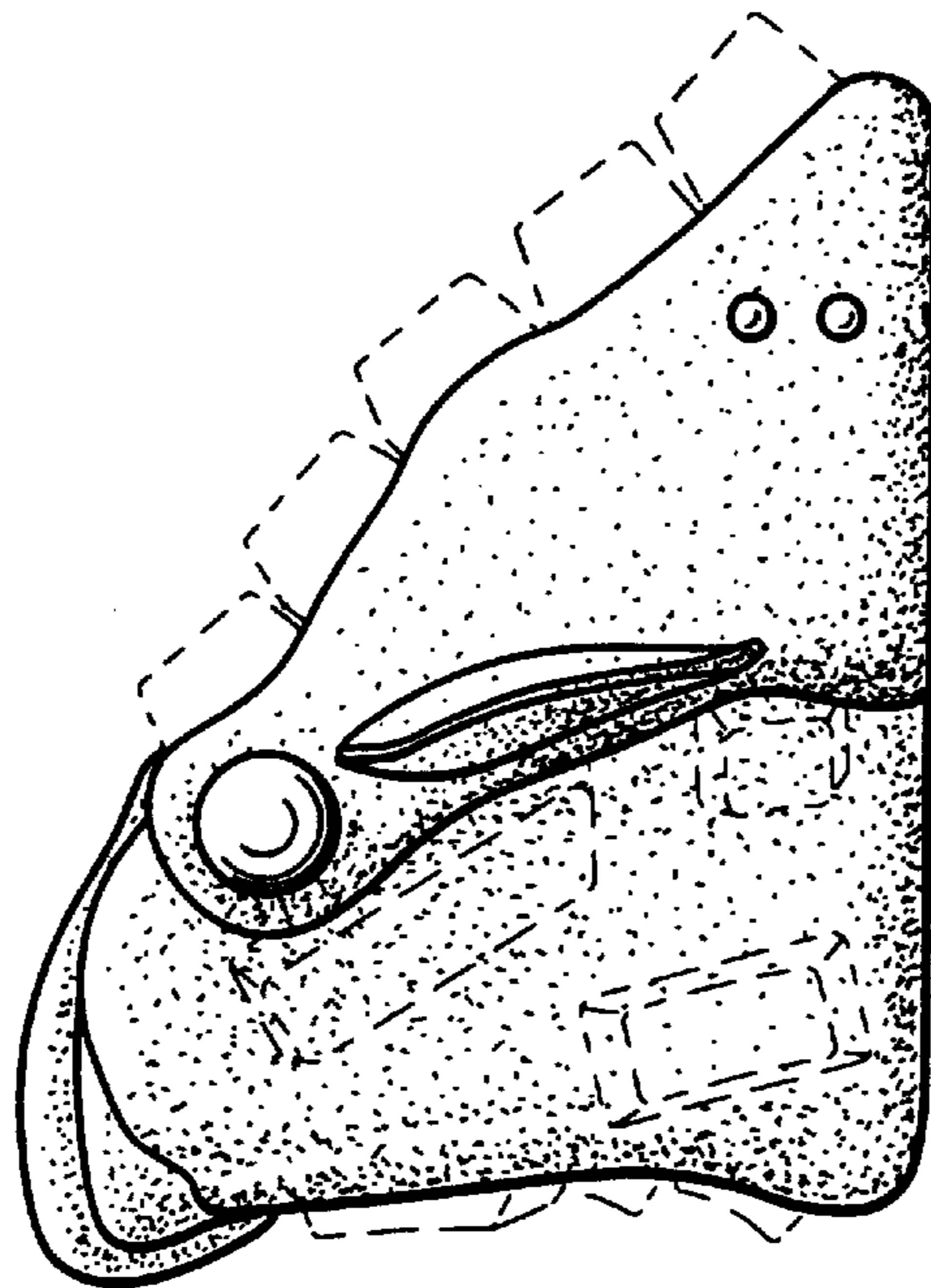

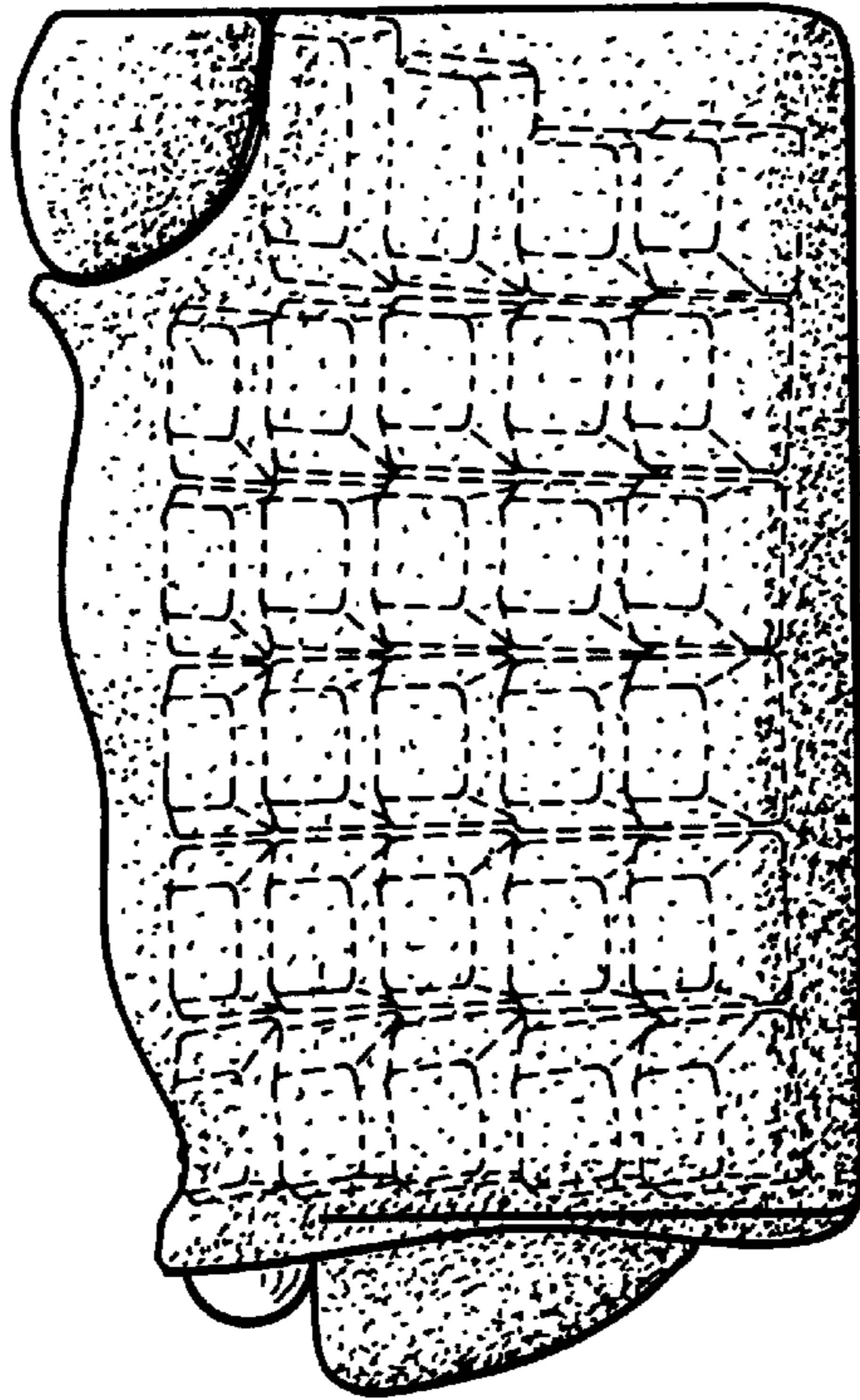

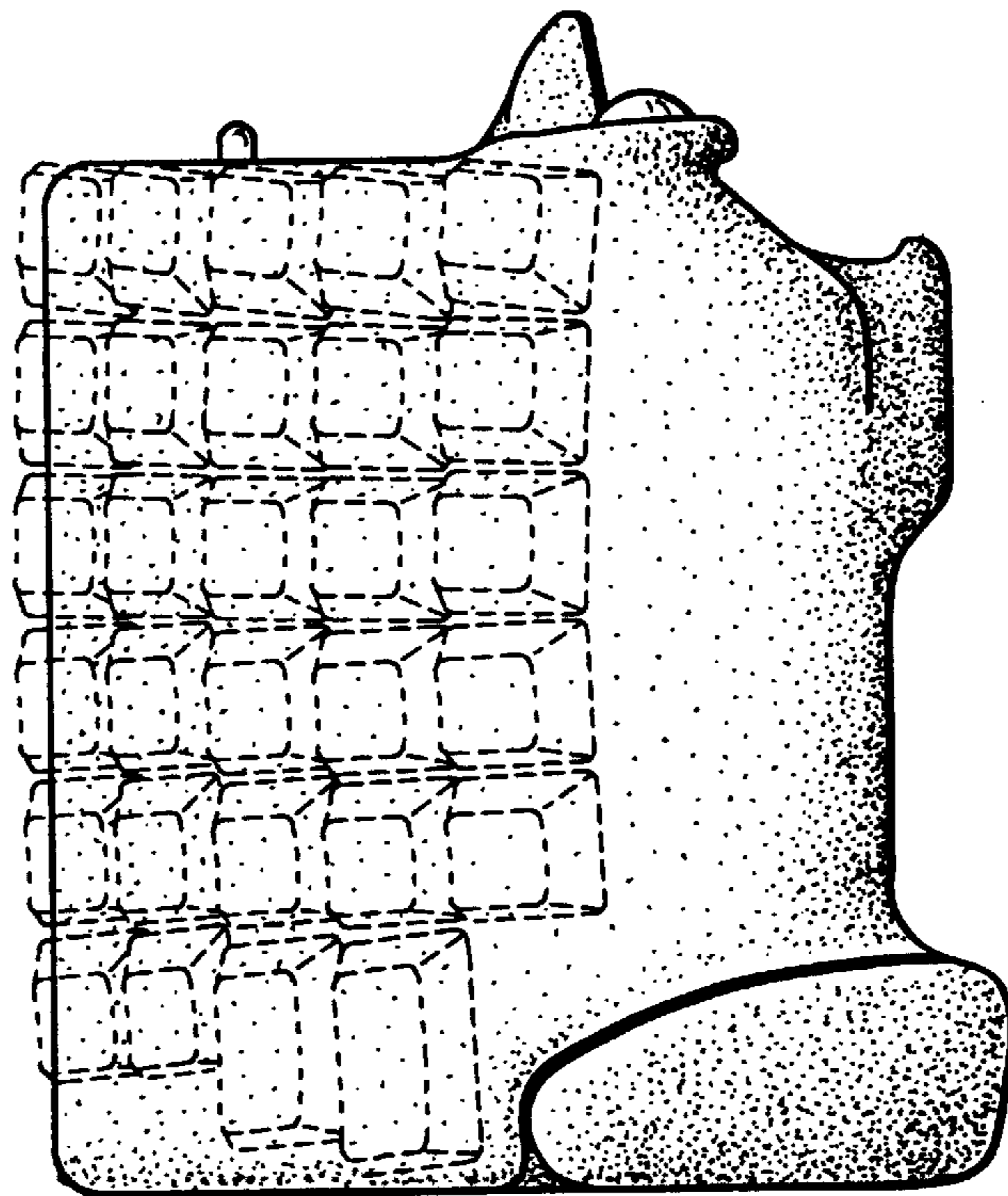

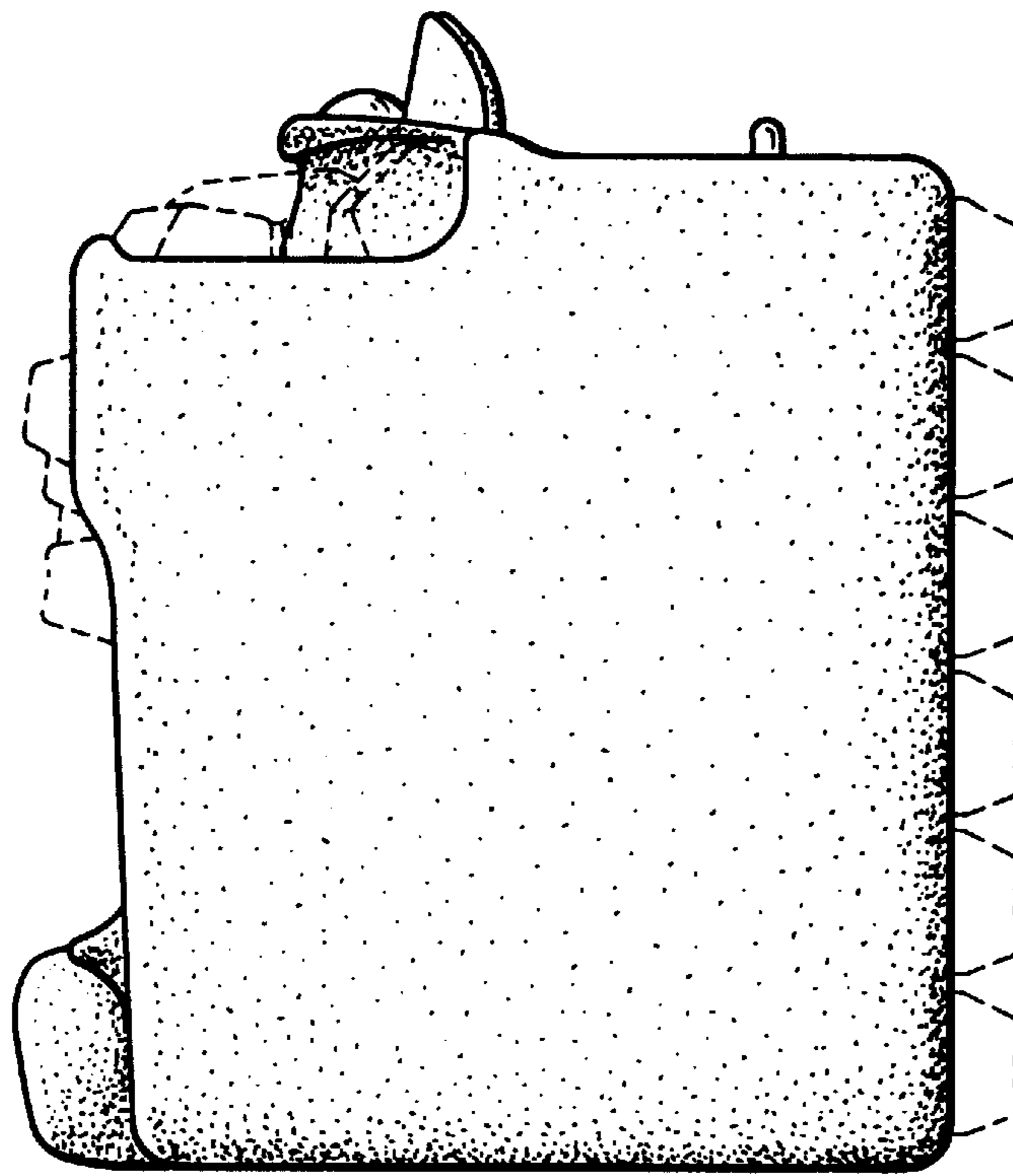

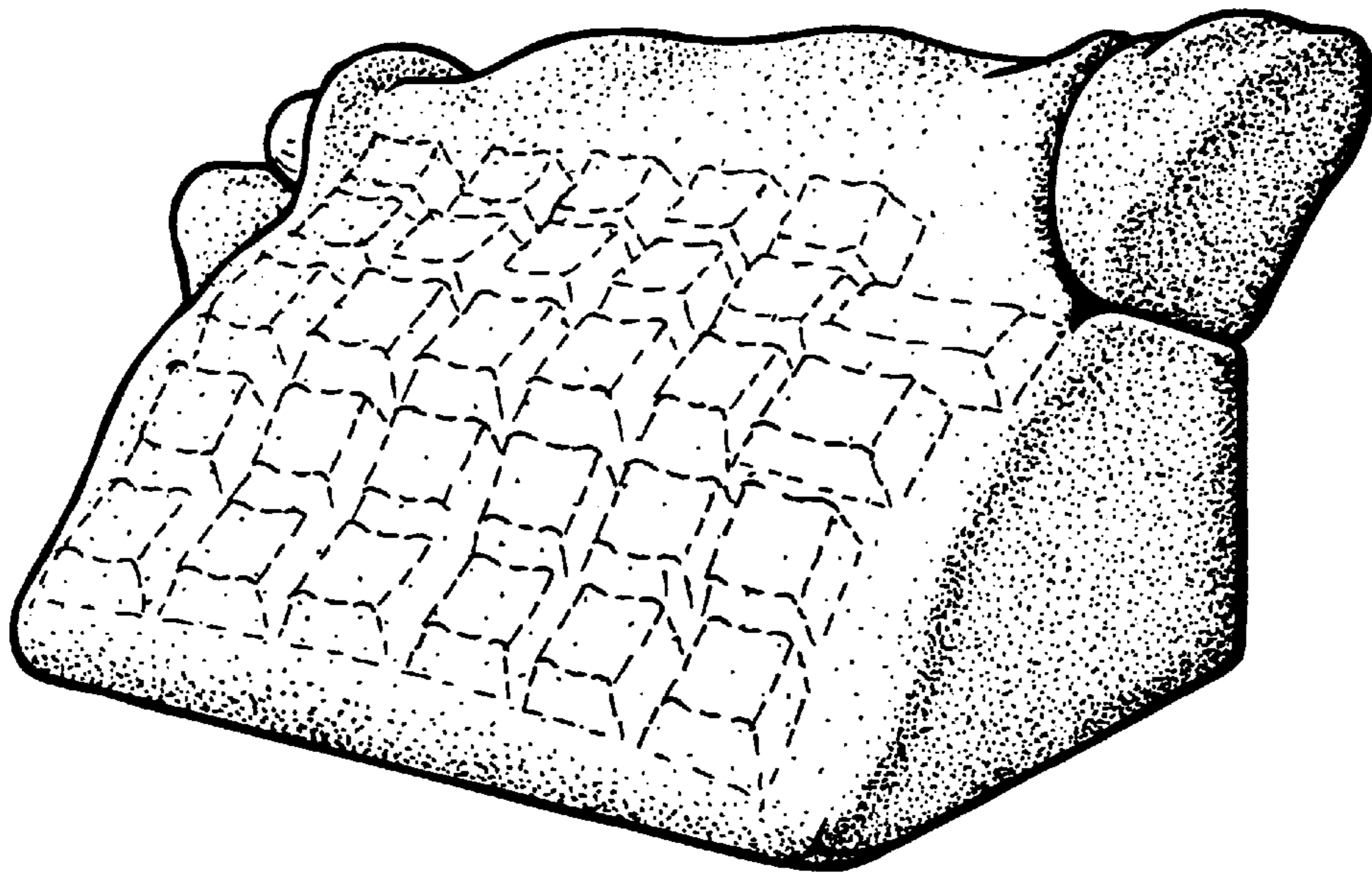

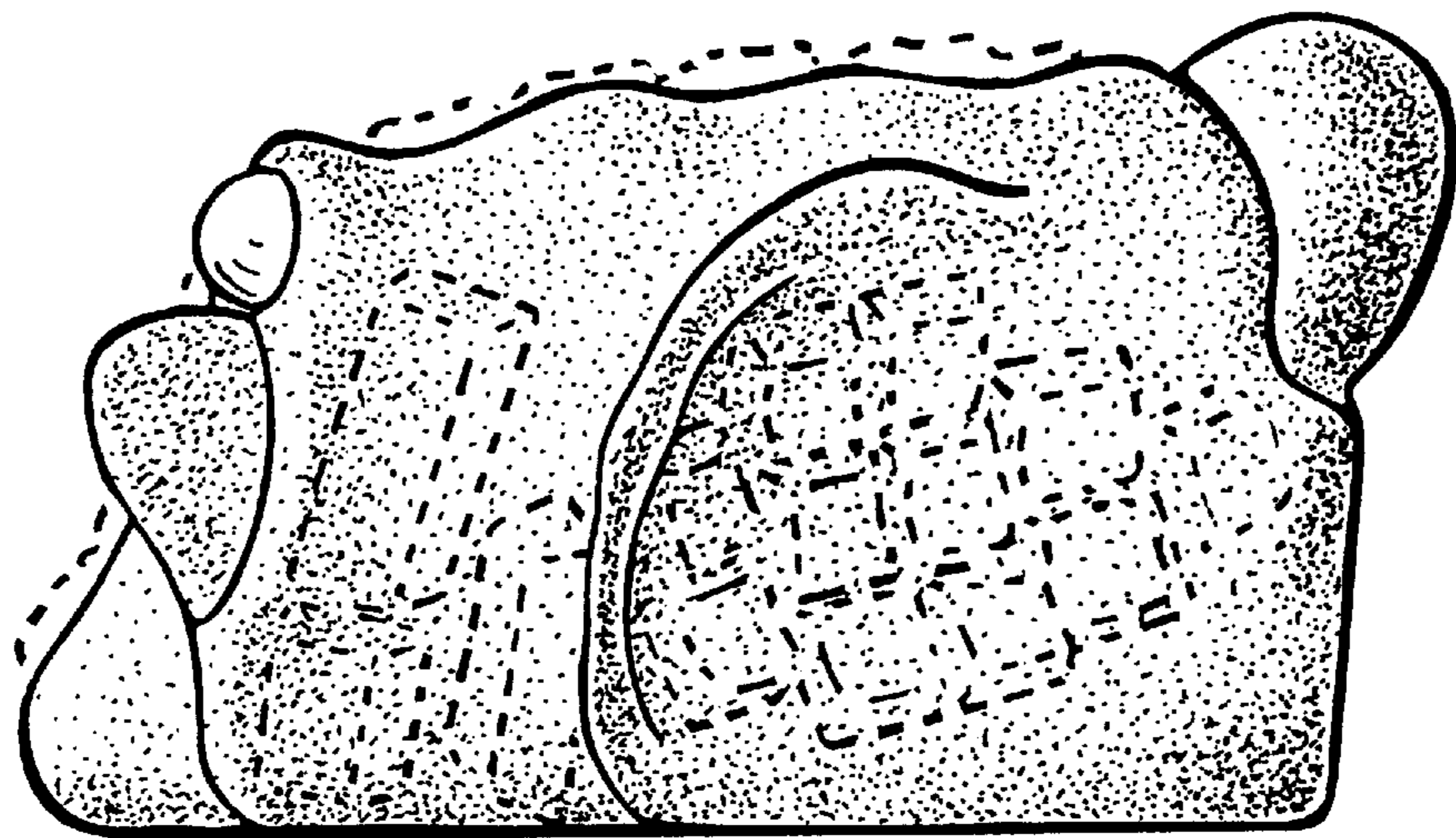

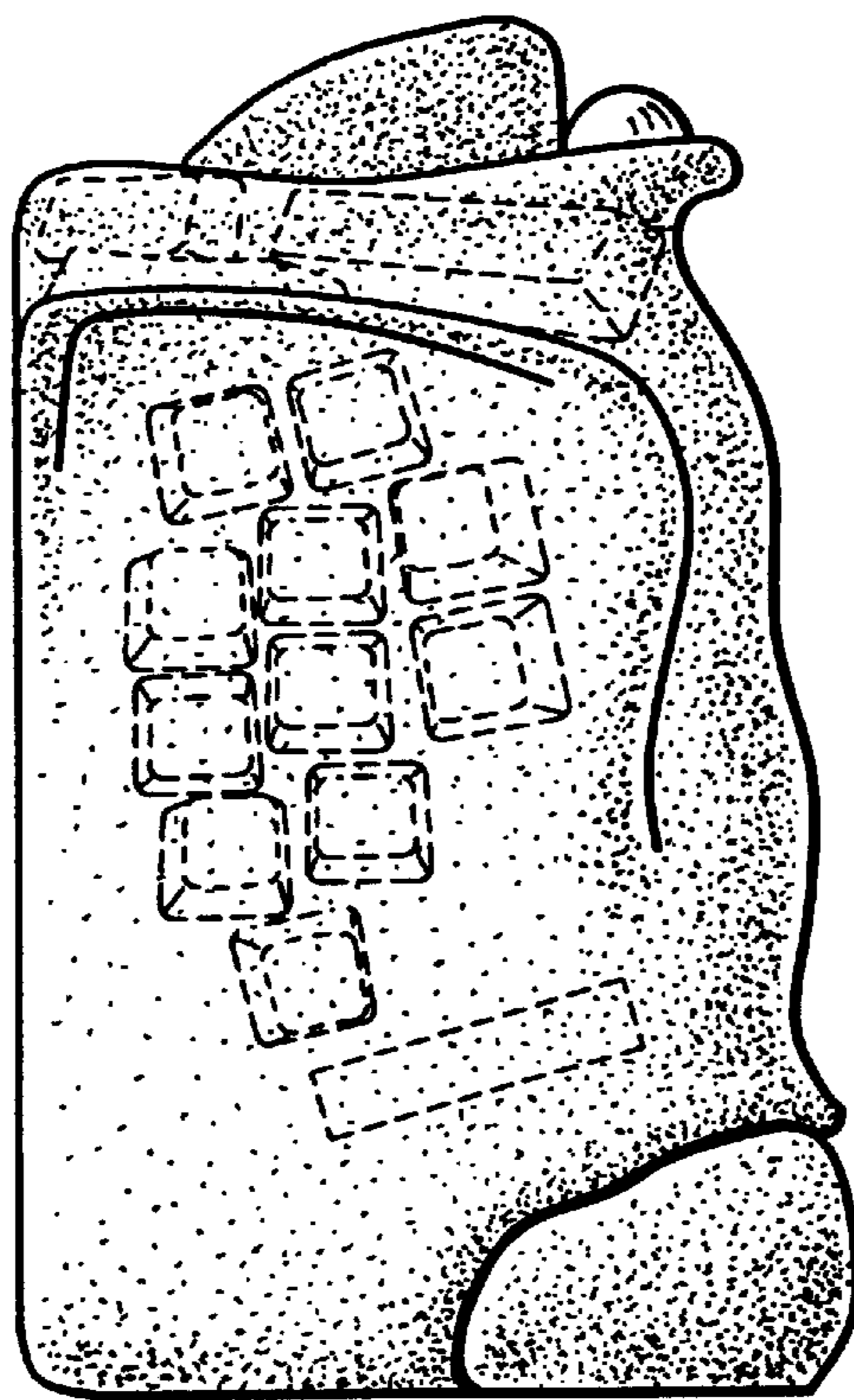

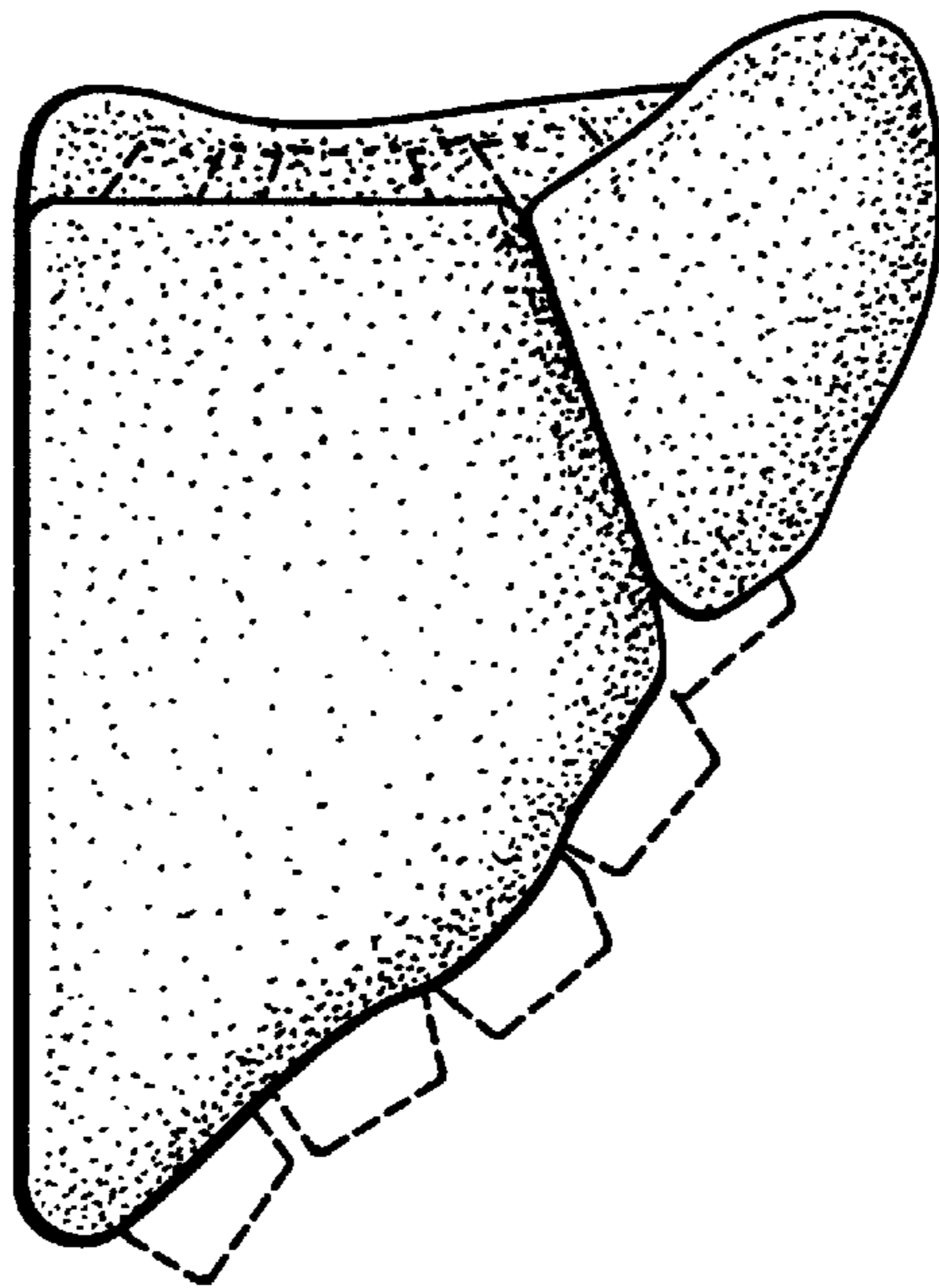

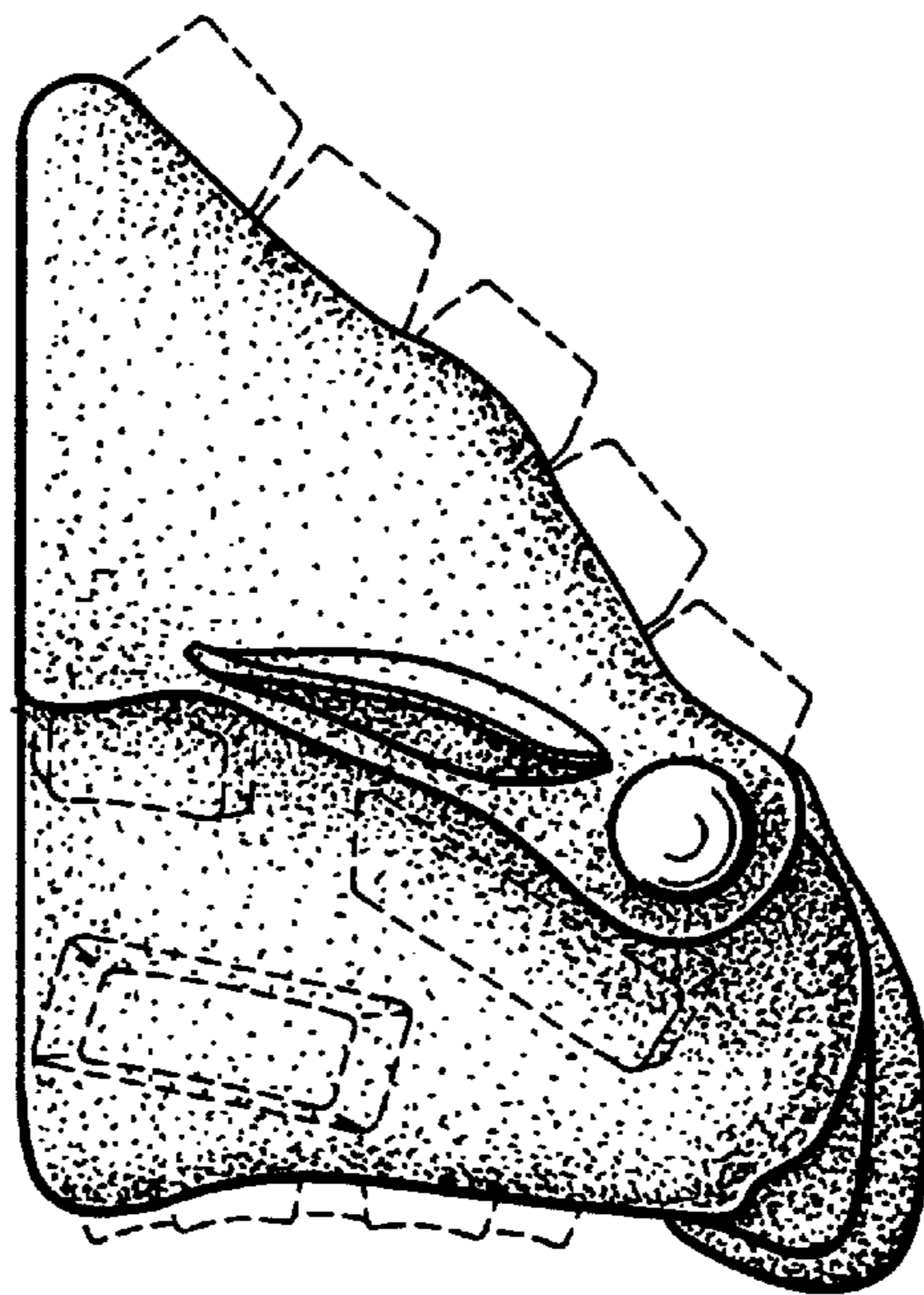

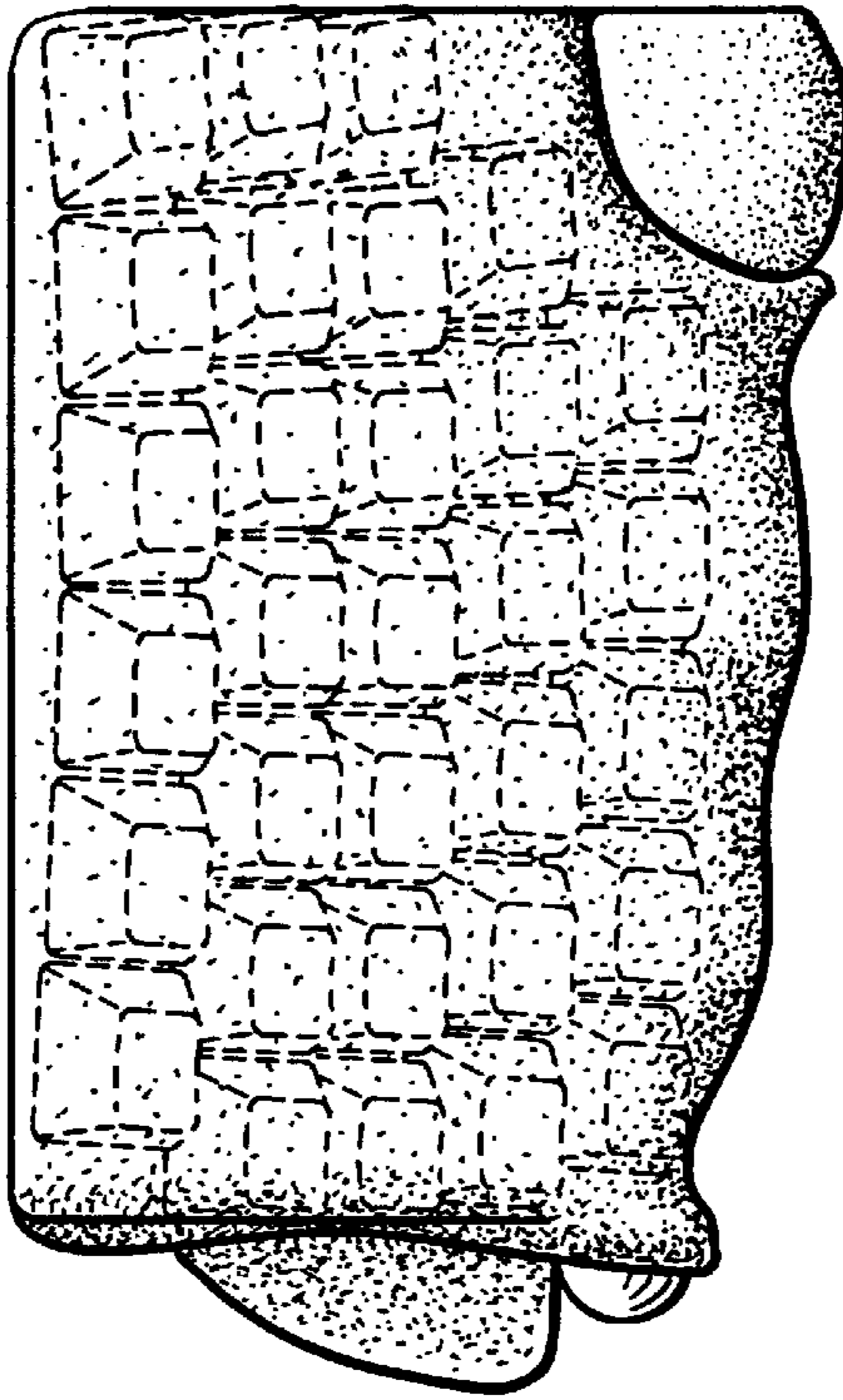

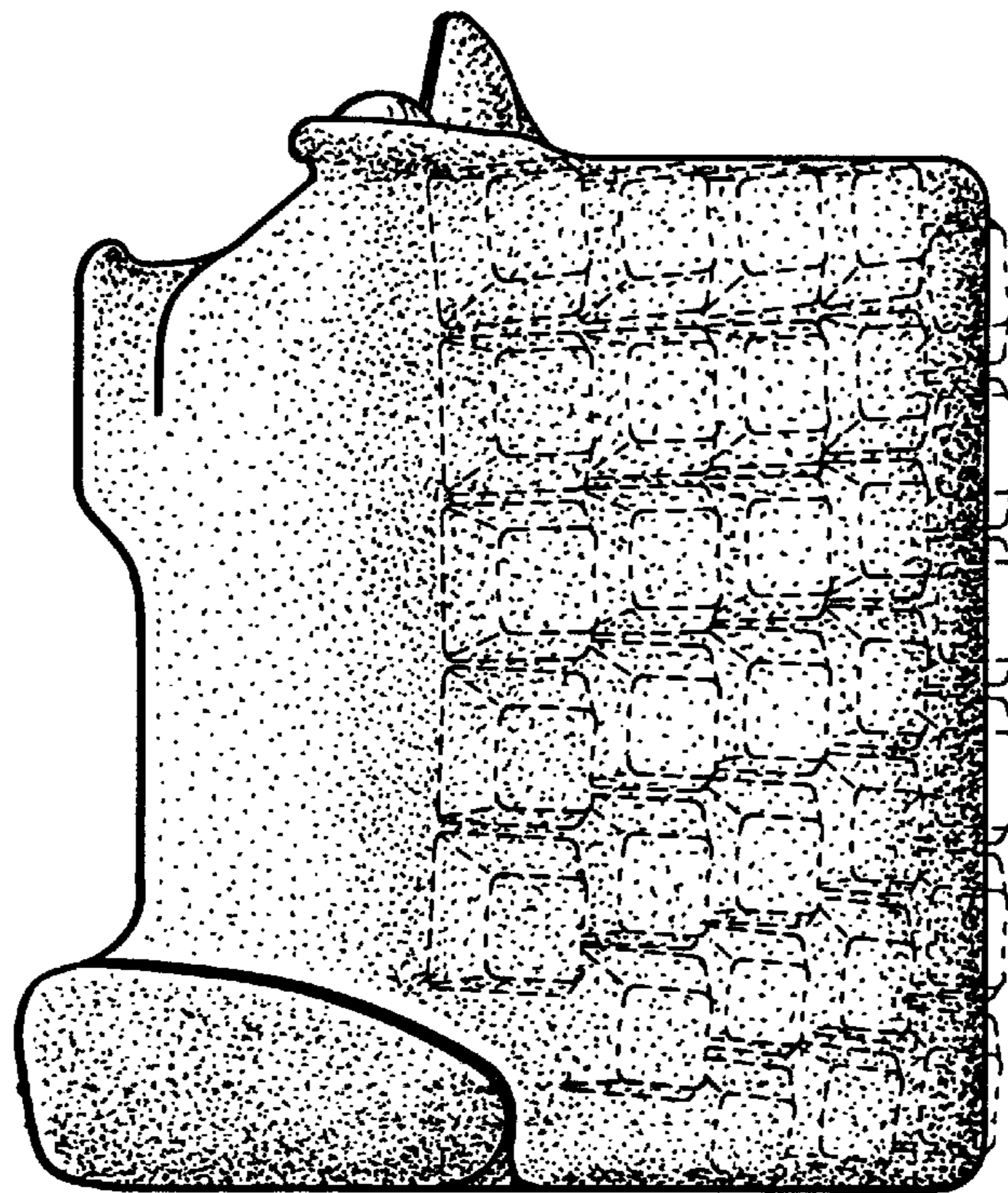

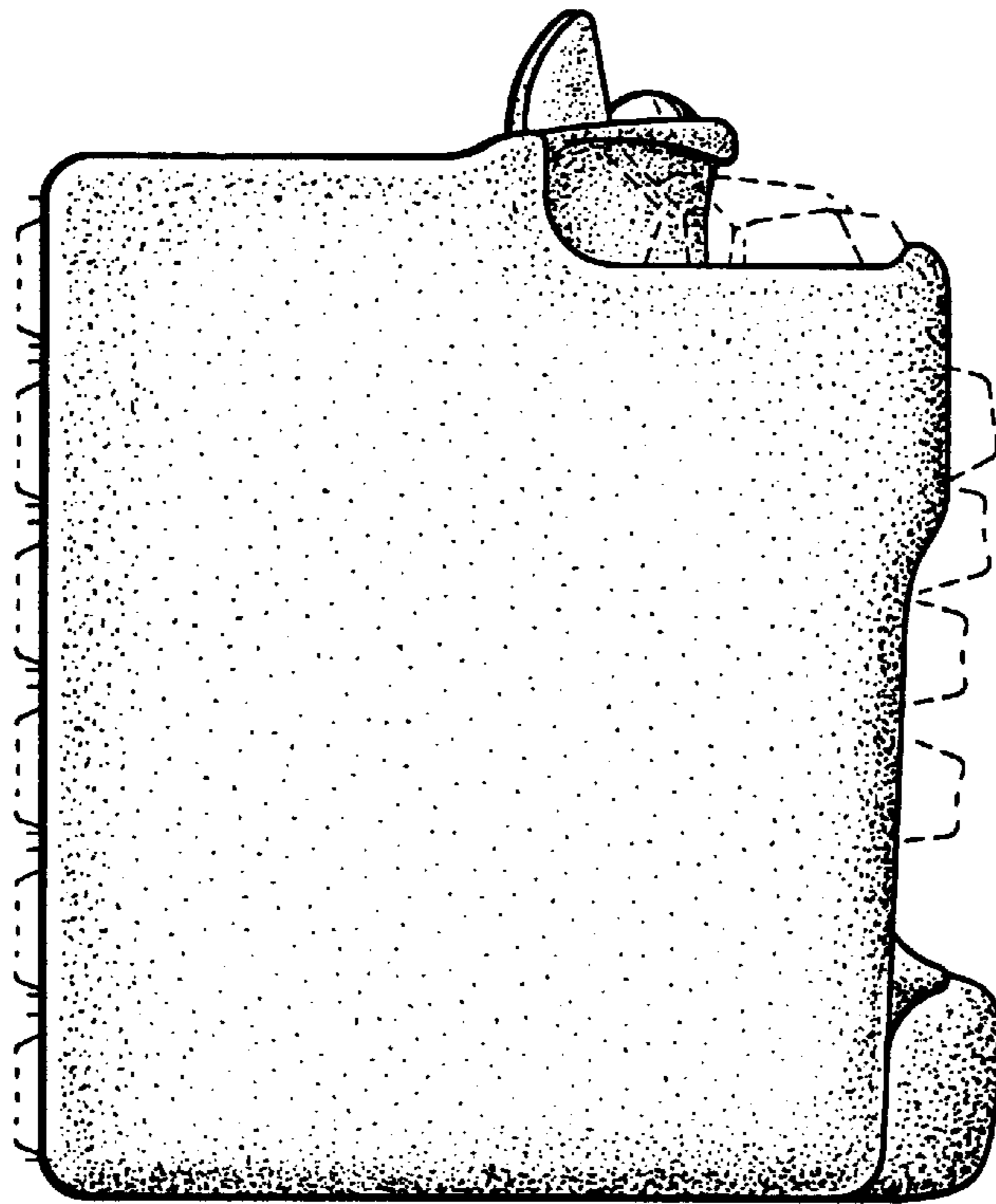

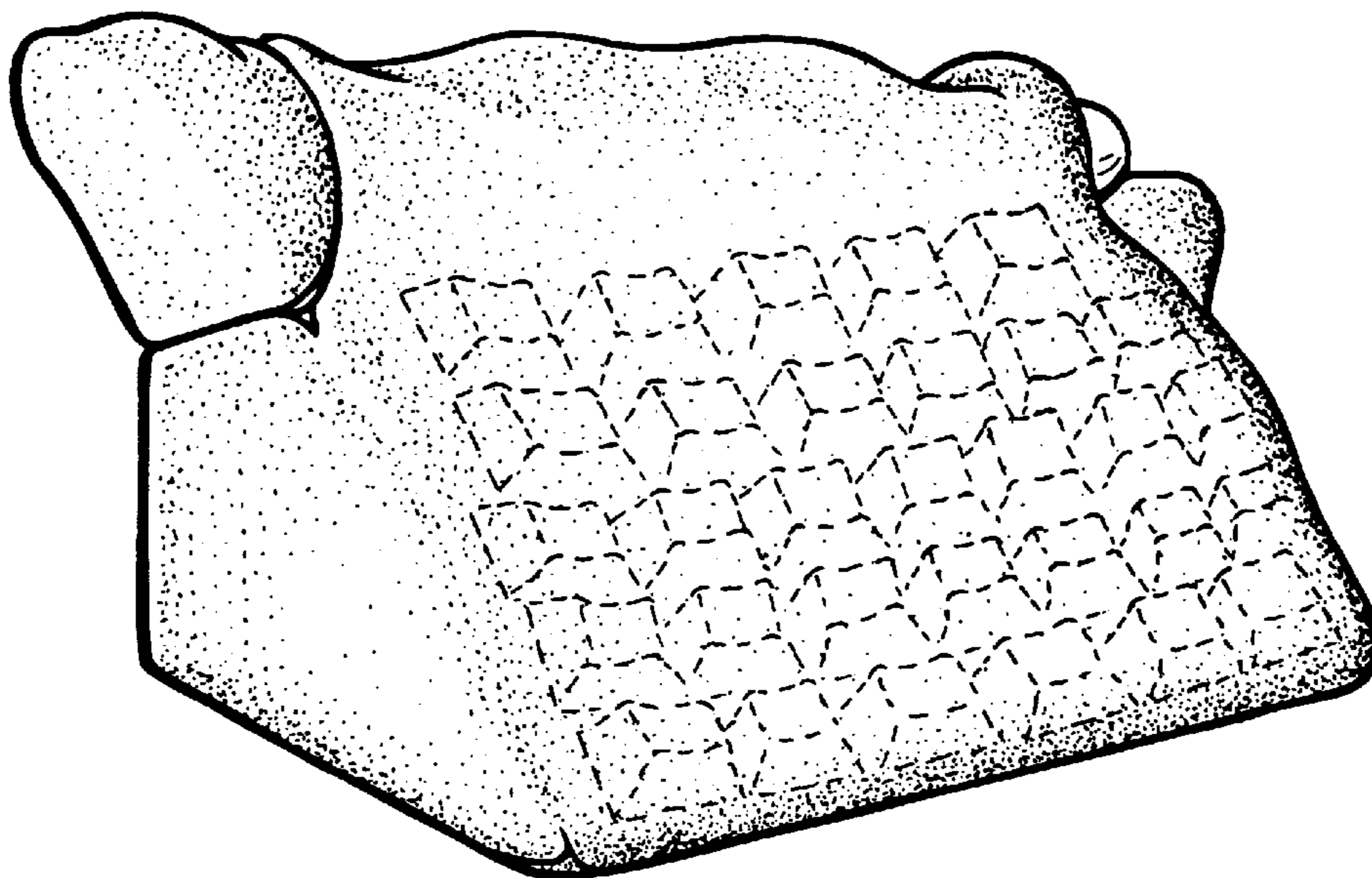
