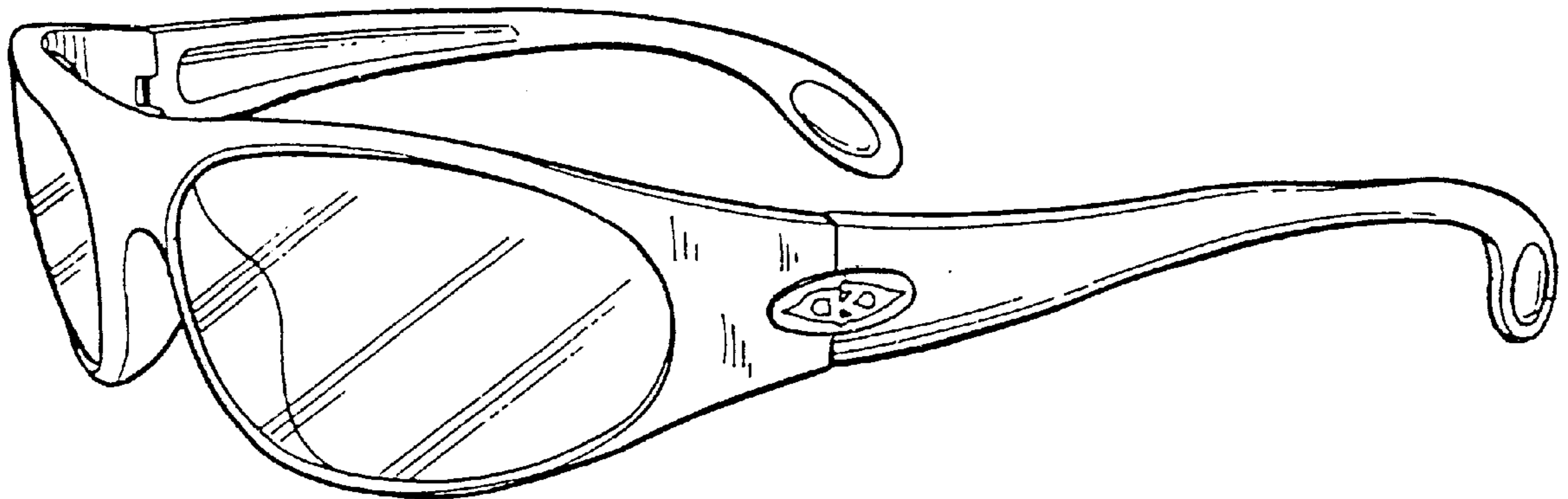
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective of eyewear showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a side elevational view thereof;
FIG. 5 is a side elevational view opposite that of FIG. 4;

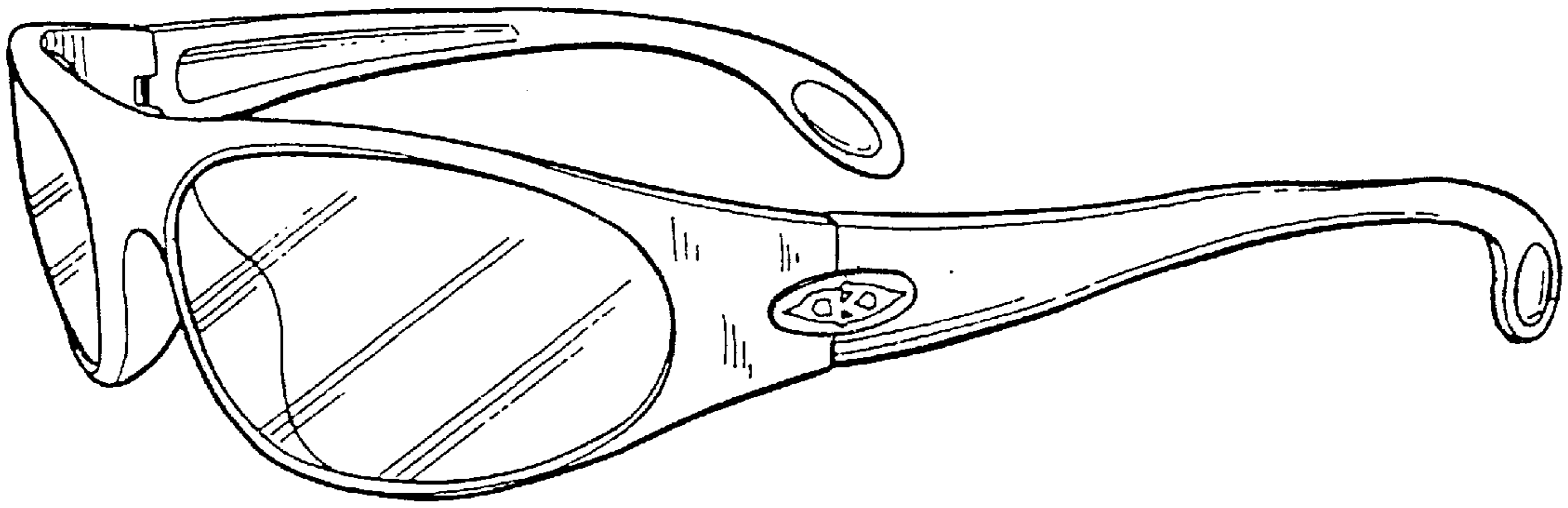

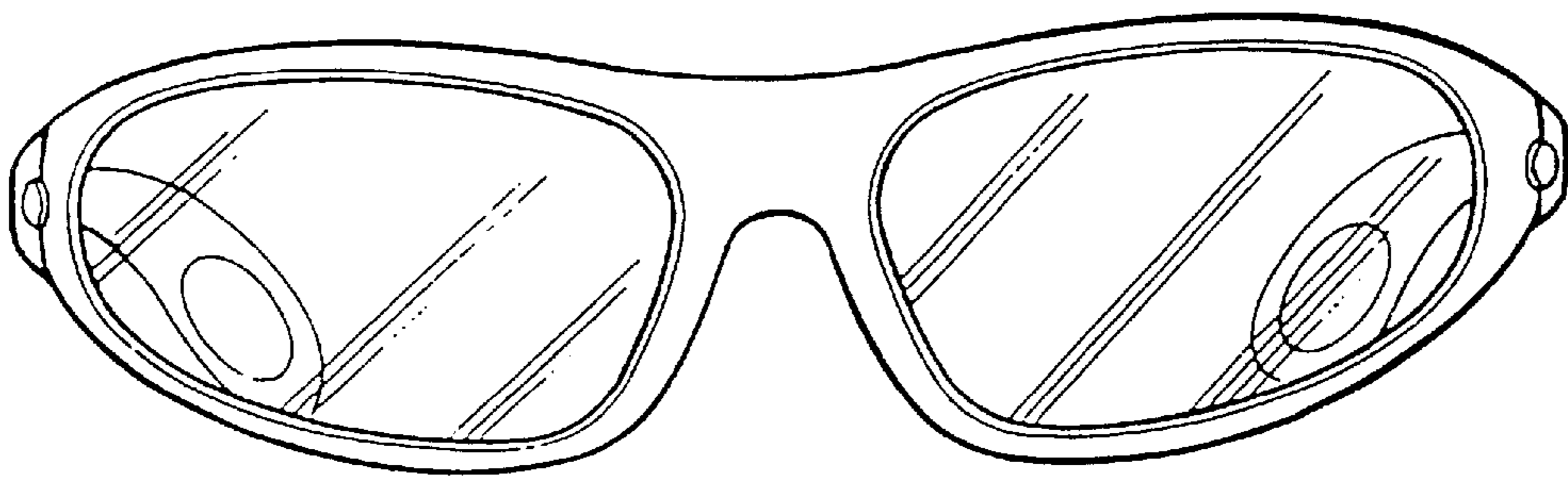

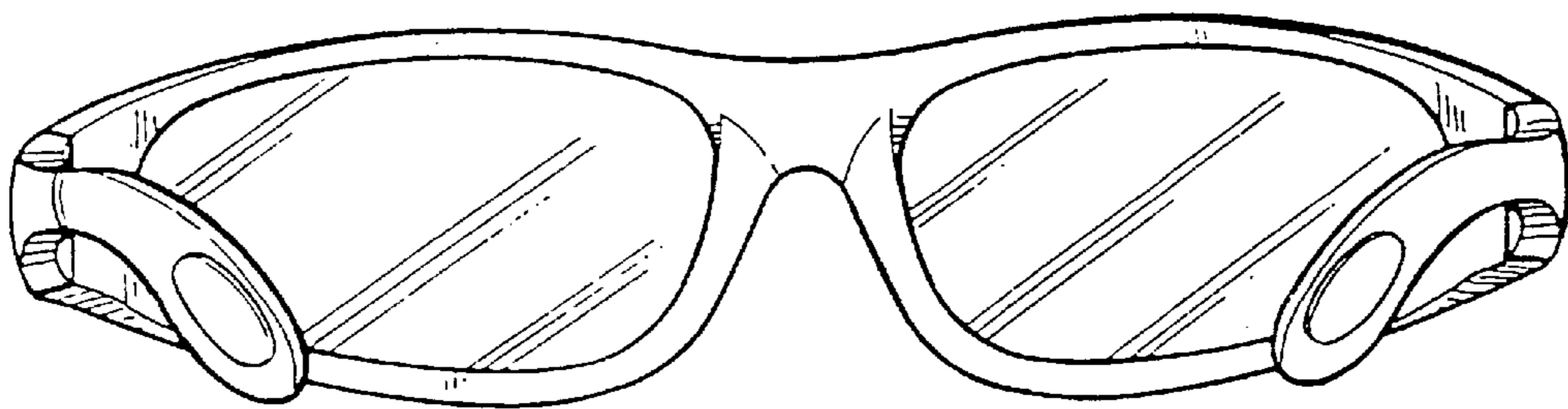

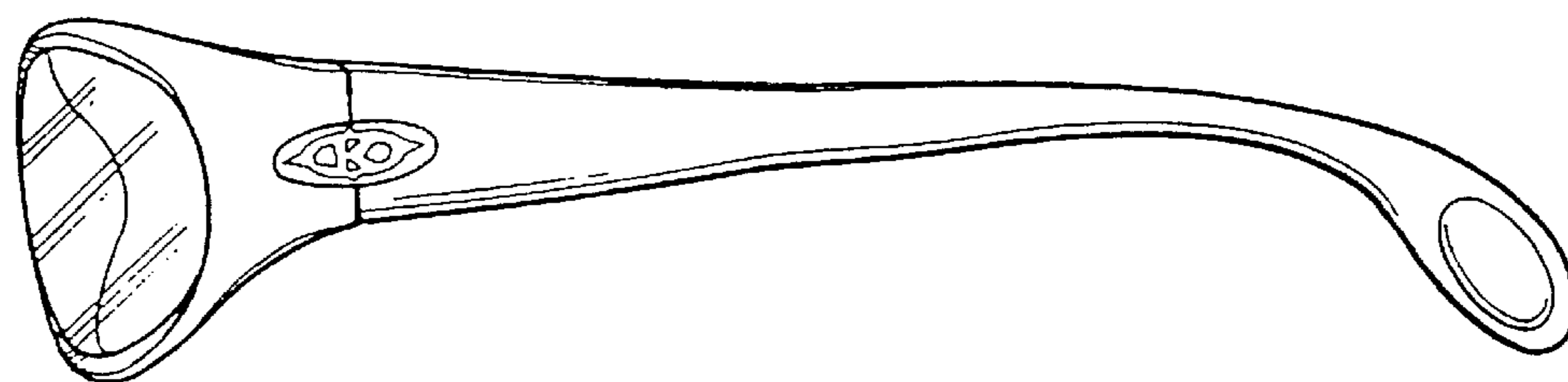

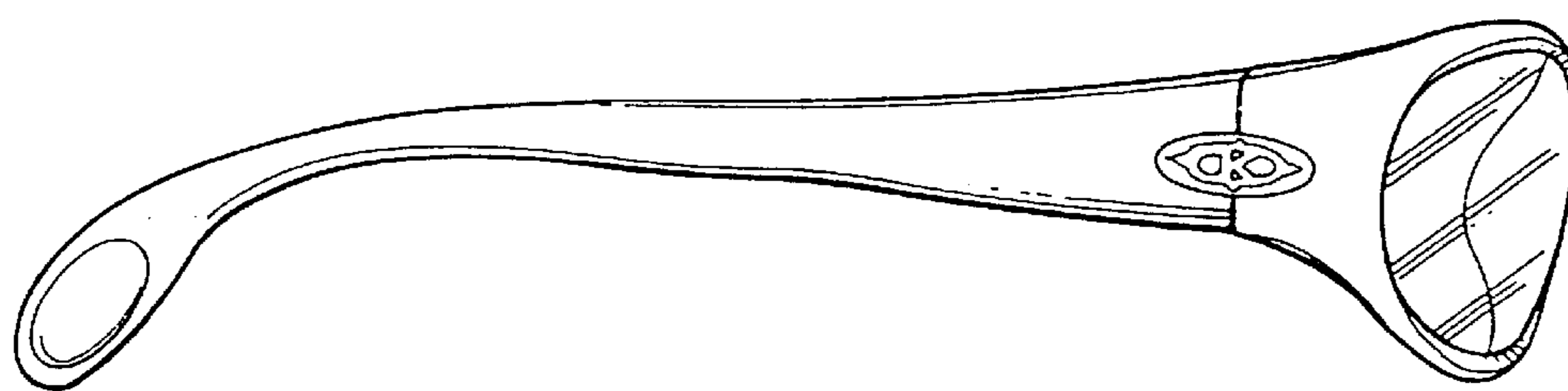

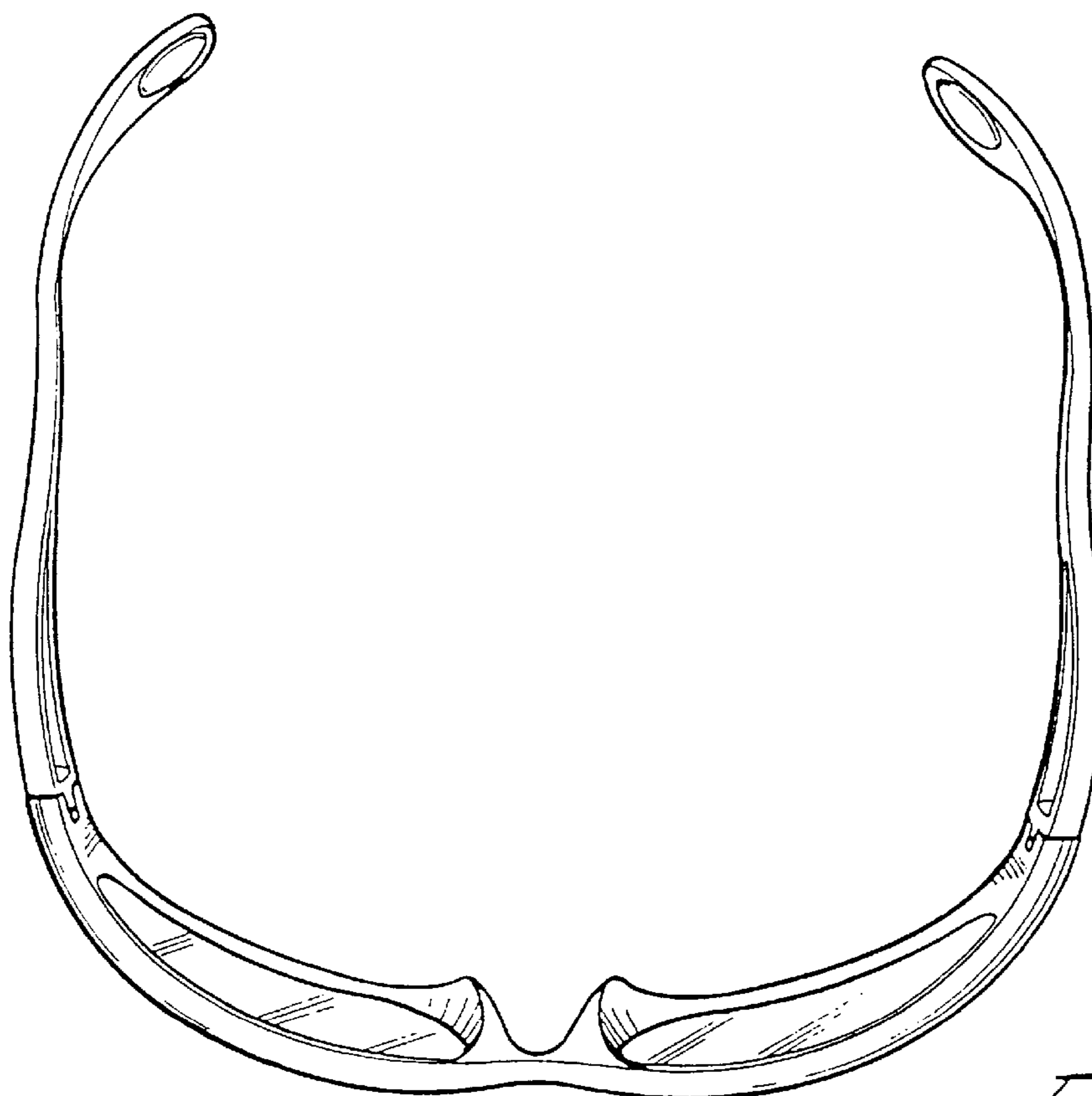

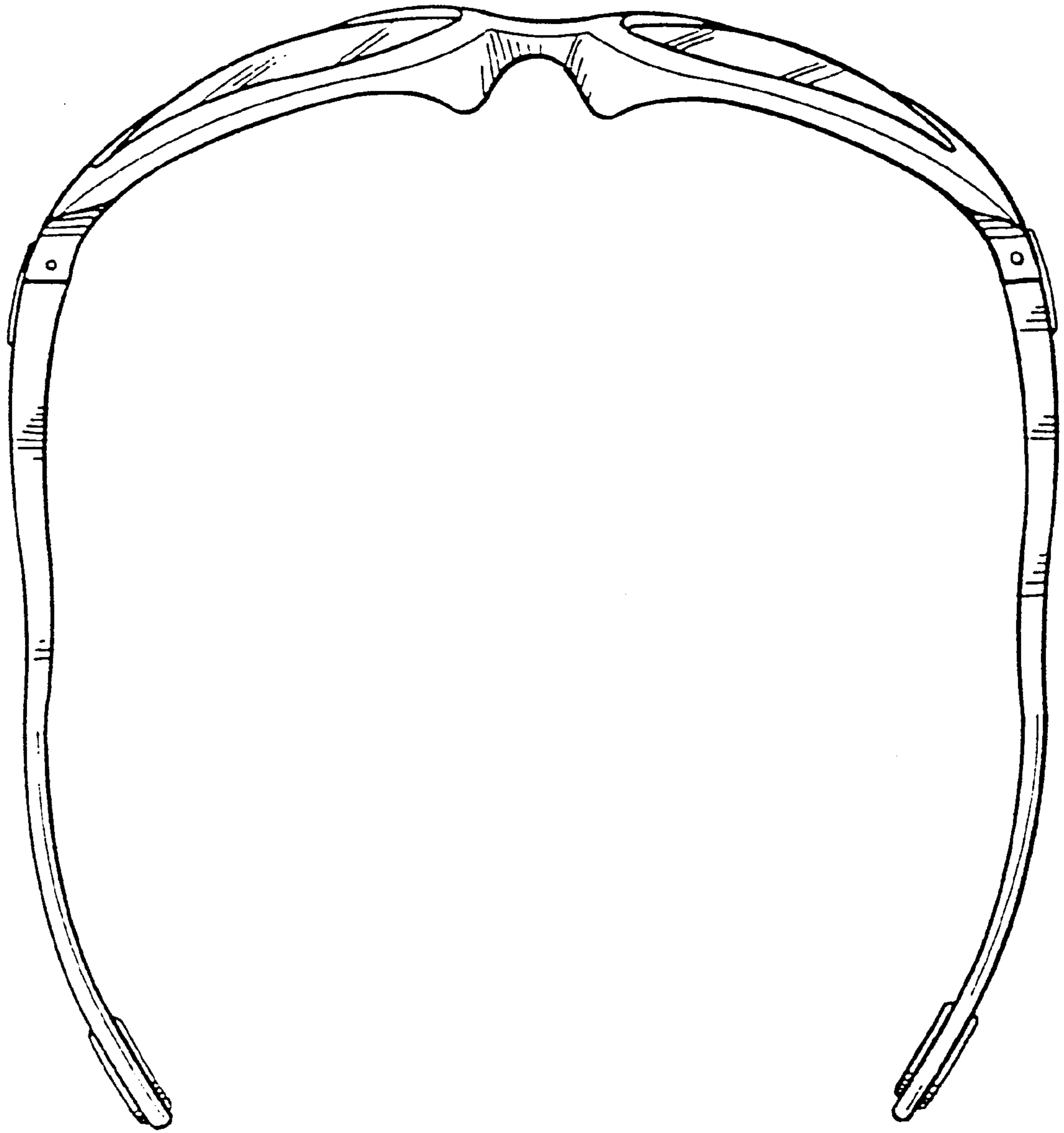
