## DESCRIPTION

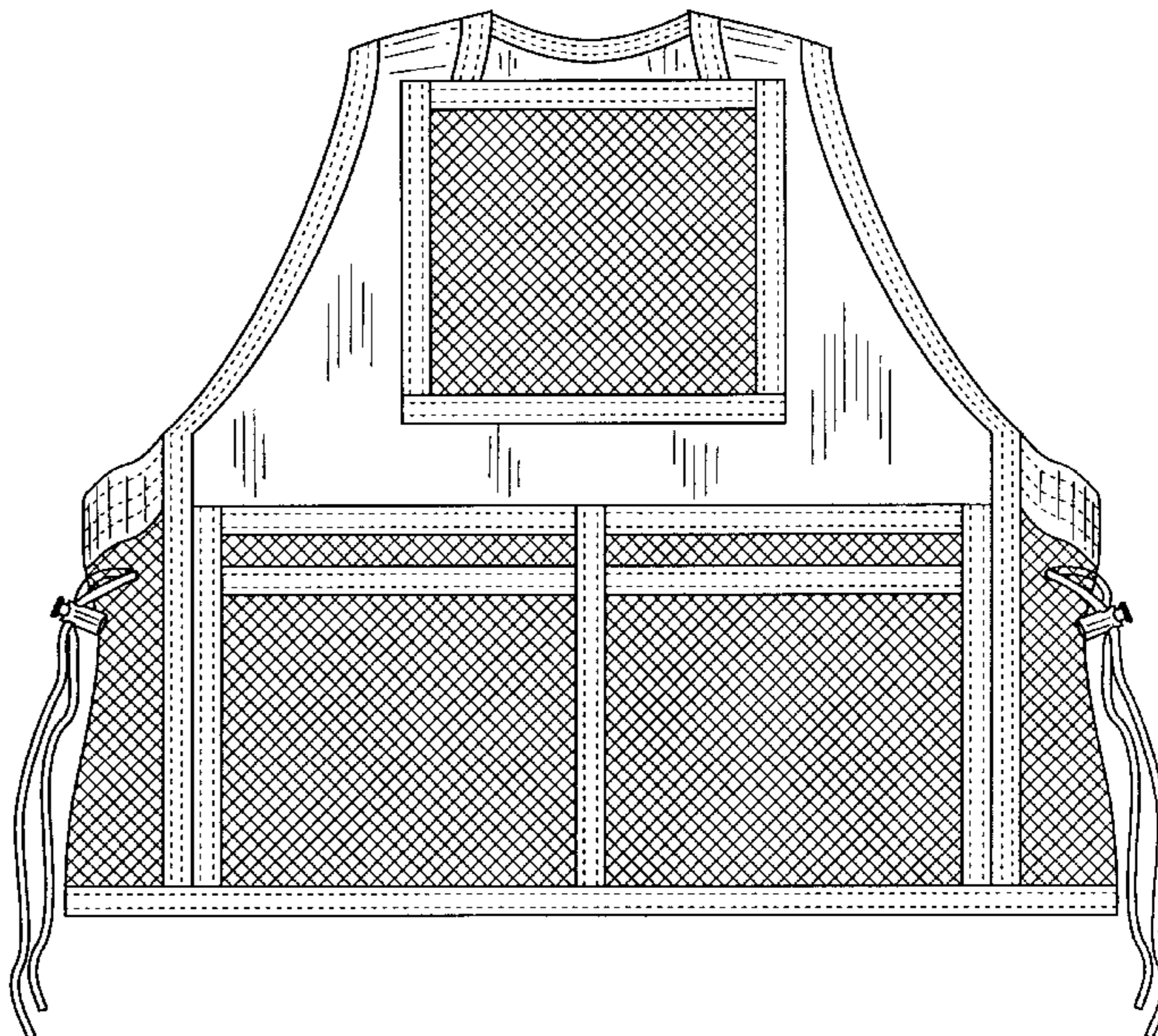
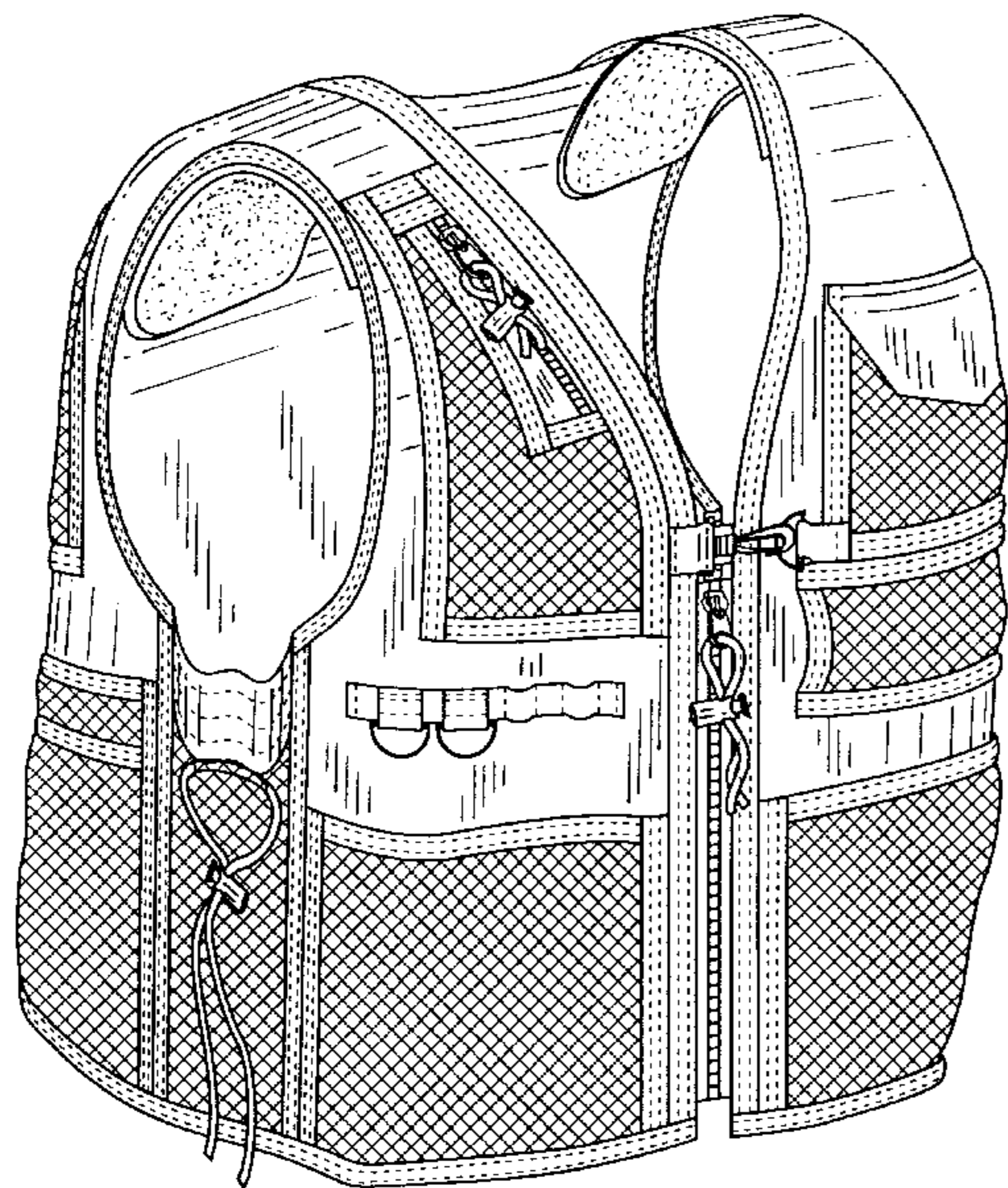
FIG. 1 is a perspective view of a see-through vest for school supplies showing our new design;

The broken lines shown throughout the views are understood to represent stitching.

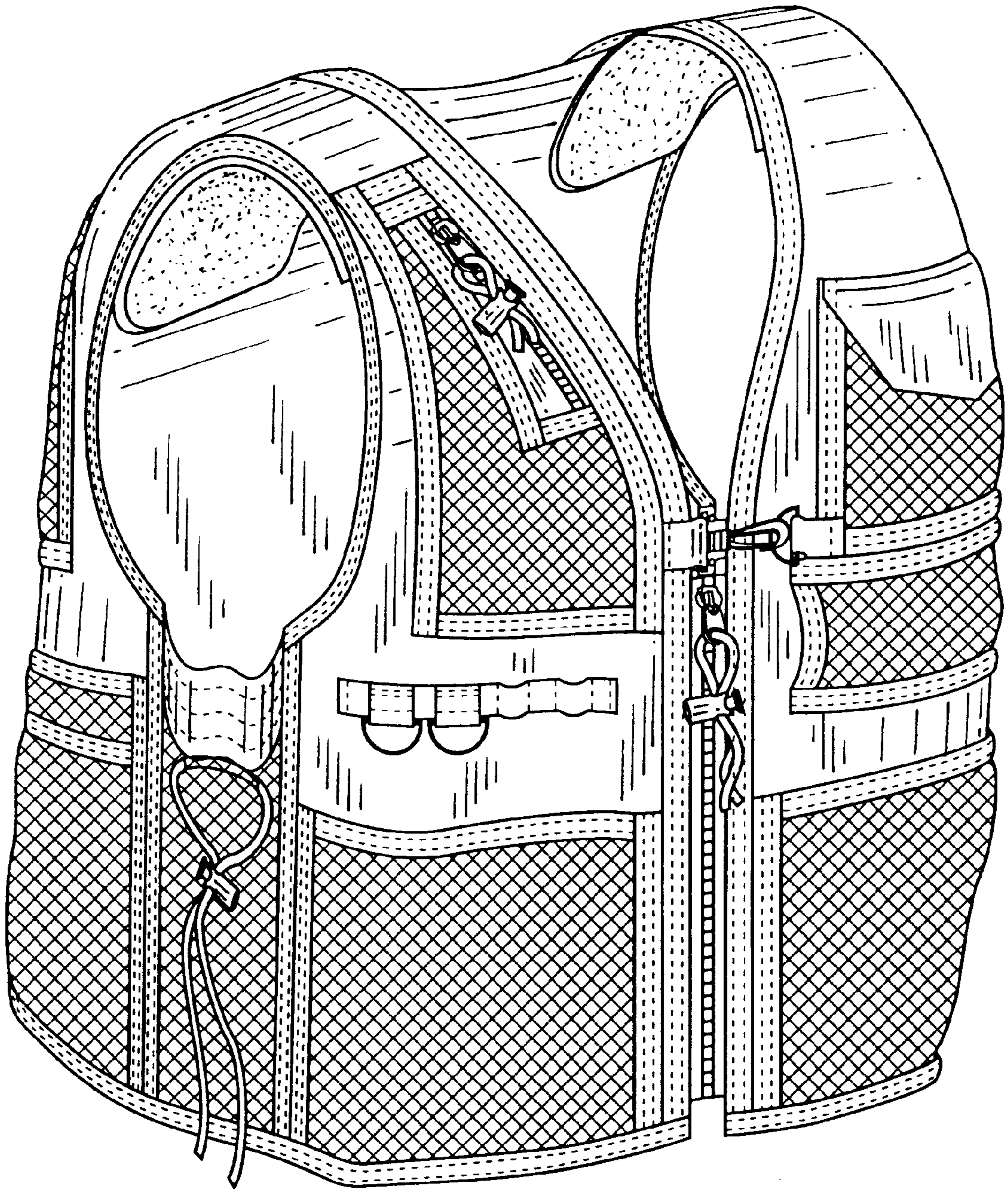

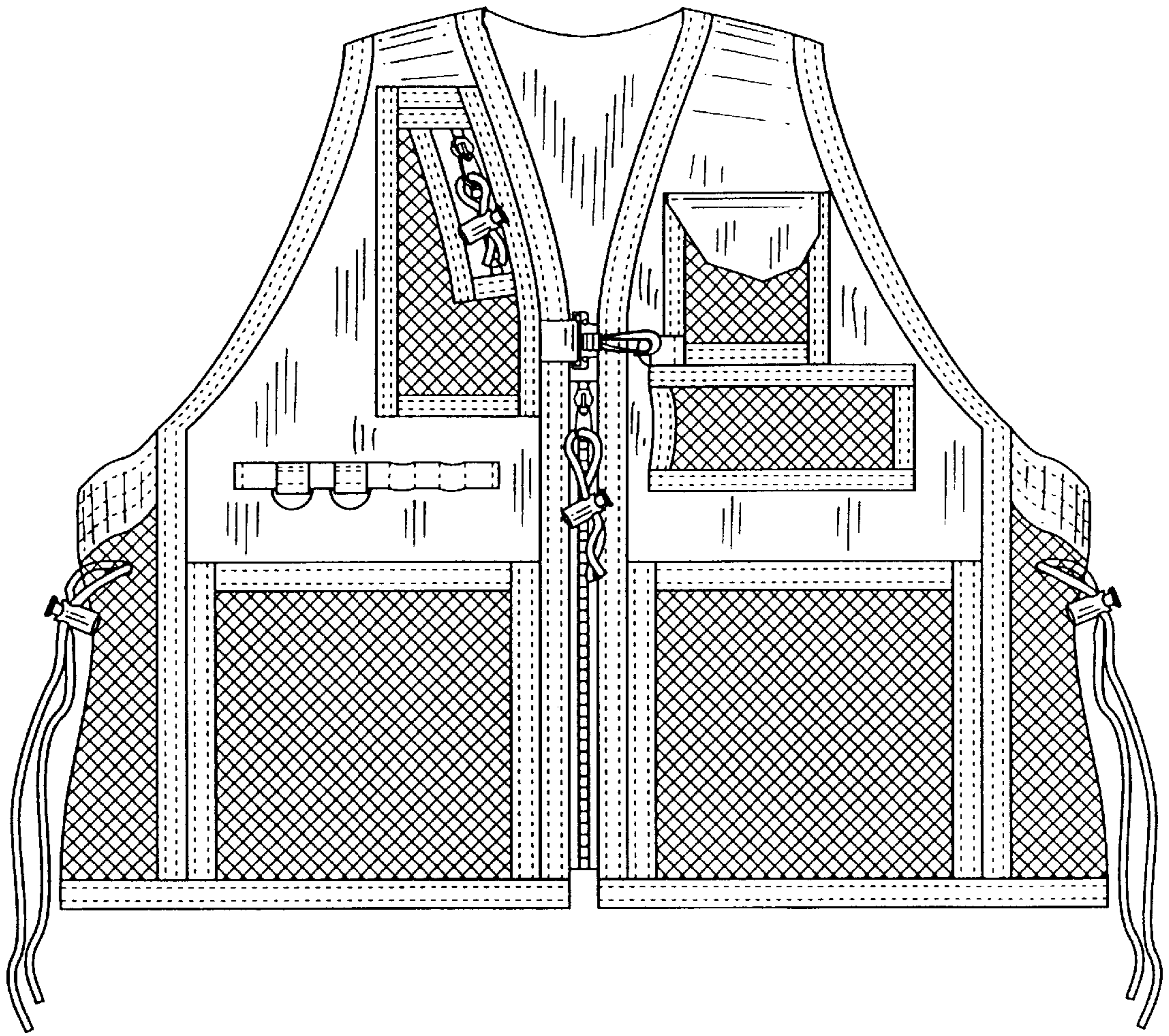

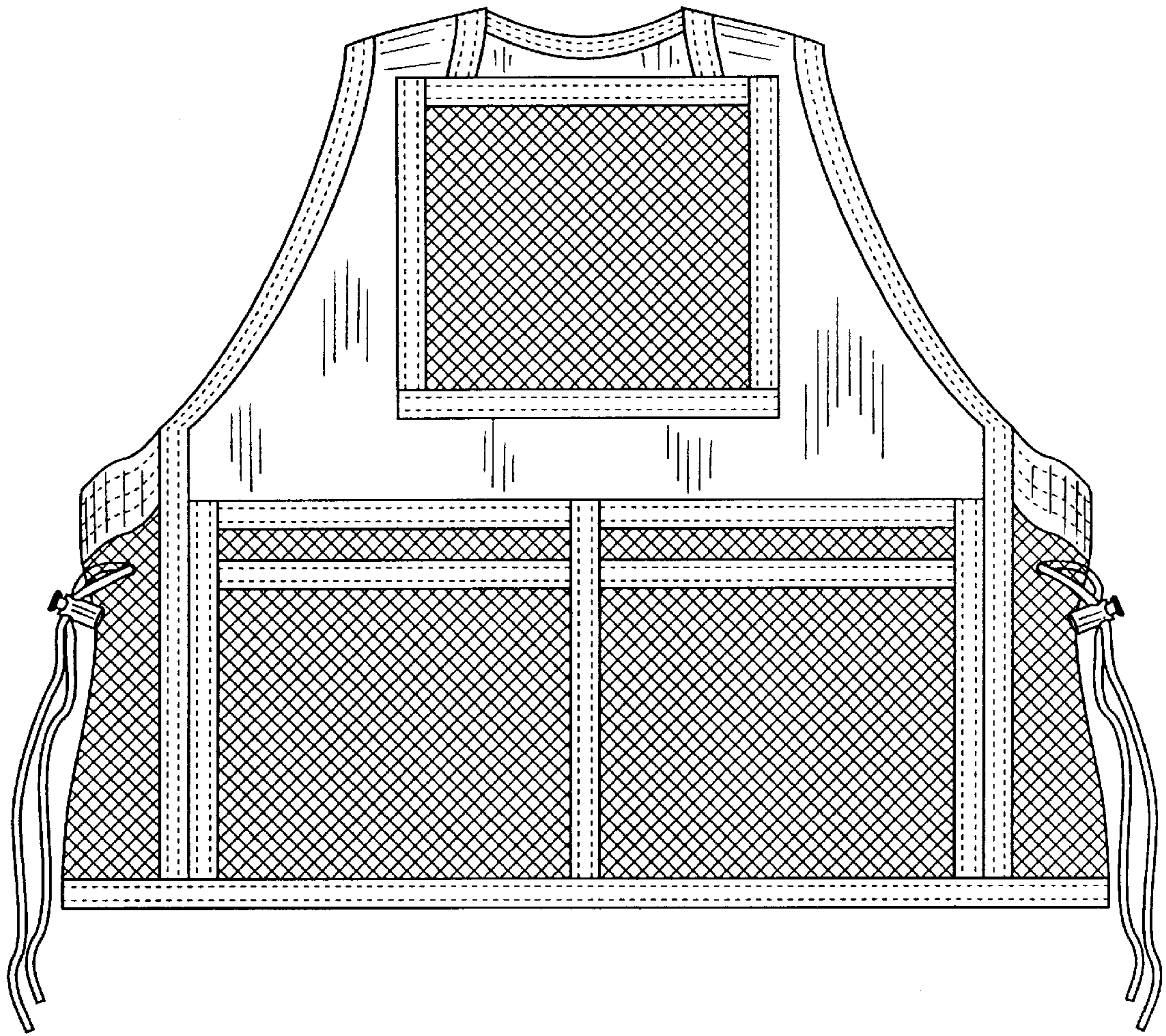




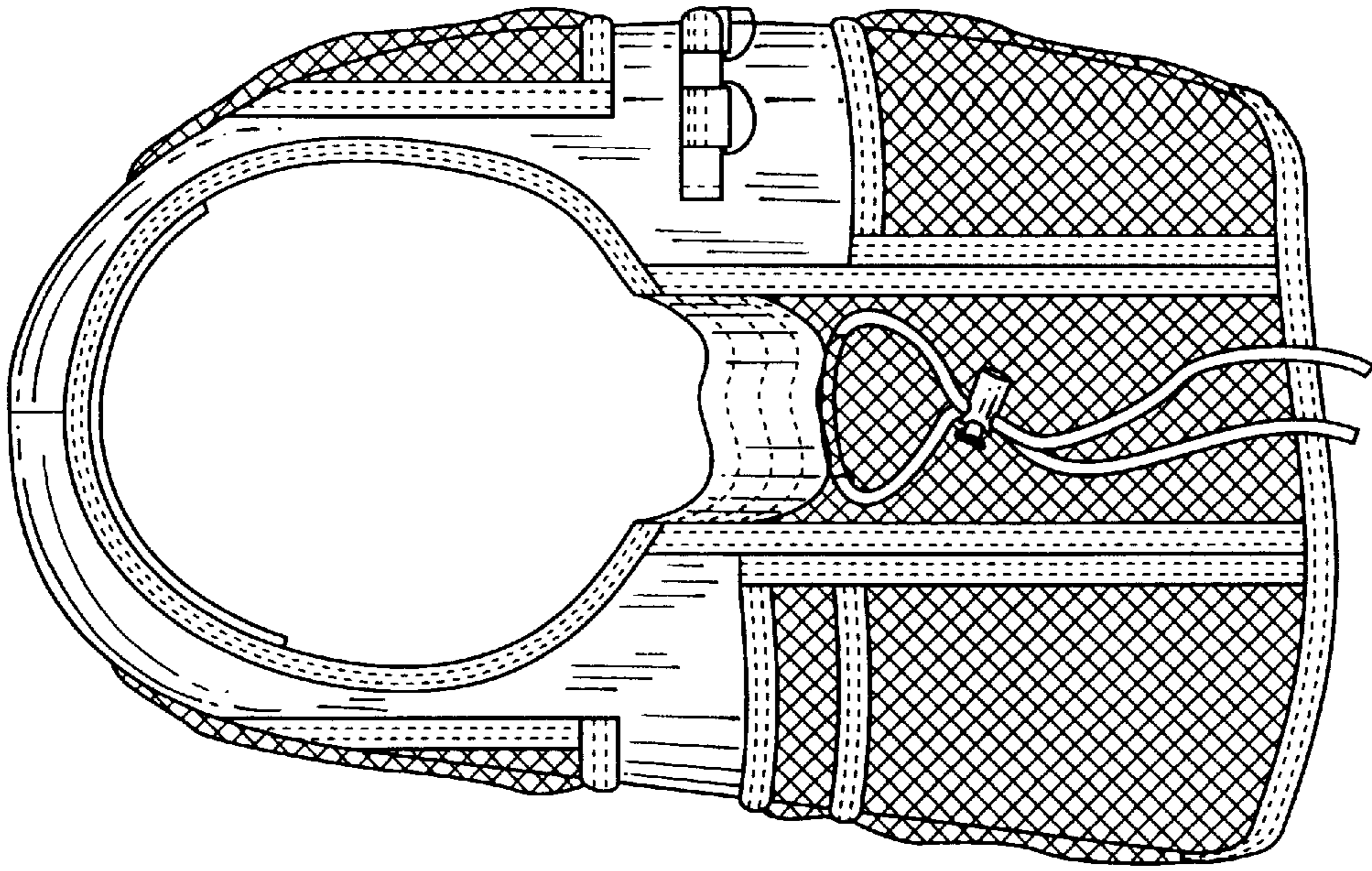

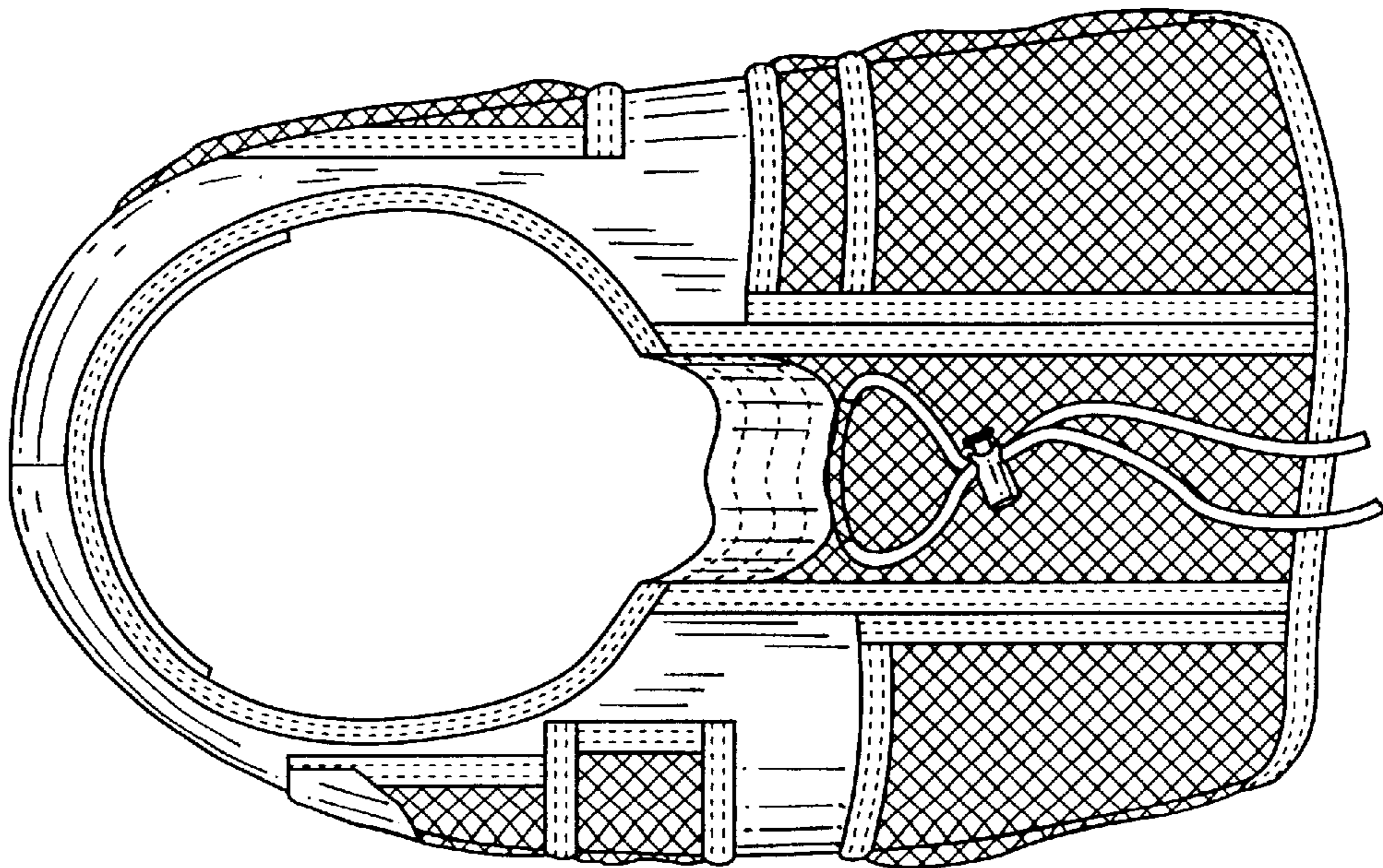

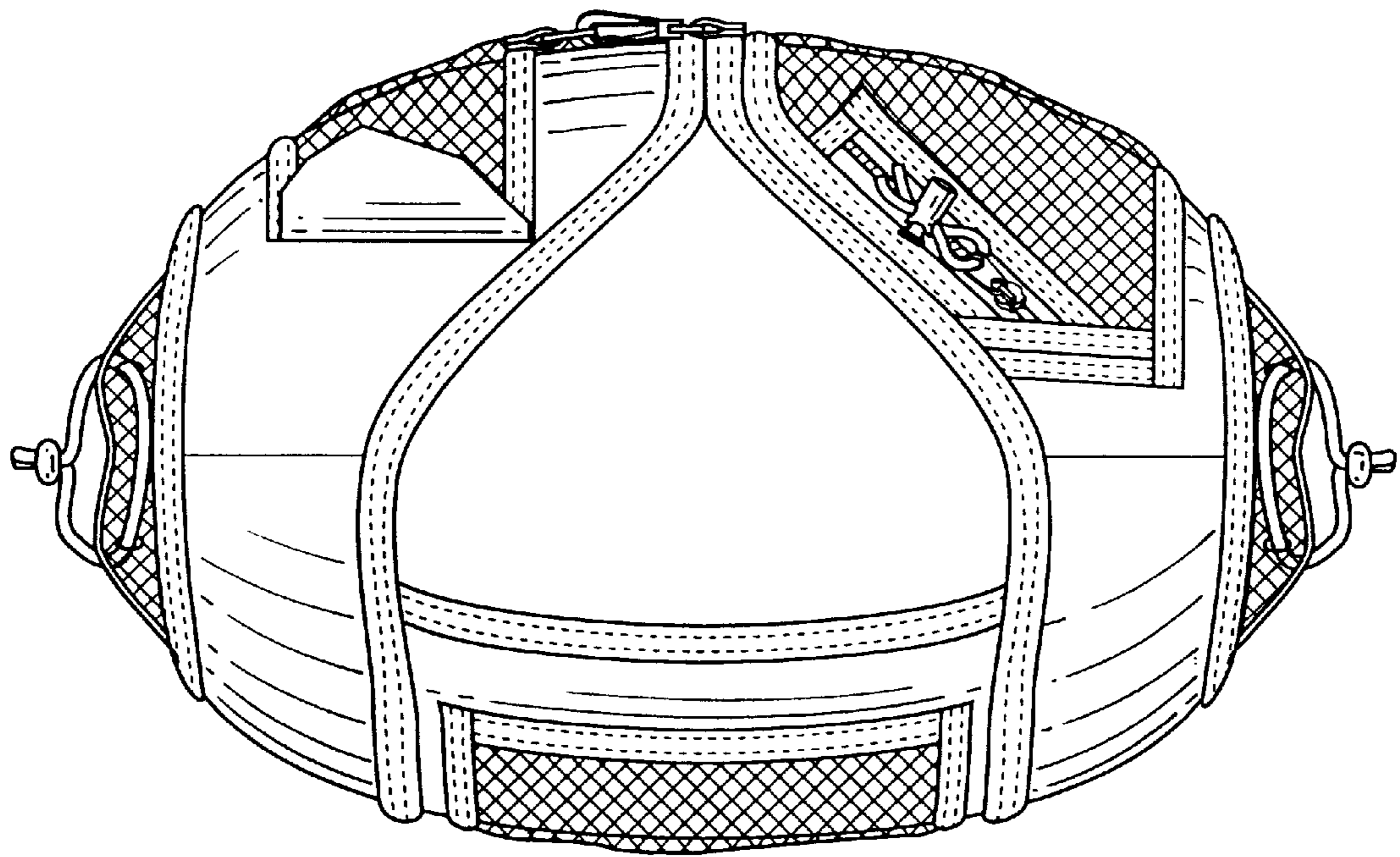

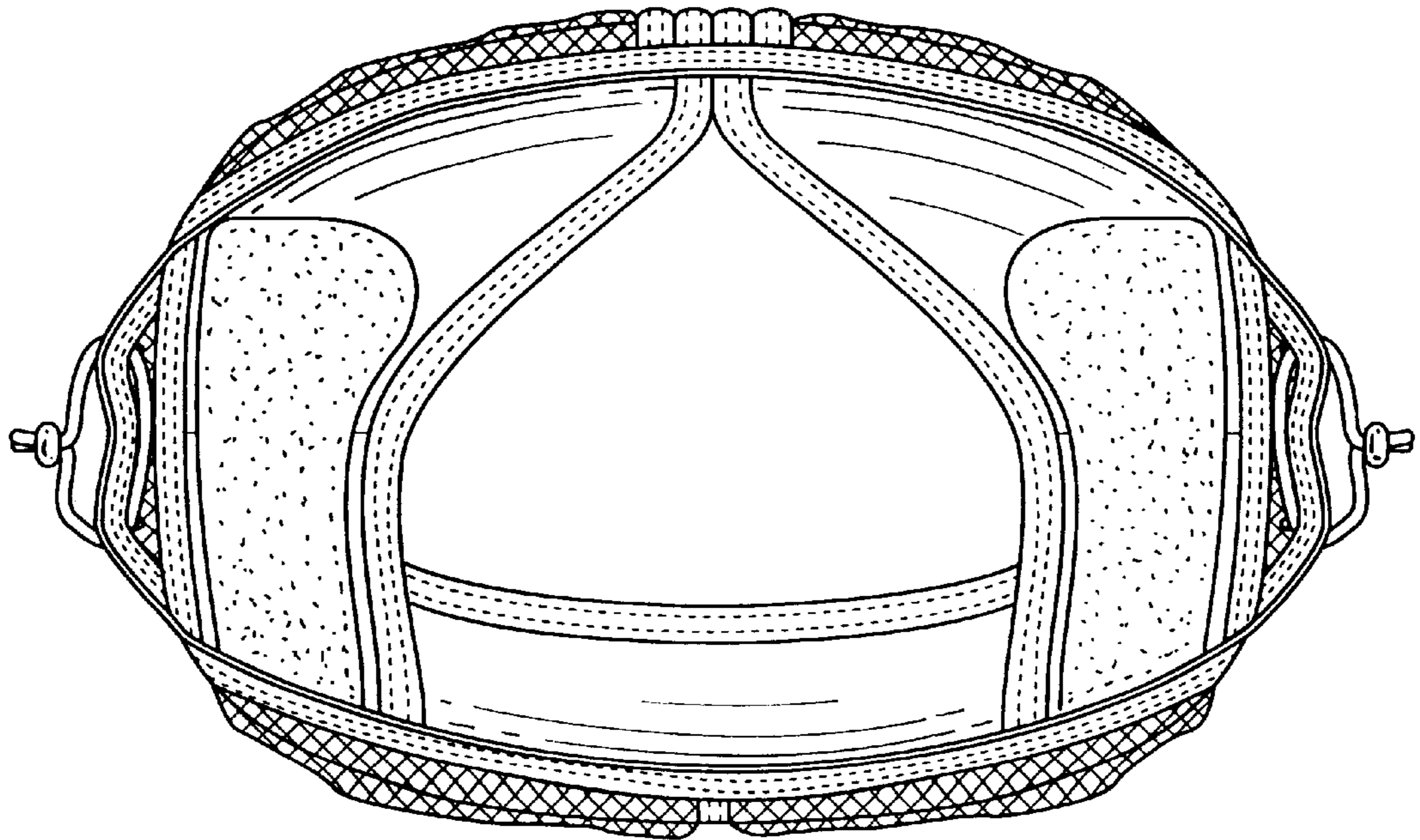
