[57] **CLAIM**

The ornamental design for a pair of football-style cowboy boots, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of pair of football-style cowboy boots showing my new design; and, FIG. 2 through 7 comprise a series of engineering views of the left boot of FIG. 1, the right boot being a mirror opposite thereof, wherein:

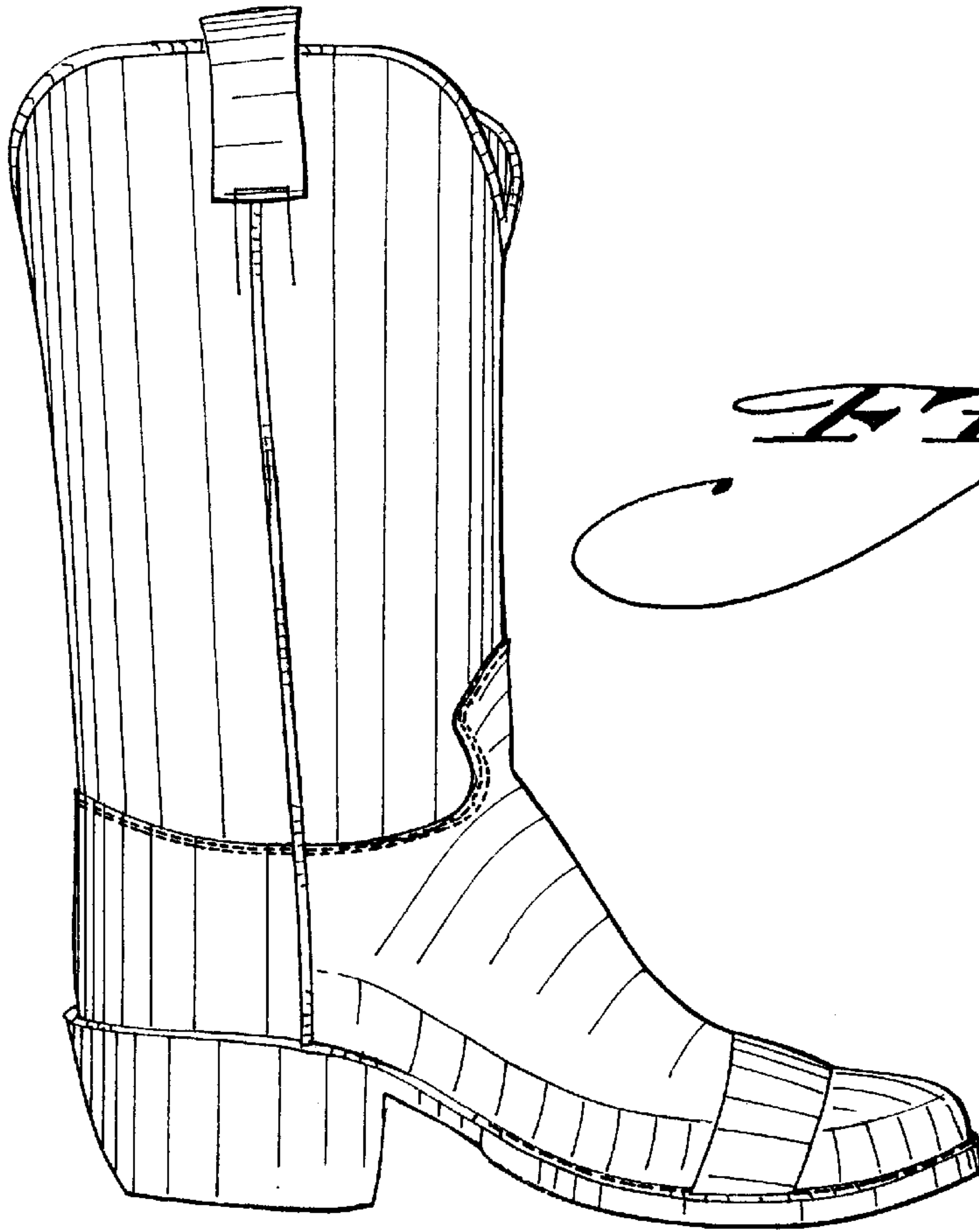

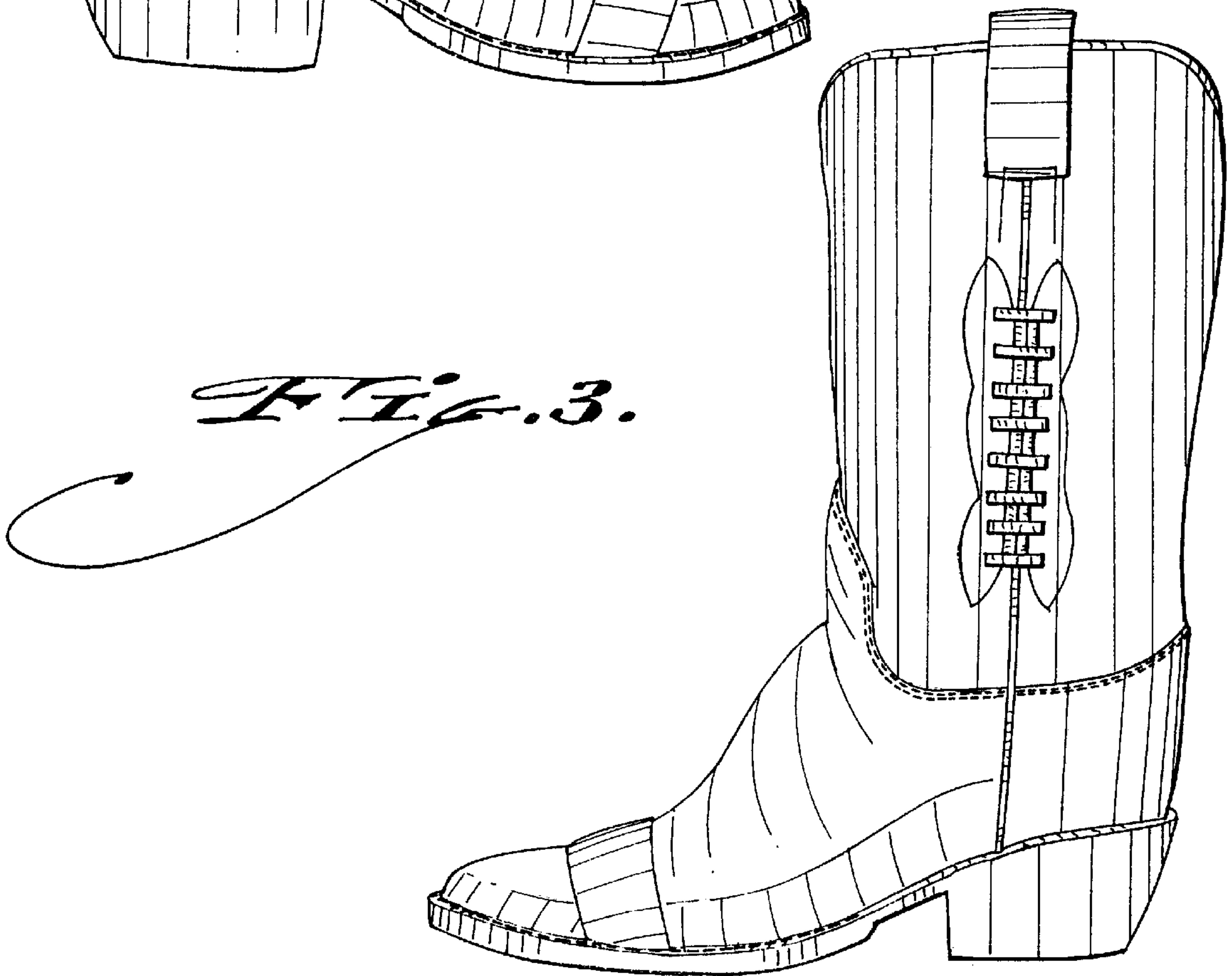

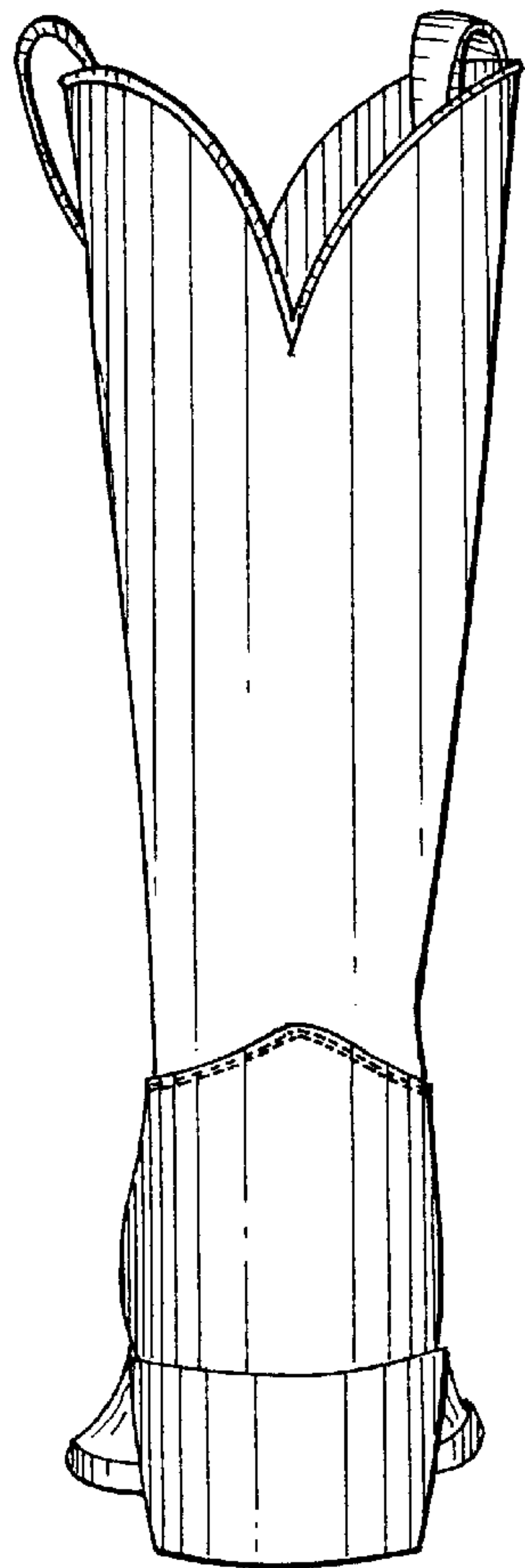
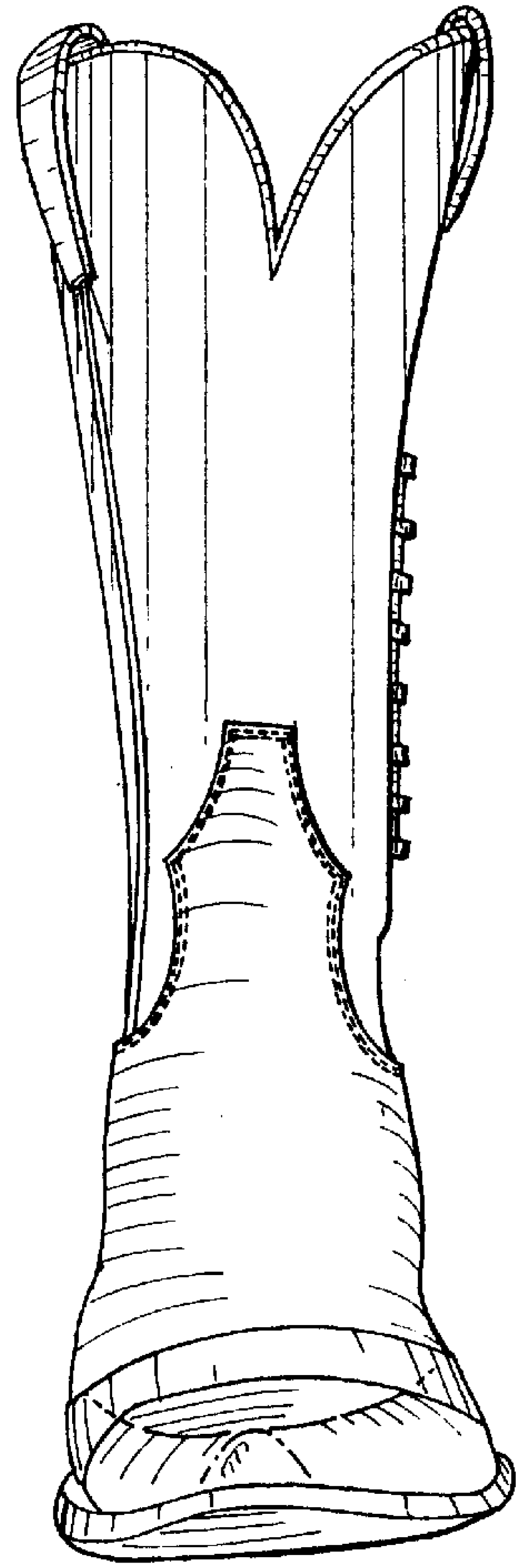

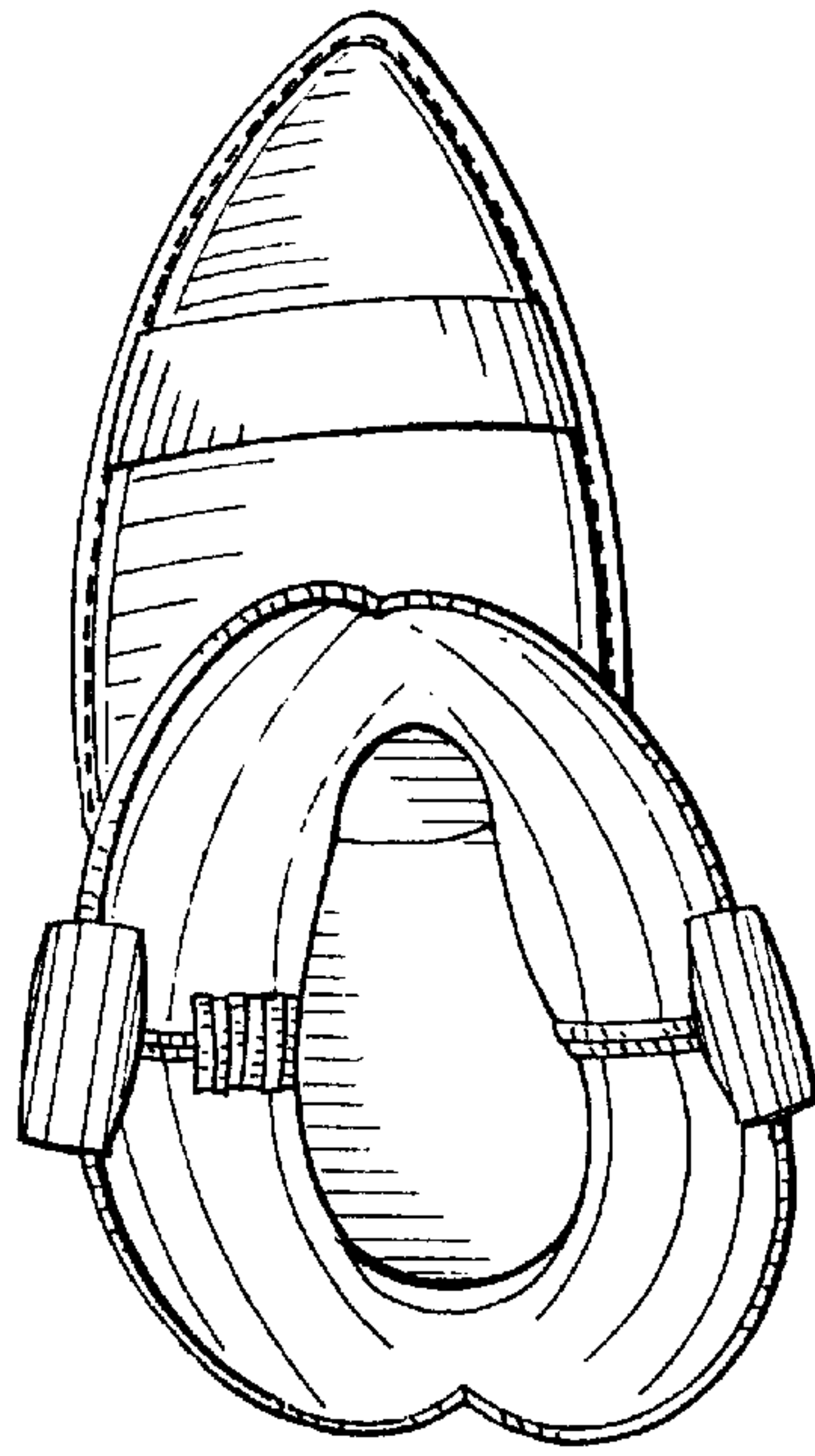

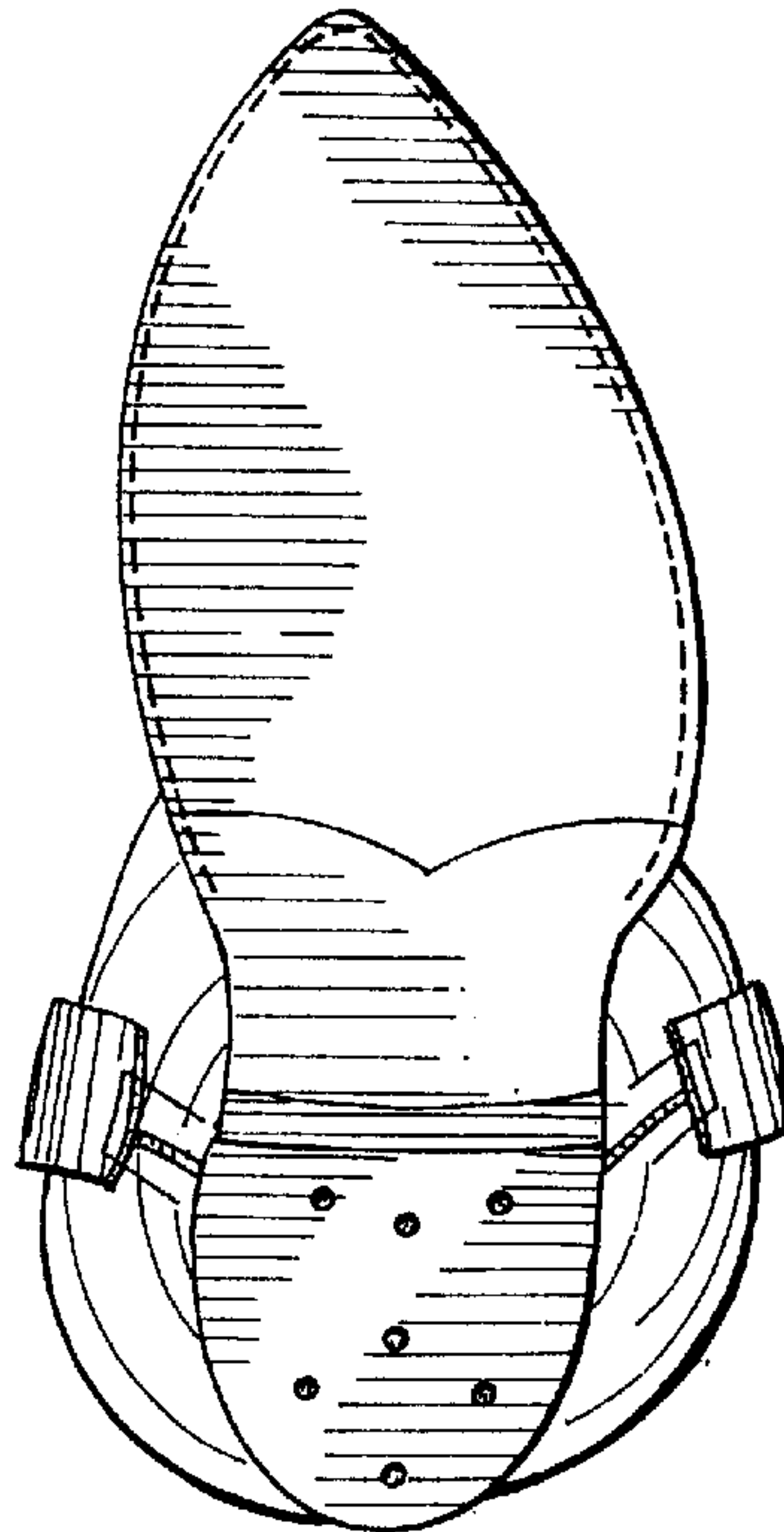
