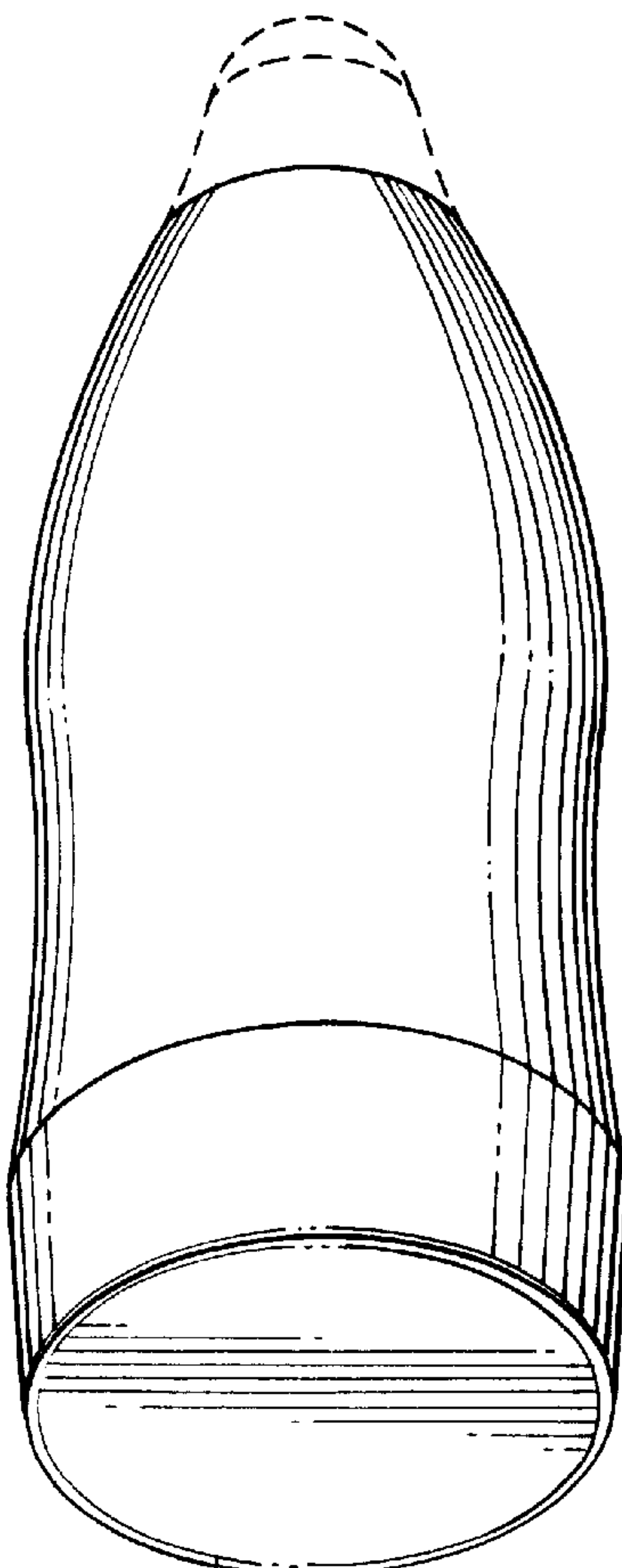
[57] **CLAIM**

The ornamental design for a combined bottle and lens case, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the lens case portion of a combined bottle and lens case, showing our new design; FIG. 2 is a side elevational view thereof, with sides, front and back being identical; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a top plan view. The broken line showing of environment in FIGS. 1 and 2 is for illustrative purposes only and forms no part of the claimed design.

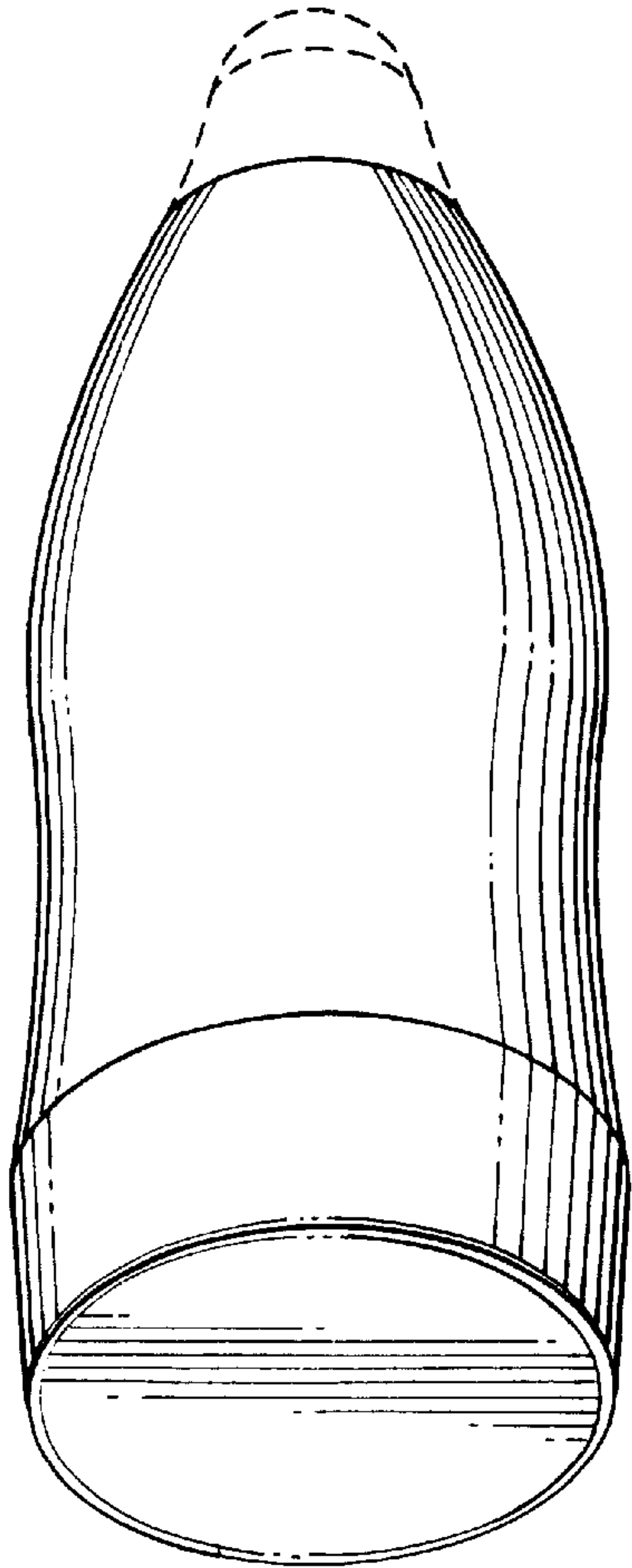

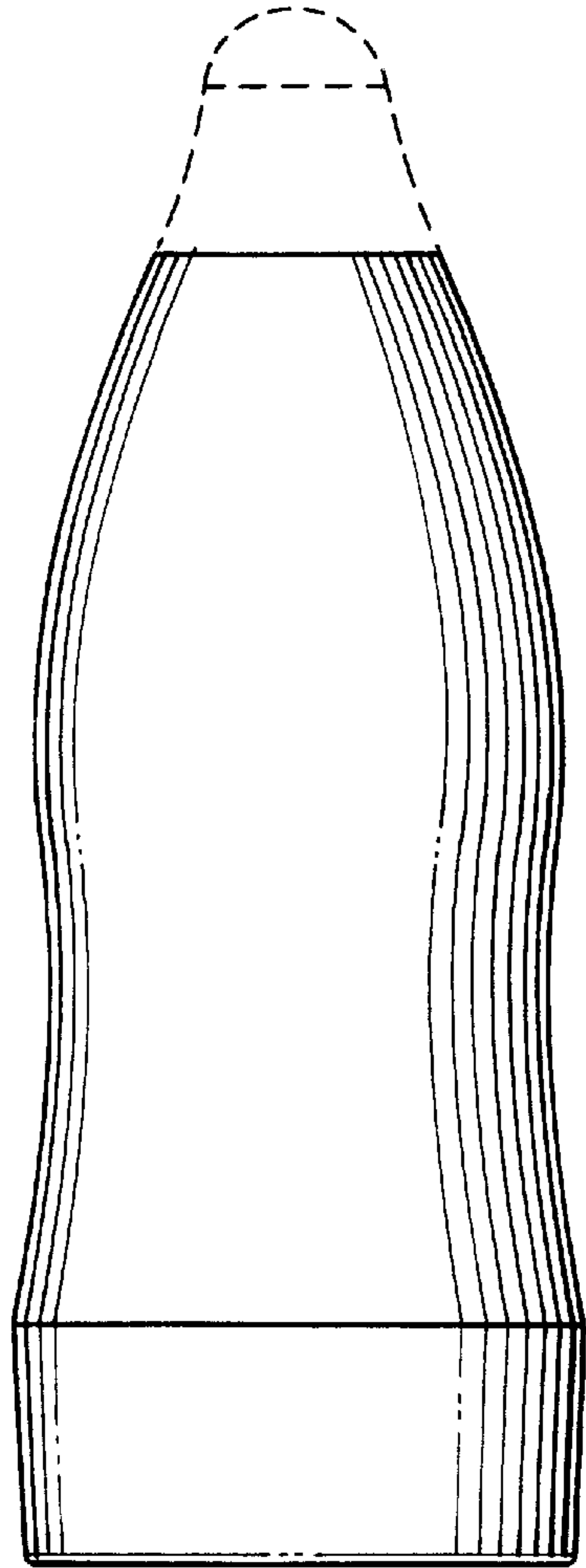

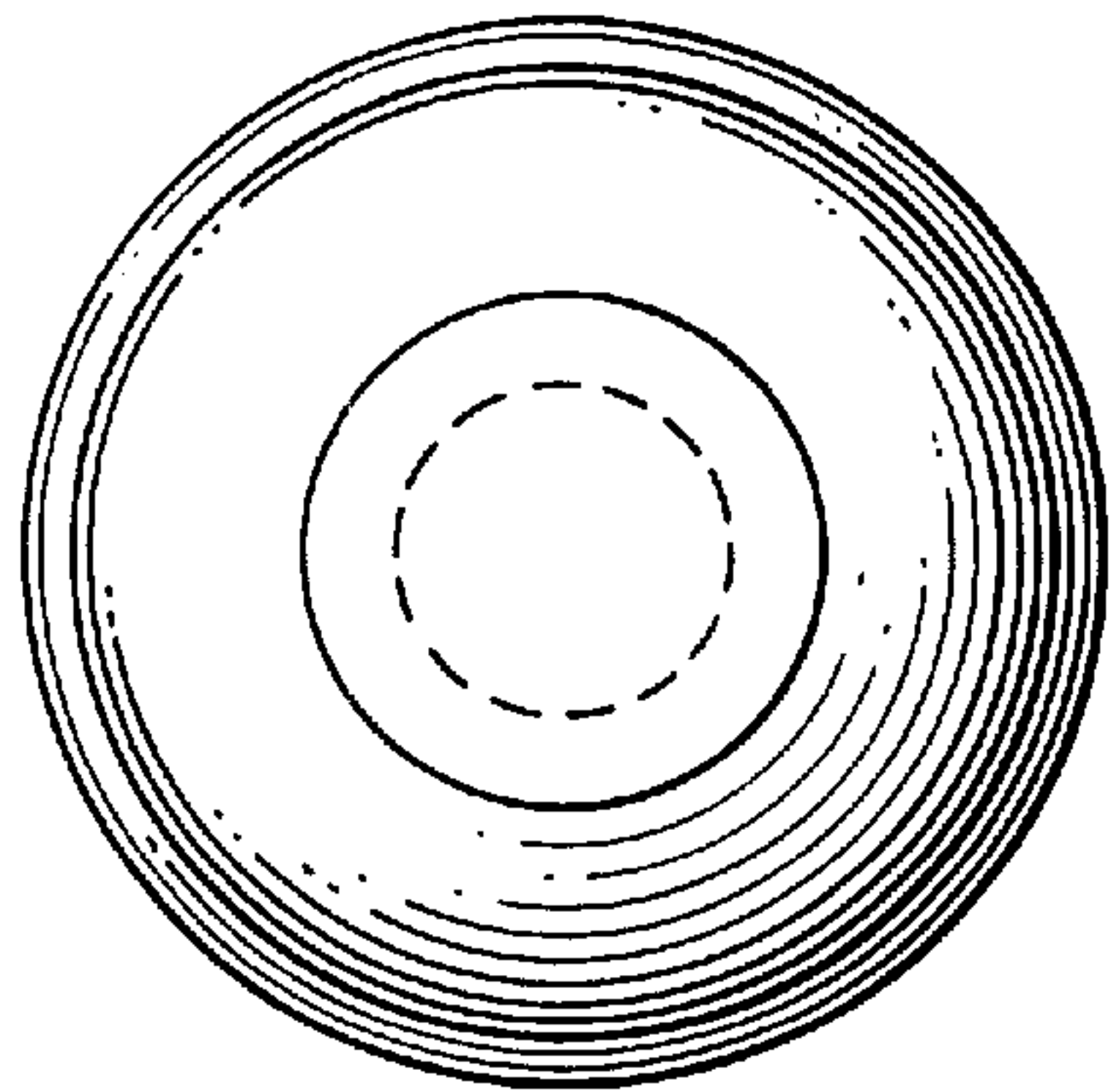

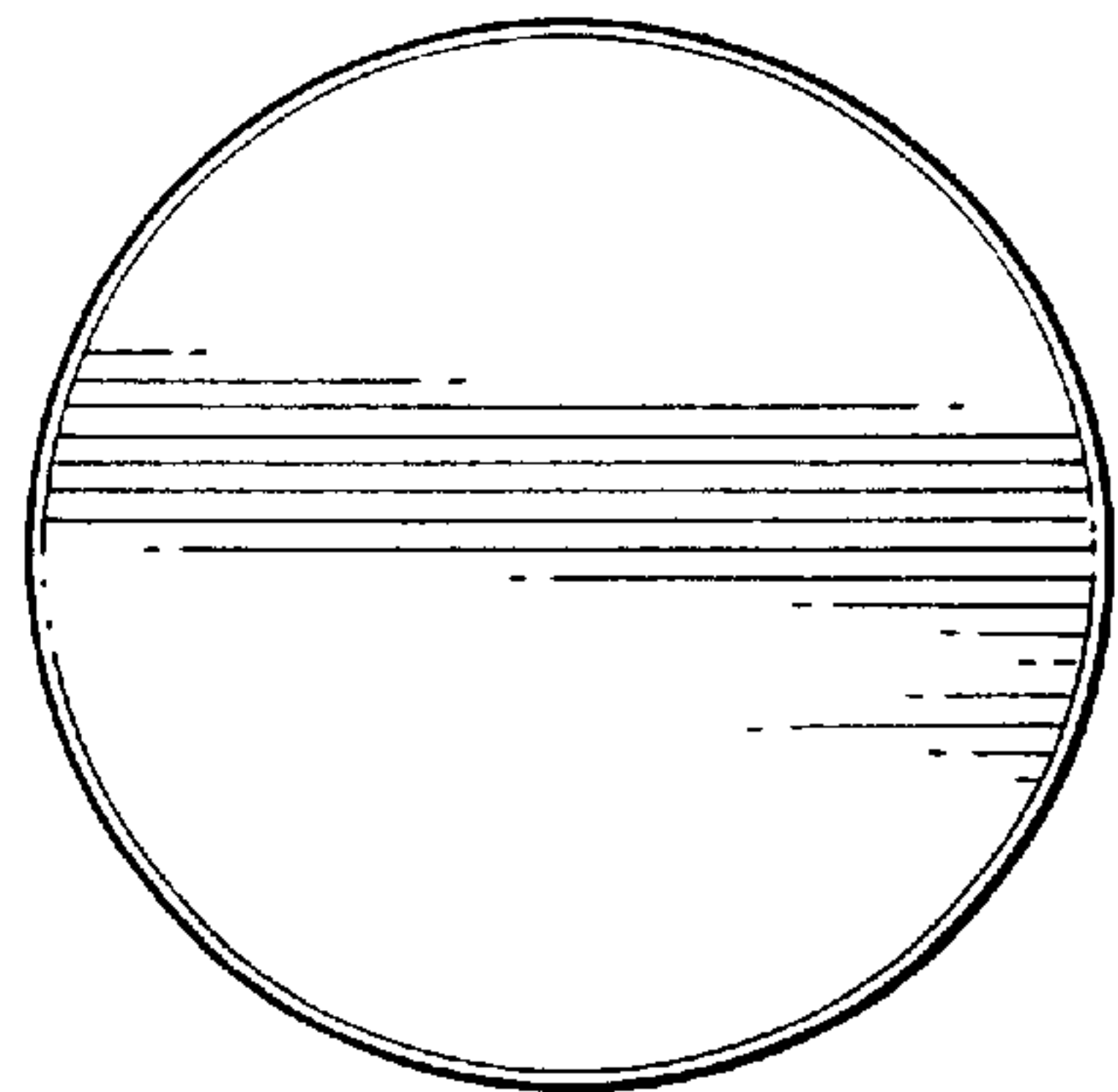
