[57] **CLAIM**

The ornamental design for a carrying case, as shown and described.

FIG. 1 is a perspective view of a carrying case, showing my new design, wherein the flap is shown in its unzipped open position;
FIG. 2 is a perspective view of the carrying case illustrated in FIG. 1, with the zippered flap in its closed position;
FIG. 3 is a front view of the carrying case illustrated in FIG. 2;
FIG. 4 is a back view of the carrying case illustrated in FIG. 2;
FIG. 5 is a right view of the carrying case illustrated in FIG. 2;
FIG. 6 is a left view of the carrying case illustrated in FIG. 2;
FIG. 7 is a top view of the carrying case illustrated in FIG. 2;
FIG. 8 is a bottom view of the carrying case illustrated in FIG. 2;
FIG. 9 is a perspective view of an alternate embodiment of the carrying case, wherein the flap is shown in its unzipped open position;
FIG. 10 is a perspective view of the carrying case illustrated in FIG. 9, wherein the zippered flap is in its closed position;
FIG. 11 is a front view of the carrying case illustrated in FIG. 10;
FIG. 12 is a back view of the carrying case illustrated in FIG. 10;
FIG. 13 is a right view of the carrying case illustrated in FIG. 10;
FIG. 14 is a left view of the carrying case illustrated in FIG. 10;
FIG. 15 is a top view of the carrying case illustrated in FIG. 10; and,
FIG. 16 is a bottom view of the carrying case illustrated in FIG. 10.

The broken line showings of the defibrillator and the other structure are for illustrative purposes only and form no part of the claimed design.

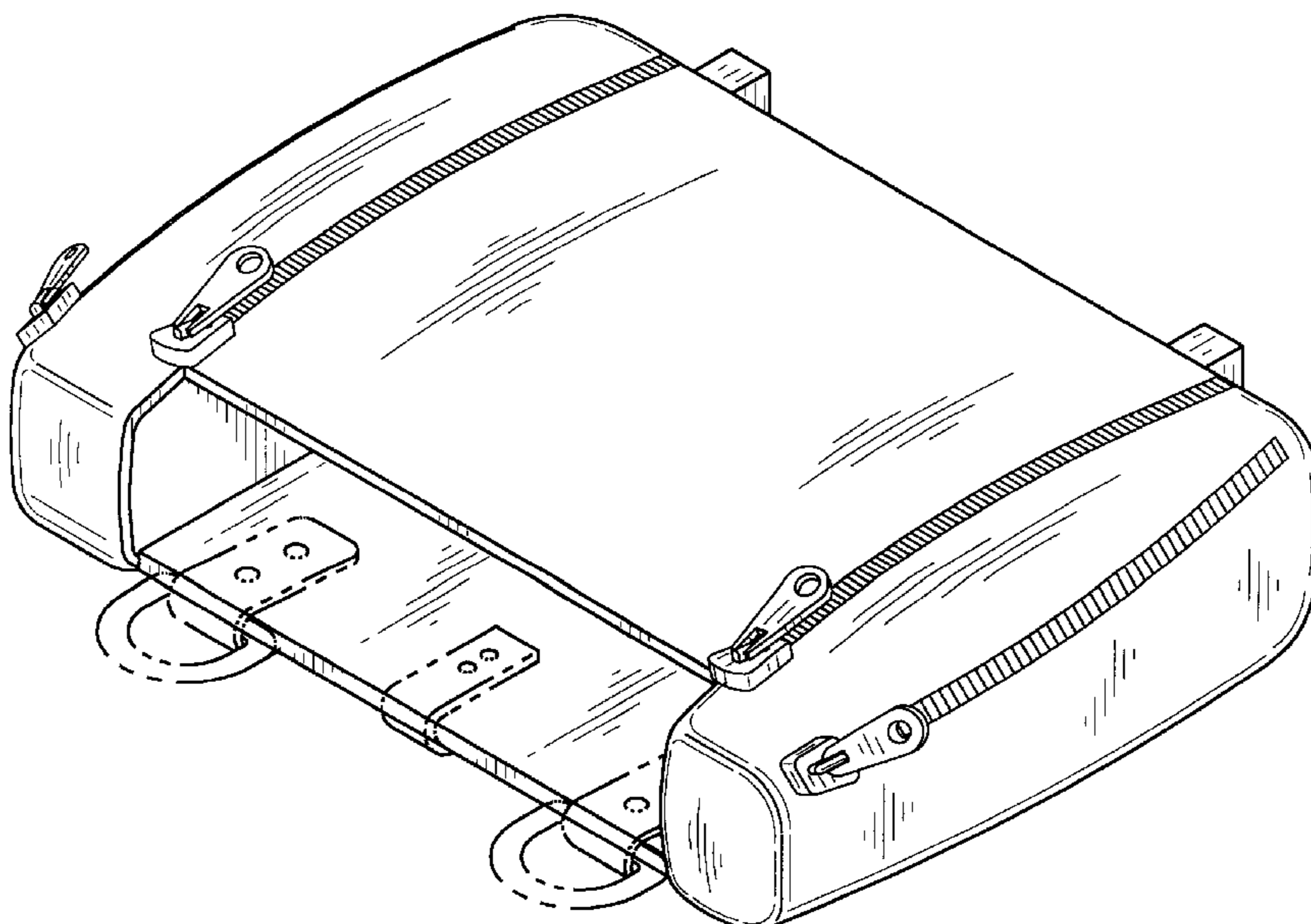

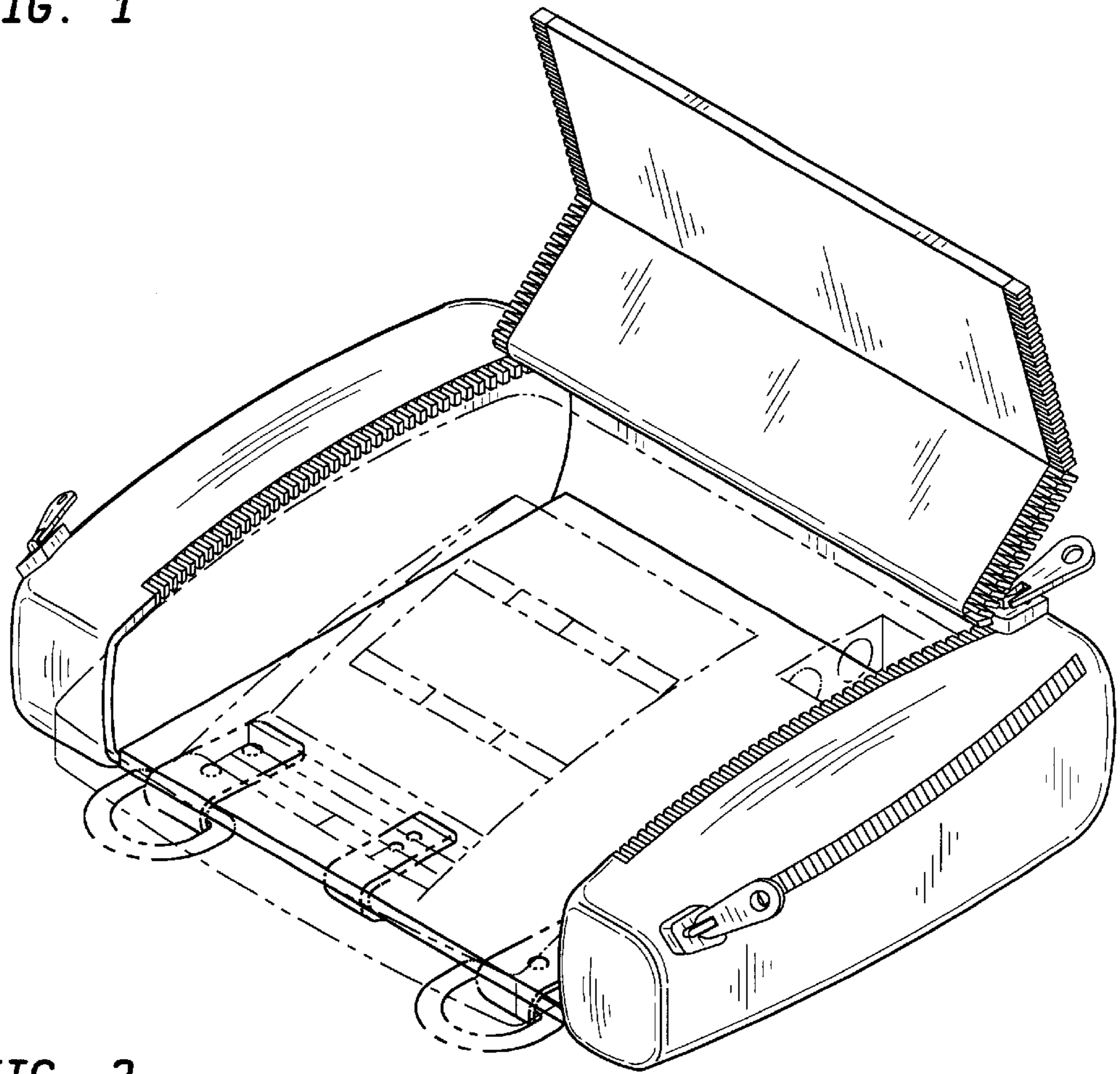

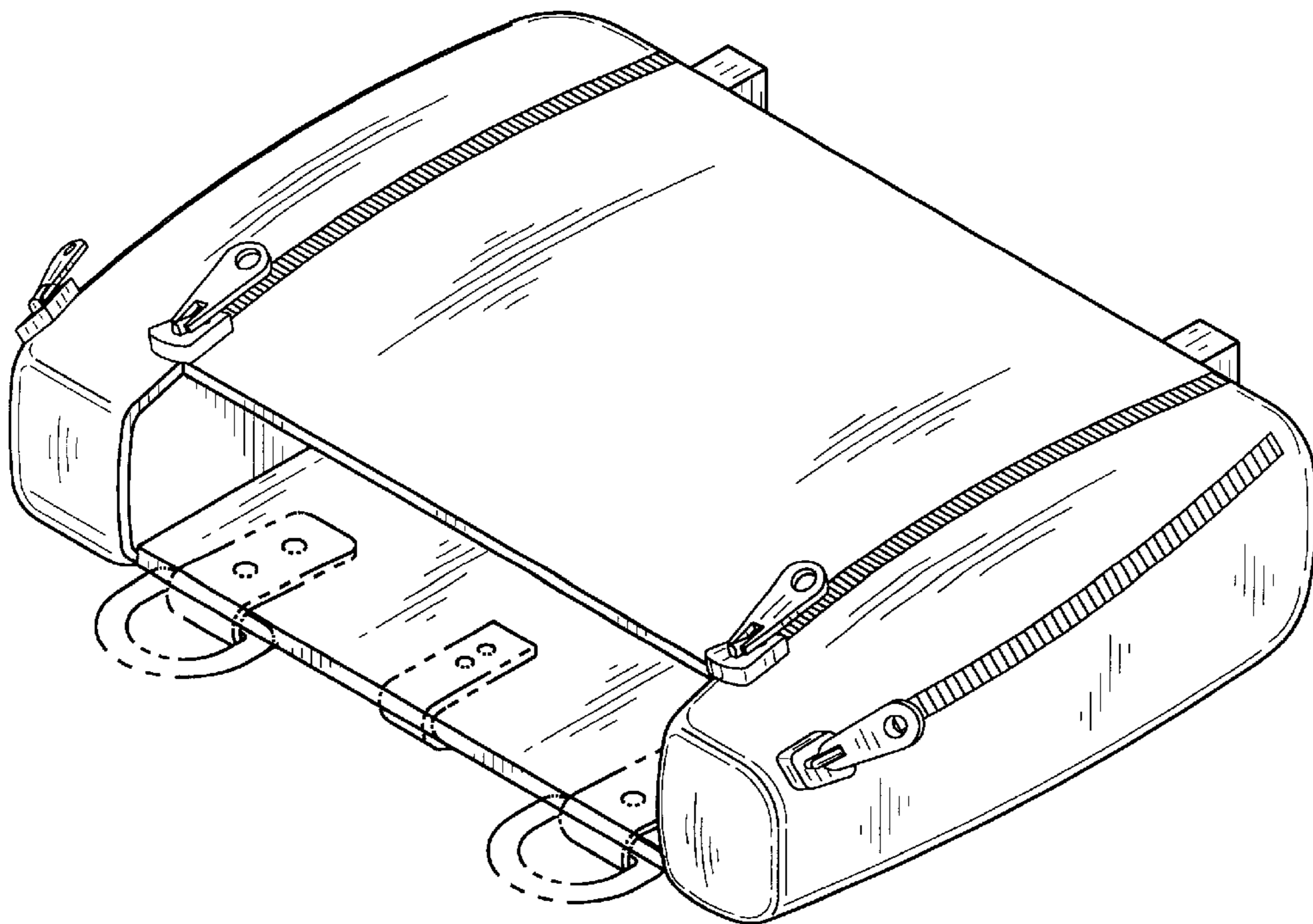

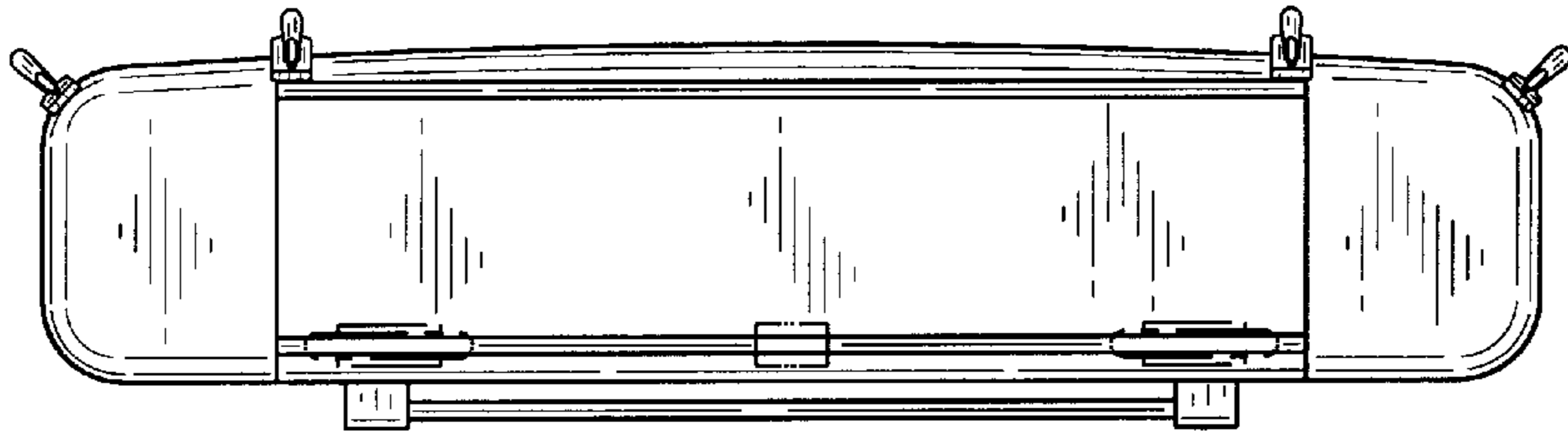

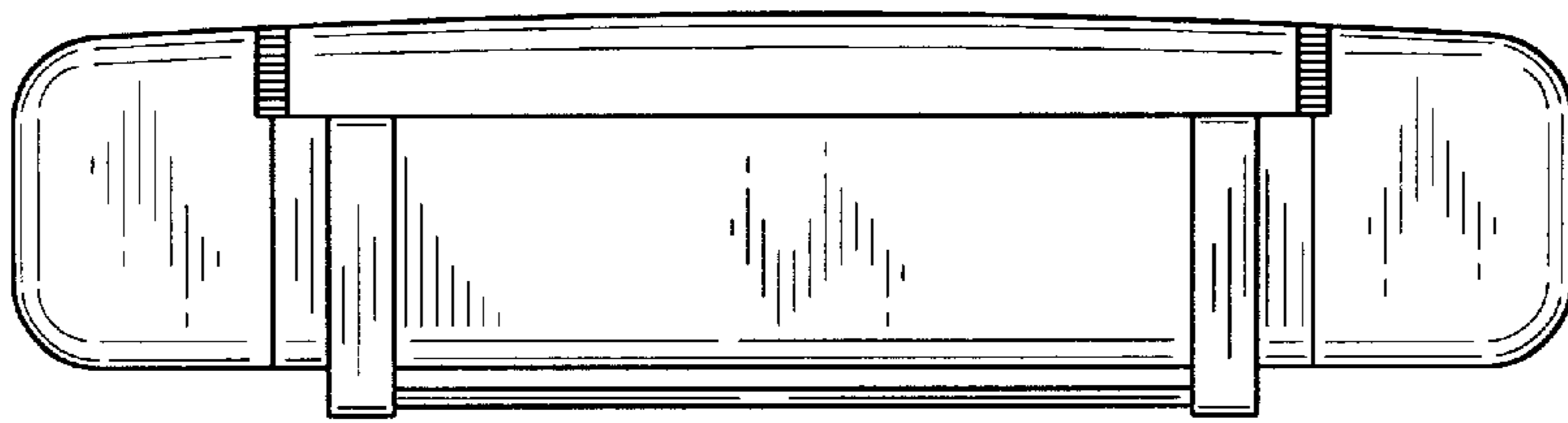

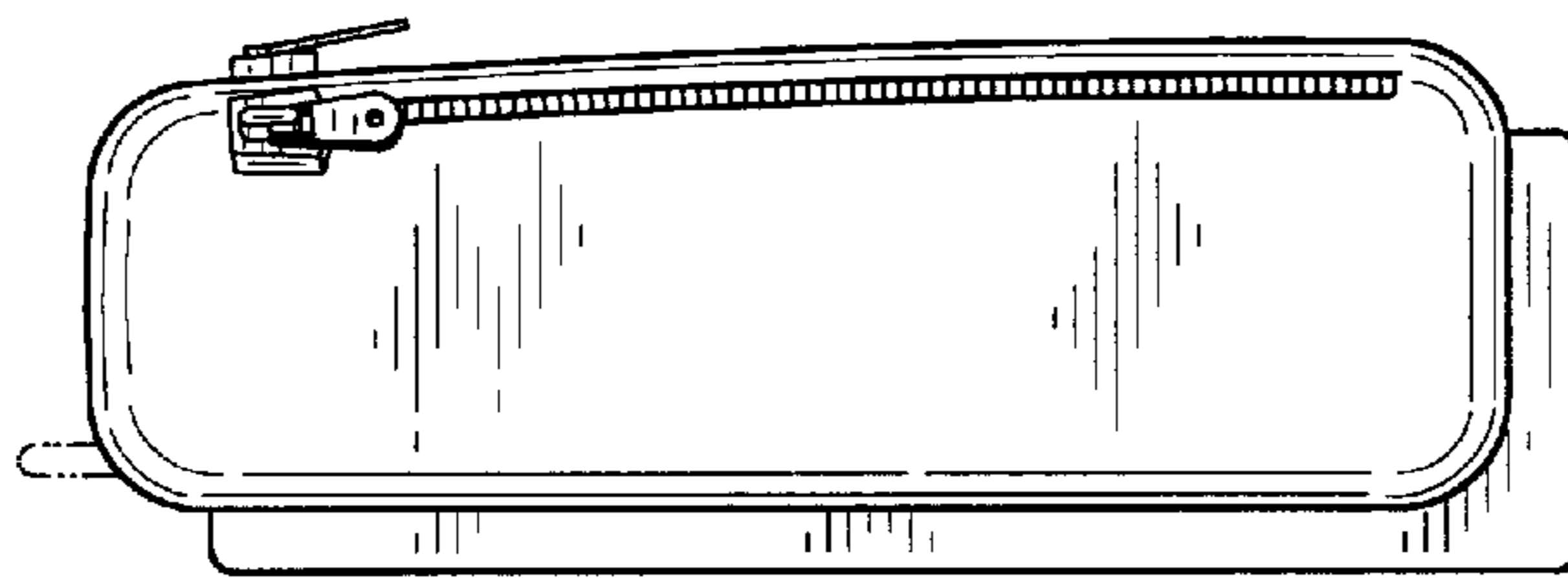

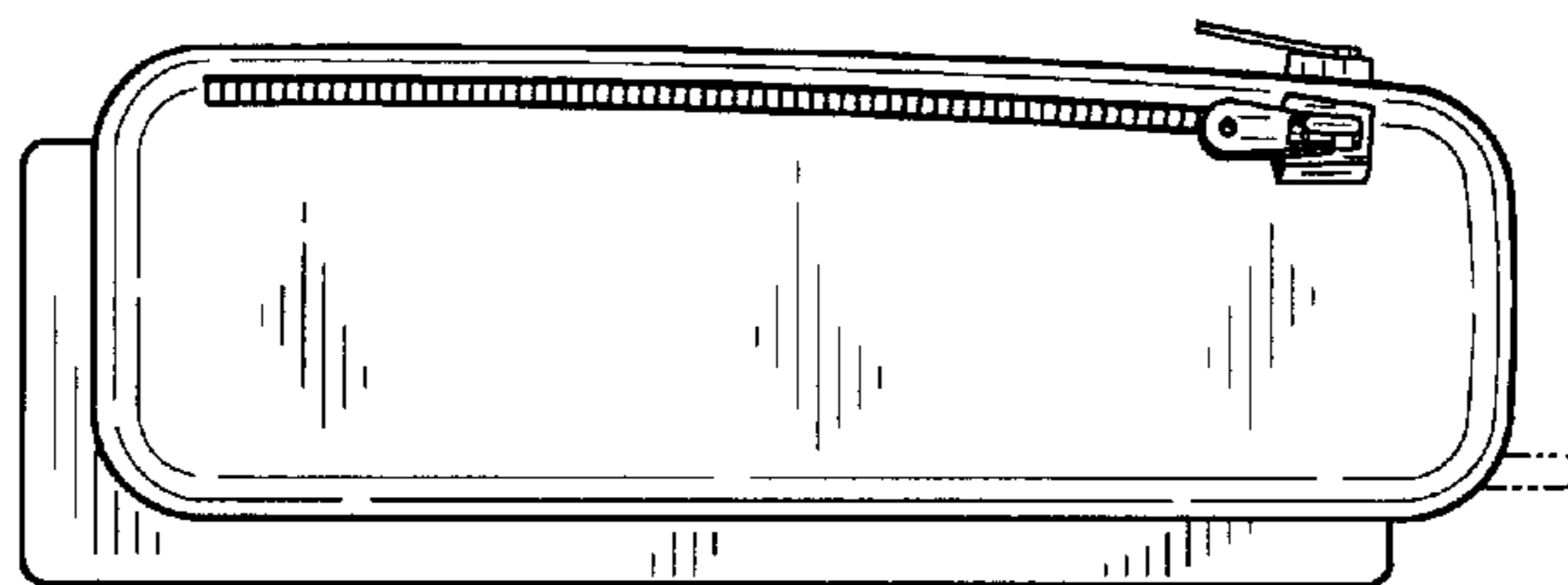

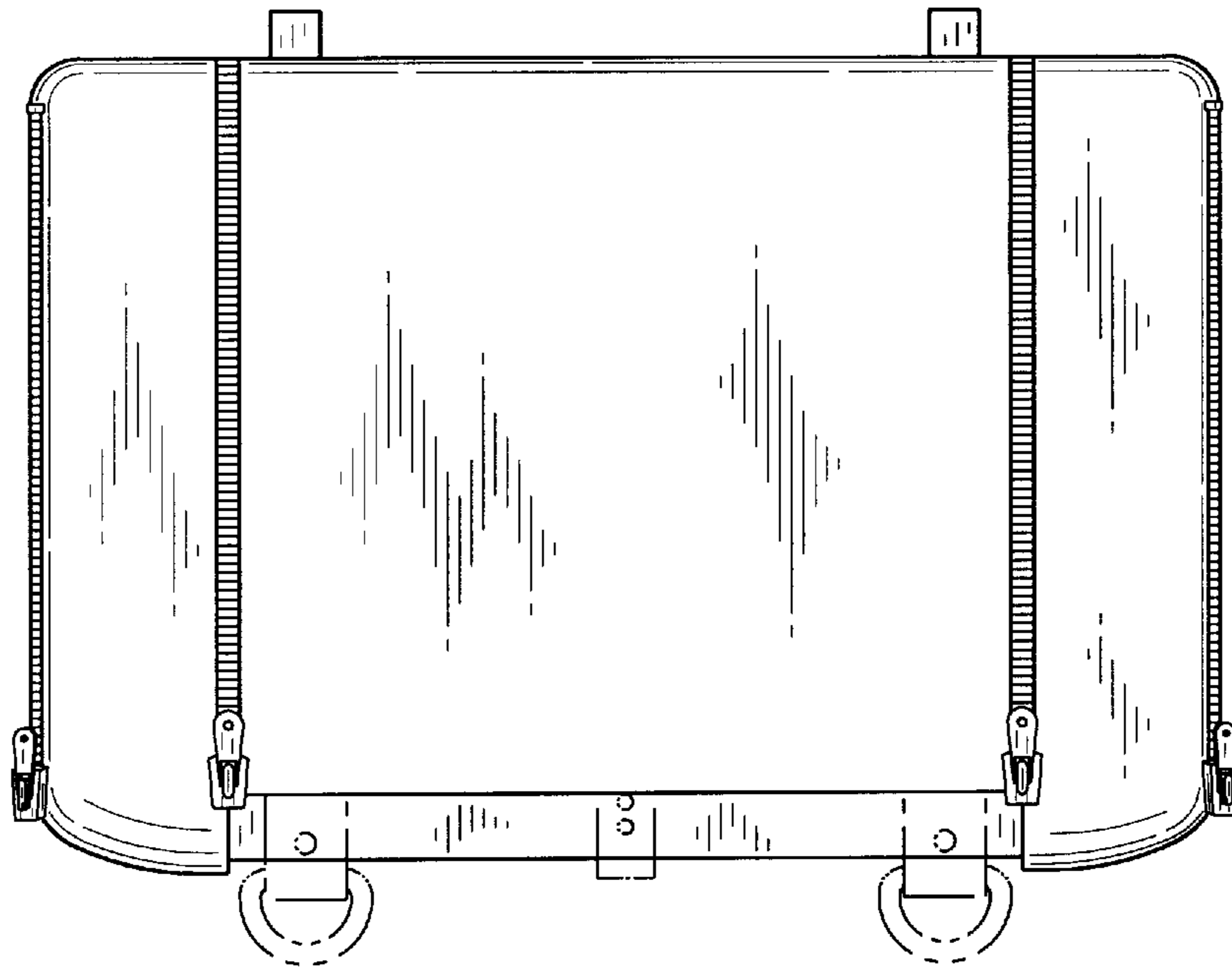

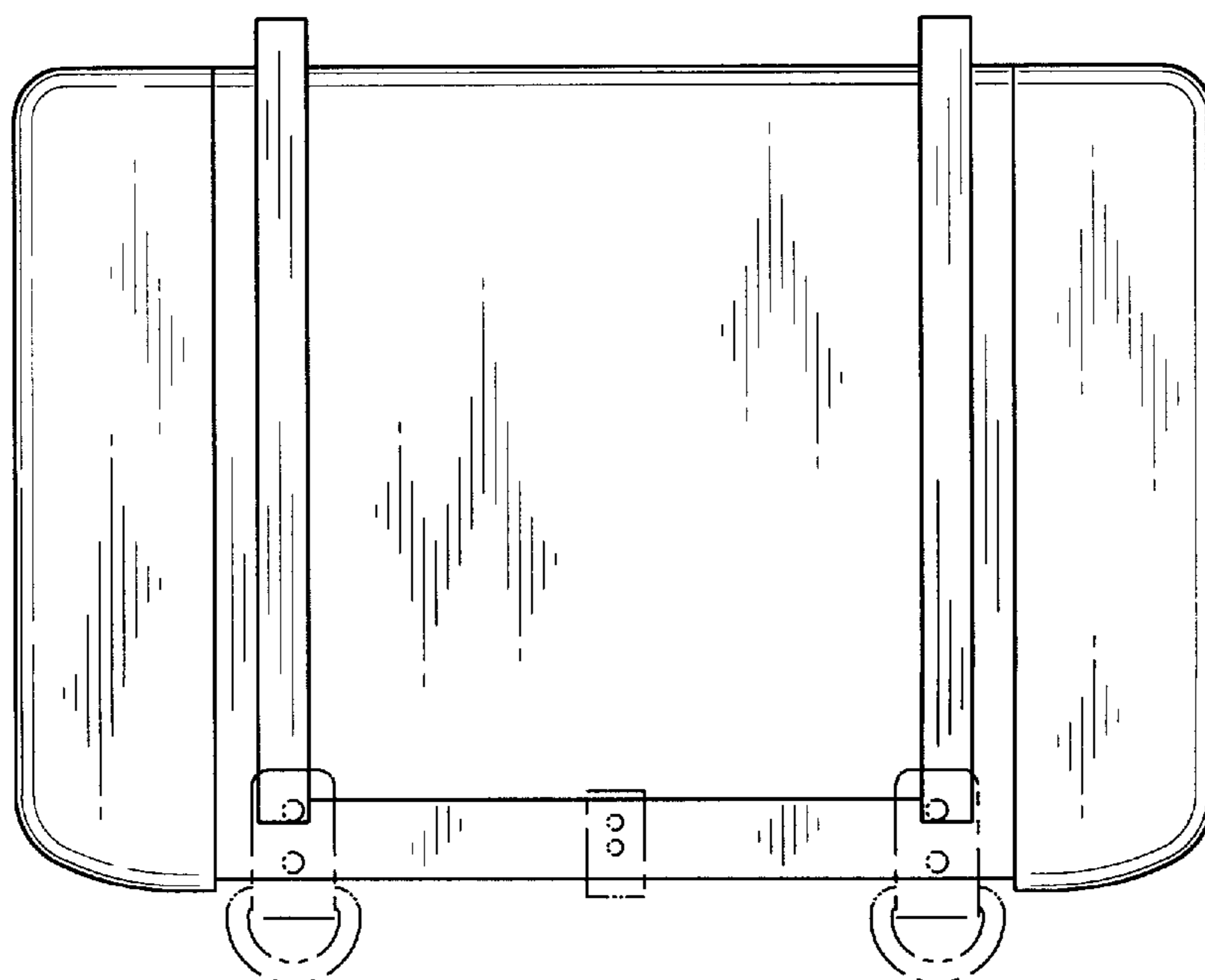

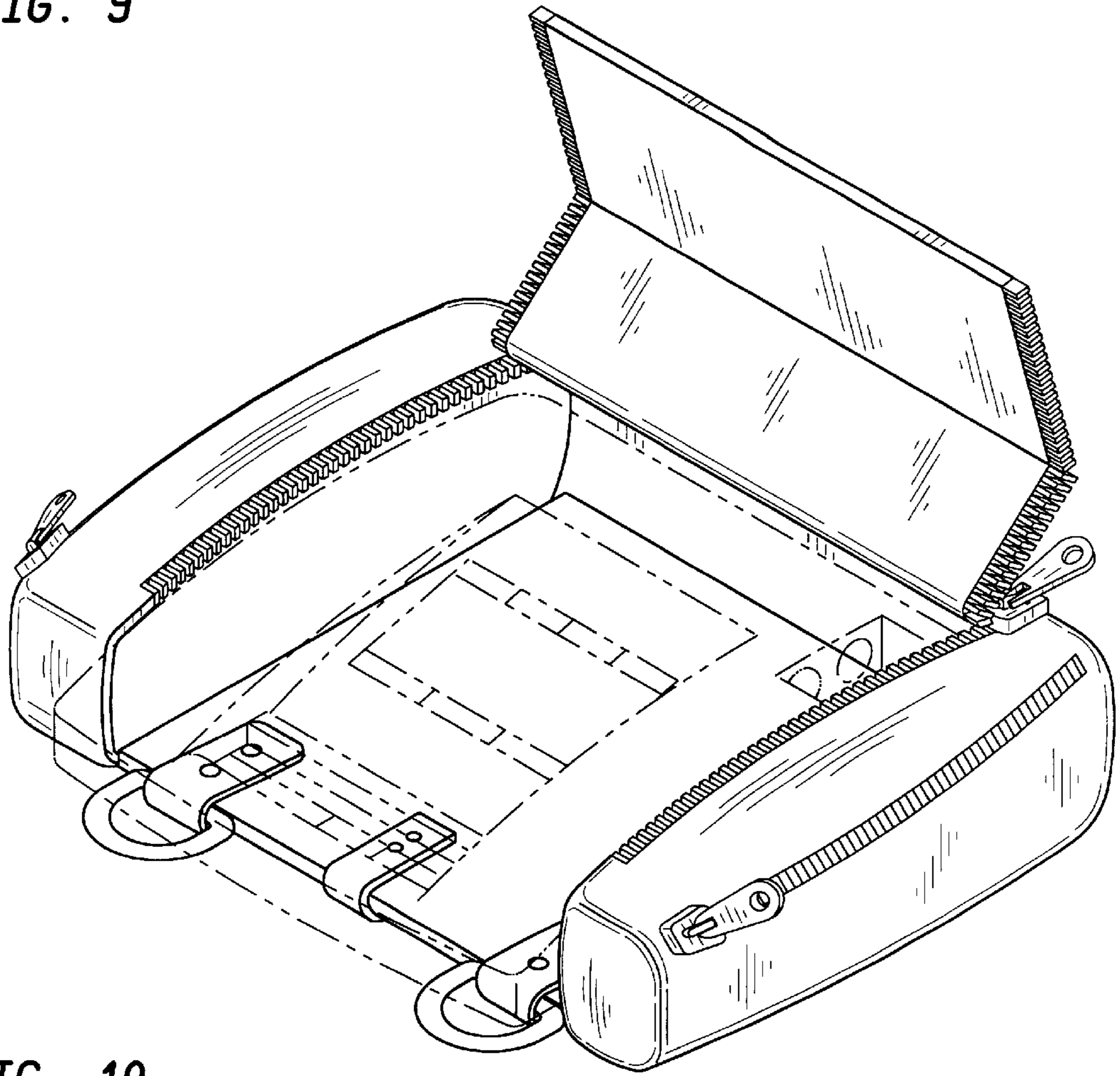

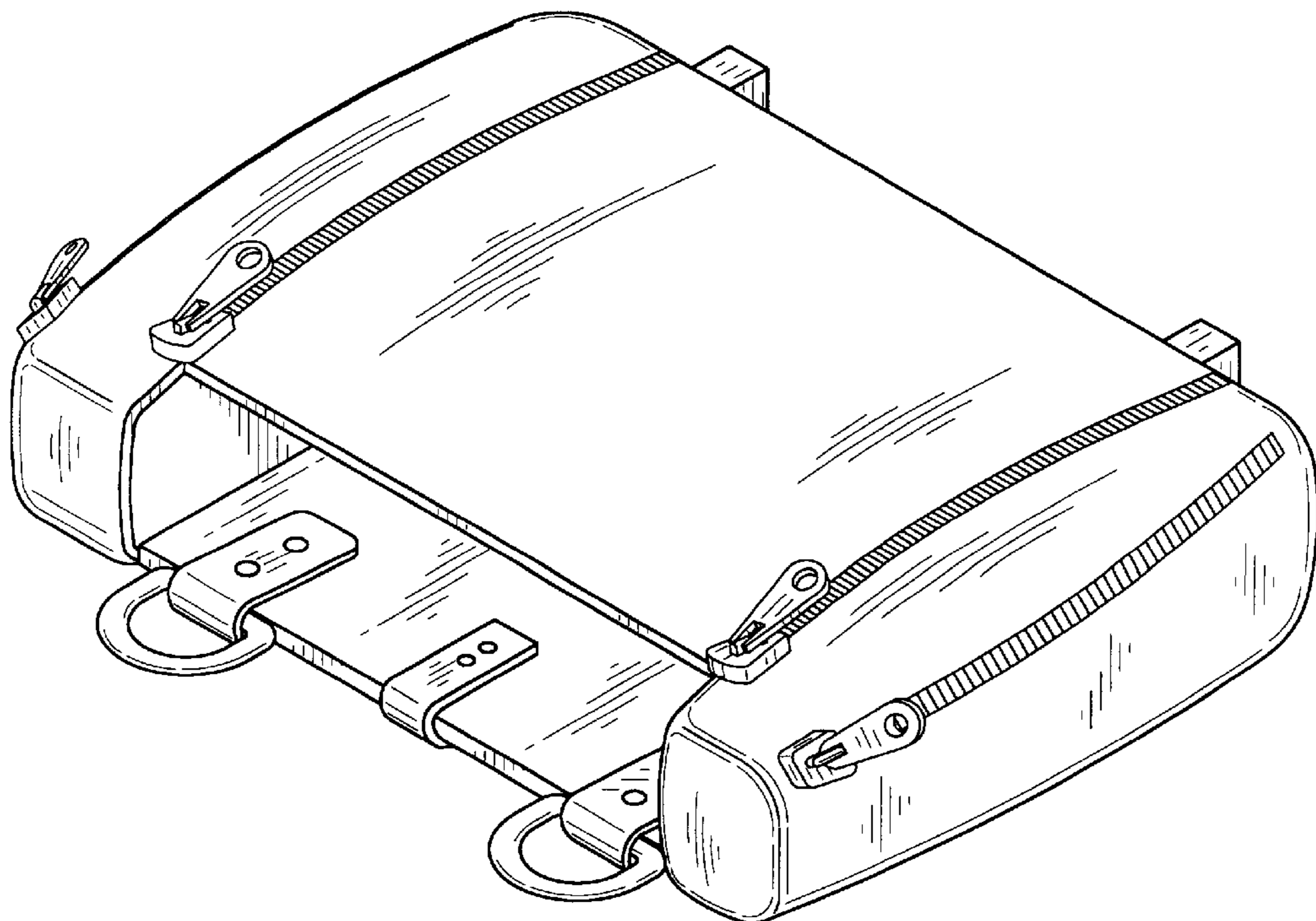

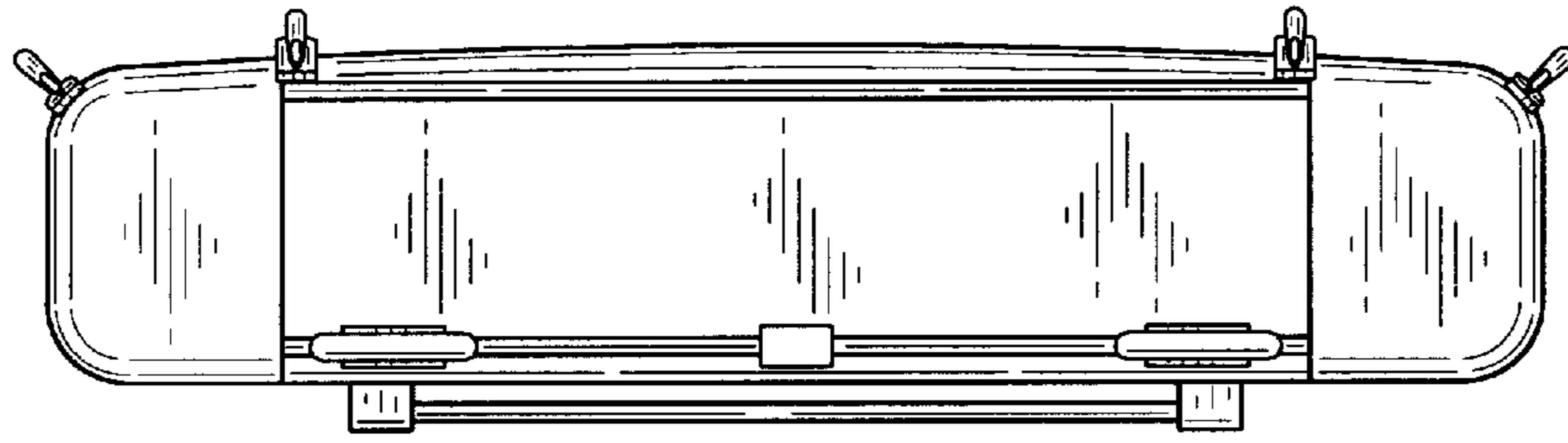

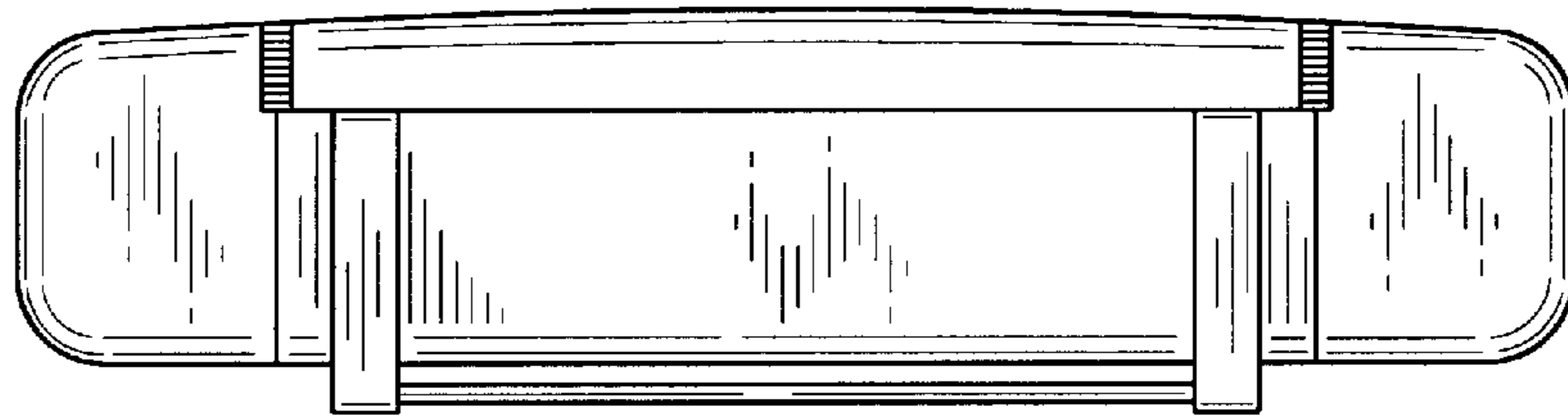

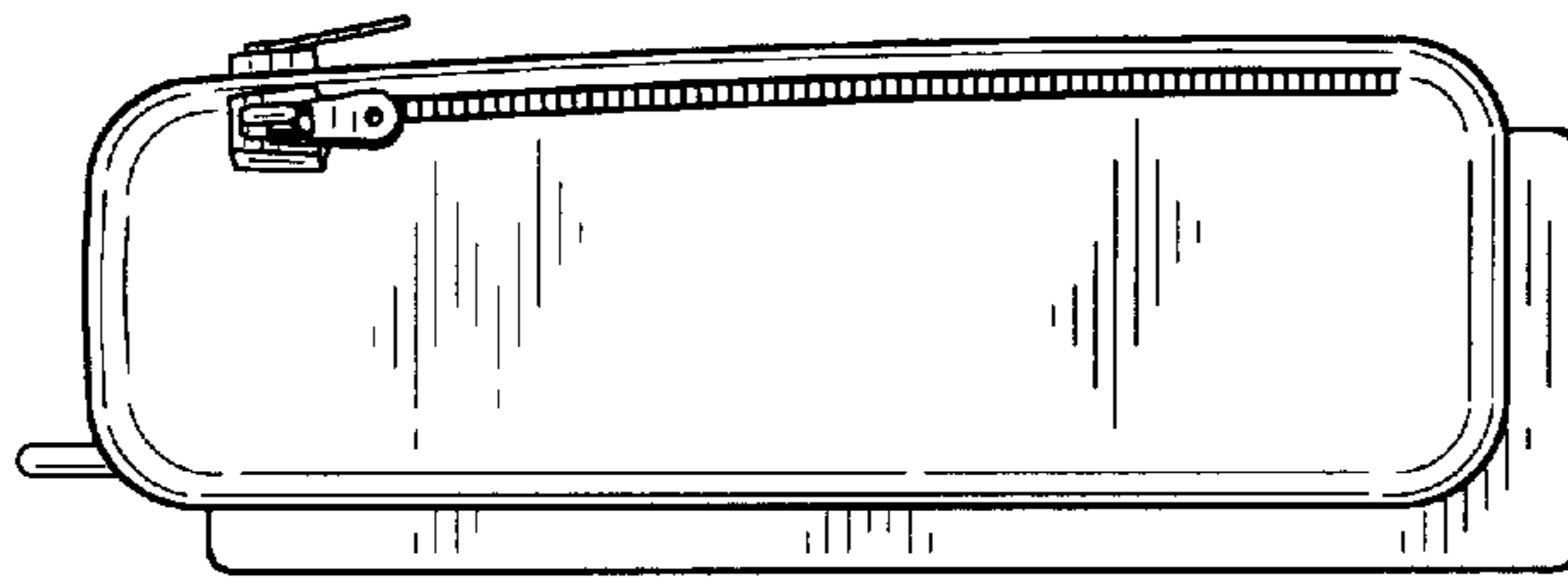

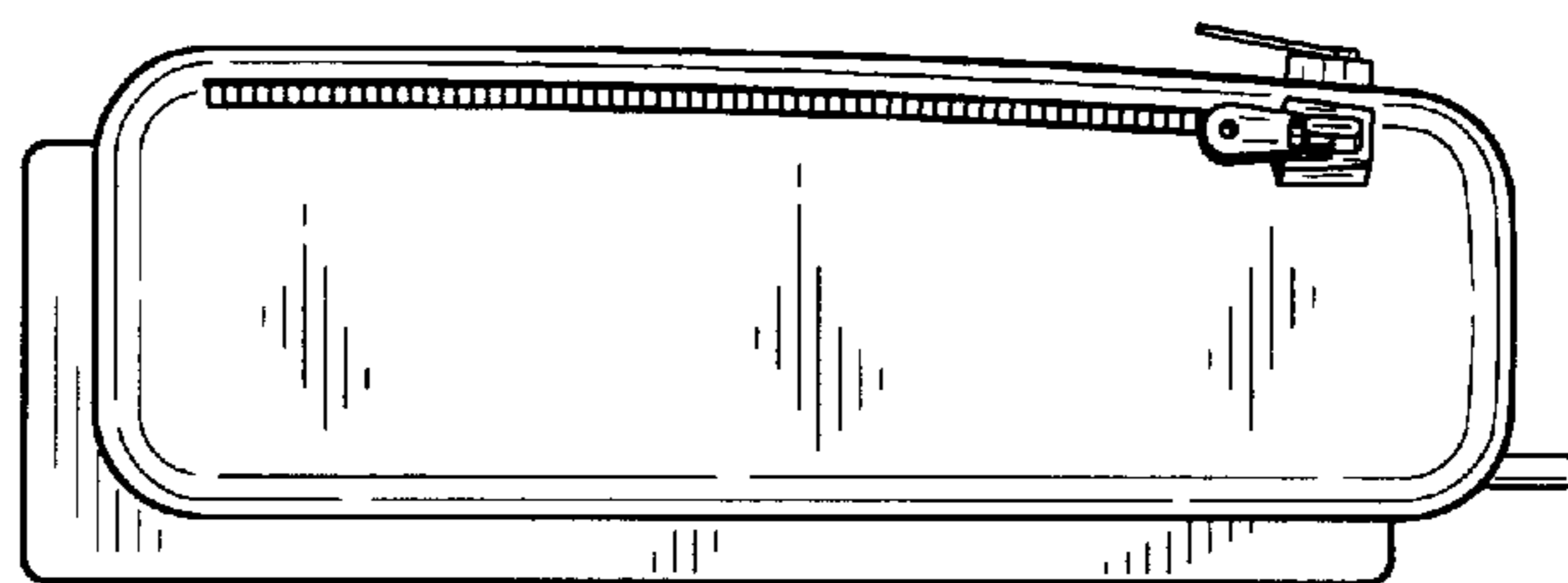

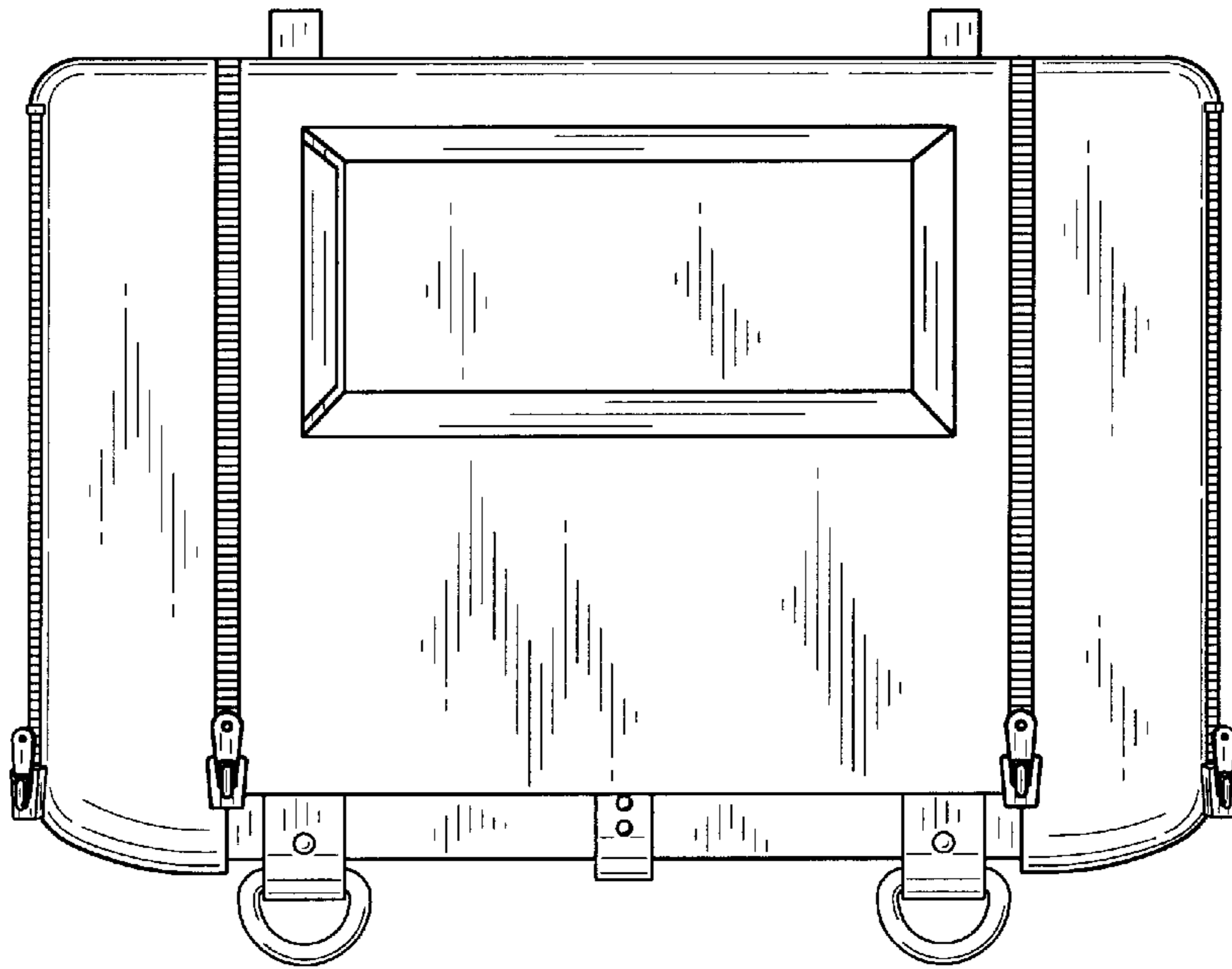
