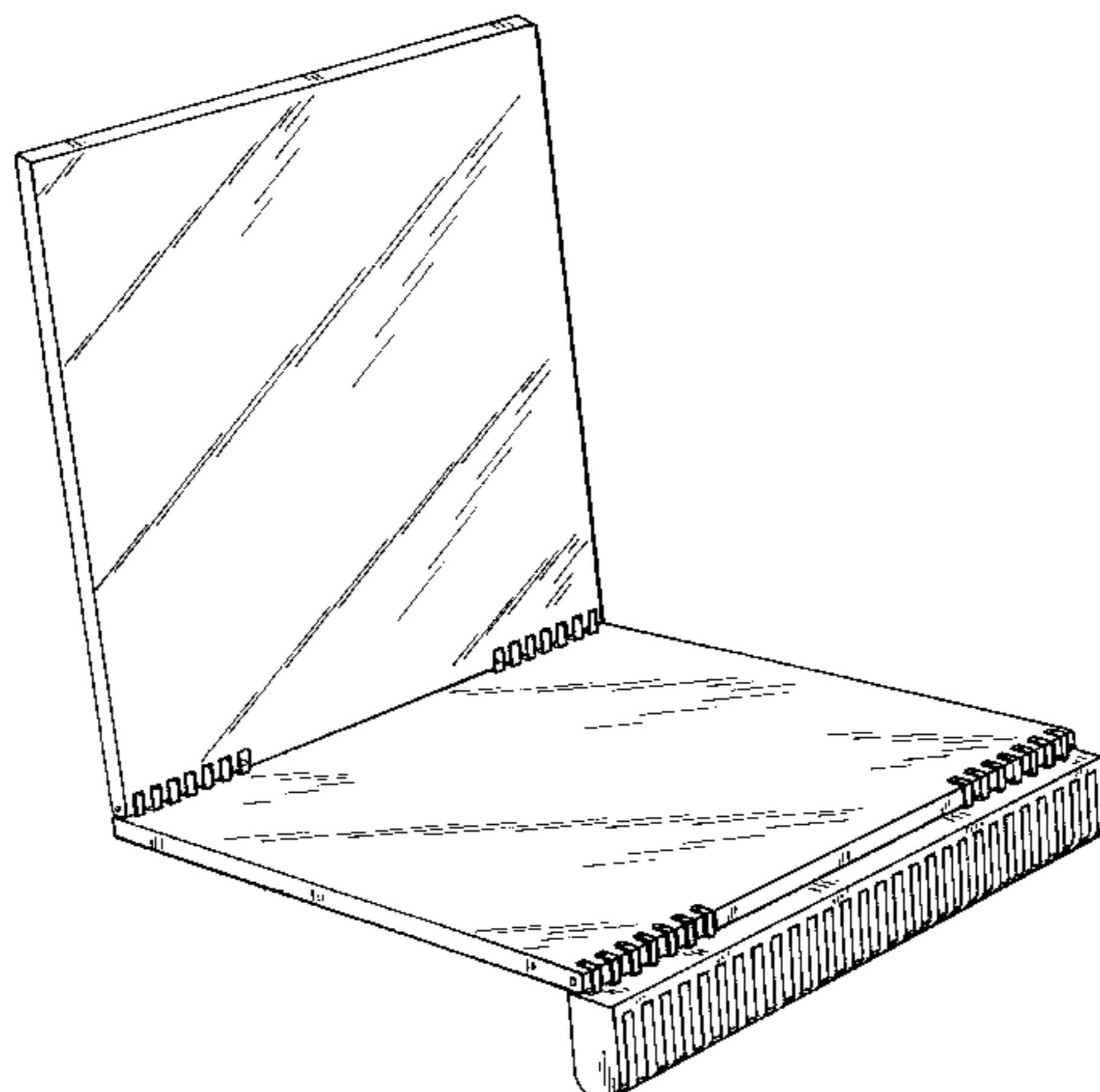
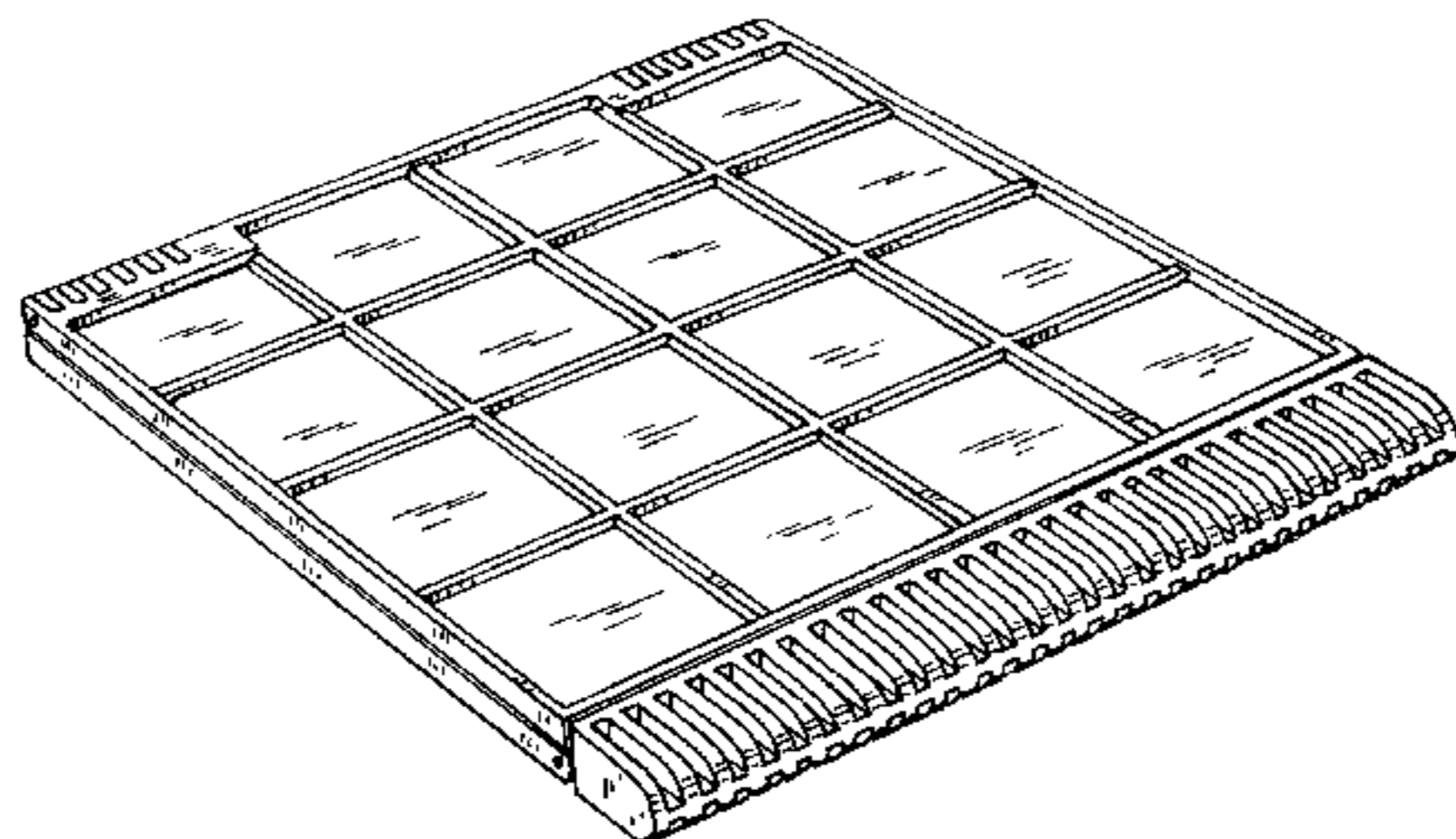
[57] **CLAIM**

The ornamental design for a supporting device for compact disc boxes, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a supporting device for compact disc boxes in a closed position showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a perspective view thereof; FIG. 7 is a top view thereof; FIG. 8 is a perspective view thereof in an open position; FIG. 9 is a front view thereof in the open position; FIG. 10 is a bottom side thereof in the open position; FIG. 11 is a top view thereof in the open position; FIG. 12 is a left side view thereof in the open position; FIG. 13 is a rear view thereof in the open position; and, FIG. 14 is a right side thereof in the open position.

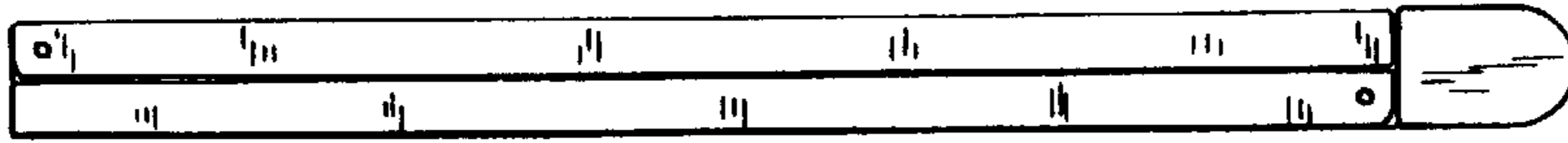

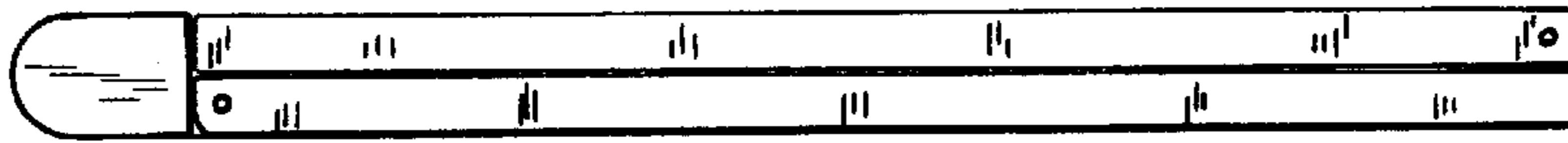

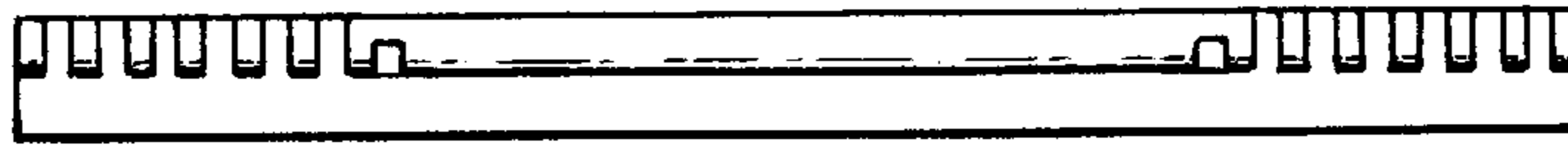

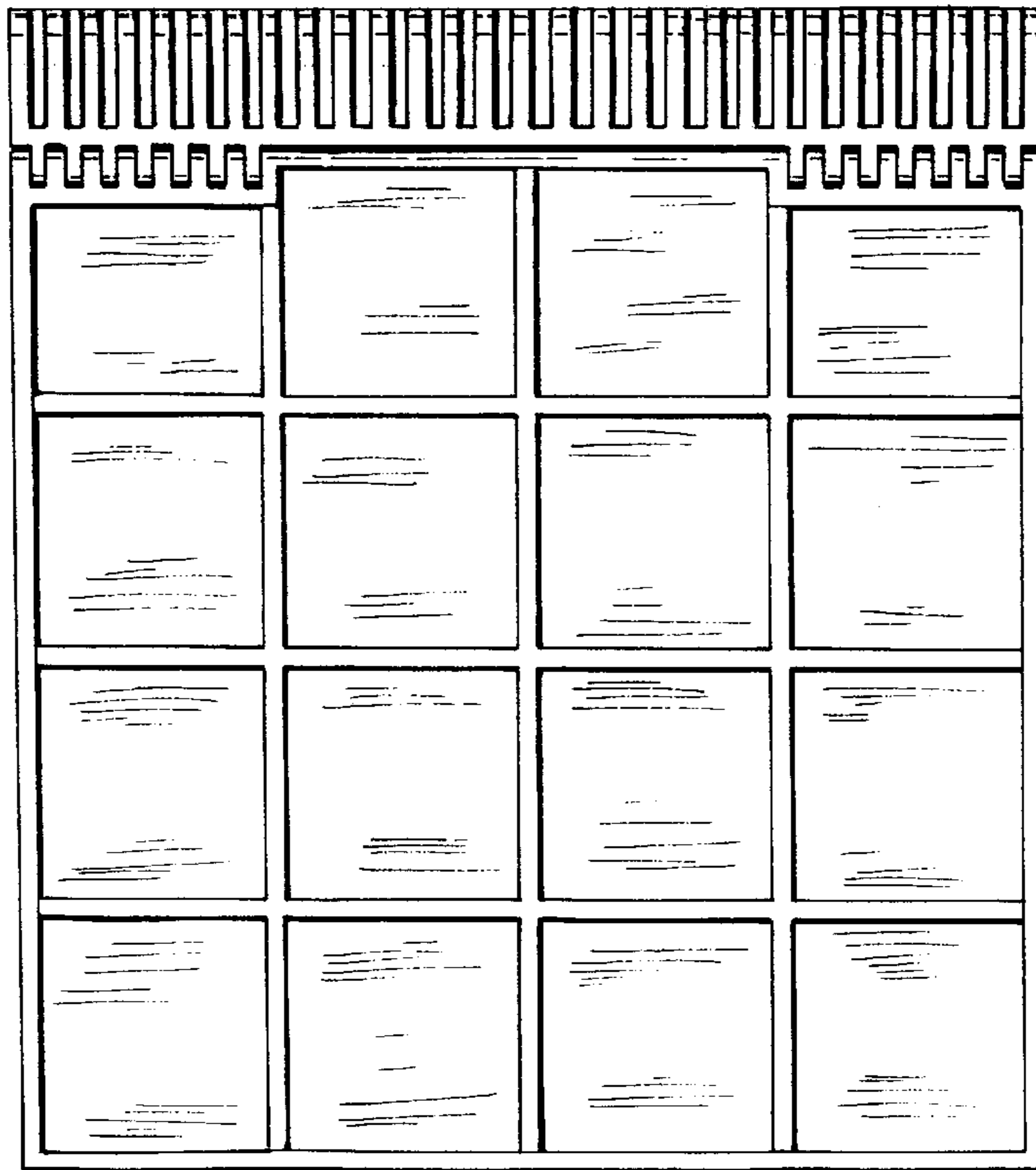

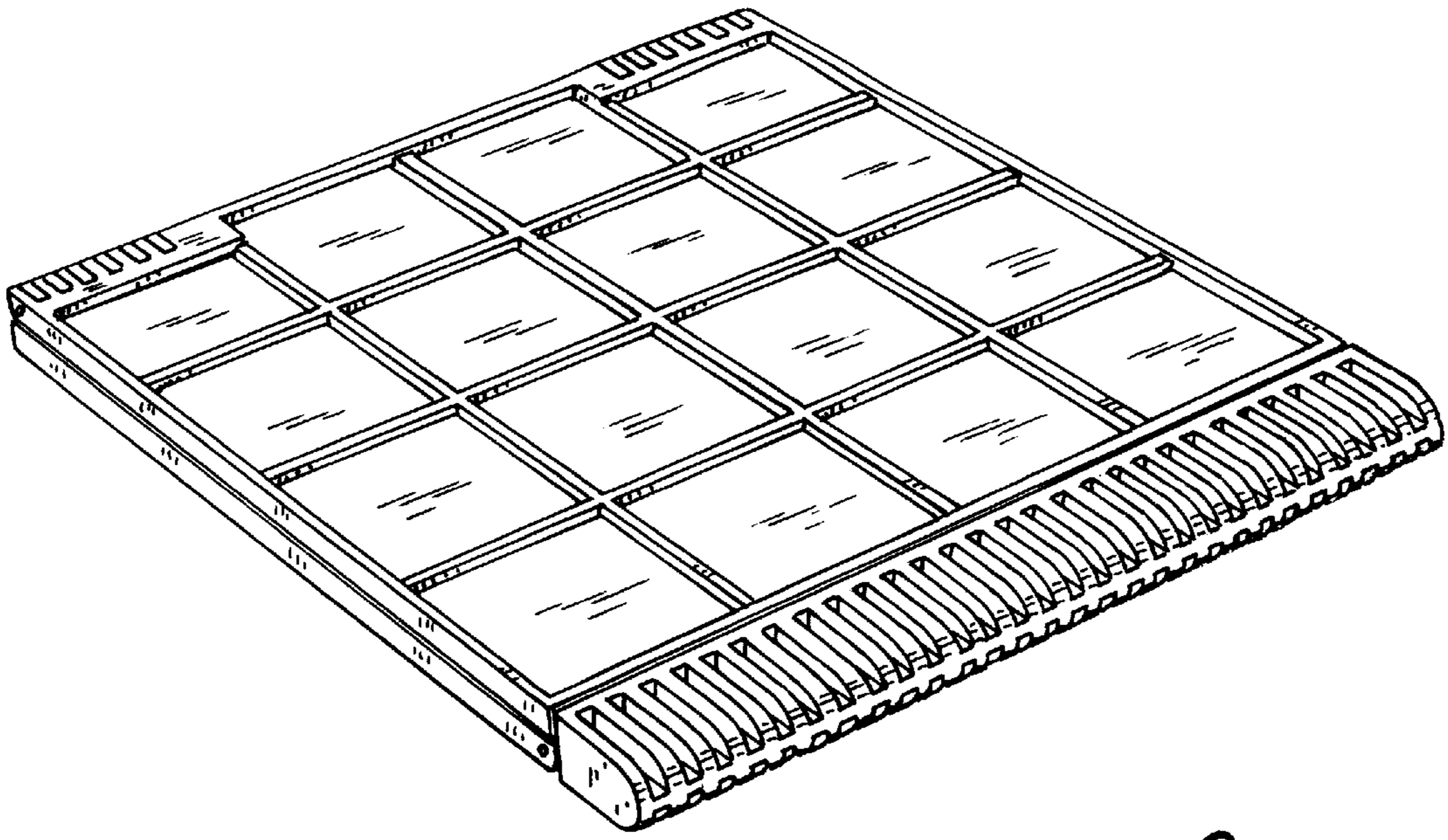

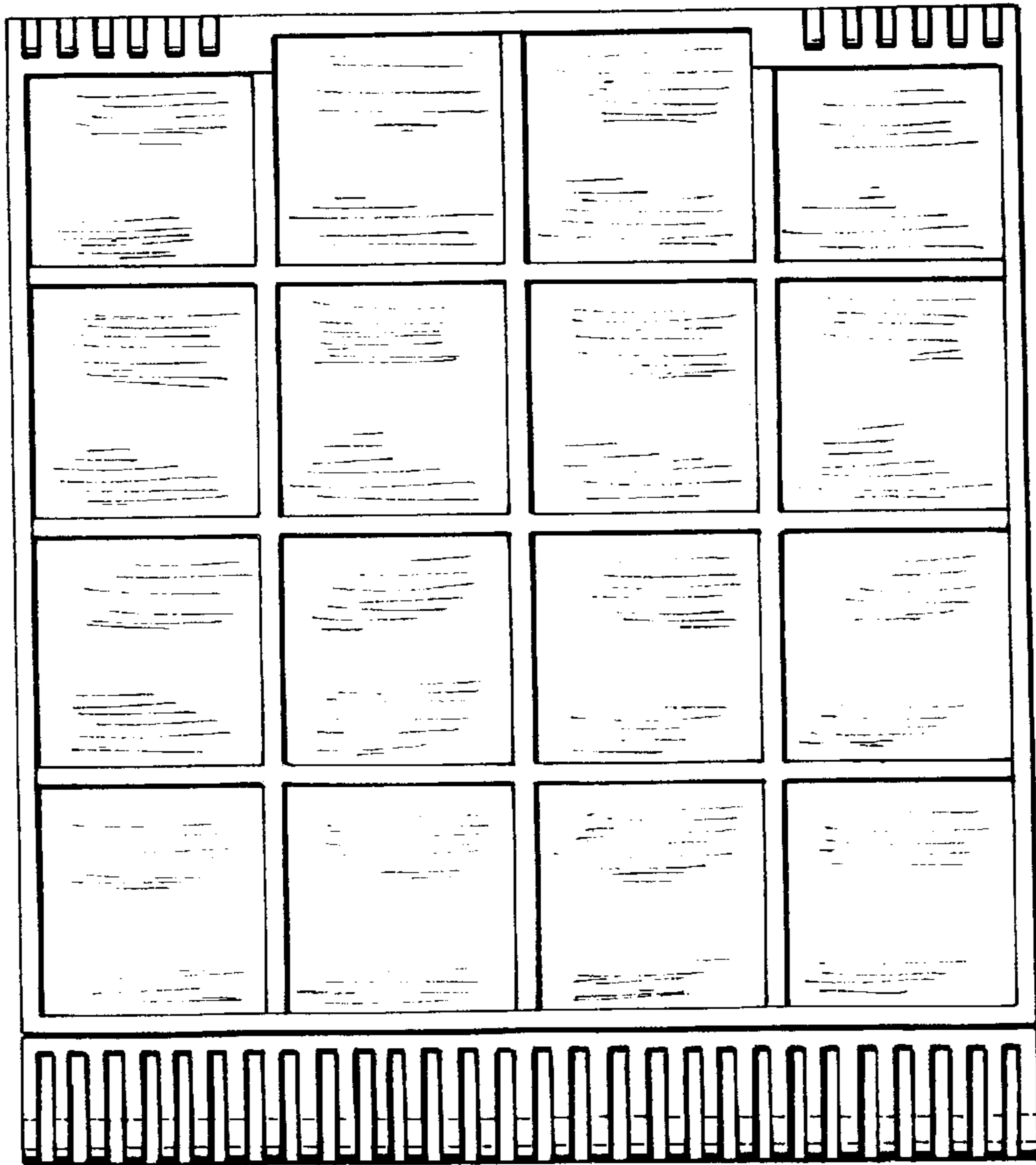

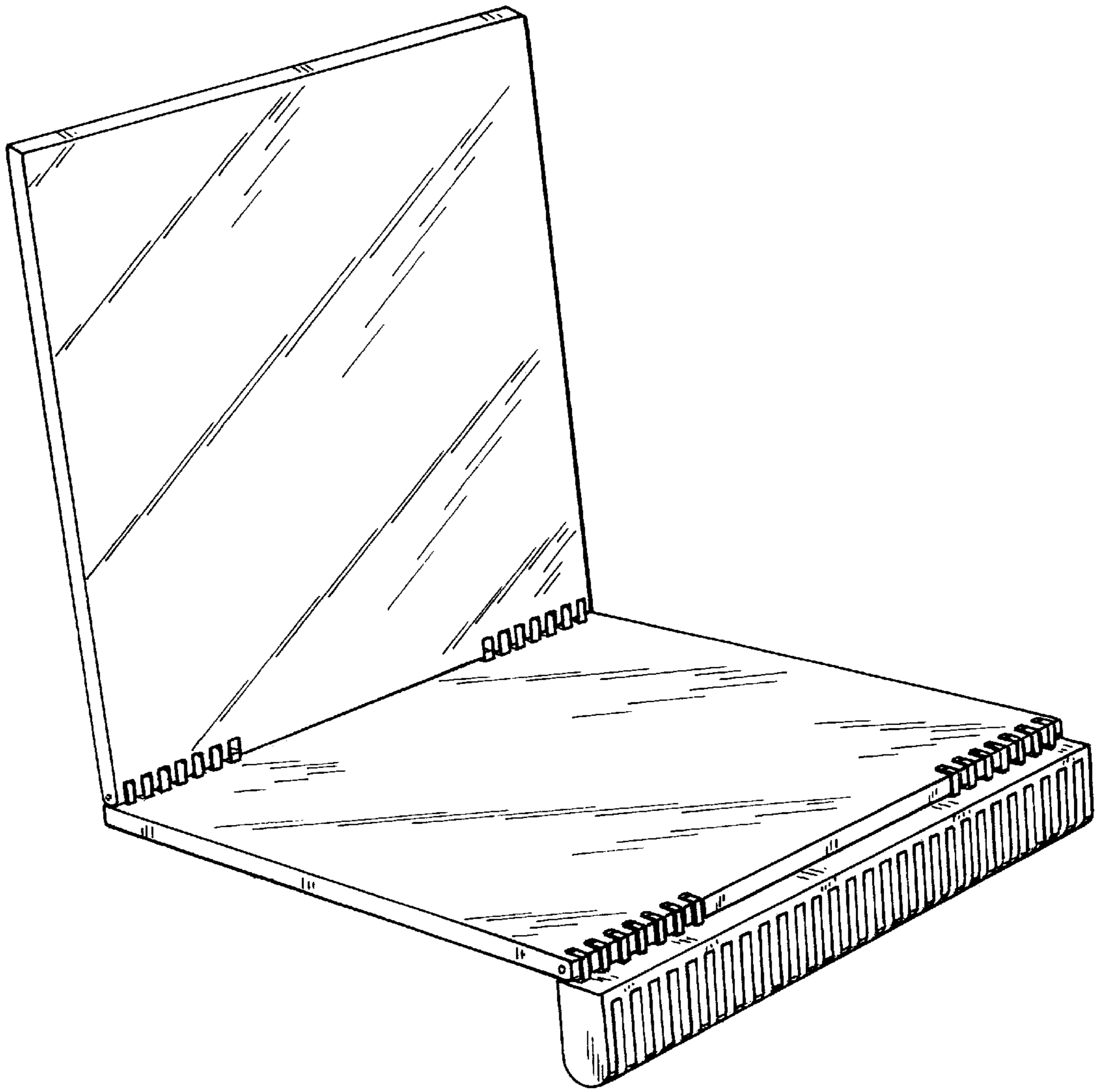

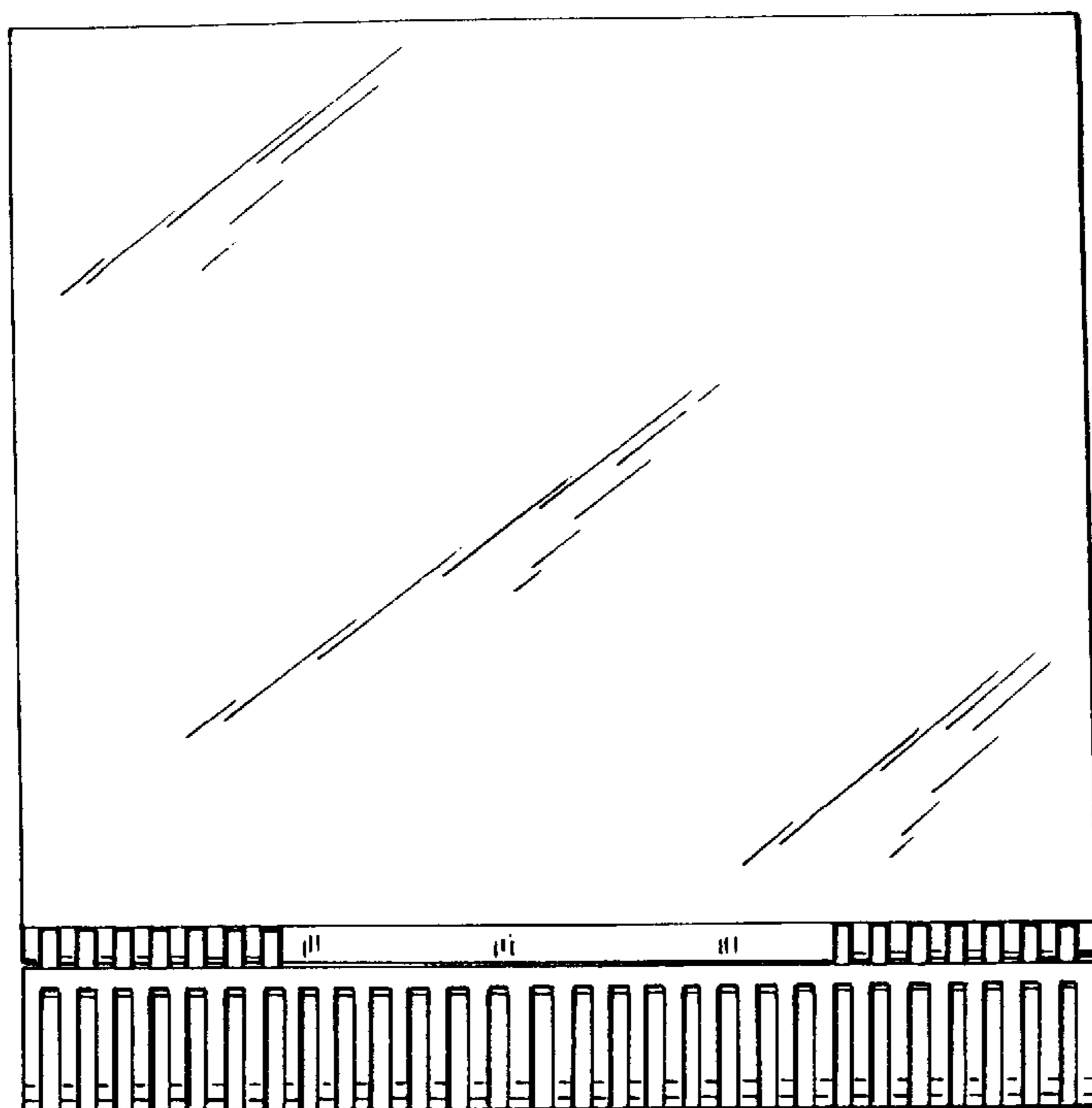

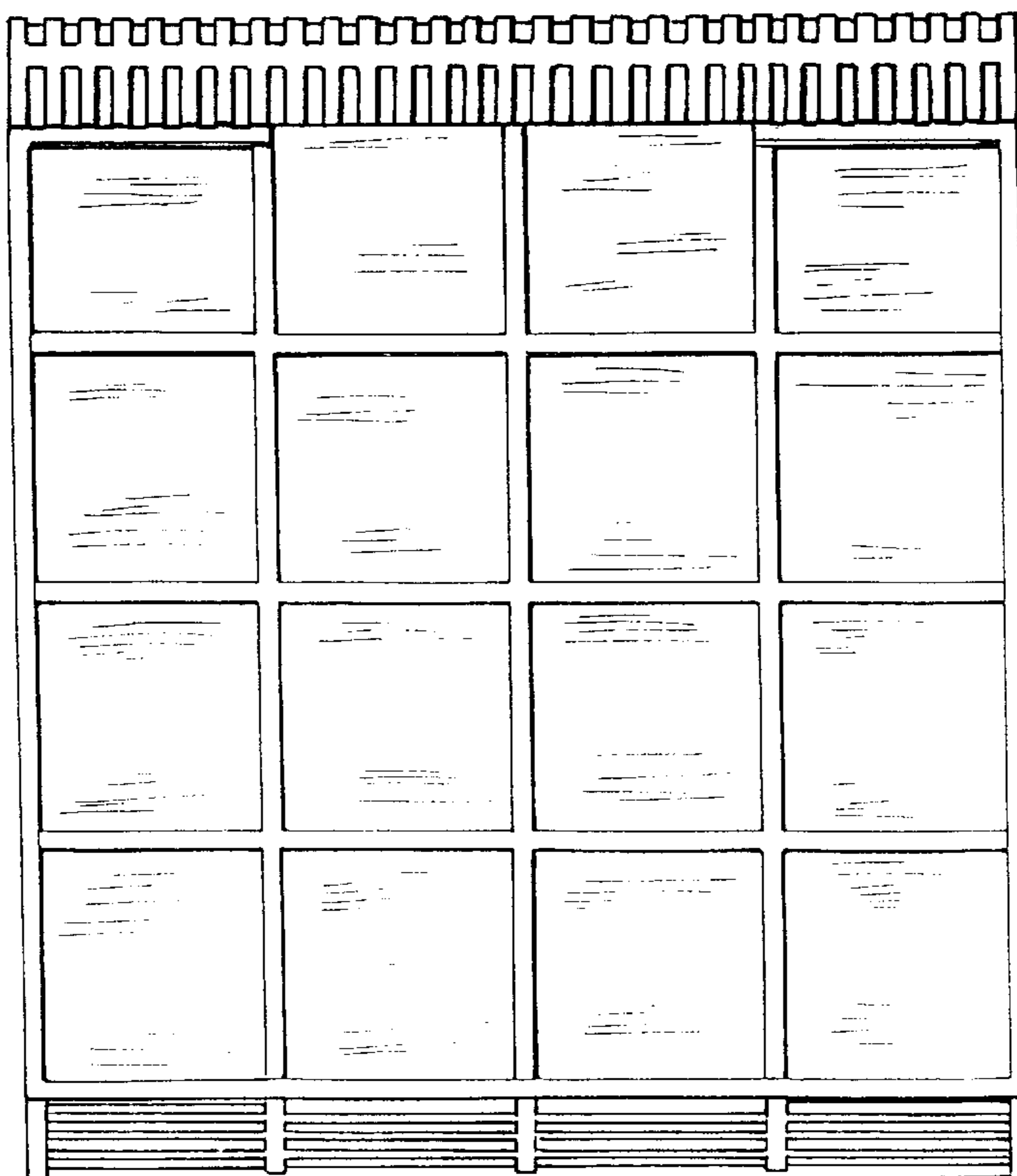

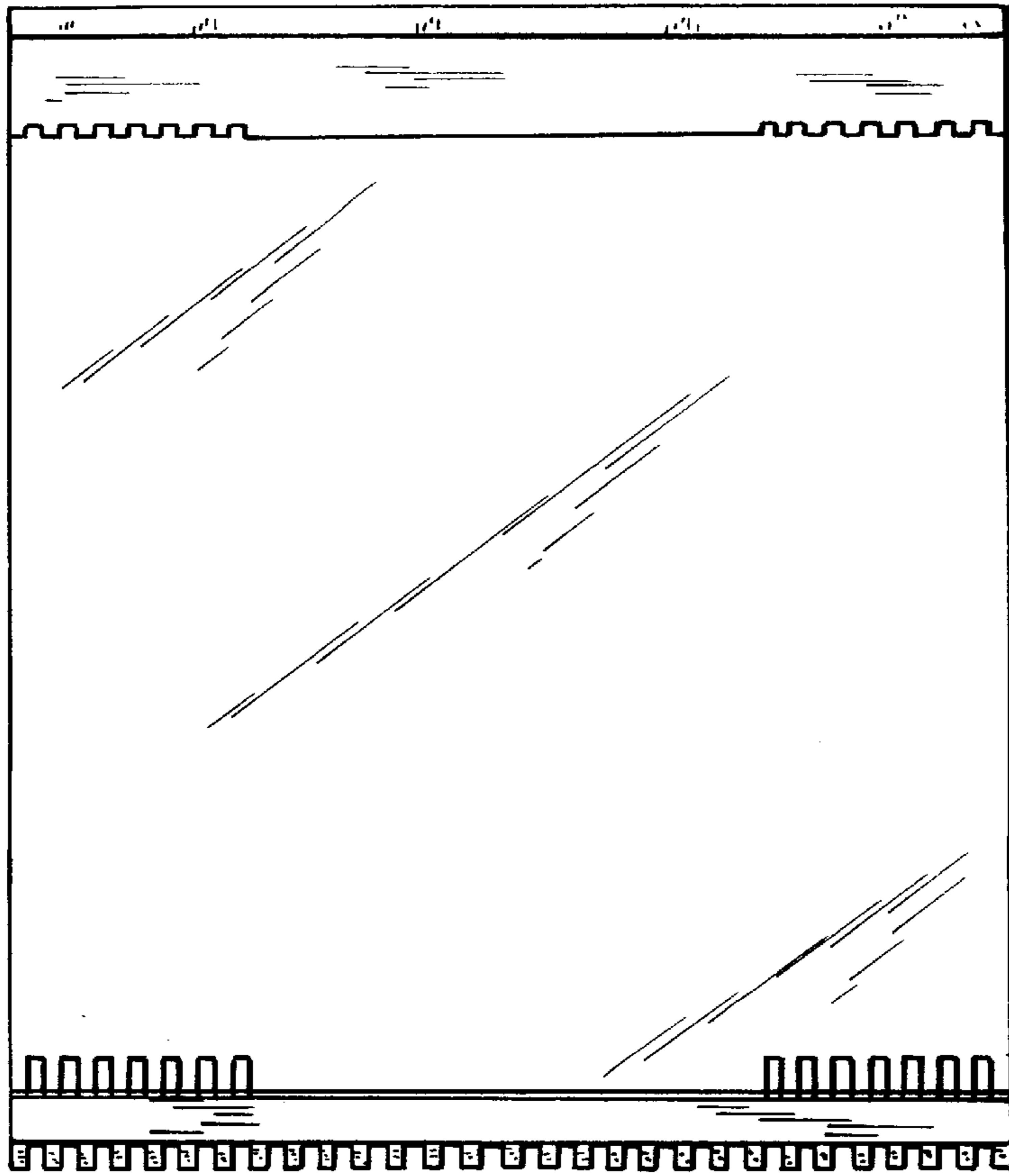

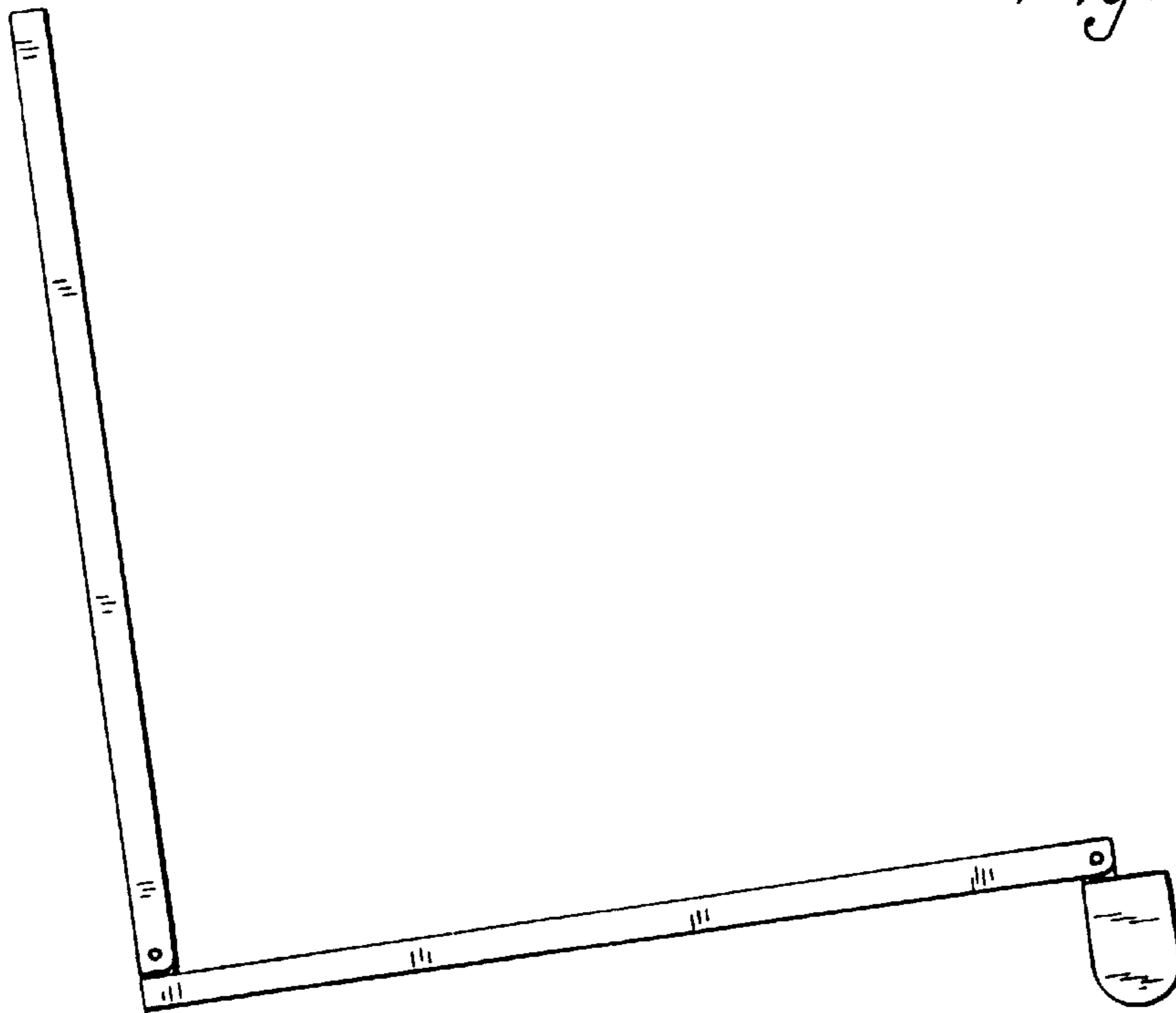

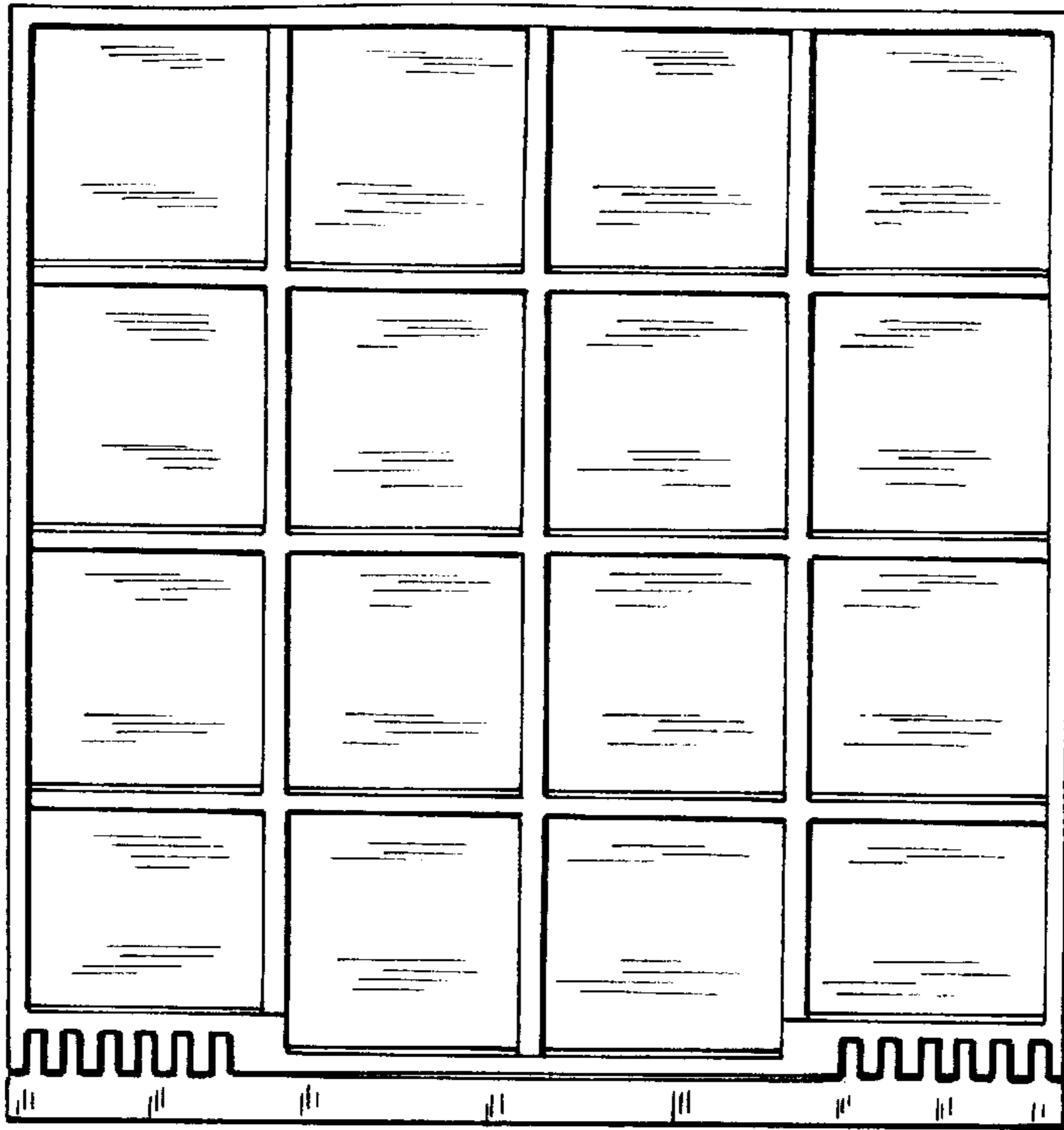

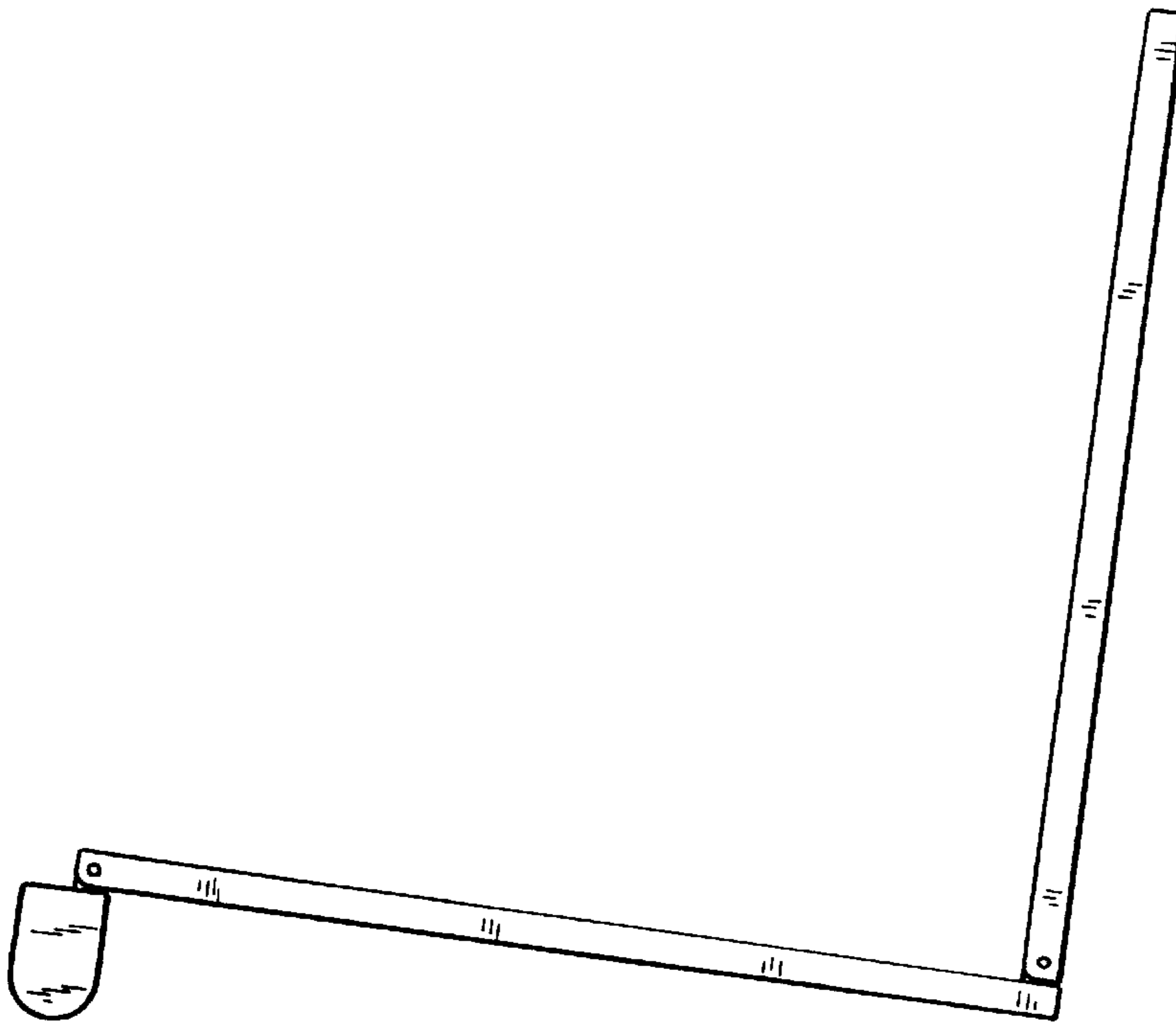
