### [57] CLAIM

The ornamental design for a container blank for adhesively secured flat bottom bag, as shown and described.

### DESCRIPTION

The FIGURE is a plan view of the container blank for adhesively secured flat bottom bag.  
The container blank for adhesively secured flat bottom bag is of no appreciable thickness, and the opposite side thereof forms no part of the claimed design.  
The broken lines are understood to represent fold lines.
