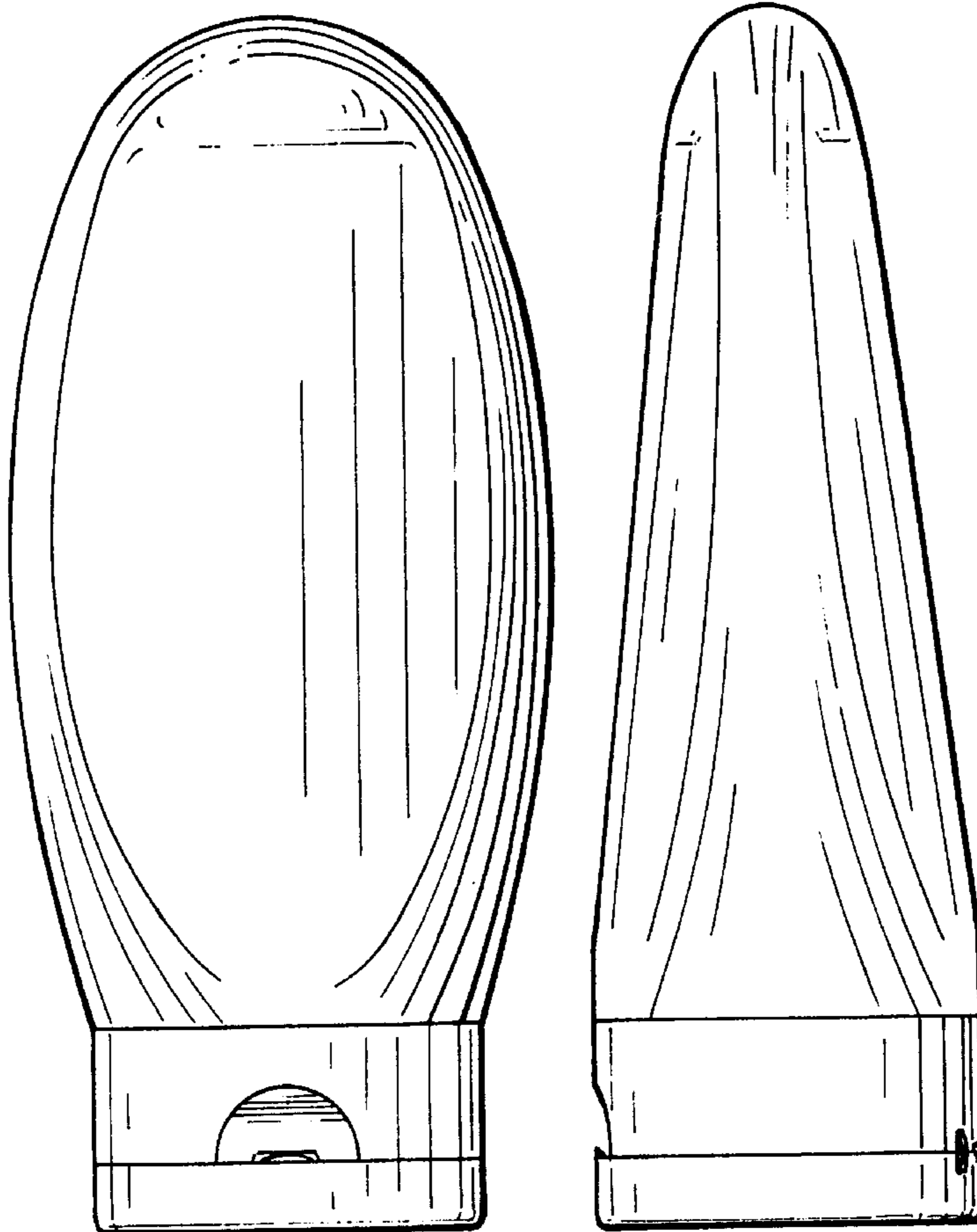
[57] **CLAIM**

The ornamental design for a combined container and closure, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational view showing a side of a combined container and closure showing our new design;  
 FIG. 2 is an elevational view showing the opposed side of the combined container and closure of FIG. 1.  
 FIG. 3 is an elevational view showing an end of the container of FIGS. 1 and 2;  
 FIG. 4 is an elevational view showing the opposed end of the combined container and closure of FIGS. 1-3;  
 FIG. 5 is a bottom plan view of the container of FIGS. 1-4; and,  
 FIG. 6 is a bottom plan view of the container of FIGS. 1-5.

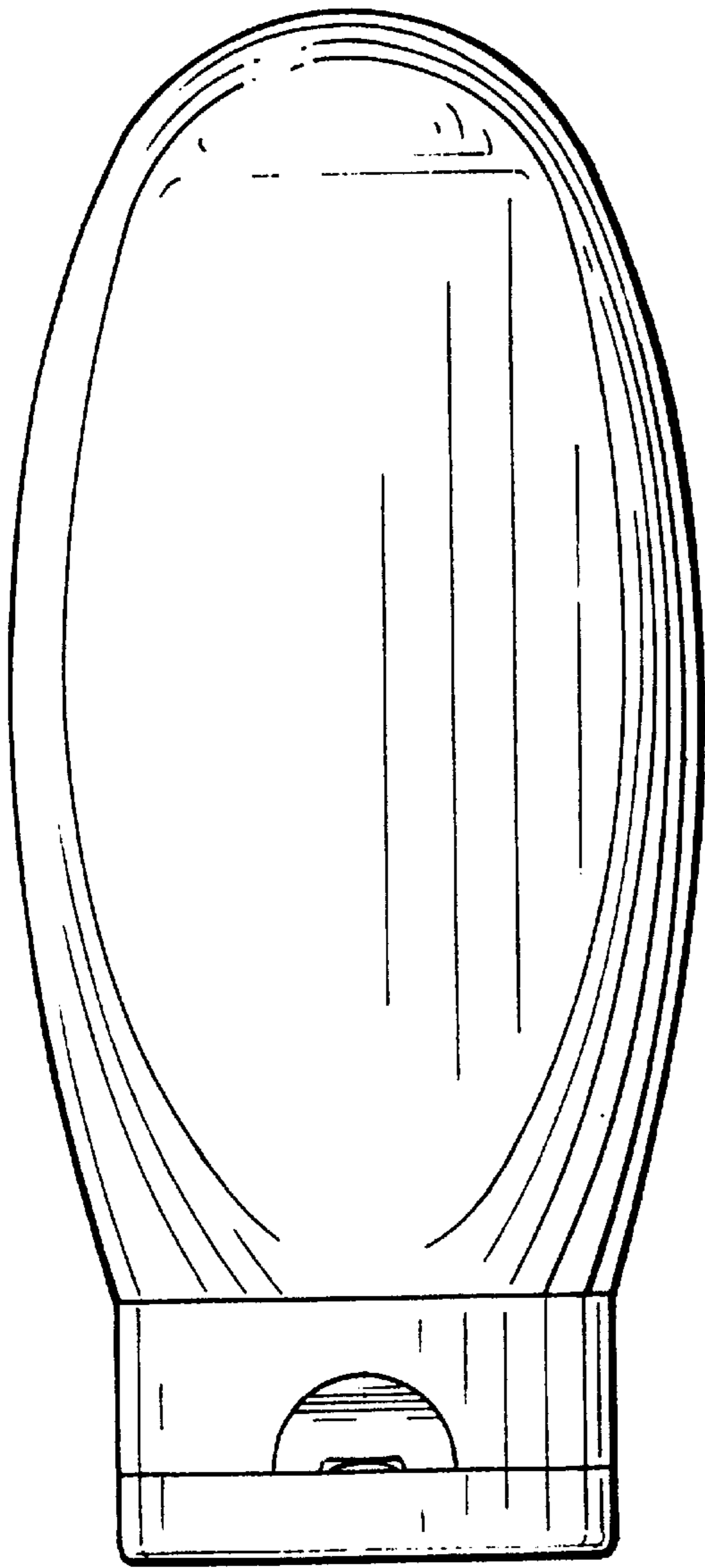

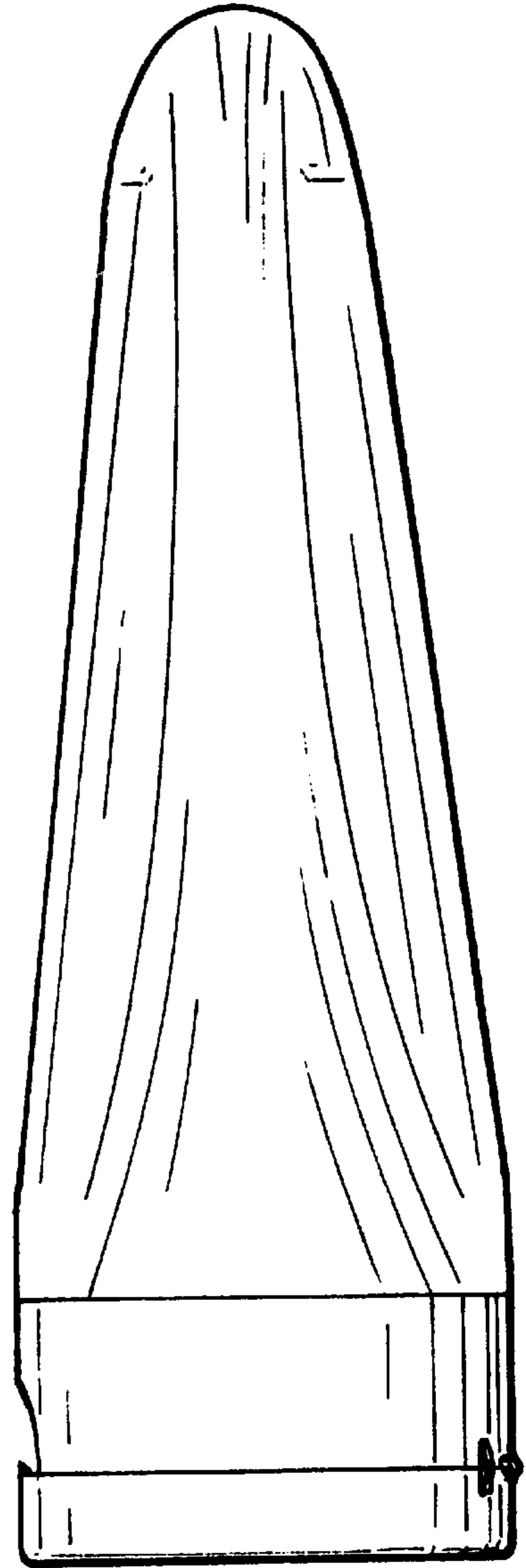

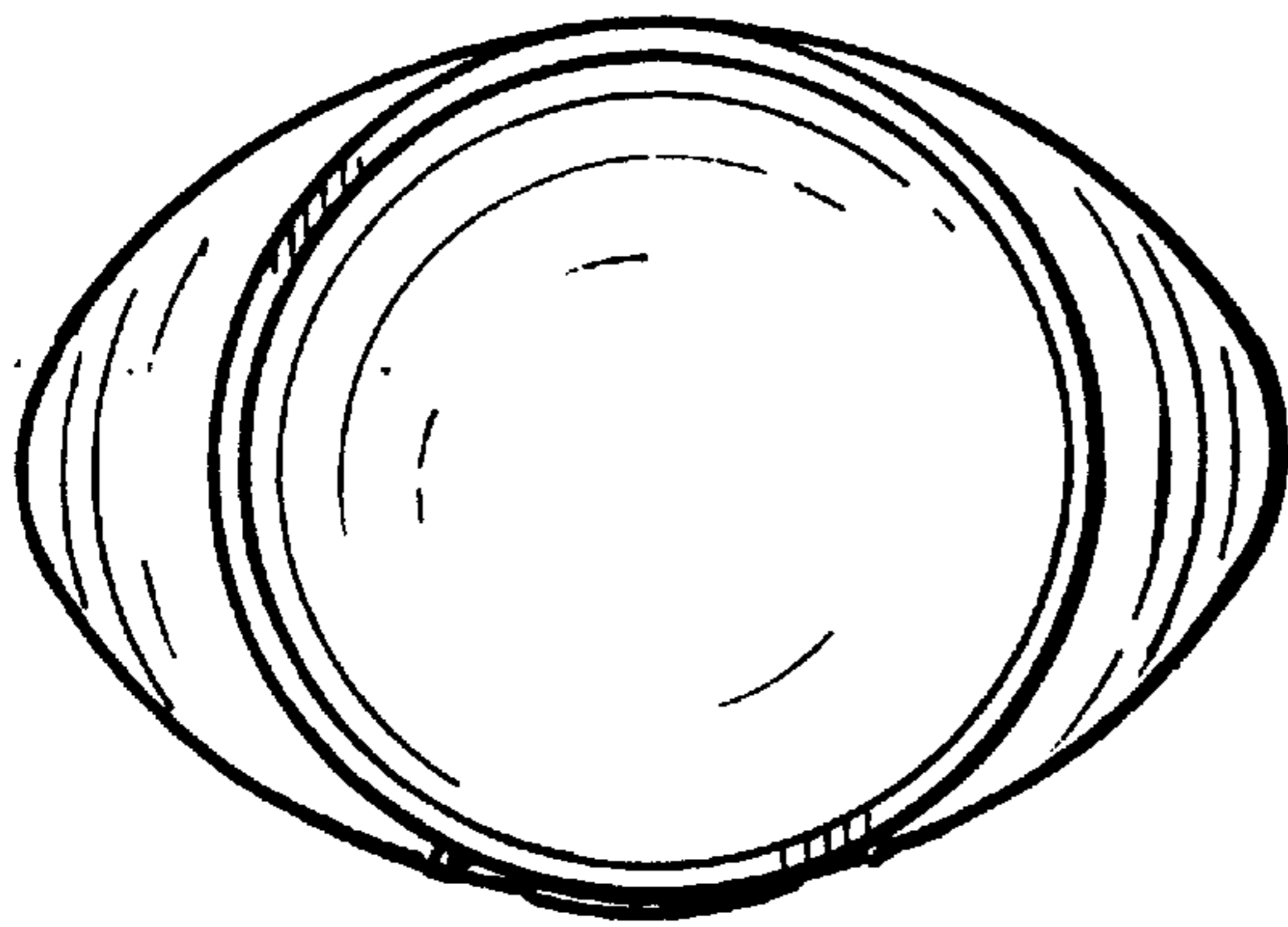

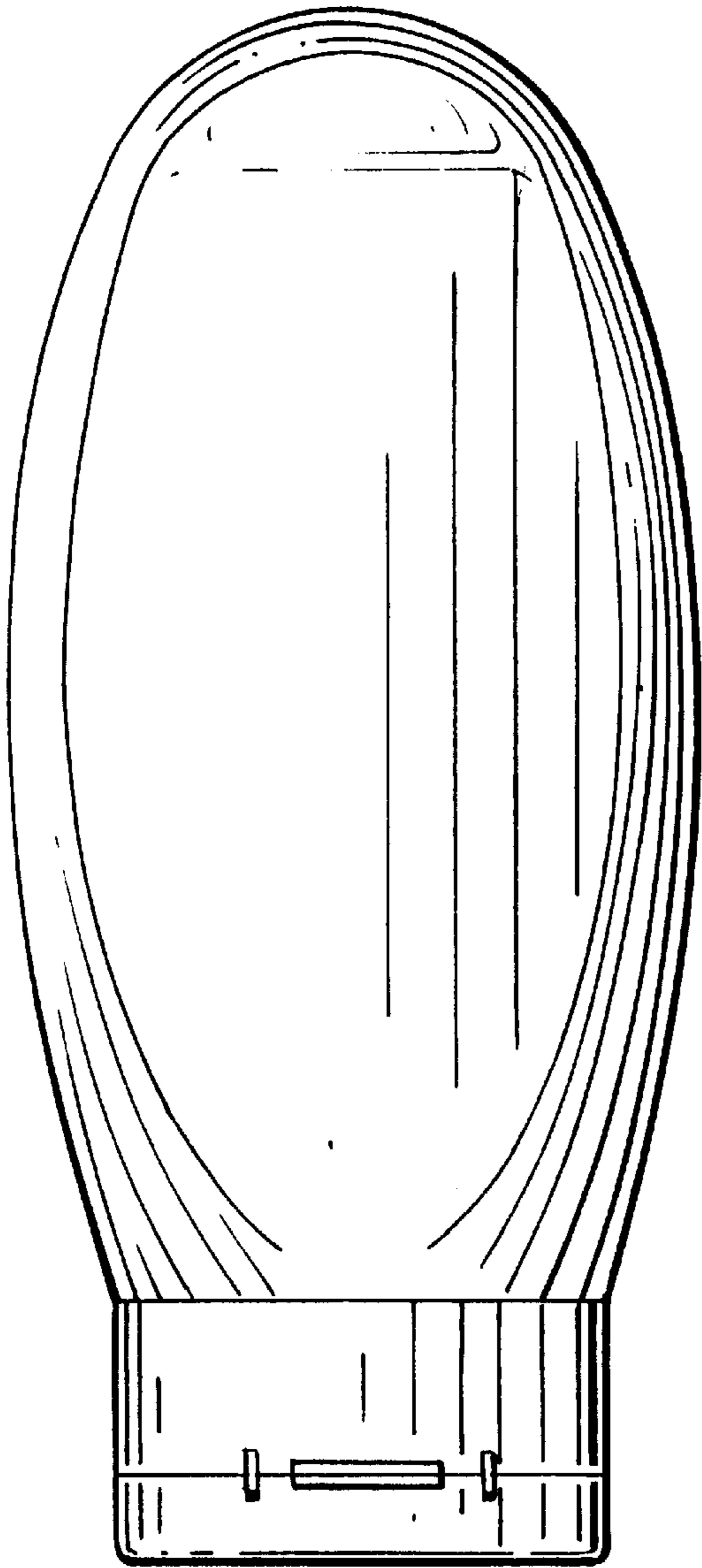

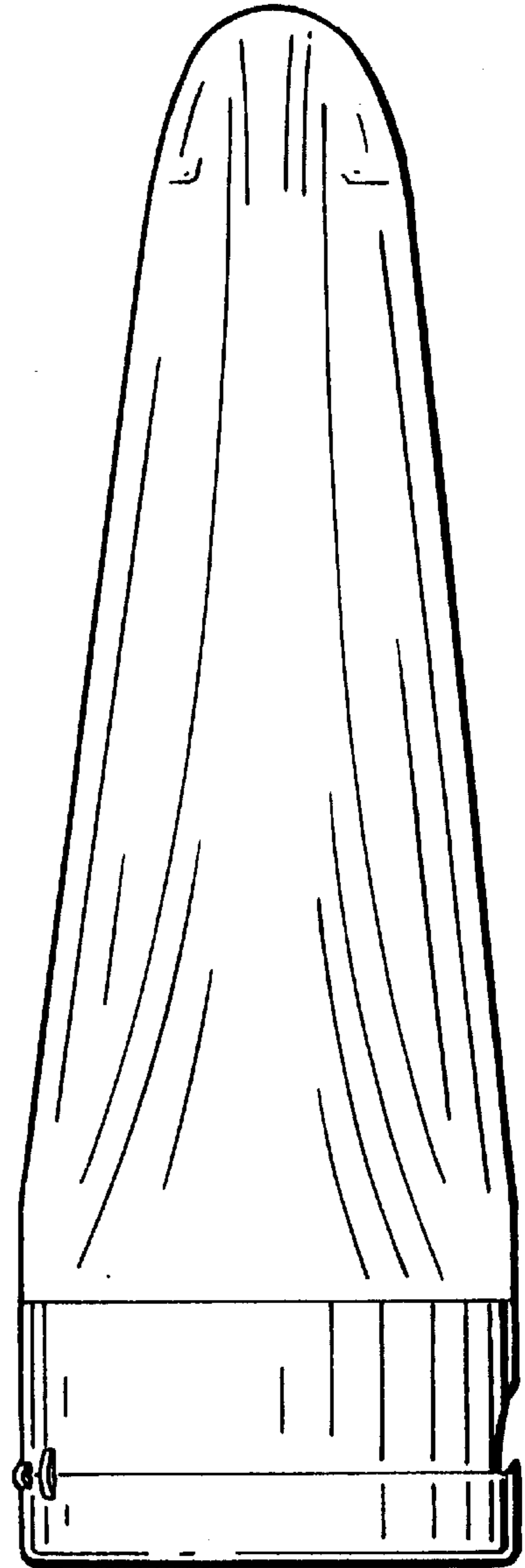

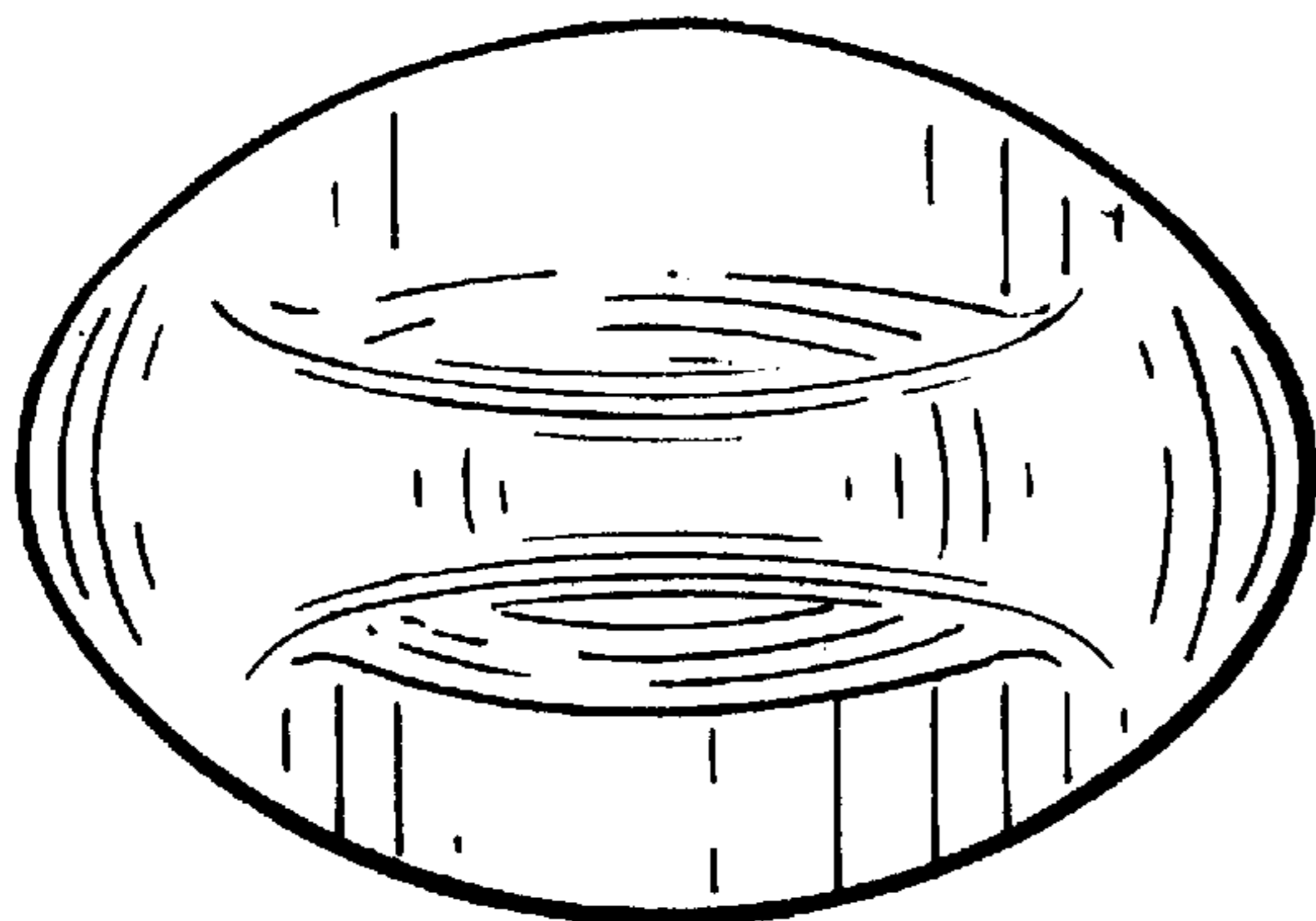
