FIG. 4 is a side view thereof, an opposite side view being a mirror image thereof;

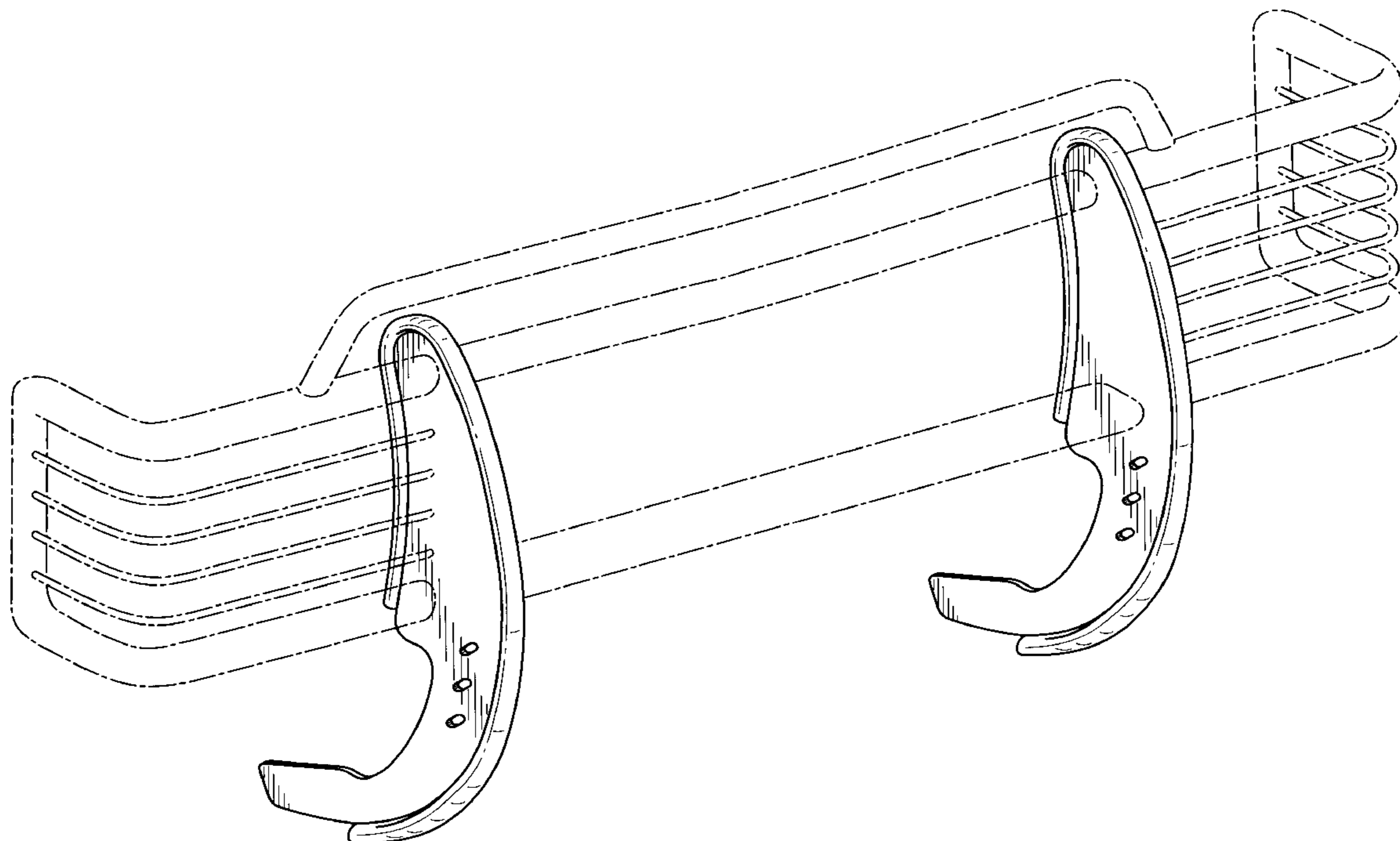
FIG. 5 is a rear view thereof; and,

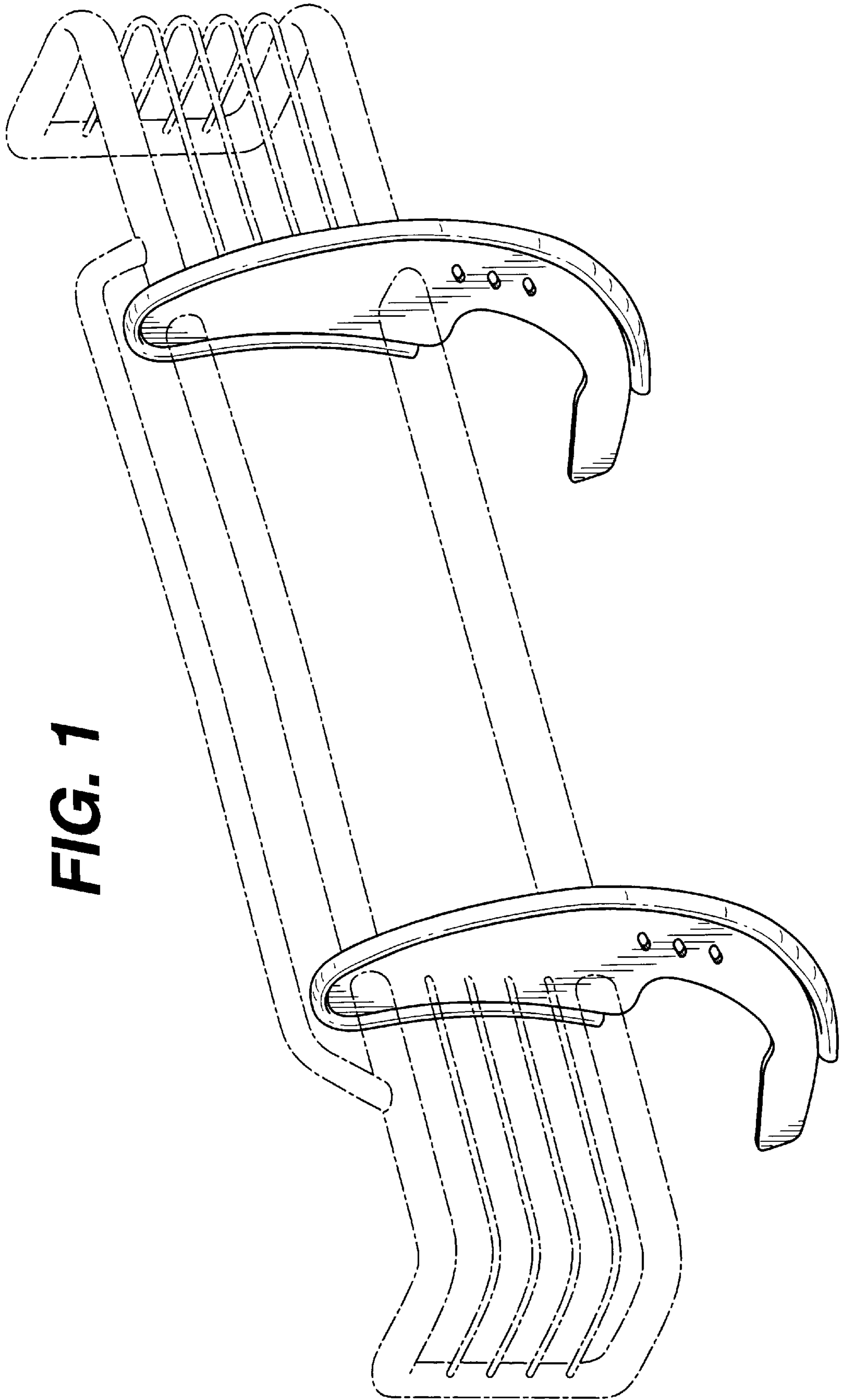

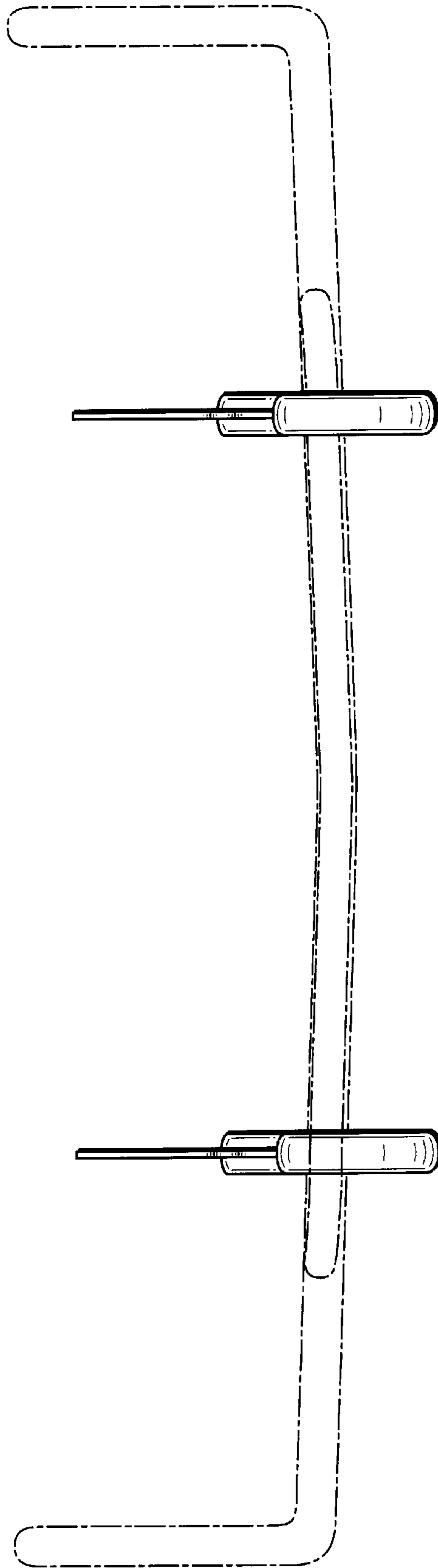

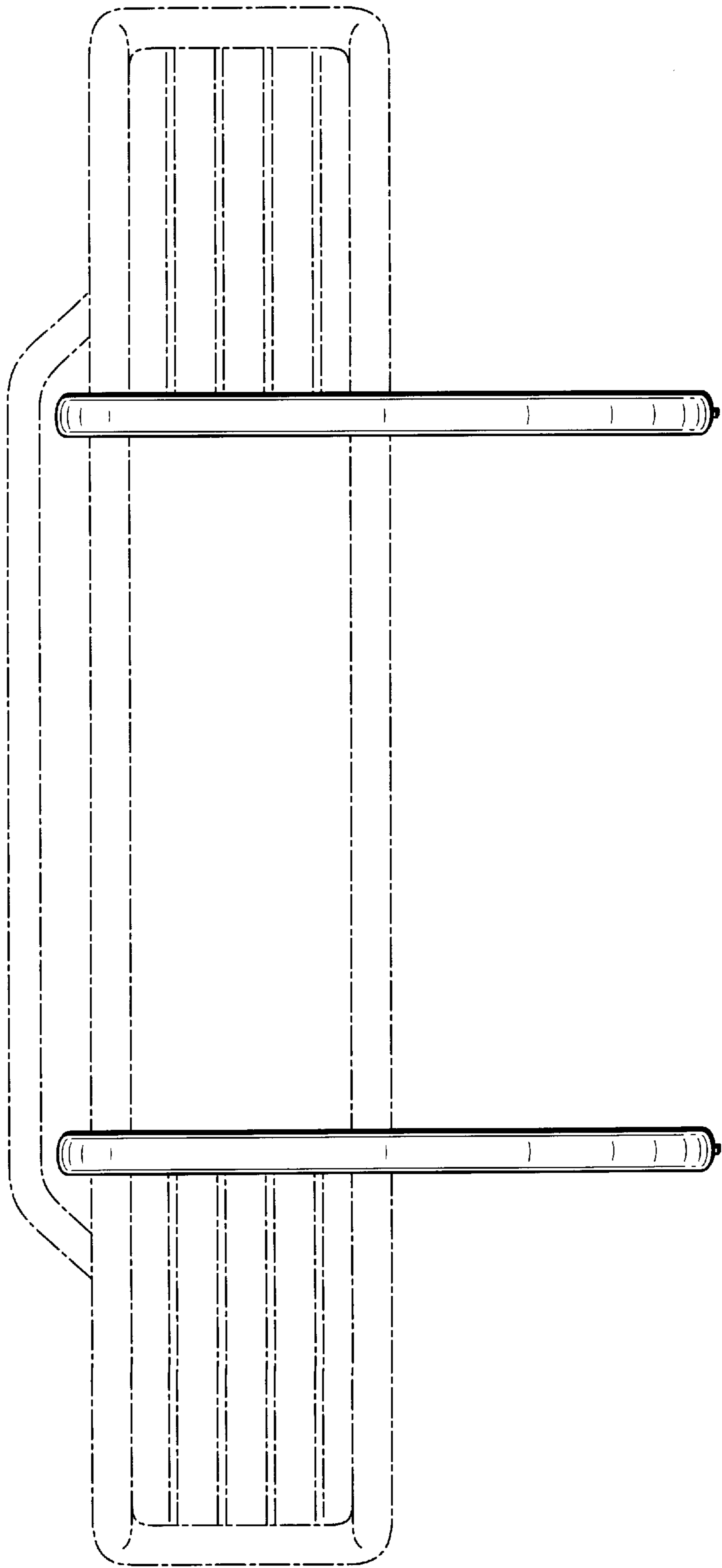

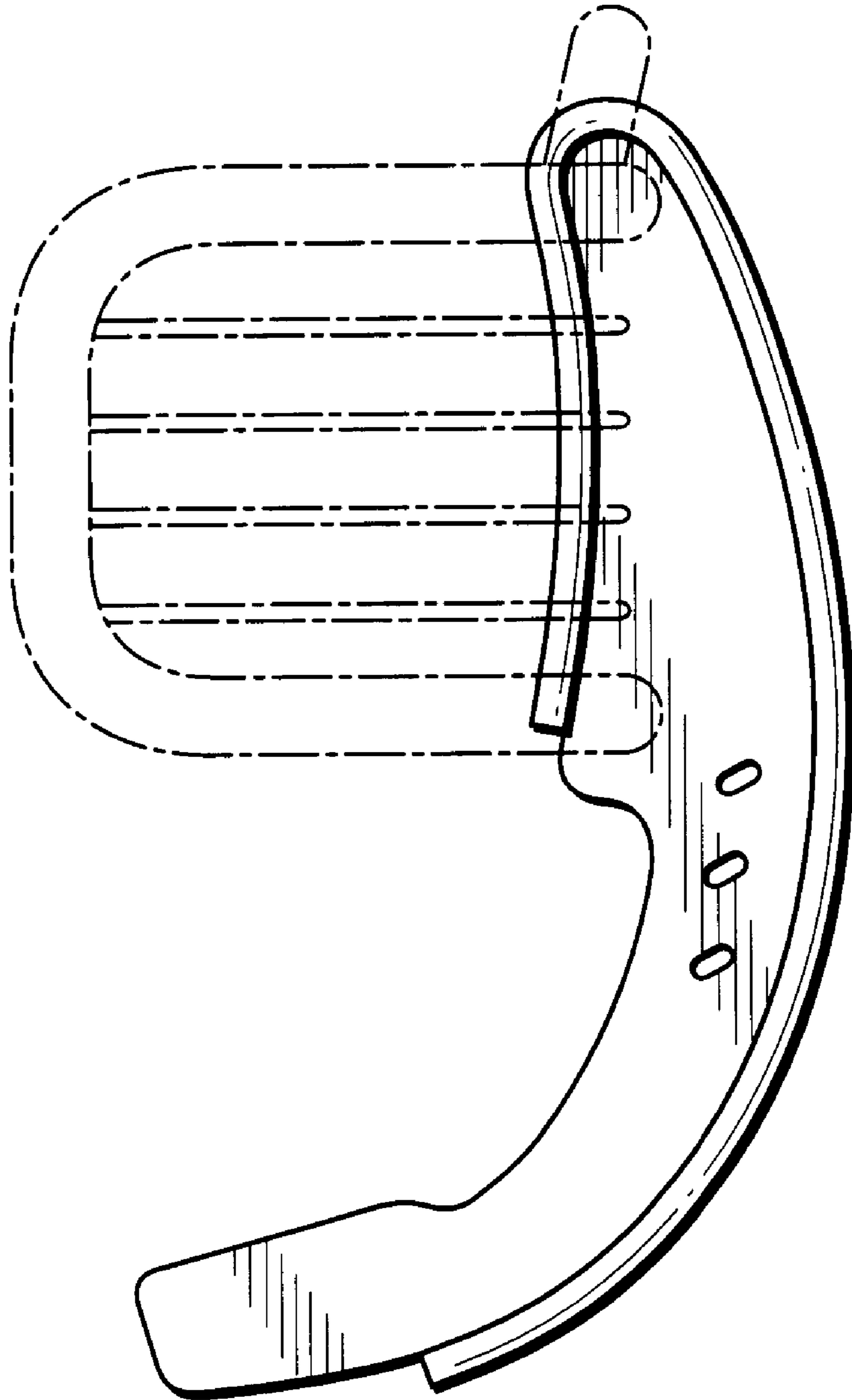

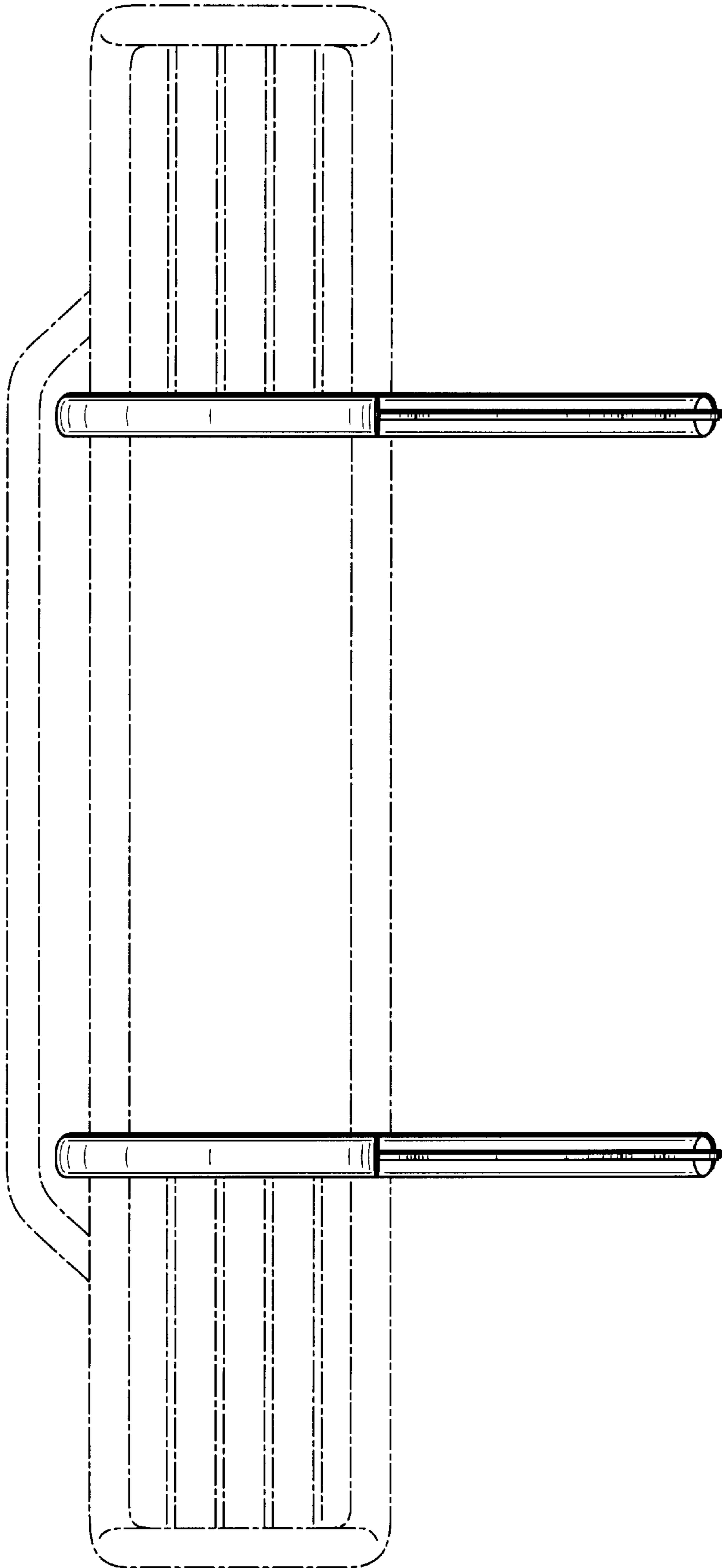
