FIG. 1 is a perspective view of a combined rearview mirror and signalling indicator showing my new design, and with

the signalling indicator energized, and with the broken line showing for illustrative purposes only and forming no part of the claim design;

DESCRIPTION

FIG. 2 is a front elevation view of the combined rearview mirror and signalling indicator of FIG. 1, and showing the signalling indicator energized;

FIG. 3 is a side elevation view of the combined rearview mirror and signalling indicator of FIG. 1;

FIG. 4 is a second side elevation view of the combined rearview mirror and signalling indicator of FIG. 1, and which is taken from a position opposite to that shown in FIG. 3;

FIG. 5 is a third side elevation view of the combined rearview mirror and signalling indicator of FIG. 1, and which is taken from a position approximately 90 degrees from the orientation shown in FIGS. 3 or 4;

FIG. 6 is a rear elevation view of the combined rearview mirror and signalling indicator shown in FIG. 1;


FIG. 7 is a perspective view of the combined rearview mirror and signalling indicator showing my new design, and with the signalling indicator energized;


FIG. 8 is a second perspective view of the combined rearview mirror and signalling indicator showing my new design and with the signalling indicator energized;

FIG. 9 is a perspective view of the combined rearview mirror and signalling indicator showing my new design and with the signalling indicator deenergized; and,


FIG. 10 is a second perspective view of the combined rearview mirror and signalling indicator showing my new design with the signalling indicator deenergized.


