FIG. 6 is a rear view thereof.

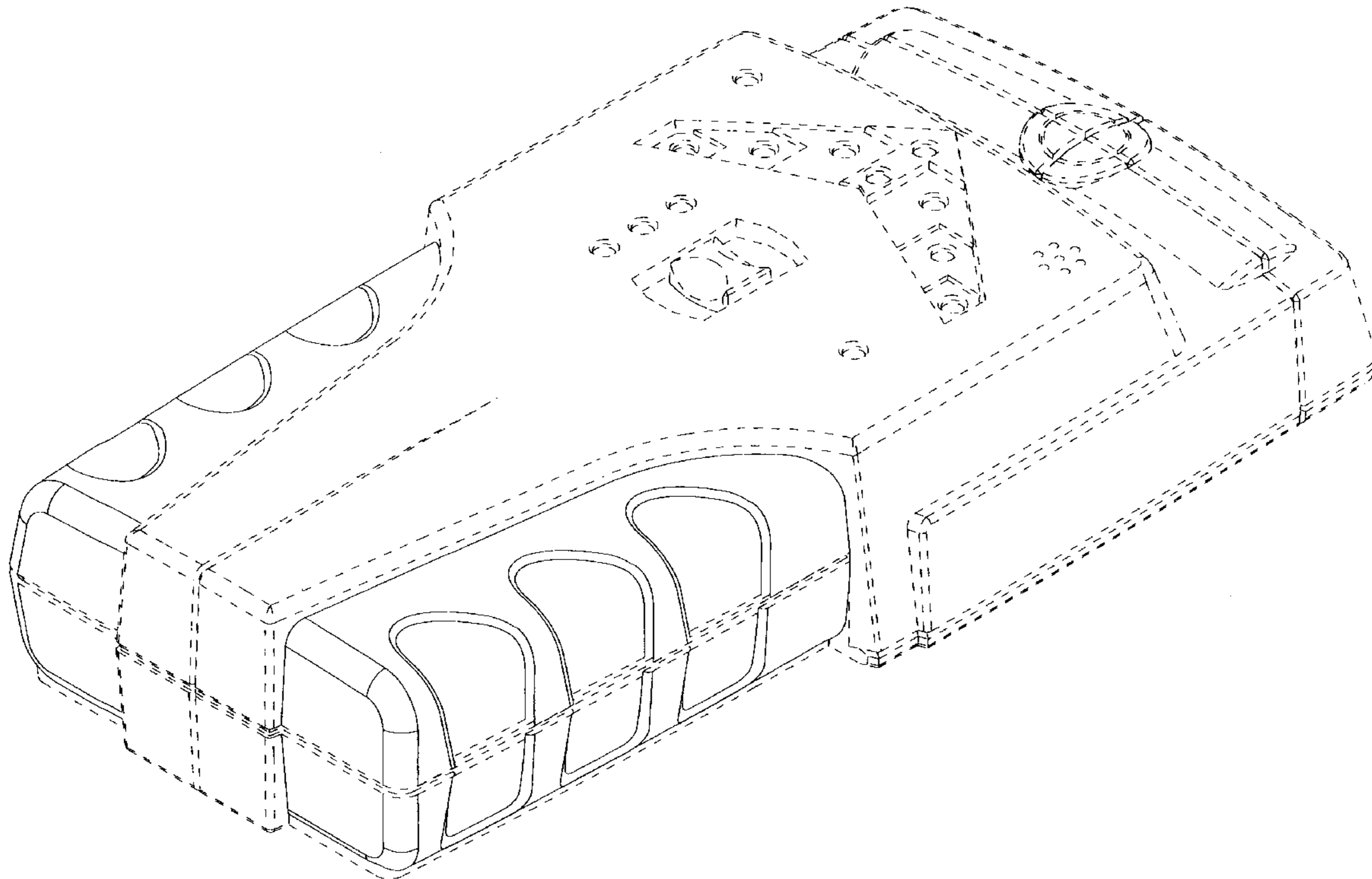
The broken lines shown in FIGS. 1-6 are environmental only and form no part of the claimed design.

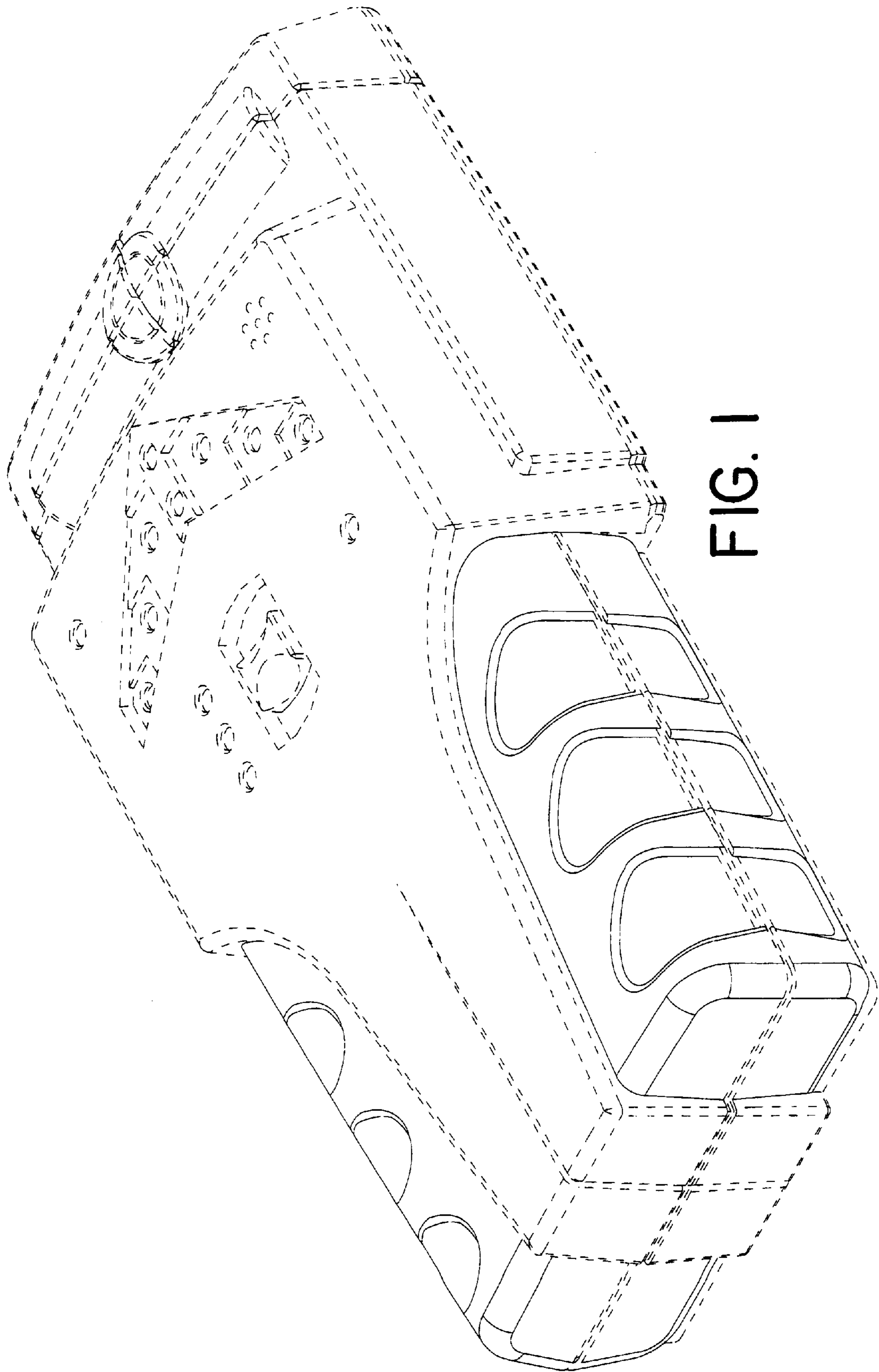

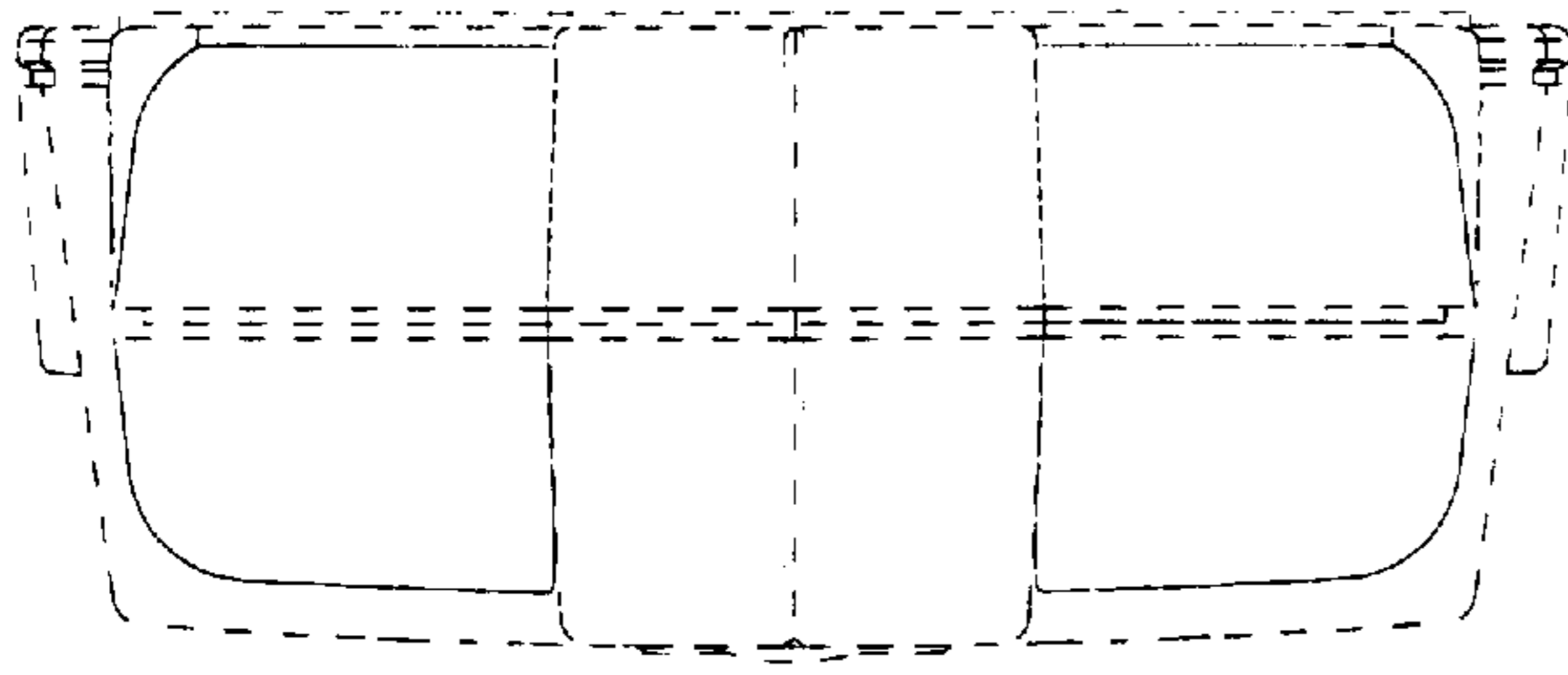

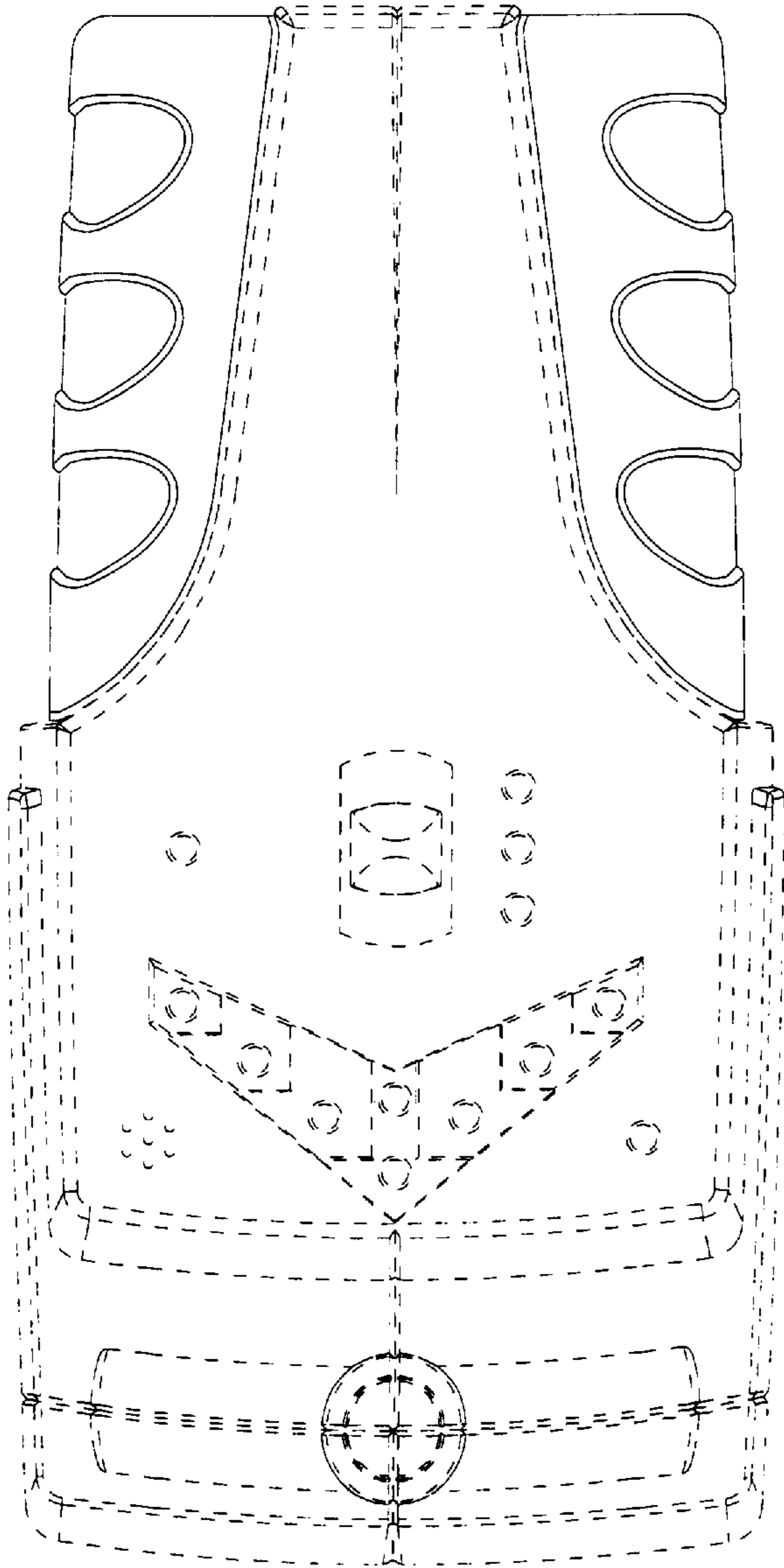

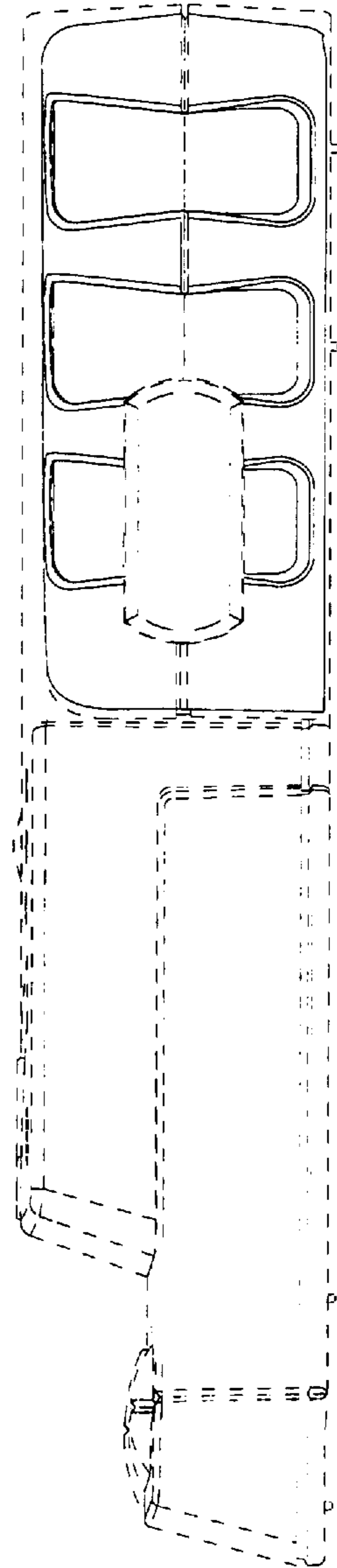

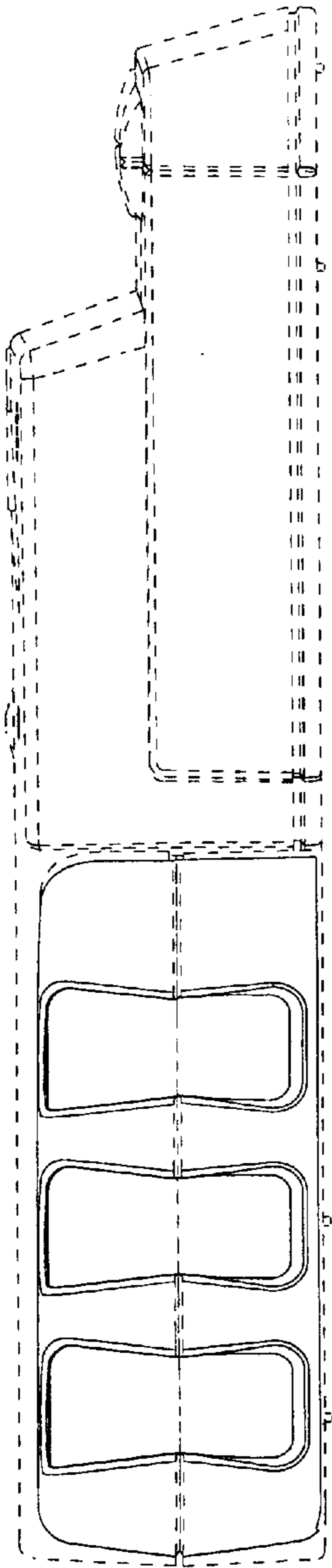

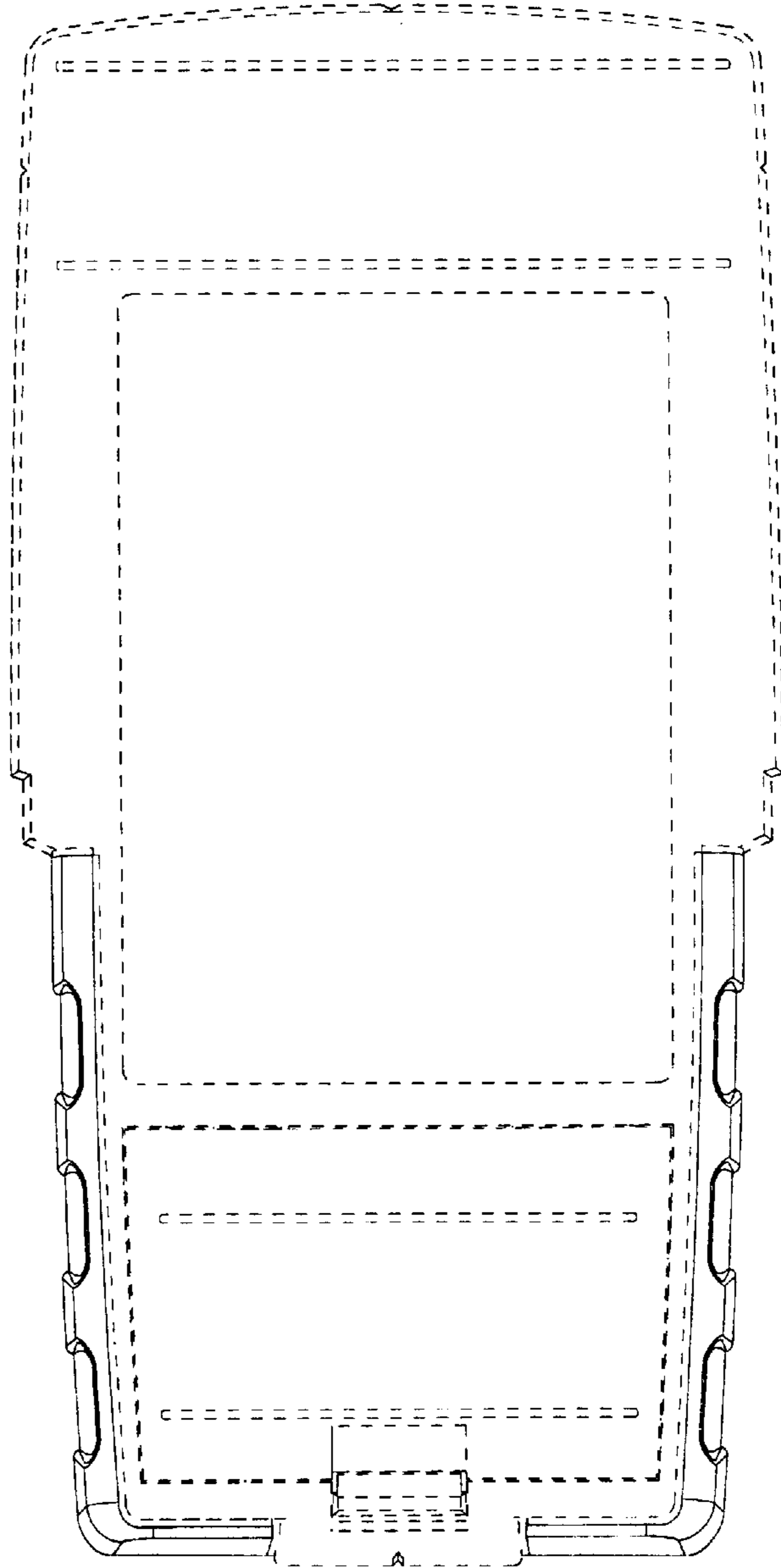
