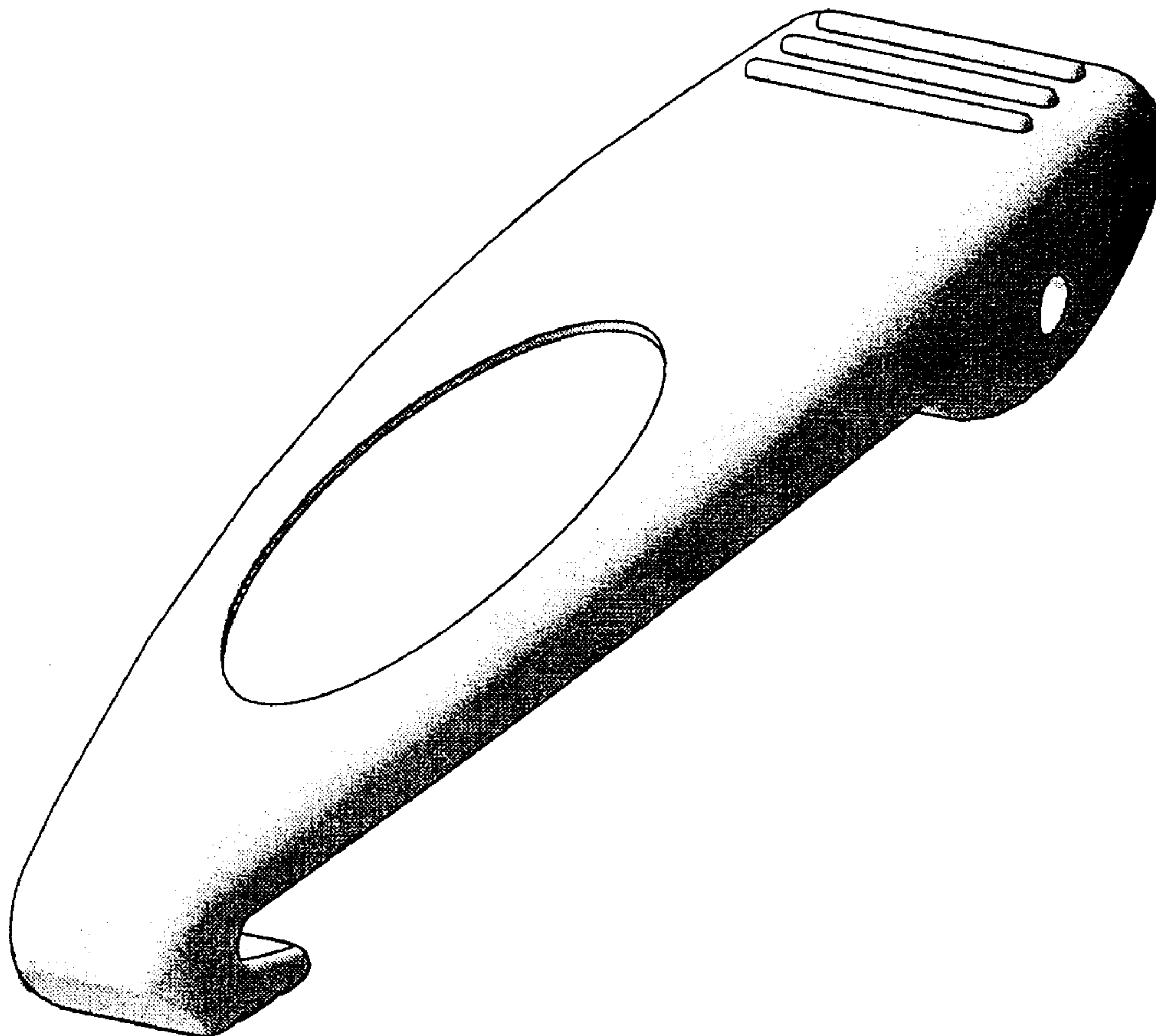
[57] **CLAIM**

The ornamental design for a portable electronic device attachment clip, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portable electronic device attachment clip in accordance with our new design;
 FIG. 2 is a top view of the portable electronic device attachment clip shown in FIG. 1;
 FIG. 3 is a rear view of the portable electronic device attachment clip shown in FIG. 1;
 FIG. 4 is a right side view of the portable electronic device attachment clip shown in FIG. 1;
 FIG. 5 is a left side view of the portable electronic device attachment clip shown in FIG. 1;
 FIG. 6 is a bottom view of the portable electronic device attachment clip shown in FIG. 1; and,
 FIG. 7 is a bottom, right and front perspective view of the portable electronic device attachment clip shown in FIG. 1.

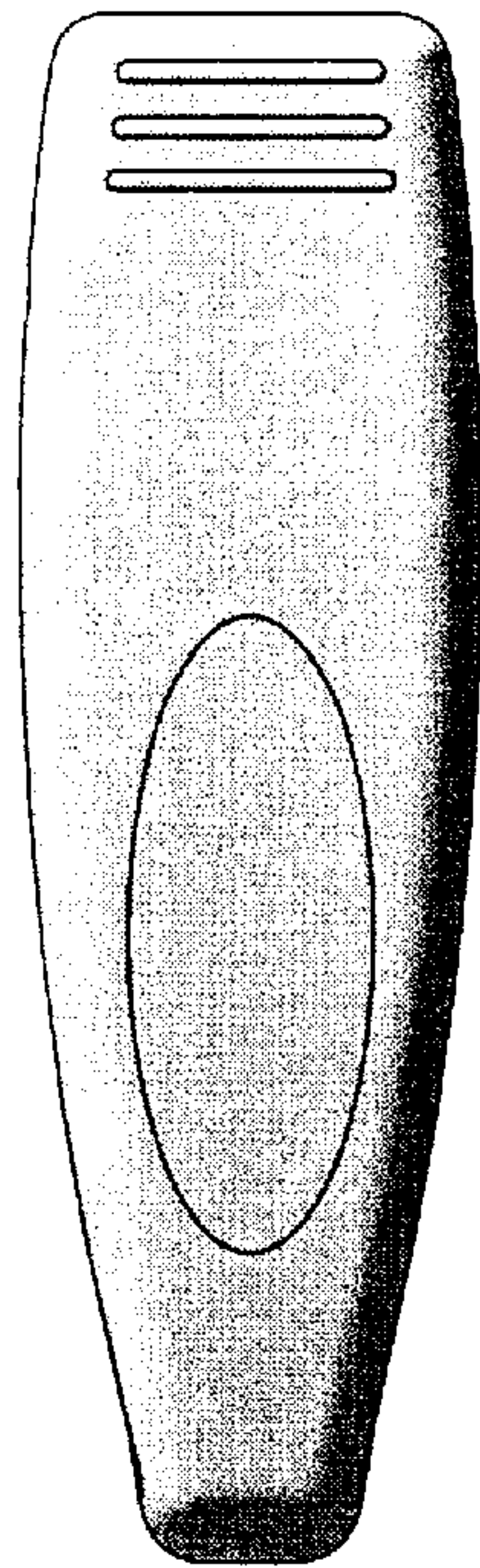

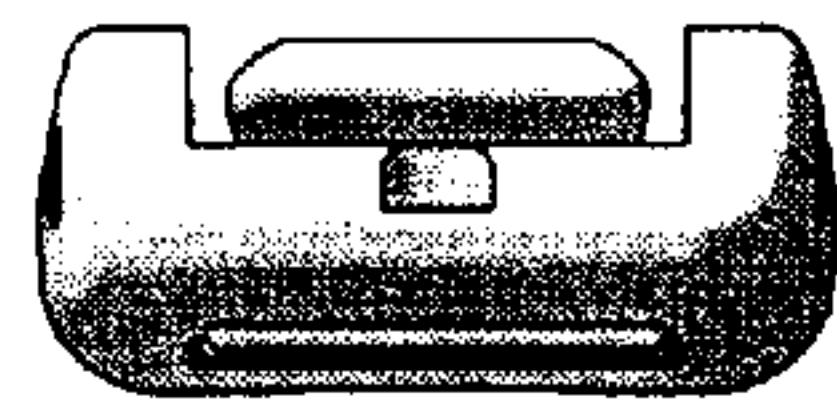

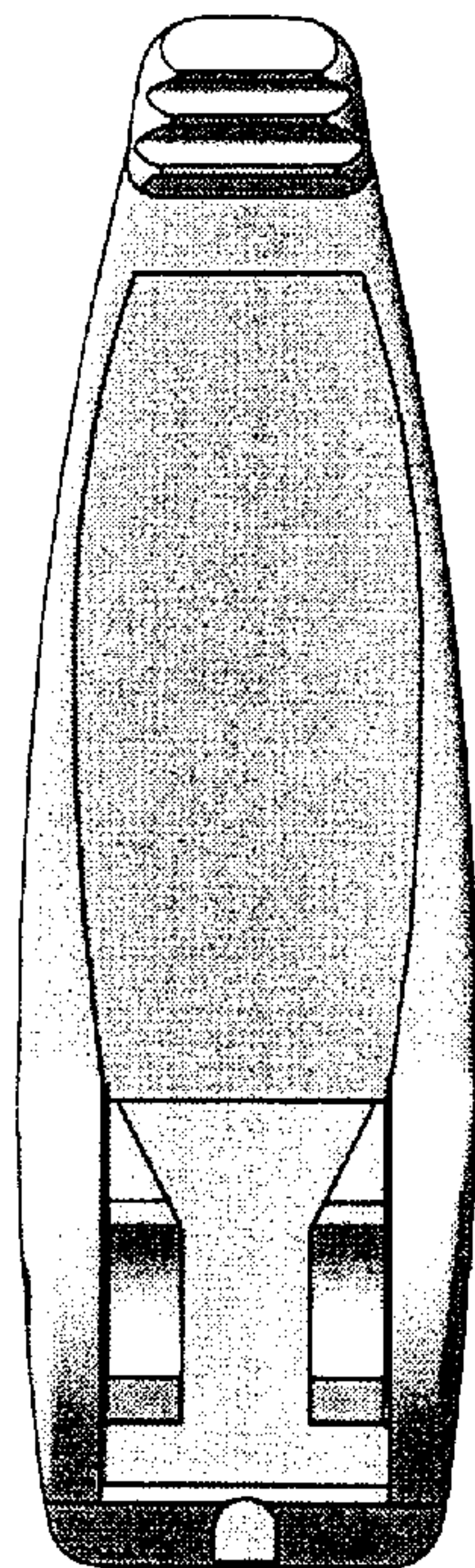

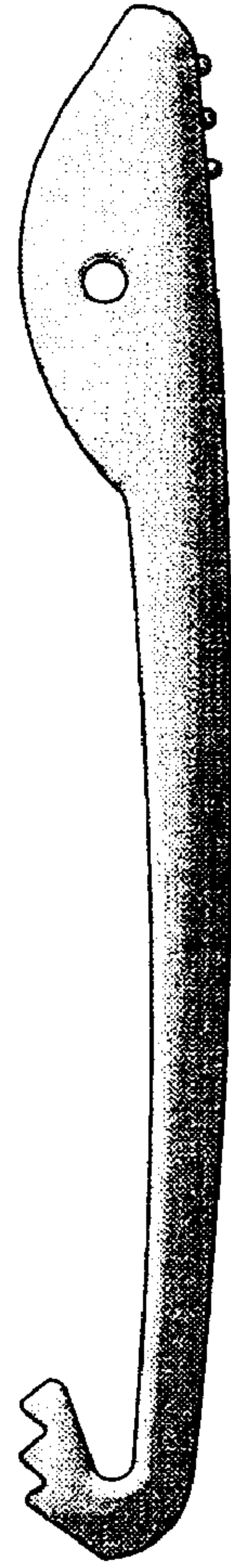

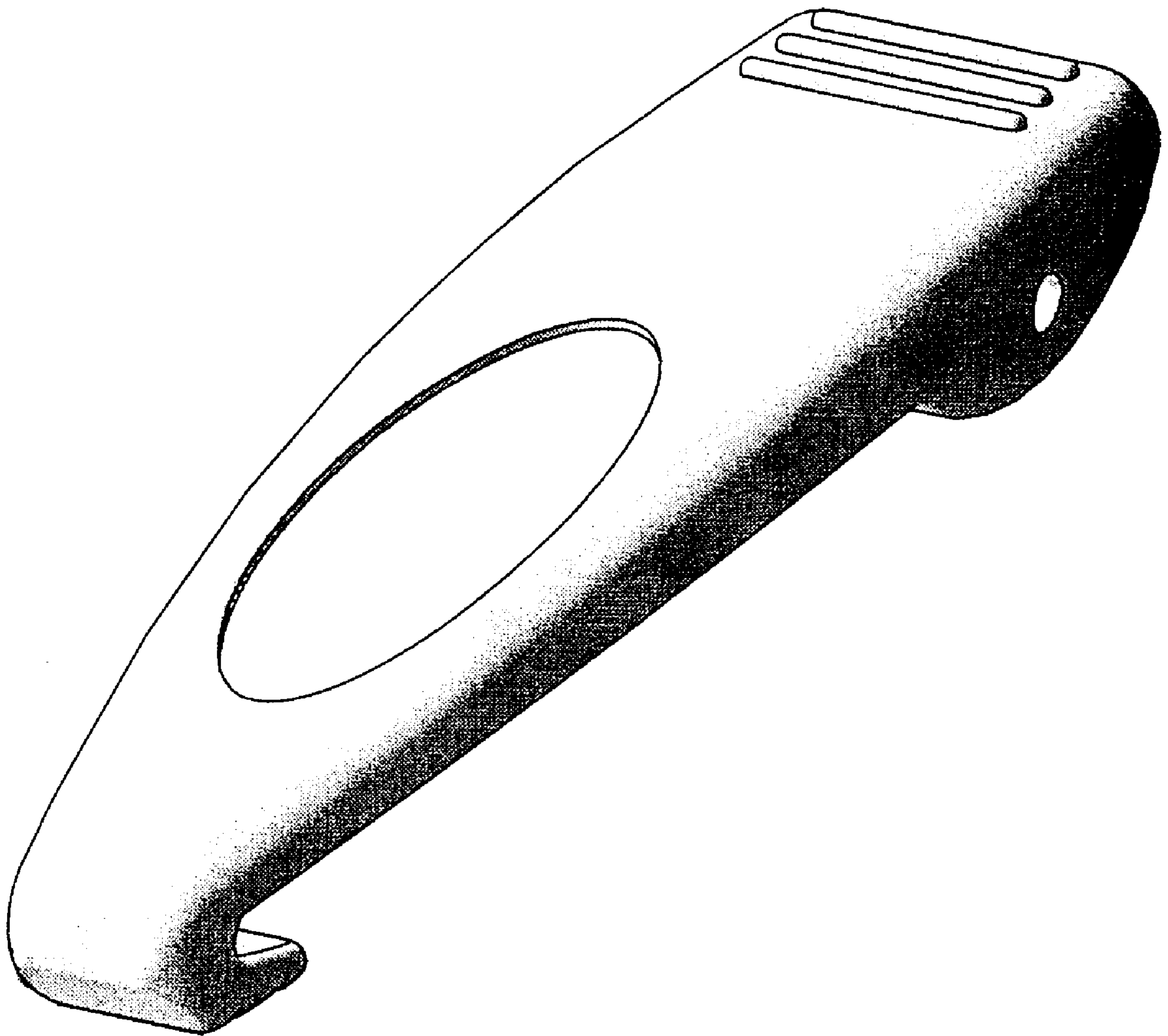
