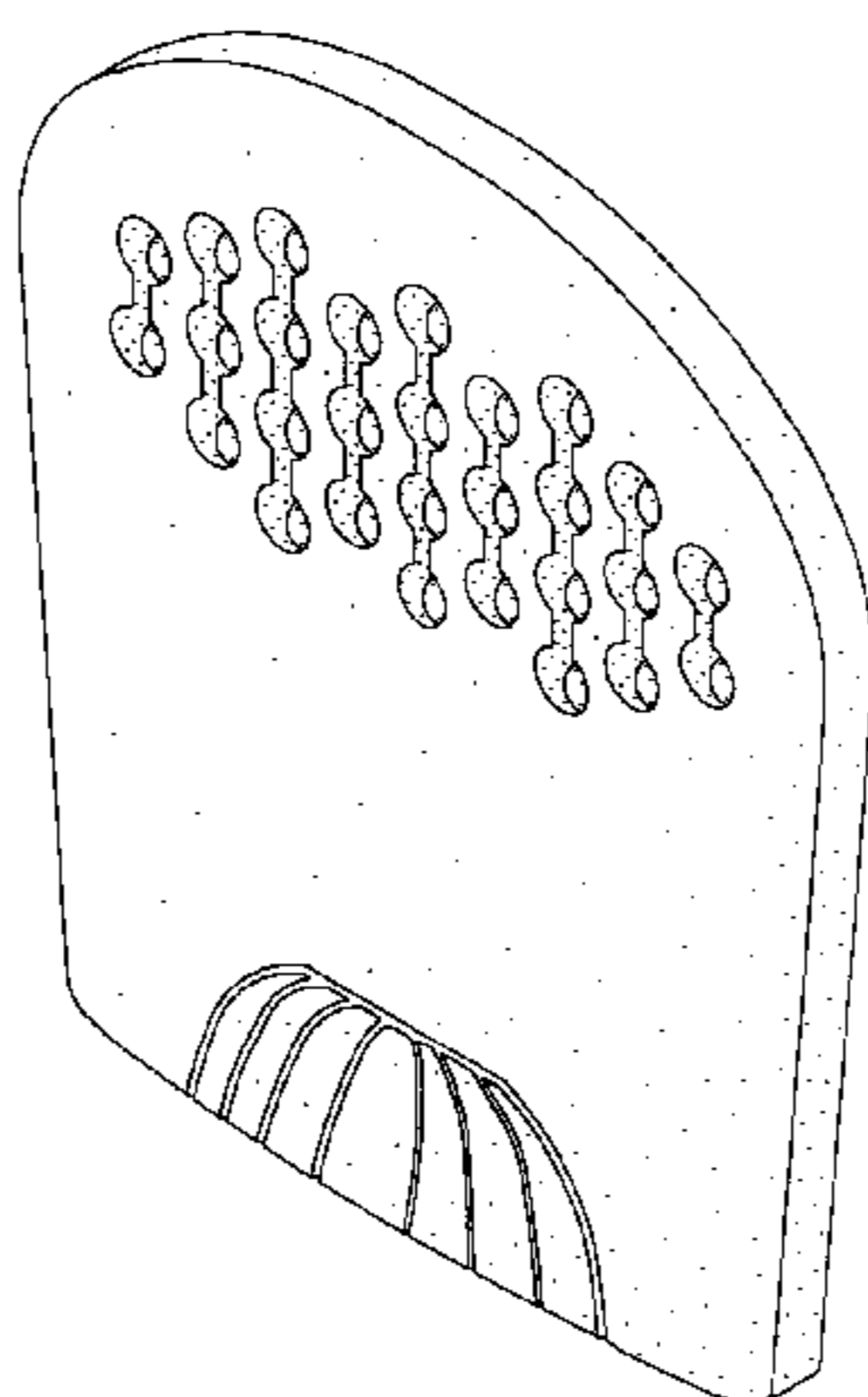
[57] **CLAIM**

The ornamental design for an applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an applicator, embodying our new design;  
FIG. 2 is top view thereof;  
FIG. 3 is rear elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a right side elevational view thereof; the left side elevational view thereof being a mirror image; and,  
FIG. 6 is a bottom view thereof.

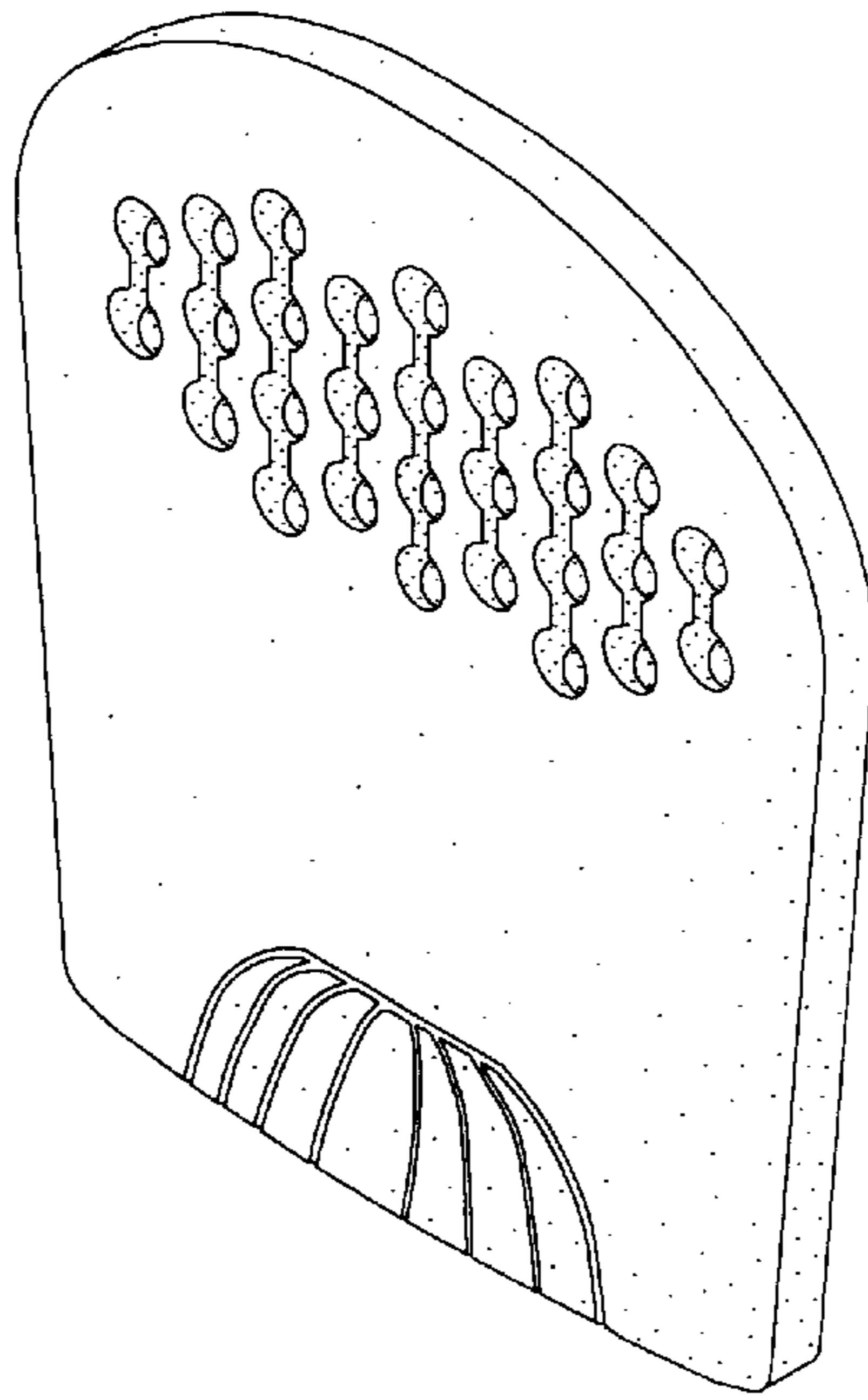

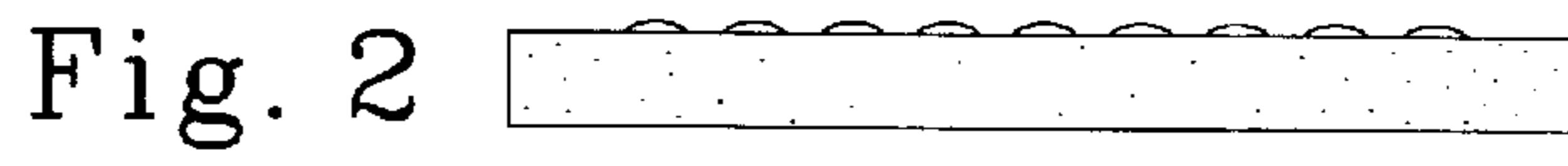

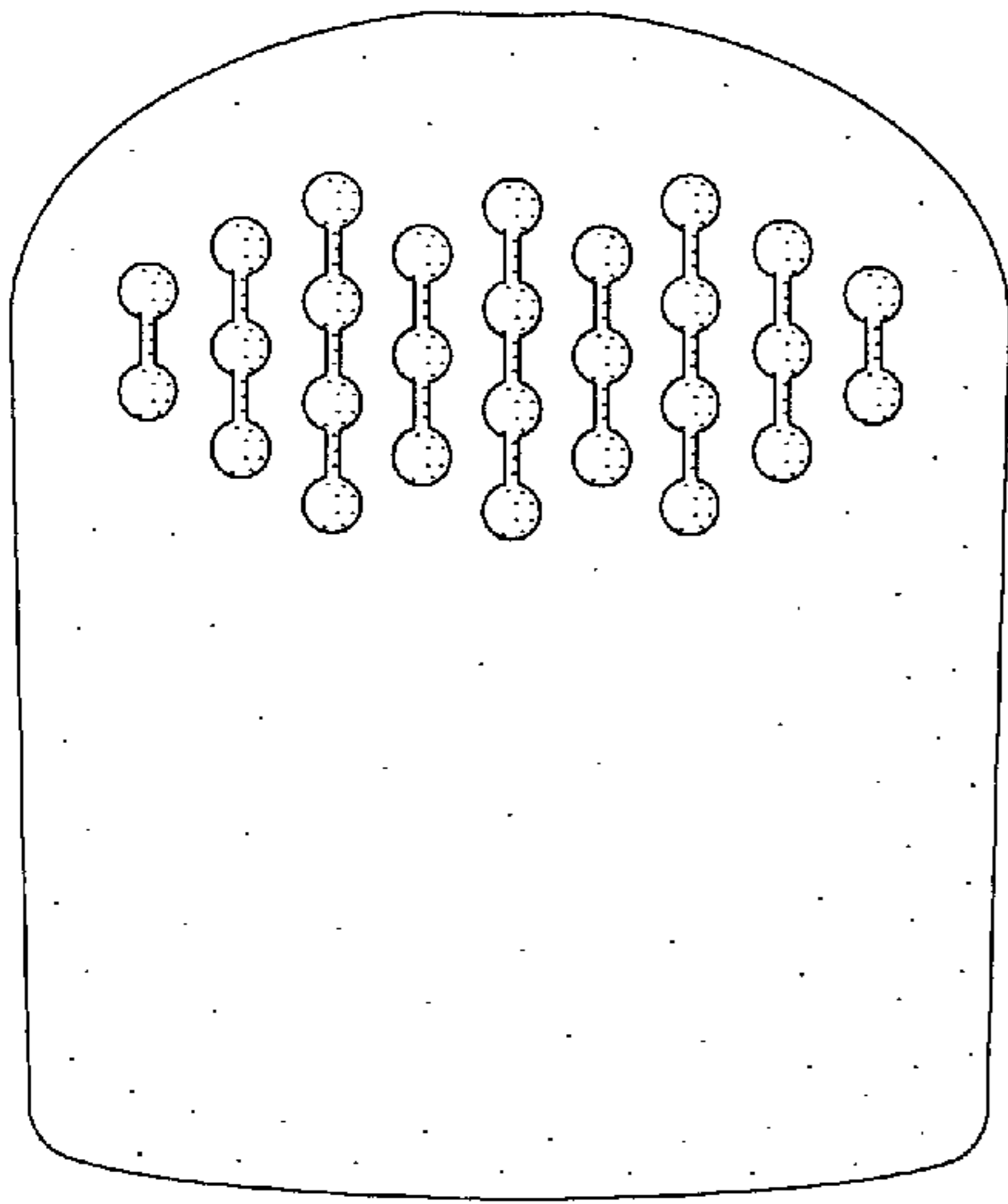

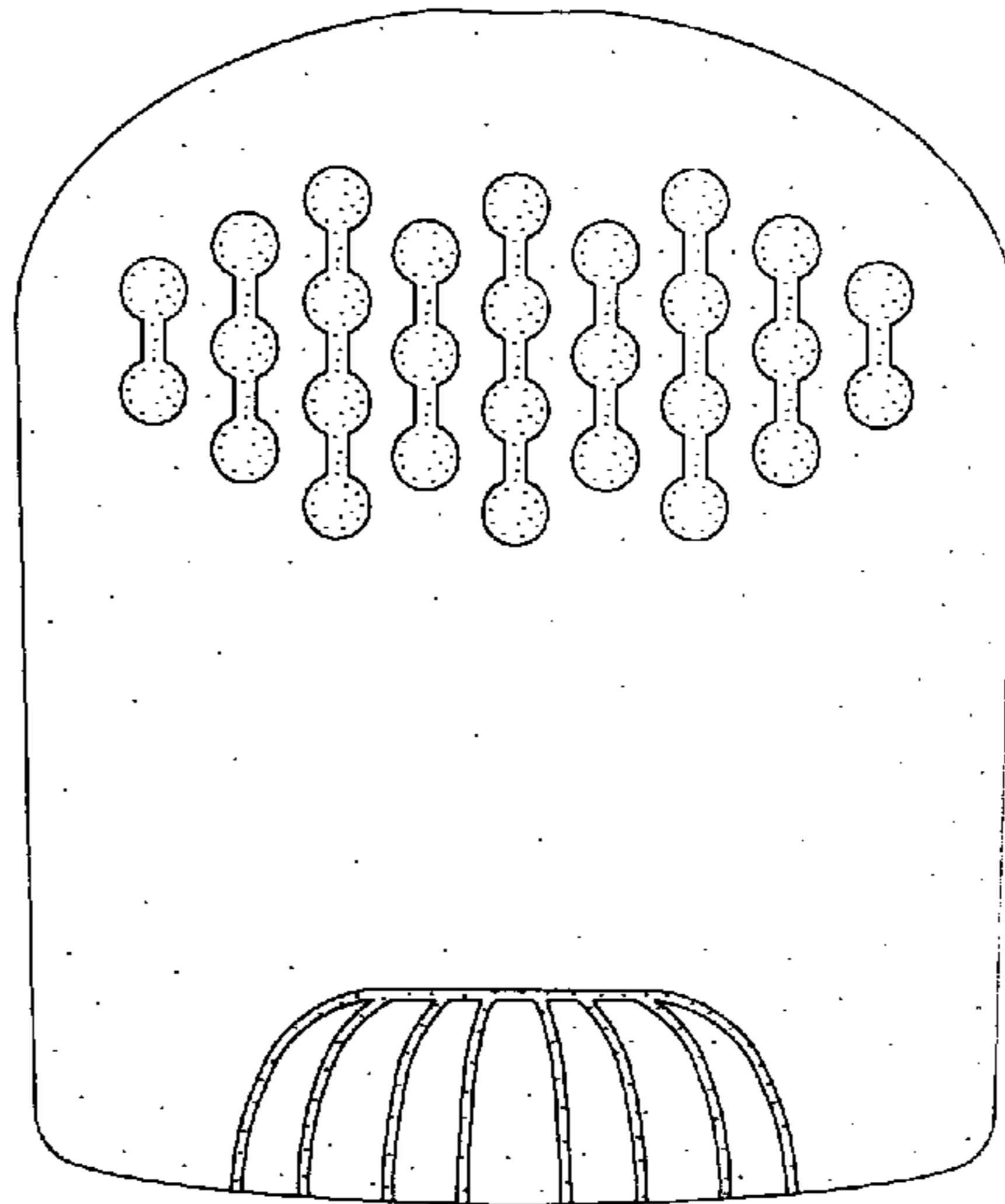

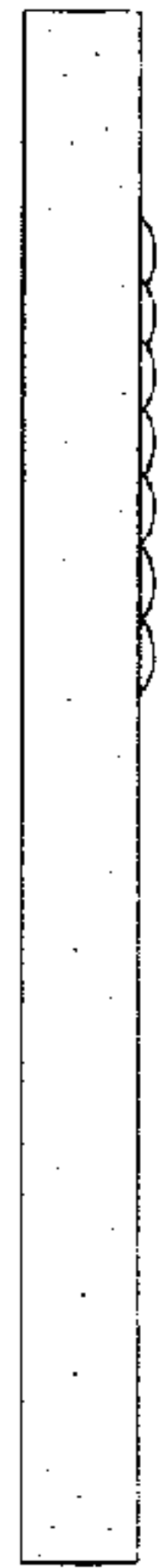

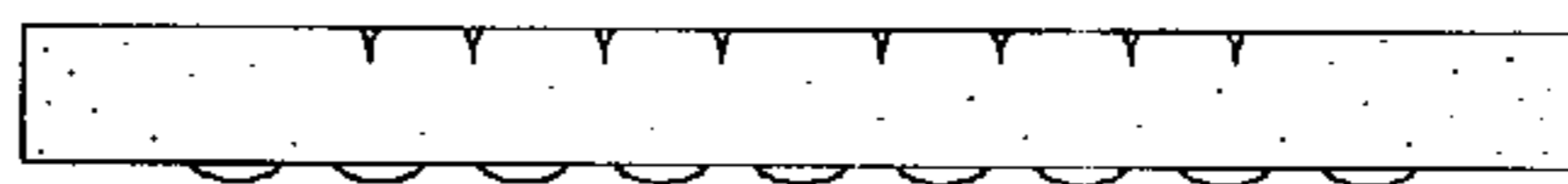
