DESCRIPTION

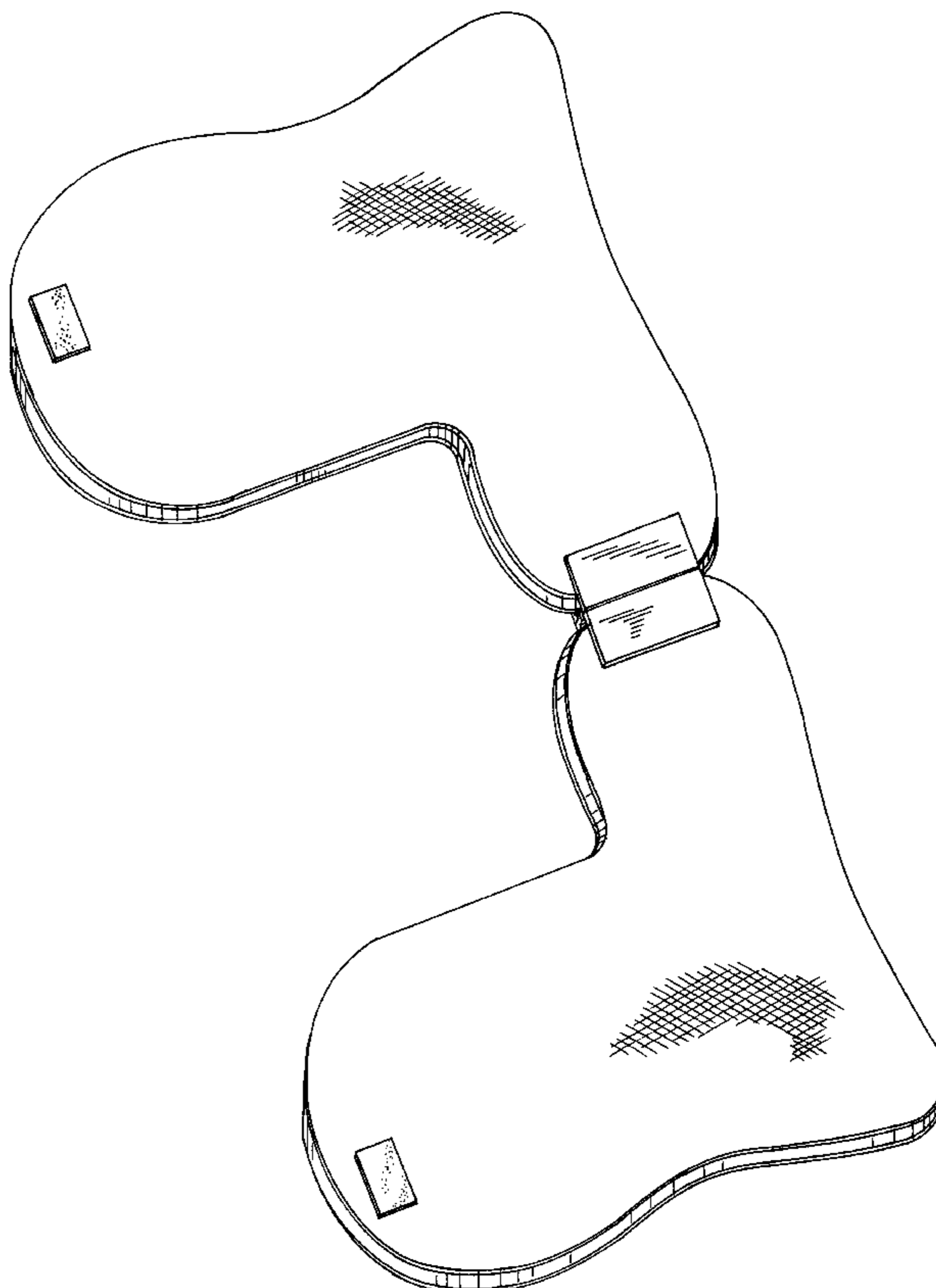
FIG. 1 is a side perspective view of the hairspray shield of my invention;

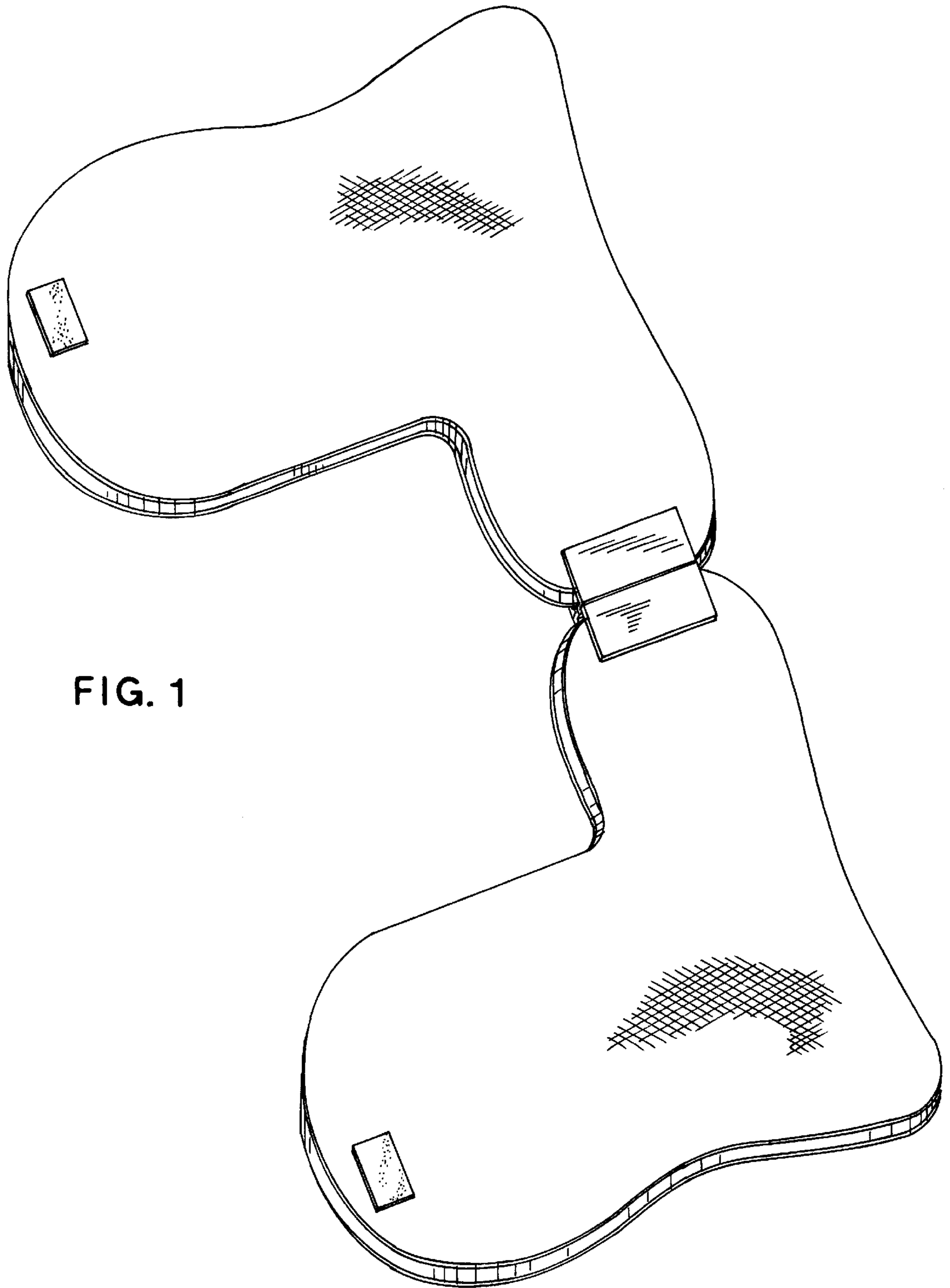

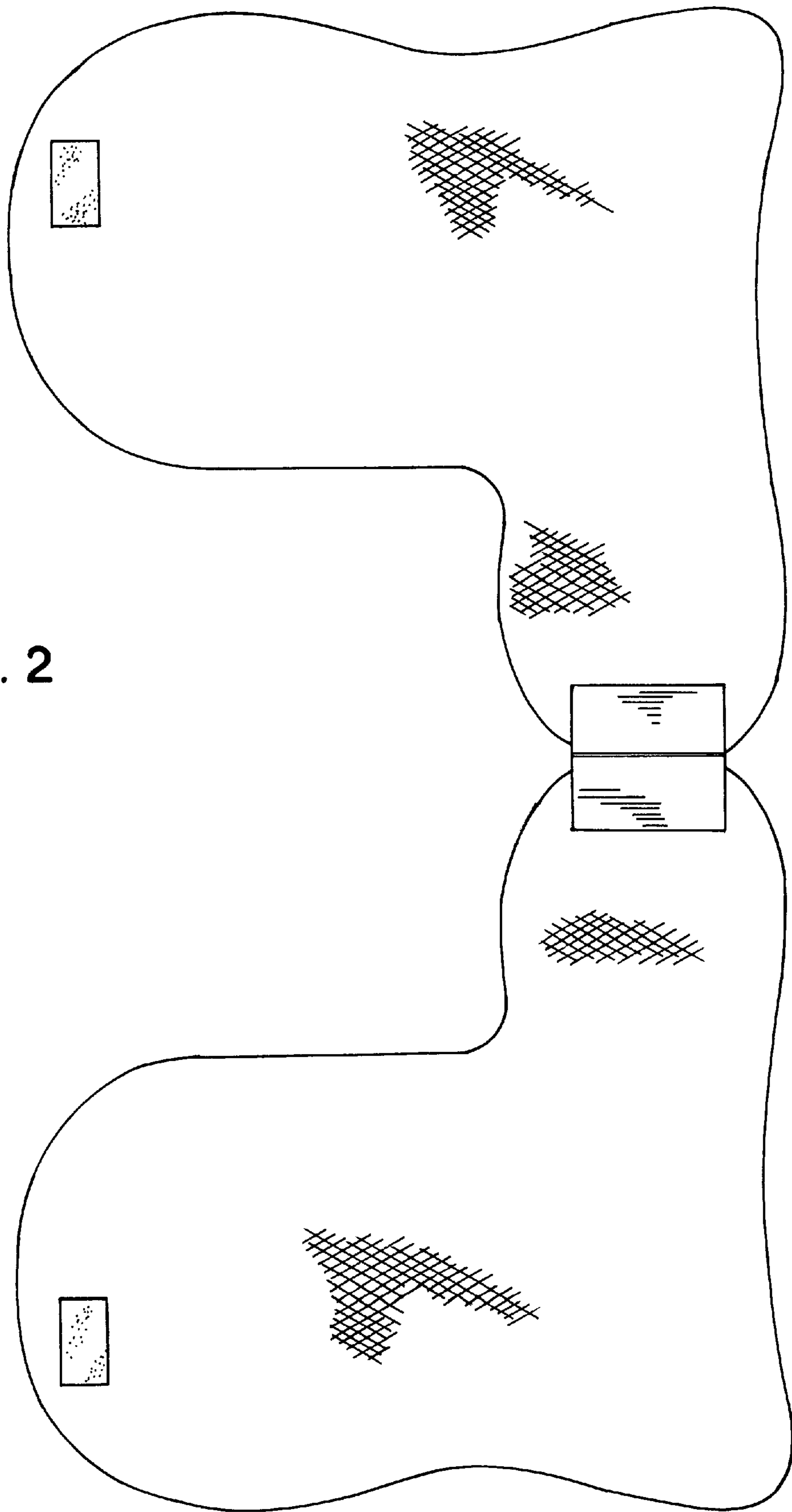
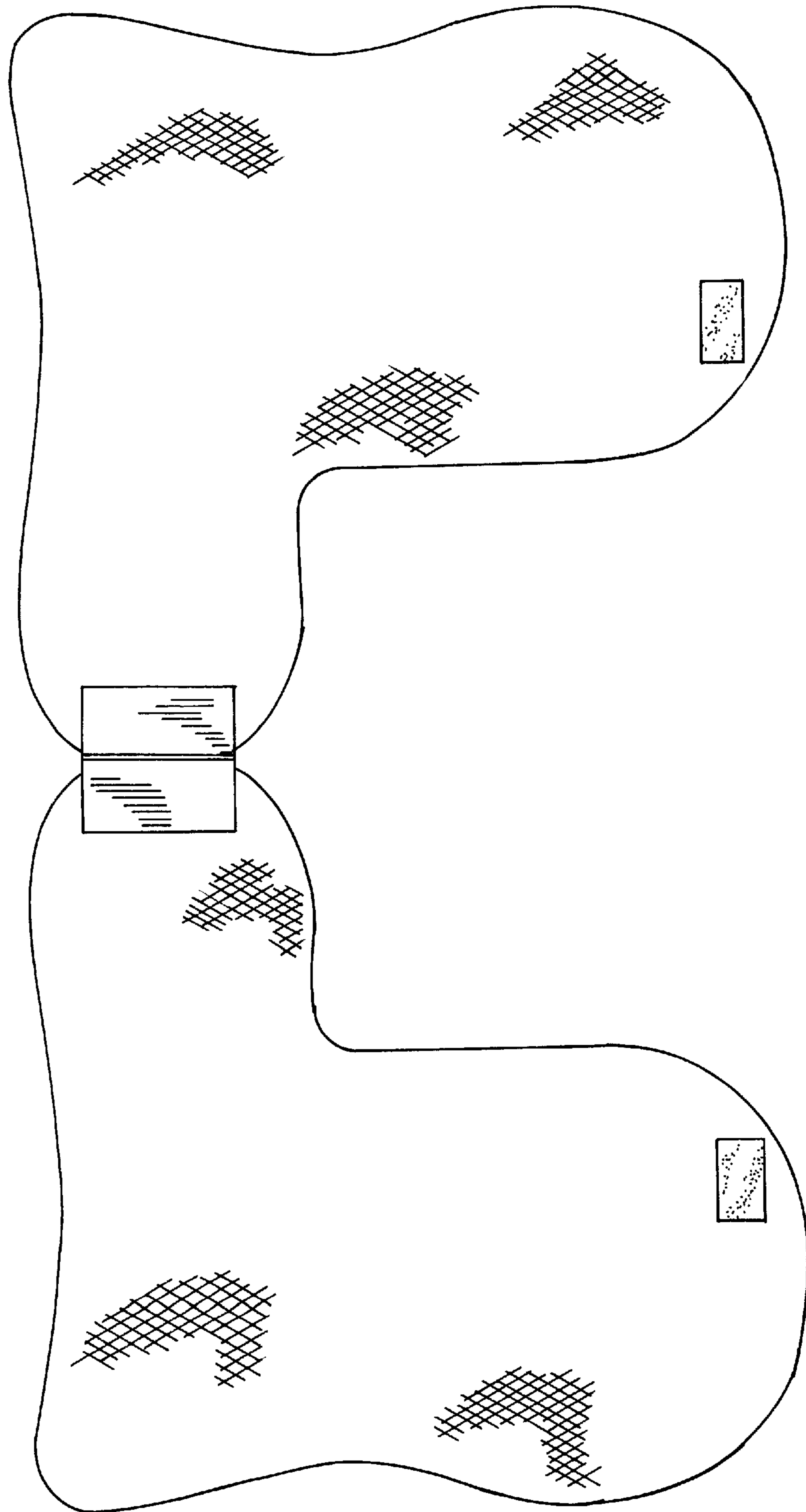

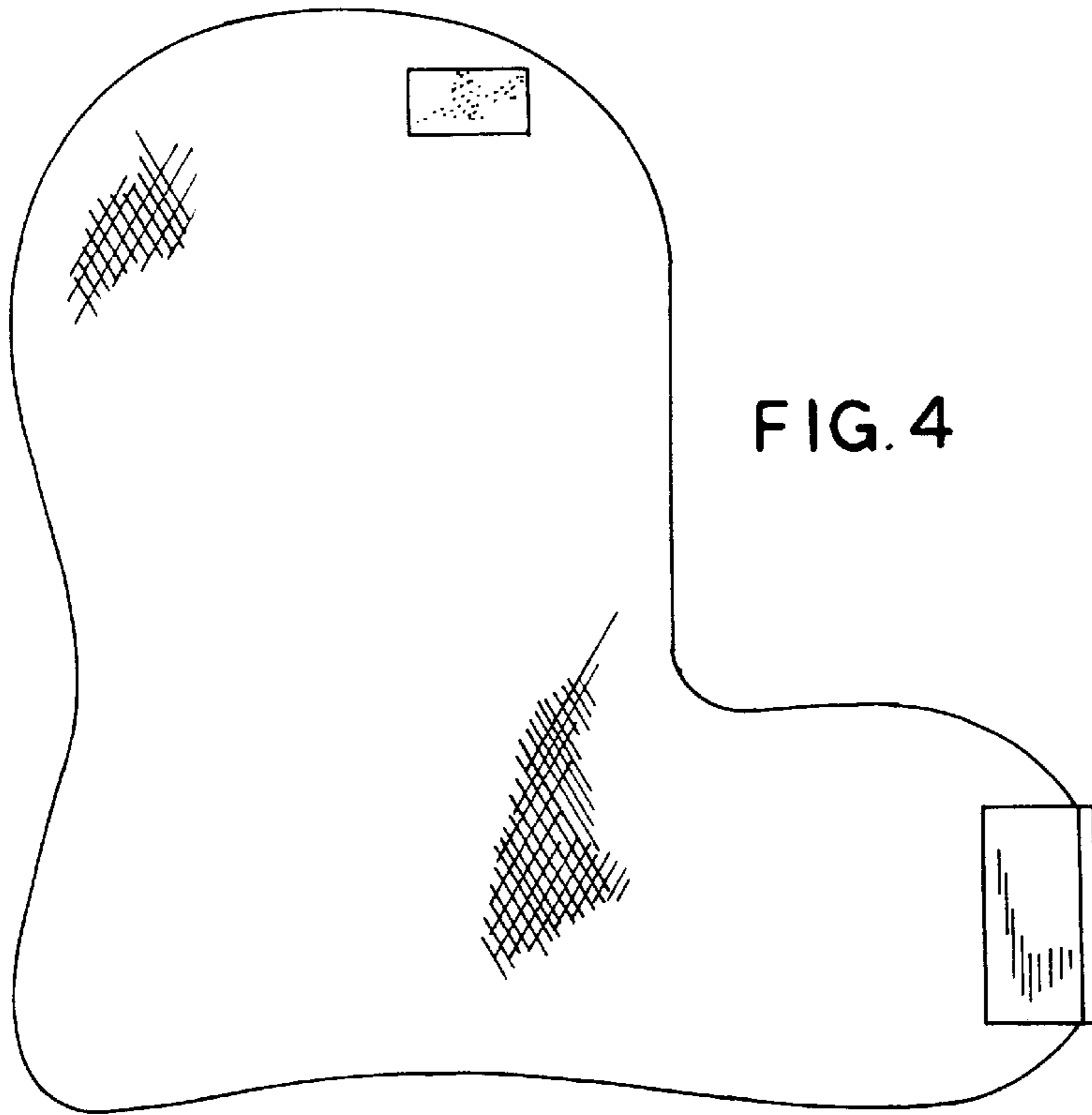

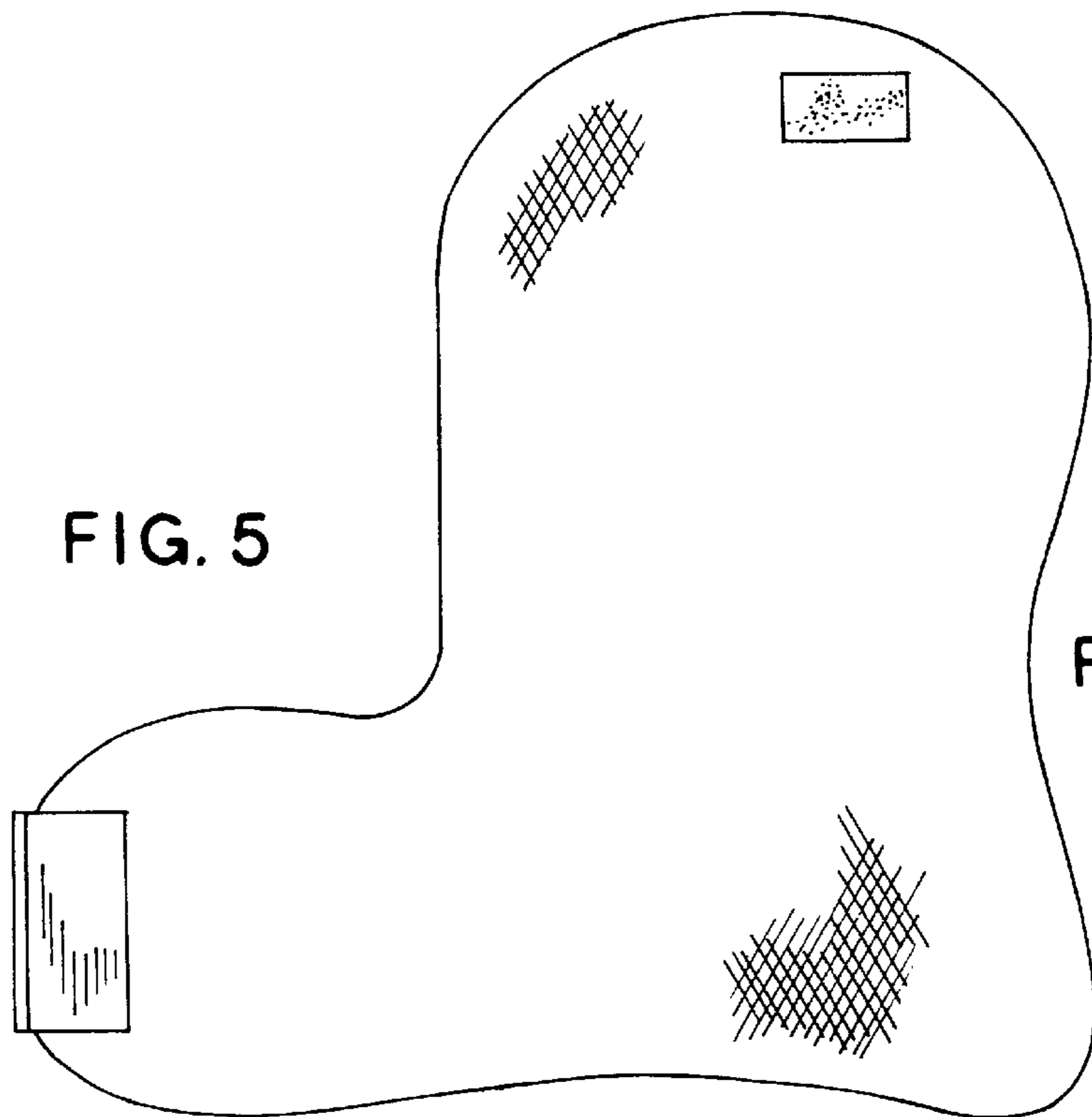
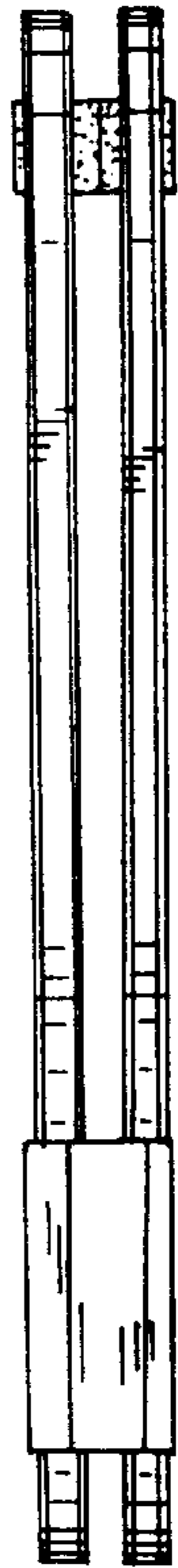

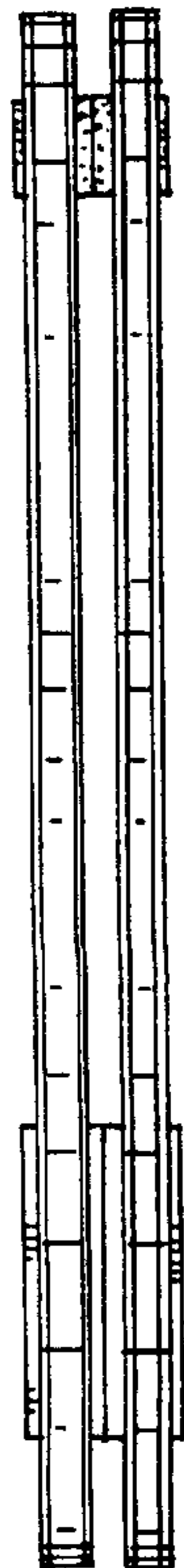

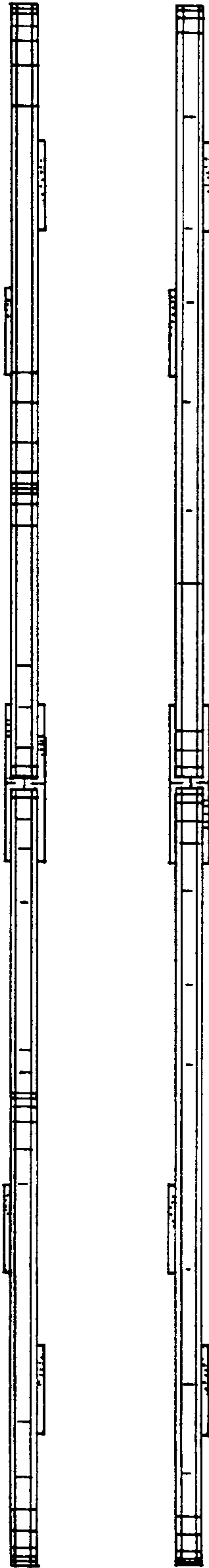

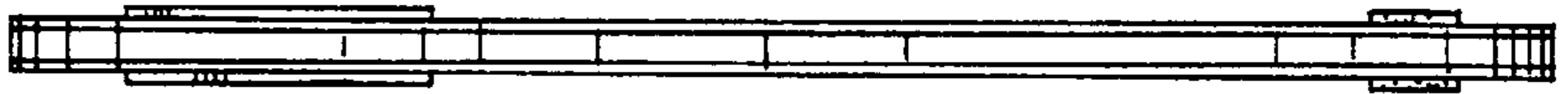

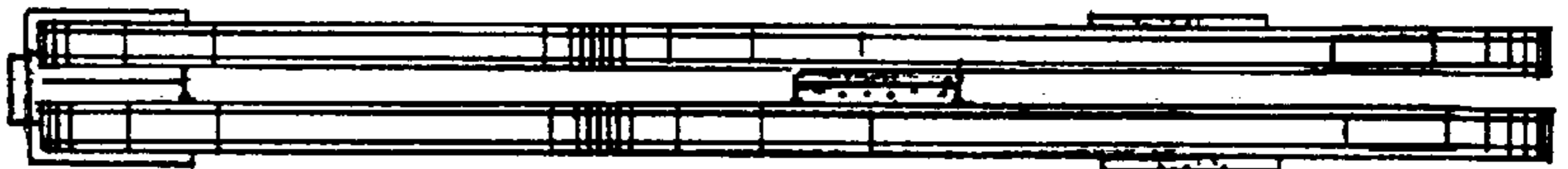
