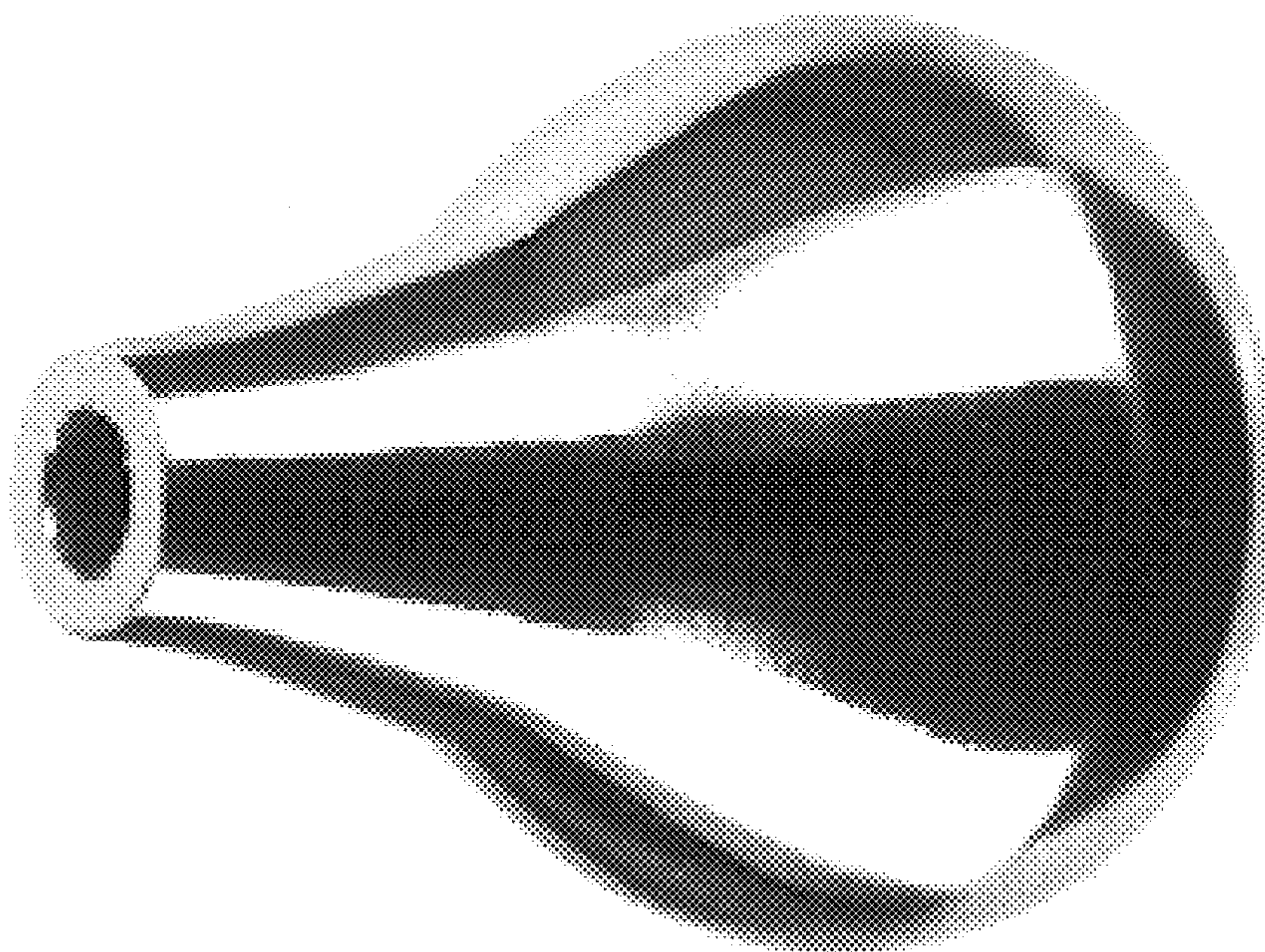
[57] **CLAIM**

The ornamental design for a finial, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a finial showing my new design;
FIG. 2 is a front view thereof, the rear view, top view, and bottom view all being identical;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof; and,
FIG. 5 is a perspective view of a second embodiment showing my new design.
The undisclosed views of the second embodiment are similar in appearance to the views shown in FIGS. 2-4 of the first embodiment.

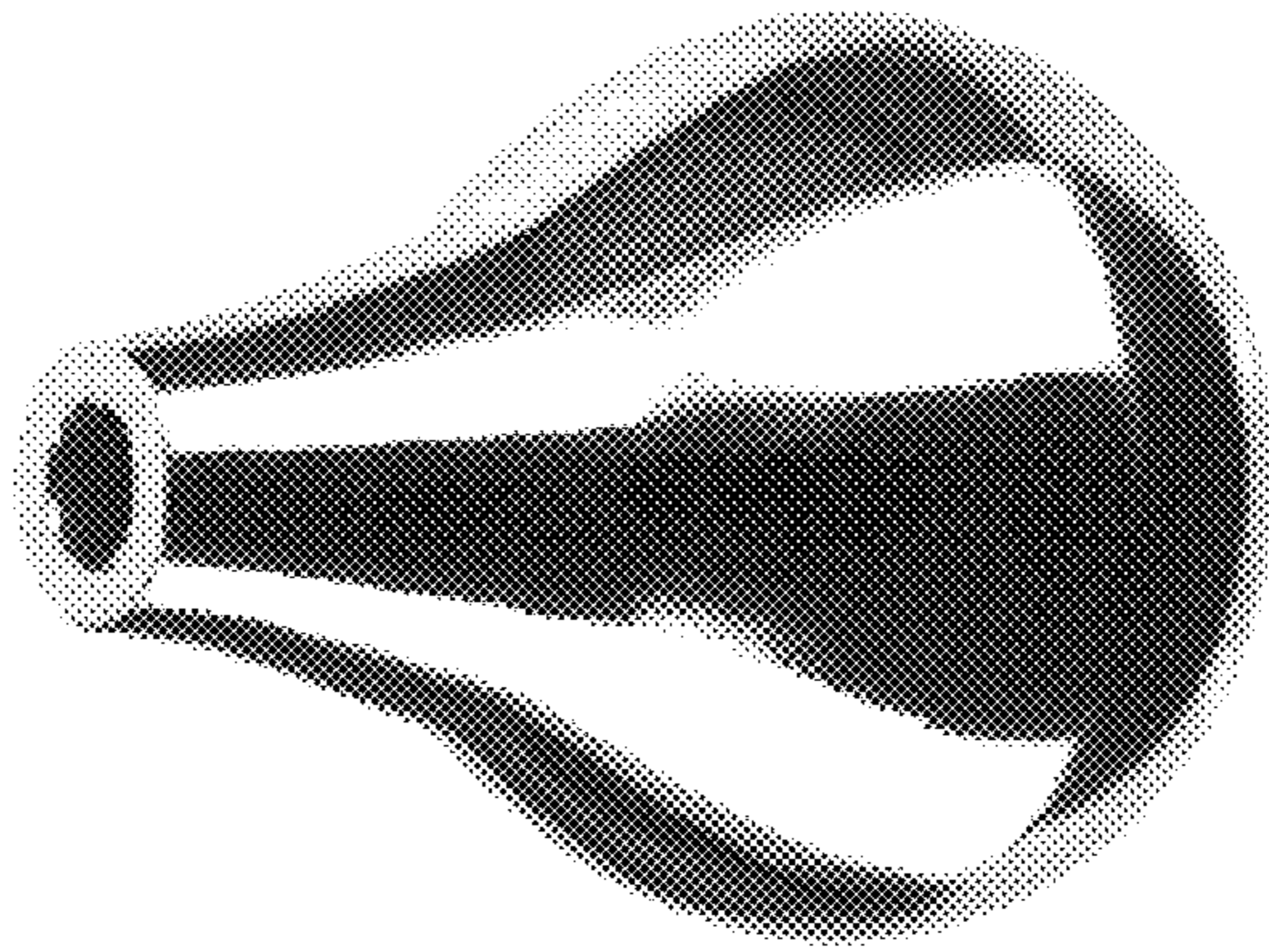

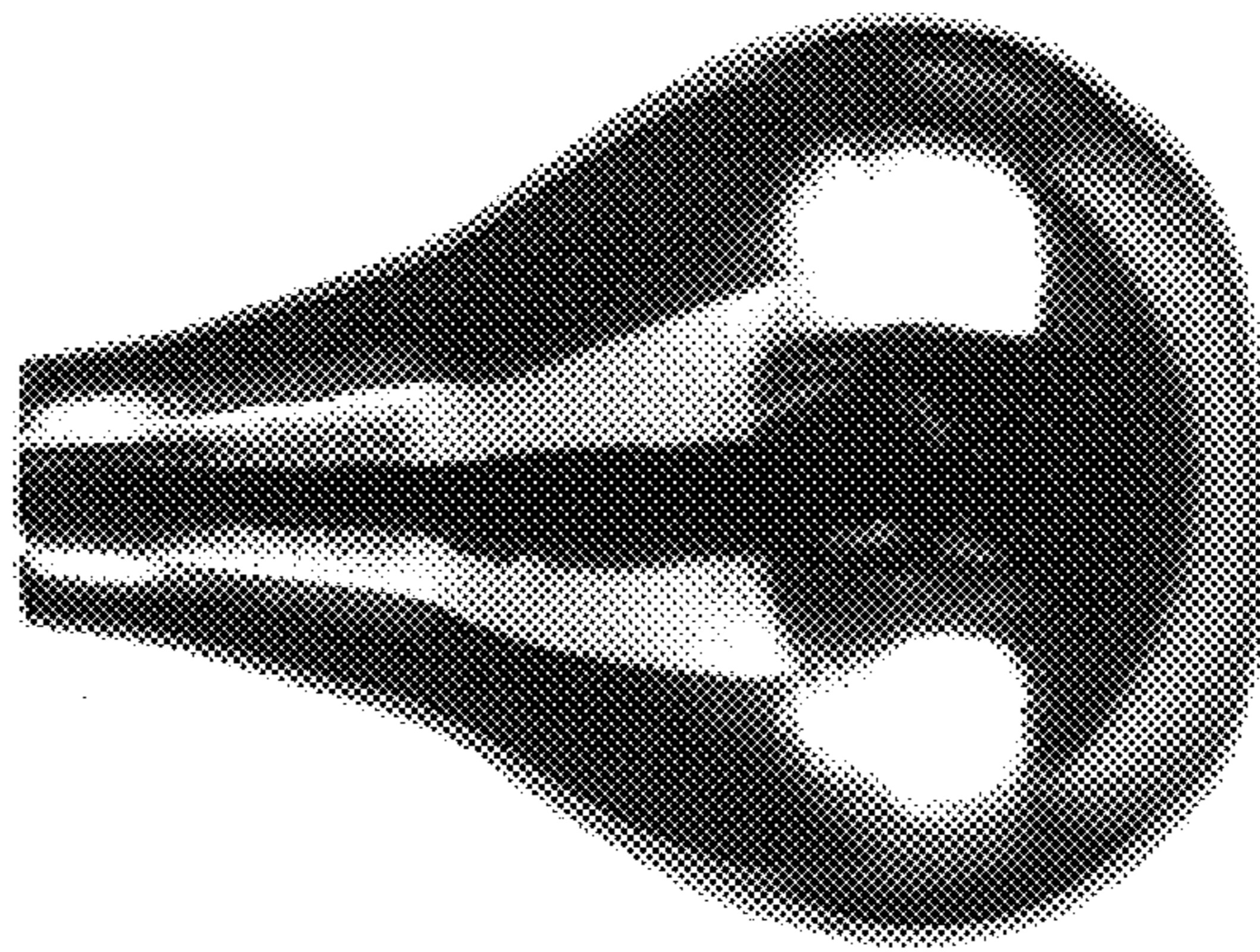

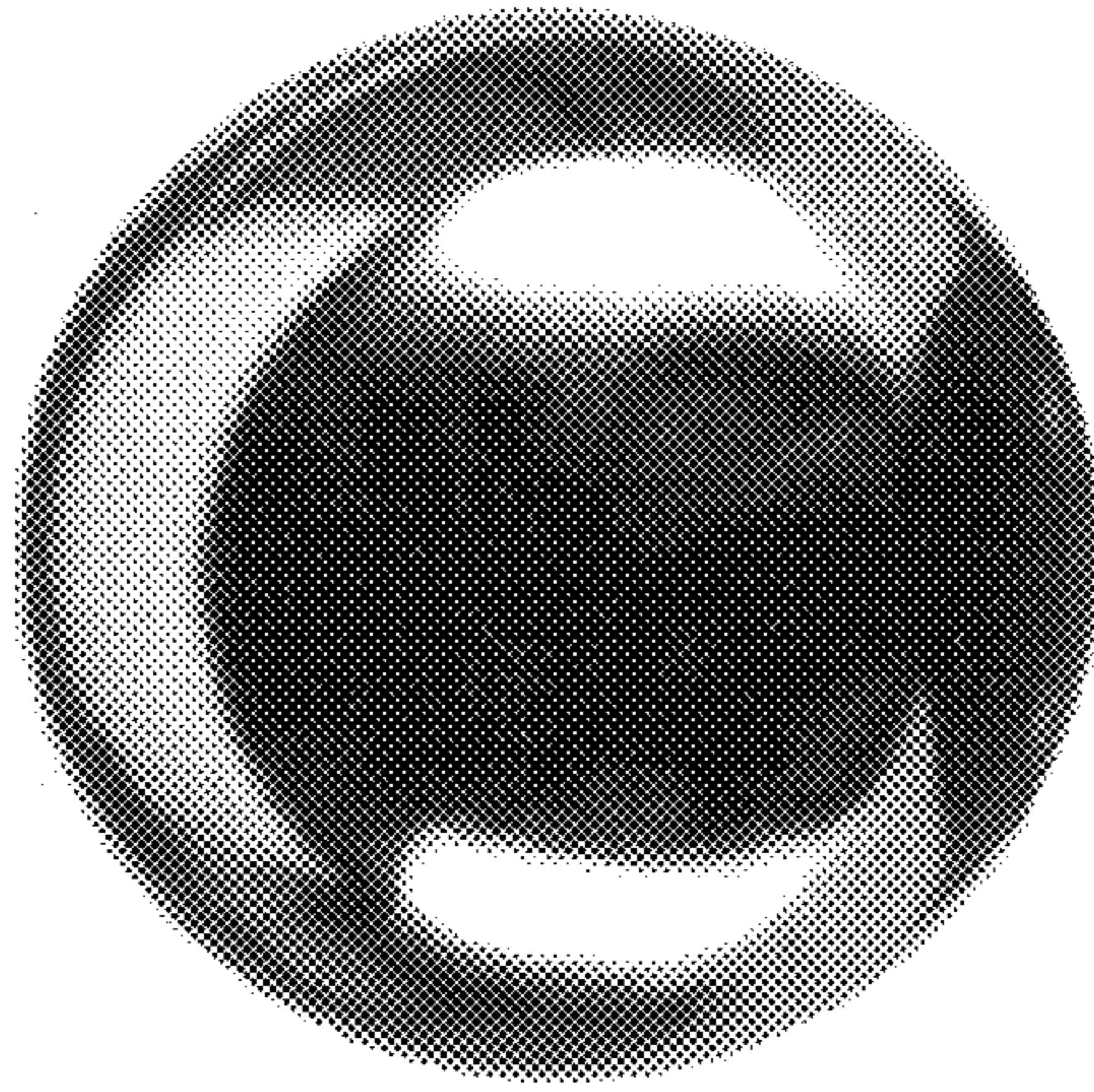

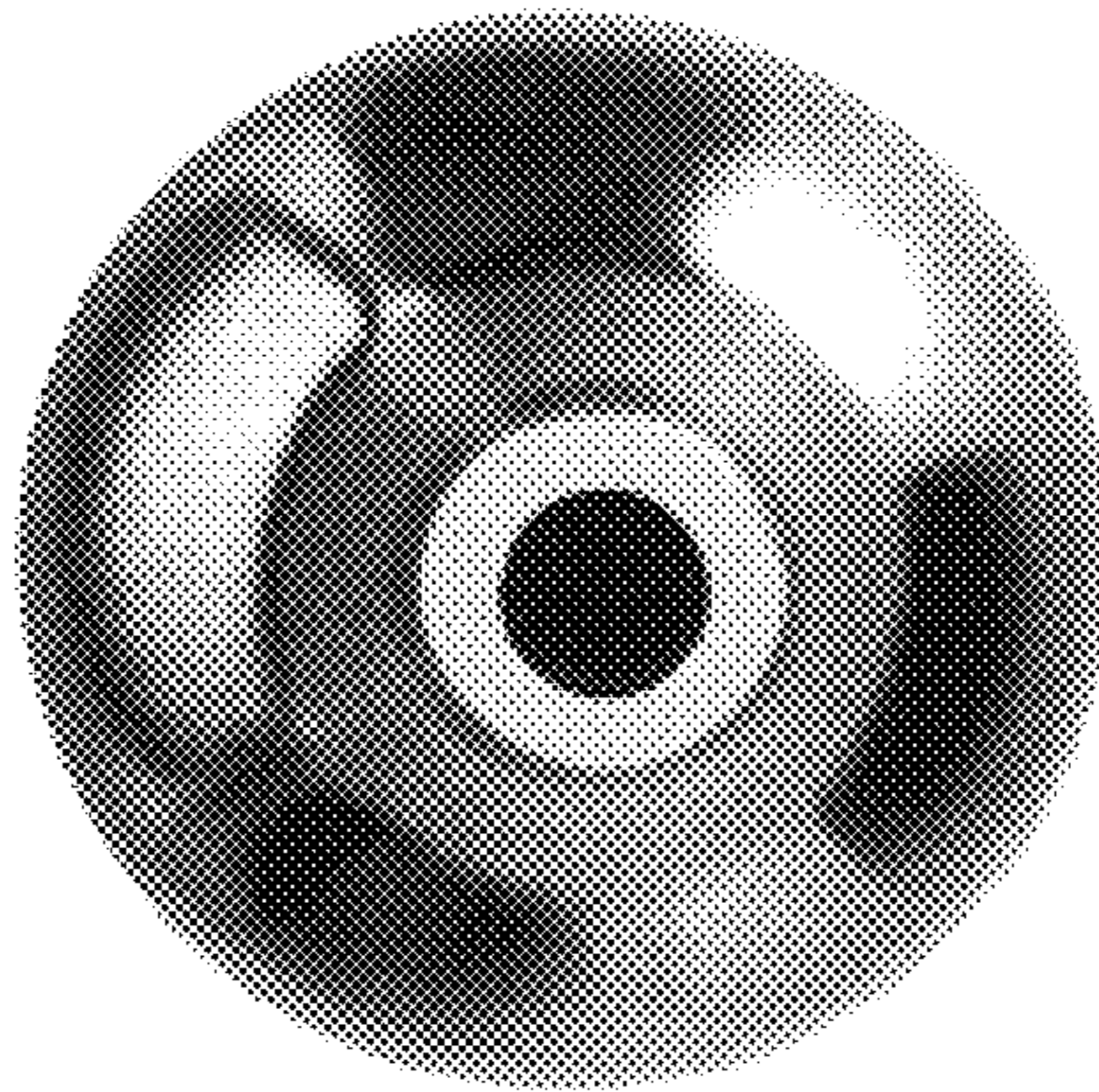

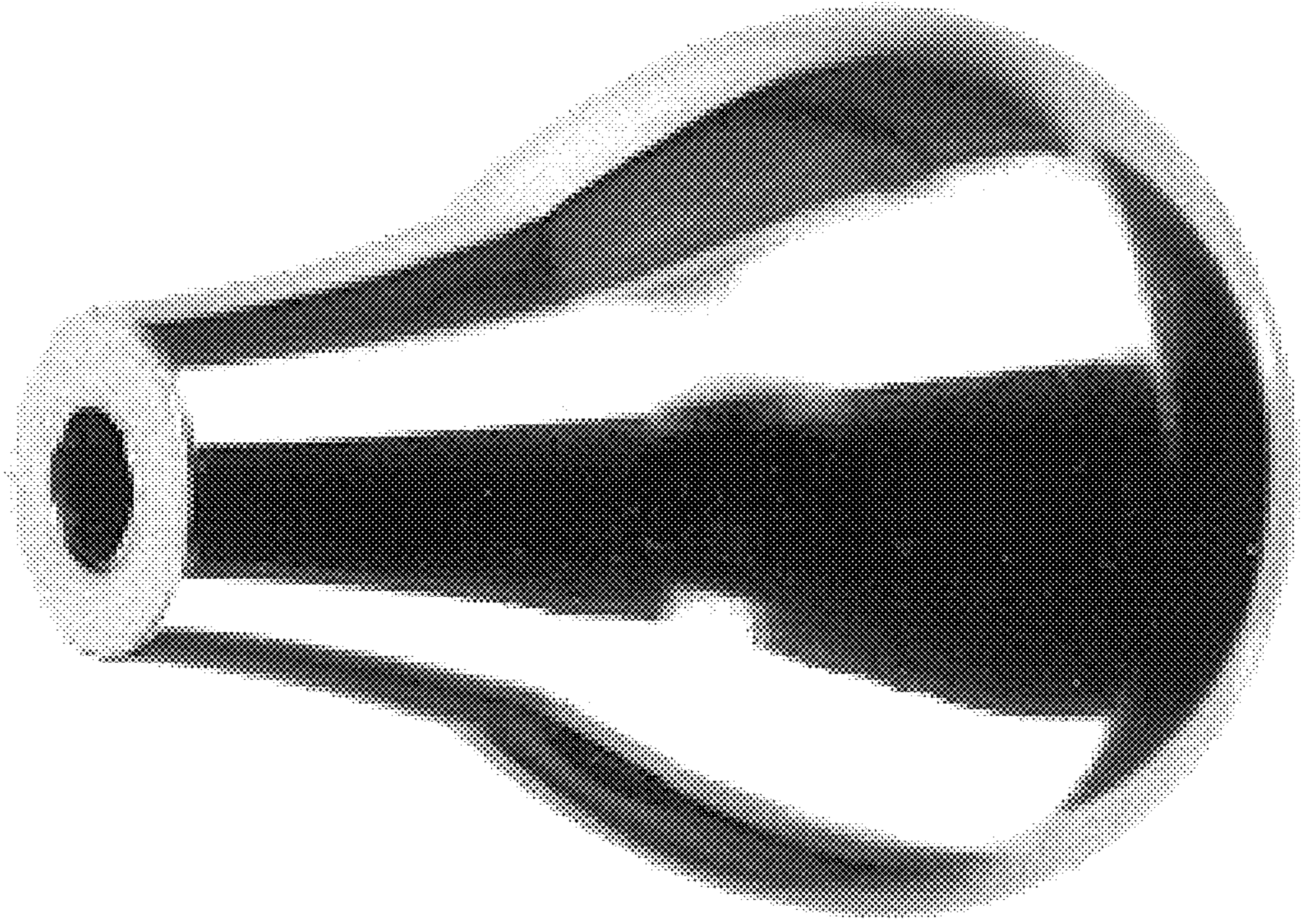
