DESCRIPTION

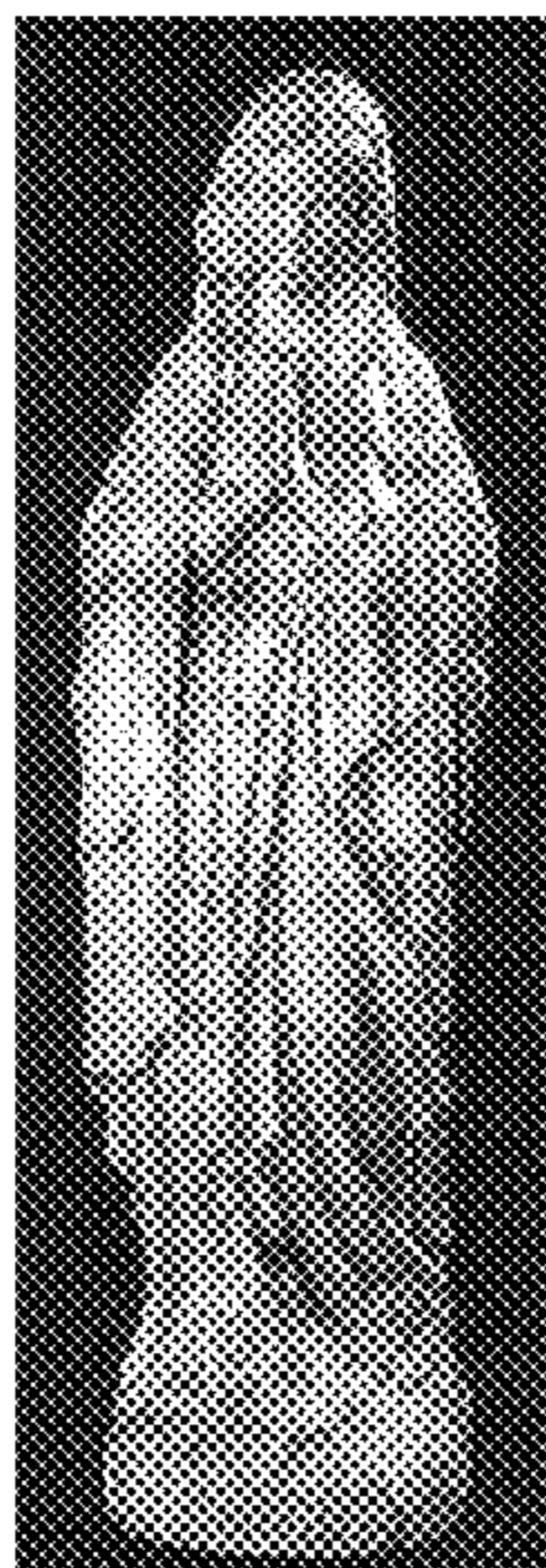
FIG. 1 is a front elevational view of a statue of a saint, showing my new design;

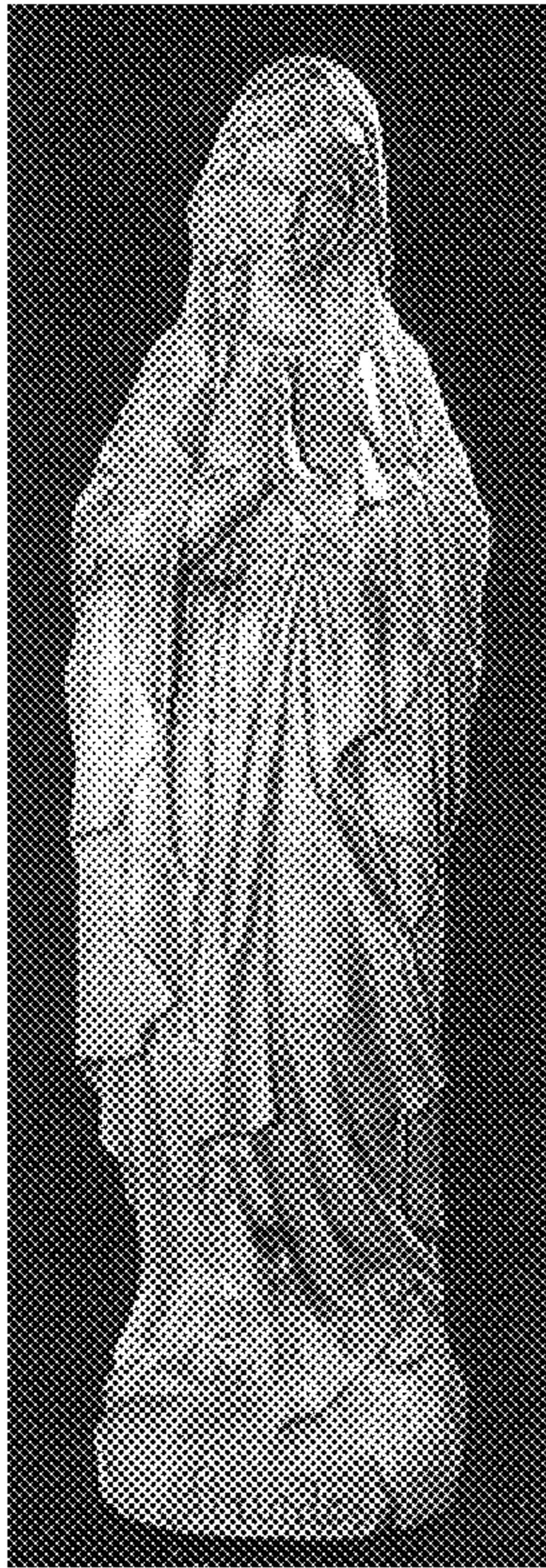

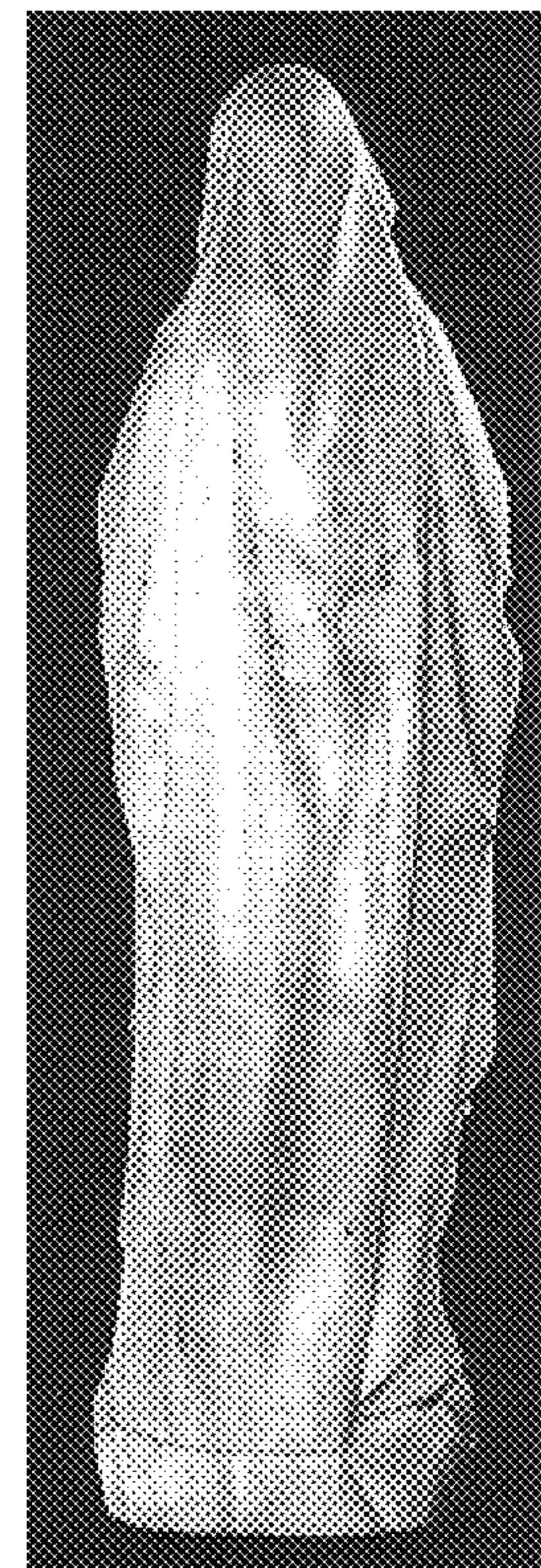

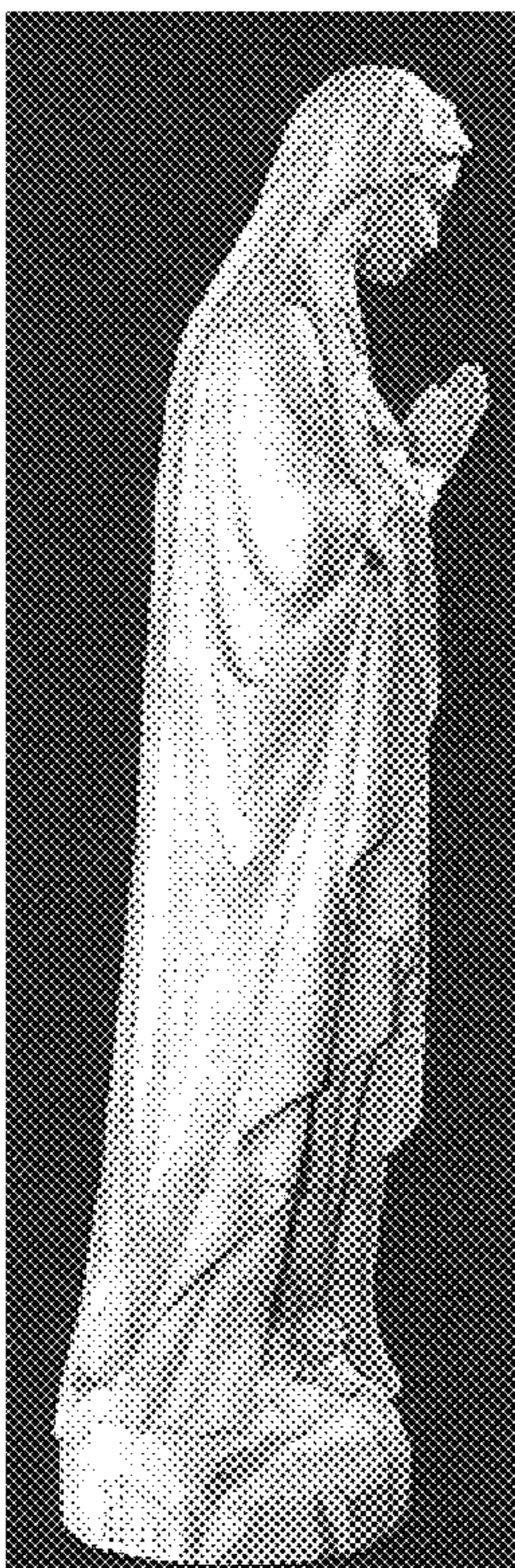
