The ornamental design for a computer generated image for a display panel or screen for controlling or editing image data, as shown and described.

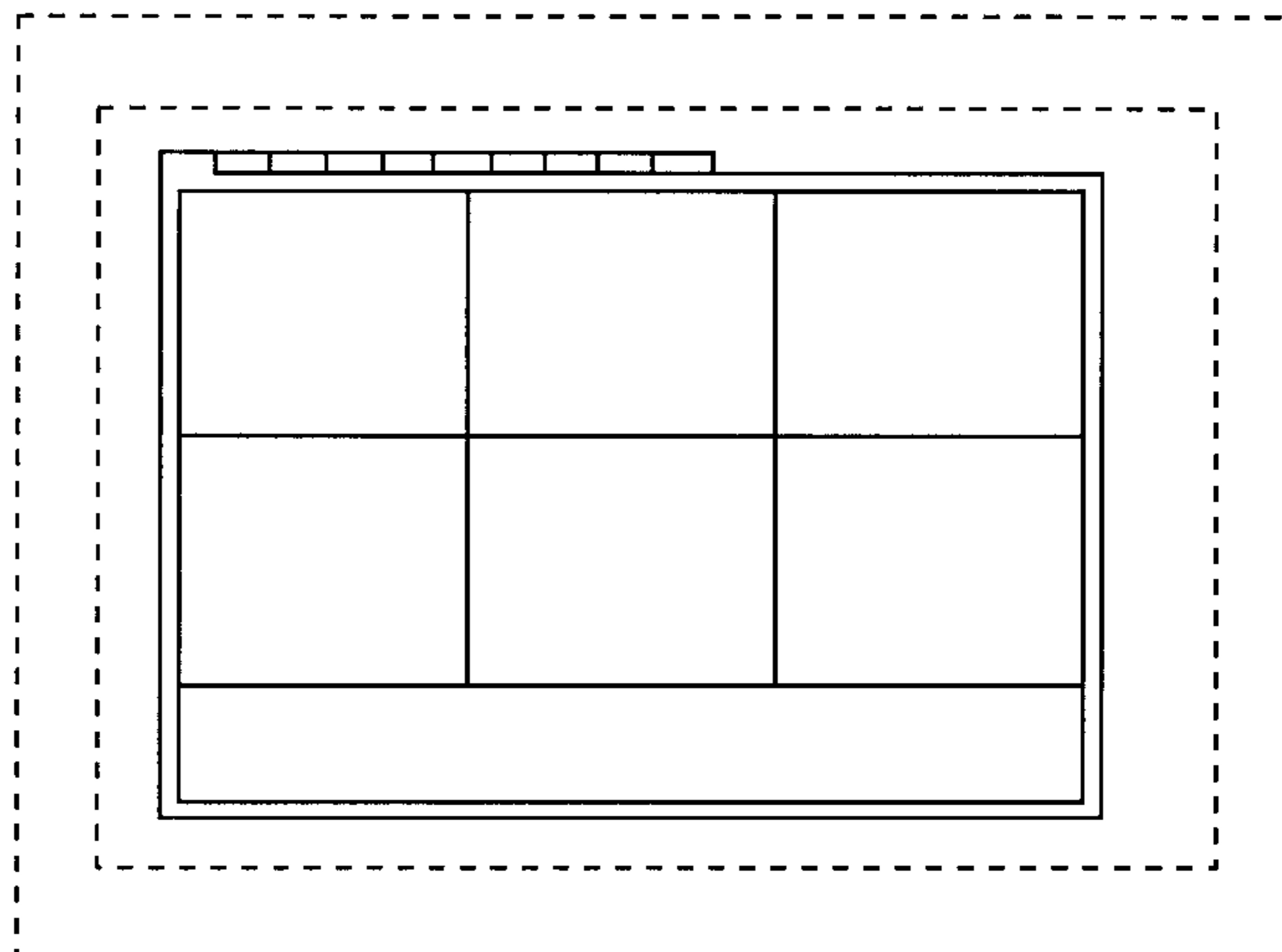

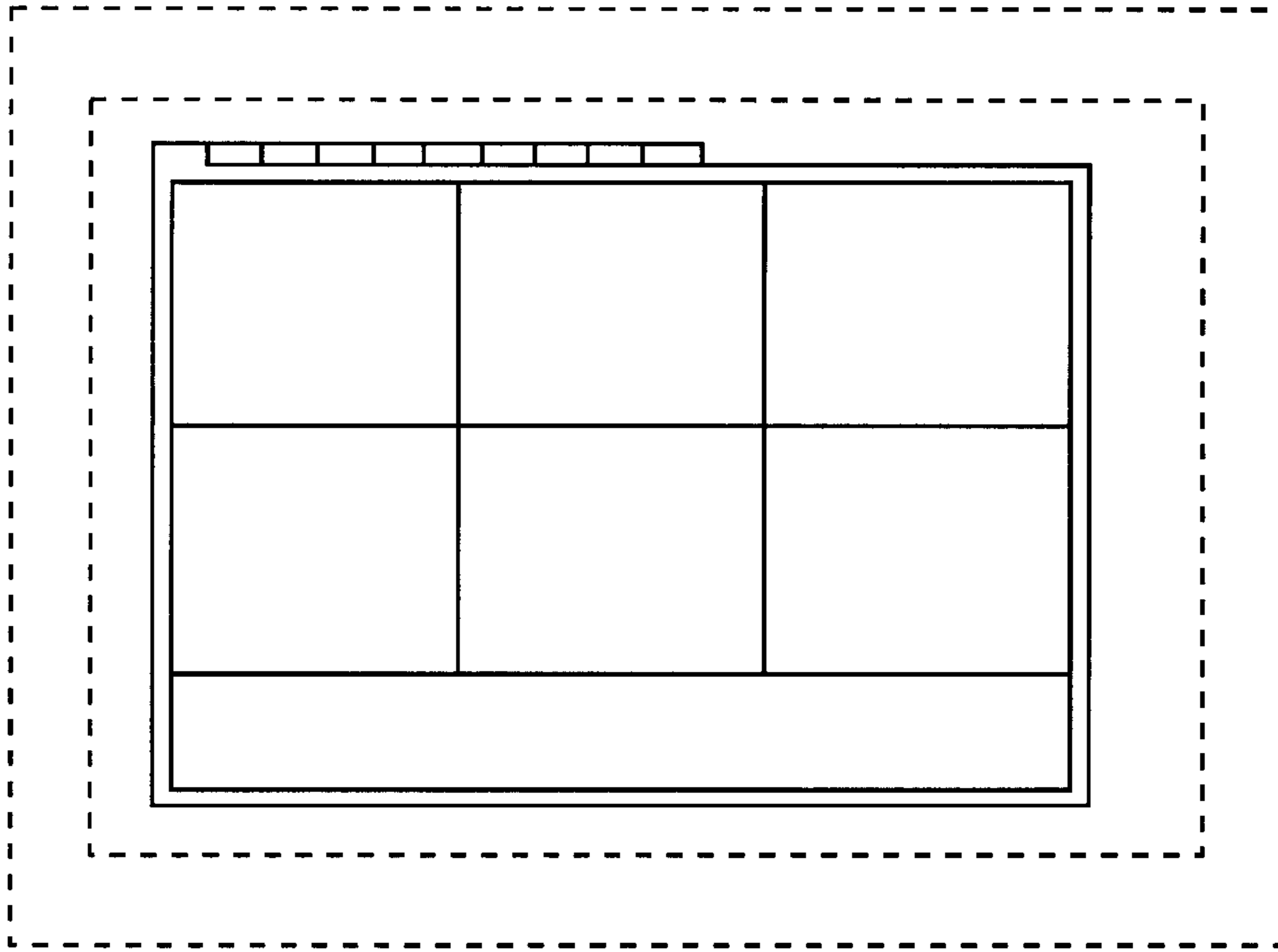
FIG. 1 is a front view of a computer generated image on a display panel and screen;

FIG. 32 is a front view of a thirty-second embodiment thereof.

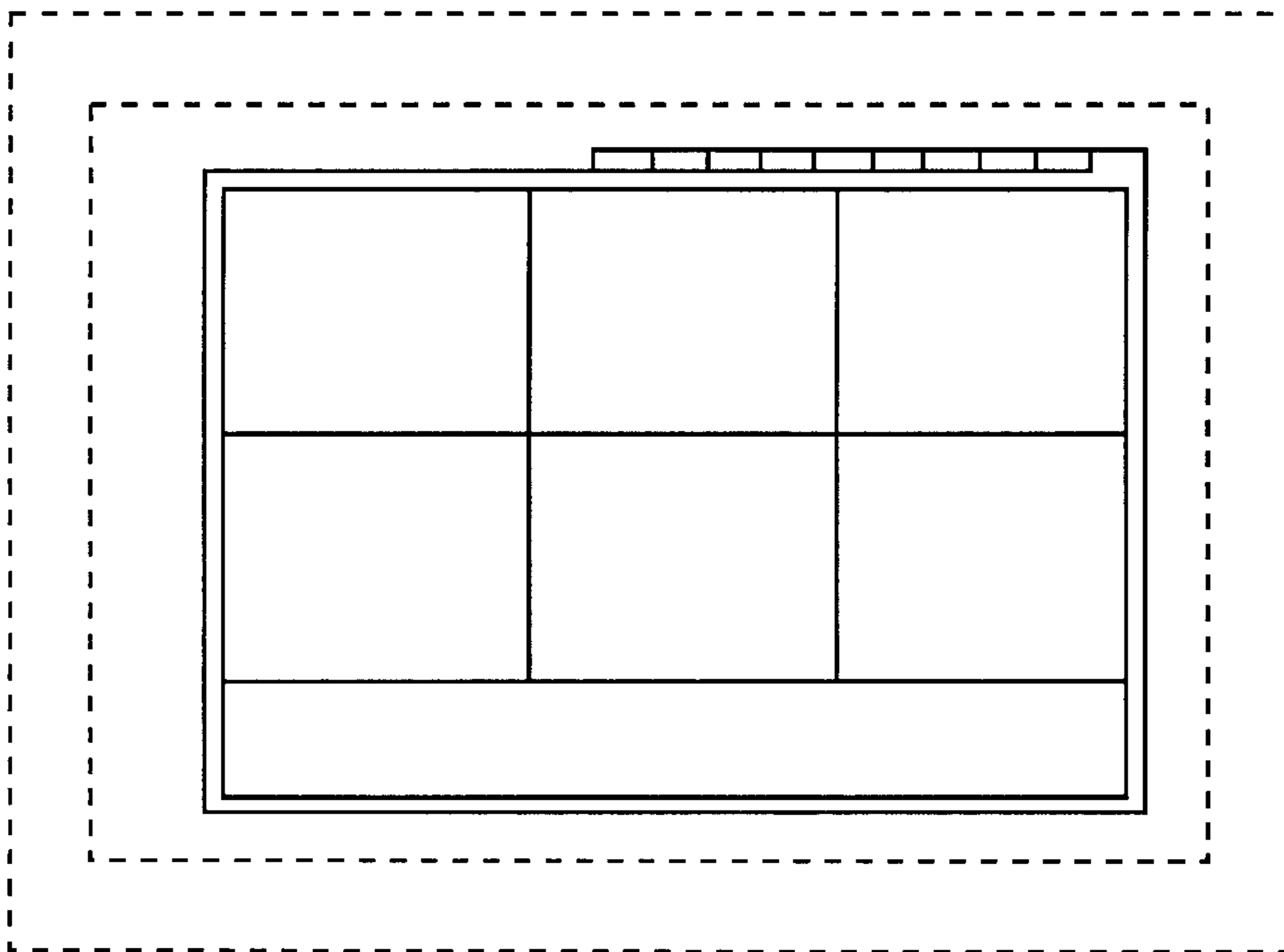

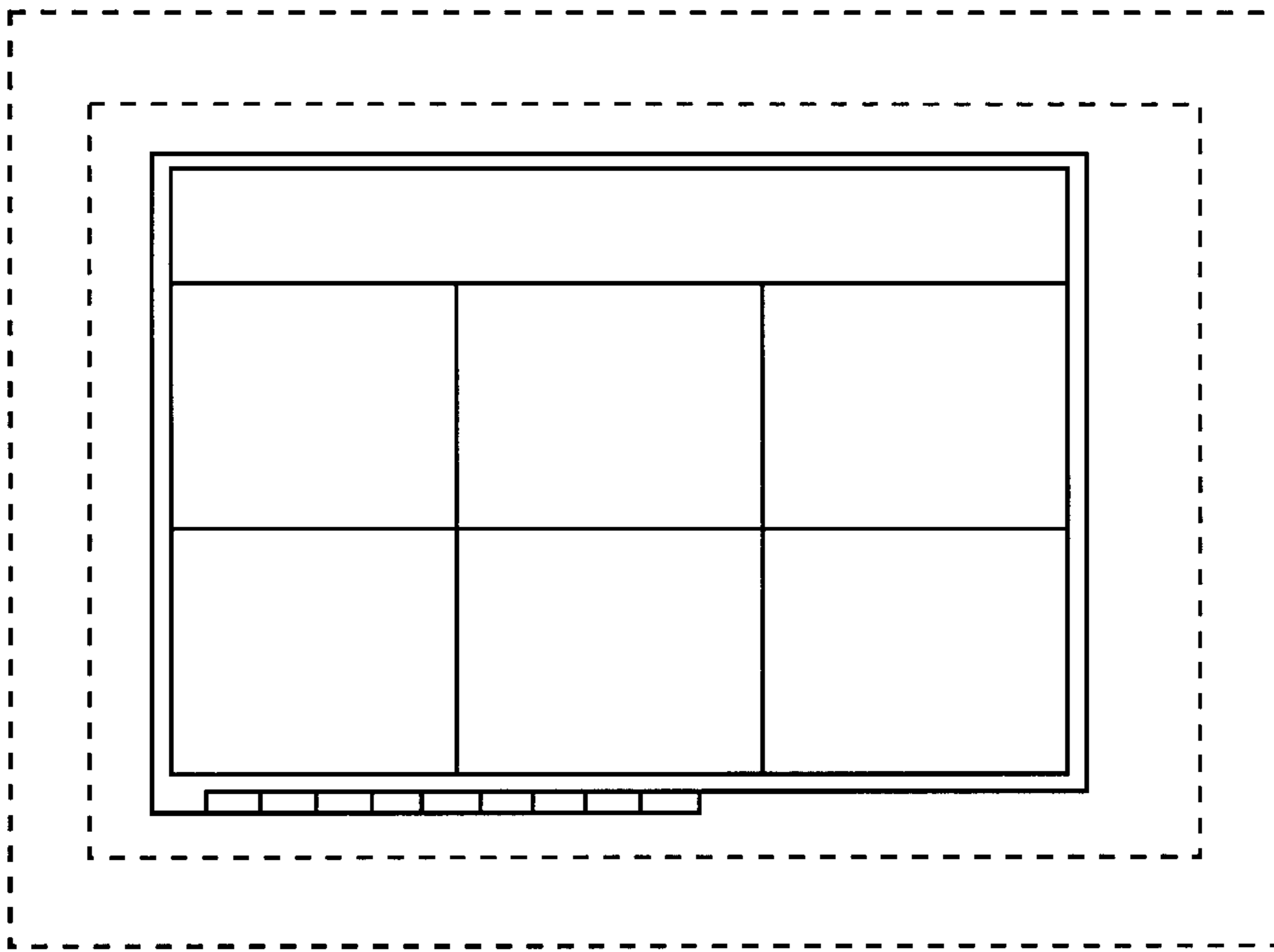




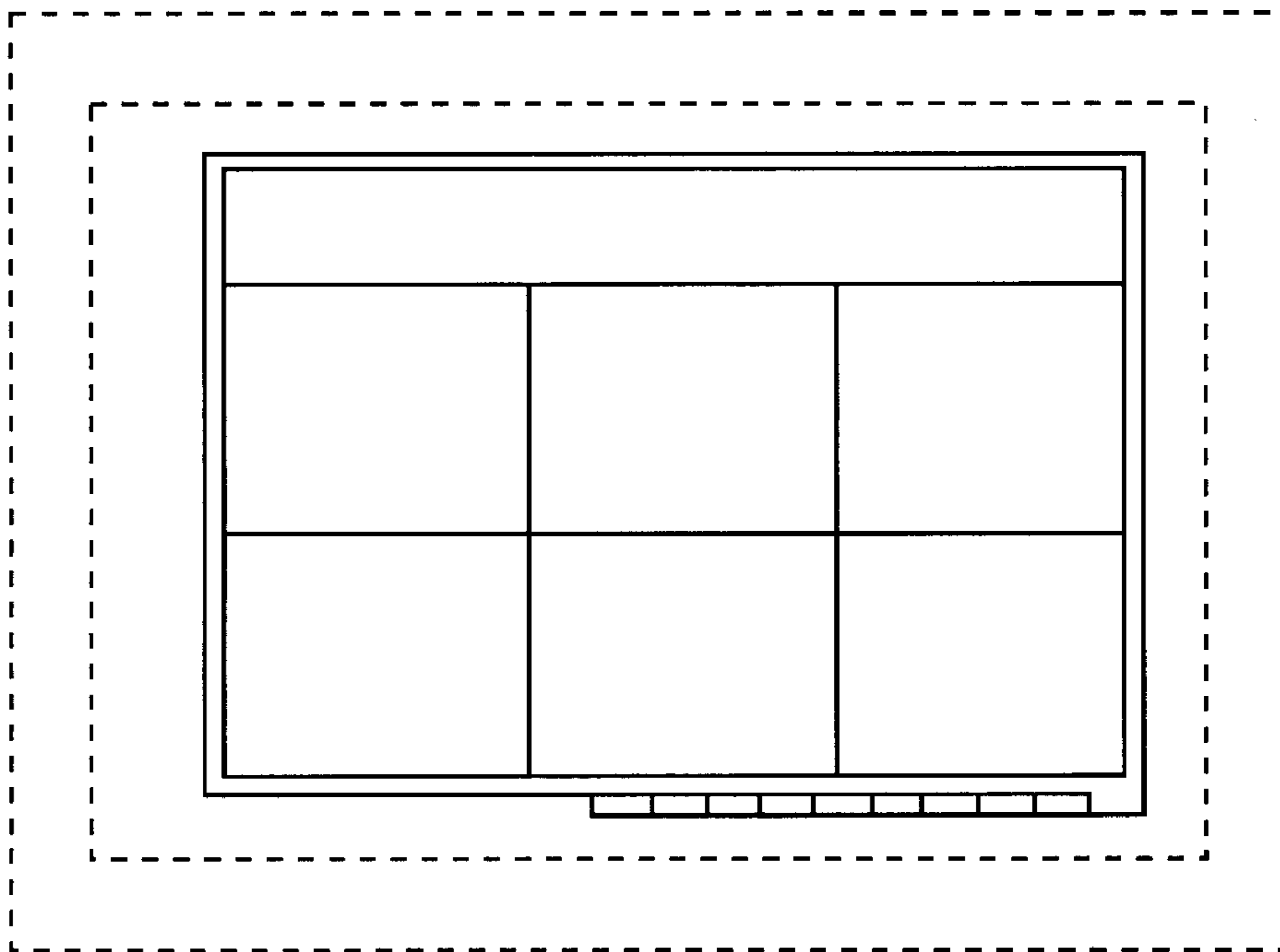

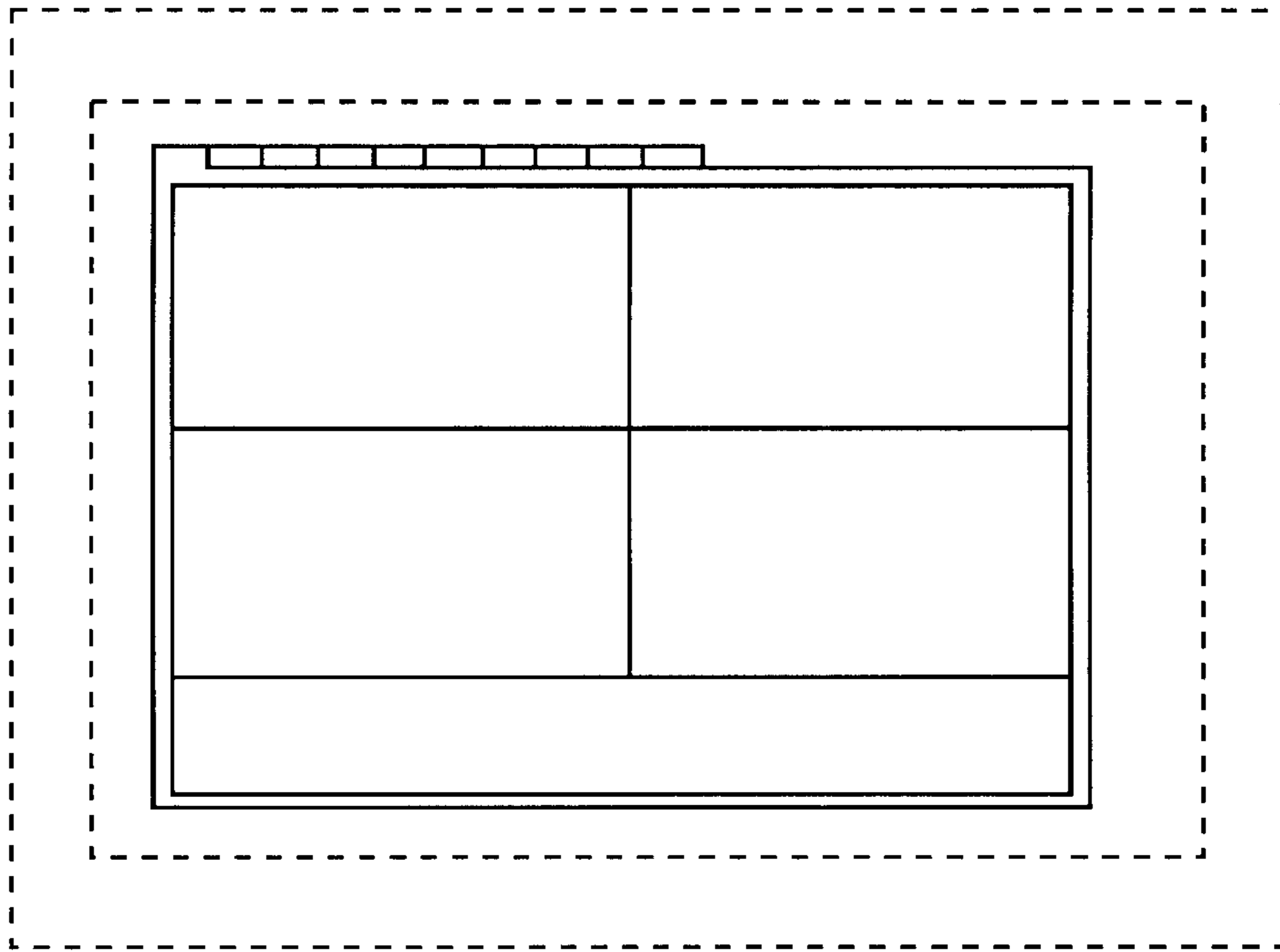

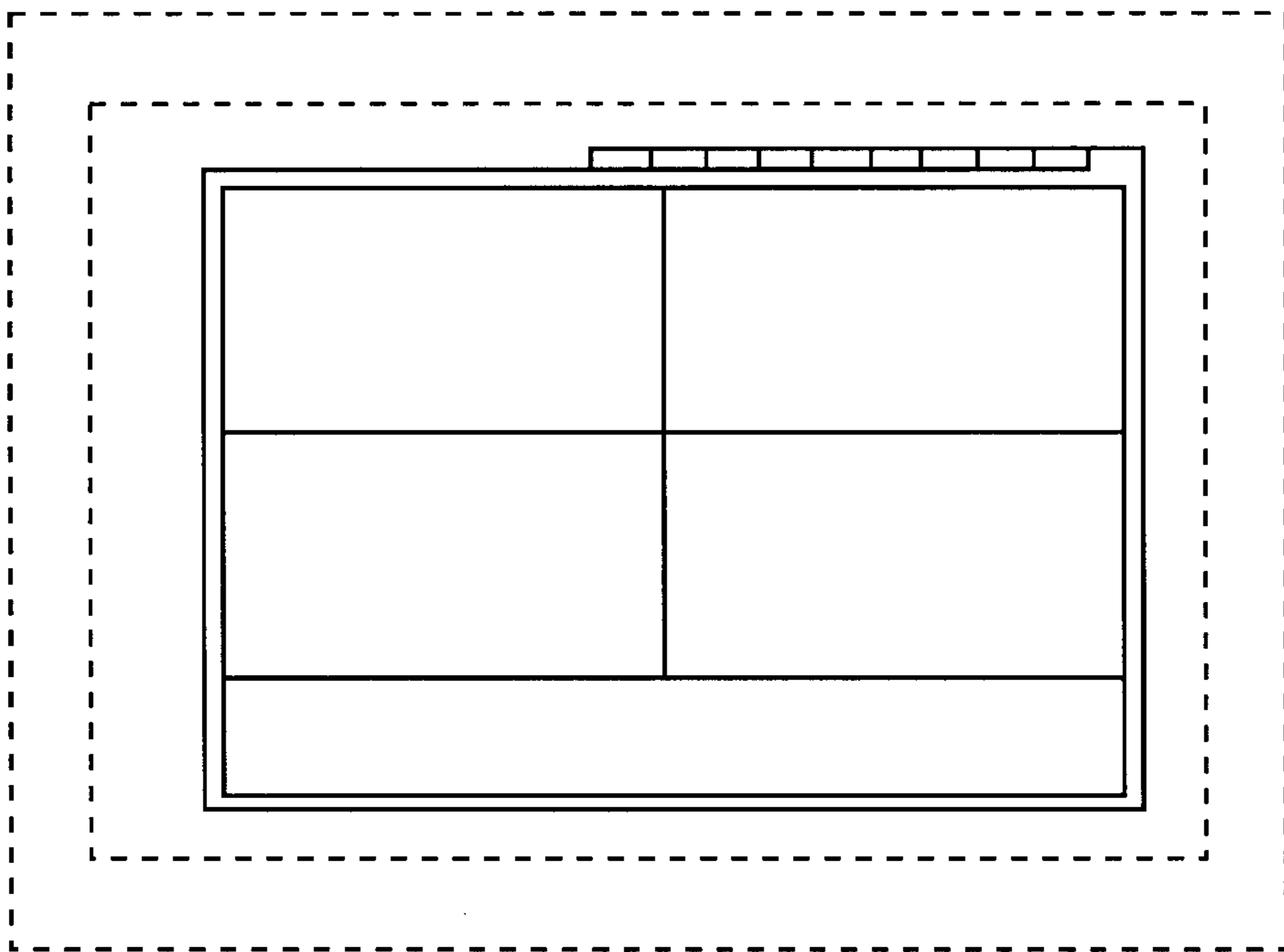

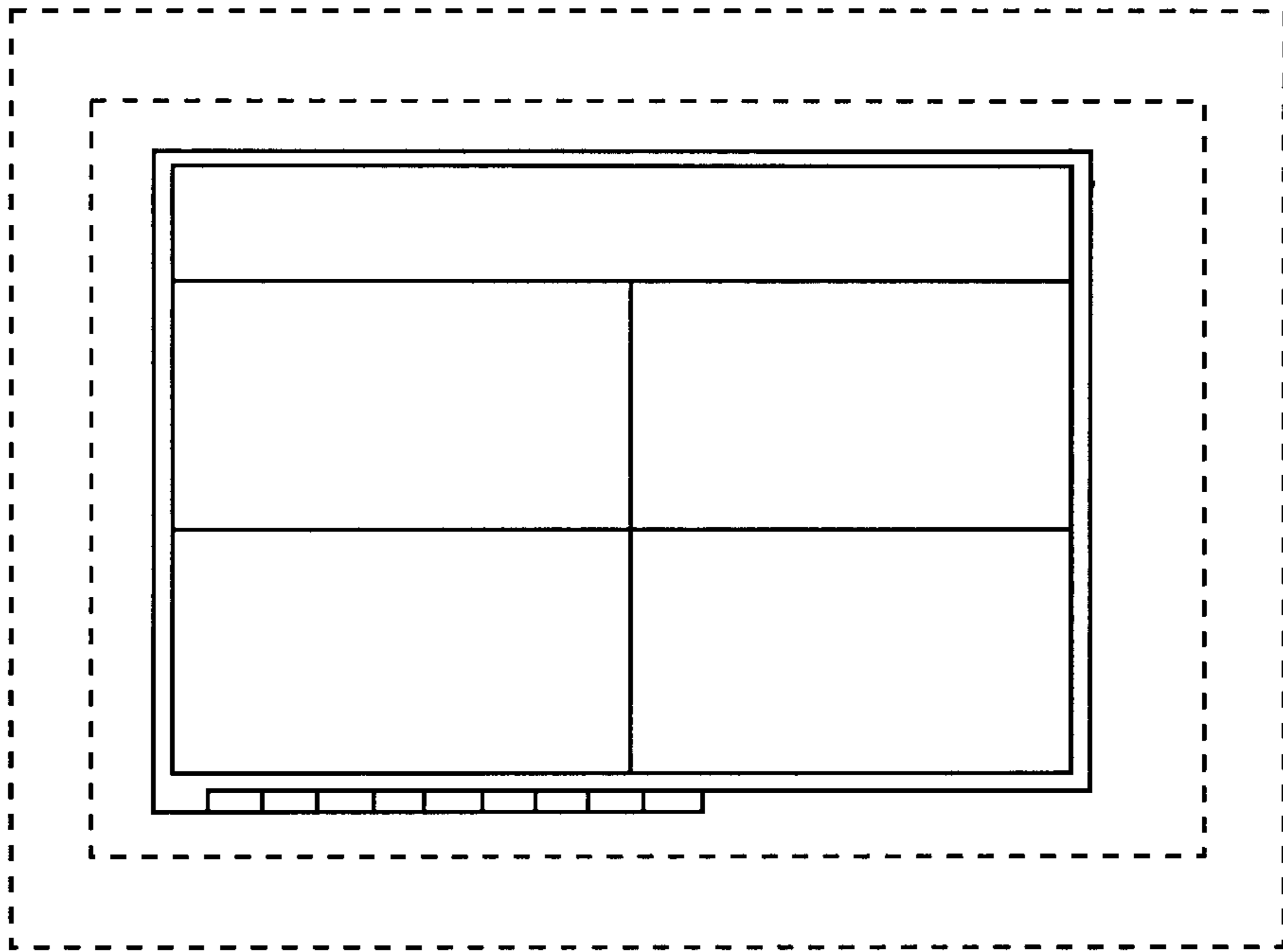

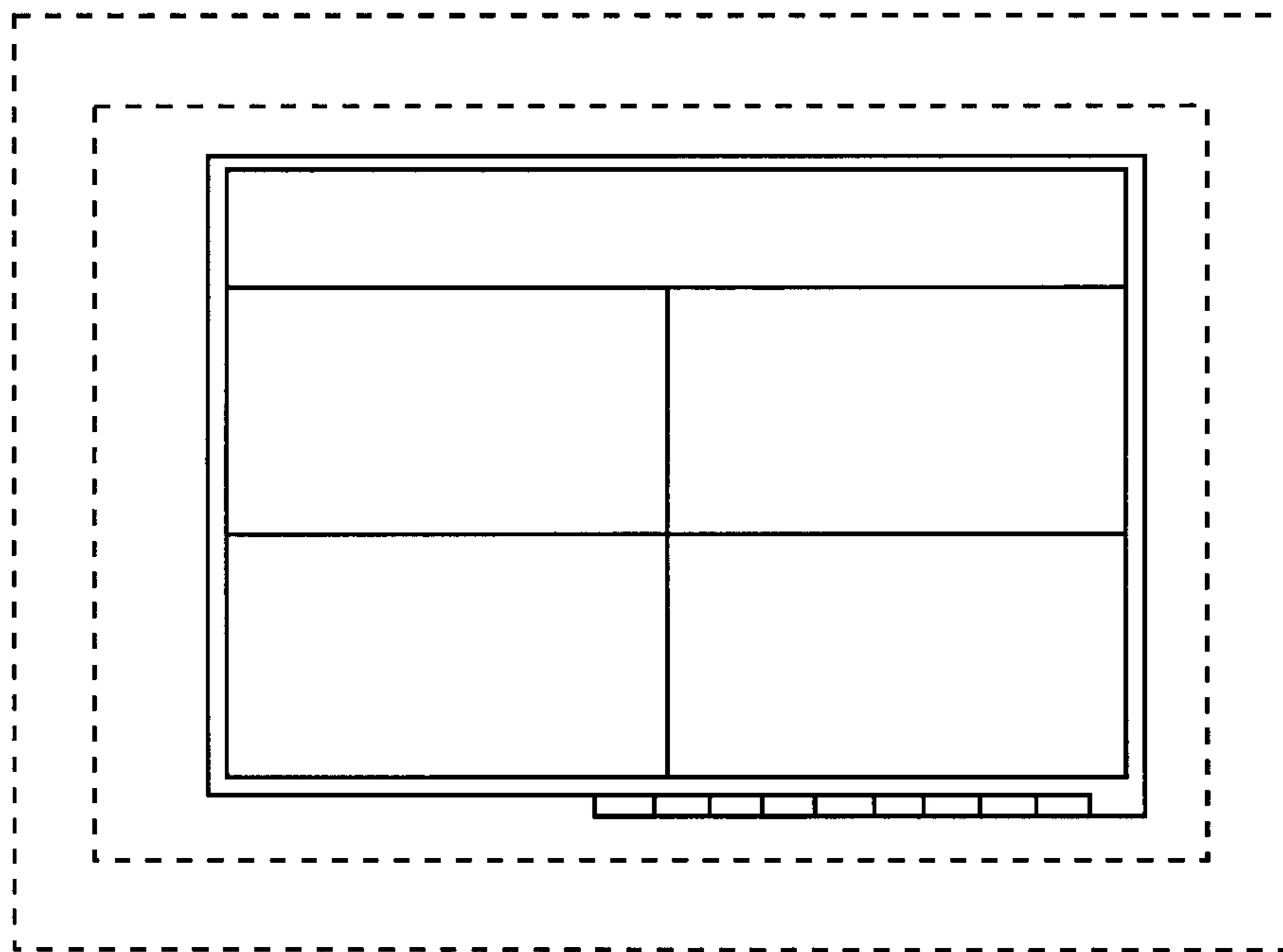

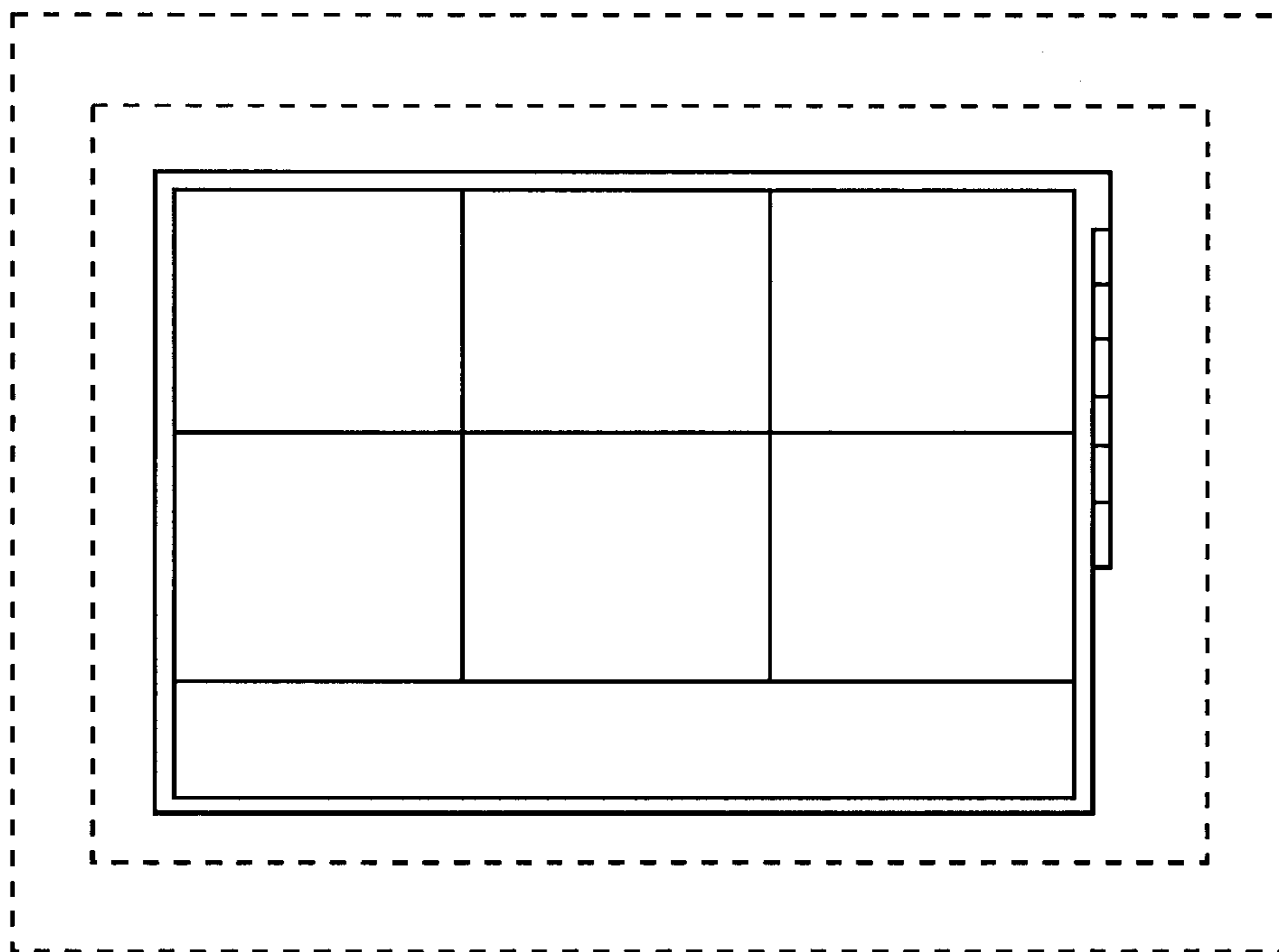

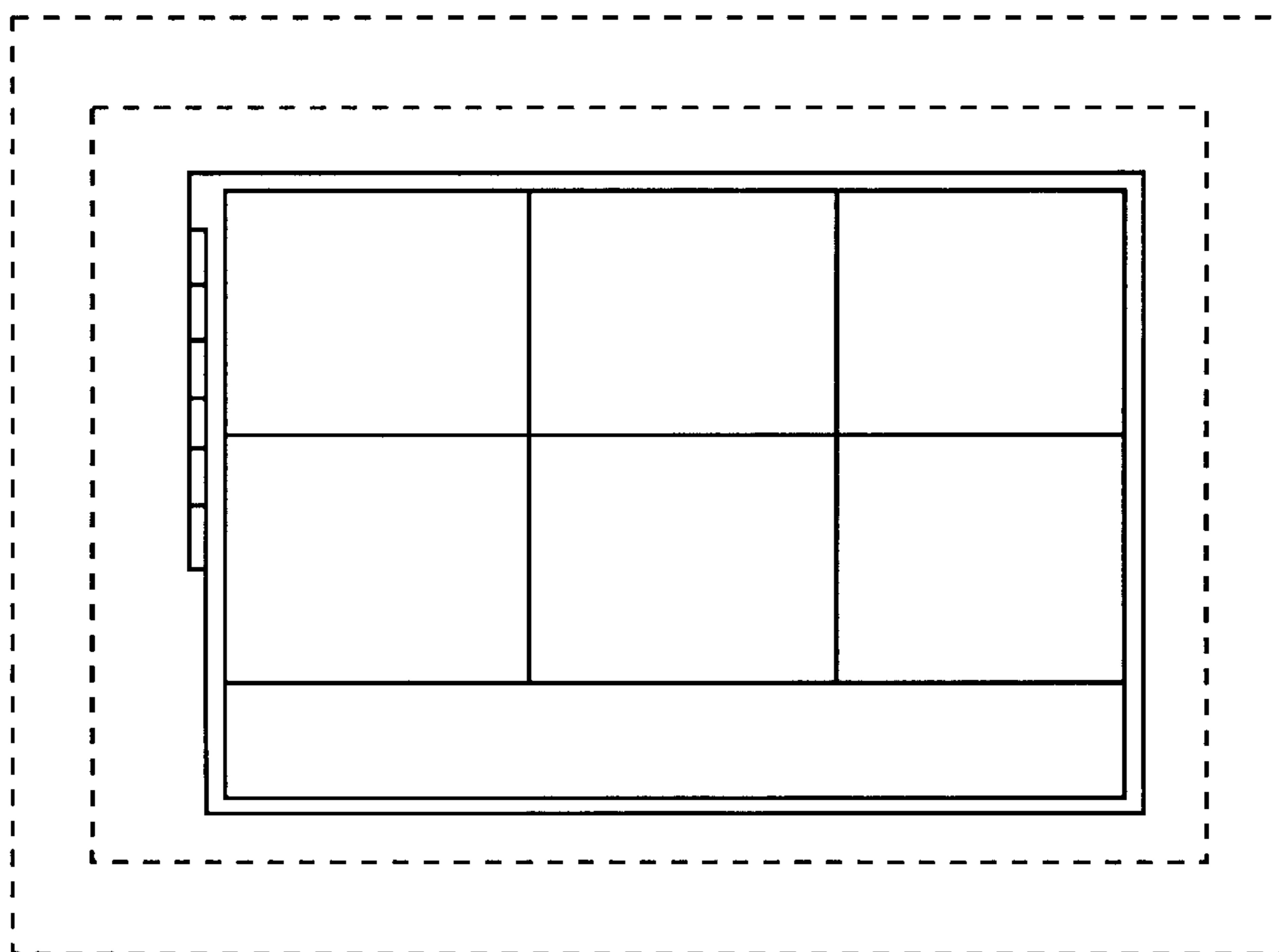

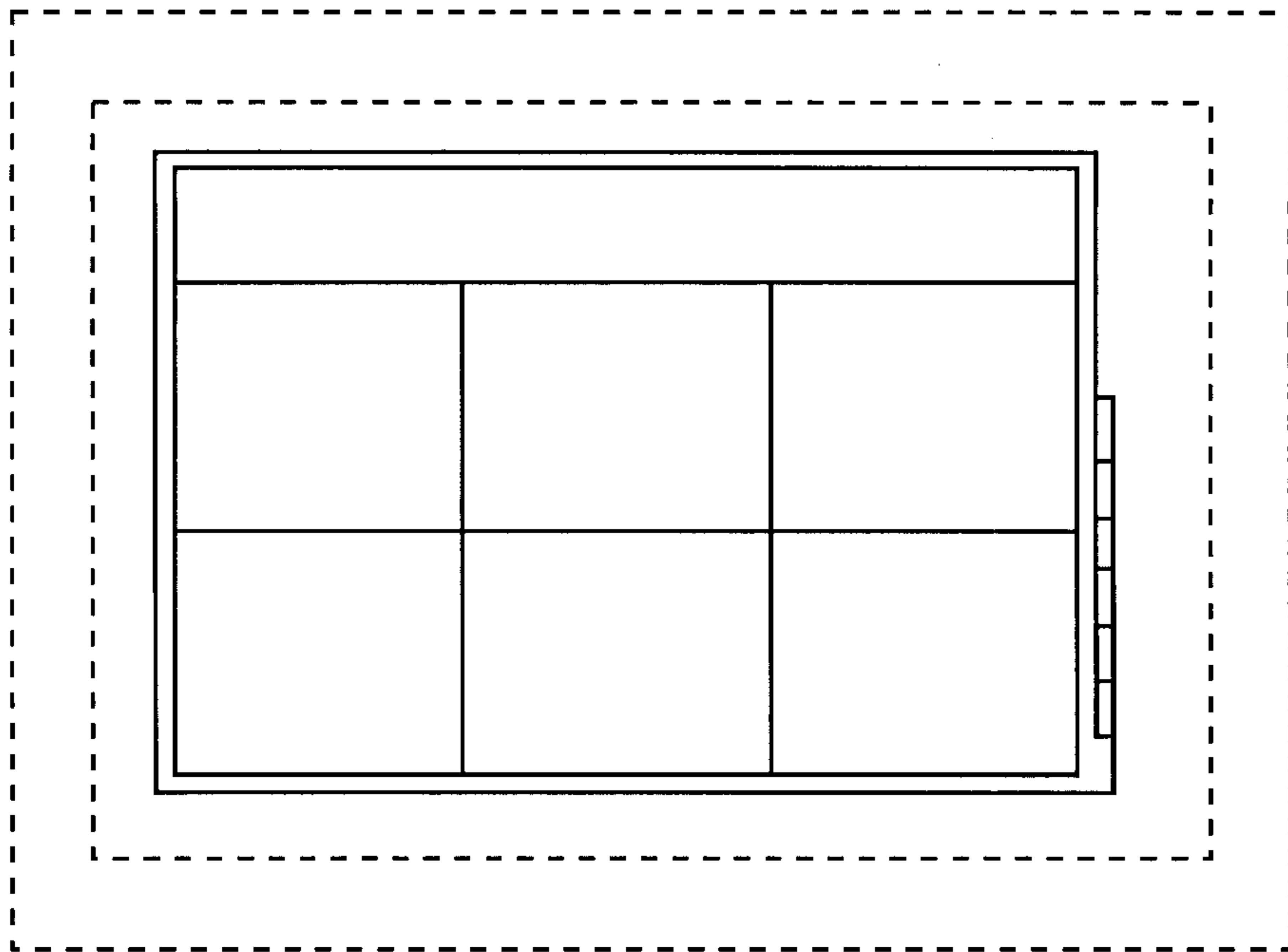

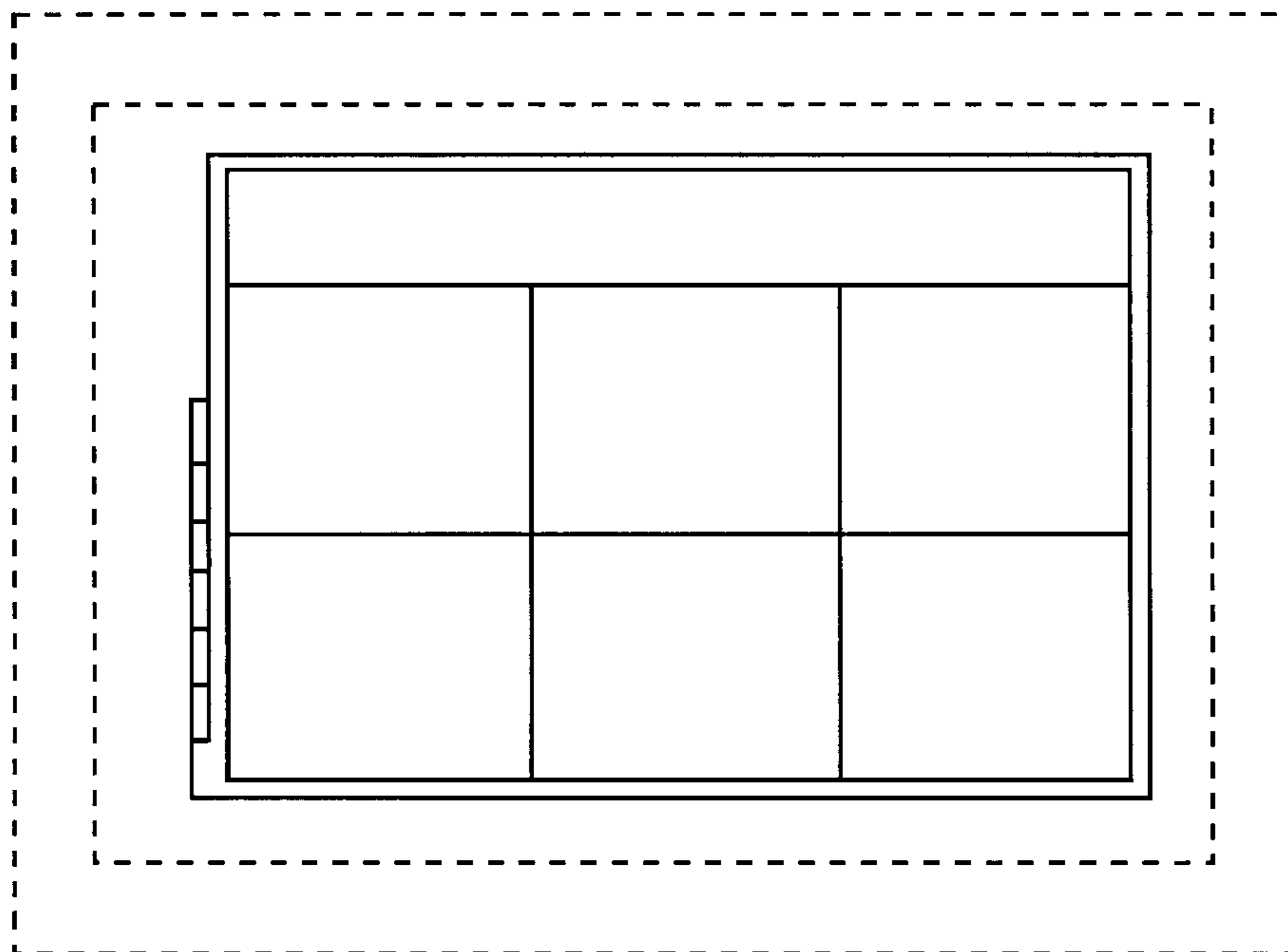

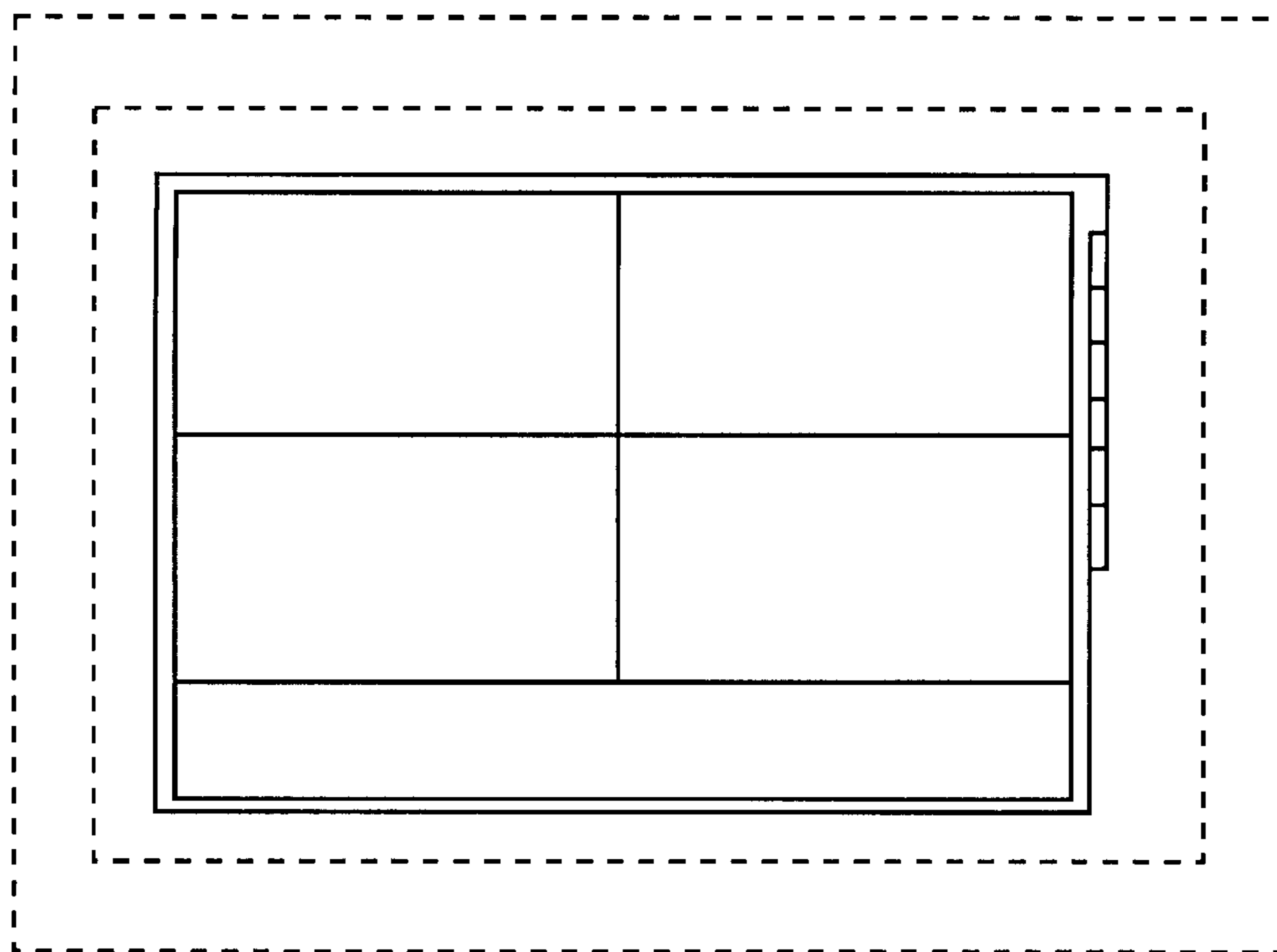

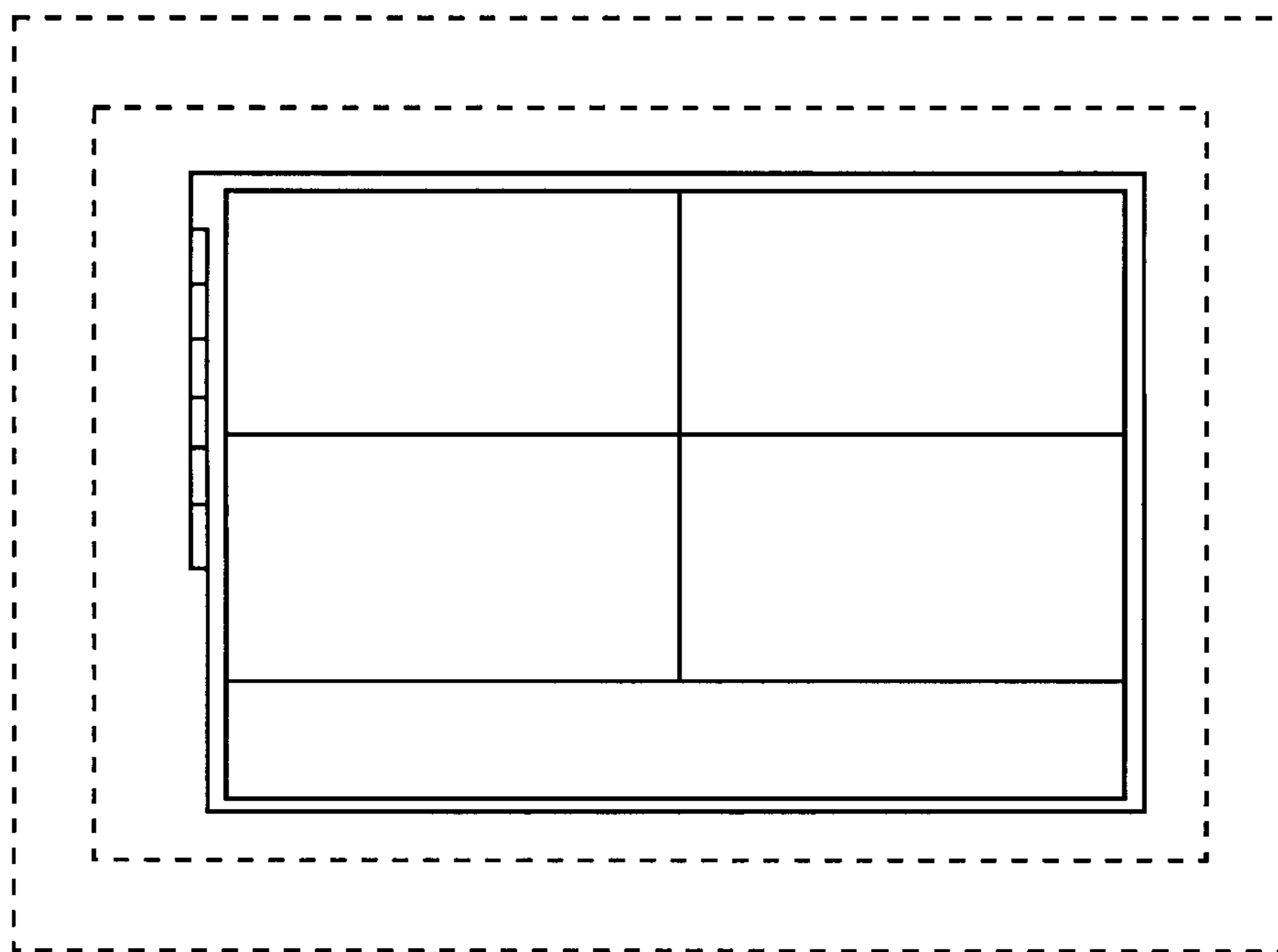

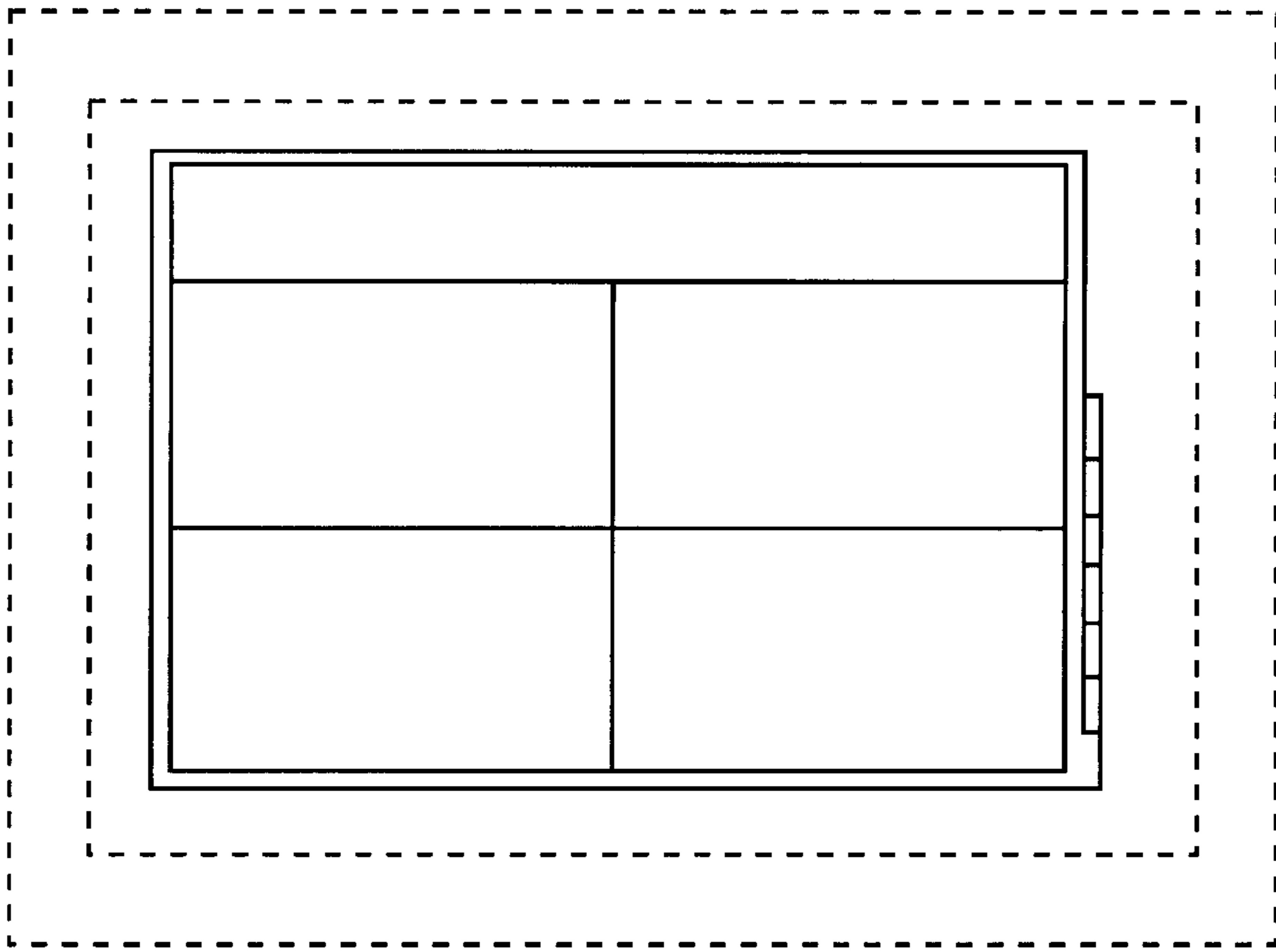

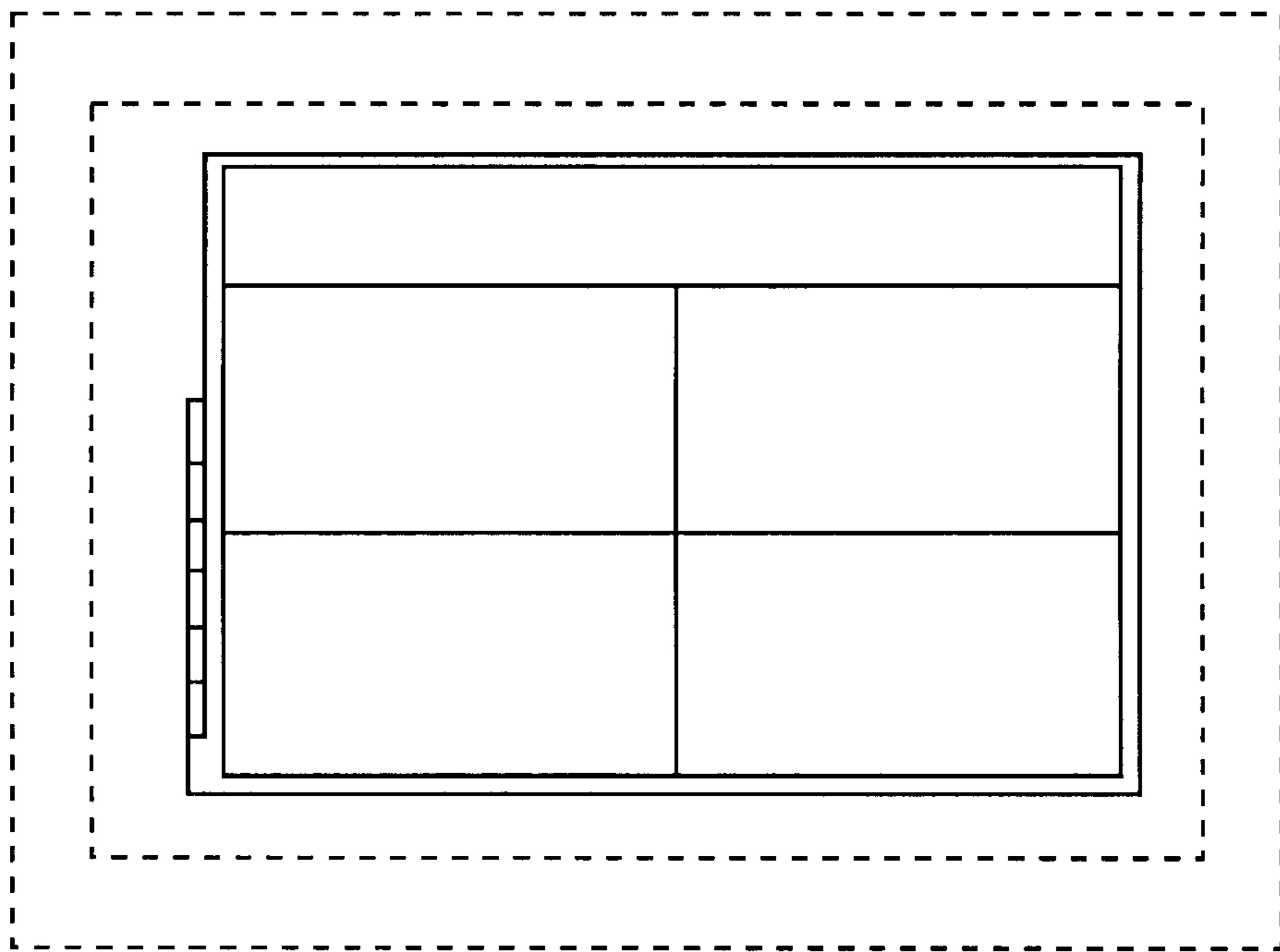

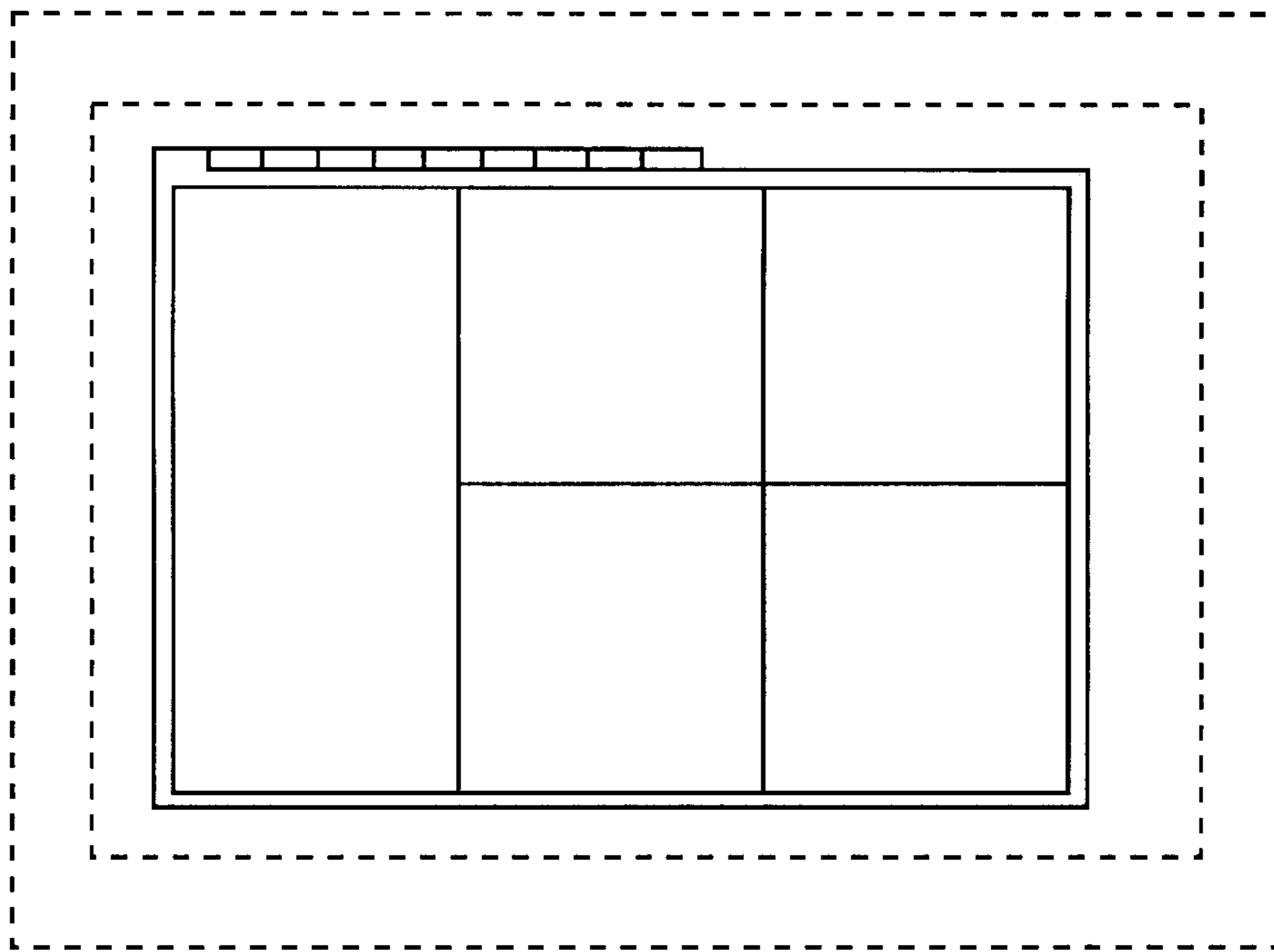




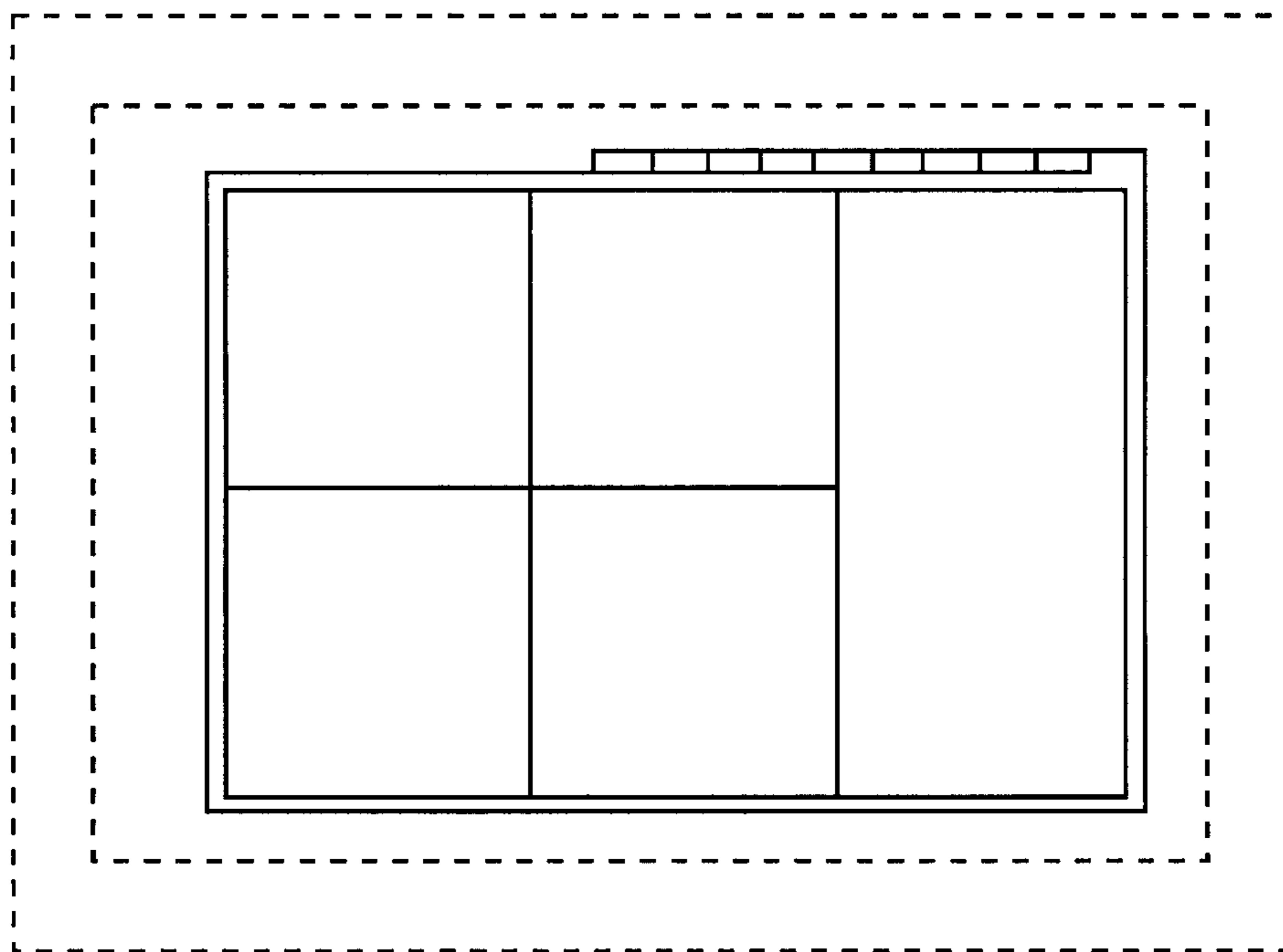

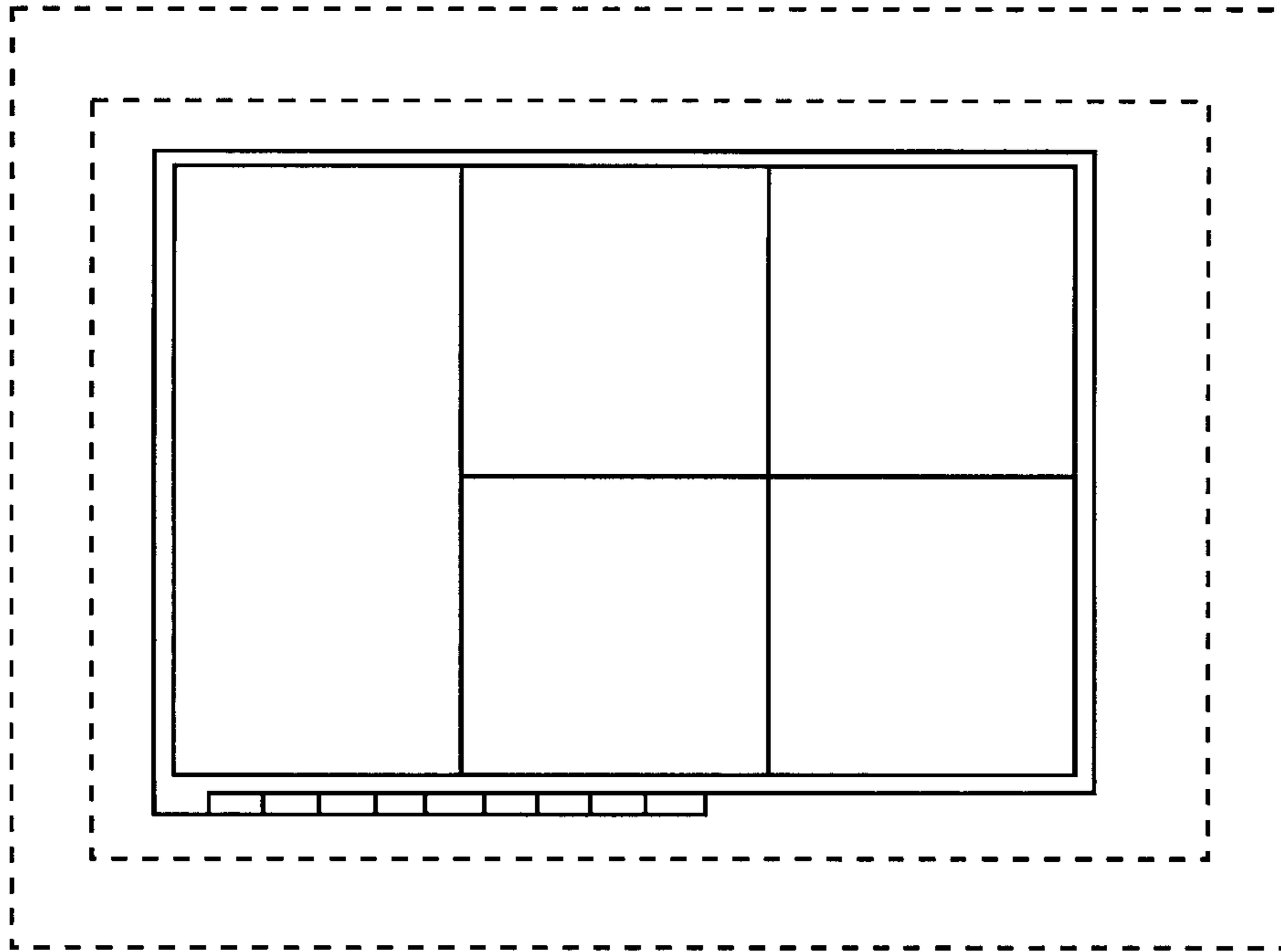

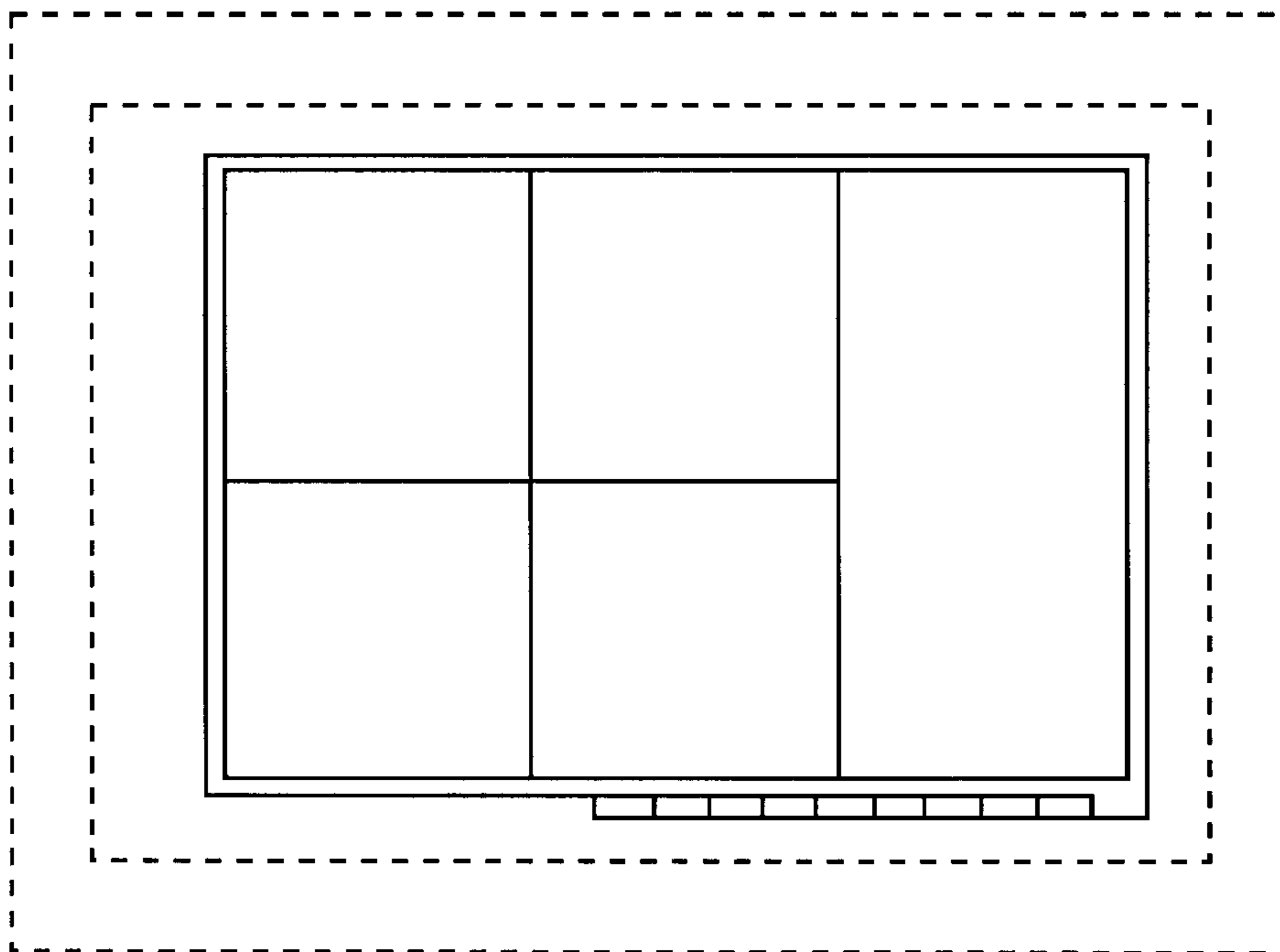

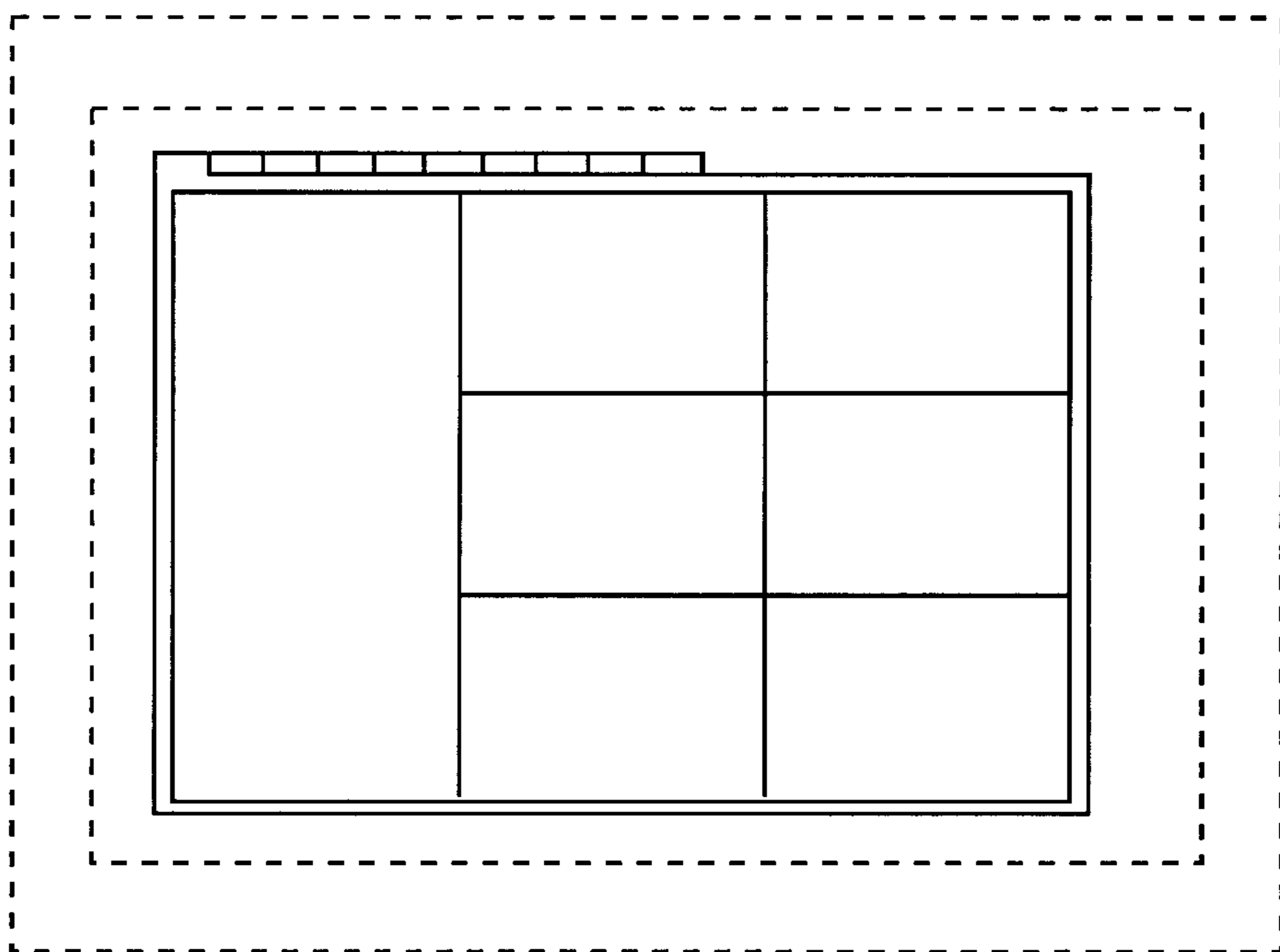

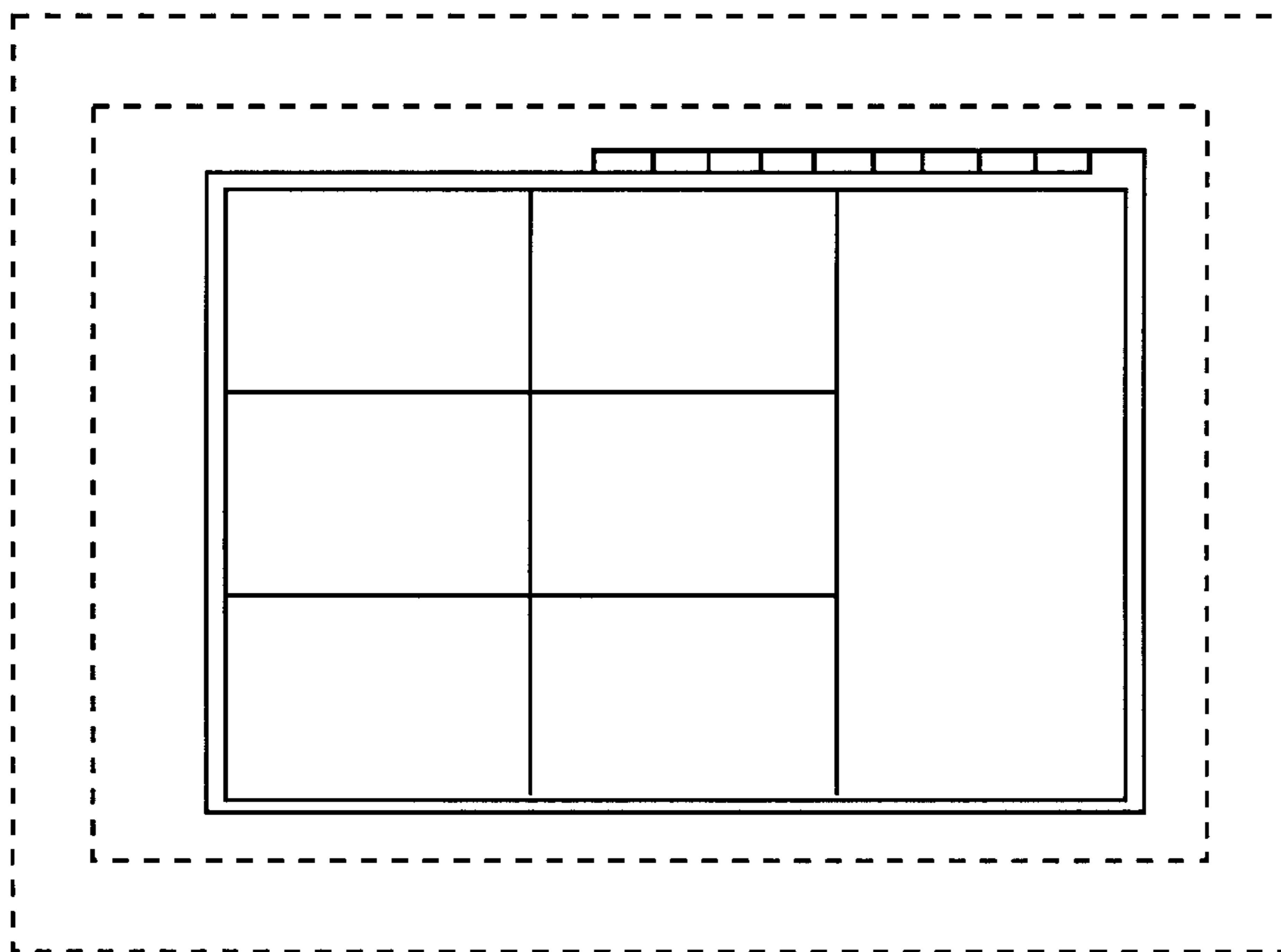

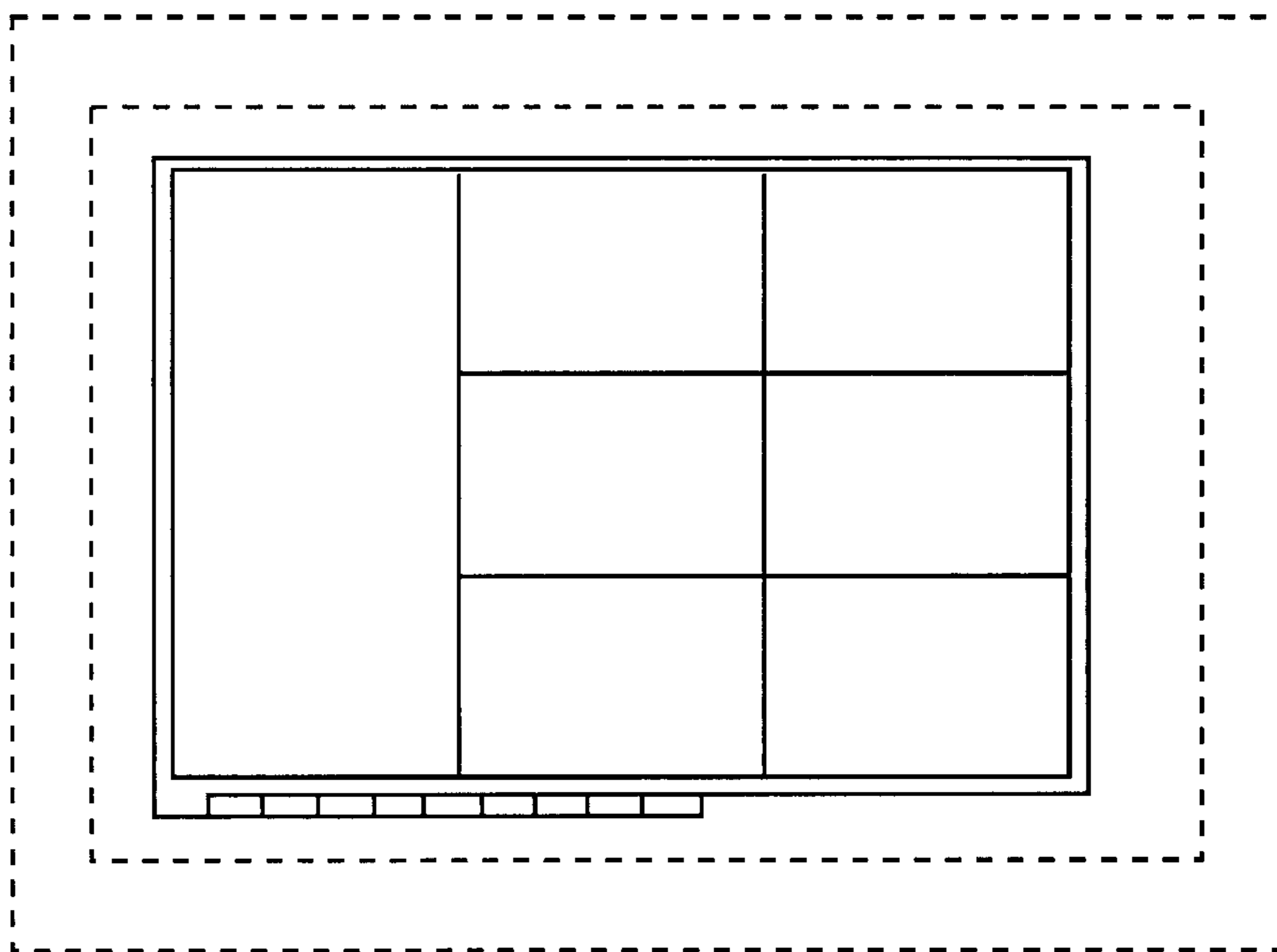

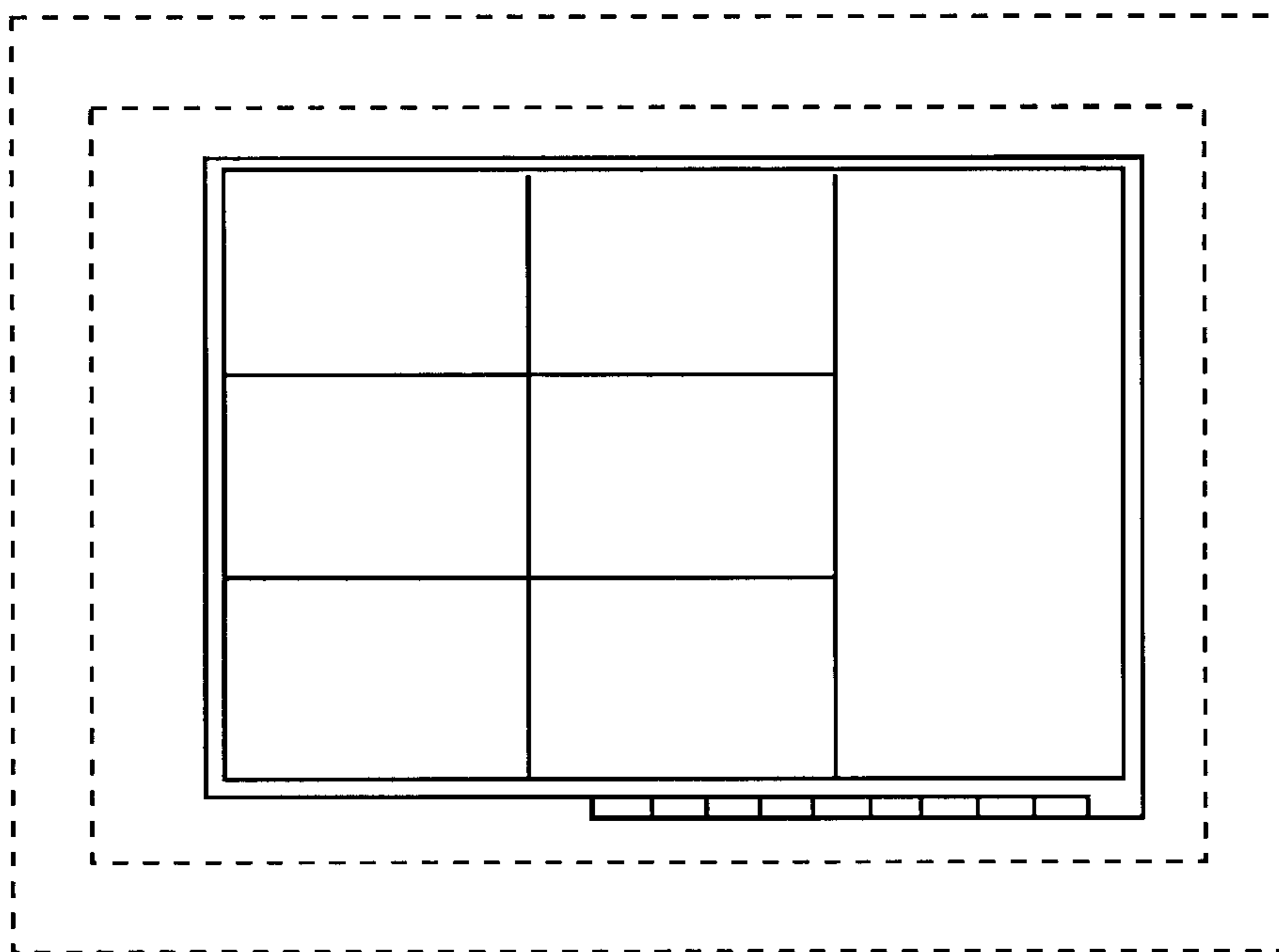

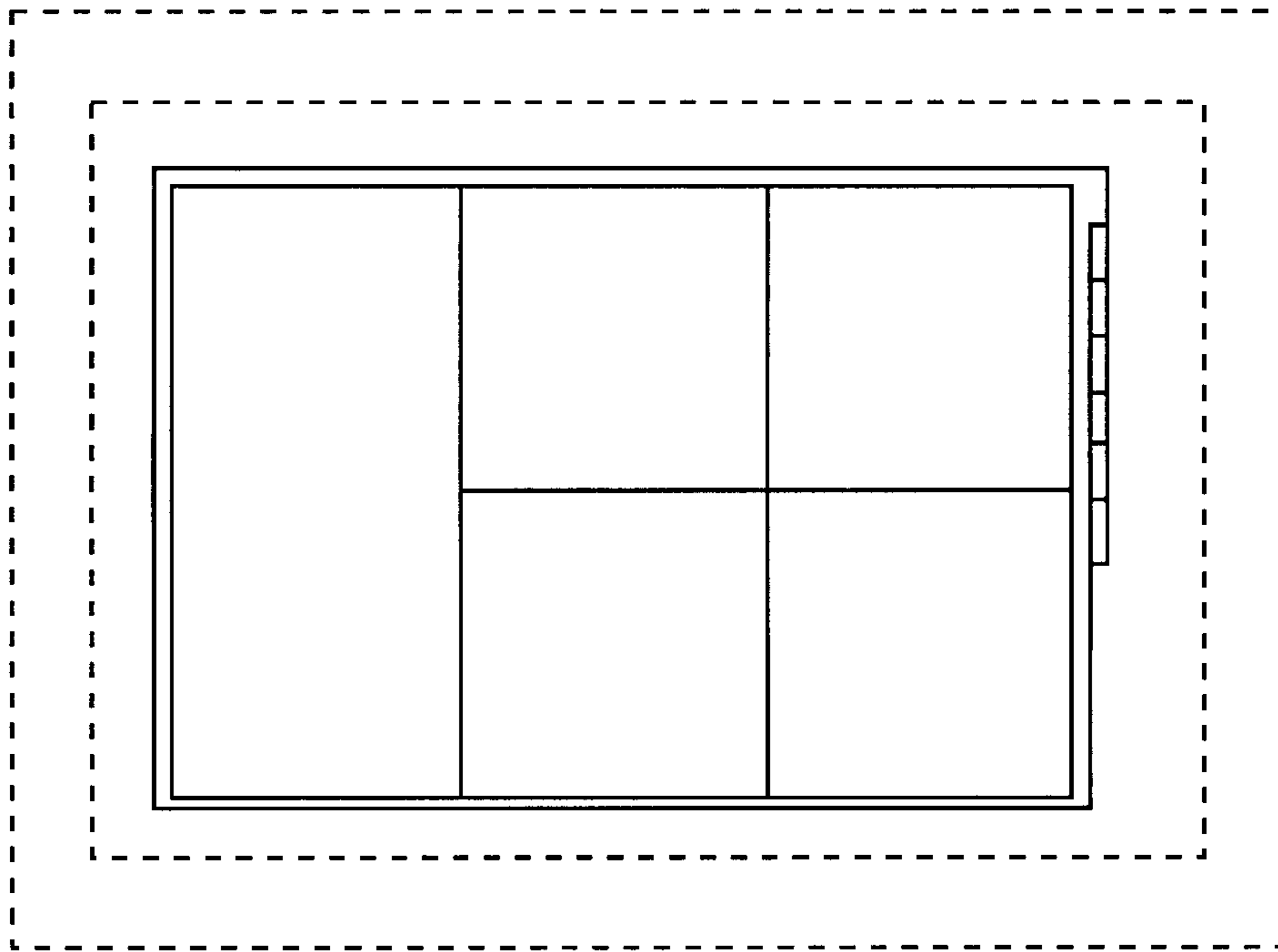

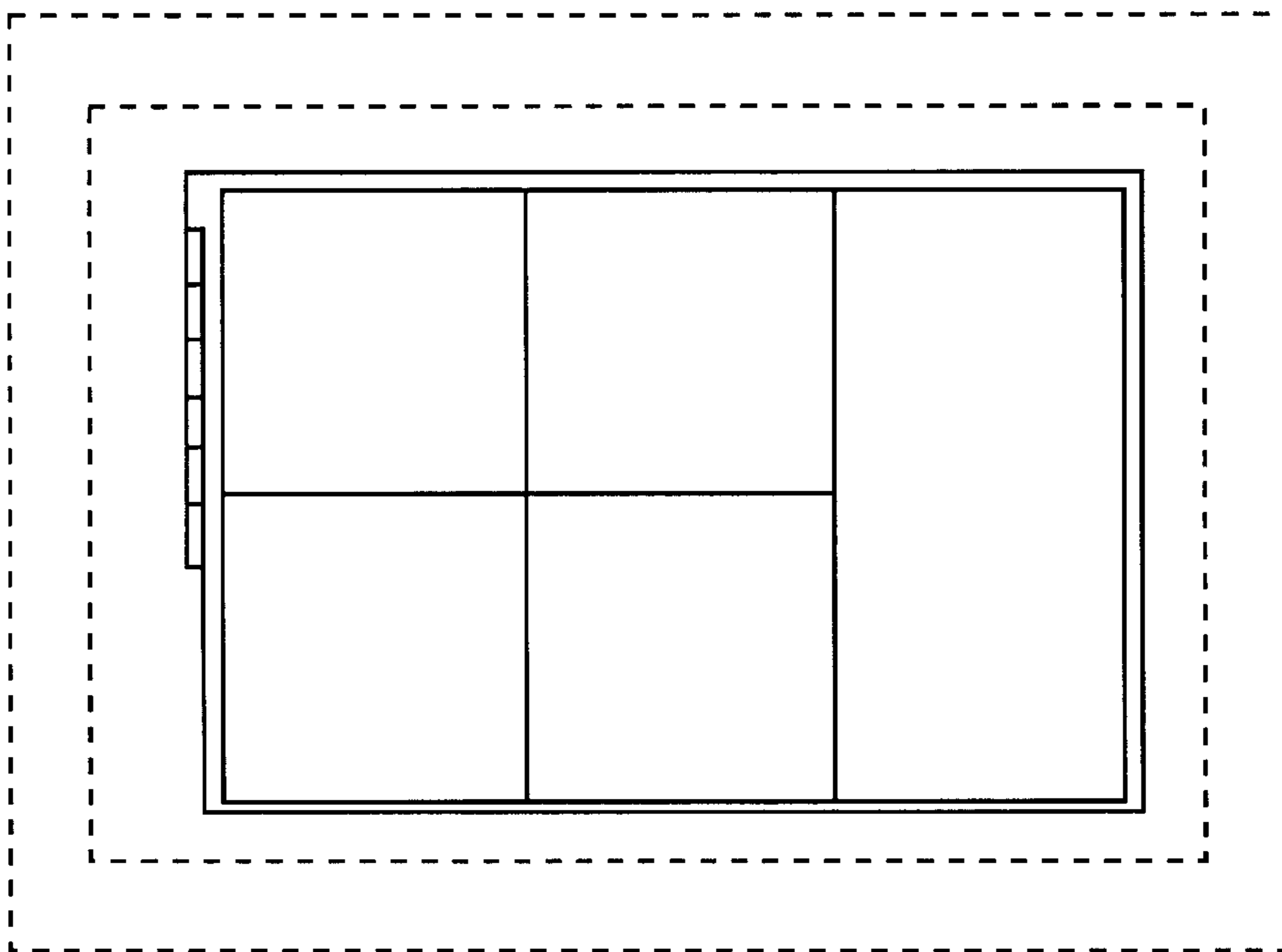

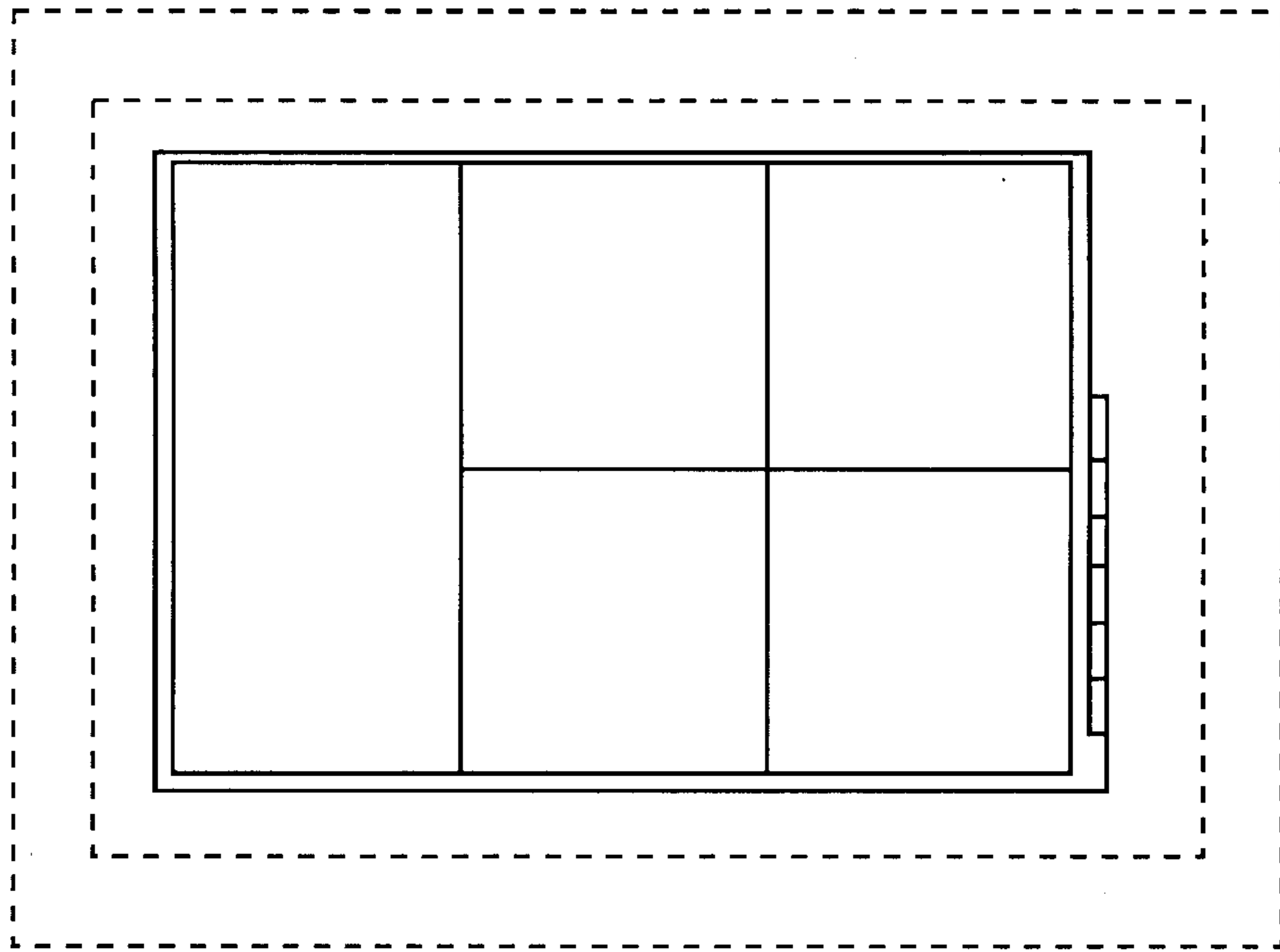

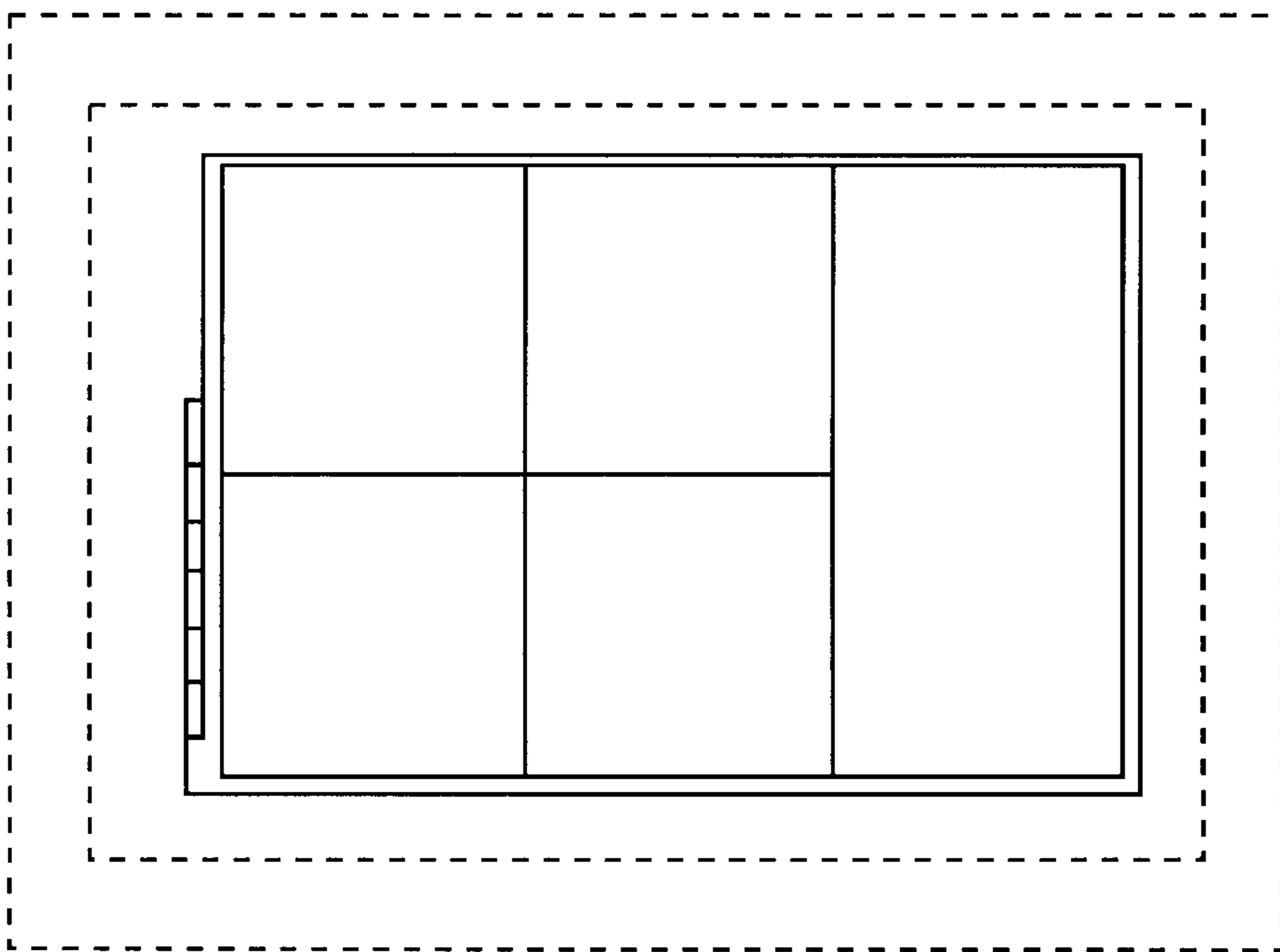

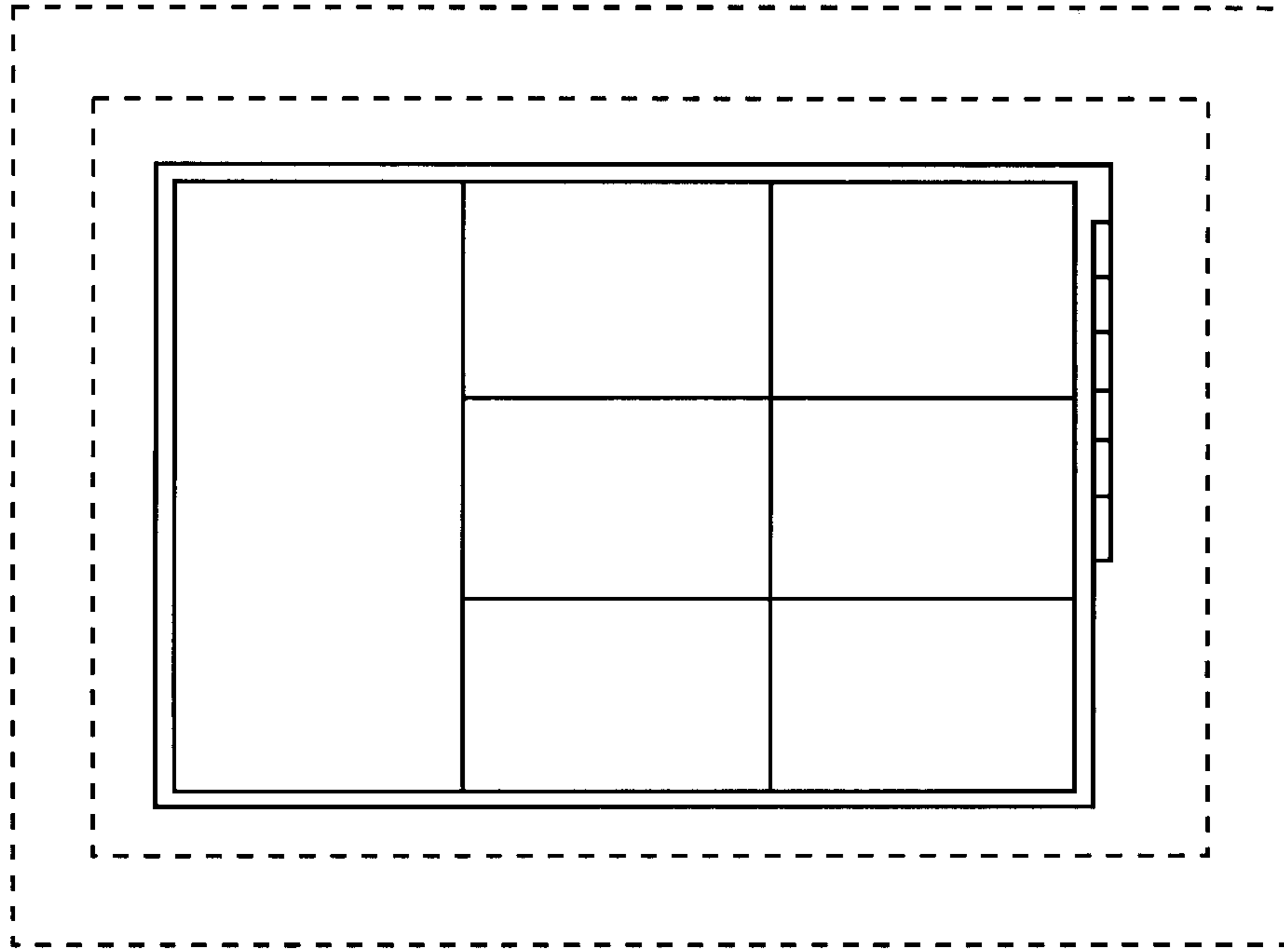

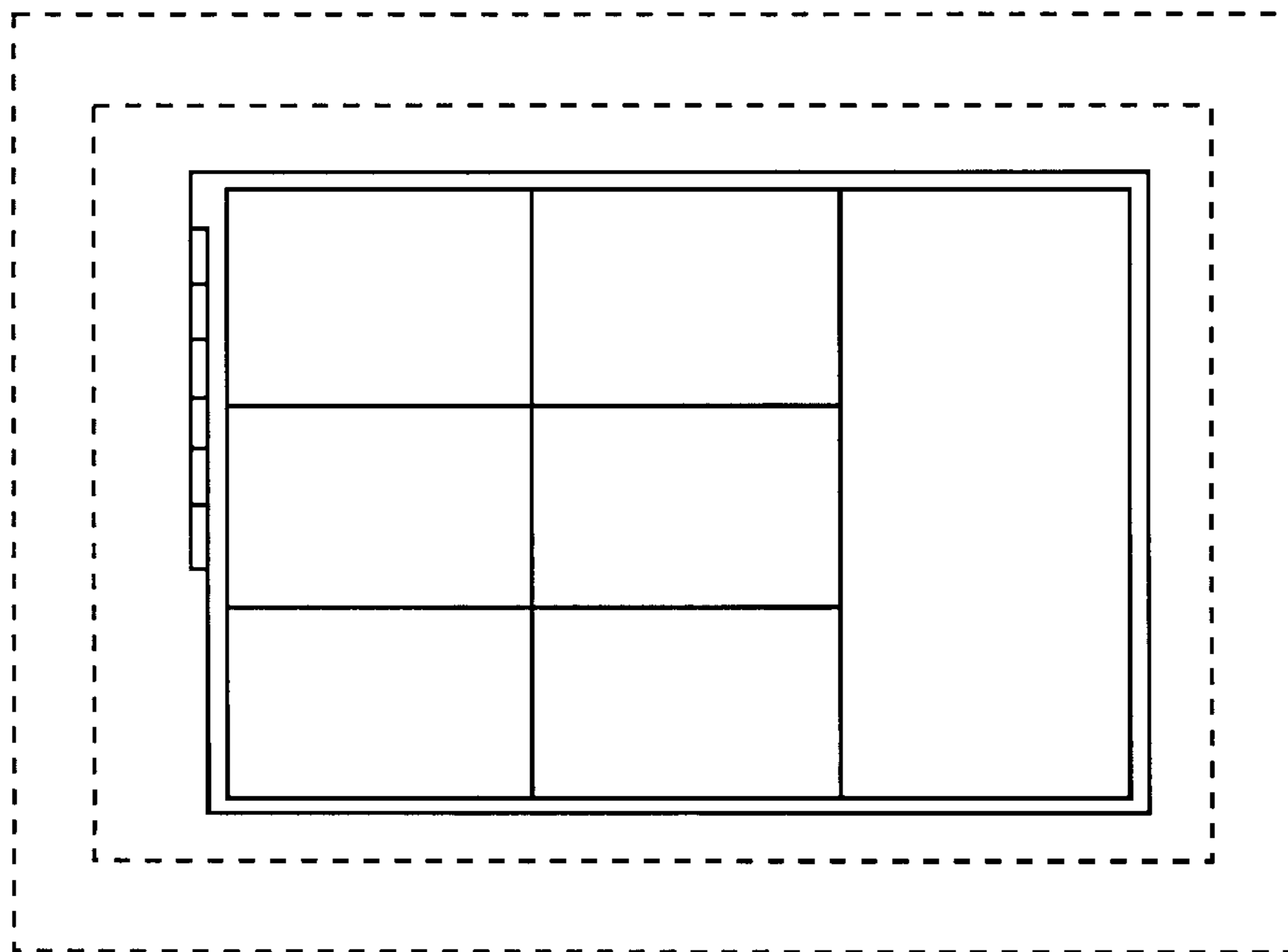

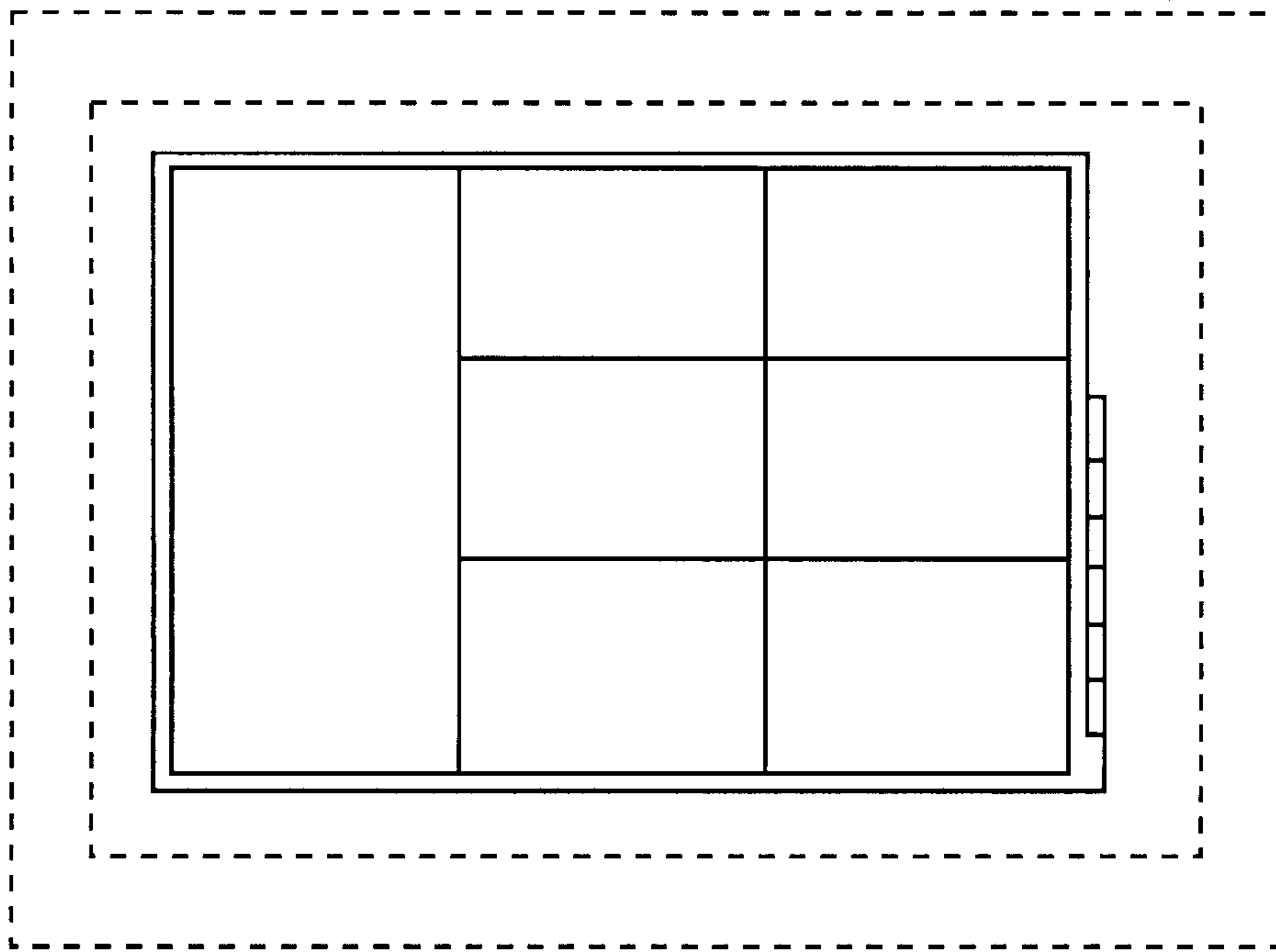

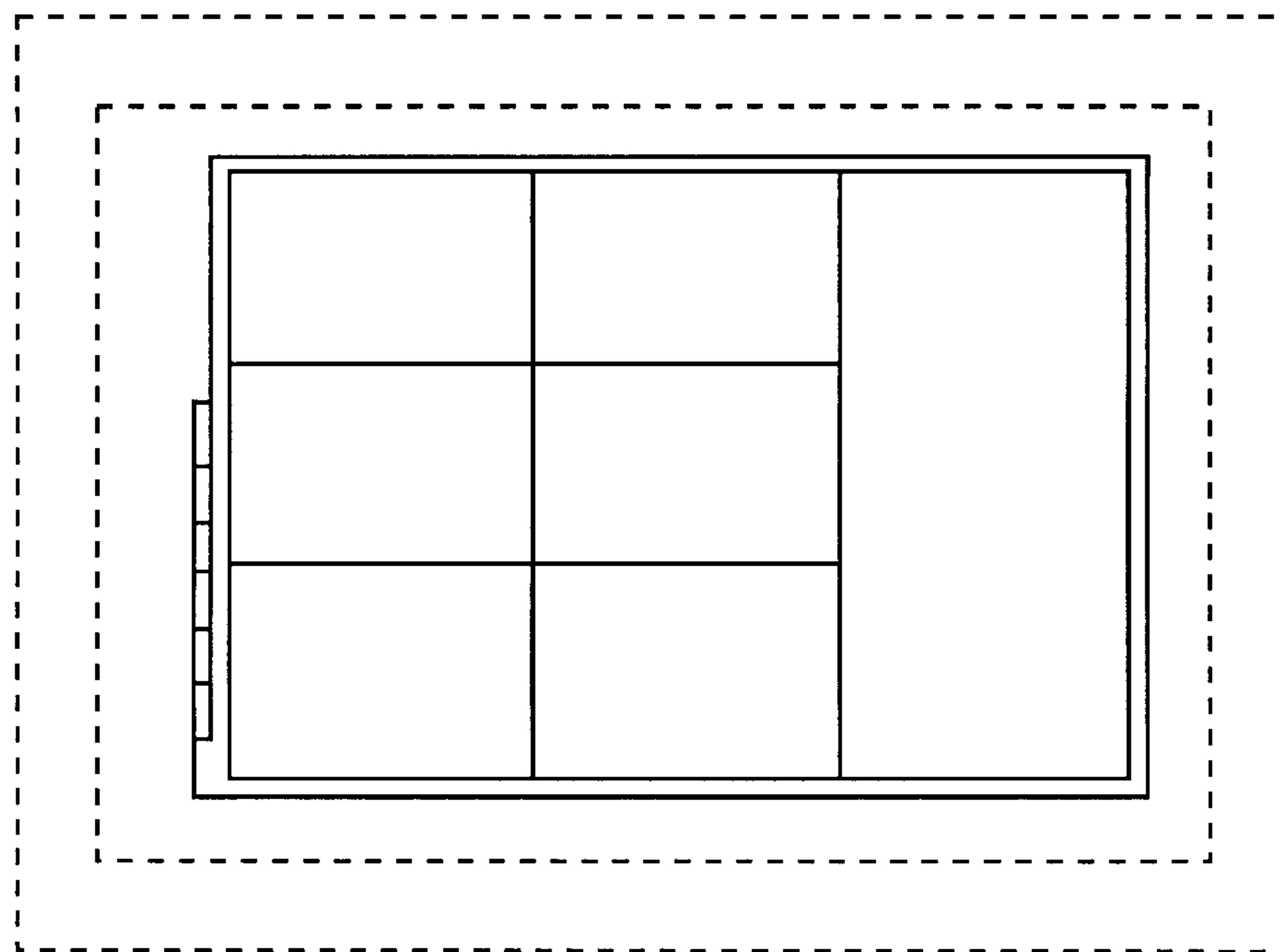
