### DESCRIPTION

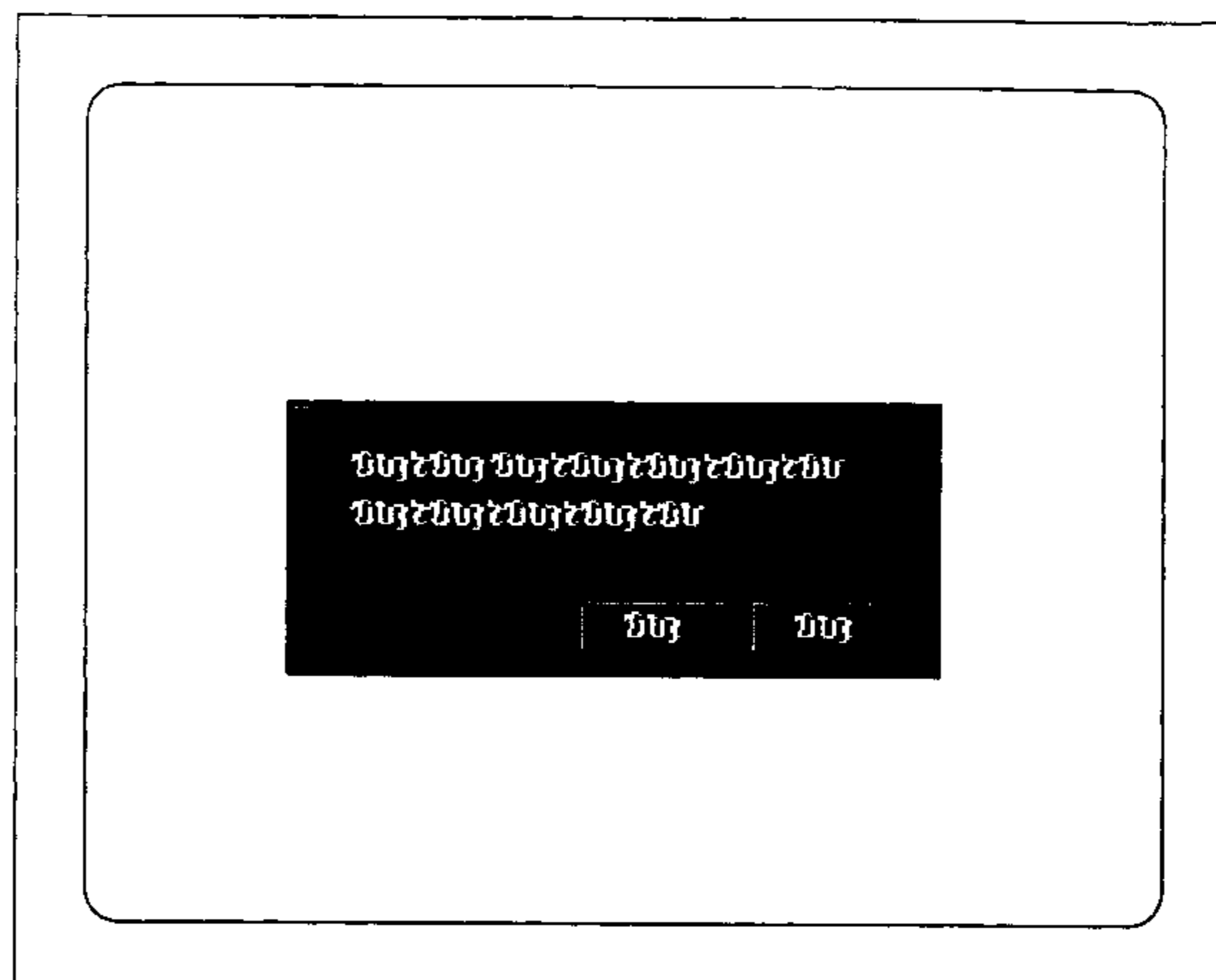

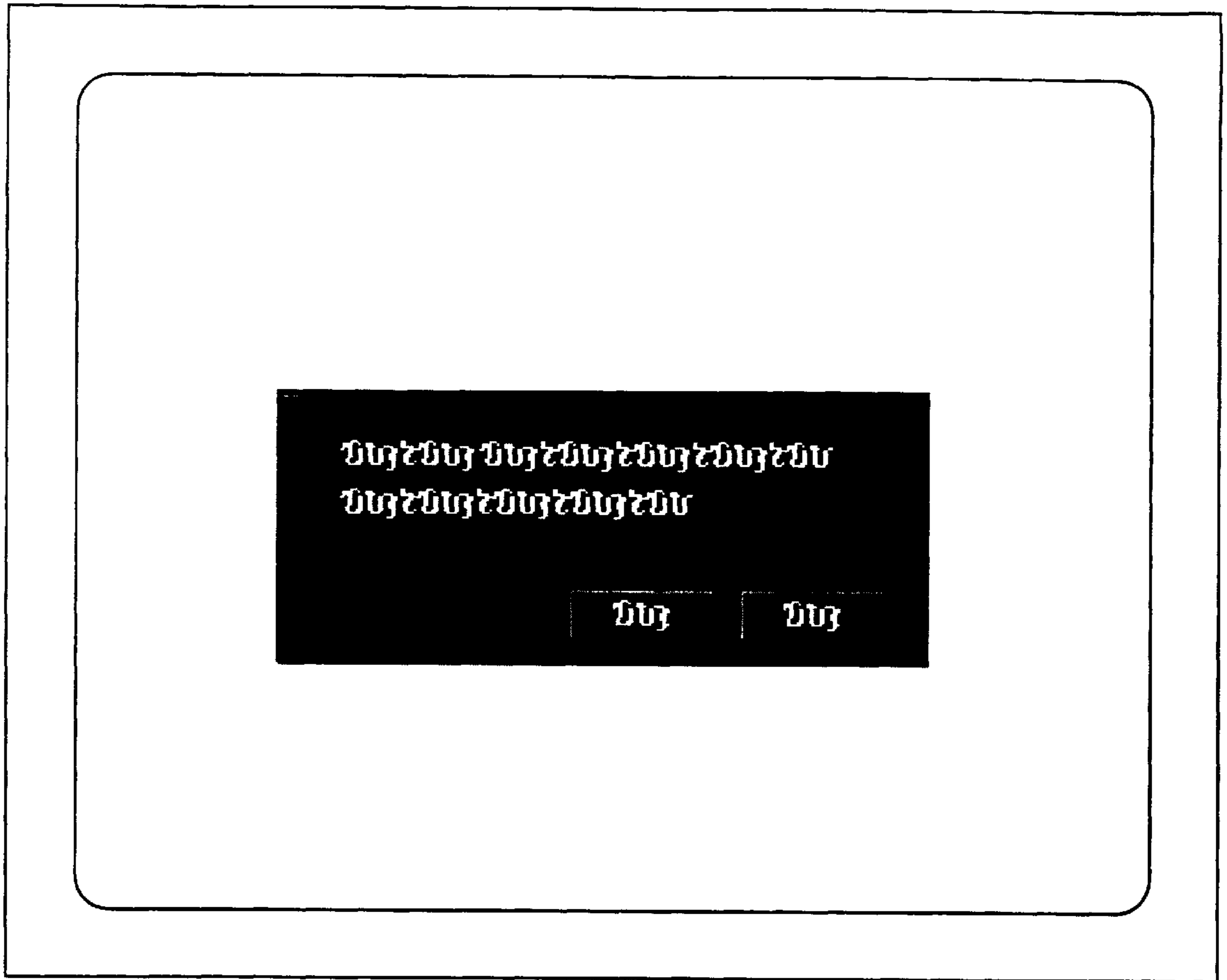
