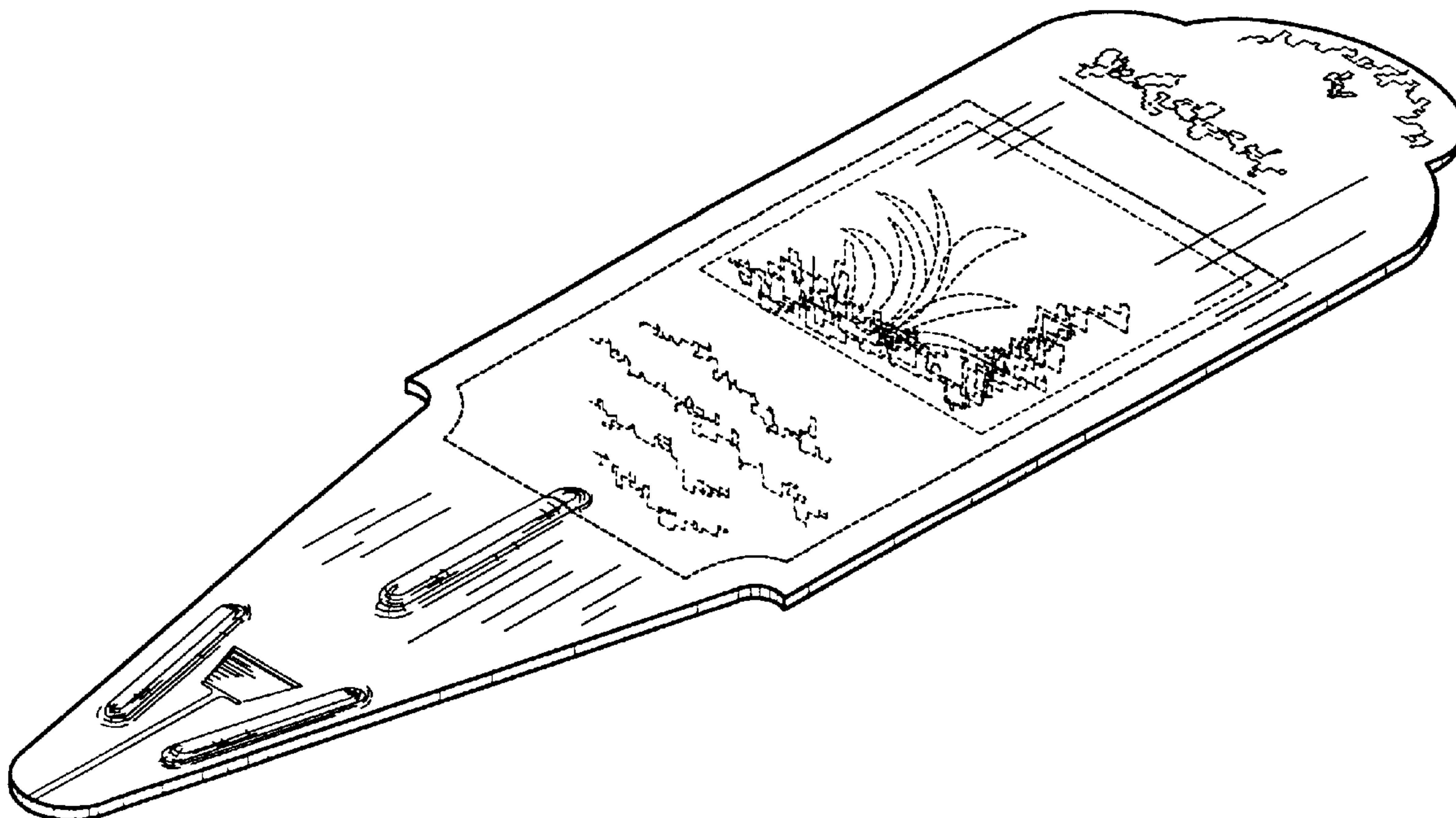
[57] **CLAIM**

I claim the ornamental design for a plant tag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the plant tag embodying the present invention;  
FIG. 2 is a front elevational view of the tag shown in FIG. 1;  
FIG. 3 is a rear elevational view of the tag shown in FIG. 1;  
FIG. 4 is an enlarged top plan view of the tag shown in FIGS. 1-3;  
FIG. 5 is an enlarged bottom plan view of the tag shown in FIGS. 1-3; and,  
FIG. 6 is an enlarged right-side elevational view of the tag shown in FIGS. 1-5, the left side elevational view is a mirror image.  
The broken lines are shown for illustrative purposes only and form no part of the claimed design.

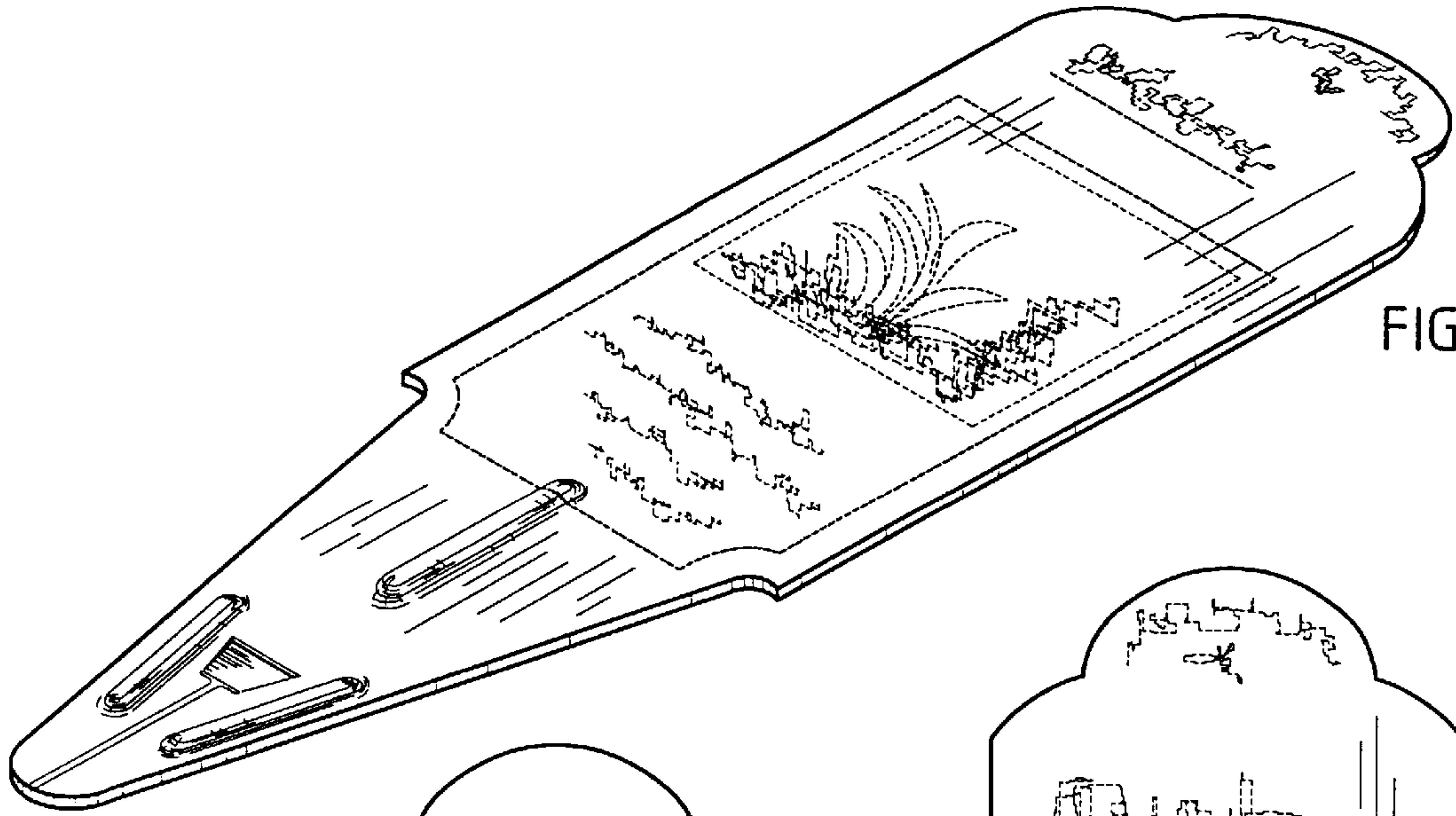

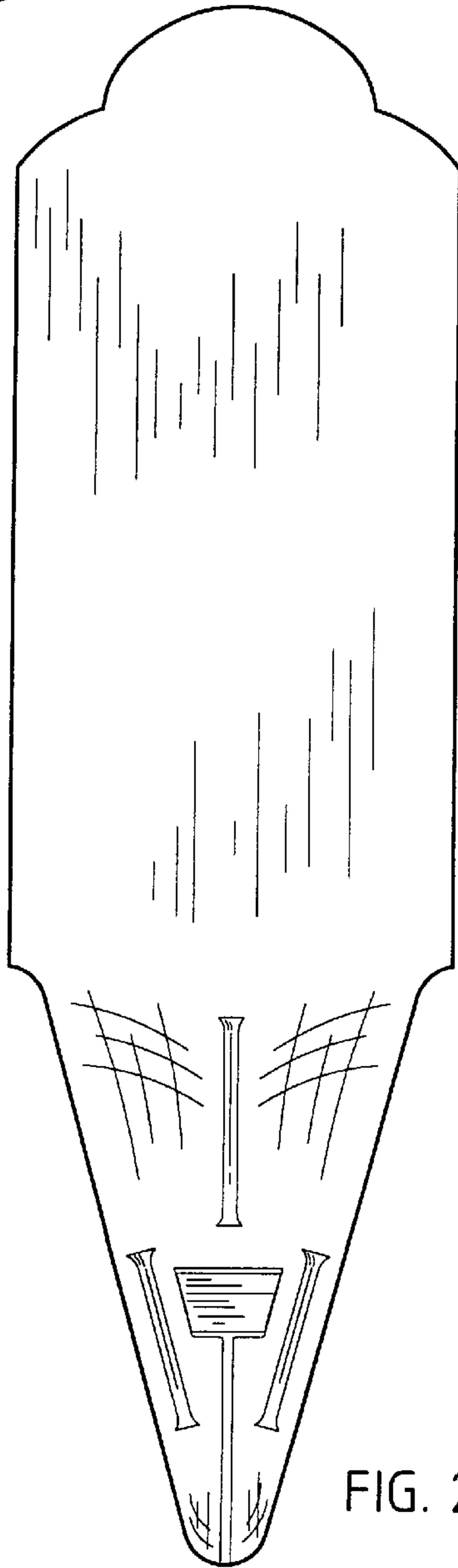

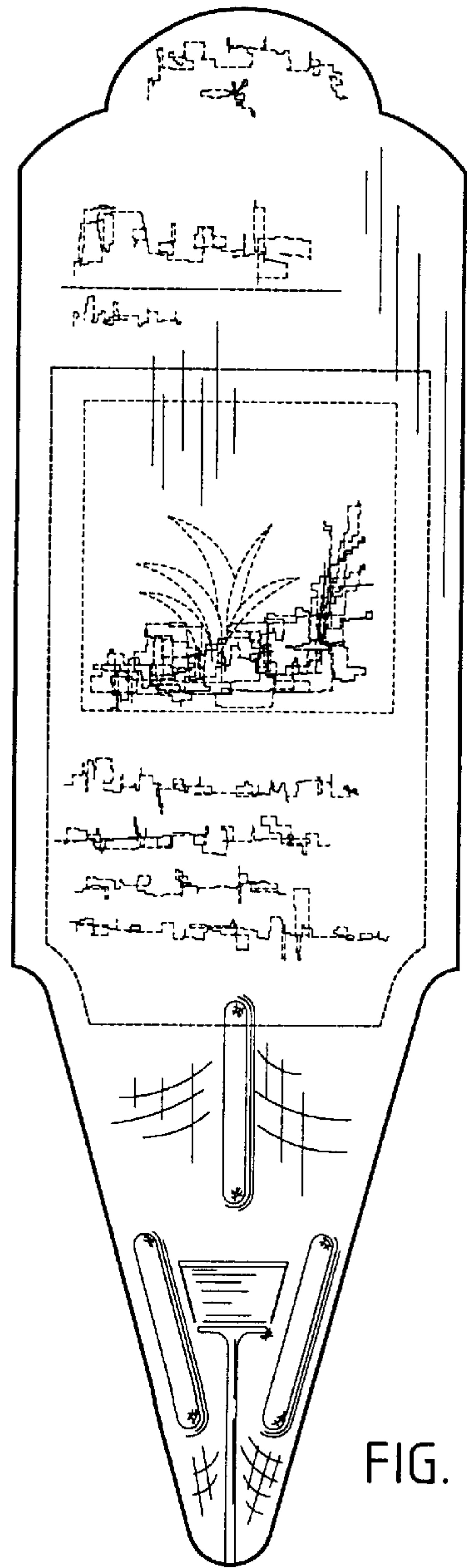

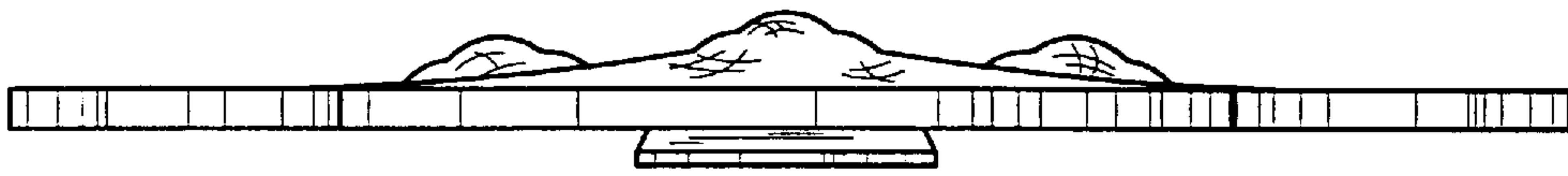

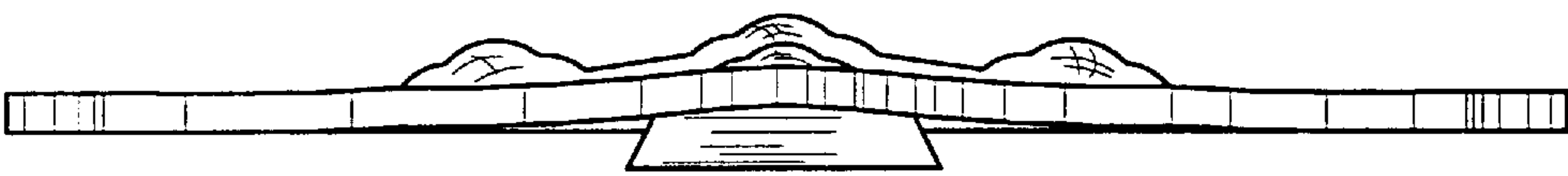

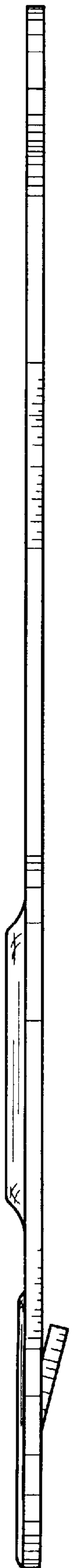
